## 1 - Summary

### 1.1 Semi-classical limits of the number and Riesz means of discrete eigenvalues of the N -body Schrödinger operators

In this section, we introduce the main work which is done in Chapter 2.

PROBLEMS. First, we introduce the problems we considered in Chapter 2. Let $H(h)$ denote the N-body Schrödinger operator obtained by removing the mass center of Hamilton of an N-particle system

$$
\begin{equation*}
-\sum_{j=1}^{N} \frac{h^{2}}{2 m_{i}} \Delta_{r_{i}}+\sum_{1 \leq i<j \leq N} V_{i j}\left(r_{i}-r_{j}\right) \tag{1.1}
\end{equation*}
$$

Here $r_{j} \in \mathbb{R}^{v}(v \geq 3)$ and $m_{j}>0$ denote the position and the mass of the $j$-th particle respectively, and $-\Delta_{r_{i}}$ is the Laplacian in the $r_{i}$ variables. Let $C_{i}(i=1, \cdots, k)$ be the subsets of $\{1, \cdots, N\}$. If $C_{i} \cap C_{j}=\emptyset, i \neq j$ and $\cup_{i=1}^{k} C_{i}=\{1, \cdots, N\}$, we say that $D=\left\{C_{1}, \cdots, C_{k}\right\}$ is a partition (or cluster decomposition) of $\{1, \cdots, N\}$. If $D=\left\{C_{1}, \cdots, C_{k}\right\}$, we denote $\# D=k$. If $i, j$ are two numbers in $\{1, \cdots, N\}$, we write $i D j$ if and only if $i$ and $j$ are in the same cluster $C_{l}$, and $\sim i D j$ if they are in the different clusters. Let $\sum_{i D j}$ (resp. $\sum_{\sim i D j}$ ) denote the sum over all pairs with $i, j$ in the same ( resp. different ) cluster of $D$. We define

$$
\begin{gathered}
V_{D}=\sum_{i D j} V_{i j} ; \quad I_{D}=\sum_{\sim i D j} V_{i j} ; \\
H_{D}(h)=H(h)-I_{D} ; \quad \Sigma_{D}(h)=\inf \sigma\left(H_{D}(h)\right) \\
a_{D}=\min _{\left\{x ; x \in \mathbb{R}^{(N-1) v}\right\}} V_{D}(x) ; \quad \Sigma_{c l}=\min _{\{D ; \# D \geq 2\}} a_{D} .
\end{gathered}
$$

For each $D$, there is a natural decomposition of $\mathscr{H}=L^{2}\left(\mathbb{R}^{(N-1) v}\right)$ as $\mathscr{H}^{D} \otimes \mathscr{H}_{D}$ with $\mathscr{H}_{D}=$ functions of $r_{i j}$ with $i D j$ and $\mathscr{H}^{D}=$ functions of $R_{q}-R_{l}$ where $R_{q}=\sum_{i \in C_{q}} m_{i} r_{i} / \sum_{i \in C_{q}} m_{i}$ is the center of the mass of $C_{q}$. Under this decomposition

$$
H_{D}(h)=h_{D}(h) \otimes 1+1 \otimes t_{D}(h)
$$

By the well known HVZ-theorem [54, Section XIII.5 ],

$$
\begin{equation*}
\inf \sigma_{e s s}(H(h))=\Sigma_{h}, \tag{1.2}
\end{equation*}
$$

where $\Sigma_{h}=\min _{\{D ; \# D=2\}} \Sigma_{D}(h)$. We say $H(h)$ is unique two-cluster, if there is only one cluster decomposition $D$ with $\# D=2$, such that $\Sigma_{h}=\Sigma_{D}(h)$. The intuition is quite simple : if $H(h)$ is two-cluster, the threshold is basically due to a $v$-dimensional Laplacian, namely the relative kinetic energy of the two clusters. So one expects the coupling constant behavior to be a $v$ dimensional problem. We concentrate on the unique two-cluster $H(h)$. We mainly work on two problems in Chapter 2. The first one is the semi-classical limit of the number of discrete eigenvalues of the $N$-body Schrödinger operator $H(h)$. The second is the semi-classical limit of Riesz means of discrete eigenvalues of $H(h)$.

KNOWN RESULTS. The semi-classical limit of the number of discrete eigenvalues of $H(h)$ has been studied by many authors for $N=2$ (see [4], [31], [40], [44], [54], [68]). Roughly speaking, in the case of 3-dimensional space, $\mathbb{R}^{3}$, the result obtained by these authors can be formulated as following : assume that $V(x)$ is real and $V(x) \in L^{3 / 2}\left(\mathbb{R}^{3}\right)$, the number of the negative eigenvalues, $N(\lambda)$, of $-\Delta+\lambda V$ obeys the asymptotic formula :

$$
N(\lambda)=\left(6 \pi^{2}\right)^{-1} \int\left|V_{-}(x)\right|^{3 / 2} d x(1+o(1)), \quad \lambda \rightarrow \infty
$$

Here $V_{-}(x)=\min \{0, V(x)\}$. The remainder term in the result of Tamura is $O\left(\lambda^{-1 / 2}\right)$, under the condition $V(x) \in C^{\infty}\left(\mathbb{R}^{3} \backslash\{0\}\right), V(x) \sim|x|^{-d}, 0 \leq d<2,\left|\partial_{x}^{\alpha} V(x)\right| \leq C_{\alpha} V(x)|x|^{-|\alpha|}$ for $|x| \leq 1$ and $|V(x)| \leq C\langle x\rangle^{-m}, m>2,\left|\partial_{x}^{\alpha} V(x)\right| \leq C_{\alpha} V(x)\langle x\rangle^{-l|\alpha|}, 3-m<l \leq 1$, for $|x| \geq 1$. For the proof [4] and [44] use the min-max principle combined with a technique of Dirichlet-Neumann bracketing while [31],[40] and [54] use the Feyman-Kac formula. Tamura [68] uses pseudodifferential operators and Fourier integral operators to study this problem for $N=2$. KlausSimon studied this problem (see [34]) for the 3-body Schrödinger operators. The main tool they used in that paper is Birman-Schwinger kernel. Their result is the following : assume $v \geq 3, V \leq 0, V_{i j} \in C_{0}^{\infty}(1 \leq i<j \leq 3)$ and in the unique two-cluster case, the number of bound states, $N(\mu)$, of $-\mu \Delta+\sum_{1 \leq i<j \leq 3} V_{i j}$ on $L^{2}\left(\mathbb{R}^{2 v}\right)$ obeys the asymptotic formula :

$$
\lim _{\mu \rightarrow 0} \mu^{v} N(\mu)=\tau_{2 v}(2 \pi)^{-2 v} \int_{V(x) \leq \Sigma_{c l}}\left[\Sigma_{c l}-V(x)\right]^{v} d x
$$

Here $\tau_{v}$ is the volume of the unit sphere in $\mathbb{R}^{2 v}$.
Semi-classical limit of Riesz means of discrete eigenvalues of Schrödinger operator $P(h)=$ $-h^{2} \Delta+V$ has been studies by Helffer and Robert [23], Bruneau [9]. Let $\Sigma=\underset{|x| \rightarrow \infty}{\lim } V(x)$. They studied semi-classical limit of Riesz means of discrete eigenvalues less than $\lambda_{0}$. Here $\lambda_{0}$ is a constant that $\lambda_{0}<\Sigma$. They used pseudo-differential operators to get the asymptotic expansion of

$$
R_{\gamma}(h, \lambda)=\sum_{e_{j}(h) \leq \lambda}\left(\lambda-e_{j}(h)\right)^{\gamma}
$$

for $\lambda<\lambda_{0}$ as $h \rightarrow 0$. They did not get the semi-classical limit of Riesz means of all bound states of $P(h)$.

OUR METHODS AND RESULTS. In Chapter 2, we concentrate on the unique two-cluster $N$-body Schrödinger operators. We also use the Birman-Schwinger kernel to get the semiclassical limit of the number of discrete eigenvalues of the $N$-body Schrödinger operator. Hence we recall some results of Birman-Schwinger kernel in Section 2.2. We use these results to get the leading term of the number of discrete eigenvalues of the $N$-body Schrödinger operator. We suppose that

$$
\begin{equation*}
V_{i j} \leq 0, \quad V_{i j} \in C^{2}\left(\mathbb{R}^{\nu}\right) \text { and }\left|V_{i j}\right| \leq C\langle x\rangle^{-\rho} \text { with some } \rho>2 \tag{1.3}
\end{equation*}
$$

First, we explain why we need the condition $V_{i j} \in C^{2}\left(\mathbb{R}^{\nu}\right)$. In fact, we do not use this condition in Section 2.2, since the condition $\left|V_{i j}\right| \leq C\langle x\rangle^{-\rho}$ with some $\rho>2$ is enough. The condition $V_{i j} \in C^{2}\left(\mathbb{R}^{\nu}\right)$ is used to prove that $\Sigma_{h}-\Sigma_{c l}=O(h)$. The number of discrete eigenvalues in $\left(-\infty, \Sigma_{c l}\right)$ is standard Dirichlet-Neumann bracket. The difficulty is to estimate the number of eigenvalues in the interval $\left(\Sigma_{c l}, \Sigma_{h}\right)$.

Our result for the semi-classical limit of the number of discrete eigenvalues which is less than $\Sigma_{h}, N(h)$, of $H(h)$ is the following :
Theorem 1.1. Let $v \geq 3$ and $H_{0}=-h^{2} \Delta$ on $L^{2}\left(\mathbb{R}^{(N-1) v}\right)$. Suppose (1.3) holds. Then

$$
\begin{equation*}
N(h)=h^{-(N-1) v} \tau_{(N-1) v}(2 \pi)^{-(N-1) v} \int_{V(x) \leq \Sigma_{c l}}\left[\Sigma_{c l}-V(x)\right]^{(N-1) v / 2} d x(1+o(1)) \tag{1.4}
\end{equation*}
$$

where $\tau_{(N-1) v}$ is the volume of the unit sphere in $\mathbb{R}^{(N-1) v}$.
In Section 2.4, we use Dirichlet-Neumann bracket to study the Riesz means of discrete eigenvalues of the $N$-body Schrödinger operator. We suppose that

$$
\begin{equation*}
V_{i j} \in C_{0}^{\infty}\left(\mathbb{R}^{\nu}\right) \text { and } V_{i j} \leq 0 \tag{1.5}
\end{equation*}
$$

Define the Riesz means of the N -body Schrödinger operator as

$$
R_{\gamma}\left(h, \Sigma_{h}\right)=\sum_{e_{j}(h) \leq \Sigma_{h}}\left|e_{j}(h)-\Sigma_{c l}\right|^{\gamma}
$$

for $\gamma \geq 0$. We first consider the semi-classical limit of Riesz means of discrete eigenvalues of the 2-body Schrödinger operator. Then we use this result to estimate $\sum_{e_{j}(h) \leq \Sigma_{c l}}\left|e_{j}(h)-\Sigma_{c l}\right|^{\gamma}$. Since

$$
\sum_{\Sigma_{c l} \leq e_{j}(h) \leq \Sigma_{h}}\left|e_{j}(h)-\Sigma_{c l}\right|^{\gamma} \leq N_{2}(h)\left(\Sigma_{h}-\Sigma_{c l}\right)^{\gamma}
$$

and $\Sigma_{h}-\Sigma_{c l}=O(h)$, we can get the estimate of $\sum_{\Sigma_{c l} \leq e_{j}(h) \leq \Sigma_{h}}\left|e_{j}(h)-\Sigma_{c l}\right|^{\gamma}$. Here $N_{2}(h)$ is the number of eigenvalues in $\left(\Sigma_{c l}, \Sigma_{h}\right)$.

We get the following result :

Theorem 1.2. Let $v \geq 3$. Let $H_{0}=-h^{2} \Delta$ on $L^{2}\left(\mathbb{R}^{(N-1) v}\right)$. Suppose (1.5) holds. Then we have

$$
\begin{equation*}
R_{\gamma}\left(h, \Sigma_{h}\right)=C(\gamma, v) h^{-(N-1) v} \int_{\left\{x ; V(x) \leq \Sigma_{c l}\right\}}\left(\Sigma_{c l}-V(x)\right)^{\gamma+\frac{(N-1) v}{2}} d x\left(1+O\left(h^{t}\right)\right) \tag{1.6}
\end{equation*}
$$

where $C(\gamma, v)=(2 \pi)^{-(N-1) v} \tau_{(N-1) \nu} C_{\gamma,(N-1) v}, C_{\gamma,(N-1) v}=\gamma \int_{0}^{1} \beta^{\gamma-1}(1-\beta)^{n / 2} d \beta$ and $\tau_{(N-1) v}$ is the volume of the unit sphere in $\mathbb{R}^{(N-1) v}, t=\min \left\{\frac{1}{2}, \gamma\right\}$.

NEW POINTS IN METHODS AND RESULTS. Our first result is the generalization of the result of Klaus-Simon's [34]. In their paper, the conditions on $V_{i j}$ are too strong and they only consider the 3-body case. Our conditions on $V$ are much weaker than theirs and we get the result for general $N$. In the second part of Chapter 2, we get the semi-classical limit of Riesz means of all discrete eigenvalues of $H(h)$.

### 1.2 Coupling constant limits and the asymptotic expansion of resolvent of Schrödinger operators with critical potentials

PROBLEMS. In Chapter 3, we consider a family of Schrödinger operators

$$
P(\lambda)=P_{0}+\lambda V
$$

in $L^{2}\left(\mathbb{R}^{n}\right)$. Here $P_{0}=-\Delta+\frac{q(\theta)}{r^{2}}$ on $L^{2}\left(\mathbb{R}^{n}\right)$ and $(r, \theta)$ is the polar coordinates on $\mathbb{R}^{n}$. $V \leq 0$ is a non-zero continuous function and satisfies

$$
\begin{equation*}
|V(x)| \leq C\langle x\rangle^{-\rho_{0}}, \quad \text { for some } \rho_{0}>2 \tag{1.7}
\end{equation*}
$$

In Section 2.5 (Chapter 2), we study the $N$-body Schrödinger operator with Coulomb potential, and we get that the effective potential has the following expansion for $\rho$ large (see Section 2.5 (Chapter 2)) :

$$
I_{e f f}(\rho)=\frac{f_{1}(\hat{\rho})}{|\rho|^{2}}+\frac{f_{2}(\hat{\rho})}{|\rho|^{3}}+o\left(\frac{1}{|\rho|^{4}}\right)
$$

with $\hat{\rho}=\frac{\rho}{|\rho|}$, if $C_{1} \equiv \sum_{i \in a_{1}} e_{i}=0$ or $C_{2} \equiv \sum_{i \in a_{2}} e_{i}=0 . e_{i}$ is the charge of $i$-th particle. $f_{j}(\hat{\rho})(j=$ $1,2)$ are the continuous functions of $\hat{\rho}$. Hence, we study the Schrödinger operators of the form $P(\lambda)=P_{0}+\lambda V$. We suppose that

$$
\begin{equation*}
-\Delta_{s}+q(\theta) \geq-\frac{1}{4}(n-2)^{2}, \quad \text { on } L^{2}\left(\mathbb{S}^{n-1}\right) \tag{1.8}
\end{equation*}
$$

Here $\mathbb{S}^{n-1}$ is the unit sphere in $\mathbb{R}^{n}$. Under this assumption, the operator $P_{0}$ is a positive operator on $L^{2}\left(\mathbb{R}^{n}\right)$ (see Chapter 3 for details). Set

$$
\sigma_{\infty}=\left\{v ; v=\sqrt{\lambda+\frac{1}{4}(n-2)^{2}}, \lambda \in \sigma\left(-\Delta_{s}+q(\theta)\right)\right\}, \quad \sigma_{k}=\sigma_{\infty} \cap[0, k], k \in \mathbb{N} .
$$

1.2. Coupling constant limits and the asymptotic expansion of resolvent of Schrödinger operators with critical potentials

If $q=0$, then $P_{0}=-\Delta$. In this case, $\sigma_{\infty}$ consists of either only half-integers (n odd) or only integers (n even). In particular, for Laplace operator $-\Delta$, one has $\sigma_{1}=\{0,1\}, n=2 ; \sigma_{1}=\left\{\frac{1}{2}\right\}$, $n=3 ; \sigma_{1}=\{1\}, n=4 ; \sigma_{1}=\emptyset, n=5$.

We show that the discrete eigenvalue, $e_{i}(\lambda)$, of $P(\lambda)$ converges to 0 , as $\lambda \downarrow \lambda_{0}$ for some $\lambda_{0}>0$ in Chapter 3. We study the asymptotic behavior of $e_{i}(\lambda)$ as $\lambda \downarrow \lambda_{0}$.

Let $H^{r, s}\left(\mathbb{R}^{n}\right), \quad r \in \mathbb{Z}, s \in \mathbb{R}$, denote the weighted Sobolev space of order $r$ with volume element $\langle x\rangle^{2 s} d x$.

Definition 1.3. Set $\mathcal{N}(\lambda)=\left\{u ; P(\lambda) u=0, u \in H^{1,-s}, \forall s>1\right\}$, for $\lambda \geq \lambda_{0}$. If $\mathcal{N}(\lambda) \backslash L^{2} \neq\{0\}$, we say that 0 is the resonance of $P(\lambda)$. A non-zero function $u \in \mathcal{N}(\lambda) \backslash L^{2}$ is called a resonant state of $P(\lambda)$ at zero. $\operatorname{dim} \mathcal{N}(\lambda) \backslash L^{2}$ is called the multiplicity of 0 as the resonance of $P(\lambda)$.

Let $\lambda_{1}$ be the value at which $e_{1}(\lambda)$ converges to $0 . e_{1}(\lambda)$ is the smallest eigenvalue of $P(\lambda)$. In Chapter 3, we show that 0 is not the eigenvalue of $P\left(\lambda_{1}\right)$. The multiplicity of 0 as the resonance of $P\left(\lambda_{1}\right)$ is also studied in that chapter.

In Chapter 3, we also consider the Schrödinger operator $P=-\Delta+\tilde{V}$. Here $\tilde{V}=V_{1}+V_{2}$. $V_{1} \in C\left(\mathbb{R}^{n}\right)$ and $V_{1}(x)=\frac{q(\theta)}{|x|^{2}}$ for $|x|>R . R>0$ is the constant. $q(\theta)$ satisfies (1.8). $V_{2} \in C\left(\mathbb{R}^{n}\right)$ satisfies (1.7). Let

$$
\tilde{P}_{0}=\chi_{1}(-\Delta) \chi_{1}+\chi_{2} P_{0} \chi_{2}
$$

Here $0 \leq \chi_{1} \leq 1$ is a smooth function on $\mathbb{R}^{n}$ such that $\chi_{1}(x)=1$ for $|x| \leq R, \operatorname{supp} \chi_{1} \subset\{x ;|x| \leq$ $R_{1}$ \} for some $R_{1}>R>0$ and $\chi_{1}^{2}+\chi_{2}^{2}=1$. Then $P$ can be treated as the perturbation of $\tilde{P}_{0}$ and $P$ also can be treated as the perturbation of $P_{0}$. One has

$$
P=\tilde{P}_{0}+\tilde{W}=P_{0}+V
$$

Here

$$
V=\tilde{V}-\frac{q(\theta)}{r^{2}}, \tilde{W}=V+W, W=\frac{\chi_{1}^{2}}{r^{2}} q(\theta)+\sum_{i=1}^{2}\left|\nabla \chi_{i}\right|^{2}
$$

Then $\tilde{W}$ is a continuous function and satisfies $|\tilde{W}| \leq C\langle x\rangle^{-\rho_{0}}$. $V$ has singularity at 0 . We study the asymptotic expansion of $(P-z)^{-1}$ for $z$ near $0, \mathfrak{J} z \neq 0$ in Chapter 3.

KNOWN RESULTS. Klaus-Simon [33] studied the asymptotic behavior of eigenvalue, $e_{i}(\lambda)$, of $H(\lambda)=-\Delta+\lambda V, \lambda$ near $\lambda_{0}$. $\lambda_{0}$ is the value at which $e_{i}(\lambda) \rightarrow 0$ as $\lambda \downarrow \lambda_{0}$. They got the leading term of $e_{i}(\lambda)$ using Birman-Schwinger kernel. The result depends on the dimension of the space. If the dimension of the space $n=3$,

$$
e_{i}(\lambda)=-c\left(\lambda-\lambda_{0}\right)^{2}+O\left(\left(\lambda-\lambda_{0}\right)^{3}\right)
$$

or

$$
e_{i}(\lambda)=-c\left(\lambda-\lambda_{0}\right)+O\left(\left(\lambda-\lambda_{0}\right)^{3 / 2}\right)
$$

and the ground state is in the first case. If $n \geq 5$, and $n$ is odd, then

$$
e_{i}(\lambda)=a\left(\lambda-\lambda_{0}\right)^{2}+O\left(\left(\lambda-\lambda_{0}\right)^{3}\right)
$$

If $n \geq 6$, and $n$ is even, then

$$
\begin{equation*}
e_{i}(\lambda)=\sum_{n=2}^{\infty} \sum_{m=0}^{\infty} c_{n m}\left[\left(\lambda-\lambda_{0}\right)^{1 / 2}\right]^{n}\left[\left(\lambda-\lambda_{0}\right)^{1 / 2} \ln \left(\lambda-\lambda_{0}\right)\right] . \tag{1.9}
\end{equation*}
$$

If $n=4$, then $e_{i}(\lambda)$ obeys (1.9) or

$$
e_{i}(\lambda)=\frac{q\left(\lambda-\lambda_{0}\right)}{\left[\ln \left(\lambda-\lambda_{0}\right)\right]^{2}}+\text { lower order term }
$$

Fassri-Klaus [20] also studied this problem for Schrödinger operator $-\Delta+V+\lambda W$ with $V$ periodic. They also used Birman-Schwinger kernel in their paper.

The operators of $P_{0}$ and $P$ have been studied by Carron [14] and X.P. Wang [69, 70]. In [14], Carron gave some properties of $\left(P_{0}-z\right)^{-1}$ for $z$ near 0 and got the formula for the jump at zero of the spectral shift function associated with the pair $\left(P_{0}, P\right)$. In [70], X.P. Wang gave the asymptotic expansion of $\left(P_{0}-z\right)^{-1}$ for $z$ near $0, \mathfrak{J} z \neq 0$ which is used to study the asymptotic expansion of $(P-z)^{-1}$ for $z$ near $0, \mathfrak{J} z \neq 0$. In [69], asymptotic expansion of $(P-z)^{-1}$ has been studied for $\mathfrak{J} z \neq 0, z$ near 0 .

OUR METHODS AND RESULTS. In the first part of Chapter 3, we use Birman-Schwinger kernel to study the asymptotic behavior of $e_{i}(\lambda)$ as $\lambda \downarrow \lambda_{0}$. To get the leading term of $e_{i}(\lambda)$ as $\lambda \downarrow \lambda_{0}$, we need to know the asymptotic expansion of $\left(P_{0}-\alpha\right)^{-1}$ for $\alpha$ near $0, \alpha<0$, which has been studied by X.P. Wang ([70]). We recall some results of $P_{0}$ and give some properties of Birman-Schwinger kernel, $|V|^{1 / 2}\left(P_{0}-z\right)^{-1}|V|^{1 / 2}$, in Section 3.2(Chapter 3). For the technical reason, we let $V \leq 0$ when we study the asymptotic behavior of discrete eigenvalues. We show that there exists a one-to-one correspondence between the discrete eigenvalues of $P(\lambda)$ and the discrete eigenvalues of

$$
K(\alpha)=|V|^{1 / 2}\left(P_{0}-\alpha\right)^{-1}|V|^{1 / 2}, \quad \alpha<0 .
$$

Therefore, we study discrete eigenvalues of $K(\alpha)$ in Section 3.3 (Chapter 3), and then get the asymptotic behavior of discrete eigenvalues of $P(\lambda)$. Our main result is the following :

Theorem 1.4. Assume $0 \notin \sigma_{\infty}$ and $n \geq 3$. Suppose that $e_{1}(\lambda)$ is the ground state energy (the smallest eigenvalue) of $P(\lambda)$. $\phi$ is some function in $L^{2}\left(\mathbb{R}^{n}\right)$. If $\rho_{0}>6$, one of three exclusive situations holds :
(a). If $\sigma_{1}=\emptyset$, then $e_{1}(\lambda)=-c\left(\lambda-\lambda_{0}\right)+o\left(\lambda-\lambda_{0}\right), c=\left(\lambda_{0}\left\|F_{0}|V|^{\frac{1}{2}} \phi\right\|\right)^{-2} \neq 0$;
(b). If $v_{0}=1$, then $\left.e_{1}(\lambda)=-c \frac{\lambda-\lambda_{0}}{\ln \left(\lambda-\lambda_{0}\right)}+o\left(\frac{\lambda-\lambda_{0}}{\ln \left(\lambda-\lambda_{0}\right)}\right), c=\left.\lambda_{0}^{-2}\langle\phi| V\right|^{,1 / 2} G_{1,0} \pi_{1}|V|^{1 / 2} \phi\right\rangle^{-1} \neq 0$;
(c). If $v_{0}<1$, then $\left.e_{1}(\lambda)=c\left(\left(\lambda-\lambda_{0}\right)^{\frac{1}{v_{0}}}\right)+o\left(\left(\lambda-\lambda_{0}\right)^{\frac{1}{v_{0}}}\right), c=\left.\lambda_{0}^{-2}\langle\phi| V\right|^{,1 / 2} G_{v_{0}, 0} \pi_{v_{0}}|V|^{1 / 2} \phi\right\rangle^{-1} \neq$ 0.

Similarly, we can get the asymptotic behavior of the other discrete eigenvalues of $P(\lambda)$. In Section 3.4, we use the fact that discrete eigenvalues, $\mu_{i}(\alpha)$, of $K(\alpha)$ are continuous and monotonous with respect to $\alpha$ to get the result for the multiplicity of 0 as the resonance of $P\left(\lambda_{0}\right)$. Here $\lambda_{0}$ is the value at which the smallest eigenvalue of $P(\lambda)$ converges to 0 .

Theorem 1.5. Suppose $\sum_{0<v \leq 1} n_{v}=m$. If $m>0$, then there exists $\lambda_{1}>\lambda_{0}$ such that for all $\lambda_{0}<\lambda<\lambda_{1}$, the number of eigenvalues, less than 0 , of $P(\lambda)$ is equal to the dimension of $\mathcal{N}\left(\lambda_{0}\right)$.

In Chapter 3, we also study the asymptotic expansion of $(P-z)^{-1}$ for $z$ near $0, \mathfrak{J} z \neq 0$, which is used to study the spectral shift function. X.P. Wang ([69]) has studied the asymptotic expansion of $\left(P_{0}+V-z\right)^{-1}$ with $V$ satisfying $|V| \leq C_{\alpha}\langle x\rangle^{-\rho_{0}}$. Since our $V=\tilde{V}-\frac{q(\theta)}{r^{2}}$ with $\tilde{V}$ satisfying the condition (1.7), we can not use X.P. Wang's result directly. Note $\frac{\chi_{1}^{2}}{r^{2}} q(\theta) \in$ $\mathcal{L}(1,-s ;-1, s), \forall s>0$ for $n \geq 3$. We can use X.P. Wang's method to get the asymptotic expansion of $(P-z)^{-1}$. For $z \in \mathbb{C} \backslash \mathbb{R}, z$ near 0 , we have

$$
\left(P_{0}-z\right)^{-1}(P-z)=1+F(z)
$$

with

$$
F(z)=\left(P_{0}-z\right)^{-1} V
$$

In Section 3.5 (Chapter 3), we prove that $1+F(0)$ is a Fredholm operator in $\mathcal{L}(1,-s ; 1,-s)$. Let $\mathcal{N}=\left\{u ; P u=0, u \in H^{1,-s}, \forall s>1\right\}$. If $\mathcal{N}=\{0\}$, then $(1+F(z))^{-1}$ exists for $z$ near $0, \mathfrak{J} z \neq 0$. We can get the asymptotic expansion of $(P-z)^{-1}$ by formula $(P-z)^{-1}=(1+F(z))^{-1}\left(P_{0}-z\right)^{-1}$. If $\mathcal{N} \neq\{0\}$, we solve a Grushin problem associated to $P-z$, and get that

$$
(P-z)^{-1}=E(z)-E_{+}(z) E_{+-}(z)^{-1} E_{-}(z)
$$

for $z$ near 0 . Here $E(z), E_{+}(z), E_{-}(z)$ are holomorphic near 0 . Hence, the main task is to study the asymptotic expansion of $E_{+-}(z)^{-1}$ near 0 . Note $\frac{\chi_{1}^{2}}{r^{2}} q(\theta) \notin \mathcal{L}(1,-s ; 1,-s)$ for $n=2$. Therefore, we can not get the expansion of $(P-z)^{-1}$ by this method for $n=2$.

### 1.3 Low-energy asymptotic of the spectral shift function for perturbation with critical decay

PROBLEMS. In Chapter 4, we study the spectral shift function. The spectral shift function was introduced in 1952 by the physicist I. M. Lifshitz in paper [41] as a trace perturbation formula in quantum mechanics. Its mathematical theory was created by M. G. Krein. Let $P, P_{0}$ be a pair of self-adjoint operators in some separable Hilbert space $H$. M. G. Krein proved in [36] that if
$V=P-P_{0}$ is a trace class operator, then $\forall f \in \mathcal{S}(\mathbb{R}), f(P)-f\left(P_{0}\right)$ is of trace class and there exists some function $\xi \in L^{1}(\mathbb{R})$, called spectral shift function, such that

$$
\begin{equation*}
\operatorname{Tr}\left(f(P)-f\left(P_{0}\right)\right)=-\int_{\mathbb{R}} f^{\prime}(\lambda) \xi(\lambda) d \lambda, \quad \forall f \in \mathcal{S}(\mathbb{R}) \tag{1.10}
\end{equation*}
$$

Then it was extended by him in [37] (see [38], for a more complete exposition) to operators $P_{0}, P$ with a trace class difference $R(z)-R_{0}(z)$. Here $R_{0}(z)=\left(P_{0}-z\right)^{-1}$ and $R(z)=(P-z)^{-1}$. Yafaev ([73]) proved that if there exists some $c$ such that $P+c I$ and $P_{0}+c I$ are positive and there exists some $k \in \mathbb{N}^{*}$,

$$
\begin{equation*}
\left\|(P+c I)^{-k}-\left(P_{0}+c I\right)^{-k}\right\|_{t r}<\infty \tag{1.11}
\end{equation*}
$$

then $f(P)-f\left(P_{0}\right)$ is of trace class and there exists some function $\xi \in L_{l o c}^{1}(\mathbb{R})$, such that (1.10) holds. The right hand side of (1.10) can be interpreted as $\left\langle f, \xi^{\prime}\right\rangle$, where $\xi^{\prime}$ is the derivative of $\xi$ in the sense of distributions. For simplicity we assume that $P_{0}, P$ are bounded below. By the Birman-Krein theory ([6]), $\xi$ is related with the scattering phase, $\rho(\lambda)=\arg \operatorname{det} S(\lambda)$, by the formula

$$
\rho(\lambda)=2 \pi \xi(\lambda), \quad \bmod 2 \pi \mathbb{Z}
$$

and

$$
\xi^{\prime}(\lambda)=\frac{1}{2 \pi} \operatorname{Tr} T(\lambda)
$$

where $T(\lambda)=-i S(\lambda)^{*} \frac{d}{d \lambda} S(\lambda)$ is the Eisenbud-Wigner formula for the time-delay operator.
Let $0 \leq \chi_{1} \leq 1$ be a smooth function on $\mathbb{R}^{n}$ such that $\chi_{1}(x)=1$ for $|x| \leq R$, supp $\chi_{1} \subset$ $\left\{x ;|x| \leq R_{1}\right\}$ for some $R_{1}>R>0$ and $\chi_{1}^{2}+\chi_{2}^{2}=1$. Let $P_{0}=\chi_{1}(-\Delta) \chi_{1}+\chi_{2}\left(-\Delta+\frac{q(\theta)}{r^{2}}\right) \chi_{2}$ and $P=P_{0}+V$ with $V$ satisfying

$$
\begin{equation*}
\left|\partial_{x}^{\alpha} V(x)\right| \leq C_{\alpha}\langle x\rangle^{-\rho-|\alpha|} \tag{1.12}
\end{equation*}
$$

for some $\rho>2$. We study the spectral shift function, $\xi(\lambda)$, of the pair $\left(P_{0}, P\right)$.
We are mainly interested in the low-energy asymptotics of the derivative of the spectral shift function. We use the asymptotic expansion of $R_{0}(z)=\left(P_{0}-z\right)^{-1}$ and $R(z)=(P-z)^{-1}$ for $\mathfrak{J} z \neq 0, z$ near 0 , to study the asymptotic behavior of $\xi^{\prime}(\lambda)$ for $\lambda$ near 0 . After that, we use this result to prove the Levinson's Theorem. The Levinson's theorem is a fundamental theorem in quantum scattering theory, which shows the relation between the number of bound states and the phase shift at zero momentum. Levinson first established and proved this theorem in [39] for the Schrödinger equation with a spherically symmetric potential $V(r)$.

KNOWN RESULTS. The spectral shift function for Schrödinger operators has been studied by many authors (see for example [1],[11],[12],[47], [49],[50],[73] ). High-energy asymptotics of the spectral shift function was studied in these paper. The result got by Robert in [49] is the following : assume $\left|\partial_{x}^{\alpha} V\right| \leq C_{\alpha}\langle x\rangle^{-\rho-|\alpha|}$ with $\rho>n$, then the spectral shift function, $\xi(\lambda)$, for the pair $(-\Delta, \Delta+V)$ satisfying :
(i). $\xi(\lambda)$ is $C^{\infty}$ in $(0, \infty)$.
(ii). $\frac{d^{k}}{d \lambda^{k}} \xi(\lambda)$ has a complete asymptotic expansion for $\lambda \rightarrow \infty$,

$$
\frac{d^{k}}{d \lambda^{k}} \xi(\lambda) \sim \lambda^{n / 2-k-1} \sum_{j \geq 0} \alpha_{j}^{(k)} \lambda^{-j}
$$

Levinson's theorem has been studied by many authors (see [8],[42], [32],[18] and references therein). In [8], Bolle got the Levinson's theorem for $V$ satisfying $\langle x\rangle^{n} V \in L^{1}\left(\mathbb{R}^{d}\right)(d=1,2,3)$ for appropriate $n$, and $V \in L^{4 / 3}\left(\mathbb{R}^{2}\right)$ for $d=2$, such that the absence of positive embedded eigenvalues and of the singular continuous spectrum of $-\Delta+V$ is guaranteed. Levinson's theorem for the nonlocal interaction in one dimension was studied in [18].

OUR METHODS AND RESULTS. In Chapter 4, we use the asymptotic expansion of ( $P_{0}-$ $z)^{-1}$ and $(P-z)^{-1}$ for $z$ near $0, \mathfrak{J} z \neq 0$ to study the low-energy asymptotics of the derivative of the spectral shift function.

Our main result is the following :
Theorem 1.6. Suppose $n \geq 3$ and $0 \notin \sigma_{\infty}$. If (1.12) holds for $\rho>\max \{6, n+2\}$, one has

$$
\xi^{\prime}(\lambda)=J_{0} \delta(\lambda)+g(\lambda)
$$

with $|g(\lambda)|=O\left(\lambda^{-1+\epsilon_{0}}\right)$ for some $\epsilon_{0}>0$, as $\lambda \downarrow 0$. Here $J_{0}=N_{0}+\sum_{j=1}^{k_{0}} \varsigma_{j} m_{j}$ where $N_{0}$ is the multiplicity of zero as eigenvalues of $P$ and $m_{j}$ the multiplicity of $\varsigma_{j}$-resonance of zero.

Using this Theorem and the asymptotic expansion of $\xi^{\prime}(\lambda)$ for $\lambda$ large (see [49]), we can get the Levinson's Theorem.

Theorem 1.7. Suppose $n \geq 3$ and $0 \notin \sigma_{\infty}$. If (1.12) holds for $\rho>n+3$, one has

$$
\begin{equation*}
\int_{0}^{\infty}\left(\xi^{\prime}(\lambda)-\sum_{j=1}^{\left[\frac{n}{2}\right]} c_{j} \lambda^{\left[\frac{n}{2}\right]-1-j}\right) d \lambda=-\left(N+J_{0}\right)+\beta_{n / 2} \tag{1.13}
\end{equation*}
$$

$\beta_{n / 2}$ depends on $n$ and $V$ and $\beta_{n / 2}=0$ if $n$ is odd.

## 2 - Semi-Classical limits of the number and Riesz means of discrete eigenvalues of the N -body Schrödinger operators

### 2.1 Introduction

In this chapter, we consider the $N$-body system of $v$-dimensional $(v \geq 3)$ particles on $L^{2}\left(\mathbb{R}^{(N-1) v}\right)$ :

$$
\begin{aligned}
& H=H_{0}+V \\
& V=\sum_{i<j} V_{i j}\left(r_{i}-r_{j}\right), r_{i} \in \mathbb{R}^{v} .
\end{aligned}
$$

Here $H_{0}$ is the operator resulting from removing the center of mass from $\sum_{i=1}^{N}-\left(2 m_{i}\right)^{-1} \Delta_{i} . m_{i}$ is the mass of the $i-$ th particle, $\Delta_{i}$ is the Lpalacian in the $r_{i}$ variables. We discuss the semi-classical limits of the number and the Riesz means of discrete eigenvalues of $N$-body Schrödinger operators $H(h)=h^{2} H_{0}+V$.

The semi-classical limit of the number of discrete eigenvalues has been studied by many authors for $N=2$ (see [4], [31], [40], [44], [54], [68]). Roughly speaking, in the case of 3dimensional space, $\mathbb{R}^{3}$, the result obtained by these authors can be formulated as following : assume that $V(x)$ is real and $V(x) \in L^{3 / 2}\left(\mathbb{R}^{3}\right)$, the number of discrete eigenvalues less than 0 , $N(\lambda)$, of $-\Delta+\lambda V$ obeys the asymptotic formula :

$$
N(\lambda)=\left(6 \pi^{2}\right)^{-1} \int\left|V_{-}(x)\right|^{3 / 2} d x(1+o(1)), \quad \lambda \rightarrow \infty .
$$

Here $V_{-}(x)=\min \{0, V(x)\}$. The remainder term in the result of Tamura is $O\left(\lambda^{-1 / 2}\right)$ under the condition $V(x) \in C^{\infty}\left(\mathbb{R}^{3} \backslash\{0\}\right), V(x) \sim|x|^{-d}, 0 \leq d<2,\left|\partial_{x}^{\alpha} V(x)\right| \leq C_{\alpha} V(x)|x|^{|\alpha|} \mid$ for $|x| \leq 1$ and $|V(x)| \leq C\langle x\rangle^{-m}, m>2,\left|\partial_{x}^{\alpha} V(x)\right| \leq C_{\alpha} V(x)\langle x\rangle^{-l|\alpha|}, 3-m<l \leq 1$, for $|x| \geq 1$. For the proof [4] and [44] use the min-max principle combined with a technique of Dirichlet-Neumann bracketing while [31],[40] and [54] use the Feyman-Kac formula. Tamura [68] uses pseudodifferential operators and Fourier integral operators to study this problem for $N=2$. The semiclassical limit of discrete eigenvalues for the 3-body Schrödinger operator has been studied by

Klaus-Simon (see [34]). The main tool they used in that paper is Birman-Schwinger kernel. Their result is the following : Assume $v \geq 3, V \leq 0, V_{i j} \in C_{0}^{\infty}(1 \leq i<j \leq 3)$. Denote $a_{i j}=\min _{x \in \mathbb{R}^{v}} V_{i j}(x), \Sigma_{c l}=\min _{i, j} a_{i j}$. If there exists only one $a_{i j}$, such that $a_{i j}=\Sigma_{c l}$, then the number of discrete eigenvalues, $N(\mu)$, of $-\mu \Delta+\sum_{1 \leq i<j \leq 3} V_{i j}$ on $L^{2}\left(\mathbb{R}^{2 v}\right)$ obeys the asymptotic formula :

$$
\lim _{\mu \rightarrow 0} \mu^{v} N(\mu)=\tau_{2 v}(2 \pi)^{-2 v} \int_{V(x) \leq \Sigma_{c l}}\left[\Sigma_{c l}-V(x)\right]^{v} d x
$$

Here $\tau_{v}$ is the volume of the unit sphere in $\mathbb{R}^{2 v}$.
Semi-classical limit of Riesz means of discrete eigenvalues of Schrödinger operator $P(h)=$ $-h^{2} \Delta+V$ has been studied by Helffer and Robert [23], Bruneau [9]. Let $\Sigma=\underset{|x| \rightarrow \infty}{\lim } V(x)$. They studied semi-classical limit of Riesz means of discrete eigenvalues less than $\lambda_{0}$. Here $\lambda_{0}$ is a constant less than $\Sigma$. They used pseudo-differential operators to get the asymptotic expansion of

$$
R_{\gamma}(h, \lambda)=\sum_{e_{j}(h) \leq \lambda}\left(\lambda-e_{j}(h)\right)^{\gamma}
$$

for $\lambda<\lambda_{0}$ as $h \rightarrow 0 . e_{j}(h)$ is the discrete eigenvalue of $P(h)$. They did not get the semi-classical limit of Riesz means of all bound states of $P(h)$.

Here is the plan of this chapter. We use the Birman-Schwinger kernel to study the number of discrete eigenvalues of the N -body Schrödinger operator $H(h)$. For the unique two-cluster Schrödinger operator, we introduce a suitable Birman-Schwinger kernel in Section 2.2 and recall the results of the Birman-Schwinger kernel. In Section 2.3, we use these results to discuss the semi-classical limit of the number of discrete eigenvalues of the unique two-cluster Schrödinger operator $H(h)$. The result we get is the following : if V's lie in $C^{2}\left(\mathbb{R}^{n}\right)$, and are negative, $\left|V_{i j}\right| \leq C\langle x\rangle^{-\rho}$ with some $\rho>2$, then

\begin{equation*}
N(h)=h^{-(N-1) v} \tau_{(N-1) v}(2 \pi)^{-(N-1) v / 2} \int_{V(x) \leq \Sigma_{c l}}\left[\Sigma_{c l}-V(x)\right]^{(N-1) v / 2} d x(1+O(1)) \tag{2.1}
\end{equation*}
$$

for $v \geq 3$. Here $N(h)$ is the number of eigenvalues of $H(h)$ in $\left(-\infty, \Sigma_{h}\right)$. The number of eigenvalues of $H(h)$ in $\left(-\infty, \Sigma_{c l}\right)$ is standard Dirichlet-Neumann bracketing [53, Section 8.15]. The difficulty is to estimate the number of discrete eigenvalues in $\left(\Sigma_{c l}, \Sigma_{h}\right)$. In Section 2.4, we use Dirichlet-Neumann bracketing to study the semi-classical of the Riesz means of discrete eigenvalues of $H(h)$. The result we get is following : Assume $v \geq 3, H_{0}=-h^{2} \Delta$ on $L^{2}\left(\mathbb{R}^{(N-1) v}\right)$ and (1.5) holds, then the Riesz means of discrete eigenvalues of $H(h)$ obeys the following estimate

\begin{equation*}
R_{\gamma}\left(h, \Sigma_{h}\right)=C(\gamma, v) h^{-(N-1) v} \int_{\left\{x ; V(x) \leq \Sigma_{c l}\right\}}\left(\Sigma_{c l}-V(x)\right)^{\gamma+\frac{(N-1) v}{2}} d x\left(1+O\left(h^{t}\right)\right) \tag{2.2}
\end{equation*}
$$

where $C(\gamma, v)=(2 \pi)^{-(N-1) v} \tau_{(N-1) v} C_{\gamma,(N-1) v}, C_{\gamma,(N-1) v}=\gamma \int_{0}^{1} \beta^{\gamma-1}(1-\beta)^{n / 2} d \beta$ and $\tau_{(N-1) v}$ is the volume of the unit sphere in $\mathbb{R}^{(N-1) v}, t=\min \left\{\frac{1}{2}, \gamma\right\}$. In Section 2.5 , we study the N -body Schrödinger operator with Coulomb potential. We get the asymptotic expansion of the effective potential, $I_{e f f}(\rho)$, for $|\rho| \rightarrow \infty$.

### 2.2 A Birman-Schwinger kernel for the $N$-body Schrödinger operator

Consider a general $N$-body system of $v$-dimensional particles. $H$ is an operator on $L^{2}\left(\mathbb{R}^{v(N-1)}\right)$ :

\end{equation*}

Here $H_{0}$ is the operator resulting from removing the center of mass from $\sum_{i=1}^{N}-\left(2 m_{i}\right)^{-1} \Delta_{r_{i}}$ and

$$
\begin{equation*}
V=\sum_{i<j} V_{i j}\left(r_{i}-r_{j}\right) \tag{2.4}
\end{equation*}
$$

Here $r_{j}$ and $m_{j}>0$ denote the position and the mass of the $j$-th particle respectively, $-\Delta_{r_{i}}$ is the Laplacian in the $r_{i}$ variables. In this chapter, we suppose

$$
\begin{equation*}
V_{i j} \leqslant 0, \tag{2.5}
\end{equation*}
$$

and normally we suppose

$$
\begin{equation*}
V_{i j} \in C^{2}\left(\mathbb{R}^{v}\right), \text { and }\left|V_{i j}(x)\right| \leq C\langle x\rangle^{-\epsilon_{0}}, \text { with } \epsilon_{0}>2 \tag{2.6}
\end{equation*}
$$

Condition (2.5) considerably simplifies the arguments since the Birman-Schwinger kernel is self-adjoint when (2.5) holds. But most results should hold without (2.5). Condition (2.6) is similarly made for technical convenience. We begin this section with introducing some notations. NOTATION : Let $C_{i}(i=1, \cdots, k)$ be the subsets of $\{1, \cdots, N\}$. If $C_{i} \cap C_{j}=\emptyset, i \neq j$ and $\cup_{i=1}^{k} C_{i}=\{1, \cdots, N\}$, we say that $D=\left\{C_{1}, \cdots, C_{k}\right\}$ is a partition (or cluster decomposition) of $\{1, \cdots, N\}$. If $D=\left\{C_{1}, \cdots, C_{k}\right\}$, we denote $\# D=k$. If $i, j$ are two numbers in $\{1, \cdots, N\}$, we write $i D j$ if and only if $i$ and $j$ are in the same cluster $C_{l}$, and $\sim i D j$ if they are in the different clusters. Let $\sum_{i D j}$ (resp. $\sum_{\sim i D j}$ ) denote the sum over all pairs with $i, j$ in the same (resp. different ) cluster of $D$. We define

V_{D}=\sum_{i D j} V_{i j} ; \quad I_{D}=\sum_{\sim i D j} V_{i j} ; \\
H_{D}=H-I_{D} ; \quad \Sigma_{D}=\inf \sigma\left(H_{D}\right) \\
a_{D}=\min _{\left\{x ; x \in \mathbb{R}^{(N-1) v}\right\}} V_{D}(x) ; \quad \Sigma_{c l}=\min _{\{D ; \# D \geq 2\}} a_{D}
\end{gathered}
$$

For each $D$, there is a natural decomposition of $\mathscr{H}=L^{2}\left(\mathbb{R}^{(N-1) v}\right)$ as $\mathscr{H}^{D} \otimes \mathscr{H}_{D}$ with $\mathscr{H}_{D}=$ functions of $r_{i j}$ with $i D j$ and $\mathscr{H}^{D}=$ functions of $R_{q}-R_{l}$ where $R_{q}=\sum_{i \in C_{q}} m_{i} r_{i} / \sum_{i \in C_{q}} m_{i}$ is the center of the mass of $C_{q}$. Under this decomposition

H_{D}=h_{D} \otimes 1+1 \otimes t_{D}
$$

By the HVZ-theorem [54, Section XIII. 5 ],

$$
\begin{equation*}
\inf \sigma_{e s s}(H)=\Sigma \tag{2.7}
\end{equation*}
$$

where $\Sigma=\min _{D} \Sigma_{D}$. We say that $H$ is unique two-cluster, if there is only one $D$ with $\# D \geq 2$, such that $\Sigma=\Sigma_{D}$. The intuition is quite simple : if the continuum is two-cluster, the threshold is basically due to a $v$-dimensional Laplacian, namely the relative kinetic energy of the two clusters. So one expects the coupling constant behavior to be a $v$-dimensional problem. We will concentrate on the unique two-cluster $N$-body Schrödinger operators.

By the hypothesis of unique two-cluster, we know that there exists a decomposition $D$ with $\#(D) \equiv k \neq 1$ such that

$$
\begin{equation*}
\Sigma_{D}<\Sigma_{D^{\prime}} \tag{2.8}
\end{equation*}
$$

for all $D^{\prime} \neq D$ with $\#\left(D^{\prime}\right) \neq 1$. It is easy to see that $(2.8)$ can only hold if \# $(D)=2$ ( since $\Sigma_{D_{1}} \leq \Sigma_{D_{2}}$ if $D_{2}$ is a refinement of $D_{1}$ written $D_{1}<D_{2}$ ). If (2.8) holds, then $h_{D}$ must have an eigenvalue at the bottom of its spectrum ([54, Section XIII.12] since inf $\sigma_{\text {ess }}\left(h_{D}\right)=$ $\min \left(\Sigma_{D^{\prime}} \mid D<D^{\prime}, D \neq D^{\prime}\right)$ by the HVZ-Theorem) and this eigenvalue will be simple. Thus, we pick once and for all a vector $\eta \in \mathscr{H}_{D}$ with $\|\eta\|=1$ and

h_{D} \eta=\Sigma_{D} \eta \tag{2.9}
\end{equation*}
$$

Let $p$ be the projection in $\mathscr{H}_{D}$ onto $\eta$ and $P=p \otimes 1$, the projection in $\mathscr{H}$. We define $q=$ $1-p, Q=1-P$. It follows that

\begin{equation*}
\sigma\left(H_{D} \uparrow Q \mathscr{H}\right)=\left[\Sigma^{\prime}, \infty\right) . \tag{2.10}
\end{equation*}
$$

with

$$
\begin{equation*}
\Sigma^{\prime}>\Sigma \equiv \min _{D^{\prime}} \Sigma_{D^{\prime}}=\Sigma_{D} \tag{2.11}
\end{equation*}
$$

since $\Sigma_{D}$ is the simple eigenvalue of $h_{D}$.
We define the Birman-Schwinger kernel by :

\begin{equation*}
K(E)=\left|I_{D}\right|^{1 / 2}\left(H_{D}-E\right)^{-1}\left|I_{D}\right|^{1 / 2} \tag{2.12}
\end{equation*}
$$

for $E<\Sigma$. In the following we recall some results for the Birman-Schwinger kernel. These results have been studied by Klaus-Simon for $V_{i j} \in C_{0}^{\infty}$. In fact, these results are also true for $V_{i j}$ satisfying (2.6).

Proposition 2.1. (Proposition 2.1 and Proposition 2.2 [34]) Let $E<\Sigma$. Then $E \in \sigma\left(H_{D}+\mu I_{D}\right)$ if and only if $\mu^{-1} \in \sigma(K(E))$. This result remains true if $\sigma$ is replaced by $\sigma_{\text {ess }}$ in both places. Moreover, the multiplicity of $E$ as an eigenvalue of $H_{D}+\mu_{0} I_{D}$ is exactly the multiplicity of $\mu_{0}^{-1}$ as an eigenvalue of $K(E)$.

Remark 2.2. This result is from Proposition 2.1 and Proposition 2.2 [34]. In fact, they did not use the condition $V_{i j} \in C_{0}^{\infty}$ in the proof.

Proof. Write

$$
H_{D}+\mu I_{D}-E=\left(H_{D}-E\right)\left(1+\mu\left(H_{D}-E\right)^{-1} I_{D}\right)
$$

We conclude that (since $\left.E \notin \sigma\left(H_{D}\right)\right), E \in \sigma\left(H_{D}+\mu I_{D}\right)$ if and only if

$$
\mu^{-1} \in \sigma\left(-\left(H_{D}-E\right)^{-1} I_{D}\right)=\sigma\left(\left(H_{D}-E\right)^{-1}\left|I_{D}\right|\right)=\sigma(K(E))
$$

The last equality follows from the well-known fact (see eg.[16]) that $\sigma(A B) \backslash\{0\}=\sigma(B A) \backslash\{0\}$ for any bounded operators $A, B$.

If $E \in \sigma_{\text {ess }}\left(H_{D}+\mu_{0} I_{D}\right)$, then since $\sigma_{\text {ess }}\left(H_{D}+\mu I_{D}\right)=\left[\Sigma_{\mu}, \infty\right)$ with $\Sigma_{\mu}$ decreasing in $\mu, E \in$ $\sigma_{\text {ess }}\left(H_{D}+\mu I_{D}\right)$ for all $\mu \geqslant \mu_{0}$, so $\left[0, \mu_{0}^{-1}\right) \subset \sigma(K(E))$ which implies that $\mu_{0}^{-1} \in \sigma_{\text {ess }}(K(E))$. If $E \notin \sigma_{\text {ess }}\left(H_{D}+\mu_{0} I_{D}\right)$, then, we claim that for some $\delta>0, E \notin \sigma\left(H_{D}+\mu I_{D}\right)$ for $\mu \in$ $\left(\mu_{0}-\delta, \mu_{0}+\delta\right) \backslash\left\{\mu_{0}\right\}$. This is obvious if $E \notin \sigma\left(H_{D}+\mu_{0} I_{D}\right)$ and if $E \in \sigma_{d i s c}\left(H_{D}+\mu_{0} I_{D}\right), E \notin$ $\sigma_{\text {disc }}\left(H_{D}+\mu I_{D}\right)$ for $\mu$ near $\mu_{0}$, since discrete eigenvalues of $H_{D}+\mu I_{D}$ are strictly monotonous in $\mu$. It follows that $\mu^{-1}$ is either not in $\sigma(K(E))$ or is an isolated point of $\sigma(K(E))$. In the later case, we must show that the multiplicity of $\mu_{0}^{-1}$ as an eigenvalue of $K(E)$ is finite. But if $K(E) \psi=\mu_{0}^{-1} \psi$, then $\left(H_{D}+\mu I_{D}-E\right) \phi=0$ with

$$
\phi=\left(H_{D}-E\right)^{-1}\left|I_{D}\right|^{1 / 2} \psi
$$

since

$$
\left(H_{D}+\mu I_{D}-E\right) \phi=\left|I_{D}\right|^{1 / 2}(1-\mu K(E)) \psi
$$

Since $\left(H_{D}-E\right)^{-1}\left|I_{D}\right|^{1 / 2} \upharpoonright\left\{\psi \mid K(E) \psi=\mu_{0}^{-1} \psi\right\}$ has no kernel, this shows that the multiplicity of $\mu_{0}^{-1}$ is at most the multiplicity of $E$ as an eigenvalue of $H_{D}+\mu I_{D}$. Notice that if $\left(H_{D}+\mu I_{D}-E\right) \phi=0$, then

$$
\psi=\left|I_{D}\right|^{1 / 2} \phi
$$

satisfies $K(E) \psi=\mu_{0}^{-1} \psi$. Since $\left|I_{D}\right|^{1 / 2}$ is non-vanishing on such $\phi$ (since $\operatorname{ker}\left(H_{D}-E\right)=\{0\}$ ). This ends the proof.

In the proof of the proposition, we noted that $\sigma_{e s s}\left(H_{D}+\mu I_{D}\right)=\left[\Sigma_{\mu}, \infty\right)$ with $\Sigma_{\mu}$ monotone in $\mu$. It follows that :

Proposition 2.3. (Proposition 2.3 [34]) Let $E<\Sigma$. Then $\sigma_{\text {ess }}(K(E))=[0, \Lambda(E)]$ where $\Lambda(E)=\sup _{\lambda}\left\{\lambda ; E \in \sigma_{\text {ess }}\left(H_{D}+\lambda^{-1} I_{D}\right)\right\}$.

For later reference, it is useful to show that $K(E)$ has a norm limit as $E \uparrow \Sigma$. To see this, we decompose $K(E)$ as $K(E)=K_{P}(E)+K_{Q}(E)$ with

$$
\begin{aligned}
& K_{P}(E)=\left|I_{D}\right|^{1 / 2}\left(H_{D}-E\right)^{-1} P\left|I_{D}\right|^{1 / 2} \\
& K_{Q}(E)=\left|I_{D}\right|^{1 / 2}\left(H_{D}-E\right)^{-1} Q\left|I_{D}\right|^{1 / 2}
\end{aligned}
$$

where $P, Q$ are the projections introduced before (2.10). Before analyzing $K(E)$, we need to introduce two definitions first.

Definition 2.4. Let A be a compact operator, and all of the singular values of $A$ are denoted by $\left\{\mu_{i}(A)\right\}$ with $\mu_{1}(A) \geqslant \mu_{2}(A) \geqslant \mu_{3}(A) \geqslant \cdots$. We say that $A \in \mathscr{S}_{r}, r \geq 1$, if

$$
\|A\|_{r}=\left(\sum_{i} \mu_{i}(A)^{r}\right)^{1 / r}<\infty
$$

We say that $A \in \mathscr{S}_{p}^{w}, p>1$, if

$$
\|A\|_{p, w}=\sup _{n} n^{(-1+1 / p)} \sum_{j=1}^{n} \mu_{j}(A)<\infty .
$$

From the definition, it is easy to see that $\|A\| \leq\|A\|_{r}$ and $\|A\| \leq\|A\|_{p, w}$.
We want to consider the operators on $L^{2}\left(\mathbb{R}^{\nu}\right)$ formally given by $f(x) g(-i \nabla)$. First, we need to the give the definition of these operators (see [60] for details). If $f$ and $g$ are a.e. finite measurable function on $\mathbb{R}^{v}$, the sets $D_{f}$ and $D_{g}$ in $L^{2}$ given by $D_{f}=\left\{h \in L^{2} ; f h \in L^{2}\right\}$, $D_{g}=\left\{h \in L^{2} ; g h \in L^{2}\right\}$ are dense in $L^{2}$. For $\phi \in D_{f}$ and $\mathscr{F}(\psi) \in D_{g},(\mathscr{F}$ denote Fourier transform), we can unambiguously define $\langle\phi, A \psi\rangle$ with $A$ given formally by $f(x) g(-i \nabla)$ as the inner product of $f \phi$ and $\mathscr{F}^{-1}(g \mathscr{F} \psi)\left(\mathscr{F}^{-1}\right.$ denote inverse Fourier transform). Some of the most celebrated estimates in analysis assert that $A$ is a bounded operator (to be pedantic, there is a bounded operator $A$ with $\langle\phi, \tilde{A} \psi\rangle=\langle\phi, A \psi\rangle$ for $\phi \in D_{f}, \psi \in D_{g}$; henceforth, we will be sloppy about this point). For example, if $g(-i \nabla)=(-\Delta)^{-1}$, then $\mathscr{F}^{-1}(g \mathscr{F} \psi)=h * \psi$ with $h=c_{\nu}|x|^{-v+2}$ for $v \geq 3$. Thus using Holder's inequality $(2<p<\infty)$,

\begin{equation*}
\|f(h * \psi)\|_{2} \leq C_{p}\|f\|_{p}\|h\|_{p^{\prime}, w}\|\psi\|_{2} \tag{2.13}
\end{equation*}
$$

Here $p^{\prime}=\frac{p}{p-1}$ and $\|\cdot\|_{p^{\prime}, w}$ is the norm of $L_{w}^{p}$. Under this definition, we have the following result.
Theorem 2.5. ([60, Theorem 4.2],) If $f \in L^{p}$ and $g \in L_{w}^{p}$ with $2<p<\infty$, then $f(x) g(-i \nabla)$ is in $\mathscr{S}_{p}^{w}$ and

$$
\|f(x) g(-i \nabla)\|_{p, w} \leq C_{p}\|f\|_{p}\|g\|_{p, w}
$$

We use this theorem to study $K_{P}(E)$.
Proposition 2.6. (1). $K_{Q}(E)$ has an analytic continuation to $\mathbb{C} \backslash\left[\Sigma^{\prime},+\infty\right)$. In particular, on account of (2.11), $K_{Q}(E)$ has a norm limit as $E \uparrow \Sigma$.
(2). Let $v \geq 3$ and let $r>v / 2$. Then for all $E<\Sigma, K_{P}(E)$ is in the trace ideal $\mathscr{S}_{r}^{w}$ and as $E \uparrow \Sigma, K_{P}(E)$ converges to an operator $K_{P}(\Sigma)$ in $\mathscr{S}_{r}^{w}$ norm.

Proof : (1). This result is directly from (2.10) and (2.11).
(2). We use Theorem 2.5 to prove this result. We first prove the operator $K_{P}(\Sigma)$ is in $\mathscr{S}_{r}^{w} . K_{P}(E) \in \mathscr{S}_{r}^{w}$ with $E<\Sigma$ can be proved in the similar way. We need only to prove $\left(H_{D}-\Sigma\right)^{-1 / 2} P\left|I_{D}\right|^{1 / 2}$ is in $\mathscr{S}_{2 r}^{w}$. Since $\left|I_{D}\right|^{1 / 2}\left(\sum_{\sim i D j}\left(V_{i j}^{1 / 2}\right)^{-1}\right)$ is multiplication by a function bounded by 1 , it suffices to show the required fact for $\left(H_{D}-E\right)^{-1 / 2} P\left|V_{i j}\right|^{1 / 2}$ with $\sim i D j$. Since

\left(H_{D}-\Sigma\right)^{-1 / 2} P\left|V_{i j}\right|^{1 / 2}=t_{D}^{-1 / 2} P\left|V_{i j}\left(r_{i}-r_{j}\right)\right|^{1 / 2}
$$

and $r_{i}-r_{j}=R+\rho$ with $R=R_{c_{1}}-R_{c_{2}}$ and $\rho$ an "internal coordinate". By Theorem 2.5 , we know the operator $\left(t_{D}\right)^{-1 / 2}\langle R\rangle^{-s} \in \mathscr{S}_{v}^{w}\left(L^{2}\left(\mathbb{R}^{v} ; R\right)\right)$ if $s>1$. So $\left(t_{D}\right)^{-1 / 2}\langle R\rangle^{-s} P \in \mathscr{S}_{t}^{w}$ for all $t>v$ by the definition of $\mathscr{S}_{p}^{w}$. We need only to prove that $\langle R\rangle^{s} P\left|V_{i j}\right|^{1 / 2}$ is a bounded operator. Then it suffices to show that $\left(\langle R\rangle^{s} P\left|V_{i j}\right|^{1 / 2}\right)^{*}=\left|V_{i j}\right|^{1 / 2}\langle R\rangle^{s} P$ is a bounded operator.

For each $u \in L^{2}\left(\mathbb{R}^{(N-1) v}\right)$,

$$
\left|V_{i j}\right|^{1 / 2}\langle R\rangle^{s} P u(\zeta, \rho)=\int\left|V_{i j}\right|^{1 / 2}(\zeta, \rho)\langle R\rangle^{s} \eta(\zeta) \eta\left(\zeta^{\prime}\right) u\left(\zeta^{\prime}, R\right) d \zeta^{\prime} .
$$

(i) If $R \sim \rho$, we have

$$
\left.\left|\langle R\rangle^{s} \eta\left(\zeta^{\prime}\right) \eta(\zeta)\right| V_{i j}(R+\rho)\right|^{1 / 2}\left|\leq\left|C\langle\rho\rangle^{s} \eta\left(\zeta^{\prime}\right) \eta(\zeta)\right|\right.
$$

with $C$ be a constant independent of $R$.
(ii) If $R \gtrsim \rho$, since $\left|V_{i j}(x)\right| \leq C\langle x\rangle^{-\epsilon_{0}}$, we know $\left|V_{i j}(R+\rho)\right|^{1 / 2} \leq C\langle R\rangle^{-\epsilon_{0} / 2}$. Then, we can get

$$
\left.\left|\langle R\rangle^{s} \eta\left(\zeta^{\prime}\right) \eta(\zeta)\right| V_{i j}(R+\rho)\right|^{1 / 2}\left|\leq C\langle R\rangle^{\left(s-\epsilon_{0} / 2\right)}\right| \eta\left(\zeta^{\prime}\right) \eta(\zeta) \mid .
$$

Choose $1<s<\epsilon_{0} / 2$, one has

$$
\left.\left|\langle R\rangle^{s} \eta\left(\zeta^{\prime}\right) \eta(\zeta)\right| V_{i j}(R+\rho)\right|^{1 / 2}|\leq C| \eta\left(\zeta^{\prime}\right) \eta(\zeta) \mid .
$$

(iii) If $R \lesssim \rho$,

$$
\left.\left|\langle R\rangle^{s} \eta\left(\zeta^{\prime}\right) \eta(\zeta)\right| V_{i j}(R+\rho)\right|^{1 / 2}|\leq C| \eta\left(\zeta^{\prime}\right) \eta(\zeta) \mid .
$$

From the argument above, one has $\langle R\rangle^{s} P\left|V_{i j}(R+\rho)\right|^{1 / 2}$ is a bounded operator, since $\eta$ has an exponential decay at infinity. It follows $\left(H_{D}-\Sigma\right)^{-1 / 2} P\left|I_{D}\right|^{1 / 2} \in \mathscr{S}_{2 r}^{w}$. Then we get $K_{P}(\Sigma) \in \mathscr{S}_{r}^{w}$. In the similar way, we can get $K_{P}(E) \in \mathscr{S}_{r}^{w}$, and

$$
\begin{aligned}
K_{P}(\Sigma)-K_{P}(E) & =\left|I_{D}\right|^{1 / 2}\left(\left(H_{D}-E\right)^{-1}-\left(H_{D}-\Sigma\right)^{-1}\right) P\left|I_{D}\right|^{1 / 2} \\
& =(\Sigma-E)\left|I_{D}\right|^{1 / 2}\left(\left(H_{D}-E\right)^{-1}\left(H_{D}-\Sigma\right)^{-1}\right) P\left|I_{D}\right|^{1 / 2} \\
& \leq(\Sigma-E)^{\delta}\left|I_{D}\right|^{1 / 2}\left(t_{D}\right)^{-1-\delta} P\left|I_{D}\right|^{1 / 2}
\end{aligned}
$$

with $0<\delta \leq 1$. Then, one has $K_{P}(\Sigma)-K_{P}(E)$ is in $\mathscr{S}_{2 r}^{w}$ and tends to zero when $E \rightarrow \Sigma$.
Theorem 2.7. (Theorem 2.8 [34])
$K(E)$ has a norm limit $K(\Sigma)$ as $E \uparrow \Sigma$ and moreover :
(i). $\sigma_{\text {ess }}(K(E))=[0, \Lambda(\Sigma)]$, where $\Lambda(\Sigma)=\sup _{\lambda}\left\{\lambda ; \sigma_{\text {ess }}\left(H_{D}+\lambda^{-1} I_{D}\right) \cap(-\infty, \Sigma] \neq \emptyset\right\}<1$;
(ii). $K(E) \leq K(\Sigma)$ for all $E \leq \Sigma$.

Remark 2.8. This theorem is from Theorem 2.8 [34]. In their proof, they use that $K_{P}(E) \rightarrow$ $K_{P}(\Sigma)$ in norm as $E \uparrow \Sigma\left(\right.$ Proposition 2.6 [34]). But they only proved that $K_{P}(E)$ were uniformly bounded for $E<\Sigma$, $E$ near $\Sigma$, they did not prove $K_{P}(E) \rightarrow K_{P}(\Sigma)$. So we rewrite the proof of Proposition 2.6.

Proof. Propositions 2.6 imply the existence of the norm limit. The identification of $\sigma_{e s s}(K(\Sigma))$ follows form Proposition 2.3 and Lemma 2.9 below. That $\Lambda(\Sigma)<1$ follows from the fact that $\Sigma$ is unique two cluster. Finally $(i i)$ is obvious since

The following lemma is the result of [34].
Lemma 2.9. (Lemma 2.9 [34]) Let $A_{n} \geq 0, \sigma_{\text {ess }}\left(A_{n}\right)=\left[0, a_{n}\right]$ and suppose $A_{n} \rightarrow A$ in norm. Then $a=\lim _{n \rightarrow \infty} a_{n}$ exists and $\sigma_{\text {ess }}(A)=[0, a]$.

Proof. Let $\bar{a}$ (resp. a) be $\overline{\lim } a_{n}\left(\right.$ resp. $\left.\underline{\lim } a_{n}\right)$. Let $\lambda<\overline{\lim } a_{n}$. If $\lambda \notin \sigma(A)$, then $\lambda \notin \sigma\left(A_{n}\right)$ for all large $n$, so $[0, \bar{a}] \subset \sigma_{\text {ess }}(A)$. Now let $\lambda>a$. Pick $\delta>0$ so that $\lambda-\delta>a$. Pick $n$ so large that $\left\|A-A_{n}\right\| \leq \delta / 3$ and that $\lambda-2 \delta / 3>a_{n}$. Since $[\lambda-2 \delta / 3, \lambda+2 \delta / 3] \cap \sigma\left(A_{n}\right)=\emptyset$, we can find $F$ finite rank so that $[\lambda-2 \delta / 3, \lambda+2 \delta / 3] \cap \sigma\left(A_{n}+F\right)=\emptyset$. Thus $[\lambda-\delta / 3, \lambda+\delta / 3] \cap \sigma(A+F)=\emptyset$. So $\lambda \notin \sigma_{e s s}(A)$, i.e. $\sigma(A)=[0, a]$.

By Theorem 2.7, we can get the following result.
Theorem 2.10. (Theorem 2.9 [34])) Let $H$ be the Hamiltonian of an $N$-body system with potentials satisfying (2.5) and (2.6). Let $\Sigma$, the infimum of the essential spectrum of $H$ be unique two cluster. Then $\operatorname{dim} \operatorname{ran} E_{(-\infty, \Sigma)}(H)<\infty$ (i.e. there are finitely many "bound states").

Proof.

& \leq \#\{\lambda \mid \lambda>1, \lambda \in \sigma(K(\Sigma))\}  \tag{2.15}\\
& <\infty .
\end{align*}
$$

In (2.14) we use the standard Birman [5]-Schwinger [56] argument; in the next step, we use $K(E) \leq K(\Sigma)$, in the last step, we use that $[1, \infty) \cap \sigma_{e s s}(K(\Sigma))=\emptyset$ which can be get from Lemma 2.9 and Theorem 2.7.

### 2.3 Semi-classical limit of the number of discrete eigenvalues

Let $N(h)$ denote the number of discrete eigenvalues, less than $\Sigma_{h}$, of $H(h)=h^{2} H_{0}+V$. From the last section, we can see that $N(h)$ is finite for any $h>0$. In this section, we want to discuss the small $h$ behavior of $N(h)$. For the two-body case the result is well-known ( see [4, 43, 66] for original work or [54, 65] for further discussion). Here we consider the unique
two-cluster $N$-body Schrödinger operators. First we will show that if (2.5) and (2.6) hold, then $\left|\left(V-\Sigma_{c l}\right)-\right| \in L^{(N-1) v / 2}$. Here $\left(V-\Sigma_{c l}\right)_{-}$is the negative part of $V-\Sigma_{c l}$. It suffices to show that

\left|\left(V(x)-\Sigma_{c l}\right)_{-}\right| \leq C\langle x\rangle^{-\epsilon_{0}}, \quad \epsilon_{0}>2 . \tag{2.16}
\end{equation*}

Let $\mathcal{A}$ denote the set of all cluster decompositions of the $N$-particle system. For each $D=$ $\left\{C_{1}, \cdots, C_{k}\right\} \in \mathcal{A}$, there is a natural decomposition of $\mathscr{H}=L^{2}\left(\mathbb{R}^{(N-1) v}\right)$ as $\mathscr{H}^{D} \otimes \mathscr{H}_{D}$ with

Here $m_{j}$ is the mass of the $j$-th particle. Under these notations, one has for each $x \in \mathscr{H}$, $x=x^{D}+x_{D}$ with $x^{D} \in \mathscr{H}^{D}, x_{D} \in \mathscr{H}_{D}$.

V_{D}=\sum_{\# D^{\prime}=N-1, D^{\prime} \subset D} V_{D^{\prime}}\left(x^{D^{\prime}}\right), \quad I_{D}=\sum_{\# D^{\prime}=N-1, D^{\prime} \nsubseteq D} V_{D^{\prime}}\left(x^{D^{\prime}}\right)

Lemma 2.11. For some $\delta>0$ small, define

then $\bigcup_{\# D=2} J_{D}=\mathscr{H} \backslash\{0\}$.
Proof. It is easy check that $J_{D^{\prime}} \subset J_{D}$, if $D^{\prime} \subset D$. Therefore, it suffices to prove that $\bigcup_{\mathcal{F}: \# D \geq 2} J_{D}=\mathscr{H} \backslash\{0\}$. Let $\mathbb{S}$ denote the unite sphere in $\mathscr{H}$ and \#D $\mathcal{A} ;: \# D \geq 2$

It can be easily checked that $x \notin \mathscr{H}_{D^{\prime}}, \forall D^{\prime} \not \subset D_{0}$. For any $x \in \mathbb{S}_{D}$, we can take some $\delta_{0}=$ $\delta_{0}(x)>0$, such that

for $D^{\prime} \not \subset D$. The family of open sets $\left\{y \in \mathbb{S} ;|y-x| \leq \epsilon_{x}\right\}=O_{x}, x \in \mathbb{S}$ forms a covering for $\mathbb{S}$ and we can extract a finite covering of $\mathbb{S}$ from it, denoted by $\left\{O_{x_{j}} ; j=1, \cdots, N\right\}$. Put
$\delta=\min _{j} \epsilon_{x_{j}}>0$. Define $J_{D}$ as in lemma. We derive that $\bigcup_{\# D \in \mathcal{A} ; \# D \geq 2} J_{D} \supseteq \cup_{j} \Omega\left(x_{j}, \delta\right)=\mathscr{H} \backslash\{0\}$.

By the above lemma, we know that there exists a family of non-negative smooth function $\left\{\chi_{D} ; D \in \mathcal{A}, \# D=2\right\}$ such that

Since $\Sigma_{c l}=\min _{\# D=2} a_{D}$ with $a_{D}=\min _{x \in \mathscr{H} D} V_{D}(x)$, one has $V_{D}(x) \geq \Sigma_{c l}$. It follows that $\chi_{D}\left(V_{D}-\Sigma_{c l}\right) \geq$ 0 , since $\chi_{D} \geq 0$. Note $\chi_{D} I_{D}=\chi_{D} \sum_{\# D^{\prime}=N-1, D^{\prime} \not \subset D} V_{D^{\prime}}\left(x^{D^{\prime}}\right)$, and $\left|V_{D^{\prime}}\left(x^{D^{\prime}}\right)\right| \leq C\langle x\rangle^{-\epsilon_{0}}$. One has $\left|\chi_{D} V_{D^{\prime}}\left(x^{D^{\prime}}\right)\right| \leq C\left\langle x^{D^{\prime}}\right\rangle^{-\epsilon_{0}} \leq C_{\delta}\langle x\rangle^{-\epsilon_{0}}$. Therefore, we get (2.16).

The main result of this section is the following.
Theorem 2.12. Let $v \geq 3$. Let $H_{0}=-h^{2} \Delta$ on $L^{2}\left(\mathbb{R}^{(N-1) v}\right)$ and let $V$ be given by (2.4) with $V_{i j}$ satisfying (2.5),(2.6). Suppose that (2.8) holds. Then

where $\tau_{(N-1) v}$ is the volume of the unit sphere in $\mathbb{R}^{(N-1) \nu}$.
Before proving this theorem, we first give a useful lemma.
Lemma 2.13. Let $\Sigma_{h}=\min _{D}\left\{\min \sigma\left(h_{D}(h)\right)\right\}$. $\Sigma_{c l}$ is defined as before. Under the condition of Theorem 2.12, one has $\Sigma_{h} \stackrel{D}{-\Sigma_{c l}}=O(h)$.

Proof. By the definition of $\Sigma_{h}$, we know that there exists a cluster decomposition $D$, such that

Let $\psi \in C_{0}^{\infty}\left(\mathbb{R}^{(N-2) v}\right)$ be a normalized function, which is supported in $B\left(x_{0}, 1\right)\left(=\left\{x \in \mathbb{R}^{(N-2) v} ;\left|x-x_{0}\right| \leq 1\right\}\right)$. Define

Choose $s=1 / 2$, we have $\min \sigma\left(-h^{2} \Delta+V_{D}-\Sigma_{c l}\right) \leq C h$. This ends the proof.
Proof of Theorem 2.12 : Write

= & \lim _{h \rightarrow 0} h^{(N-1) v}\left[\#\left(\text { e.v. of } K_{h}\left(\Sigma_{h}\right)>1\right)-\#\left(\text { e.v. of } K_{h}\left(\Sigma_{c l}\right)>(1+\epsilon)^{-1}\right)\right] \\
\leq & \lim _{h \rightarrow 0} h^{(N-1) v} \#\left(\text { e.v. of }\left(K_{h}\left(\Sigma_{h}\right)-K_{h}\left(\Sigma_{c l}\right)\right)>(1+\epsilon)^{-1}-1\right) .

= & \left(\Sigma_{h}-\Sigma_{c l}\right)\left|I_{D}\right|^{1 / 2}\left(P_{1 h}+P_{2 h}\right)\left(H_{D}(h)-\Sigma_{h}\right)^{-1}\left(H_{D}(h)-\Sigma_{c l}\right)^{-1}\left(P_{1 h}+P_{2 h}\right)\left|I_{D}\right|^{1 / 2} \\
\leq & \left.2\left(\Sigma_{h}-\Sigma_{c l}\right) I_{D}\right|^{1 / 2} P_{1 h}\left(H_{D}(h)-\Sigma_{h}\right)^{-1}\left(H_{D}(h)-\Sigma_{c l}\right)^{-1} P_{1 h}\left|I_{D}\right|^{1 / 2} \\
& +\left.2\left(\Sigma_{h}-\Sigma_{c l}\right) I_{D}\right|^{1 / 2} P_{2 h}\left(H_{D}(h)-\Sigma_{h}\right)^{-1}\left(H_{D}(h)-\Sigma_{c l}\right)^{-1} P_{2 h}\left|I_{D}\right|^{1 / 2} \\
= & \alpha_{P_{h}}^{(1)}+\alpha_{P_{h}}^{(2)} .

\leq & t_{D}^{-1},
\end{aligned}

where $C_{3}>0$ and $C_{2}, C_{3}$ is independent of $h$ and $\varphi(h)$ is the eigenvector of $h_{D}(h)$ correspondent to eigenvalue $E(h)<\alpha$. From the one body result, one has

so $\alpha_{P_{h}}^{(1)}$ is a sum of at most $\mathrm{Ch}^{-(N-2) v}$ terms, and each of them of the form controlled by Proposition 2.6. Using the similar methods used in Proposition 2.6 and by (2.23), we can get that each of these terms has a norm bounded by

& \leq 2\left|I_{D}\right|^{1 / 2} P_{2 h}\left(\Sigma_{h}-\Sigma_{c l}\right)^{\delta}\left(H_{D}(h)-\Sigma_{h}\right)^{-1-\delta} P_{2 h}\left|I_{D}\right|^{1 / 2} \\
& \leq\left. 2\left(\Sigma_{h}-\Sigma_{c l}\right)^{\delta}\left|I_{D}\right|^{1 / 2} P_{2 h}\left(t_{D}\right)^{-1-\delta} P_{2 h} I_{D}\right|^{1 / 2} .
\end{aligned}

= & \operatorname{dim} \operatorname{ran}\left(P_{h}\right) \#\left\{\text { e.v. of }\langle\rho\rangle^{-n / 2} t_{D}^{-1-\delta}\langle\rho\rangle^{-n / 2} \geq \frac{\epsilon}{4}\left(\Sigma_{h}-\Sigma_{c l}\right)^{-\delta} h^{2+2 \delta}\right\} \\
= & \operatorname{dim} \operatorname{ran}\left(P_{h}\right) \#\left\{\text { e.v. of } t_{D}^{1+\delta}+4 \epsilon^{-1} h^{-2-2 \delta}\left(\Sigma_{h}-\Sigma_{c l}\right)^{\delta}\langle\rho\rangle^{-n} \leq 0\right\} \\
\leq & C \operatorname{dim} \operatorname{ran}\left(P_{h}\right) h^{-\nu} \frac{\frac{\delta \nu}{2(\phi+1)}}{\frac{--\nu}{2((+1))}} \tag{2.25}
\end{align*}

in (2.25), we use Birman-Schwinger principle and in the last step, we use $n>2$. Choose $\delta>0$ small enough. We complete the proof.

### 2.4 Semi-classical limit of Riesz means of discrete eigenvalues

In this section, we want to discuss the small $h$ behavior of Riesz means of discrete spectrum of Schrödinger operators. First, we consider the Riesz means of the two-body Schrödinger operators $P(h)=-h^{2} \Delta+V$ on $L^{2}\left(\mathbb{R}^{n}\right), n \geq 3$ with

and

We define the Riesz means of order $\gamma \geq 0$ of $P(h)$ by

R_{\gamma}(h ; \lambda)=\sum_{e_{j}(h) \leq \lambda}\left(\lambda-e_{j}(h)\right)^{\gamma},
$$

where $\lambda<\sigma_{\text {ess }}(P(h))$. Let $N_{h}(\lambda)$ be the number of discrete eigenvalues of $P(h)$ less than $\lambda$, then $R_{0}(h ; \lambda)=N_{h}(\lambda)$.

Then the main result for Riesz means of the two-body Schrödinger operator is the following :

Theorem 2.17. Let $n \geq 3$. If (2.26) and (2.27) hold, then

R_{\gamma}(h ; 0)=(2 \pi)^{-n} \tau_{n} h^{-n} C_{\gamma, n} \int_{\{x ; V(x) \leq 0\}}(-V(x))^{\gamma+\frac{n}{2}} d x\left(1+O\left(h^{1 / 2}\right)\right) \tag{2.28}
\end{equation*}
$$

where $C_{\gamma, n}=\gamma \int_{0}^{1} \beta^{\gamma-1}(1-\beta)^{\frac{n}{2}} d \beta$ and $\tau_{n}$ is the volume of the unit sphere in $\mathbb{R}^{n}$.
Before proving the theorem, we give a lemma first which can be proved by DirichletNeumann bracket. We begin with recalling some results of Dirichlet-Neumann bracket (See [54] for details).

Let $\Omega$ be an open region of $\mathbb{R}^{n}$ with connected components $\Omega_{1}, \cdots$ (finite or infinite). The Dirichlet Laplacian for $\Omega,-\Delta_{D}^{\Omega}$ is the unique self-adjoint operator on $L^{2}(\Omega)$ whose quadratic form is the closure of the form $q(f, g)=\int \overline{\nabla f} \cdot \nabla g d x$ with the domain $C_{0}^{\infty}(\Omega)$. The Neumann Laplacian for $\Omega,-\Delta_{N}^{\Omega}$ is the unique self-adjoint operator on $L^{2}(\Omega)$ whose quadratic form is the closure of the form $q(f, g)=\int \overline{\nabla f} \cdot \nabla g d x$ with the domain $H^{1}(\Omega)=\left\{f \in L^{2}(\Omega) ; \nabla f \in L^{2}\left(\mathbb{R}^{n}\right)\right\}$.

Proposition 2.18. ([54])
(1). Let $N_{D}(a, \lambda)$ (respectively, $\left.N_{N}(a, \lambda)\right)$ denote the dimension of the spectral projection $P_{[0, \lambda)}$ for $-\Delta_{D}\left(\right.$ respectively, $\left.-\Delta_{N}\right)$ on $(-a, a)^{m}$. Then for all $a$, $\lambda$, we have

\end{aligned}

Here $\tau_{m}$ is the volume of the unit ball in $\mathbb{R}^{n}$ and $C$ is a suitable constant independent of a and $\lambda$.
(2). Let $N_{D}(\Omega, \lambda)$ (respectively, $N_{N}(\Omega, \lambda)$ ) be the dimension of the spectral projection $P_{[0, \lambda)}$ for $-\Delta_{D}$ (respectively, $-\Delta_{N}$ ). Then if $\Omega_{1}, \cdots, \Omega_{k}$ are disjoint,

& N_{D}\left(\cup_{i=1}^{k} \Omega_{i}, \lambda\right)=\sum_{i=1}^{k} N_{D}\left(\Omega_{i}, \lambda\right) \\
& N_{N}\left(\cup_{i=1}^{k} \Omega_{i}, \lambda\right)=\sum_{i=1}^{k} N_{N}\left(\Omega_{i}, \lambda\right)
\end{aligned}
$$

(3). For any $\Omega, 0 \leq-\Delta_{N}^{\Omega} \leq-\Delta_{D}^{\Omega}$. If $\Omega_{1}, \Omega_{2}$ be disjoint open subsets of an open set $\Omega$ so that $\overline{\left(\Omega_{1} \cup \Omega_{2}\right)}{ }^{\text {int }}=\Omega$ and $\Omega \backslash\left(\Omega_{1} \cup \Omega_{2}\right)$ has measure 0 , then

& 0 \leq-\Delta_{D}^{\Omega} \leq-\Delta_{D}^{\Omega_{1} \cup \Omega_{2}} \\
& 0 \leq-\Delta_{N}^{\Omega_{1} \cup \Omega_{2}} \leq-\Delta_{N}^{\Omega}
\end{aligned}
$$

Lemma 2.19. If (2.26) and (2.27) hold, then

N_{h}(0)=(2 \pi)^{-n} \tau_{n} h^{-n} \int_{\{x ; V(x) \leq 0\}}(-V(x))^{\frac{n}{2}} d x\left(1+O\left(h^{1 / 2}\right)\right), \tag{2.29}
\end{equation*}
$$

where $O\left(h^{1 / 2}\right)$ depends only on $\left|\left\{x \in \mathbb{R}^{n} ; V(x)<0\right\}\right|(|A|$ denotes the Lebesgue measure of set A).

Proof : Let $h^{2}=\lambda^{-1}$. Then we consider the number of the negative eigenvalues of $-\Delta+\lambda V$. Let $A=\left\{x \in \mathbb{R}^{n} ; V(x)<0\right\}$. Let $A_{i}$ be the cube of the form

V_{i}^{+}=\sup _{x \in A_{i}} V(x) ; V_{i}^{-}=\inf _{x \in A_{i}} V(x) .

Let

V^{+}(x)=V_{i}^{+} ; V^{-}(x)=V_{i}^{-}, \text {if } x \in A_{i}
$$

Let $-\Delta^{+}$be the Laplace operator on $\mathbb{R}^{n}$ but with Dirichlet boundary conditions on the boundaries of all the $A_{i}$, and let $-\Delta^{-}$be the Laplace operator on $\mathbb{R}^{n}$ but with Neumann boundary conditions on the boundaries of all the $A_{i}$. Now, since $V^{-} \leq V \leq V^{+}$, and $-\Delta^{-} \leq-\Delta \leq-\Delta^{+}$by Proposition 2.18, we have that

Let $N(\lambda)$ be the number of the negative eigenvalues of $-\Delta+\lambda V$, and $N^{+}(\lambda)$ (respectively, $N^{-}(\lambda)$ ) be the number of the negative eigenvalues of $-\Delta^{+}+\lambda V^{+}$(respectively, $-\Delta^{-}+\lambda V^{-}$). Then by Proposition 2.18, one has

\geq & \tau_{n}(2 \pi)^{-n} \lambda^{n / 2} \int_{\left\{x \in A_{i} ; V_{i}^{+} \leq 0\right\}}\left|V_{i}^{+}\right|^{n / 2} d x \\
& -\frac{1}{d} C_{n} \lambda^{(n-1) / 2} \int_{\left\{x \in A_{i} ; V_{i}^{+} \leq 0\right\}}\left|V_{i}^{+}\right|^{(n-1) / 2} d x-C_{n} C\left(\frac{1}{d}\right)^{n}
\end{aligned}
$$

where $C_{n}$ depends only on $n$. For $x \in A_{i}$ with $i$ satisfying $V_{i}^{+} \leq 0$, one has

Here $C$ depends on $\|\nabla V\|_{L^{\infty}}$. In the last step, we use that $\left|V_{i}^{+}\right| \leq|V|$, since $V_{i}^{+} \leq 0$. It follows

& -C_{n}\left(\frac{c}{d}\right)^{n}-\frac{C_{n}}{d} \lambda^{(n-1) / 2} \int_{\{x ; V \leq 0\}}(-V)^{(n-1) / 2} d x-C_{n} \lambda^{(n-1) / 2} \int_{\{x ; V \leq 0\}}(-V)^{(n-3) / 2} d x
\end{aligned}
$$

Let $d=c \lambda^{-1 / 4}$. One has

with $C$ depending on $|A|$ and $\|\nabla V\|_{L^{\infty}}$ only.
Similarly, we can get

\leq & \tau_{n}(2 \pi)^{-n} \lambda^{n / 2} \int_{\left\{x \in A_{i} ; V_{i}^{-} \leq 0\right\}}\left|V_{i}^{-}\right|^{n / 2} d x \\
& -\frac{1}{d} C_{n} \lambda^{(n-1) / 2} \int_{\left\{x \in A_{i} ; V_{i}^{-} \leq 0\right\}}\left|V_{i}^{-}\right|^{(n-1) / 2} d x-C_{n} C\left(\frac{1}{d}\right)^{n} .
\end{aligned}
$$

Note that for $x \in A_{i}, v \geq 1$, one has

& +\lambda^{n / 2} d \int_{\{x ; V \leq 0\}}|V|^{n / 2-1} d x+\lambda^{(n-1) / 2} d \int_{\{x ; V \leq 0\}}|V|^{n / 2-3 / 2} \\
& +G_{n} d^{n / 2} \lambda^{n / 2-1}|A|+H_{n} \lambda^{n / 2-1} d^{1 / n-1 / 2}|A|+C_{n}\left(\frac{C}{d}\right)^{n}
\end{aligned}
$$

where $C_{n}, H_{n}, G_{n}$ are the constants depending on $n$ only. If we choose $d=c \lambda^{-1 / 4}$, then we get

N(\lambda) \leq \frac{\tau_{n}}{(2 \pi)^{n}} \lambda^{n / 2} \int_{\{x ; V(x) \leq 0\}}\left|V_{-}\right|^{n / 2}+C \lambda^{n / 2-1 / 4}

where $C$ depends only on $|A|,\|\nabla V\|_{L^{\infty}}$ and $n$. This ends the proof.
Proof of Theorem 2.17 : By Lemma 2.19, one has, for $\mu \leq 0$,

= & \gamma(2 \pi)^{-n} h^{-n} \tau_{n} \int_{0}^{1} \int_{\{x ; V(x)<0\}}(-V(x))^{\gamma+n / 2} d x \beta^{\gamma-1}(1-\beta)^{n / 2} d \beta\left(1+O\left(h^{1 / 2}\right)\right) \\
= & \gamma(2 \pi)^{-n} h^{-n} \tau_{n} \int_{0}^{1} \beta^{\gamma-1}(1-\beta)^{n / 2} d \beta \int_{\{x ; V(x) \leq 0\}}(-V(x))^{\gamma+n / 2} d x\left(1+O\left(h^{1 / 2}\right)\right) \\
= & (2 \pi)^{-n} h^{-n} \tau_{n} C_{\gamma, n} \int_{\{x ; V(x) \leq 0\}}(-V(x))^{\gamma+n / 2} d x\left(1+O\left(h^{1 / 2}\right)\right),
\end{align*}
$$

with

C_{\gamma, n}=\gamma \int_{0}^{1} \beta^{\gamma-1}(1-\beta)^{n / 2} d \beta \tag{2.33}
\end{equation*}

This ends the proof.
We use Theorem 2.17 to study the Riesz means of the $N$-body Schrödinger operators $H(h)=h^{2} H_{0}+\sum_{i<j} V_{i j}$ with

Theorem 2.20. Let $v \geq 3$. Let $H_{0}=-h^{2} \Delta$ on $L^{2}\left(\mathbb{R}^{(N-1) v}\right)$. Suppose (2.34) and (2.35) hold. Then, we have

where $C(\gamma, v)=(2 \pi)^{-(N-1) v} \tau_{(N-1) v} C_{\gamma,(N-1) v}, C_{\gamma,(N-1) v}$ is given by (2.33), and $\tau_{(N-1) v}$ is the volume of the unit sphere in $\mathbb{R}^{(N-1) \nu}, t=\min \left\{\frac{1}{2}, \gamma\right\}$.

Proof. From the definition of $R_{\gamma}\left(h, \Sigma_{h}\right)$, one has

R_{\gamma}\left(h, \Sigma_{h}\right)=\sum_{e_{j}(h) \leq \Sigma_{c l}}\left(\Sigma_{c l}-e_{j}(h)\right)^{\gamma}+\sum_{\Sigma_{c l} \leq e_{j}(h) \leq \Sigma_{h}}\left|\Sigma_{c l}-e_{j}(h)\right|^{\gamma}
$$

By Theorem 2.12 and Lemma 2.13, one has

Let $\tilde{V}=V-\Sigma_{c l}$. First, we will show that $\left\{x \in \mathbb{R}^{(N-1) v} ; \tilde{V}(x)<0\right\}$ is a bounded set. Let $\left\{\chi_{D} ; D \in \mathcal{A}, \# D=2\right\}$ be a family of non-negative smooth functions such that

Here $B(0,1)$ is the unite ball in $\mathscr{H}$. Then

V-\Sigma_{c l}=\sum_{D \in \mathcal{A}, \# D=2} \chi_{D}\left(V_{D}-\Sigma_{c l}\right)+\sum_{D \in \mathcal{A}, \# D=2} \chi_{D} I_{D}
$$

Note $\chi_{D} I_{D}=\chi_{D} \sum_{\# D^{\prime}=N-1, D^{\prime} \not D_{D}} V_{D^{\prime}}\left(x^{D^{\prime}}\right)$, and $V_{D^{\prime}}\left(x^{D^{\prime}}\right) \in C_{0}^{\infty}$. It is easy to check that $\chi_{D} V_{D^{\prime}}\left(x^{D^{\prime}}\right)=0$ for $D^{\prime} \not \subset D, \# D^{\prime}=N-1,|x|$ large enough. It follows that $\chi_{D} I_{D} \in C_{0}^{\infty}(\mathscr{H})$. Since $\Sigma_{c l}=\min _{\# D=2} a_{D}$ with $a_{D}=\min _{x \in \mathscr{H}^{D}} V_{D}(x)$, one has $V_{D}(x) \geq \Sigma_{c l}$. It follows that $\chi_{D}\left(V_{D}-\Sigma_{c l}\right) \geq 0$, since $\chi_{D} \geq 0$. Therefore, we drive that $\left(V(x)-\Sigma_{c l}\right)_{-}$has compact support.

Then $\left\{x \in \mathbb{R}^{(N-1) v} ; \tilde{V}(x)<0\right\}$ is a bounded set. Using Theorem 2.17 for Schrödinger operator $-h^{2} \Delta+\tilde{V}$, one has

$$
\sum_{e_{j}(h) \leq \Sigma_{c l}}\left(\Sigma_{c l}-e_{j}(h)\right)^{\gamma}=C(\gamma, v) \int_{\left\{x ; V(x) \leq \Sigma_{c l}\right\}}\left(\Sigma_{c l}-V(x)\right)^{\gamma+\frac{(N-1) v}{2}} d x\left(1+O\left(h^{1 / 2}\right)\right) .
$$

This ends the proof.
Remark 2.21. From the proof of Theorem 2.17, one can see that the uniform holding of the remainder term of $N(h, \lambda)$ with respected to $\lambda \leq 0$ play an important role. For the two-body case, we can only get that for the V's satisfying (2.27). If we can extend this results to general $V$, then we can get the estimate of the Riesz means for general $V$. In the $N-b o d y$ case, we need (2.34) and (2.35), because these two conditions imply that $\left\{x ; V<\Sigma_{c l}\right\}$ is a bound set.

### 2.5 The N -body Schrödinger operators with Coulomb potentials

In Chapter 3 and Chapter 4, we consider the Schrödinger operators of the form $-\Delta+V$ with $V=\frac{q(\theta)}{|x|^{2}}+o\left(\langle x\rangle^{-\rho}\right)$ for $|x|$ large, with some $\rho>2$. Here $\theta=\frac{x}{|x|}$, and $q(\theta)$ is a real continuous
function. We explain why we consider these Schrödinger operators in this section. We consider the $N$-body system of $v$-dimensional particles with Coulomb potential. Let

$$

with

\tilde{H}_{0}=\sum_{i=1}^{N} \frac{1}{2 m_{i}}\left(-\Delta_{r_{i}}\right)

and

$$

Here $m_{j}$ is the mass of $j$-th particle and $e_{j}$ is the charge of $j$-th particle. $-\Delta_{r_{j}}$ is the Laplacian in the $r_{j}$ variables. Let $H_{0}$ be the operator resulting from removing the center of mass from $\tilde{H}_{0}$ and $H=H_{0}+V$. For each cluster decomposition $D$, there is a natural decomposition of $\mathscr{H}=L^{2}\left(\mathbb{R}^{(N-1) v}\right)$ as $\mathscr{H}^{D} \otimes \mathscr{H}_{D}$ with $\mathscr{H}_{D}=$ functions of $r_{i j}$ with $i D j$ and $\mathscr{H}^{D}=$ functions of $R_{q}-R_{l}$ where $R_{q}=\sum_{i \in a_{q}} m_{i} r_{i} / \sum_{i \in a_{q}} m_{i}$ is the center of the mass of $a_{q}$. By HVZ-Theorem, we know that there exists a decomposition $D$, such that

and $E_{0}$ is the simple eigenvalue of $H_{D}$. Obviously, $\#(D)=2$, since $\sigma_{D^{\prime}} \leq \sigma_{D}$, if $D^{\prime}$ is the refinement of $D$. Without loss of generality, we can suppose that $D=\left\{a_{1}, a_{2}\right\}$ with $a_{1}=\{1,2, \cdots, k\}$ and $\{k+1, k+2, \cdots, N\}$. Let $\eta$ be the normlized function such that

with $M_{c}^{-1}=m_{a_{1}}^{-1}+m_{a_{2}}^{-1}$ and $H\left(c_{i}\right)$ be the sub-Hamilton to $\sum_{j \in a_{i}} \frac{1}{2 m_{j}}\left(-\Delta_{j}\right)+\sum_{l, j \in a_{i}} \frac{e_{l} e_{j}}{r_{l}-r_{j}}$ with its center of mass removed. Then one has,

Here $l$, and $l_{i}$ are linear combination of $\xi_{j}(j=1,2, \cdots, k-1)$. Similarly, we can get

with $l_{i}$ the linear combination of $\xi_{j}(j=k+1, k+2, \cdots, N-1)$. It follows that, for $i \in a_{1}, j \in a_{2}$,

Lemma 2.22. Let $\hat{\rho}=\frac{\rho}{|\rho|}$. Then $I_{\text {eff }}$ has the following expansion :

f_{1}(\hat{\rho})=\int \sum_{i \in a_{1}, j \in a_{2}} e_{i} e_{j} \hat{\rho} \cdot l_{i, j}|\eta|^{2} d \xi_{1} \cdots d \xi_{N-2} ; \\
f_{2}(\hat{\rho})=\int \sum_{i \in a_{1}, j \in a_{2}} e_{i} e_{j}\left(\left|l_{i, j}\right|^{2}-3\left|\hat{\rho} \cdot l_{i j}\right|^{2}\right) d \xi_{1} \cdots d \xi_{N-2} .
\end{gathered}

Moreover, if $C_{1}=C_{2}=0, f_{1}(\hat{\rho})=0$.

The first term of the right hand side is equal to 0 if $C_{1}=0$ or $C_{2}=0$. Note that $l_{i j}=l_{i}-l_{j}$ for $i \in a_{1}, j \in a_{2}$. It follows that $\sum_{i \in a_{1}, j \in a_{2}} e_{i} e_{j} l_{i, j}=0$, if $C_{1}=C_{2}=0$. This ends the proof.

## 3 - COUPLING CONSTANT LIMITS OF Schrödinger operators with critical POTENTIALS AND THE ASYMPTOTIC EXPANSION OF RESOLVENT OF SCHRÖDINGER OPERATORS

### 3.1 Introduction

In Section 2.5 (Chapter 2), we consider the $N$-body System of $v$-dimensional particles with Coulomb potentials. The effective potential has the form $\frac{f_{1}(\hat{\rho})}{|\rho|^{2}}+\frac{f_{2}(\hat{\rho})}{|\rho|^{3}}+O\left(\frac{1}{|\rho|^{4}}\right)$ as $|\rho|$ large. Here $\hat{\rho}=\frac{\rho}{|\rho|}$. Hence, we study Schrödinger operators $P(\lambda)=P_{0}+\lambda V$ and $P(\lambda)=\tilde{P}_{0}+\lambda V$ in $L^{2}\left(\mathbb{R}^{n}\right)$ in this chapter. Here $P_{0}$ and $\tilde{P}_{0}$ are perturbation of $-\Delta$ in the form $-\Delta+f(x)$ on $L^{2}\left(\mathbb{R}^{n}\right)$ with $f(x)=\frac{q(\theta)}{|x|^{2}}$ when $|x|$ is large enough. Here $\theta=\frac{x}{|x|}$ and $q(\theta)$ is a real continuous function on unit sphere $\mathbb{S}^{n-1}$. Assume that $V(x)=O\left(|x|^{-2-\epsilon}\right)$ with some $\epsilon>0$, when $|x|$ large enough.

This chapter is composed of two parts. In the first part, we consider a family of Schrödinger operators, $P(\lambda)$, which are the perturbation of $P_{0}$ in the form

$$
P(\lambda)=P_{0}+\lambda V, \text { for } \lambda \geq 0
$$

on $L^{2}\left(\mathbb{R}^{n}\right), n \geq 2$. Here $P_{0}=-\Delta+\frac{q(\theta)}{r^{2}} .(r, \theta)$ is the polar coordinates on $\mathbb{R}^{n}, q(\theta)$ is a real continuous function. $V \leq 0$ is a non-zero continuous function and satisfies

$$
\begin{equation*}
|V(x)| \leq C\langle x\rangle^{-\rho_{0}}, \quad \text { for some } \rho_{0}>2 \tag{3.1}
\end{equation*}
$$

Let $\Delta_{s}$ denote Laplace operator on the sphere $\mathbb{S}^{n-1}$. Assume

$$
\begin{equation*}
-\Delta_{s}+q(\theta) \geq-\frac{1}{4}(n-2)^{2}, \quad \text { on } L^{2}\left(\mathbb{S}^{n-1}\right) \tag{3.2}
\end{equation*}
$$

We will show that $P_{0}$ and $P(\lambda)$ are self-adjoint operators in $L^{2}\left(\mathbb{R}^{n}\right)$ with the form domain $Q\left(P_{0}\right)$, when $-\Delta_{s}+q(\theta)>-\frac{1}{4}(n-2)^{2}$, on $L^{2}\left(\mathbb{S}^{n-1}\right)$ (see Section 3.2), especially $Q\left(P_{0}\right)=H^{1}$ if $n \geq 3$. If (3.2) holds, we also have $P_{0} \geq 0$ in $L^{2}\left(\mathbb{R}^{n}\right)$ (see Section 3.2). Set

$$
\sigma_{\infty}=\left\{v ; v=\sqrt{\lambda+\frac{1}{4}(n-2)^{2}}, \lambda \in \sigma\left(-\Delta_{s}+q(\theta)\right)\right\}, \quad \sigma_{k}=\sigma_{\infty} \cap[0, k], k \in \mathbb{N} .
$$

If $q=0$, then $P_{0}=-\Delta$. In this case, $\sigma_{\infty}$ consists of either only half-integers ( n odd) or only integers ( n even). In particular, for Laplace operator $-\Delta$, one has $\sigma_{1}=\{0,1\}, n=2 ; \sigma_{1}=\left\{\frac{1}{2}\right\}$, $n=3 ; \sigma_{1}=\{1\}, n=4 ; \sigma_{1}=\emptyset, n=5$.
$P(\lambda)$ has continuous spectrum $[0, \infty)$ for $\lambda \geq 0$, because $\lim _{|x| \rightarrow \infty} V(x)$ exists and equals to 0 (See [3]). We claim that when $\lambda$ large enough, $P(\lambda)$ has discrete spectrum less than 0 . In fact, we need only to show that there exists a function $\psi \in L^{2}\left(\mathbb{R}^{n}\right)$ such that $\langle\psi, P(\lambda) \psi\rangle<0$.

From the assumption on $V$, we know that there exists a point $x_{0} \in \mathbb{R}^{n}$ such that $V\left(x_{0}\right)=$ $\inf _{x \in \mathbb{R}^{n}} V(x)$. Choose $\delta>0$ small enough such that for all $x \in B\left(x_{0}, \delta\right), V(x)<\frac{1}{2} V\left(x_{0}\right)$. For $\psi \in C_{0}^{\infty}\left(\mathbb{R}^{n}\right),\|\psi(x)\|=1, \operatorname{supp} \psi \subset B\left(x_{0}, \delta\right)$, one has

$$
\langle\psi, P(\lambda) \psi\rangle=\left\langle\psi, P_{0} \psi\right\rangle+\lambda\langle\psi, V \psi\rangle<\left\langle\psi, P_{0} \psi\right\rangle+\frac{\lambda}{2} V\left(x_{0}\right),
$$

when $\lambda$ large enough , one has $\langle\psi, P(\lambda) \psi\rangle<0$.
We also know that $\sigma(P(0))=\sigma\left(P_{0}\right)=[0, \infty)$. Hence, from the continuity of discrete spectrum of $P(\lambda)$, we know there exists some $\lambda_{0}$ such that when $\lambda>\lambda_{0}, P(\lambda)$ has eigenvalues less then 0 , and when $\lambda \leq \lambda_{0}, \sigma(P(\lambda))=[0, \infty)$. So $P(\lambda)$ has an eigenvalue $e_{1}(\lambda)<0$ at the bottom of its spectrum for $\lambda>\lambda_{0}$. By Proposition 3.5, one has $e_{1}(\lambda)$ is simple and the corresponding eigenfunction can be chosen to be positive everywhere. (There are many results about the simplicity of the smallest eigenvalue of Schrödinger operator with potential without singularity, but we did not find the result which can be used directly, because the potential of our Schrödinger operator has singularity at 0 . Theorem XIII. 48 [54] can treat the Schrödinger operator with the potential with singularity at 0 , but the positivity of potential is demanded. Hence we give this result.) In this paper, we suppose $\lambda_{0}>0$. We study the 0 resonances of $P\left(\lambda_{0}\right)$ and the asymptotic behavior of discrete eigenvalues of $P(\lambda)$ at value $\lambda_{0} . \lambda_{0}$ is the value at which some eigenvalue converges to 0 . In [33], Klaus and Simon studied the convergent rate of discrete eigenvalues of $P(\lambda)=-\Delta+\lambda V$, when $\lambda \rightarrow \lambda_{0}$. Here $\lambda_{0}$ is the value at which some discrete eigenvalue $e_{i}(\lambda) \uparrow 0$ of $P(\lambda)$. Fassri-Klaus [20] also studied this problem for Schrödinger operator $-\Delta+V+\lambda W$ with $V$ periodic. They used Birman-Schwinger kernel in their papers. We also use Birman-Schwinger kernel to study this problem. In order to use the Birman-Schwinger technic to $P(\lambda)$, we need to know the asymptotic expansion of $\left(P_{0}-\alpha\right)^{-1}$ for $\alpha$ near $0, \alpha<0$, which has been studied by X.P. Wang ([70]).

In the second part, we consider Schrödinger operator $P$, which is the perturbation of $-\Delta$ in the form

$$
\begin{equation*}
P=-\Delta+\tilde{V}, \text { for } \lambda \geq 0 \tag{3.3}
\end{equation*}
$$

on $L^{2}\left(\mathbb{R}^{n}\right), n \geq 3$. Here $\tilde{V}=V_{1}+V_{2} . V_{1}, V_{2}$ are continuous function such that $\left|V_{1}\right|=\frac{q(\theta)}{r^{2}}$ when $r$ large enough, $V_{2} \leq 0$ is a non-zero function and satisfies $\left|V_{2}\right| \leq C\langle x\rangle^{-\rho_{0}}$ with some $\rho_{0}>2$. $q(\theta)$ is a real function on sphere $\mathbb{S}^{n-1}$ such that (3.4) holds. We study the asymptotic expansion of $(P-z)^{-1}$ for $z$ near $0, \mathfrak{J} z>0$. Let

$$
\tilde{P}(\lambda)=\tilde{P}_{0}+\lambda V
$$

with $\tilde{P}_{0}=\chi_{1}(-\Delta) \chi_{1}+\chi_{2}\left(-\Delta+\frac{q(\theta)}{r^{2}}\right) \chi_{2} .(r, \theta)$ is the polar coordinates on $\mathbb{R}^{n}, V$ is given by (3.1). $\chi_{1} \in C_{0}^{\infty}(\mathbb{R})$ such that $\chi_{1}(r)=1$ for $|r| \leq 1$ and $\chi_{1}^{2}+\chi_{2}^{2}=1$. We study the asymptotic behavior of the smallest eigenvalue of $\tilde{P}(\lambda)$ as $\lambda \rightarrow \lambda_{0}$. $\lambda_{0}$ is the value, at which the smallest discrete eigenvalue of $\tilde{P}(\lambda)$ converges to 0 .

Here is the plan of this chapter. In section 3.2, we recall some results of $P_{0}([70])$. In section 3.3, we study the asymptotic behavior of $e_{1}(\lambda)$ of $P(\lambda)$ when $0 \notin \sigma_{\infty}$. We get the leading term of $e_{1}(\lambda)$. The multiplicity of 0 as the resonance of $P\left(\lambda_{0}\right)$ is studied in Section 3.4. In Section 3.5 , we study the asymptotic expansion of $(P-z)^{-1}, z$ near $0, \mathfrak{J} z>0$ ( $P$ is given by (3.3)). In section 3.6 , we study the asymptotic behavior of the smallest eigenvalue of $\tilde{P}(\lambda)$.

### 3.2 Some results for $P_{0}$

In this section, we consider the operator

$$
P_{0}=-\Delta+\frac{q(\theta)}{r^{2}}
$$

on $L^{2}\left(\mathbb{R}^{n}\right) n \geq 2$. Here $(r, \theta)$ is the polar coordinates on $\mathbb{R}^{n}, q(\theta)$ is a real continuous function. Let $\Delta_{s}$ denote Laplace operator on the sphere $\mathbb{S}^{n-1}$. Assume

$$
\begin{equation*}
-\Delta_{s}+q(\theta) \geq-\frac{1}{4}(n-2)^{2}, \quad \text { on } L^{2}\left(\mathbb{S}^{n-1}\right) \tag{3.4}
\end{equation*}
$$

We begin this section with studying the form domain of $P_{0}$. We will show that $-\Delta_{s}+q(\theta) \geq$ $-\frac{1}{4}(n-2)^{2}$, on $L^{2}\left(\mathbb{S}^{n-1}\right)$ implies

Here $D=C_{0}^{\infty}\left(\mathbb{R}^{n} \backslash\{0\}\right)$. Let $\tilde{D}$ be the set of functions in $D$ which is the set of finite linear combination of products $f(r) g(\theta)$. Note that $\tilde{D}$ is dense in $L^{2}\left(\mathbb{R}^{n}\right)$. One has

To prove $P_{0} \geq 0$ on $\tilde{D}$, it suffices to show that $\left\langle\psi,\left(-\frac{\partial^{2}}{\partial r^{2}}-\frac{1}{4 r^{2}}\right) \psi\right\rangle \geq 0$ for $\psi \in C_{0}^{\infty}(\mathbb{R} \backslash\{0\}, d r)$. To prove that $-\Delta+\frac{q^{+}(\theta)}{r^{2}}$ is a self-adjoint operator in $L^{2}\left(\mathbb{R}^{n}\right)$ with the form domain $H^{1}\left(\mathbb{R}^{n}\right)$, we need only to show that $\gamma(\cdot, \cdot)$ is a closed semi-bounded quadratic form (see Theorem VIII 15 [52]). Since $\langle\phi,-\Delta \phi\rangle+\left\langle\phi, \frac{q^{+}(\theta)}{r^{2}} \phi\right\rangle \geq 0$ for $\phi \in H^{1}\left(\mathbb{R}^{n}\right)$, then $\gamma$ is a semibounded quadratic form. Note that

This means $\gamma$ is closed. It follows that $\gamma$ is the quadratic form of a unique self-adjoint operator with form domain $H^{1}\left(\mathbb{R}^{n}\right)$. Then $-\Delta+\frac{q^{+}(\theta)}{r^{2}}$ is a self-adjoint operator in $L^{2}\left(\mathbb{R}^{n}\right)$ with the form domain $H^{1}\left(\mathbb{R}^{n}\right)$. If $n=2$, let $Q\left(P_{0}\right)$ be the completion of $D$ under the norm $\|\cdot\|_{1} \equiv \sqrt{\langle\cdot,-\Delta \cdot\rangle+\left\langle\cdot, \frac{q^{+}(\theta)}{r^{2}} \cdot\right\rangle+\|\cdot\|^{2}}$. Then $Q\left(P_{0}\right)$ is the form domain of $-\Delta+\frac{q^{+}(\theta)}{r^{2}}$. If

For $v>0$, let $[v]_{-}$be the largest integer strictly less than $v$. When $v=0$, set $[v]_{-}=0$. Define $\delta_{v}$ by $\delta_{v}=1$, if $v \in \sigma_{\infty} \cap \mathbb{N}, \delta_{v}=0$, otherwise. One has $[v]=[v]_{-}+\delta_{v}$.

Theorem 3.2. (Theorem 2.2 [70]) The following asymptotic expansion holds for $z$ near 0 with $\mathfrak{J} z>0$,

F_{j}=\sum_{v \in \sigma_{\infty}} F_{v, j} \pi_{v} \in \mathcal{L}(-1, s ; 1,-s), s>2 j+1 \\
R_{0}^{(N)}(z)=O\left(|z|^{N+\epsilon}\right) \in \mathcal{L}(-1, s ; 1,-s), s>2 N+1, \epsilon>0 .
\end{gathered}

Here $b_{v^{\prime}, j}$ is given by (3.19).
Let $V \leq 0$ be a non-zero continuous function and satisfying

Let $P(\lambda)=P_{0}+\lambda V$.
Definition 3.3. Set $\mathcal{N}(\lambda)=\left\{u ; P(\lambda) u=0, u \in H^{1,-s}, \forall s>1\right\}$, for $\lambda \geq \lambda_{0}$. If $\mathcal{N}(\lambda) \backslash L^{2} \neq\{0\}$, we say that 0 is the resonance of $P(\lambda)$. A non-zero function $u \in \mathcal{N}(\lambda) \backslash L^{2}$ is called a resonant state of $P(\lambda)$ at zero. $\operatorname{dim} \mathcal{N}(\lambda) \backslash L^{2}$ is called the multiplicity of 0 as the resonance of $P(\lambda)$.

Let $K(z)=|V|^{1 / 2}\left(P_{0}-z\right)^{-1}|V|^{1 / 2}$ for $z \notin \sigma\left(P_{0}\right)$, and $K(0)=|V|^{1 / 2} F_{0}|V|^{1 / 2}$. Then we have the following

Proposition 3.4. Let $\alpha<0$. Then $\alpha \in \sigma_{d}(P(\lambda))$ if and only if $\lambda^{-1} \in \sigma_{d}(K(\alpha))$. Moreover, the multiplicity of $\alpha$ as the eigenvalue of $P(\lambda)$ is exactly the multiplicity of $\lambda^{-1}$ as the eigenvalue of $K(\alpha)$.

Proof. Since $P_{0} \geq 0$ in $L^{2}\left(\mathbb{R}^{n}\right)$ and $\alpha<0$, then $\left(P_{0}-\alpha\right)^{-1}$ exists in $L^{2}\left(\mathbb{R}^{n}\right)$.

P(\lambda)-\alpha=\left(P_{0}-\alpha\right)\left(I+\lambda\left(P_{0}-\alpha\right)^{-1} V(x)\right) .
$$

Therefore $\alpha \in \sigma_{d}(P(\lambda))$ if and only if $\lambda^{-1} \in \sigma_{d}\left(-\left(P_{0}-\alpha\right)^{-1} V(x)\right)=\sigma_{d}(K(\alpha))$. In the last equality, we use that for bounded operators $A, B, \sigma(A B) \backslash\{0\}=\sigma(B A) \backslash\{0\}($ See [16]).

For fixed $\alpha<0$, let

\end{aligned}

It suffices to prove $\operatorname{dim} A=\operatorname{dim} B$. First, we will prove that $|V|^{1 / 2}$ is injective from $A$ to $B$. Note that if $\psi \in A$, then

with $\phi=|V|^{1 / 2} \psi$. And if $\phi=0$, then

It follows that $|V|^{1 / 2}$ is injective from $A$ to $B$. On the other hand, we can show that $\left(P_{0}-\right.$ $\alpha)^{-1}|V|^{1 / 2}$ is injective from $B$ to $A$. If $\phi \in B$, then

It follows that $\left(P_{0}-\alpha\right)^{-1}|V|^{1 / 2}$ is injective from $B$ to $A$. This ends the proof.
From this proposition, we can see that there is a one-to-one corresponding between discrete eigenvalues of $P(\lambda)$ and discrete eigenvalues of $K(\alpha)$. Thus we study discrete eigenvalue of $K(\alpha)$ in the next section.

### 3.3 The case $0 \notin \sigma_{\infty}$

If $P_{0}$ and $V$ are defined as before, we will show that if $P_{0}+V$ has the eigenvalue less than 0 , then the smallest eigenvalue of $P_{0}+V$ is simple. We use Theorem XIII. 45 [54] to prove that.

Proposition 3.5. Suppose $P_{0}+V$ has an eigenvalue at the bottom of its spectrum. If $0 \notin \sigma_{\infty}$, then this eigenvalue is simple and the corresponding eigenfunction can be chosen to be a positive function.

Proof. Let $0 \leq \chi(t) \leq 1$ be a smooth function such that $\chi(t)=1$ if $|t|<1$ and $\chi(t)=0$ if $t>2$. Let $\chi_{n}(t)=\chi(n t)$. Let

By Theorem XIII45 [54], we need only to prove that $P_{n}$ converges to $P$, and $P-V_{n}$ converges to $-\Delta$ in the strong resolvent norm sense. By min-max principle, we know that if $\mu<P$, then
$\mu<P_{n}$, because $0 \leq \chi(t) \leq 1$. It suffices to show that there exists some $\mu_{0}<\sigma(P)$, such that $\forall \phi \in D(P)$, the domain of $P$,

when $n \rightarrow \infty$. The proof of (3.21) and the proof of (3.22) are similar. So we need only to prove (3.21). $q^{+}(\theta)$ and $q^{-}(\theta)$ are given by (3.6), then

& \left.+\left(-\Delta+\frac{q^{+}(\theta)}{r^{2}}+1\right)^{-1 / 2}\left(V-\mu_{0}-1\right)\left(-\Delta+\frac{q^{+}(\theta)}{r^{2}}+1\right)^{-1 / 2}\right]^{-1}\left(-\Delta+\frac{q^{+}(\theta)}{r^{2}}+1\right)^{-1 / 2} \\
\equiv & A_{n}\left(-\Delta+\frac{q^{+}(\theta)}{r^{2}}+1\right)^{-1 / 2} .

From (3.8), we know that $\left(-\Delta+\frac{q^{+}(\theta)}{r^{2}}+1\right)^{-1 / 2}\left(1-\chi_{n}(r)\right)^{\frac{q^{-}(\theta)}{r^{2}}}\left(-\Delta+\frac{q^{+}(\theta)}{r^{2}}+1\right)^{-1 / 2} \leq \alpha_{0} I$, and choose $\mu_{0}$ so negative such that $V-\mu_{0}-1>0$, then $A_{n}$ are uniform bounded operators. Similarly, one has

with $B$ is a bounded operator. Then

= & \left(P_{n}-\mu_{0}\right)^{-1} \chi_{n}(r) \frac{q(\theta)}{r^{2}}\left(P-\mu_{0}\right)^{-1} \phi \\
= & A_{n}\left(-\Delta+\frac{q^{+}(\theta)}{r^{2}}+1\right)^{-1 / 2} \chi_{n}(r) \frac{q(\theta)}{r^{2}}\left(-\Delta+\frac{q^{+}(\theta)}{r^{2}}+1\right)^{-1 / 2} B \phi
\end{aligned}
$$

by (3.8),

\left(-\Delta+\frac{q^{+}(\theta)}{r^{2}}+1\right)^{-1 / 2} \frac{q^{-}(\theta)}{r^{2}}\left(-\Delta+\frac{q^{+}(\theta)}{r^{2}}+1\right)^{-1 / 2} \leq \alpha_{0}

and

Therefore,

Similarly, we can prove (3.22). This ends the proof.

Lemma 3.6. Assume $0 \notin \sigma_{\infty}$, and $\rho_{0}>3$. If $\sigma_{1} \neq \emptyset$, then 0 is not the eigenvalue of $P\left(\lambda_{0}\right)$.
Proof. If 0 is the eigenvalue of $P\left(\lambda_{0}\right)$. Then there exists a function $u \in L^{2}\left(\mathbb{R}^{n}\right)$ such that $P(\lambda) u=0$. By Proposition 3.5, one has that $u$ can be chosen to be a positive function. By Theorem 3.1 [69],

with $\tilde{u} \in L^{2}\left(\mathbb{R}^{n}\right)$. Since $u$ and $\varphi_{v}^{(1)}$ are positive, $V \leq 0$ is a non-zero function, we have $u \notin L^{2}\left(\mathbb{R}^{n}\right)$. This is contradictory to that $u$ is the eigenfunction of $P\left(\lambda_{0}\right)$.

In the following of this section, we suppose that $n \geq 3$.
Proposition 3.7. Assume $0 \notin \sigma_{\infty}$ and $n \geq 3 . P_{0} F_{0} u=u$, for any $u \in H^{-1, s}, s>1 ; F_{0} P_{0} u=u$ for $u \in H^{1,-s}$ and $P_{0} u \in H^{-1, s}, s>1$.

Proof. If $u \in H^{-1, s}$, then $F_{0} u \in H^{1,-s}$. For any test function $\phi \in C_{0}^{\infty}\left(\mathbb{R}^{n}\right)$, we have $\left\langle P_{0} F_{0} u, \phi\right\rangle=\left\langle u, F_{0} P_{0} \phi\right\rangle$. If $0 \notin \sigma_{\infty}$, we have $\lim _{z \rightarrow 0}\left(P_{0}-z\right)^{-1}=F_{0}$ in $H^{-1, s}$ for $\mathfrak{J} z>0$. It follows $\left\langle u, F_{0} P_{0} \phi\right\rangle=\lim _{z \rightarrow 0}\left\langle u,\left(P_{0}-z\right)^{-1} P_{0} \phi\right\rangle=\lim _{z \rightarrow 0}\left\langle u, \phi-z\left(P_{0}-z\right)^{-1} \phi\right\rangle=\langle u, \phi\rangle$, because $\phi$ and $P_{0} \phi$ belong to $H^{-1, s}$. Hence, $P_{0} F_{0} u=u$ in $H^{-1, s}$.

On the other hand, if $P_{0} u \in H^{-1, s}$, we have $P_{0} F_{0} P_{0} u=P_{0} u$ in $H^{-1, s}$. It follows $P_{0}\left(F_{0} P_{0} u-\right.$ $u)=0$. Then $F_{0} P_{0} u=u$, because $F_{0} P_{0} u-u \in H^{1,-s}$ and $P_{0}$ has no kernel in $H^{1,-s}, s>1$.

Proposition 3.8. Assume $0 \notin \sigma_{\infty}, n \geq 3$ and $\rho_{0}>2$. For $\lambda \geq \lambda_{0}$, $\operatorname{dim} \mathcal{N}(\lambda)$ is equal to the multiplicity of $\lambda^{-1}$ as the eigenvalue of $K(0)$.

Proof. We use the method used in the proof of Proposition 3.4. First, for $u \in \mathcal{N}(\lambda)$, one has $\left(1+\lambda F_{0} V\right) u=0$, by Proposition 3.7. Then $K(0) \tilde{u}=\lambda^{-1} \tilde{u}$ with $\tilde{u}=|V|^{1 / 2} u$. Due to $|V| \leq C\langle x\rangle^{-\rho_{0}}$ with some $\rho_{0}>2$, one has $\tilde{u} \in L^{2}\left(\mathbb{R}^{n}\right)$. By the same argument as in Proposition 3.4 , one can show that $|V|^{1 / 2}$ is injective from $\mathcal{N}(\lambda)$ to $\left\{\psi \in L^{2}\left(\mathbb{R}^{n}\right) ; K(0) \psi=\lambda^{-1} \psi\right\}$. This means that $\operatorname{dim} \mathcal{N}(\lambda)$ is at most the multiplicity of $\lambda^{-1}$ as the eigenvalue of $K(0)$.

On the other hand, if $\lambda^{-1}$ is the eigenvalue of $K(0)$. Then there exists a function $\tilde{u} \in L^{2}\left(\mathbb{R}^{n}\right)$ such that $K(0) \tilde{u}=\lambda^{-1} \tilde{u}$. Let $u=F_{0}|V|^{1 / 2} \tilde{u}$. Note that $|V|^{1 / 2} \tilde{u} \in H^{-1, \rho_{0} / 2}$, since $|V| \leq C\langle x\rangle^{-\rho_{0}}$ with some $\rho_{0}>2$. It follows $u \in H^{1,-\rho_{0} / 2}$ because $F_{0}$ is a bounded operator in $\mathcal{L}(-1, s ; 1,-s)$ for $s>1$. Then

$$
P(\lambda) u=P_{0} F_{0}|V|^{1 / 2} \tilde{u}+\lambda V F_{0}|V|^{1 / 2} \tilde{u}=|V|^{1 / 2} \tilde{u}-\lambda|V|^{1 / 2}|V|^{1 / 2} F_{0}|V|^{1 / 2} \tilde{u}=0
$$

This implies $u \in \mathcal{N}(\lambda)$. As in Proposition 3.4, we can get that $F_{0}|V|^{1 / 2}$ is the injective from $\left\{\psi \in L^{2}\left(\mathbb{R}^{n}\right) ; K(0) \psi=\lambda^{-1} \psi\right\}$ to $\mathcal{N}(\lambda)$. It follows that the multiplicity of $\lambda^{-1}$ as the eigenvalue of $K(0)$ is at most $\operatorname{dim} \mathcal{N}(\lambda)$.

Proposition 3.9. Assume $0 \notin \sigma_{\infty}$. $K(\alpha)$ is a compact operator for $\alpha \leq 0$. And $K(\alpha)$ convergent to $K(0)$ in operator norm sense.

Proof. For $\alpha<0, K(\alpha)=|V|^{1 / 2}\left(P_{0}-\alpha\right)^{-1}|V|^{1 / 2}$. Since $\left(P_{0}-\alpha\right)^{-1}$ is a bounded operator from $L^{2}\left(\mathbb{R}^{n}\right)$ to $H^{1}\left(\mathbb{R}^{n}\right)$, and V is a compact operator from $H^{1}\left(\mathbb{R}^{n}\right)$ to $L^{2}\left(\mathbb{R}^{n}\right)$. Then $V\left(P_{0}-\alpha\right)^{-1}$ is a compact operator on $L^{2}\left(\mathbb{R}^{n}\right)$. So is $K(\alpha)$. Because

and if $\rho_{0}>2$, then $|V|^{1 / 2} R_{0}^{(0)}|V|^{1 / 2}=o\left(|\alpha|^{\epsilon}\right)$ in $L^{2}\left(\mathbb{R}^{n}\right)$. Hence, $K(\alpha) \rightarrow K(0)$ in operator norm sense, as $\alpha \rightarrow 0$. This means $K(0)$ is a compact operator.

Lemma 3.10. Suppose $A_{1}, A_{2}$ are two bounded self-adjoint operators on Hilbert space H. Set

Proof. By the definition of $\mu_{n}\left(A_{i}\right)$, one has

\leq & \sup _{\operatorname{suf}_{1}}\left[\operatorname { i n f } \operatorname { i n f } _ { 1 , \cdots , \phi _ { n } } \left(\psi \psi=1, \psi \in\left[\phi_{1}, \cdots, \phi_{n}\right]^{\perp}\right.\right.
\end{array}\left(\psi, A_{1} \psi\right)-\sin _{\|\psi\|=1, \psi \in\left[\phi_{1}, \cdots, \phi_{n}\right]^{\perp}}\left(\psi, A_{2} \psi\right)\right]\right)

Similarly, we have $\mu_{n}\left(A_{2}\right)-\mu_{n}\left(A_{1}\right) \leq\left\|A_{1}-A_{2}\right\|$. This ends the proof.
Lemma 3.11. Suppose $T(\alpha)$ is a family of compact self-adjoint operators on some separable Hilbert space $H$, and $T(\alpha)=T_{0}+o\left(|\alpha|^{\epsilon}\right)$, for $\alpha$ near 0 . Set

(a). $\mu_{i}(\alpha)$ is the eigenvalue of $T(\alpha)$ and $\mu_{i}(\alpha)$ converges when $\alpha \rightarrow 0$. Moreover, if $\mu_{i}(\alpha) \rightarrow$ $\mu_{i}$, then $\mu_{i}$ is the eigenvalue of $T_{0}$.
(b). Suppose $E_{0} \neq 0$ is the eigenvalue of $T_{0}$ of multiplicity $m$. Then there are $m$ eigenvalues (counting multiplicity), $E_{i}(\alpha)(1 \leq i \leq m)$, of $T(\alpha)$ near $E_{0}$. Moreover, we can choose $\left\{\phi_{i}(\alpha) ; 1 \leq i \leq m\right\}$ such that $\left(\phi_{i}(\alpha), \phi_{j}(\alpha)\right)=\delta_{i j}(1 \leq i, j \leq m), \phi_{i}(\alpha)$ is the eigenvector of $T(\alpha)$ corresponding to $E_{i}(\alpha)\left(E_{i}(\alpha) \rightarrow E_{0}\right)$, and $\phi_{i}(\alpha)$ converges as $\alpha \rightarrow 0$. If $\phi_{i}(\alpha)$ converges to $\phi_{i}$, then $\phi_{i}$ is the eigenvector of $T_{0}$ corresponding to $E_{0}$.

Proof. (a). By min-max principle, we know that $\mu_{i}(\alpha)$ is an eigenvalue of $T(\alpha)$. By Lemma 3.10, one has

\left|\mu_{i}(\alpha)-\mu_{i}(0)\right| \leq\left\|T(\alpha)-T_{0}\right\|=O\left(|\alpha|^{\epsilon}\right)
$$

It follows $\mu_{i}(\alpha)$ converges to the eigenvalue of $T_{0}$.
(b). Because $T_{0}$ is a compact operator, and $E_{0} \neq 0$ is the eigenvalue of $T_{0}$, then $E_{0}$ is a discrete spectrum of $T_{0}$. Then there exists a constant $\delta>0$ small enough, such that $T_{0}$ has only one eigenvalue, $E_{0}$, in $B\left(E_{0}, \delta\right)\left(=\left\{z \in \mathbb{C} ;\left|z-E_{0}\right|<\delta\right\}\right)$. For $\alpha$ small enough, $T(\alpha)$ has exactly $m$ eigenvalues ( counting multiplicity ) in $B\left(E_{0}, \delta\right)$ because the eigenvalues of $T(\alpha)$ converge to the eigenvalues of $T_{0}$, by part (a) of the lemma. Suppose the $m$ eigenvalues, near $E_{0}$, of $T(\alpha)$ are $E_{1}(\alpha), E_{2}(\alpha), \cdots, E_{m}(\alpha)$, and the corresponding eigenvectors are $\psi_{1}(\alpha), \psi_{2}(\alpha), \cdots, \psi_{m}(\alpha)$ such that $\left(\psi_{i}(\alpha), \psi_{j}(\alpha)\right)=\delta_{i j}$. Then there exist exactly $m$ eigenvalues (counting multiplicity), $e_{i}(\beta), e_{i+1}(\beta), \cdots, e_{i+m-1}(\beta)$, of $T(\beta)$ near $e_{i}$. By Lemma 3.11,

Suppose $\phi_{i}(\alpha) \rightarrow \phi_{i}$ as $\alpha \rightarrow 0$, then $\phi_{i}(1 \leq i \leq m)$ is the eigenfunction of $K(0)$ corresponding to $\mu_{1}$, and $\left\langle\phi_{i}, \phi_{j}\right\rangle=\delta_{i j}$ for $1 \leq i, j \leq m$. Note that $\mu_{1}=\lambda_{0}^{-1}$, one has $P\left(\lambda_{0}\right) \psi_{i}=0(1 \leq i \leq m)$ with $\psi_{i}=F_{0}|V|^{1 / 2} \phi_{i} \in H^{1,-s}, s>1$. By Lemma 3.6, we know that 0 is not the eigenvalue of $P\left(\lambda_{0}\right)$, then $\psi_{i}(1 \leq i \leq m)$ is the 0 resonance of $P\left(\lambda_{0}\right)$. Suppose that $\psi_{i}(1 \leq i \leq m)$ is $v_{i}$-resonant state of $P\left(\lambda_{0}\right)$. Then $0<v_{i} \leq 1$ by Theorem 3.1 [70]. Then, we have

Lemma 3.14. Assume $n \geq 3, \sigma_{1} \neq \emptyset$ and $0 \notin \sigma_{\infty} . \psi_{i}, \phi_{i}, \mu_{i}(\alpha), \mu_{i}$ are defined as above. Then $\left.\left.\left\langle\phi_{i},\right| V\right|^{1 / 2} G_{v_{i}, 0} \pi_{v_{i}}|V|^{1 / 2} \phi_{i}\right\rangle \neq 0$, and $\left.\left.\left\langle\phi_{i},\right| V\right|^{1 / 2} G_{v, 0} \pi_{v}|V|^{1 / 2} \phi_{i}\right\rangle=0$ for $v<v_{i}$. Moreover, if $v_{j}<1$, $\mu_{j}(\alpha)=c \alpha^{\nu_{j}}+o\left(\alpha^{\nu_{j}}\right)$ with some $c \neq 0$; if $v_{j}=1, \mu_{j}(\alpha)=c \alpha \ln \alpha+o(\alpha)$ with some $c \neq 0$ for $1 \leq j \leq m$.

Proof. From the definition of $\phi_{j}$, one has

where $C_{v} \neq 0$ is a constant dependent on $v$. Hence, if $\left.\left.\left\langle\phi_{j},\right| V\right|^{1 / 2} G_{v, 0} \pi_{v}|V|^{1 / 2} \phi_{j}\right\rangle=0$, one has $\left\langle V \psi_{j}, \frac{1}{|x|^{\frac{1}{2}(n-2)-v}} \varphi_{v}\right\rangle=0$. It follows $\left.\left.\left\langle\phi_{j},\right| V\right|^{1 / 2} G_{v, 0} \pi_{v}|V|^{1 / 2} \phi_{k}\right\rangle=0$. If $\phi_{j}$ is $v_{j^{-}}$resonant state of $P\left(\lambda_{0}\right)$, then by Theorem 3.1 [70], one has $\left.\left.\left\langle\phi_{j},\right| V\right|^{1 / 2} G_{v, 0} \pi_{v}|V|^{1 / 2} \phi_{j}\right\rangle \neq 0$, and $\left.\left.\left\langle\phi_{j},\right| V\right|^{1 / 2} G_{v, 0} \pi_{v}|V|^{1 / 2} \phi_{j}\right\rangle=0$ for all $v \in \sigma_{\infty}, v<v_{j}$. Theorem 3.15. Assume $0 \notin \sigma_{\infty}$ and $n \geq 3$. Suppose that $e_{1}(\lambda)$ is the ground state energy (the smallest eigenvalue) of $P(\lambda) . \phi$ is defined in Lemma 3.13. If $\rho_{0}>6$, one of three exclusive situations holds :
(a). If $\sigma_{1}=\emptyset$, then $e_{1}(\lambda)=-c\left(\lambda-\lambda_{0}\right)+o\left(\lambda-\lambda_{0}\right), c=\left(\lambda_{0}\left\|F_{0}|V|^{\frac{1}{2}} \phi\right\|\right)^{-2} \neq 0$;
(b). If $v_{0}=1$, then $\left.e_{1}(\lambda)=-c \frac{\lambda-\lambda_{0}}{\ln \left(\lambda-\lambda_{0}\right)}+o\left(\frac{\lambda-\lambda_{0}}{\ln \left(\lambda-\lambda_{0}\right)}\right), c=\left.\lambda_{0}^{-2}\langle\phi| V\right|^{,1 / 2} G_{1,0} \pi_{1}|V|^{1 / 2} \phi\right\rangle^{-1} \neq 0$;

Because $e_{1}(\lambda)$ is the simple eigenvalue of $P(\lambda)$, then $\lambda^{-1}$ is the simple eigenvalue of $K\left(e_{1}(\lambda)\right)$. And we also have that $\lambda^{-1}$ is the biggest eigenvalue of $K\left(e_{1}(\lambda)\right)$. If not, suppose that $a>\lambda^{-1}$ is the eigenvalue of $K\left(e_{1}(\lambda)\right)$, then by the continuous and monotonous of the eigenvalue of $K\left(e_{1}(\lambda)\right)$ with respect to $\lambda$, we know that there exists a constant $\lambda^{\prime}<\lambda$ such that $\lambda \in \sigma\left(K\left(e_{1}\left(\lambda^{\prime}\right)\right)\right)$. It follows that $e_{1}\left(\lambda^{\prime}\right)<e_{1}(\lambda)$ is the eigenvalue of $P_{0}+\lambda V$. This is contradictory to that $e_{1}(\lambda)$ is the smallest eigenvalue. By Lemma 3.13, we know the normalized eigenfunction, $\tilde{u}(\lambda)$, of $K\left(e_{1}(\lambda)\right.$ ) converges to $\phi$. It follows $\tilde{u}(\lambda)=\frac{P_{\lambda} \phi}{\left\|P_{\lambda} \phi\right\|}$. Then

So, $\mu(\alpha)=\lambda_{0}^{-1}+c_{1} \alpha+o\left(|\alpha|^{1+\epsilon}\right)$, with $c_{1}=\left\|F_{0}|V|^{\frac{1}{2}} \phi\right\|^{2}$. By the Proposition 3.4, one has $\mu(e(\lambda))=\lambda^{-1}$. It follows

We say that there are $m$ eigenvalues of $P(\lambda)$ converge to 0 at $\lambda_{0}$, if there exist some $k$ such that $\lim _{\lambda \downarrow \lambda_{0}} e_{i}(\lambda)=0$ for $k+1 \leq i \leq k+m$; $e_{i}(\lambda) \neq 0(i=k+1, \cdots, i=k+m)$ for any $\lambda>\lambda_{0} ; e_{i}\left(\lambda_{0}\right) \neq 0$ for some $i \leq k$. Let $u_{i}(\lambda)$ be the eigenfunction of $P(\lambda)$, then $\tilde{u}_{i}(\lambda) \equiv|V|^{1 / 2} u_{i}(\lambda)$ is the eigenfunction of $K\left(e_{i}(\lambda)\right)$ corresponding to $\lambda^{-1}$. Because $K\left(e_{i}(\lambda)\right)$ converges to $K(0)$ as $\lambda \rightarrow 0$, by Lemma 3.11, one can choose $u_{i}(\lambda)$ such $\tilde{u}_{i}(\lambda)$ converges as $\lambda \rightarrow \lambda_{0}$ and $\left\langle\tilde{u}_{i}(\lambda), \tilde{u}_{j}(\lambda)\right\rangle=\delta_{i j}$. Let $\tilde{u}_{i}(\lambda) \rightarrow \phi_{i}$ in $L^{2}\left(\mathbb{R}^{n}\right)$. Then, $K(0) \phi_{i}=\lambda_{0}^{-1} \phi_{i}$ and $\left\langle\phi_{i}, \phi_{j}\right\rangle=\delta_{i j}$.

Theorem 3.16. Assume $0 \notin \sigma_{\infty}$ and $n \geq 3$. $e_{i}(\lambda), \phi_{i}(1 \leq i \leq m)$ are defined as above, $v_{i}$ is defined as in Lemma 3.14. If $\rho_{0}>6$, one of three exclusive situations holds :
(a). If $\sigma_{1}=\emptyset$, then $m=1$ and $e_{1}(\lambda)=-c\left(\lambda-\lambda_{0}\right)+o\left(\lambda-\lambda_{0}\right), c=\left(\lambda_{0}\left\|F_{0}|V|^{\frac{1}{2}} \phi_{1}\right\|\right)^{-2} \neq 0$;
(b). If $v_{i}=1$, then $\left.e_{i}(\lambda)=-c \frac{\left(\lambda-\lambda_{0}\right)}{\ln \left(\lambda-\lambda_{0}\right)}+o\left(\lambda-\lambda_{0}\right), c=\left.\lambda_{0}^{-2}\left\langle\phi_{i},\right| V\right|^{1 / 2} G_{1,0} \pi_{1}|V|^{1 / 2} \phi_{i}\right\rangle^{-1} \neq 0$;
(c). If $v_{i}<1$, then $\left.e_{i}(\lambda)=c\left(\left(\lambda-\lambda_{0}\right)^{\frac{1}{v_{i}}}\right)+o\left(\left(\lambda-\lambda_{0}\right)^{\frac{1}{v_{i}}}\right), c=\left.\lambda_{0}^{-2}\left\langle\phi_{i},\right| V\right|^{1 / 2} G_{v_{i}, 0} \pi_{v_{i}}|V|^{1 / 2} \phi_{i}\right\rangle^{-1} \neq$ 0.

Proof. (a). If $\sigma_{1}=\emptyset$, by Theorem 3.2, one has

[70], one has $\psi_{i} \in L^{2}$. This means that $\phi_{i}$ is the eigenfunction of $P\left(\lambda_{0}\right)$ corresponding to 0 . Because 0 is the simple eigenvalue of $P\left(\lambda_{0}\right)$, then $m=1$. It is clearly, this case is the same as part(a) of Theorem 3.15.
(b). If $v_{i}=1$, by Lemma 3.14, one has

### 3.4 Zero resonance in coupling constant limit

In this section, we study the multiplicity of zero as the resonance of $P$. We have the following result. Suppose $\sum_{0<v \leq 1} n_{v}=m$. If $m>0$, then $P\left(\lambda_{0}\right)$ has at most $m$ linear independent zero resonance solutions, by Corollary 4.2[70].

Theorem 3.17. Assume $0 \notin \sigma_{\infty}$ and $n \geq 3$. Suppose $\sum_{0<v \leq 1} n_{v}=m$. If $m>0$, then there exists $\lambda_{1}>\lambda_{0}$ such that for all $\lambda_{0}<\lambda<\lambda_{1}$, the multiplicity of zero as the resonance of $P\left(\lambda_{0}\right)$ is equal to the number of eigenvalues, less than 0 , of $P(\lambda)$.

Proof.Let $n(\lambda, \alpha)$ denote the multiplicity of $\lambda^{-1}$ as the eigenvalue of $K(\alpha)$. Let $\lambda_{1}>\lambda_{0}$ such that for any $\lambda_{0}<\lambda<\lambda_{1}, \lambda^{-1}$ is not the eigenvalue of $K(0)$. Then,

& \operatorname{dim}\left\{u \in H^{1,-s}\left(\mathbb{R}^{n}\right) \backslash L^{2}\left(\mathbb{R}^{n}\right) ; P\left(\lambda_{0}\right) u=0\right\} \\
= & \mathcal{N}\left(\lambda_{0}\right) \\
= & \operatorname{dim}\left\{\phi \in L^{2}\left(\mathbb{R}^{n}\right) ; K(0) \phi=\lambda_{0} \phi\right\} \\
= & \#\left\{\mu_{i}(\lambda) \in \sigma(K(\alpha)) ; \mu_{i}(\alpha) \rightarrow \lambda_{0}^{-1} \text { as } \alpha \rightarrow 0\right\} \text { ( counting multiplicity ) } \\
= & \sum_{\alpha} n(\lambda, \alpha) \quad\left(\lambda_{0}<\lambda<\lambda_{1}\right) \\
= & \#\left\{\alpha ; \alpha \in \sigma\left(P_{0}+\lambda V\right) ;\right\} \text { (counting multiplicity ) }
\end{aligned}
$$

In the first step, we use that 0 is not the eigenvalue of $P\left(\lambda_{0}\right)$, by Lemma 3.6. In the second step, we use Proposition 3.8. In the third step, we use Proposition 3.9 and Lemma 3.11. In the fourth step, we use that the eigenvalue of $K(\alpha)$ is continuous and monotonous increasing with respect to $\alpha$, and the eigenvalue of $K(\alpha) \rightarrow \lambda_{0}^{-1}$. Hence, for any $\lambda_{0}<\lambda<\lambda_{1}$, there exist $\alpha_{i}$ such that $\mu_{i}\left(\alpha_{i}\right)=\lambda^{-1}$ for all $i$ such that $\mu_{i}(\alpha) \rightarrow \lambda_{0}^{-1}$. In the last step, we use Proposition 3.4.

### 3.5 Asymptotic expansion of resolvent of Schrödinger operator with critical potential

This section is concerned with the Schrödinger operator $P=-\Delta+\tilde{V}$ in $L^{2}\left(\mathbb{R}^{n}\right)$ for some $n \geq 2$. First we make some assumptions on $\tilde{V}$.

Assumption on $\tilde{V}$ :
(1). $\tilde{V}=V_{1}+V_{2}$;
(2). $V_{1} \in C\left(\mathbb{R}^{n}\right)$, and there exists a constant $R$ such that $\left|V_{1}(x)\right|=\frac{q(\theta)}{r^{2}}$ when $|x| \geq R$, where $(r, \theta)$ is the polar coordinate of $\mathbb{R}^{n}, q(\theta)$ is a real continuous function on sphere $\mathbb{S}^{n-1}$.
(3). $V_{2} \in C\left(\mathbb{R}^{n}\right)$, and there exists some $\rho_{0}>2$ such that $\left|V_{2}(x)\right| \leq c\langle x\rangle^{-\rho_{0}}$.

Assume $-\Delta_{s}+q(\theta) \geq-\frac{1}{4}(n-2)^{2}$ on $L^{2}\left(\mathbb{S}^{n-1}\right)$ in this section. Here $-\Delta_{s}$ is the Laplace operator on sphere $\mathbb{S}^{n-1}$. In this section, we want to study the asymptotic expansion of $(P-z)^{-1}$ for $z \in \mathbb{C} \backslash \mathbb{R}, z$ near 0 , in $\mathcal{L}(-1, s ; 1,-s)$ for appropriate $s$.

Set $R(z)=(P-z)^{-1}$. Let $R_{1}>R$. Let $0 \leq \chi_{j} \leq 1, j=1,2$ be smooth functions on $\mathbb{R}^{n}$ such that $\operatorname{supp} \chi_{1} \subset B\left(0, R_{1}\right), \chi_{1}(x)=1$ when $|x|<R$ and

$$

Set

P_{0}=-\Delta+\frac{q(\theta)}{r^{2}} ; \quad \quad \tilde{P}_{0}=\chi_{1}(-\Delta) \chi_{1}+\chi_{2} P_{0} \chi_{2}
$$

Then

& \tilde{P}_{0}=P_{0}-\frac{\chi_{1}^{2}}{r^{2}} q(\theta)-\sum_{i=1}^{2}\left|\nabla \chi_{i}\right|^{2}=P_{0}-W, \\
& P=P_{0}+\left(\tilde{V}-\frac{q(\theta)}{r^{2}}\right)=P_{0}+V
\end{aligned}
$$

where

W=\frac{\chi_{1}^{2}}{r^{2}} q(\theta)+\sum_{i=1}^{2}\left|\nabla \chi_{i}\right|^{2}, V=-\frac{\chi_{1}^{2}}{r^{2}} q(\theta)+\tilde{W}

$\tilde{W}$ is a continuous function and satisfies $|\tilde{W}| \leq C\langle x\rangle^{-\rho_{0}}$. Under the above notation, we can see that the Schrödinger operator $P$ can be considered as the perturbation of the model operator $P_{0}$. In the following we use the asymptotic expansion of $\left(P_{0}-z\right)^{-1}$ to get the expansion of $R(z)$. This
problem has been studied by X.P. Wang (see [69]). Note that our potential $V$ has singularity at 0 . We can not use his result directly. We use his method to get the asymptotic expansion of $R(z)$ for $\mathfrak{J} z \neq 0$ and $z$ near 0 .

Definition 3.18. Set $\mathcal{N}=\left\{u ; P u=0, u \in H^{1,-s}, \forall s>1\right\}$. We say that 0 is the regular point of $P$ if $\mathcal{N}=\{0\}$.

As in [69], we need to get the asymptotic expansion of 0 resonant states of $P$. Set $v_{0}=\min \left\{v ; v \in \sigma_{\infty}\right\}$. Let $0 \leq \tilde{\chi}_{1}, \tilde{\chi}_{2} \leq 1$ belong to $C^{\infty}\left(\mathbb{R}_{+}\right)$such that $\tilde{\chi}_{1}(r)=1$ on $r \leq 1$, and $\tilde{\chi}_{1}+\tilde{\chi}_{2}=1$.

Theorem 3.19. Assume $\rho_{0}>3$ and that $0 \notin \sigma_{1}$. Let $u \in \mathcal{N}$. Then,

where $\tilde{u} \in L^{2}$, and $<\cdot, \cdot>$ is the scalar product in $L^{2}\left(\mathbb{S}^{n-1}\right)$. In particular,

Remark 3.20. This theorem has been proved for $P=-\Delta+\frac{q(\theta)}{r^{2}}+V$ with $|V| \leq C\langle x\rangle^{-\rho}$ by X.P. Wang (see [70]). We use the same method with a little change.

r^{\nu^{\prime}+1}(V u)_{v, j}=r^{\nu^{\prime}+1}\left(-\frac{\chi_{1}^{2}}{r^{2}} q(\theta) u\right)_{v, j}+r^{\nu^{\prime}+1}(\tilde{W} u)_{v, j} \in L^{2}\left(\mathbb{R}_{+}, r^{n-1} d r\right)
$$

Then $\tilde{u}_{v, j}^{(1)}\left(e^{t}\right)$ and $\tilde{u}_{v, j}^{(2)}\left(e^{t}\right)$ can be bounded by

& \quad \leq \frac{1}{2 v}\left\{\int_{t}^{\infty} e^{2 v(s-t)-2 v^{\prime} s} d s\right\}^{1 / 2}\left\|e^{\left(v^{\prime}+\frac{n+2}{2}\right) s}(V u)_{v, j}\right\|_{L^{2}(\mathbb{R} ; d s)} \\
& \quad \leq C e^{-v^{\prime} t}\left\|r^{v^{\prime}+1}(V u)_{v, j}\right\|_{L^{2}\left(\mathbb{R}+; r^{n-1} d r\right)}
\end{aligned}
$$

with $1<v^{\prime}<\rho_{0}-2 . \tilde{\chi}_{2} v_{v, j}^{(1)}$ and $\tilde{\chi}_{2} v_{v, j}^{(2)}$ give rise to the $L^{2}$-remainder term of $u_{v, j}$.

For $v>1$, set $\tilde{u}_{v, j}\left(e^{t}\right)=\tilde{u}_{v, j}^{(1)}+\tilde{u}_{v, j}^{(2)}$ with

& \quad \leq C e^{-v^{\prime} t}\left\|r^{\nu^{\prime}+1}(V u)_{v, j}\right\|_{L^{2}\left(\mathbb{R}+; r^{n-1} d r\right)}
\end{aligned}

for $1<v^{\prime}<\min \left\{\rho_{0}-2, \min \left\{v \in \sigma_{\infty}\right\} \backslash \sigma_{1}\right\}$, and

& \frac{1}{2 v} \int_{t}^{\infty} e^{v(t-s)} e^{\frac{n+2}{2} s}\left|(V u)_{v, j}\left(e^{s}\right)\right| d s \\
& \quad \leq \frac{1}{2 v}\left\{\int_{t}^{\infty} e^{2 v(t-s)+2 v^{\prime}(t-s)-2 v^{\prime} t} d s\right\}^{1 / 2}\left\|e^{\left(v^{\prime}+\frac{n+2}{2}\right) s}(V u)_{v, j}\right\|_{L^{2}(\mathbb{R} ; d s)} \\
& \quad \leq C e^{-v^{\prime} t}\left\|r^{v^{\prime}+1}(V u)_{v, j}\right\|_{L^{2}\left(\mathbb{R}+; r^{n-1} d r\right)}

for $1<v^{\prime}<\min \left\{\rho_{0}-2, \min \left\{v \in \sigma_{\infty}\right\} \backslash \sigma_{1}\right\}$. It follows that $\tilde{\chi}_{2} u_{v, j} \in L^{2}\left(\mathbb{R}^{n}\right)$.
Proposition 3.21. Assume $\rho_{0}>3$ and that $0 \notin \sigma_{1} .0$ is a regular point of $\tilde{P}_{0}$.
Proof.By Theorem 3.1 [69], we deduce that $u \in L^{2,-s^{\prime}}\left(\mathbb{R}^{n}\right)$ with $s^{\prime}=1-v_{0} / 2$, because $v_{0}>0$, and $u \in H^{1,-s}\left(\mathbb{R}^{n}\right), \forall s>1$. Let $0 \leq \tilde{\chi}(t) \leq 1$ be a smooth function on $\mathbb{R}$ such that $\operatorname{supp} \tilde{\chi} \subset B(0,2), \tilde{\chi}(t)=1$ on $|t|<1$. Let $\tilde{\chi}_{m}(t)=\tilde{\chi}\left(\frac{t}{m}\right)$. Then $\left\langle\tilde{\chi}_{m} u, \tilde{P}_{0} \tilde{\chi}_{m} u\right\rangle \geq c\left\langle\tilde{\chi}_{m} u, \frac{1}{r^{2}} \tilde{\chi}_{m} u\right\rangle$ with some $c>0$. It suffices to prove

when $m \rightarrow \infty$. This implies that $\left\langle u, \tilde{P}_{0} u\right\rangle=\lim _{m \rightarrow 0}\left\langle\tilde{\chi}_{m} u, \tilde{P}_{0} \tilde{\chi}_{m} u\right\rangle \geq\left\langle u, \frac{1}{r^{2}} u\right\rangle$ with some $c>0$. It follows that ker $\tilde{P}_{0}=\{0\}$ in $H^{1,-s}\left(\mathbb{R}^{n}\right)$.

For $z \in \mathbb{C} \backslash \mathbb{R}^{+}$, z near 0 , one has

& A_{1}=-\left[-\Delta, \chi_{1}^{2}\right] \chi_{1}+\chi_{1}+\frac{q(\theta)}{r^{2}} \chi_{1} \chi_{2}^{2}-\left[\chi_{1} \chi_{2},-\Delta\right] \chi_{2} \\
& A_{2}=\left[\chi_{1} \chi_{2},-\Delta\right] \chi_{1}+\frac{q(\theta)}{r^{2}} \chi_{1}^{2} \chi_{2}-\left[\chi_{2}^{2},-\Delta\right] \chi_{2}
\end{aligned}
$$

Assume $0 \notin \sigma_{\infty}$. Then one has $\left(P_{0}-z\right)^{-1}=F_{0}+o(1)$ in $\mathcal{L}(-1, s ; 1,-s)$ with $s>1$, for $z$ near $0, \mathfrak{J} z \neq 0 . K(0) \in \mathcal{L}(-1, s ; 1,-s), s>1$ and close to 1 .

Lemma 3.22. Assume $0 \notin \sigma_{\infty}, n \geq 3$. $\operatorname{ker}(1-K(0))=\{0\}$ and $1-K(0)$ is a Fredhlom operator in $\mathcal{L}(-1, s ; 1,-s), s>1$.

Proof. If $u \in H^{1,-s}$ belong to $\operatorname{ker}(1+K(0))$, then $\tilde{P}_{0} u=\tilde{P}_{0} K(0) u$. It is easy to check that $\tilde{P}_{0} K(0) u \in H^{-1, s}$, for some $s>1$. This means that $\tilde{u}=\tilde{P}_{0} K(0) u$ satisfies

This ends the proof.

By Lemma 3.22 and Proposition 3.21, one has $1-K(0)$ has bounded inverse on $H^{1,-s}$. It follows that $(1-K(z))^{-1}$ exists for $z$ small. We can use Theorem 2.2 [69] to get the asymptotic expansion of $\left(\tilde{P}_{0}-z\right)^{-1}$. For $z \in \mathbb{C} \backslash \mathbb{R}^{+}, z$ near 0 , one has

We write

where $V=\tilde{V}-\frac{q(\theta)}{r^{2}}$ and $\tilde{W}=V-W$. It's easy to see that $\tilde{W} \in C\left(\mathbb{R}^{n}\right)$, and $|\tilde{W}| \leq C\langle x\rangle^{-\rho_{0}}$.
For $z \in \mathbb{C} \backslash \mathbb{R}, z$ near 0 , we have

In the following, we use these two formulas to study the asymptotic expansion of $R(z)$.
Lemma 3.23. Assume $0 \notin \sigma_{\infty}, n \geq 3 . \operatorname{ker}(1+F(0))$ and $\operatorname{ker}(1+\tilde{F}(0))$ coincide with the kernel, $\mathcal{N}$, of $P$ in $H^{1,-s} .1+\tilde{F}(0)$ and $1+F(0)$ are Fredholm operators in $\mathcal{L}(1,-s ; 1,-s), s>1$.

Proof. It is clear that $\mathcal{N} \subseteq \operatorname{ker}(1+\tilde{F}(0))$. If $u \in H^{1,-s}$ is in $\operatorname{ker}(1+\tilde{F}(0))$, then $P u=$ $-P \tilde{F}(0) u \in H^{-1, s}$ for some $s>1$, because $P=\tilde{P}_{0}+O\left(r^{-\rho_{0}}\right)$ for some $\rho_{0}>2$. This means that $\tilde{u}=P u$ satisfies $\tilde{F}_{0} \tilde{u}=0$ in $H^{1,-s}$. It follows that $\tilde{u}=0$ and $u \in \mathcal{N}$. Similarly, we can get $\operatorname{ker}(1+F(0))=\mathcal{N}$.

It is easy to check that $\tilde{F}(0)$ is a compact operator. It follows that $1+\tilde{F}(0)$ is a Fredholm operator. Note that due to the local singularity and the second order perturbation, $F(0)$ is not a compact operator. Since $\operatorname{ker}(1+F(0))=\mathcal{N}=\operatorname{ker}(1+\tilde{F}(0))$, and $1+\tilde{F}(0)$ is a Fredholm operator, one has that $\operatorname{ker}(1+F(0))$ is of finite dimension. In the following we will show that $\operatorname{Ran}(1+F(0))$ is closed.

Suppose that $f \in \overline{\operatorname{Ran}(1+F(0))}$, then there exist $u_{n} \in H^{1,-s}$ such that $f_{n}=(1+F(0)) u_{n} \rightarrow$ $f$ in $H^{1,-s}$. Then

it follows

Because $1+\tilde{F}_{0} W$ is a bounded operator, and $f_{n} \rightarrow f$ in $H^{1,-s}$, one has

$$

It follows that

in $H^{1,-s}$, because Ran $1+\tilde{F}(0)$ is closed. Then $\left(1+\tilde{F}_{0} W\right) f=(1+\tilde{F}(0)) u$. It follows $f=$ $(1+F(0)) u$. This proves that the Ran $(1+F(0))$ is closed. By Lemma 3.25 (a), we can derive that $\operatorname{dim} \operatorname{coker}(1+F(0))$ is of finite, since $\mathcal{N}$ is a finite dimension subspace of $H^{1,-s}$. Then, we obtain that $1+F(0)$ is a Fredholm operator.

Denote

\vec{v}=\left(v_{1}, \cdots, v_{k}\right) \in\left(\sigma_{N}\right)^{k}, \quad z_{\vec{v}}=z_{v_{1}} \cdots z_{v_{k}} \\
\{\vec{v}\}=\sum_{j=1}^{k} v_{j}^{\prime}, \quad[\vec{v}]_{-}=\sum_{j=1}^{k}\left[v_{j}\right]_{-}, \quad[\vec{v}]=\sum_{j=1}^{k}\left[v_{j}\right] .
\end{gathered}
$$

Here $v_{j}^{\prime}=v_{j}-\left[v_{j}\right]_{-}$for $v_{j}>0$.
First, we need to study the operator $(1-F(z))^{-1}$. If $\mathcal{N}=\{0\}$, then $1+F(0)$ has a bounded inverse on $H^{1,-s}$, by Lemma 3.23. It follows that $(1+F(z))^{-1}$ exists for $z$ small. We can use the formula

Here $N_{0}$ is some integer large enough depending on $\sigma_{\infty}$ and $N$,

and $R_{j}\left(\right.$ resp., $\left.R_{\vec{v} ; j}\right)$ are in $\mathcal{L}(1,-s ; 1,-s)$ for $s>2 j+1$ (resp., for $\left.s>2 j+\{\vec{v}\}+1\right)$.
When $\mathcal{N} \neq\{0\}$, we use the Grushin's method to study $(1+F(z))^{-1}$ as in [69]. Set

Since $V\left(1+F_{0} V\right)=\left(1+V F_{0}\right) V=\left(1+F_{0} V\right)^{*} V$, one can check that $V$ is injective from $\mathcal{N}$ into $\mathcal{N}^{*}$ and $V^{*}=V$ is injective from $\mathcal{N}^{*}$ into $\mathcal{N}$. Consequently, $V$ is bijective from $\mathcal{N}$ onto $\mathcal{N}^{*}$. This shows that $\mathcal{N}$ is independent of $s$ with $1<s<\rho_{0}-1, \operatorname{dim} \mathcal{N}=\operatorname{dim} \mathcal{N}^{*}$, and the quadratic form

Decompose $Q$ as $Q=Q_{r}+Q_{e}$ where $Q_{r}=\sum_{j=1}^{\mu_{r}}<\cdot,-V \phi_{j}>\phi_{j}$. Then,

As in [69], we first show that $\left(1+F_{0} V\right)^{-1}$ exists in some space. We need to decompose the space $H^{1,-s}$ first. We have the following result.

Lemma 3.25. (a). One has the decomposition

(b). Let $Q^{\prime}=1-Q$. Then, $Q^{\prime}\left(1+F_{0} V\right) Q^{\prime}$ is invertible on the range of $Q^{\prime}$ and $\left(Q^{\prime}(1+\right.$ $\left.\left.F_{0} V\right) Q^{\prime}\right)^{-1} Q^{\prime} \in \mathcal{L}(1,-s ; 1,-s), s>1$.

Remark 3.26. This lemma has been proved by X.P. Wang [69] for $V$ without singularity. In fact, these two results are also true for $V=-\frac{\chi_{1}^{2}}{r^{2}} q(\theta)+\tilde{W}$, because $-\frac{\chi_{1}^{2}}{r^{2}} q(\theta)$ is a bounded operator from $H^{1,-s}$ to $H^{-1, s}$ for any $s>1$, if $n \geq 3$. Here $|\tilde{W}| \leq C\langle x\rangle^{-\rho_{0}}$.

Proof. (a). It is easy to check that $\mathcal{N} \cap \operatorname{Ran}\left(1+F_{0} V\right)=\{0\}$. Since $1+F_{0} V$ is continuous on $H^{1,-s}, \operatorname{Ran}\left(1+F_{0} V\right)$ is closed and is therefore equal to $\left(\operatorname{ker}\left(1+F_{0} V\right)^{*}\right)^{\perp}$. For any $u \in H^{1,-s}$, one has $u=Q u+(u-Q u)$ with

This proves $H^{1,-s}=\mathcal{N} \oplus \operatorname{Ran}\left(1+F_{0} V\right)$. It is easy to verify that $Q$ is the projection onto $\mathcal{N}$ w.r.t. this decomposition of $H^{1,-s}$.
(b). $Q^{\prime}=1-Q$ is a projection from $H^{1,-s}$ onto $\operatorname{Ran}\left(1+F_{0} V\right)=F$. For $u \in F$ such that $Q^{\prime}\left(1+F_{0} V\right) Q^{\prime} u=0$, we have $Q^{\prime} u=u$ and $0=Q^{\prime}\left(1+F_{0} V\right) Q^{\prime} u=\left(1+F_{0} V\right) u-Q\left(1+F_{0} V\right) u=$ $\left(1+F_{0} V\right) u$. This means $u \in \mathcal{N}$. By (a), $u=0$. This proves that $Q^{\prime}\left(1+F_{0} V\right) Q^{\prime}$ is injective on Range $\left(1+F_{0} V\right)$. Since Range $Q^{\prime}=\operatorname{Range}\left(1+F_{0} V\right)$, we can show also that $Q^{\prime}\left(1+F_{0} V\right) Q^{\prime}$ is surjective on $\operatorname{Ran}\left(1+F_{0} V\right)$. Therefore, $Q^{\prime}\left(1+F_{0} V\right) Q^{\prime}$ is bijective on $\operatorname{Ran}\left(1+F_{0} V\right)$. Since $\operatorname{Ran}\left(1+F_{0} V\right)$ is closed, $Q^{\prime}\left(1+F_{0} V\right) Q^{\prime}$ is invertible on $\operatorname{Ran}\left(1+F_{0} V\right)$ and

It follows that $Q^{\prime} W(z) Q^{\prime}$ is invertible on $\operatorname{Ran}\left(1+F_{0} V\right)$ with bounded by the asymptotic expansion of $R_{0}(z)$. Let

Note that $V$ is a bounded operator from $H^{1,-s}$ to $H^{-1, s}$ for $s>\rho / 2$ if $\rho>0$, because $\frac{\chi_{1}^{2}}{r^{2}} q(\theta)$ is a bounded operator from $H^{1,-s}$ to $H^{-1, s}$ for any $s>1, n \geq 3$. Using the asymptotic expansion of $R_{0}(z)$, we can get that, if $k \geq 1$ and $\rho_{0}>4 N+2$, the following asymptotic expansion holds

Here $D_{j}$ (resp., $D_{\vec{v} ; j}$ ) are in $\mathcal{L}(1,-s ; 1,-s)$ for $s>2 j+1$ (resp., for $s>2 j+\{\vec{v}\}+1)$ and $D_{\vec{v}, j}$ are operators of finite rank. Here and in the following, $N_{0}$ is some integer large enough depending on $\sigma_{\infty}$ and $N$. Here $N_{0}$ can be taken as the largest integer such that $N_{0} v_{0} \leq N$, where $v_{0}=\min \left\{v \in \sigma_{\infty}\right\}>0$. Since the terms with $\{\vec{v}\}+j>N$ can be put into the remainder, (3.37) can be rewritten as

Therefore the asymptotic expansion of $W(z)^{-1}$ depends on the asymptotic expansion of $E_{+-}(z)^{-1}$.

Proposition 3.27. (Proposition 4.4 [69]) Let $\rho_{0}>3$ if $\mu_{r}=0$, and $\rho_{0}>4$ if $\mu_{r} \neq 0 . E_{+-}(z)$ is invertible for $z$ small enough and its inverse is given by

Remark 3.28. This proposition has been studied by X.P. Wang for Schrödinger operator with potentials without singularity.

It is not clear from (3.44) whether the inverse of $\mathcal{U}^{*} \mathcal{D}(z) \mathcal{U}$ gives the leading term of the inverse of $E_{+-}(z)$, because due to different values of $v$, not all of the entries in $\mathcal{U}^{*} \mathcal{D}(z) \mathcal{V}(z)$ are of higher order in $z$ than those in $\mathcal{U}^{*} \mathcal{D}(z) \mathcal{U}$. To prove that $\mathcal{U}^{*} \mathcal{D}(z)(\mathcal{U}+\mathcal{V}(z))$ is invertible for $z \in U_{\delta}$ with an explicit leading term, we compute the matrix of the Hermitian form $\Phi(\cdot, \cdot)$ in another basis $\left\{\psi_{j} ; 1 \leq j \leq \mu_{r}\right\}$ constructed in the following way. Let $0<\varsigma_{1}<\varsigma_{2}<\cdots<$ $\varsigma_{\kappa_{0}} \leq 1$ be those of $v \in \sigma_{\infty}$ for which there are $m_{\varsigma_{j}}$ linearly independent $\varsigma_{j}$-resonant states with $m_{\varsigma_{j}} \geq 1$ and $\sum_{j=1}^{\kappa_{0}} m_{\varsigma_{j}}=\mu_{r}$. Let $\left\{\varphi_{\varsigma_{j}}^{(l)}(\theta) ; l=1, \cdots, n_{\varsigma_{j}}\right\}\left(n_{\varsigma_{j}} \geq m_{\varsigma_{j}}\right)$ be an orthonormal basis of the eigenspace of $-\Delta_{h}+q(\theta)$ associated with the eigenvalue $\varsigma_{j}^{2}-(n-2)^{2} / 4$. Modifying the orthonormal basis $\varphi_{v}^{(l)}$ used before if necessary, we can assume that there are $m_{\varsigma_{j}}$ linearly independent $\varsigma_{j}$-resonant states in the form

Here $\left(z_{\vec{\zeta}}\right)^{-\alpha}=\left(z_{\varsigma_{1}}\right)^{-\alpha_{1}} \cdots\left(z_{\varsigma_{\kappa_{0}}}\right)^{-\alpha_{\kappa_{0}}}$ and the summation $\sum^{+}$is taken over all possible $\vec{v}=$ $\left(v_{1}, \cdots, v_{s}\right) \in \sigma_{1}^{s}$ for which there are at least $\alpha_{l}$ of the $v_{j}$ 's belonging to $\sigma_{1}$ with $v_{j} \geq \varsigma_{l}$ for all $1 \leq l \leq \kappa_{0}$.

Since $I_{r, 0}(z) S_{r, 1}(z)=O\left(\left|\frac{z}{z_{s_{k_{0}}}}\right|\right)=O\left(\left|\frac{1}{\ln z}\right|\right)$, one has the following convergent series in $\mathcal{L}(1,-s ; 1,-s), s>1$, for $z \in U_{\delta}$ with $\delta>0$ small enough,

S_{r, 1}(z)= & Q_{r}\left(-\left[z F_{1}+L_{2}(z)\right]+\left[z F_{1}+L_{2}(z)\right] V\left[D_{0}+D_{1}(z)\right] L_{1}(z)\right. \\
& \left.+L_{1}(z) V\left[D_{2}(z) L_{1}(z)+\left(D_{0}+D_{1}(z)\right)\left(z F_{1}+L_{2}(z)\right)\right]\right) V Q_{r} \\
= & z Q_{r}\left(-F_{1}+\sum_{\vec{v} \in\left(\sigma_{2}\right)^{s}, 1 \leq s \leq 3, j=0,1} z_{\vec{v}} z^{j} S_{r, \vec{v}, j}\right) V Q_{r} .
\end{aligned}
$$

Inserting the expansions of $I_{r, 0}(z)$ and $S_{r, 1}(z)$ into $I_{r}(z)$ and rearranging the terms, we obtain

Note that here $N=2$ and only $v \sigma_{2}$ is needed. In the case $\varsigma_{\kappa_{0}}<1$, a finite sum on $\beta$ is sufficient in order to obtain an asymptotic expansion of $R(z)$ up to $O\left(|z|^{N-2+\epsilon}\right)$. In the case $\varsigma_{\kappa_{0}}=1$, $z_{\varsigma_{K_{0}}}=z \ln z$. It is then necessary first to sum over all $\beta$ in order to expand $R(z)$ up to $O\left(|z|^{N-2+\epsilon}\right)$. It is now clear that

For the interaction between resonant states and eigenfunctions, note that $S_{e r}(z)=$ $-z Q_{e}\left(F_{1} V+O\left(|z|^{\epsilon}\right)\right) Q_{r}$ and $S_{r e}(z)=-z Q_{r}\left(F_{1} V+O\left(|z|^{\epsilon}\right)\right) Q_{e}$. It follows that

The remainder terms have asymptotic expansions of the form of $T_{e r}(z)$. Theorem 3.29 is proved.

Theorem 3.29 shows that the asymptotic expansion of $R(z)$ may contain any terms of the form $z_{\vec{v}} z^{l},\left(\frac{z_{\varsigma}}{z^{j_{j}}}\right)^{k}, \varsigma \in \sigma_{1}$ with $\varsigma_{j}<v \leq 1$, and $\left(\frac{1}{\ln z}\right)^{m}$. If $P$ has only 1 -resonant states (i.e., $\kappa_{0}=1$ and $\varsigma_{1}=1$ ) which may, however, still have an arbitrarily large multiplicity, $\alpha$ is absent in the summation $\sum_{\alpha, \beta, \vec{v}, l}^{+, N-1}$ and the sum on $\beta$ is infinite and gives rise to convergent series in $\frac{1}{\ln z}$. In this case, $T_{r}(z)$ in Theorem 3.29 can be written in the form

### 3.6 Asymptotic behavior of the smallest eigenvalue of $\tilde{P}(\lambda)$

In this section, we consider a family of Schrödinger operators, $\tilde{P}(\lambda)$, which are the perturbation of $\tilde{P}_{0}$ in the form

\tilde{P}(\lambda)=\tilde{P}_{0}+\lambda V(x), \text { for } \lambda \geq 0
$$

on $L^{2}\left(\mathbb{R}^{n}\right), n \geq 3$. Here

$$

$V_{1}(x)=\chi_{2}^{2}(x) \frac{q(\theta)}{r^{2}}, 0 \leq \chi_{2} \leq 1$ be a smooth function such that $\chi_{2}(x)=1$ when $|x|>R_{1}, \chi_{2}=0$ when $|x|<R$. Let $\chi_{1}$ be a non-negative function such that $\chi_{1}^{2}+\chi_{2}^{2}=1 . V$ and $q(\theta)$ are defined in Section 2, $(r, \theta)$ is the polar coordinates on $\mathbb{R}^{n}$.

By min-max principle, one has $\tilde{P}_{0} \geq 0$, because $P_{0} \geq 0$. As in Section 1, we can also show that $\tilde{P}(\lambda)$ has negative eigenvalue when $\lambda$ large enough and there exists some $\lambda_{0}$ such that when $\lambda>\lambda_{0}, \tilde{P}(\lambda)$ has eigenvalues less then 0 , and when $\lambda \leq \lambda_{0}, \sigma(\tilde{P}(\lambda))=[0, \infty)$. As in Section 3, to study the asymptotic behavior of the smallest eigenvalue of $\tilde{P}(\lambda)$, we need to know the asymptotic expansion of $\left(\tilde{P}_{0}-z\right)^{-1}$.

Assume $0 \notin \sigma_{\infty}$. Let $N \in \mathbb{N}$ and $\rho_{0}>4 N+2$. For $z \in \mathbb{C} \backslash \mathbb{R}, z$ near $0,\left(\tilde{P}_{0}-z\right)^{-1}$ has the following expansion in $\mathcal{L}(-1, s ; 1,-s)$ with $s>2 N+1$

Here $N_{0}$ is some integer large enough depending on $\sigma_{\infty}$ and $N$, and

& R_{\left(v_{i}, v_{j}, v_{k}\right), 0}=A G_{v_{i}, 0} \pi_{v_{i}} \frac{\chi_{1}^{2}}{r^{2}} q(\theta) A G_{v_{j}, 0} \pi_{v_{j}} \frac{\chi_{1}^{2}}{r^{2}} q(\theta) A G_{v_{k}, 0} \pi_{v_{k}} A^{*},
\end{aligned}
$$

where $A=\left(1-F_{0} \frac{\chi_{1}^{2}}{r^{2}} q(\theta)\right)^{-1}$.
Definition 3.31. Set $\tilde{\mathcal{N}}(\lambda)=\left\{u ; \tilde{P}(\lambda) u=0, u \in H^{1,-s}, \forall s>1\right\}$, for $\lambda \geq \lambda_{0}$. A function $u \in$ $\tilde{\mathcal{N}}(\lambda) \backslash L^{2}$ is called a resonant state of $\tilde{P}(\lambda)$ at zero.

$$
\text { Set } \tilde{K}(z)=|V|^{1 / 2}\left(\tilde{P}_{0}-z\right)^{-1}|V|^{1 / 2} \text { for } z \notin \sigma\left(\tilde{P}_{0}\right) \text {, and } \tilde{K}(0)=|V|^{1 / 2} A F_{0}|V|^{1 / 2}
$$

There are some results for $\tilde{P}(\lambda)$ similar to those for $P(\lambda)$. We state these results without proof (see Section 3 for details).

Proposition 3.32. Let $\alpha<0$. Then $\alpha \in \sigma(\tilde{P}(\lambda))$ if and only if $\lambda^{-1} \in \sigma(\tilde{K}(\alpha))$. Moreover, the multiplicity of $\alpha$ as the eigenvalue of $\tilde{P}(\lambda)$ is exactly the multiplicity of $\lambda^{-1}$ as the eigenvalue of $\tilde{K}(\alpha)$.

Proposition 3.33. $\tilde{K}(\alpha)$ is a compact operator for $\alpha \leq 0$. And $\tilde{K}(\alpha)$ converges to $\tilde{K}(0)$ as $\alpha \rightarrow 0$ in operator norm sense.

Let

$$
\mu_{i}(\alpha)=\inf _{\phi_{1}, \cdots, \phi_{i}} \sup _{\|\psi\|=1, \psi \in\left[\phi_{1}, \cdots, \phi_{i}\right]^{\perp}}(\psi, \tilde{K}(\alpha) \psi) .

Then, $\mu_{i}(\alpha)$ is the eigenvalue of $\tilde{K}(\alpha)$. Because $\tilde{K}(\alpha) \rightarrow \tilde{K}(0)$ as $\alpha \rightarrow 0$, one has $\mu_{i}(\alpha)$ converges to the eigenvalue of $\tilde{K}(0)$ by Lemma 3.11. Suppose $\mu_{i}(\alpha) \rightarrow \mu_{i}$, and suppose $\mu_{1}=\cdots=$ $\mu_{m}, \mu_{1} \neq \mu_{m+1}$, then $\mu_{1}$ is an eigenvalue of $\tilde{K}(0)$ of multiplicity $m$. By Lemma 3.11, one can choose $\phi_{i}(\alpha)(1 \leq i \leq m)$, which is the eigenfunction of $\tilde{K}(\alpha)$ corresponding to $\mu_{i}(\alpha)$ such that $\left\langle\phi_{i}(\alpha), \phi_{j}(\alpha)\right\rangle=\delta_{i j}$ and $\phi_{i}(\alpha)$ converges. Suppose $\phi_{i}(\alpha) \rightarrow \phi_{i}$ as $\alpha \rightarrow 0$, then $\phi_{i}(1 \leq i \leq m)$ is the eigenfunction of $\tilde{K}(0)$ corresponding to $\mu_{1}$, and $\left\langle\phi_{i}, \phi_{j}\right\rangle=\delta_{i j}$ for $1 \leq i, j \leq m$. Note that $\mu_{1}=\lambda_{0}^{-1}$, one has $\tilde{P}\left(\lambda_{0}\right) \psi_{i}=0(1 \leq i \leq m)$ with $\psi_{i}=A F_{0}|V|^{1 / 2} \phi_{i} \in H^{1,-s}, s>1$. Because 0 is the simple eigenvalue of $\tilde{P}\left(\lambda_{0}\right)$, then there is at most one $\psi_{i} \in L^{2}\left(\mathbb{R}^{n}\right)$ and the other $\psi_{i}$ is the 0 resonant solution of $\tilde{P}\left(\lambda_{0}\right)$. Suppose that $\psi_{i}(1 \leq i \leq m)$ which is not belongs to $L^{2}\left(\mathbb{R}^{n}\right)$ is $v_{i}$-resonant state of $\tilde{P}\left(\lambda_{0}\right), 0<v_{i} \leq 1$. Then we have

Lemma 3.34. Assume $0 \notin \sigma_{\infty}$. Let $\phi_{i}, \psi_{i}, \mu_{i}, \mu_{i}(\alpha), v_{i}$ are defined as above. If $\psi_{i} \notin L^{2}$, and $\psi_{i}$ is $v_{i}$-resonant state. If $v_{i}<1$, then $\mu_{i}(\alpha)=c \alpha^{\nu_{i}}+o\left(\alpha^{v_{i}}\right)$ with some $c \neq 0$; if $v_{i}=1$ then $\mu_{i}(\alpha)=c \alpha \ln \alpha+o(\alpha)$ with some $c \neq 0$.

Proof. The proof of this lemma is similar to that of lemma3.14. Because $\psi_{i} \in H^{1,-s}, s>1$ satisfies $\left(\tilde{P}_{0}+\lambda_{0} V\right) \psi_{i}=0$, then $\left(P_{0}-\frac{\chi_{1}^{2}}{r^{2}} q(\theta)\right) \psi_{i}=0$. It follows that

Then $\left(P_{0}+\lambda_{0}\left(1-\frac{\chi_{1}^{2}}{r^{2}} q(\theta) F_{0}\right)^{-1} V\right) \psi_{i}=0$. By Theorem 3.19, we have

& \left.=\sum_{0<v \leq 1} \sum_{j=1}^{n_{v}}-\frac{1}{2 v}-\left.\left\langle P_{0} \psi_{i},\right| y\right|^{-\frac{1}{2}(n-1)+v} \varphi_{v}^{(j)}\right\rangle \varphi_{v}^{(j)}(\theta) \\
r^{\frac{1}{2}}(n-2)+\nu
\end{array} \tilde{u} \quad \begin{array}{l}
0<v \leq 1
\end{array} \sum_{j=1}^{n_{v}}-\left.\frac{1}{2 v}\left\langle\lambda_{0} A^{*} V \psi_{i},\right| y\right|^{-\frac{1}{2}(n-1)+v} \varphi_{v}^{(j)}\right\rangle \frac{\varphi_{v}^{(j)}(\theta)}{r^{\frac{1}{2}(n-2)+v}}+\tilde{u} . \quad .
$$

One has

$$
\begin{aligned}
& \left.\left.\left\langle\phi_{j},\right| V\right|^{1 / 2} A G_{\nu, 0} \pi_{\nu}^{(i)} A^{*}|V|^{1 / 2} \phi_{k}\right\rangle \\
= & \lambda_{0}^{2}\left\langle A^{*} V \psi_{j}, \frac{1}{|x|^{\frac{1}{2}(n-2)-\nu}} \varphi_{\nu}^{(i)}\right\rangle\left\langle A^{*} V \psi_{k}, \frac{1}{|x|^{\frac{1}{2}}(n-2)-\nu} \varphi_{\nu}^{(i)}\right\rangle .
\end{aligned}
$$

As the proof of Lemma 3.14, we can get the result.
Using this lemma, we can get the following result.
Theorem 3.35. Assume $0 \notin \sigma_{\infty}$. Suppose that $e_{1}(\lambda)$ is the ground state of $\tilde{P}(\lambda)$, and $\phi_{1}, \psi_{1}$ are defined as in Lemma 3.34. Then,
(a). If $\psi_{1} \in L^{2}$, then $e_{1}(\lambda)=-c\left(\lambda-\lambda_{0}\right)+o\left(\lambda-\lambda_{0}\right)$, with some $c \neq 0$;
(b). If $\psi_{1} \notin L^{2}$, and $\psi_{1}$ is $v$-resonant state of $\tilde{P}\left(\lambda_{0}\right)$, then if $v^{\prime}=1, e_{1}(\lambda)=c \frac{\lambda-\lambda_{0}}{\ln \left(\lambda-\lambda_{0}\right)}+o\left(\lambda-\lambda_{0}\right)$, and if $v^{\prime}<1, e_{1}(\lambda)=c\left(\left(\lambda-\lambda_{0}\right)^{\frac{1}{v^{\prime}}}\right)+o\left(\left(\lambda-\lambda_{0}\right)^{\frac{1}{\nu}}\right)$.

Moreover, if the eigenvalue of $\tilde{P}(\lambda), e(\lambda)$, which is not ground state, approaches to 0 as $\lambda \downarrow \lambda_{0}$, then $e(\lambda)$ has the similar asymptotic expansion as $e_{1}(\lambda)$.

The proof of this Theorem is similar to that of Theorem 3.15. We omit the proof.

## 4 - Low-ENERGY ASYMPTOTICS OF THE

## SPECTRAL SHIFT FUNCTION FOR PERTURBATION

## WITH CRITICAL DECAY

### 4.1 Introduction

In this chapter, we study Schrödinger operator $P=-\Delta+V(x)$ on $L^{2}\left(\mathbb{R}^{n}\right)$ with $V(x)$ a real smooth function on $\mathbb{R}^{n}, n \geq 3$, satisfying

$$
\begin{equation*}
V(x)=\frac{q(\theta)}{r^{2}}+O\left(\langle x\rangle^{-\rho}\right), \quad|x| \rightarrow \infty \tag{4.1}
\end{equation*}
$$

for some $q \in C^{\infty}\left(\mathbb{S}^{n-1}\right)$ and $\rho>2$. Here $x=r \theta$ with $r=|x|$ and $\theta=\frac{x}{|x|} \cdot \mathbb{S}^{n-1}$ is the unit sphere in $\mathbb{R}^{n}$.

Let $0 \leq \chi_{j} \leq 1(j=1,2)$ be smooth functions on $\mathbb{R}^{n}$ such that supp $\chi_{1} \subset B\left(0, R_{1}\right), \chi_{1}(x)=1$ when $|x|<R_{0}$ and

$$
\chi_{1}(x)^{2}+\chi_{2}(x)^{2}=1
$$

Consider the operator

$$
P_{0}=\chi_{1}(-\Delta) \chi_{1}+\chi_{2} \tilde{P}_{0} \chi_{2}
$$

on $L^{2}\left(\mathbb{R}^{n}\right)$, where $\tilde{P}_{0}=-\Delta+\frac{q(\theta)}{r^{2}}$. Let $\Delta_{s}$ denote the Laplacian on the sphere $\mathbb{S}^{n-1}$. Assume that $\lambda_{1}$ is the smallest eigenvalue of $-\Delta_{s}+q(\theta)$ on the sphere $\mathbb{S}^{n-1}$ and verifies

$$
\begin{equation*}
\lambda_{1}>-\frac{1}{4}(n-2)^{2} \tag{4.2}
\end{equation*}
$$

Under this assumption, one has $P_{0} \geq 0$ on $L^{2}\left(\mathbb{R}^{n}\right)$. The operator $P$ can be considered as a perturbation of model operator $P_{0}$. We are mainly interested in the low-energy asymptotics of the derivative of the spectral shift function.

The spectral shift function was introduced in 1952 by the physicist I. M. Lifshitz in paper [41] as a trace perturbation formula in quantum mechanics. Its mathematical theory was created by M. G. Krein. Let $H, H_{0}$ be a pair of self-adjoint operators in some separable Hilbert space
$\mathcal{H}$. Krein proved in [36] that if $V=H-H_{0}$ is a trace class operator, then $f(H)-f\left(H_{0}\right)$ is of trace class and there exists some function $\xi \in L^{1}(\mathbb{R})$, called spectral shift function, such that

$$
\begin{equation*}
\operatorname{Tr}\left(f(H)-f\left(H_{0}\right)\right)=-\int_{\mathbb{R}} f^{\prime}(\lambda) \xi(\lambda) d \lambda, \quad \forall f \in \mathcal{S}(\mathbb{R}) \tag{4.3}
\end{equation*}
$$

Then it was extended by him in [37] (see [38], for a more complete exposition) to operators $H_{0}, H$ with a trace class difference $R(z)-R_{0}(z)$. Here $R_{0}(z)=\left(H_{0}-z\right)^{-1}$ and $R(z)=(H-z)^{-1}$. Yafaev ([73]) proved that if there exists some $c$ such that $P+c I$ and $P_{0}+c I$ are positive and there exists some $k \in \mathbb{N}^{*}$,

$$
\begin{equation*}
\left\|(P+c I)^{-k}-\left(P_{0}+c I\right)^{-k}\right\|_{t r}<\infty \tag{4.4}
\end{equation*}
$$

then $f(P)-f\left(P_{0}\right)$ is of trace class and there exists some function $\xi \in L_{l o c}^{1}(\mathbb{R})$, such that (4.3) holds. The right hand side of (4.3) can be interpreted as $\left\langle f, \xi^{\prime}\right\rangle$, where $\xi^{\prime}$ is the derivative of $\xi$ in the sense of distributions.

The spectral shift function of Schrödinger operator has been studied by many authors (see for example [1],[47],[49],[50],[73] ). High-energy asymptotics of the spectral shift function was studied in these paper. The result got by Robert in [49] is the following : assume $\left|\partial_{x}^{\alpha} V\right| \leq$ $C_{\alpha}\langle x\rangle^{-\rho-|\alpha|}$ with $\rho>n$, then the spectral shift function, $\xi(\lambda)$, for the pair $(-\Delta, \Delta+V)$ satisfying :
(i). $\xi(\lambda)$ is $C^{\infty}$ in $(0, \infty)$.
(ii). $\frac{d^{k}}{d \lambda^{k}} \xi(\lambda)$ has a complete asymptotic expansion for $\lambda \rightarrow \infty$,

$$
\frac{d^{k}}{d \lambda^{k}} \xi(\lambda) \sim \lambda^{n / 2-k-1} \sum_{j \geq 0} \alpha_{j}^{(k)} \lambda^{-j}
$$

In this chapter, we use the asymptotic expansion of $\left(P_{0}-z\right)^{-1}$ and $(P-z)^{-1}$ for $z$ near 0 , $\mathfrak{J} z \neq 0$ to study the low-energy asymptotics of the derivative of the spectral shift function. The main result we get is the following : assume $V=\frac{q(\theta)}{r^{2}}+W$, and $\left|\partial_{x}^{\alpha} W\right| \leq C_{\alpha}\langle x\rangle^{-\rho-|\alpha|}$ with $\rho>\max \{6, n+2\}$ for $|x|$ large, then

$$
\xi^{\prime}(\lambda)=J_{0} \delta(\lambda)+g(\lambda)
$$

with $|g(\lambda)|=O\left(\lambda^{-1+\epsilon_{0}}\right)$ for some $\epsilon_{0}>0$, as $\lambda \rightarrow 0, J_{0}$ depends on the multiplicity of 0 as the eigenvalue of $P$ and the multiplicity of 0 as the resonance of $P$. Then we use this result and Robert's result to study Levinson's theorem. If $\rho>n+3$, we can get that

$$
\begin{equation*}
\int_{0}^{\infty}\left(\xi^{\prime}(\lambda)-\sum_{j=1}^{\left[\frac{n}{2}\right]} c_{j} \lambda^{\left[\frac{n}{2}\right]-1-j}\right) d \lambda=-\left(N+J_{0}\right)+\beta_{n / 2} \tag{4.5}
\end{equation*}
$$

Here $\beta_{n / 2}$ depends on the dimension $n$ and $V . \beta_{n / 2}=0$ if $n$ is odd. $N$ is the number of discrete eigenvalues of $P$.

Here is the plan of this chapter. In Section 4.2, we study a representation formula of the spectral shift function which is used to study Levinson's theorem. In Section 4.3, we use the
asymptotic expansion of $\left(\tilde{P}_{0}-z\right)^{-1}$ to get the asymptotic expansion of $\left(P_{0}-z\right)^{-1}$. The residues of $\operatorname{Tr}\left(R(z)-R_{0}(z)\right) f(P)$ is studied in Section 4.4. Here $f$ is some smooth function with compact support. This result is used to study the low-energy asymptotics of the derivative of the spectral shift function in Section 4.5. The Levinson's theorem is also studied in this section.

### 4.2 A representation formula

Let $P, P_{0}$ be a pair of self-adjoint operators, semi-bounded from below, in some separable Hilbert space $H$. Assume that for some $k \in \mathbb{N}^{*}$,

\begin{equation*}
\left\|(P-i)^{-k}-\left(P_{0}-i\right)^{-k}\right\|_{t r}<\infty . \tag{4.6}
\end{equation*}
$$

Then for any $f \in \mathcal{S}(\mathbb{R}), f(P)-f\left(P_{0}\right)$ is of trace class and there exists some function $\xi \in L_{l o c}^{1}(\mathbb{R})$, called spectral shift function, such that

$$
\begin{equation*}
\operatorname{Tr}\left(f(P)-f\left(P_{0}\right)\right)=-\int_{\mathbb{R}} f^{\prime}(\lambda) \xi(\lambda) d \lambda, \quad \forall f \in \mathcal{S}(\mathbb{R}) \tag{4.7}
\end{equation*}
$$

The right hand side can be interpreted as $\left\langle f, \xi^{\prime}\right\rangle$, where $\xi^{\prime}$ is the derivative of $\xi$ in the sense of distributions. By the Birman-Krein theory, $\xi$ is related with the scattering phase, $\rho(\lambda)=$ $\arg \operatorname{det} S(\lambda)$, by the formula

$$
\rho(\lambda)=2 \pi \xi(\lambda), \quad \bmod 2 \pi \mathbb{Z}
$$

and

$$
\xi^{\prime}(\lambda)=\frac{1}{2 \pi} \operatorname{Tr} T(\lambda),
$$

where $T(\lambda)=-i S(\lambda)^{*} \frac{d}{d \lambda} S(\lambda)$ is the Eisenbud-Wigner formula for the time-delay operator. We make the following assumptions.

- The spectra of $P$ and $P_{0}$ are purely absolutely continuous in $] 0,+\infty[$

$$
\begin{align*}
\sigma\left(P_{0}\right)=\sigma_{a c}\left(P_{0}\right) & =[0,+\infty[,  \tag{4.8}\\
\sigma_{a c}(P) & =[0,+\infty[. \tag{4.9}
\end{align*}
$$

In particular, there are no embedded eigenvalues of $P$ and $P_{0}$ in $] 0,+\infty[$.

- Let $f \in C_{0}^{\infty}(\mathbb{R})$. There exists some $\epsilon_{0}>0$ and $C_{f}>0$ such that

$$
\begin{equation*}
\left|\operatorname{Tr}\left[\left(R(z)-R_{0}(z)\right) f(P)\right]\right| \leq C_{f} \frac{1}{|z|^{1+\epsilon_{0}}} \tag{4.10}
\end{equation*}
$$

uniformly in $z \in \mathbb{C}$ with $|z|$ large and $z \notin \sigma(P)$. For any $\delta>0$, and $\lambda>\delta, \lim _{\epsilon\rfloor 0} \operatorname{Tr}[(R(\lambda \pm$ $\left.\left.i \epsilon)-R_{0}(\lambda \pm i \epsilon)\right) f(P)\right]$ exists. Moreover, there exists $C_{\delta, f}>0$ such that

$$
\left|\lim _{\epsilon\rfloor 0} \operatorname{Tr}\left[\left(R(\lambda \pm i \epsilon)-R_{0}(\lambda \pm i \epsilon)\right) f(P)\right]\right| \leq C_{\delta, f},
$$

uniformly in $\lambda$ with $\lambda>\delta$.

- The residue of the function $z \rightarrow \operatorname{Tr}\left[\left(R(z)-R_{0}(z)\right) f(P)\right]$ at $z=0$ is finite in the following sense :

$$
\begin{equation*}
J_{0}=-\frac{1}{2 \pi i} \lim _{\epsilon \rightarrow 0} \lim _{\delta \rightarrow 0} \int_{|z|=\epsilon,|\mathfrak{J} z| \geq \delta} \operatorname{Tr}\left[\left(R(z)-R_{0}(z)\right) f(P)\right] d z<\infty . \tag{4.11}
\end{equation*}
$$

- $\xi^{\prime}(\lambda) \in L_{l o c}^{1}(] 0, \infty[)$.
- The total number, $N$, of negative eigenvalues of $P$ is finite.

We have the following representation formula for the spectral shift function $\xi(\lambda)$.
Theorem 4.1. Under the above assumptions, suppose in addition that $\xi(\cdot)$ is absolutely continuous in $] 0, \infty\left[\right.$. Let $f \in C_{0}^{\infty}(\mathbb{R})$ such that $f(\lambda)=1$ for $\lambda$ in neighborhood of $\sigma_{p p}(P) \cup\{0\}$. Under the above assumptions, the limit

$$
\int_{0}^{\infty} f(\lambda) \xi^{\prime}(\lambda) d \lambda=\lim _{\delta \rightarrow 0_{+}} \lim _{R \rightarrow \infty} \int_{\delta}^{R} f(\lambda) \xi^{\prime}(\lambda) d \lambda
$$

exists and one has

$$
\begin{equation*}
\operatorname{Tr}\left(f(P)-f\left(P_{0}\right)\right)-\int_{0}^{\infty} \xi^{\prime}(\lambda) f(\lambda) d \lambda=N+J_{0} \tag{4.12}
\end{equation*}
$$

Proof. $\left(R(z)-R_{0}(z)\right) f(P)$ can be written as

$$
\left(R(z)-R_{0}(z)\right) f(P)=\left(R(z) f(P)-R_{0}(z) f\left(P_{0}\right)\right)-\left(R_{0}(z)\left(f(P)-f\left(P_{0}\right)\right)\right)
$$

Under the condition (4.6), $\left(R(z)-R_{0}(z)\right) f(P)$ is of trace class for any $f \in \mathcal{S}(\mathbb{R})$ and $z \notin \sigma(P)$ and the function

$$
F(z)=\operatorname{Tr}\left(R(z)-R_{0}(z) f(P)\right)
$$

is holomorphic outside $\sigma(P)$. We want to deduce (4.12) from Cauchy's formula applied to $F(z)$.
Let $N$ be the total number of discrete eigenvalues of $P$ (counted with the multiplicity). Let $E_{i}, 1 \leq i \leq k$, be the distinct eigenvalues of $P$ with multiplicity $m_{i}$, such that $E_{i}<E_{j}$ if $i<j$. Then, $\sum_{i=1}^{k} m_{i}=N$. Denote for $z_{0} \in \mathbb{C}$ and $\delta>0$

$$
\gamma\left(z_{0} ; \delta\right)=\left\{z \in \mathbb{C} ;\left|z-z_{0}\right|=\delta\right\} ; \quad D\left(z_{0} ; \delta\right)=\left\{z \in \mathbb{C} ;\left|z-z_{0}\right| \leq \delta\right\}
$$

Then if $\delta>0$ small enough, $\sigma(P) \cap D\left(E_{i} ; \delta\right)=\left\{E_{i}\right\}$ and $\sigma\left(P_{0}\right) \cap D\left(E_{i} ; \delta\right)=\emptyset$ for $1 \leq i \leq k$.
Set $E_{0}=0$. For $R \gg 1$ and $0<\epsilon \ll \delta$, denote

$$
\begin{aligned}
& \gamma_{R, \epsilon}=\left\{z \in \mathbb{C} ;|z|=R, \operatorname{dist}\left(z, \mathbb{R}_{+}\right) \geq \epsilon\right\} \\
& \gamma(1, \delta, \epsilon)=\left\{z \in \mathbb{C} ;\left|z-E_{1}\right|=\delta, \operatorname{dist}(z,] E_{1}, \infty[) \geq \epsilon\right\} \\
& \gamma(i, \delta, \epsilon)=\left\{z \in \gamma\left(E_{i}, \delta\right),|\mathfrak{J} z| \geq \epsilon\right\}, 0 \leq i \leq k \text { with } i \neq 1 \\
& d_{j}^{ \pm}=\left[E_{j}+\sqrt{\delta^{2}-\epsilon^{2}} \pm i \epsilon, E_{j+1}-\sqrt{\delta^{2}-\epsilon^{2}} \pm i \epsilon\right], \quad 1 \leq j \leq k, E_{k+1}=E_{0}=0 \\
& d_{R}^{ \pm}(\delta, \epsilon)=\left[\sqrt{\delta^{2}-\epsilon^{2}} \pm i \epsilon, R \pm i \epsilon\right] .
\end{aligned}
$$

We denote by $\Gamma_{\delta, \epsilon, R}$ the closed curve defined by

$$
\Gamma_{\delta, \epsilon, R}=\left(\cup_{j=0}^{k} \gamma(j ; \delta, \epsilon)\right) \cup\left(\cup_{j=1}^{k} d_{j}^{+} \cup d_{j}^{-}\right) \cup d_{R}^{+}(\delta, \epsilon) \cup d_{R}^{-}(\delta, \epsilon) \cup \gamma_{R, \epsilon} .
$$

$\Gamma_{\delta, \epsilon, R}$ is positively oriented according to the anti-clockwise orientation of the big circle $\gamma_{R, \epsilon}$. Since $F(z)$ is holomorphic in the domain limited by $\Gamma_{\delta, \epsilon, R}$, the Cauchy integral formula gives

\frac{1}{2 \pi i} \oint_{\Gamma_{\delta, \epsilon, R}} F(z) d z=0
$$

We split the integral into four terms

\begin{gather*}
\frac{1}{2 \pi i} \oint_{\Gamma_{\delta, \epsilon, R}} F(z) d z=\sum_{j=1}^{4} I_{j} \quad \text { with }  \tag{4.13}\\
I_{1}=\frac{1}{2 \pi i} \oint_{\gamma(R, \epsilon)} F(z) d z, \quad I_{2}=\sum_{j=0}^{k} \frac{1}{2 \pi i} \oint_{\gamma(j ; \delta, \epsilon)} F(z) d z \\
I_{3}=-\frac{1}{2 \pi i} \sum_{j=1}^{k} \oint_{d_{j}^{+} \cup d_{j}^{-}} F(z) d z, \quad I_{4}=\frac{1}{2 \pi i} \oint_{d_{R}^{+}(\delta, \epsilon) \cup d_{R}^{-}(\delta, \epsilon)} F(z) d z
\end{gather*}
$$

By condition (4.10), one has $I_{1}=O\left(R^{-\epsilon_{0}}\right)$ uniformly in $\epsilon>0$. For $z$ in $D\left(E_{j}, \delta\right), j=1, \cdots, k$, one has

$$
R(z)=\Pi_{j}\left(E_{j}-z\right)^{-1}+R_{j}(z)
$$

where $\Pi_{j}$ is the spectral projection onto the eigenspace of $P$ associated with the eigenvalue $E_{j}$ and $R_{j}(z)$ is holomorphic in $D\left(E_{j}, \delta\right) .\left(R_{j}(z)-R_{0}(z)\right) f(P)$ is of trace class and $z \rightarrow \operatorname{Tr}\left(R_{j}(z)-\right.$ $\left.R_{0}(z)\right) f(P)$ is holomorphic near $z=E_{j}$. Therefore, for $j=1, \cdots, k$

$$
\frac{1}{2 \pi i} \oint_{\gamma(j ; \delta, \epsilon)} F(z) d z \rightarrow \frac{1}{2 \pi i} \oint_{\gamma(j ; \delta)} \operatorname{Tr}\left(\Pi_{j} f(P)\right)\left(E_{j}-z\right)^{-1} d z=-m_{j} f\left(E_{j}\right)=-m_{j}
$$

as $\epsilon \rightarrow 0$, for each $\delta>0$ sufficiently small. For the integral over $\gamma(0 ; \delta, \epsilon)$, the assumption (4.11) and the choice of orientation on $\Gamma_{\delta, \epsilon, R}$ gives

$$
\lim _{\delta \rightarrow 0} \lim _{\epsilon \rightarrow 0} \frac{1}{2 \pi i} \oint_{\gamma(0 ; \delta, \epsilon)} F(z) d z=-J_{0}
$$

Therefore

$$
\begin{equation*}
\lim _{\delta \rightarrow 0} \lim _{\epsilon \rightarrow 0} I_{2}=N+J_{0} \tag{4.14}
\end{equation*}
$$

For $\delta>0$ small enough and for $j=1, \cdots, k,\left[E_{j}+\delta, E_{j+1}-\delta\right] \cap \sigma(P)=\emptyset$ and $F(z)$ is holomorphic in a connected domain containing $\left[E_{j}+\delta, E_{j+1}-\delta\right]$. Thus,

$$
\lim _{\epsilon \rightarrow 0} \oint_{d_{j}^{+} \cup d_{j}^{-}} F(z) d z=\lim _{\epsilon \rightarrow 0} \int_{E_{j}+\delta}^{E_{j+1}-\delta}(F(\lambda+i \epsilon)-F(\lambda-i \epsilon)) d \lambda=0
$$

which shows that $\lim _{\epsilon \rightarrow 0} I_{3}=0$. We obtain that

$$
\begin{equation*}
\lim _{R \rightarrow \infty, \delta \rightarrow 0} \lim _{\epsilon \rightarrow 0} I_{4}=-N-J_{0} \tag{4.15}
\end{equation*}
$$

Decompose $F(z)$ as

$$
F(z)=F_{1}(z)+F_{2}(z)
$$

where

$$
F_{1}(z)=\operatorname{Tr}\left(R(z) f(P)-R_{0}(z) f\left(P_{0}\right)\right), \quad F_{2}(z)=\operatorname{Tr}\left(R_{0}(z)\left(f\left(P_{0}\right)-f(P)\right)\right.
$$

By the definition of the spectral shift function,

$$
F_{1}(z)=-\int_{\mathbb{R}} \xi(\lambda) f_{z}^{\prime}(\lambda) d \lambda=\int_{\mathbb{R}} \xi^{\prime}(\lambda) f_{z}(\lambda) d \lambda
$$

with $f_{z}(\lambda)=(\lambda-z)^{-1} f(\lambda), f_{z}^{\prime}$ is the derivative of $f_{z}$ with respect to $\lambda$ and $\xi^{\prime}(\cdot)$ denotes the derivative of $\xi(\cdot)$ in the sense of distributions. It is elementary to check that

$$
\lim _{\epsilon \rightarrow 0} \frac{1}{2 \pi i} \oint_{d_{R}^{+}(\delta, \epsilon) \cup d_{R}^{-}(\delta, \epsilon)} f_{z}(\lambda) d z= \begin{cases}f(\lambda), & \text { if } \lambda \in] \delta, R[  \tag{4.16}\\ \frac{f(\lambda)}{2}, & \text { if } \lambda=\delta \text { or } R \\ 0, & \text { if } \lambda \in \mathbb{R} \backslash[\delta, R]\end{cases}
$$

Note that $\xi^{\prime}(\lambda)$ is in $L_{l o c}^{1}(] 0, \infty[)$. Making use of Fubini and the dominated convergence theorems, one derives that

$$
\begin{equation*}
\lim _{\epsilon \rightarrow 0} \frac{1}{2 \pi i} \oint_{d_{R}^{+}(\delta, \epsilon) \cup d_{R}^{-}(\delta, \epsilon)} F_{1}(z) d z=\int_{\delta}^{R} \xi^{\prime}(\lambda) f(\lambda) d \lambda \tag{4.17}
\end{equation*}
$$

For $F_{2}(z)$, making use of the Stone's formula for $P_{0}$ and the assumption (4.8), one has

$$
\lim _{\epsilon \rightarrow 0} \frac{1}{2 \pi i} \oint_{d_{R}^{+}(\delta, \epsilon) \cup d_{R}^{-}(\delta, \epsilon)} F_{2}(z) d z=\operatorname{Tr}\left(E_{0}(\delta, R)\left(f(P)-f\left(P_{0}\right)\right)\right.
$$

where $E_{0}(\delta, R)$ is the spectral projection of $P_{0}$ onto the interval $[\delta, R]$. Since

$$
s-\lim _{\delta \rightarrow 0, R \rightarrow \infty} E_{0}(\delta, R)=I
$$

and $f(P)-f\left(P_{0}\right)$ is of trace class, one can deduce that

$$
\lim _{\delta \rightarrow 0, R \rightarrow \infty} \operatorname{Tr} E_{0}(\delta, R)\left(f\left(P_{0}\right)-f(P)\right)=\operatorname{Tr}\left(f\left(P_{0}\right)-f(P)\right)
$$

See Lemma 4.2 below. (4.15) shows that the limit

\int_{0}^{\infty} \xi^{\prime}(\lambda) f(\lambda) d \lambda=\lim _{\delta \rightarrow 0, R \rightarrow \infty} \int_{\delta}^{R} \xi^{\prime}(\lambda) f(\lambda) d \lambda
$$

exists and

\begin{equation*}
\operatorname{Tr}\left(f(P)-f\left(P_{0}\right)\right)-\int_{0}^{\infty} \xi^{\prime}(\lambda) f(\lambda) d \lambda=N+J_{0} \tag{4.18}
\end{equation*}
$$

Lemma 4.2. Suppose $A$ is of trace class and $f(\lambda)$ is an operator valued function such that $\|f(\lambda)\| \leq C$ with $C$ independent of $\lambda$. If $B=s-\lim _{\lambda \rightarrow \lambda_{0}} f(\lambda)$ exists, then $f(\lambda) A$ converges to BA in $\mathscr{S}^{1}$ as $\lambda \rightarrow \lambda_{0}$. In particular,

$$
\lim _{\lambda \rightarrow \lambda_{0}} \operatorname{Tr} f(\lambda) A=\operatorname{Tr} B A
$$

Proof. For any $\epsilon>0$, let $F$ be a finite rank operator such that $\|A-F\|_{1}<\epsilon$. Then

$$
\|f(\lambda) A-B A\|_{1} \leq\|(f(\lambda)-B) F\|_{1}+\|(f(\lambda)-B)(F-A)\|_{1} .
$$

The first term on the right hand side can be controlled by $C \epsilon$ when $\left|\lambda-\lambda_{0}\right| \leq \delta$ with some $\delta>0$ small enough, since $s-\lim _{\lambda \rightarrow \lambda_{0}} f(\lambda)=B$ and $F$ is a finite rank operator. The second term also can be controlled by $C \epsilon$, since $f(\lambda)-B$ is a bounded operator and $\|A-F\|_{1} \leq \epsilon$. This ends the proof.

Remark. In many cases, the high energy asymptotics of the spectral shift function is known. For example, if $P_{0}=-\Delta$ and $P=-\Delta_{g}+V(x)$ on $\mathbb{R}^{n}$ with $g$ a smooth metric $g$ and a smooth potential $V(x)$ satisfying

$$
\left|\partial_{x}^{\alpha}(g(x)-I)\right|+\left|\partial_{x}^{\alpha} V(x)\right| \leq C_{\alpha}\langle x\rangle^{-\rho-|\alpha|}
$$

for some $\rho>n$ and the metric $g$ has no trapped geodesics. Then, the asymptotic expansion of $\xi^{\prime}(\lambda)$ as $\lambda \rightarrow+\infty$ is given in [49] :

$$
\begin{equation*}
\xi^{\prime}(\lambda) \sim \lambda^{\frac{n}{2}-1} \sum_{j \geq 0} c_{j} \lambda^{-j} \tag{4.19}
\end{equation*}
$$

where

$$
c_{0}=\frac{4 \pi^{(n+1) / 2}}{\Gamma(n / 2+1)} \int_{\mathbb{R}^{n}} \sqrt{\operatorname{det} g(x)-1} d x .
$$

If one can show that $\xi^{\prime}(\lambda)$ is integrable in $\left.] 0,1\right]$, then one can take a family of functions $f_{R}(\lambda)=$ $\chi\left(\frac{\lambda}{R}\right)$, where $\chi$ is smooth and $0 \leq \chi(s) \leq 1, \chi(s)=1$ for $s$ near $0, \chi(s)=0$ for $s>1$ and expand both the terms

$$
\int_{0}^{\infty} \xi^{\prime}(\lambda) f_{R}(\lambda) d \lambda, \text { and } \operatorname{Tr}\left(f_{R}(P)-f_{R}\left(P_{0}\right)\right)
$$

in $R \rightarrow \infty$. Theorem 4.1 will give a generalized Levinson's theorem.
The remaining part of this work is to apply Theorem 4.1 to Schrödinger operator, using the known results on the asymptotic expansion of $\xi^{\prime}(\lambda)$ as $\lambda \rightarrow \infty$. The main task is to study $\xi^{\prime}(\lambda)$ as $\lambda \rightarrow 0$.

### 4.3 Some results for $P_{0}$ and $P$

In this section, we will study the operator $P=-\Delta+V_{1}+V_{2}$. Here $V_{i}(x) \in C^{\infty}\left(\mathbb{R}^{n}\right),(i=1,2)$. $V_{1}(x)=\frac{q(\theta)}{|x|^{2}}$, if $|x|>R_{0}$ for some $R_{0}$ large enough. $V_{2}(x)$ satisfies

$$
\begin{equation*}
\left|\partial_{x}^{\alpha} V_{2}(x)\right| \leq C_{\alpha}\langle x\rangle^{-\rho-|\alpha|} \tag{4.20}
\end{equation*}
$$

for some $\rho>2$. Let $0 \leq \chi_{j} \leq 1(j=1,2)$ be smooth functions on $\mathbb{R}^{n}$ such that $\operatorname{supp} \chi_{1} \subset$ $B\left(0, R_{1}\right), \chi_{1}(x)=1$ when $|x|<R_{0}$ and

$$
\chi_{1}(x)^{2}+\chi_{2}(x)^{2}=1
$$

Consider the operator

$$
P_{0}=\chi_{1}(-\Delta) \chi_{1}+\chi_{2} \tilde{P}_{0} \chi_{2}
$$

on $L^{2}\left(\mathbb{R}^{n}\right)$, where $\tilde{P}_{0}=-\Delta+\frac{q(\theta)}{r^{2}}$. $(r, \theta)$ is the polar coordinates on $\mathbb{R}^{n}, q(\theta)$ is a real continuous function. Let $\Delta_{s}$ denote Laplace operator on the sphere $\mathbb{S}^{n-1}$. Assume

$$
\begin{equation*}
-\Delta_{s}+q(\theta) \geq-\frac{1}{4}(n-2)^{2}, \quad \text { on } L^{2}\left(\mathbb{S}^{n-1}\right) \tag{4.21}
\end{equation*}

We have that $\tilde{P}_{0} \geq 0$ in $L^{2}\left(\mathbb{R}^{n}\right)$, if (4.21) holds. By the above notation, we can see that operator $P$ can be treated as the perturbation of $P_{0}$, and if we denote $V=\sum_{i=1}^{2}\left|\nabla \chi_{i}\right|^{2}+V_{2}+\chi_{1}^{2} V_{1}$, then $P=P_{0}+V . V$ satisfies

Let $\tilde{R}_{0}(z)=\left(\tilde{P}_{0}-z\right)^{-1}$ for $z \notin \sigma\left(P_{0}\right)$. For the later purpose, we should establish the asymptotic expansion of $\frac{d}{d z} \tilde{R}_{0}(z)$ for $z$ near 0 . Let

Since $\mathfrak{J} z>0$, and $J_{v}\left(\frac{1}{2 t}\right)=O\left(t^{1 / 2}\right)$ as $t \rightarrow 0, J_{v}\left(\frac{1}{2 t}\right)=O\left(t^{-v}\right)$ as $t \rightarrow \infty$, one has

= & \left(\frac{1}{i \rho}\right)^{N}(-1)^{N} \int_{0}^{\infty} e^{i \rho \lambda} \sum_{i_{1}+i_{2}+i_{3}=N} C\left(i_{1}, i_{2}, i_{3}\right) \frac{d^{i_{1}}}{d \lambda^{i_{1}}}\left(e^{i \frac{z \tau \tau}{\lambda}}\right) \frac{d^{i_{2}}}{d \lambda^{i_{2}}}\left(J_{v}\left(\frac{\lambda}{2}\right)\right) \frac{d^{i_{3}}}{d \lambda^{i_{3}}}\left(\lambda^{-2}\right) d \lambda \\
= & \left(\frac{i}{\rho}\right)^{N} \int_{0}^{\infty} e^{i \rho \lambda+i \frac{z r \tau}{\lambda}} \sum_{i_{1}+i_{2}+i_{3}=N} \sum_{0 \leq k \leq i_{1}} C^{\prime}\left(i_{1}, i_{2}, i_{3}, k\right) \frac{d^{i_{2}}}{d \lambda^{i_{2}}}\left(J_{v}\left(\frac{\lambda}{2}\right)\right)\left(i z r \tau \lambda^{-2}\right)^{k} \lambda^{k-i_{1}} \lambda^{-2-i_{3}} d \lambda \\
= & \left(\frac{i}{\rho}\right)^{N} \int_{0}^{\infty} e^{i \frac{\rho}{t}+i z r \tau t} \sum_{i_{1}+i_{2}+i_{3}=N} \sum_{0 \leq k \leq i_{1}} C^{\prime}\left(i_{1}, i_{2}, i_{3}, k\right) \frac{d^{i_{2}}}{d t^{i_{2}}}\left(J_{v}\right)\left(\frac{1}{2 t}\right)(i z r \tau)^{k} t^{i_{1}+i_{3}+k} d t .

One has $\frac{d^{i}}{d z^{2}} J_{v}(z)=O\left(|z|^{\nu-i_{2}}\right)$ when $z \rightarrow 0$, and $\frac{d^{i}}{d z^{i_{2}}} J_{v}(z)=O\left(|z|^{-1 / 2}\right)$ when $z \rightarrow \infty$, since $J_{v}^{\prime}(z)=v J_{v}(z) / z-J_{v+1}(z)$ (see [72, P.45]). It follows that

Then for all $z \in U$, one has $\left|\frac{d}{d z} K_{\nu}(r, \tau ; z) \phi(\tau) \tau^{(n-1)}\right| \leq g(\tau)$, and $g(\tau) \in L^{1}\left(\mathbb{R}_{+}\right)$if $N$ large enough. This ends the proof.

In the following, we suppose that $0 \notin \sigma_{\infty}$. We use the method used in [70] to get the asymptotic expansion of $\frac{d}{d z}\left(\tilde{P}_{0}-z\right)^{-1}$. In [70], X.P. Wang got the expansion of $\left(\tilde{P}_{0}-z\right)^{-1}$, we wish to take the derivative in that formula.

$\operatorname{Using}$ (3.9) and (3.10), we can get $\left|I I I_{1}\right| \leq C_{N}|z|^{N}(r \tau)^{N+1-\frac{n-2}{2}}$, and $\left|I I I_{2}\right| \leq C_{N}|z|^{N}(r \tau)^{N+1-\frac{n-2}{2}}$. It follows that $I I I=O\left(|z|^{N}\right)$ in $\mathcal{L}(0, s ; 0,-s), s>N+2$.

(1). if $\mathfrak{R} z=0$, then $f(z) \in X_{0}$, and if $\mathfrak{R} z=1$, then $f(z) \in X_{1}$;
(2). $\sup _{z \in S}\|f(z)\|_{+}<\infty$;
(3). $\left|\|f \mid\| \equiv \sup _{t \in \mathbb{R}}\left\{\|f(i t)\|^{(0)},\|f(i t)\|^{(0)}\right\}<\infty\right.$.

$\forall x \in X$, let $\|x\|^{(t)}=\inf \{|\|f\| \|| f \in \mathscr{F}(X), f(t)=x\}$. Let $X_{t}$ be the completion of $X$ in the norm $\|\cdot\|^{(t)}$. From appendix of IX. 4 [55], we know that $X_{t}=\mathscr{F}(X) / K_{t}$.

Theorem 4.7. (Calderon-Lions interpolation theorem) Let $X$ and $Y$ be complex vector spaces with given consistent norms $\|\cdot\|_{X}^{(0)}$ and $\|\cdot\|_{X}^{(1)}$ on $X$ and $\|\cdot\|_{Y}^{(0)}$ and $\|\cdot\|_{Y}^{(1)}$ on $Y$. Suppose that $T(\cdot)$ is an analytic, uniformly bounded, continuous, $\mathscr{L}\left(X_{+}, Y_{+}\right)$-valued function on the strip $S$ with the following properties :
(1). $T(t): X \rightarrow Y$ for each $t \in(0,1)$.
(2). For all $y \in \mathbb{R}, T(i y) \in \mathscr{L}\left(X_{0}, Y_{0}\right)$ and

(b). Suppose $F(z)=O\left(|z|^{m_{1}}\right) \in \mathcal{L}\left(0, s_{1} ; 0,-s_{1}\right)$ and $F(z)=O\left(|z|^{m_{2}}\right) \in \mathcal{L}\left(0, s_{2} ; 0,-s_{2}\right)$. Then $F(z)=O\left(|z|^{(1-t) m_{1}+t m_{2}}\right) \in \mathcal{L}\left(0, p_{t} ; 0,-p_{t}\right)$.

Proof. (a). Let $X=L^{2, s_{1}}\left(\mathbb{R}_{n}\right) \cap L^{2, s_{2}}\left(\mathbb{R}_{n}\right)$. Since $C_{0}^{\infty}\left(\mathbb{R}_{n}\right)$ is dense in $X$, it suffices to show that $\|\cdot\|^{(t)}-$ norm on $C_{0}^{\infty}\left(\mathbb{R}_{n}\right)$ coincides with $\|\cdot\|_{p_{t}}-$ norm on $C_{0}^{\infty}\left(\mathbb{R}_{n}\right)$. Let $t \in(0,1)$ and $\phi \in C_{0}^{\infty}\left(\mathbb{R}_{n}\right)$ and define

To prove $\|\phi\|_{L^{2}, p_{t}} \leq\|f\|^{(t)}$, let $f \in \mathscr{F}(X)$ and let $\psi \in C_{0}^{\infty}\left(\mathbb{R}^{n}\right)$. Let $g(z)=\langle x\rangle^{-\frac{p_{t}-s_{1}+1 t\left(s_{1}-s 2\right)}{2}} \psi, H(z)=\int_{\mathbb{R}^{n}} f(z) g(z) d x$. Then $H(z)$ is analytic and bounded in $S$, and $H(t)=\int_{\mathbb{R}^{n}} f(t) \psi d x$. By the three line theorem, one has

Thus the norms $\|\cdot\|_{L^{2, p t}}$ and $\|\phi\|^{(t)}$ agree on $C_{0}^{\infty}$. Since $C_{0}^{\infty}$ is dense in $X$, we conclude that $X_{t}=L^{2, p_{t}}$.
(b). Let $T(\lambda ; z)=|z|^{m_{1}(\lambda-1)-m_{2} \lambda} F(z)$, for $\lambda \in S$. Apply Calderon-lions interpolation theorem to $T(\lambda ; z)$, we conclude (b).

### 4.4 Residues of the trace at zero

Let $f \in C_{0}^{\infty}(\mathbb{R})$ and $f(t)=1$ for $t$ near 0 . Then $\left(R(z)-R_{0}(z)\right) f(P)$ is in trace class for $z \notin \sigma(P)$ and $z \rightarrow T(z)=\operatorname{Tr}\left[\left(R(z)-R_{0}(z)\right) f(P)\right]$ is meromorphic on $\mathbb{C} \backslash \mathbb{R}_{+}$. We want to calculate the residues of $T(z)$ at $z=0$. First, we recall some results (see [55, IX.4] for details ).

Definition 4.11. Let $A$ be a compact operator on a separable Hilbert space $H$. We say that $A \in \mathscr{S}_{p}(H), 1 \leq p<\infty$, if $|A|^{p}$ is a trace class operator and set $\|A\|_{p}=\left(\operatorname{Tr}|A|^{p}\right)^{1 / p}$.

Proposition 4.12. ([55, IX.4]) Let $1 \leq p<\infty$ and $p^{-1}+q^{-1}=1$.
(a).If $A \in \mathscr{S}_{p}$ and $B \in \mathscr{S}_{q}$, then $A B \in \mathscr{S}_{1}$ and $\|A B\|_{1} \leq\|A\|_{p} \cdot\|B\|_{q}$.
(b). $\mathscr{S}_{p}$ is a Banach space with norm $\|\cdot\|_{p}$.
(c). $\mathscr{S}_{1} \subset \mathscr{S}_{p}$.
(d).If $A \in \mathscr{S}_{p}$, then $A^{*} \in \mathscr{S}_{p}$ and $\left\|A^{*}\right\|_{p}=\|A\|_{p}$.

By Proposition 4.10, one has for $z$ near $0, \mathfrak{J} z \neq 0$,

By Proposition 4.10, one has $\langle x\rangle^{-s} R_{0}(z)\langle x\rangle^{-s^{\prime}}$ is uniformly bounded for $z$ near $0, \mathfrak{J} z \neq 0$. Then we deduce that $F_{2}(z) \in \mathscr{S}_{m}$, and $\left\|F_{2}(z)\right\|_{m} \leq C$ with some constant $C$ independent of $z$. Moreover from the above argument, we can see that $\lim _{z \rightarrow 0} F_{2}(z)$
exists in $\mathscr{S}_{m}$. One has $F_{1}(z)=\langle x\rangle^{-s} R_{0}(z)\langle x\rangle^{-s^{\prime}}\langle x\rangle^{s^{\prime}} \chi\left(P_{0}\right)\langle x\rangle^{-s}$ for $s^{\prime}>1$. Using the similar argument as above, we can get that $\left\|F_{1}(z)\right\|_{m} \leq C$ with some constant $C$ independent of $z$, and $\lim _{z \rightarrow 0} F_{1}(z)$ exists in $\mathscr{S}_{m}$. ### 4.5 Levinson's theorm

In this section, we use Theorem 4.1 to prove Levinson's theorem. First, we should verify that the conditions (4.6) and (4.10) hold. We start this section with recalling a result.

Theorem 4.15. (Theorem 2.2 [25]) Assume that $n \geq 3, V \in L_{\text {loc }}^{n / 2}$ and there exists some $q \in$ $\left[\frac{n}{2}, \infty\right]$ such that

$C_{f}$ is the constant independent of $z$. For any $\delta>0$, if $\rho>n+3, \lim _{\epsilon \downarrow 0} \operatorname{Tr}\left[\left(R(\lambda \pm i \epsilon)-R_{0}(\lambda \pm i \epsilon)\right) f(P)\right]$ exists if $\lambda>\delta$. Moreover, there exists $C_{\delta, f}>0$ such that

(c). $(P-i)^{-k}-\left(P_{0}-i\right)^{-k}$ is of trace class, if $k>n / 2-1$ and $\rho>n$.
(d). $\sigma_{a c}\left(P_{0}\right)=\sigma_{a c}(P)=[0,+\infty[$.
(e). $\xi^{\prime}(\lambda) \in L_{l o c}^{1}(] 0, \infty[)$.

Proof. (a). Let $f_{1}$ be the smooth function such that $f_{1} f=f$. For $z \notin \sigma(P) \cup \sigma\left(P_{0}\right)$,

Note that the principal symbol of $\langle x\rangle^{-s} f_{1}(P) R(z)\langle x\rangle^{s}$ is $\frac{f\left(\left.\xi \xi\right|^{2}+V_{1}+V_{2}\right)}{|\xi|^{2}+V_{1}+V_{2}-z}$, and $f_{1}$ is a smooth function with compact support. By Calderon-Vaillancourt theorem, one has that $\left\|\langle x\rangle^{-s} f_{1}(P) R(z)\langle x\rangle^{s}\right\|=O\left(|z|^{-1}\right)$ for $|z|$ large enough. Choose $1 / 2<s<\frac{\rho-n}{2}$, then

It follows that if $\rho>n+3$, $\left|\lim _{\epsilon \leq 0} F_{1}(\lambda+i \epsilon)\right| \leq C_{\delta, f}$ for some $C_{\delta, f}>0$. Similarly, we can get $\left|\lim _{\epsilon \in 0} F_{2}(\lambda+i \epsilon)\right| \leq C_{\delta, f}$. It follows that $\left|\lim _{\epsilon\rfloor 0} F(\lambda+i \epsilon)\right| \leq C_{\delta, f}$. $\left|\lim _{\epsilon \backslash 0} F(\lambda-i \epsilon)\right| \leq C_{\delta, f}$ can be proved in the same way.

Then the number of negative eigenvalues of $P$ is less then the number of negative eigenvalues of $\left(1-\alpha_{0}\right)(-\Delta)+\tilde{W}$. Since $\rho>2, \tilde{W} \in L^{n / 2}\left(\mathbb{R}^{n}\right)$ for $n \geq 3$. By Cwikel-Lieb-Rosenbljum formula ([54, Theorem XIII.12]), one has that the number of bound states, $N(\tilde{W})$, of $\left(1-\alpha_{0}\right)(-\Delta)+\tilde{W}$ has the following estimate

It is easy to check that the conditions of Theorem 4.15 are satisfied for $q=n$ and $0<\delta_{0}<1 / 2$. Then by Theorem 4.15, one has that $u=0$. This means that $P_{0}$ has no positive eigenvalues. Similarly, we can get that $P$ has no positive eigenvalues.
(e). By Theorem 1.2 [49], one has that $\xi^{\prime}(\lambda) \in C^{\infty}\left(\left[\lambda_{0}, \infty\right)\right.$ for any $\lambda_{0}>0$. This ends the proof.

Let $b_{0}(x, \xi) \in C_{0}^{\infty}\left(\mathbb{R}^{n}\right)$ and $b_{ \pm}(x, \xi) \in C^{\infty}\left(\mathbb{R}^{n}\right)$ be non-negative functions such that

Let $\tilde{b}_{ \pm}(x, \xi) \in C^{\infty}$ satisfy (4.49) and $b_{0}(x, \xi)+\tilde{b}_{+}(x, \xi)+\tilde{b}_{-}(x, \xi)=1$, and there exists some $0<\delta^{\prime}<1$ such that $\operatorname{supp} \tilde{b}_{ \pm}(x, \xi) \subset\left\{(x, \xi) ; \pm \hat{x} \cdot \hat{\xi}>-\left(1-\delta^{\prime}\right)\right\}$, and $b_{-} \tilde{b}^{+}=0$. Denote by $a(x, D)$ by the pseudodifferential operator with the symbol $a(x, \xi)$ defined by

Let $0 \leq \chi \leq 1$ be a smooth function with compact support such that $\chi(x)=1$ for $|x| \leq 1$. Let $\chi_{R}(x)=\chi\left(\frac{x}{R}\right)$. By (3.7) [49], one has

with $\tilde{c}_{j}=c_{j} \int_{0}^{\infty} \chi(t) t^{\frac{n}{2}-1-j} d t$. By Theorem 1.1 [49], one has

$$
\begin{equation*}
\operatorname{Tr}\left(\chi\left(\frac{P}{R}\right)-\chi\left(\frac{P_{0}}{R}\right)\right) \sim \sum_{j \geq 1} \beta_{j} R^{\frac{n}{2}-j} \tag{4.51}
\end{equation*}
$$

as $R \rightarrow \infty$. It follows

$$
\begin{equation*}
\int_{0}^{\infty} \chi\left(\frac{\lambda}{R}\right)\left[g(\lambda)-\sum_{j=1}^{\left[\frac{n}{2}\right]} c_{j} \lambda^{\frac{n}{2}-1-j}\right] d \lambda=-\left(N+J_{0}\right)+\sum_{j=1}^{\left[\frac{n}{2}\right]}\left(\beta_{j}-\tilde{c}_{j}\right) R^{\frac{n}{2}-j}+O\left(R^{-\epsilon}\right) \tag{4.52}
\end{equation*}
$$

where $\epsilon=-1+\frac{n}{2}-\left[\frac{n}{2}\right]>0 . \int_{0}^{\infty} \chi\left(\frac{\lambda}{R}\right)\left[g(\lambda)-\sum_{j=1}^{\left[\frac{n}{2}\right]} c_{j} \lambda^{\frac{n}{2}-1-j}\right] d \lambda$ can be written as

$$
\begin{aligned}
& \int_{0}^{\infty} \chi\left(\frac{\lambda}{R}\right)\left[g(\lambda)-\sum_{j=1}^{\left[\frac{n}{2}\right]} c_{j} \lambda^{\frac{n}{2}-1-j}\right] d \lambda \\
= & \int_{0}^{1} \chi\left(\frac{\lambda}{R}\right)\left[g(\lambda)-\sum_{j=1}^{\left[\frac{n}{2}\right]} c_{j} \lambda^{\frac{n}{2}-1-j}\right] d \lambda+\int_{1}^{\infty} \chi\left(\frac{\lambda}{R}\right)\left[g(\lambda)-\sum_{j=1}^{\left[\frac{n}{2}\right]} c_{j} \lambda^{\frac{n}{2}-1-j}\right] d \lambda
\end{aligned}
$$

Since $g \in C^{\infty}(0,1)$ and $g$ is integrable at 0 , thus

$$
\lim _{R \rightarrow+\infty} \int_{0}^{1} \chi\left(\frac{\lambda}{R}\right)\left[g(\lambda)-\sum_{j=1}^{\left[\frac{n}{2}\right]} c_{j} \lambda^{\frac{n}{2}-1-j}\right] d \lambda=\int_{0}^{1}\left[g(\lambda)-\sum_{j=1}^{\left[\frac{n}{2}\right]} c_{j} \lambda^{\frac{n}{2}-1-j}\right] d \lambda
$$

By Theorem 1.2 [49], one has $\xi^{\prime}(\lambda) \in C^{\infty}(0, \infty)$ and

$$
\begin{equation*}
\xi^{\prime}(\lambda) \sim \sum_{j \geq 1} c_{j} \lambda^{\frac{n}{2}-j-1}, \text { as } \lambda \rightarrow+\infty \tag{4.53}
\end{equation*}
$$

By Lemma 4.17 and the above formula, we get $\left|g(\lambda)-\sum_{j=1}^{\left[\frac{n}{2}\right]} c_{j} \lambda^{\frac{n}{2}-1-j}\right| \leq C \lambda^{-v}$ with $v=2-\left(\frac{n}{2}-\right.$ $\left.\left[\frac{n}{2}\right]\right)>1$. Therefore,

$$
\lim _{R \rightarrow+\infty} \int_{1}^{\infty} \chi\left(\frac{\lambda}{R}\right)\left[g(\lambda)-\sum_{j=1}^{\left[\frac{n}{2}\right]} c_{j} \lambda^{\frac{n}{2}-1-j}\right] d \lambda=\int_{1}^{\infty}\left[g(\lambda)-\sum_{j=1}^{\left[\frac{n}{2}\right]} c_{j} \lambda^{\frac{n}{2}-1-j}\right] d \lambda
$$

It follows that

$$
\begin{aligned}
& \lim _{R \rightarrow+\infty} \int_{0}^{\infty} \chi\left(\frac{\lambda}{R}\right)\left[g(\lambda)-\sum_{j=1}^{\left[\frac{n}{2}\right]} c_{j} \lambda^{\lambda^{\frac{n}{2}-1-j}}\right] d \lambda \\
= & \int_{0}^{\infty}\left[g(\lambda)-\sum_{j=1}^{\left[\frac{n}{2}\right]} c_{j} \lambda^{\frac{n}{2}-1-j}\right] d \lambda=\int_{0}^{\infty}\left[\xi^{\prime}(\lambda)-\sum_{j=1}^{\left[\frac{n}{2}\right]} c_{j} \lambda^{\left.\lambda^{\frac{n}{2}-1-j}\right] d \lambda .}\right.
\end{aligned}
$$

Let $R \rightarrow+\infty$ in both sides of (4.52) we get that $\beta_{j}=\tilde{c}_{j}$. Thus, we get the Levinson's Theorem for odd dimension.

Case 2 : The dimension $n$ is even. Suppose $n=2 p$.

As in case 1 , we can drive that

$$
\begin{align*}
& \int_{0}^{\infty} \chi\left(\frac{\lambda}{R}\right)\left[g(\lambda)-\sum_{j=1}^{p-1} c_{j} \lambda^{p-1-j}\right] d \lambda \\
= & -\left(N+J_{0}\right)+\sum_{j=1}^{p-1}\left(\beta_{j}-\tilde{c}_{j}\right) R^{\frac{n}{2}-j}+\beta_{p}+O\left(R^{-1}\right), \tag{4.54}
\end{align*}
$$

with $\tilde{c}_{j}=\int_{0}^{\infty} \chi(t) t^{p-1-j} d t$. The first term in (4.54) can be written as :

$$
\int_{0}^{1} \chi\left(\frac{\lambda}{R}\right)\left[g(\lambda)-\sum_{j=1}^{p-1} c_{j} \lambda^{\frac{n}{2}-1-j}\right] d \lambda+\int_{1}^{\infty} \chi\left(\frac{\lambda}{R}\right)\left[g(\lambda)-\sum_{j=1}^{p-1} c_{j} \lambda^{\frac{n}{2}-1-j}\right] d \lambda
$$

Note that

$$
\int_{1}^{\infty} \chi\left(\frac{\lambda}{R}\right)\left[g(\lambda)-\sum_{j=1}^{p-1} c_{j} \lambda^{\frac{n}{2}-1-j}\right] d \lambda=\int_{1}^{\infty} \chi\left(\frac{\lambda}{R}\right)\left[\frac{c_{p}}{\lambda}+h(\lambda)\right] d \lambda
$$

with $h(\lambda)=O\left(\frac{1}{\lambda^{2}}\right)$. Formula (4.54) can be written as :

$$
\begin{aligned}
& \int_{0}^{1} \chi\left(\frac{\lambda}{R}\right)\left[g(\lambda)-\sum_{j=1}^{p-1} c_{j} \lambda^{\frac{n}{2}-1-j}\right] d \lambda+\int_{1}^{\infty} \chi\left(\frac{\lambda}{R}\right) h(\lambda) d \lambda \\
= & -\left(N+J_{0}\right)+\sum_{j=1}^{p-1}\left(\beta_{j}-\tilde{c}_{j}\right) R^{p-j}-c_{p} \int_{1}^{\infty} \chi\left(\frac{\lambda}{R}\right) \frac{d \lambda}{\lambda}+\beta_{p}+O\left(\frac{1}{R}\right) .
\end{aligned}
$$

As before, we can conclude that

$$
\int_{0}^{1} \chi\left(\frac{\lambda}{R}\right)\left[g(\lambda)-\sum_{j=1}^{p-1} c_{j} \lambda^{\frac{n}{2}-1-j}\right] d \lambda+\int_{1}^{\infty} \chi\left(\frac{\lambda}{R}\right) h(\lambda) d \lambda
$$

converges to

$$
\int_{0}^{1}\left[\xi^{\prime}(\lambda)-\sum_{j=1}^{p-1} c_{j} \lambda^{p-1-j}\right] d \lambda+\int_{1}^{\infty} h(\lambda) d \lambda
$$

as $R \rightarrow+\infty$. It follows $\beta_{j}=\tilde{c}_{j}$. Since $\int_{1}^{\infty} \chi\left(\frac{\lambda}{R}\right) \frac{d \lambda}{\lambda}=\int_{\frac{1}{R}}^{\infty} \chi(t) \frac{d t}{t} \sim \log R$, we can drive that $c_{p}=0$. Hence

$$
h(\lambda)=\xi^{\prime}(\lambda)-\sum_{j=1}^{p-1} c_{j} \lambda^{p-1-j}
$$

Therefore, we get the Levinson's theorem for even dimension :

$$
\int_{0}^{\infty}\left(\xi^{\prime}(\lambda)-\sum_{j=1}^{p-1} c_{j} \lambda^{p-1-j}\right) d \lambda=-\left(N+J_{0}\right)+\beta_{p}
$$

Remark 4.19. The values of $\beta_{p}$ is independent of $\chi$. We use the formula in [15] to compute $\beta_{p}$. Let $V_{0}=\frac{\chi_{2}^{2}}{r^{2}} q(\theta)-\sum_{i=1}^{2}|\nabla \chi|^{2}$ and $\tilde{V}_{0}=V_{0}+V$. Then $P_{0}=-\Delta+V_{0}$ and $P=-\Delta+\tilde{V}_{0}$.

- $n=2$ (i.e. $p=1$ ) :

$$
\beta_{1}=\frac{1}{(2 \pi)^{2}} \gamma_{2} \int_{\mathbb{R}^{2}} \tilde{V}_{0} d x \int_{\mathbb{R}_{+}} \chi^{\prime}(\rho) d \rho
$$

Using $\int_{\mathbb{R}_{+}} \chi^{\prime}(\rho) d \rho=1$, we get that

$$
\beta_{1}=C \int_{\mathbb{R}^{2}} \tilde{V}_{0} d x
$$

with $C=\frac{1}{(2 \pi)^{2}} \gamma_{2}$.

- $n=4$ (i.e. $p=2$ ) :

$$
\beta_{2}=\frac{1}{(2 \pi)^{4}} \frac{\gamma_{4}}{2} \int_{\mathbb{R}^{4}} \tilde{V}_{0}^{2}(x)+2 \tilde{V}_{0}(x) V_{0}(x) d x \int_{\mathbb{R}_{+}} \rho \chi^{\prime \prime}(\rho) d \rho
$$

Using $\int_{\mathbb{R}_{+}} \rho \chi^{\prime \prime}(\rho) d \rho=1$, we get that

$$
\beta_{2}=C \int_{\mathbb{R}^{4}} \tilde{V}_{0}^{2}(x)+2 \tilde{V}_{0}(x) V_{0}(x) d x
$$

with $C=\frac{1}{(2 \pi)^{4}} \frac{\gamma_{4}}{2}$.

- $n=6$ (i.e. $p=3$ ) :

$$
\begin{aligned}
\beta_{3}=C & \int_{\mathbb{R}^{6}} \\
& \tilde{V}_{0}^{3}(x)+3 \tilde{V}_{0}^{2}(x) V_{0}(x)+3 \tilde{V}_{0}(x) V_{0}^{2}(x) \\
& +\frac{1}{4}\left|\nabla \tilde{V}_{0}(x)\right|^{2}+\frac{1}{2} \nabla \tilde{V}_{0}(x) \cdot \nabla V_{0}(x) d x \int_{\mathbb{R}_{+}} \rho^{2} \chi^{\prime \prime \prime}(\rho) d \rho
\end{aligned}
$$

$U \operatorname{sing} \int_{\mathbb{R}_{+}} \rho^{2} \chi^{\prime \prime \prime}(\rho) d \rho=2$,

$$
\beta_{3}=C \int_{\mathbb{R}^{6}} \tilde{V}_{0}^{3}(x)+3 \tilde{V}_{0}^{2}(x) V_{0}(x)+3 \tilde{V}_{0}(x) V_{0}^{2}(x)+\frac{1}{4}|\nabla V(x)|^{2}+\frac{1}{2} \nabla \tilde{V}_{0}(x) \cdot \nabla V_{0}(x) d x
$$

Résumé : On étudie dans cette thèse certains problèmes spectraux pour des opérateurs de Schrödinger. On s'intéresse d'abord à la limite semi-classique pour le nombre d'états propres de l'opérateur de Schrödinger à N corps. On utilise ensuite le crochet de Dirichlet-Neumann pour obtenir la limite semi-classique des moyennes de Riesz des valeurs propres discrètes pour l'opérateur de Schrödinger à N corps. On considère également le potentiel effectif de l'opérateur de Schrödinger à N corps avec potentiel de Coulomb et on obtient qu'il a une décroissance critique à l'infini. On étudie donc l'opérateur de Schrödinger à potentiel critique. On s'intéresse au seuil pour la constante de couplage et au développement asymptotique de la résolvante de l'opérateur de Schrödinger, puis on utilise ce développement pour étudier la limite à basse énergie de la dérivée de la fonction de décalage spectral pour une perturbation à décroissance critique. Finalement, on utilise ce résultat avec le résultat connu pour le développement asymptotique à haute énergie de cette fonction de décalage spectral pour obtenir le théorème de Levinson.

Summary : This PhD thesis deals with some spectral problems of Schrödinger operators. We first consider the semi-classical limit of the number of bound states of unique two-cluster N body Schrödinger operator. Then we use Dirichlet-Neumann bracket to get semi-classical limit of Riesz means of the discrete eigenvalues of N-body Schrödinger operator. The effective potential of N-body Schrödinger operator with Coulomb potential is also considered and we find that the effective potential has critical decay at infinity. Thus, the Schrödinger operator with critical potential is studied in this thesis. We study the coupling constant threshold of Schrödinger operator with critical potential and the asymptotic expansion of resolvent of Schrödinger operator with critical potential. We use that expansion to study low-energy asymptotics of derivative of spectral shift function for perturbation with critical decay. After that, we use this result and the known result for high-energy asymptotic expansion of spectral shift function to obtain the Levinson theorem.
