# Selective poly-hetero-functionalization of cyclodextrins: realization of the hexadifferentiation of $\alpha$-cyclodextrin and the pentadifferentiation of $\boldsymbol{\beta}$-cyclodextrin 


#### Abstract

Functionalization of $C_{\mathrm{n}}$-symmetric concave cycles, especially their post-functionalization, has an important impact on their nature and their applications. In the past few decades, plenty of work has been invested in the development of simple and efficient methods. Great progress has been made concerning functionalization of cyclodextrins particularly since the discovery of the DIBAL-H-mediated debenzylation reaction. Based on this reaction and well-established site-directing rules, various cyclodextrin patterns are now accessible. However, the patterns with the higher level of complexity, i.e. hexadifferentiation of $\alpha$-cyclodextrin and heptadifferentiation of $\beta$-cyclodextrin, were still out of reach. Firstly, we combined the previously delineated site-directing rules to synthesize, for the first time, the ultimate hexadifferentiated $\alpha$-cyclodextrin on which each glucose unit possesses a different function. It opens the way to the synthesis of all $\mathbf{7 8 2 6}$ possible combinations of $\mathbf{6}$ functions on $\alpha$-cyclodextrin. Then the reactivity of DIBAL-H was studied on sulfur- and selenium-derived $\alpha$-cyclodextrins, and two site-directing methods: tandem thioester-reduction/debenzylation and a new "frustration" strategy were disclosed, which enable the preparation of new patterns of cyclodextrins. Much efforts were also paid to reach heptadifferentiated $\beta$-cyclodextrin. The initial amine strategy only gave the tetradifferentiated patterns probably due to the coordination between amine and aluminum reagents. Finally, utilization of the uncovered tandem thioester-reduction/debenzylation method allowed us to access pentadifferentiated patterns, which still need to undergo two successive debenzylation reactions to reach the ultimate heptadifferentiated $\beta$-cyclodextrin with different thioethers on its primary rim.

## RÉSUMÉ

La fonctionnalisation des cycles concaves du symétrie $C_{\mathrm{n}}$, en particulier leur post-fonctionnalisation, est importante pour leur nature et leurs applications. Au cours des dernières décennies, beaucoup de travail a été investi dans le développement de méthodes simples et efficaces pour ce fait. De grands progrès ont été réalisés concernant la fonctionnalisation des cyclodextrines, particulièrement depuis la découverte de la réaction de débenzylation utilisant DIBAL-H (l'hydrure de diisobutyl aluminium). Basés sur cette réaction et les méthodes de déprotection sélectives, divers motifs de l'hétérofonctionnalisation comportant de 2 à 3 fonctions differentes sont maintenant accessibles du façon sélective. Toutefois, les motifs plus complexes, comme l'hexadifférentiation de l' $\alpha$-cyclodextrine et l'heptadifférentiation de la $\beta$-cyclodextrine, étaient encore inaccessibles. Tout d'abord, nous avons combiné les méthodes de déprotection sélectives établies précédemment, pour synthétiser, pour la première fois, l' $\alpha$-cyclodextrine hexadifférenciée inédite sur laquel chaque unité de glucose possède une fonction différente. Cette réalisation ouvre la voie d'accès à toutes les $\mathbf{7 8 2 6}$ combinaisons possibles de $\mathbf{6}$ fonctions sur une $\alpha$-cyclodextrine.
Ensuite, la réactivité du DIBAL-H a été étudiée sur des $\alpha$-cyclodextrines fonctionnalisées avec des atoms de soufre et de selenium, et deux méthodes sélectives: la réaction tandem de debenzylation/reduction de thioester et une nouvelle stratégie de "frustration" ont été mise à jour, ce qui permettent l'accès à de nouveaux motifs de fonctionnalisation de cyclodextrines. Beaucoup d'efforts ont également été faits pour atteindre la $\beta$-cyclodextrine heptadifférenciée. La stratégie initiale utilisant les amines a seulement donné des motifs tétradifférenciées probablement à cause de la coordination entre les amines et les réactifs aluminium. Enfin, l'utilisation de la réaction tandem de débenzylation/réduction de thioester, nous a permis d'accéder à des cyclodextrines pentadifférenciées, qui doivent encore subir deux réactions de débenzylation successives pour atteindre la $\beta$-cyclodextrine heptadifférenciée avec des thioéthers différents sur sa couronne primaire.

## CHAPTER I

## FUNCTIONALIZATION OF $C_{n}$-SYMMETRIC CONCAVE CYCLES

## 1. Introduction

Cyclic concave molecules are a family of macrocyclic molecules, composed of $n$ identical monomers with $C_{\mathrm{n}}$-symmetry. Some of the most studied molecules comprise natural cyclodextrins and synthetic calixarenes, cucurbiturils, and the most recent pillararenes (Figure I-1). They all possess unique tridimensional architecture with variable-sized cavities, allowing them to be used as molecular receptors ${ }^{1}$ or catalysts ${ }^{2}$.

To adjust the properties and develop new applications, introduction of new functions on precise positions of these molecules is desired, which aims to: 1) alter their properties of complexation (such as changing the solubility in different media) or modulate the size of cavity; 2) import synthetic handle that can be further modified to meet specific applications, for instance, the introduction of terminal alkynes or azides for click reactions.
However, functionalization of these $C_{\mathrm{n}}$-symmetric molecules is a challenging task to chemists. Intrinsically, the reason lies in the identical chemical reactivity of each unit which could give different regioisomeric products.

In this thesis, we use the following definitions:

Functionalization on a position means that this position has been modified. That is we can introduce the same group to substitute one or more hydroxyls. If only one position is modified, the molecule is monofunctionalized, difunctionalized if two positions are modified, trifunctionalized if three positions are modified and if all the hydroxyls are replaced by identical groups, it is called perfunctionalized (Figure I-2).

Differentiation of the positions means that different modifications have been made on more than one positions. Differentiation means that different groups are introduced (tridifferentiated if three groups are present, tetradifferentiated if four different groups are present, and so on). Each differentiation have different patterns. The number of arrangements can be calculated by combinatorics equations (Equation I-1).

(a) Equation for calculation of possible pattern arrangements; (b) Equation for calculation of cumulative arrangements ( $n$ means the number of monomer or functionalizable sites, $k$ means the number of different functions)

According to combinatorics calculation (Equation I-1 and Table I-1): for a cycle of $C_{6}$-symmetry with six functionalizable sites, the number of cumulative arrangements $\boldsymbol{N}_{\boldsymbol{k}}(\boldsymbol{n})$ includes the arrangements of the lower rank and that with exactly $k$ colors. For example, there are 14 ways to arrange two functions, 130 ways to arrange three functions, 700 ways to arrange four functions, 2635 ways to arrange five functions and 7826 ways to arrange six functions, i.e. 6 arragements of undifferentiated pattern, 180 arragements of differentiated patterns, 1820 arragements of tridifferentiated patterns, 3900 arragements of tetradifferentiated patterns, 1800 arragements of pentadifferentiated patterns and 120 arragements of hexadifferentiated pattern (the detail calculation see Appendix 1). The arrangements of $n$ beads of $k$ colors can be generated on http://www.jasondavies.com/necklaces/, which corresponds to the well-known combinatorics problem of necklaces ${ }^{3}$. In practice, that means that reacting a $C_{6}$-functionalizable molecule

[^1]with six different reagents of equal reactivity statistically leads to a mixture of $\mathbf{7 8 2 6}$ differently functionalized molecules, ranging from 6 molecules bearing six times the same substituent to 120 molecules with six different substituents.
As shown in Table I-1, many possibilities exist during the functionalization of a $C_{6}$-cyclic concave molecule because of intrinsically symmetrical nature, which makes the functionalization much more difficult. After searching the literature, it clearly appears that numerous functionalized patterns are now available either by laborious chromatographical purification or by specific regioselective methods.
In this chapter, the methodologies we will introduce based on the introduction of new functions to the parent concave cycles, namely post-functionalization. We will not exhaustively discuss all methodologies and functionalized derivatives, just some representative examples concerning calixarenes, cucurbiturils and pillararenes. A detailed introduction of cyclodextrins will be given in Chapter II.

## 2. Calixarenes

Calixarenes are a class of cyclic oligomers, synthesized via a hydroxyl alkylation/condensation between phenols and aldehydes ${ }^{4}$. Calix[ $n$ ]arenes are made of $n$ phenol and metheylene units. Representative members of calixarenes are calix[4]arene and calix[6]arene, composed of 4 and 6 units respectively. Calix[n]arenes are flexible structures (4 conformations for calix[4]arene, 8 conformations for calix[6]arene) in a three-dimensional basket shape with a defined upper and lower rim and a central annulus (Figure I-3).


Figure I-3: Structure of calixarenes

Calixarenes possess remarkable conformational properties and hydrophobic cavities that are able to accommodate neutral or ionic species. Inspired by their unique geometries, calixarenes are attractive for applications in a variety of field, such as artificial enzymes ${ }^{5}$, ion sensitive electrodes or sensors ${ }^{6}$ and supramolecular catalysts ${ }^{7}$. By functionally modifying either the upper and/or the lower rims, or by modulating their conformations, it is possible to prepare various derivatives with differing selectivities for various guest ions and small molecules.
Functionalization of calixarenes mainly focus on two parts (Figure I-4): functionalization of the lower rim and functionalization of the upper rim.

### 2.1 Functionalization of the lower rim of calix[4]arene

The chemical modification of the lower rim of calixarenes, means introduction of functional groups to substitute the hydroxyl groups. According to the functional patterns, it can be divided into mono-, di- and perfunctionalization subparts. Obviously, perfunctionalization can be achieved easily. Hence, we just present the methodologies for mono- and difunctionalization.

### 2.1.1 Monofunctionalization and trifunctionalization of calix[4]arene

In the case of calix[4]arene, monofunctionalization and trifunctionalization give the same pattern: one function differs from the three others. This kind of functionalization mainly fulfilled by two strategies: control the amount of reagents and utilization of tripodal groups. Monofunctionalized calix[4]arene $\mathbf{2}$ was synthesized with an excellent yield by reaction with 1 equivalent of allyl bromide in the presence of one-half molar equivalent of $\mathrm{K}_{2} \mathrm{CO}_{3}$ in acetonitrile ${ }^{8}$ (Scheme I-1). The obtained calix[4]arene 2 can then be transformed into a upper-rim functionalized calixarene by Claisen rearrangement (vide infra).


Scheme I-1: Monofunctionalization of the lower rim of calix[4]arene

Temporary tri-protection of calix[4]arene is another method to achieve monofunctionalized motif. Using 8 equivalents of benzoyl chloride in the presence of pyridine, three benzoyl groups were introduced on the lower rim to give calix[4]arene 3 in $71 \%$ yield ${ }^{9}$ (Scheme I-2). After further functionalization of the free hydroxyl group, hydrolysis of benzoates gave the monofunctionalized calix[4]arene.

[^3]Alternatively, tripodal reagent $\left(\mathrm{Me}_{2} \mathrm{~N}\right)_{3}{ }_{3} \mathrm{SiMe}$ was chosen to protect three phenols on the lower rim simultaneously ${ }^{10}$ (Scheme I-3). The remaining phenol was then functionalized and it was followed by deprotection of silyl ether to give monofunctionalized calix[4]arene 6.

### 2.1.2 Difunctionalization of calix[4]arene

For difunctionalization of calix[4]arene, two possible regioisomers could be produced: proximal 1,2-motif and distal 1,3-motif (Figure I-5). Proximal 1,2-motif has two introduced functional groups on the adjacent hydroxyl groups, while distal 1,3 -motif processes the functional groups on the diametrically opposed positions.

The selective synthesis of 1,3-difunctionalized calix[4]arene has been achieved in the presence of a weak base in acetonitrile. The alkylation of calix[4]arene 4 with propyl iodide in the presence of $\mathrm{K}_{2} \mathrm{CO}_{3}$, gave a distal propoxylated derivative 7 in $74 \%$ yield ${ }^{11}$ (Scheme I-4). While using higher amount of NaOH in DMSO-water medium, 1,2-propylated calix[4]arene 8 was obtained preferentially in $90 \%$ yield ${ }^{12}$. The formed calix[4]arene 8 was then subjected to subsequent alkylation procedure with hexyl iodide in the presence of KHMDS, giving hetero-functionalized derivative $\mathbf{9}$ with 1,2-alternate conformation.

Narumi and Miyano ${ }^{13}$ demonstrated another method to access easily 1,2-difunctionalized motif. Using a disiloxane bridge to protect two adjacent phenols, gave bridged calix[4]arene 10 (Scehme I-5), which was subsequently treated with benzyl bromide in the presence of $t$-BuOK to give dibenzylated product 11 in 1,2 -alternate conformation. In contrast, switching to $\mathrm{Cs}_{2} \mathrm{CO}_{3}$, produced a partial-cone conformation derivative. Then through a quantitative fluoride-promoted desilylation, the selective proximal dibenzylation of calix[4]arene at the lower rim was reached.

Selective deprotection of fully protected calix[4]arene is also an alternative strategy to obtain difunctionalized calixarene. Pochini ${ }^{14}$ presented a method by treatment of calix[4]arene 12 with 2 equivalents of $\mathrm{TiBr}_{4}$, giving an 1,2 -demethylated derivative $\mathbf{1 3}$ in good yield (Scheme I-6), which allowed the synthesis of a new type of calixarene-based crown ether 14. The remaining two methyl groups could be removed using the same method, it was followed by introducing other functional groups to produce hetero-functionalized calix[4] arenes.

### 2.2 Functionalization of the upper rim of calix[4]arene

Functionalization on the upper rim have obtained a lot of achievements ${ }^{15}$. However, it is generally accepted that functionalization on the upper rim is more complicated. It requires to protect the phenols with appropriate functions. As in the case of the lower rim functionalization, we will present the methodologies according to functionalization patterns (mono- and di-functionalization). They can be either directly functionalized on the aromatic cone (Figure I-6a), or by transfering from the functionalized lower rim to the aromatic cone using rearrangement reactions (Figure I-6b).

### 2.2.1 Monofunctionalization and trifunctionalization of calix[4]arene

Monofunctionalization and trifunctionalization give the same pattern (vide supra). The tri-protected calix[4]arene $\mathbf{3}$ can be converted into bromo-calixarene $\mathbf{1 5}$ by direct bromination ${ }^{16}$ and subsequent removal of benzoyl groups. Then it underwent sulfonation by neat sulfuric acid in dichloromethane, provided clean product $17{ }^{17}$ (Scheme I-7). Aryl bromide $\mathbf{1 7}$ was intended to be a precursor for Suzuki couplings. In addition, calixarene $\mathbf{1 5}$ can also be transformed into monophosphine calixarene 16 by a sequence of benzylation, halogen-lithium exchange and reaction with Ph 2 PCl . After debenzylation by aluminum chloride, the obtained product 18 was used in the preparation of Suzuki-Miyaura cross-coupling catalysts. ${ }^{18}$

Besides calixarene 16, tribromo-monophosphine calixarene 21 was synthesized ${ }^{19}$ starting from tetrabromo-calixarene 19. Calixarene 19 was submitted to nickel-catalyzed monophosphorylation to give phosphine oxide 20 in $38 \%$ yield (Scheme I-8). Subsequent reduction with $\mathrm{PhSiH}_{3}$ produced phosphine 21 quantitatively.


Another method for monofunctionalization of the upper rim was explored by Claisen rearrangement ${ }^{8}$. Monosubstituted calixarene 2 was refluxed in $N$, $N$ 'diethylaniline for 2 h , giving the upper rim functionalized calixarene 22 in $71 \%$ yield (Scheme I-9).

### 2.2.2 Difucntionalization of calix[4]arene

Electrophilic aromatic substitution represents straightforward strategy for functionalization of the upper rim of calixarenes, such as nitration or acylation. For instance, nitration of calix[4]arene is a well-established method which can be performed directly, or via

[^7]ipso-substitution. Reinhoudt ${ }^{20}$ showed that tetrapropoxycalix[4]arene 23 can react directly with nitric acid in DCM to give mononitro-calix[4]arene 24, dinitrocalix[4]arenes 25 and 26 in $30 \%, 30 \%$ and $10 \%$ yields, respectively (Scheme I-10).

Meanwhile, Reinhoudt introduced another nitration method by ipso-aromatic nitration ${ }^{21}$. Calix[4]arene 27 was reacted with concentrated nitric acid in a mixture of dichloromethane and acetic acid for 2 days, affording an inseparable mixture of dinitrocalix[4]arene 28, dinitrocalix[4]arene $\mathbf{2 9}$ and trinitrocalix[4]arene $\mathbf{3 0}$ with a ratio of 3:2.2:1 in a total yield of $64 \%$ (Scheme I-11).

To be regioselective, McGiniley ${ }^{22}$ disclosed a method that performed regioselective substitution of the upper rim through partial alkylation of the lower rim. The distal dibutylated derivative 31a was prepared using butyl bromide in the presence of $\mathrm{K}_{2} \mathrm{CO}_{3}$. It was subsequently submitted to ipso-nitration to give calix[4]arene 32 with both the nitro groups on the para-positions of nonsubstituted phenolic units (Scheme I-12). Introduction of two alkyl groups into distal positions makes these two aromatic rings less reactive than those bearing free hydroxyl groups.

Very recently, Lhotak and co-workers ${ }^{23}$ developed a novel strategy by introduction of nosyl groups onto the lower rim of calix[4]arene, enabling a highly regioselective ipso-susbstitution of alkoxy-substituted aromatic rings. The distal dipropoxy derivative 31b was reacted with nosyl chloride in the presence of NaH to give derivative 33 . The ipso-nitration of 33 was carried out using $\mathrm{HNO}_{3}$ in an $\mathrm{AcOH} / \mathrm{DCM}$ mixture, afforded nitro-substituted compound with both nitro groups on the alkylated rings because of stronger deactivating effect of nosyl groups compared with alkoxy groups. It was followed by the deprotection of nosyl groups, giving calix[4]arene 34 (Scheme I-12). They also applied this method to proximally dipropoxylated and tripropoxylated derivatives and produced the corresponding derivatives with nitro groups on the alkylated phenol rings.
Selective acylation on the upper rim of calix[4]arene was explored as well by means of similar principle: introduction of alkoxy groups deactivates the aromatic rings. Huang ${ }^{24}$ reported that dimethylated calix[4]arene $\mathbf{3 5}$ underwent Friedel-Crafts acylation, giving calix[4]arene $\mathbf{3 6}$ in $65 \%$ yield (Scheme I-13). The reaction took place exclusively on the para-positions of the phenolic rings. Alternatively, calix[4]arene 36 can also be synthesized by Fries rearrangement ${ }^{25}$ of corresponding diacetoxycalix[4]arene 37.

[^9]Moreover, deprotection of fully functionalized para-positions of aromatic rings was employed to functionalize the upper rim of calix[4]arene regioselectively. The preparation of calixarene 40 is similar to that of 21 (Scheme I-8). Firstly, distal 1,3-bromo-calixarene 39 was synthesized in $90 \%$ yield by reaction of 19 with 2 equivalents of $n$-BuLi and subsequent quenching with methanol (Scheme I-14). Then using the same procedures as in the case of calix[4] arene 21 (Scheme I-8), gave 1,3-differentiated calixarene 40 in $55 \%$ yield ${ }^{19}$.

In this part, some selective methodologies were introduced for functionalization of calix[4]arene, which have been used for preparation of useful synthetic building blocks. Undoubtedly, there are a large amount of strategies developed to perform the modification of calix[4]arene efficiently. However, there are few strategies for the polydifferentiation of calixarenes, especially calix[6]arene or higher homologues. This problem is ubiquitous in the field of functionalization of such cyclic concave molecules.

## 3. Cucurbiturils

Cucurbiturils (CBs) are a family of synthetic compounds obtained from the acid-induced condensation reaction with urea, glyoxal and formaldehyde. In 1905, they were firstly reported by Behrend and co-workers ${ }^{26}$, and until 1981, the chemical nature and structure were elucidated by Mock and Freeman et al. ${ }^{27}$ It turned out to be a cyclic oligomer of glycoluril units linked by methylene bridges. In the early 2000s, different size of cucurbit[n]urils ( $\mathrm{CB}[n], \mathrm{n}=5,6,7,8,10$ ) homologues have been synthesized and isolated ${ }^{28}$ (Figure I-7). Cucurbit[n]urils have the pumpkin-like shape with two identical hydrophilic carbonyl-laced portals and a hydrophobic cavity, which can form stable host-guest complexes with organic or inorganic cations, and neutral organic guests in aqueous media. ${ }^{29}$

Although the scope of the CB chemistry have been amplified by the discovery of new CB homologues, their applications were still restricted mainly because of the poor solubility in organic solvents, and difficulty for the introduction of functional groups on their surfaces, which is in contrast to other host families including calixarenes and cyclodextrins. Particularly, introduction of reactive functional groups at the periphery was a long-standing problem. In principle, there are two main strategies to introduce functional groups (Scheme

[^10]I-15): 1) Funtionalization by cucurbituril-forming reaction ${ }^{30}$ (Route 1), condensation of glycouril derivatives with various aldehydes, would give $\mathrm{CB}[n]$ derivatives bearing the substituents on the "equator" positions or at the methylene bridges of $\mathrm{CB}[n]$. A lot of derivatives have been synthesized using this strategy. However, our interests focus on the post-functionalization of the macrocyclic molecules, thus we will discuss the second strategy. 2) Direct functionalization of the "equator" positions gives the corresponding $\mathrm{CB}[n]$ derivatives (Route 2).

## Direct functionalization on the "equator" positions

Direct introduction of functionalities on the surface of $\mathrm{CB}[n]$ was thought to be impossible for a long time. The first direct functionalization method was uncovered by Kim group, giving hydroxyl derivatives of $\mathrm{CB}[n]$. By treatment of excess $\mathrm{CB}[n](n=5-8)$ with $\mathrm{K}_{2} \mathrm{~S}_{2} \mathrm{O}_{8}$ in water at $85^{\circ} \mathrm{C}$, it was followed by crystallization to give perhydroxylated $\mathrm{CB}[n]$ as potassium complexes (Scheme I-16). ${ }^{31}$ While a typical yield of the reaction is $40-45 \%$ for CB[5] and CB[6], the higher homologues give a lower yield, presumably due to the instability of the perhydroxylated products. The obtained perhydroxylated derivatives can undergo further modification, such as acylation or alkylation, which were used in a range of supramolecular systems. ${ }^{32}$

[^11]After optimization of reaction conditions, Scherman et.al. showed a method to prepare monohydroxylated $\mathrm{CB}[6]$ directly from the parent $\mathrm{CB}[6]$ in aqueous solution by virtue of host-guest interactions to control the oxidation mechanism and product ratio. ${ }^{33}$ During this process, a tailor-made bisimidazolium guest was used to form a host-guest complex, which was able to enhance the solubility of the parent $\mathrm{CB}[6]$ prior to controlled oxidation, thus influenced the product ratios. Thereafter the obtained pure monohydroxylated product underwent the alkylations, notably the propargylation yielding an alkyne, which could be submitted to click reactions.

Much progress has been made for the functionalization of cucurbit[ $n$ ]urils and give a myriad of CB derivatives nowadays, particularly by cucurbituril-forming reactions. However, the direct functionalization has not yet been sufficiently explored, and development of efficient methods for such functionalization would be highly desired because it would have an important impact on the host-guest chemistry.

## 4. Pillararenes

Pillararenes ${ }^{34}$ (Figure I-8), a recent class of macrocyclic hosts discovered by Ogoshi and co-workers ${ }^{35}$ in 2008, are increasingly important in host-guest chemistry. Pillar[ $n$ ]arenes are made up of $n$ identical hydroquinone units held together on para-positions by methylene bridges through a Lewis acid-catalyzed Fridel-Craft cyclization (Scheme I-17). Compared with calix[ $n$ ]arenes with a basket-shaped structure, Pillar[n]arenes have a unique rigid pillar architecture, but a similar $\pi$-electron-rich cavity which can interact strongly with electron-poor species.

Like other concave cycles, in order to meet the requirement of various applications in different areas, functionalization of pillar[ $n$ ]arenes with synthetic handles was necessary. In this section, functionalization of pillar[n]arenes will be presented according to the substitution patterns (Figure I-9), namely monofunctionalization, difunctionalization, rim-differentiation, perfunctionalization and phenylene substitution.

### 4.1 Monofunctionalization of pillararenes

Monofunctionalization means that only one reactive position is substituted, which allows for the addition of novel features without altering significantly essential ability. Apart from direct co-cyclization method ${ }^{36}$, the commonly used strategy is deprotection of one alkyl group from fully protected pillar[ $n$ ]arenes.
The synthetic strategy employed to produce monofunctionalized pillar[5]arene 47 was introduced by Ogoshi group. ${ }^{37}$ Using less less than one equivalent of $\mathrm{BBr}_{3}$ at roome temperature gave mono-demethylated pillar[5]arene, albeit with a lower yield ( $22 \%$ ). Cao and coworkers ${ }^{38}$ optimized the reaction conditions to give pillar[5]arenol 47 in $60 \%$ yield (Scheme I-18)

Subsequently, the unmasked hydroxyl group of 47 was used to introduce further functionalities using a Williamson ether-type synthesis. A single alkylammonium tether ${ }^{37}$ was appended onto pillar[5]arene 47 to form product 48, allowing it to undergo self-complexation (Scheme I-19). A dimer 49 of pillar[5]arene ${ }^{39}$ was also connected through a para-xylenyl linker by the similar method. Cao and co-workers ${ }^{38}$ have synthesized monophosphoryl pillar[5]arene from pillar[5]arenol 47, which can act as a hydrogen-bond

[^14]acceptor for aliphatic alcohols.

### 4.2 Difunctionalization of pillararenes

Introduction of two functional groups onto pillar[ $n$ ]arenes, is more complicated than the monofunctionalization, because of more constitutional isomeric patterns (Figure I-10) ${ }^{40}$. Among these patterns, A1/A2 pattern with new functional groups at both ends of one hydroquinone unit is straightforward to obtained, while the regioselective formation of other constitutional isomers is still an unsolved challenge.

In separate reports, Huang ${ }^{41}$ and Ogoshi ${ }^{42}$ have prepared pillar[5]arene 50 with one benzoquinone unit by the partial oxidation of $\mathbf{4 6}$, which was then reduced to

[^15]A1/A2-pillar[5]arenediol 51 in 95\% yield (Scheme I-20, top). Alternatively, Stoddart ${ }^{43}$ introduced another synthetic route (Scheme I-20, bottom) to form 51, involving the formation of pillar[5]arene 52 , which subsequently underwent elimination reaction and a deprotection.

Pillar[5]arenediol 51 with two hydroxyl groups on the same unit can be transformed into the ditriflate 54 (Scheme I-21), which underwent Suzuki coupling reaction and ester hydrolysis to give pillar[5]arene-containing organic strut 55 in $59 \%$ yield ${ }^{43}$.

### 4.3 Rim-differentiation of pillararenes

Pillar[ $n$ ]arenes have two identical rims (upper rim and lower rim), that is entirely different to cyclodextrins or calix[ $n$ ]arenes. Rim-differentiation of pillar[n]arenes means that the substituents on the upper rim are different from those on the lower rim. Huang and co-workers ${ }^{44}$ demonstrated that four regioisomers (Figure I-11) are formed when 1-butoxy-4-methoxybenzene is used as the aromatic repeating unit of pillar[5]arene.

Because of identical properties of the two rims, to date, it is still impossible to differentiate the two rims of pillar[n]arenes by post-fucntionalization of parent pillar[n]arenes. Rim-differentiation of pillar[n]arenes are mainly fulfilled through cyclization reaction of unsymmetrical hydroquinone derivatives. Albeit in low yield, many research groups have developed them for specific applications. Rim-differentiated pillar[5]arene derivatives have been employed to design the amphiphiles with hydrophilic groups and hydrophobic groups on the two rims. A sugar-functionalized amphiphilic pillar[5]arene 56 (Figure I-12) was synthesized and used for the bacterial cell agglutination ${ }^{45}$. Other amphiphilic pillar[5]arene 57, 58 and 59 (Figure I-12) have also been employed to create micelles ${ }^{46}$, nanotubes ${ }^{47}$ and vesicles ${ }^{48}$, respectively.

### 4.4 Perfuncnctionalization of pillararenes

Pillar[n]arenes have two identical rims, which bear $2 n$ hydroxyl groups. Perfunctionalization of these macrocycles means introduction of identical functional groups to all the hydroxyls. Ogoshi and co-workers ${ }^{49}$ demonstrated the preparation of perfunctionalization of pillar[5]arene $\mathbf{6 0}$ (Scheme I-22) by direct full triflation of perhydroxylated pillar[5]arene. Pillar[5]arene $\mathbf{6 0}$ can undergo Sonogoshira Pd-catalyzed cross coupling reaction to afford a highly conjugated pillar[5]arene $\mathbf{6 1}$ which results in the efficient through-space $\pi$-delocalization. They also prepared a "clickable" pillar[5]arene 62, bearing 10 terminal alkynes using Williamson-type ether reaction ${ }^{50}$ (Scheme I-22). Peralkylated pillar[5]arene $\mathbf{6 2}$ is a key staring material, which can be submitted to Copper-catalyzed Azide Alkyne Cycloaddtion (CuAAC) reaction, affording different perfunctionalized hosts.

### 4.5 Phenylene-substituted pillararenes

The functionalization of pillar[ $n$ ]arenes is mostly achieved on the hydroxyl groups. Certainly, it can also be expanded to the aromatic positions, which are ortho to both the methylene bridges and oxygen substituents. This mode of functionalization can be used to substitute the parent pillar[ $n$ ]arenes.
Stoddart and co-workers ${ }^{51}$ have reported an example of phenylene-substituted pillar[5]arene $\mathbf{6 6}$ (Scheme I-23) by direct bromination of A1/A2-pillar[5]arenediol 51. The formed pillar[5]arene $\mathbf{6 6}$ can be used as a precursor to perform further functionalization.

As above mentioned, numerous methods have been developed for the functionalization of pillar[n]arenes, but there are still some challenge in this field, such as substitution at the methylene bridges, the selective synthesis of unsymmetrical difunctionalized pillar[ $n$ ]arenes, and rim-differentiated pillar[ $n$ ]arenes. The development of simple, efficient functionalization methodologies will expand the applications of this molecule.

## 5. Conclusion

In this chapter, we described the post-functionalization of $C_{\mathrm{n}}$-symmetric concave cyclic molecules: calixarenes, cucurbitutils and pillararenes. A lot of achievements have been obtained for calix[4]arene on both the upper and lower rims. However, the efficient methodologies for polyfunctionalization of calix[6]arene or higher homologues are still needed to be explored. Although using cucurbituril-forming reactions numerous cucurbituril derivatives are prepared, the direct functionalization on parent cycle (post-functionalization) is reported rarely. For burgeoning pillararenes, numerous methods have been developed, but there are still some challenges, such as substitution on methylene bridges, rim-differentiation.
Owing to these methodologies, many functionalized derivatives have been applied in a wide diversity of areas. It is clear that functionalization of such molecules is of crucial importance to their applications. Therefore, the development of simple and efficient functionalization methods are still desired.

## CHAPTER II

## REGIOSELECTIVE FUNCTIONALIZATION OF CONCAVE CYCLES, THE CASE OF CYCLODEXTRINS

## 1. Definition and properties

Cyclodextrins (CDs) are a series of cyclic oligomers composed of $\alpha-1,4$ linked D-(+)-glucopyranose units with a ${ }^{4} C_{1}$ chair conformation. They were isolated firstly from starch by Villiers in 1891, 52,53 but the structure was not elucidated until 1936 by Freudenberg ${ }^{54}$.
Today, cyclodextrins are industrial products, obtained from starch by means of enzymatic degradation with an enzyme called Cyclodextrin Glycosyl Transferase (CGTase) ${ }^{55}$. They are separated by selective precipitation with yields ranging from 40 to $60 \%$. The most common cyclodextrins are $\alpha$-cyclodextrin, $\beta$-cyclodextrin, and $\gamma$-cyclodextrin, bearing 6,7 , and 8 glucose units, respectively (Figure II-1).


Figure II-1. Structure of cyclodextrins

Cyclodextrins are formed with glucopyranoside units in a ring that assumes a special tridimensional shape, resembling a truncated funnel with a $C_{n}$ symmetry ( $n$ here is the number of glucose units) ${ }^{56}$. Cyclodextrin possesses a hydrophobic cavity and an external hydrophilic shell. The cavity has two rims (Figure II-2) formed by the primary alcohols (OH-6, primary rim) and secondary alcohols (OH-2, 3, secondary rim). The hydroxyls on position 2 are directed towards the interior of the cavity and those on position 3 are oriented towards the exterior.

[^19]With a lot of hydroxyls and a truncated funnel-shaped cavity, cyclodextrins are endowed with remarkable complexation capability (Figure II-3) to accommodate apolar molecular guests in aqueous solution, mainly through hydrophobic interaction, and/or other interactions ${ }^{57}$.

The size of guest molecules matching the dimensions of cavity, increases with the diameter of cyclodextrin because of the constant height ( 0.78 nm ) of torus. The parameters of cyclodextrins depend on the number of glucose units as shown in Table II-157.

Native cyclodextrins have relatively rigid structures. Although the primary hydroxyls can rotate somewhat freely, the secondary hydroxyls fix the structure of CDs by intramolecular hydrogen bonding (Figure II-4) between $\mathrm{OH}-2 \mathrm{~s}$ and $\mathrm{OH}-3 \mathrm{~s}$ of two adjacent glucose units. Because of this, the solubility of cyclodextrins in water varies from $231 \mathrm{~g} / \mathrm{L}$ in $\gamma$-CD to $18.5 \mathrm{~g} / \mathrm{L}$ in $\beta-\mathrm{CD}^{58}$. The intramolecular hydrogen bonds are favored in $\beta$-CD, which explains its poor solubility in water. For $\gamma$-CD, hydrogen bonds are less favored, due to its bigger size.

## 2. Nomenclature and reactivity of cyclodextrins

### 2.1 Nomenclature of cyclodextrins

Although according to IUPAC rules, roman numerals (I, II, III...) are utilized for the numeration of cyclodextrins, the predominant nomenclature used in the literature is the numbering of the glucopyranose units by majuscule letters (A, B, C...) ${ }^{59}$. Each glucose unit is attributed a capital letter following the direction of the $\alpha-1,4$ linked glycosidic bond (Figure II-5). If more than one glucose unit is modified, numbering should follow the shortest way.

### 2.2 Reactivity of cyclodextrins

Cyclodextrins bear abundant hydroxyls, which makes selective chemical modifications rather difficult, moreover, the hydrophobic cavity often has a tendency to form inclusion complexes with reagents, which also influences the reactivity ${ }^{60}$.
The hydroxyls on the primary rim ( $\mathrm{OH}-6$ ) are the less hindered, the most basic and often the most nucleophilic ones, which enables them to react with steric hindered electrophiles under less basic conditions (Figure II-6).
The secondary hydroxyl groups on position $2(\mathrm{OH}-2)$ are the most acidic ( $\mathrm{pKa}=12.2)^{61}$ because of the proximity to the anomeric carbon. So these hydroxyls can be deprotonated selectively under basic conditions. Finally, $\mathrm{OH}-3 \mathrm{~s}$ are the least reactive, they could be modified only after the pre-protection of the positions 2 and 6 .

In spite of the differences in reactivity that exist among these hydroxyls, more reactive reagents will react with a poor selectivity.

## 3. Functionalization of the primary rim of cyclodextrins

The intrinsic structure of cyclodextrins, makes them suitable and fascinating hosts. This distinctive feature appealed to many scientists. Owing to this property, cyclodextrins have been seen as versatile molecules, applied in a broad range of fields, such as in drug-delivery system ${ }^{62}$, artificial enzymes ${ }^{63}$, and supramolecular chemistry ${ }^{64}$. However, this rigid structure restricts their applications to some degree. So given this, introduction of some other functions to alter their properties and amplify their scope is of great interest.

### 3.1 Selective functionalization

### 3.1.1 Chemoselective functionalization

Cyclodextrins bear three types of hydroxyls (position 2, 3 and 6) with different reactivities. In light of the nucleophilicity of the primary hydroxyl groups, they are functionalized more selectively than their secondary counterparts.
The persubstitution of the position 6 hydroxyls can be carried out under weak basic conditions. Using pyridine as the solvent and weak base, the primary hydroxyl groups of native $\alpha$-cyclodextrin $\mathbf{6 7}$ were tosylated, albeit with a poor yield $(\sim 12 \%)^{65}$. Here the steric crowding might account for the unsatisfying yield (Scheme II-1).

Reagent tert-butyldimethylsilyl chloride ( TBSCl ) is chosen commonly for the preparation of silyl ethers on the primary rim of cyclodextrins. After treating native cyclodextrins in pyridine at room temperature, 6 -substituted derivatives 70 and 71 were obtained with excellent yields, $75 \%$ for $\alpha$-cyclodextrin and $83 \%$ for $\beta$-cyclodextrin (Scheme II-2). ${ }^{66}$

In the course of tosylation or silylation on the primary rim of cyclodextrins, the mono-substituted products could be reached by reducing the number of equivalents of reagents or minimizing the reaction time ${ }^{67}$, although compromising with low yields and extensive purification (Path A, Scheme II-3). The yields of the final products are often reduced because the tosylate can undergo an exchange by chloride ion or an elimination process to give either 3, 6 -anhydro compounds or alkene ${ }^{68}$.
The most popular method for monofunctionalization on the position-6 of cyclodextrins is a nucleophilic attack to replace the mono-6-sulfonyl group in the cyclodextrins. So with the mono-tosylated cyclodextrins in hand, a number of corresponding derivatives can be synthesized. For example, using sodium azide in DMF at a higher temperature, the azido-derivatives were prepared with outstanding yields of around $95 \%$ (Path B, Scheme II-3) ${ }^{69}$.
The monoazido-cyclodextrins could also be synthesized directly from native cyclodextrins (Path C, Scheme II-3) by using triphenylphosphine, tetrabromide and sodium azide and in

[^23]DMF ${ }^{70}$, albeit with a lower yield.

The monooxidation of cyclodextrins is another highly efficient method for monofunctionalization. By means of direct Dess-Martin oxidation, native cyclodextrins were transformed into monoaldehyde products with yields of $85 \%$ to $99 \%$ (Path D, Scheme II-3) ${ }^{71}$. It is also possible to access the monoaldehylde cyclodextrins by the oxidation of monotosylated cyclodextrins, utilizing dimethyl sulfoxide in the presence of a non nucleophilic base (such as collidine or diisopropylethylamine) (Path B, Scheme II-3) ${ }^{72}$.
In addition to pertosylation and silylation, another frequently used method to functionalize the primary rim of cyclodextrins is perhalogenation (Scheme II-4). Native cyclodextrins were converted into per-bromo/iodo-cyclodextrins 72, 73 and 74 with good yields. These reactions were carried out in the presence of triphenylphosphine and bromine or iodine in DMF under heating ${ }^{73}$. The substitution on the secondary rim was avoided by the utilization of crowded reagents. 6-halogenated cyclodextrins are a class of important precursors, because appropriate nucleophiles can attack the electrophilic carbon atoms on position 6 to produce the corresponding functionalities.

[^24]Methylation of the primary rim of cyclodextrins posed a problem to the chemists. Due to the difference in acidity, the per-6-methylation of cyclodextrins cannot be obtained without touching the secondary alcohols by a direct strategy (using sodium hydride and methyl iodide for methylation). Given this, Takeo ${ }^{74}$ proposed indirect protection-deprotection strategy. From persilylated cyclodextrins 70 and 71, through a sequence of protection-deprotection reactions, the methylated primary rim of cyclodextrins $\mathbf{7 5}$ and $\mathbf{7 6}$ were synthesized with moderate yields (Scheme II-5).

The perazidation of the primary rim of cyclodextrin can also be fulfilled through a three steps strategy from native cyclodextrin 67 (Scheme II-6) ${ }^{75}$. After the bromination of the primary rim, a nucleophilic substitution by lithium azide in situ to give azidated cyclodextrin which could be isolated after acetylation (77, Scheme II-6). Then cyclodextrin 78 was generated after removal of the acetates through saponification. The acetylation here was implemented to facilitate the separation of the product.

### 3.1.2 Capping reagents

A large amount of capping reagents have been employed to difunctionalize both rims of cyclodextrins. The rigid structure of $\beta$-cyclodextrin offers a precise distance between different hydroxyls, enabling the design of reagents that react regioselectively. Nonetheless, a few capping reagents also have good results on $\alpha$ - and $\gamma$-cyclodextrins.

## a. Symmetrical caps

Various disulfonyl chloride reagents have been applied to the difunctionalization of cyclodextrins. Initially, meta-benzenedisulfonyl dichloride was reacted with $\beta$-cyclodextrin to give an instable 6A, 6B-capped $\beta$-cyclodextrin in $40 \%$ yield ${ }^{76}$. Fujta ${ }^{77}$ optimized the reagent by introduction of stabilizing methyl group on the phenyl ring, yielding a stable difunctionalized cyclodextrin 79 on positions 6 A and 6 B in $19 \%$ yield (Scheme II-7). It was followed by a regioselective displacement with imidazole, which preferentially took place on position 6 A , giving cyclodextrin 80 in $42 \%$ yield. The steric hindrance created by methyl group between the sulfonyls explains the observed regioselectivity.

Another useful capping reagent is $4,4^{\prime}$-methylenebis(benzene-1-sulfonyl chloride) ${ }^{78}$. Tabushi firstly showed its versatility and applications for the introduction of different chemical groups ${ }^{79}$. The hydroxyls were activated by the sulfonyl esters which enabled the grafting of new groups such as thiol or amine through nucleophilic attack ${ }^{80}$ (Scheme II-8).

Given the practicability of this kind of method, many capping reagents have been put into use with moderate regioselectivity (Table II-2). ${ }^{81}$ According to Table II-2, reagents 85 and 86 showed less regioselectivity because of their flexibilities (Entry 1 and 2). ${ }^{78,79,82}$ To solve this problem, other capping reagents with more rigid structures were designed (Entry 3-6). The distance between the two reactive centers were controlled subtly. In virtue of this, the capping reactions favored the substitution of AC (Entry 3 and 4) ${ }^{81,83}$ or AD (Entry 5 and 6). ${ }^{82,83}$

Besides the abovementioned capping reagents, bulky reagent 91 was another alternative, which gave the AB-difunctionalized $\beta$-cyclodextrin 93 selectively in $35 \%$ yield ${ }^{84}$ (Path A, Scheme II-9).
In regard to $\alpha$-cyclodextrin, the capping reaction was less studied, nevertheless, some interesting results have been obtained for the selective difunctionalization of the primary rim. Using the same capping reagent 91, AB-difuntionalized $\alpha$-cyclodextrin 92 was also generated (Path A, Scheme II-9). The AC-difunctionalized derivative 95 was achieved using a dibenzofuran derivative 94 in $18 \%$ yield ${ }^{85}$ (Path B, Scheme II-9).

Another example was the use of a synthesized capping reagent 96 (Bis-trityl) to selectively AB-difunctionalize $\alpha$-cyclodextrin 67. This process was carried out in DMF using DMAP/1,8-bis(dimethylamino)naphtalene (as proton sponge) with an equal amount of cyclodextrin and dichloride, after methylation of the remainnig hydroxyls, the AB-difunctionalized $\alpha$-cyclodextrin 97 was obtained in $55 \%$ yield (Scheme II-10) ${ }^{84}$. This reaction was also suitable for $\beta$-cyclodextrin to give AB-difunctionalized cyclodextrin 98 in $35 \%$ yield.

The above mentioned examples all used a single capping reagent. Actually, a second capping reagent can also be attached to cyclodextrin to form tetrafunctionalized derivative. Without doubt, it is more difficult than the first capping reaction because of the increasing steric
crowding. Nevertheless, it is more selective. Matt and Armspach have shown that, reacting $\beta$-cyclodextrin with 2 eq. of capping reagent 91, a tetrafunctionalized cyclodextrin derivative was prepared. After permethylation of all remaining hydroxyls and purification, cyclodextrin 99 was obtained with installation of two capping groups on position $6 \mathrm{~A}, 6 \mathrm{~B}$ and $6 \mathrm{D}, 6 \mathrm{E}$ in $50 \%$ yield (Scheme II-11) ${ }^{86}$. Using reagent 87 (showed in Table II-2), another 6A, 6C, 6D, $6 \mathrm{~F}-\beta$-cyclodextrin was achieved with two capping groups grafted on the primary rim in $35 \%$ yield ${ }^{87}$. The same strategy was applied on $\alpha$-cyclodextrin as well, but unfortunately, with no success, that might be due to its smaller size, too small to accommodate two such crowded groups.

## b. Unsymmetrical caps

Employing a symmetrical capping reagent in a single step leads to a differentiated pattern (ether single capping or double capping). However, tridifferentiated cyclodextrins might be achieved using unsymmetrical reagents. This kind of reagents have been reported with a visual name: "Flamingo cap". Tabushi and co-workers have proposed the first unsymmetrical capping reagent 100, $N$-benzyl- $N$-methylanilin- $p, p$ 'disulfonyl chloride. A mixture of AC, AD, AE, AF- $\beta$-cyclodextrins were prepared by treatment of reagent $\mathbf{1 0 0}$ with $\beta$-cyclodextrin in dry pyridine, then $m$ CPBA oxidation gave $N$-oxide derivatives $101-\mathrm{M}$ in $17 \%$ overall yield (Scheme II-12) ${ }^{88}$. Subsequent selective nucleophilic sodium azide attack on the more electrophilic position, i.e. the para position of $N$-oxide, followed by another nucleophilic displacement by thiophenol gave tridifferentiated derivatives 103-M.

Poor selectivity is still a troublesome problem during the capping reactions, so the capping reactions should be carefully controlled on both distance and direction. Fujita introduced a two-steps strategy to meet this demand on $\beta$-cyclodextrin. Monotosylated $\beta$-cyclodextrin $\mathbf{1 0 4}$ was treated with either L-cysteine or D-cysteine, which reacted through its thiol group to give monofunctionalized cyclodextrins. Then by treatment of the amino groups with dansyl chloride, the obtained acids 105a and 105b underwent esterification to give isomers 106a and $\mathbf{1 0 6 b}$ selectively with yields of about $80 \%{ }^{89}$ (Scheme II-13).

Bols and co-workers ${ }^{90}$ proposed another method for differentiation of positions 6 A and 6 D that could be realized through regioselective opening of a symmetrical sulfonate bridge. The reaction was implemented on $\alpha$ - and $\beta$-cyclodextrins, which bear two hydroxyl groups on the positions 6 A and 6 D with the remaining positions being protected by benzyl ethers. By treatment with thionyl chloride, the two free hydroxyls reacted to form a sulfite bridge, which underwent the oxidation to give cyclodextrins 108a and 108b carrying a sulfate bridge. Then opening of bridge was executed on one side by a sodium azide nucleophilic attack, it is followed by the sulfate removal under acidic conditions, giving tridifferentiated $\alpha$ - and $\beta$-cyclodextrins 109a and 109b in about 90\% yields (Scheme II-14).

[^31]For $\alpha$-cyclodextrin 108a, both positions 6A and 6D are equivalent, and the cyclic sulfate opened on one or the other side leads to the unique regioisomer 109a with the azide ncleophilic attack on position 6D. As regards to $\beta$-cyclodextrin 108b, the two positions 6A and 6D are unequivalent due to $C_{7}$ symmetry. So opening of cyclic sulfate in 108b gave two regioisomers in $87 \%$ yield. Some other nucleophiles such as ammonia, piperidine or sodium allylate, have been used displaying the same regioselectivity, even though lower yields are obtained.

### 3.1.3 Sterically crowded reagents

Using sterically hindered reagents, occasionally could yield unpredictable results in the multifunctionalization on the primary rim of cyclodextrins. So far, two kinds of sterically crowded reagents were exploited to functionalize cyclodextrins directly. One of them is trityl and their derivatives, and another is triphenylphosphine.
Native cyclodextrin 67 can be modified to multifunctionalized derivatives using trityl chloride in pyridine at $55^{\circ} \mathrm{C}$. This method afforded 6A, 6C, 6E-cyclodextrin 110 selectively in $23 \%$ yield ${ }^{91}$. Through a longer reaction time ( 36 h ) and higher temperature $\left(70^{\circ} \mathrm{C}\right.$ ), a mixture of trifunctionalized cyclodextrins were obtained. Methylation of the remaining hydroxyls, flash chromatography then gave ACE-isomer 110 (23\%), ABC-isomer 111 (21\%), and a mixture ( $22 \%$ ) of ABD- and ABE-isomers (Path A, Scheme II-15) ${ }^{92}$. When more trityl chloride ( 4.5 eq.) was added and stirred for 72 h , three possible tetrasubstituted products ABDE ( $25 \%$ ), ABCD ( $15 \%$ ) and ABCE (32\%) were generated (Path B, Scheme II-15).

[^32]Because of the large physical dimension of the trityl group, per-6-O-tritylation on the primary rim of cyclodextrins seems to be difficult. Ling and co-workers ${ }^{93}$ reached this kind of products under harsh conditions. Native cyclodextrins were firstly reacted with 6 equivalents of trityl chloride at $80^{\circ} \mathrm{C}$ for 24 h , and during the subsequent 5 days, an additional 1 eq . of the reagent was added each day, i.e. total 11 eq. of trityl chloride. After purification, per-6-O-tritylated $\alpha$-, $\beta$ - and $\gamma$-cyclodextrins 116, 117 and 118 were afforded in $62 \%, 55 \%$ and $35 \%$ yields, respectively (Scheme II-16).

Normally the tri- or tetrafunctionalized cyclodextrins were formed when trityl groups were exploited. For the sake of difunctionalization of the primary rim of cyclodextrin, another bulkier group remains desirable. Gratifyingly, Matt and Armspach showed that tris-(4-tert-butylphenyl)methyl (super-trityl) proved to be successful in the synthesis of new patterns of functionalization ${ }^{94}$. Super-trityl (3 eq.) was employed to react with $\alpha$-cyclodextrin 67 in DMF to give different difunctionalized regioisomers. After permethylation, purification by chromatography gave AD-isomer 119 (30\%), AC-isomer 120 (27\%), AB-isomer 121 (8\%), as well as small amounts of trisubstituted ( $8 \%$ ) and monosubstituted ( $12 \%$ ) species (Scheme II-17). Through the enhancement of the temperature and of the amount of the reagent, the tetrafunctionalized pattern 123 was also reached in $46 \%$ yield ${ }^{95}$.

Triphenylphosphine mediated Mitsunobu reaction has been applied in the perhalogenation of the primary rim of cyclodextrins (Scheme II-4). To be selective, optimizing the reaction conditions leaded to a trifunctionalized cyclodextrin on positions 6A, 6C, 6E (Scheme II-18) ${ }^{96}$. Native cyclodextrin was treated with triphenylphosphine and N -bromosuccinimide in DMF, giving ACE-tribromo-cyclodextrin. It was followed by one-pot azidation and permethylation, the final product 124 was obtained after extraction of the solid residue by ether and a simple crystallization in acetonitrile.

### 3.2 DIBAL-H-mediated selective functionalization

As we have mentioned before, much more progress has been made in recent years for the functionalization of the primary rim of cyclodextrins. Those methods are mainly based on the reactivity of hydroxyls, capping reagents or the steric crowding reagents. Nevertheless, time-consuming chromatographical isolation is needed with relatively poor yield and regioselectivity. To overcome these limitations, a method of higher efficiency remains greatly desirable. One possibility is to work on protected cyclodextrins, which, on the one hand, could be modified selectively and on the other hand could be removed readily. The regioselective

[^34]de- $O$-benzylation of polybenzylated sugars by aluminum reagents meet these criterions. Using this method, polydifferentiated cyclodextrins have been already accessed. In the following of this chapter, a detailed introduction on this method and its applications for polydifferentiations of cyclodextrins will be presented.

### 3.2.1 The discovery and mechanistic study of the selective debenzylation method

Aluminum reagents are not conventional reagents for de- $O$-benzylation reactions. However, it was found serendipitously in our laboratory during the course of tributylaluminum (TIBAL)-mediated rearrangement, which induced the conversion of sugars into carbasugars by means of [1,3]-oxygen-to-carbon rearrangement ${ }^{97}$ (Scheme II-19). After treating disaccharide 125 with TIBAL, in addition to the rearrangement product 126, another product 127 (debenzylated product) was also generated ${ }^{98}$.

This finding became a useful method for sugar chemistry. After optimization, diisobutylaluminum hydride (DIBAL-H) was chosen to react with perbenzylated $\alpha$ - and $\beta$-cyclodextrins 128 and 129, generating the corresponding diols 99,100 107a and 107b regioselectively with excellent yields of about $80 \%$ (Scheme II-20). Interestingly, it is also possible to obtain monol-cyclodextrin 130 and 131 with good yields by controlling carefully the reaction conditions, either by using dilute conditions or by reducing reaction time ${ }^{100}$. The monol can also be converted into diol under the action of DIBAL-H, indicating that the reaction proceeded in a stepwise manner. It is reported that these reactions can be accelerated under the help of micro-wave with less equivalent of DIBAL-H and short reaction time. ${ }^{101}$

Since a number of encouraging results have been obtained, the following work was to clarify the mechanism of this reaction. Hence, different substrates were submitted to the action of DIBAL-H, among which, an alkyl ether 132 did not give the corresponding debenzylated product even after 4 days. In sharp contrast, benzyl group was removed favorably from a furan ether 133 with an excellent yield in 4 h (Scheme II-21). In view of these preliminary results, it was assumed that, a second oxygen on the molecular fragment is important to chelate the aluminum atom.



Scheme II-21: Deprotection of alkyl ether by DIBAL-H

Another two examples were studied to give an insight into the mechanism. In the case of carbohydrate derivative, substrate 135 afforded debenzylated product $136 \mathbf{a}$ and 136 b under the action of DIBAL-H. This result was explained by the chelation of aluminum species between the position 6 oxygen and the endocyclic oxygen, or the chelation between position 2 oxygen and the anomeric oxygen (Scheme II-22).

In the case of sugar 137, a compound missing anomeric oxygen, the only site available for aluminum chelation resides between endocyclic oxygen and oxygen on position 6, consequently, only product 138 is obtained selectively (Scheme II-23).


Scheme II-23: DIBAL-H deprotection on 1-deoxy sugar

On account of the above systematic study, it was concluded that the two oxygens chelating the aluminum derivative were necessary. Here a reasonable mechanism was proposed considering the case of 1-deoxy sugar 137 (Scheme II-24).


Scheme II-24: Mechanism of DIBAL-H induced debenzylation on sugar

During the course of the debenzylation reaction, it was propose that at least two molecules of DIBAL-H were involved. The first aluminum reagent was chelated between the two oxygens of sugar 137 to give the cyclic complex 137-Ia. Then complex 137-Ib was formed by a second aluminum coordination to the less hindered oxygen (oxygen on the position 6). The two aluminum derivatives, one as Lewis acid, which activated the C-O bond of the benzyl ether, and the other played a role in the hydride transfer for the dealkylation to give the complex 137-Ic. The following hydrolysis afforded the selective mono-debenzylated product 138.

In the case of perbenzylated $\alpha$-cyclodextrin 128, DIBAL-H-mediated debenzylation only
happened on the primary rim because of the surrounding congestion on the secondary rim. The mechanism is the same as the one proposed for the monosaccharide (Scheme II-24). Once the first debenzylation took place on sugar unit $\mathbf{A}$, the following second debenzylation occurred on sugar D, diametrically opposed position to sugar A. This regioselective debenzylation is rationalized by the steric crowding created by the formed aluminum complexes 128-Ia (Scheme II-25).

## DIBAL-H applied to persilylated primary rim of cyclodextrins

Recently, Ling and co-workers carried out a series of research concerning persilylated primary rim of cyclodextrins. As demonstrated in the case of perbenzylated cyclodextrins, when cyclodextrins bearing tert-butyldimethylsilyl ether on the primary rim, were submitted to the action of DIBAL-H, de- $O$-silylation proceeded selectively to give the 6A, 6D-dihydroxyl cyclodxtrins (Scheme II-26, Table II-3) ${ }^{102}$. Due to the big size and flexibility of $\gamma$-cyclodextrin, a mixture of inseparable regioisomers were yielded.

## Acid-mediated regioselective desilylation of cyclodextrins

Besides the de-O-silylation mediated by the action of DIBAL-H, very recently Ling and co-workers proposed another new method of acid-mediated regioselective de- $O$-silylation for multifunctionalization of cyclodextrins ${ }^{103}$. Based on the acid-sensitivity of the $O$-silyl group, HCl solution with various pH values ( $\mathrm{pH} 2-3$ ) were used to operate selective removal of silyl groups from cyclodextrins, not only on the primary rim, but also on the secondary rim, giving tri- and tetrafunctionalized cyclodextrins in a short reaction sequence (Table II-4, Scheme II-27). Most importantly, the developed method has been found applicable to all $\alpha-, \beta$ - and $\gamma$-cyclodextrins on multigram scales.

### 3.2.2 DIBAL-H-mediated debenzylation method applied on cyclodextrins to access polydifferentiated cyclodextrins

Since the debenzylation method by DIBAL-H on cyclodextrins was developed, a large number of differentiated cyclodextrin motifs have been obtained. Some of them have been used in varied fields, such as organic catalysis, supramolecular chemistry and artificial enzymes. To sum up all the obtained results, four principal site-directing rules were disclosed by our group:
a. Tandem azide-reduction/debenzylation (Scheme II-28), that means an azido group, existed on the primary rim of cyclodextrin directs the diametrically opposed debenzylation reaction selectively to give the amino-alcohol cyclodextrin motif ${ }^{104}$.


Scheme II-28: Tandem azide-reduction/debenzylation of monoazido-cyclodextrin
b. Steric decompression effect (Scheme II-29), that facilitates the debenzylation reaction only on the clockwise adjacent position (viewed from the primary rim), when less crowded groups (vinyl or methyl) which are inert to the action of DIBAL-H, are grafted onto the primary rim of cyclodextrins ${ }^{105}$.



Scheme II-29: steric decompression effect
c. "Frustration strategy" (Scheme II-30) is a method which combines strategies a and b, giving tetradifferentiated cyclodextrins in a short reaction sequence. By substituting benzyl group on the diametrically opposed position with a deoxy or a vinyl function, the directing effect of a hydroxyl or an azido group was depressed to give rise to a double-debenzylation on

[^38]both the sterically decompressed sides ${ }^{106}$.


Scheme II-30: "Frustration" strategy induced double-deprotection
d. Bridging strategy (Scheme II-31) comprises symmetrical bridge and unsymmetrical bridge. The bridges are formed either via ring-closing metathesis, or by direct alkylation under basic conditions. For an ether protected symmetrical bridged cyclodextrin, DIBAL-H debenzylation processed in a double-deprotection manner, releasing two free alcohols on both clockwise adjacent positions of the bridging ether. This kind of phenomenon can also be deemed as steric decompression. In contrast to the symmetrical bridge, a tetradifferentiated cyclodextrin pattern was afforded when an unsymmetrical bridged cyclodextrin bearing a secondary amine and an ether on the diametrically opposed positions, underwent the action of DIBAL-H. This outcome was ascribed to the complexation of the secondary amine with aluminum reagents ${ }^{107}$.

## Tandem azide-reduction/debenzylation

The selective introduction of two different functions on diametrically opposed positions of cyclodextrins in a straight way with high yield was always a problem. Thanks to the highly regioselective DIBAL-H-mediated debenzylation method, diol-cyclodextrins were obtained with excellent yields in a stepwise manner (Scheme II-25). By means of conventional procedures, monoazido-cyclodextrins 155 and 156 were synthesized with ease from monol-cyclodextrins 130 and 131 in high yields. When $\alpha$-cyclodextrin 155 was submitted to the action of DIBAL-H, a unique regioisomer 157 was afforded in $74 \%$ yield with amino and hydroxyl groups on diametrically opposed positions ${ }^{104}$ (Scheme II-32). The regioseletivity was attributed to the steric hindrance caused by the complexation of aluminum reagent to the nitrogen in the course of azide reduction. Being a little different with the case of $\alpha$-cyclodextrin, DIBAL-H reacted with $\beta$-cyclodextrin $\mathbf{1 5 6}$ under the same conditions, giving a mixture of $\mathrm{AD}, \mathrm{AE}$ isomers (ratio 4:1) in $89 \%$ yield because of its asymmetry.


Scheme II-32: Tandem azide-reduction/debenzylation on $\alpha / \beta$-cyclodextrins

This tandem azide reduction/debenzylation strategy paved the way to multifunctionalization of cyclodextrins and regioselective synthesis of NH-Boc-protected amino acids derived from cyclodextrins. The amine on cyclodextrin was protected by a Boc group, it was followed by the alcohol oxidation and palladium-mediated hydrogenolysis of benzyl groups to give the cyclodextrin-derived amino acids (Scheme II-33).


Scheme II-33: Synthesis of cyclodextrin-derived amino acids

DIBAL-H mediated de-O-benzylation reactions are controlled by steric hindrance, which is caused either by deprotonation of alcohol, or by reduction of azide forming a hindered aluminum adduct. In these two cases, the debenzylation reactions took place on the farthest
position to the previously existing functions (OH or $\mathrm{N}_{3}$ ) (Figure II-7).


Figure II-7: Steric hindrance orients the farthest debenzylation

## Steric decompression effect

In contrast to hydroxyl or azido, there are some other functions such as vinyl and methyl, which have smaller steric hindrance and are immune to the action of DIBAL-H. In those cases, the previously existing functions directed the DIBAL-H debenzylation reactions on the clockwise adjacent positions by virtue of steric decompression. As shown in Scheme II-34, alkene cyclodextrin 165 was prepared from monol-cyclodextrin 130 in $90 \%$ yield by Swern oxidation and followed Wittig reaction. Then the formed cyclodextrin 165 underwent the action of DIBAL-H, affording a unique mono-debenzylated isomer $\mathbf{1 6 6}$ in moderate yield, with a free alcohol released on sugar unit $\mathbf{F}$, clockwise adjacent position to sugar unit $\mathbf{A}^{105}$.


Scheme II-34: Regioselective mono-debenzylation of vinyl- $\alpha$-cyclodextrin

Diol-cyclodextrin 167 can also be obtained under stronger conditions. Much longer reaction time, higher concentration and equivalents of DIBAL-H were adopted (Scheme II-35). Concerning this reaction, it proceeded also in a stepwise manner as in the case of the formation of diol-cyclodextrin 107b (Scheme II-20). The first debenzylation gave a sterically hindered aluminum derivative, which forced the removal of one more benzyl group on the farthest position.

The vinyl groups on cyclodextrin 166 and 167 were then converted into free alcohols by reductive ozonolysis giving AB-diol 168 and ABD-triol 169 in $50 \%$ and $81 \%$ yields, respectively (Scheme II-36).



Scheme II-36: Deprotection of monovinyl- $\alpha$-cyclodextrins

In the case of monovinyl cyclodextrin 165 (Scheme II-35), the steric decompression effect mediated the debenzylation following the clockwise orientation. When a $C_{2}$-symmetrical cyclodextrin derivative with two sterically decompressed vinyl functions, was submitted to the action of DIBAL-H, a double-deprotection derivative might be obtained. Based on this deduction, a divinyl-cyclodextrin $\mathbf{1 7 0}$ was prepared using the same procedures as in the case of monovinyl-cyclodextrin 165. Then DIBAL-H reaction under the usual conditions gave a sole regioisomer 171 (Scheme II-37), bearing two free alcohols on the clockwise adjacent positions to the existing vinyl functions in excellent yield ${ }^{108}$.

After optimizing the reaction conditions by reducing DIBAL-H concentration and the reaction temperature, mono-debenzylated cyclodextrin 172 was obtained as a major product. More precisely, using 0.1 M of DIBAL-H and reacting at room temperature, cyclodxtrin $\mathbf{1 7 2}$ was afforded in $54 \%$ yield with a free alcohol on its primary rim (Scheme II-38). The regioselectivity of the mono-debenzylation was in favor of the sterically decompressed position, consistent with the case of di-debenzylation (Scheme II-37). Then protection of the free alcohol by a silyl group and reduction ozonolysis of alkenes, a tridifferentiated cyclodextrin 173 was synthesized in $45 \%$ yield. Alternatively, the direct regeneration of hydroxyls of cyclodextrin $\mathbf{1 7 2}$ gave another triol-cyclodextrin isomer $\mathbf{1 7 4}$ with three alcohols on sugar units A, C, D in $63 \%$ yield.

Likewise, dideoxy-cyclodextrin $\mathbf{1 7 5}$ also possesses a similar property, which can induce a double-deprotection (Scheme II-39). Cyclodextrin 175 was prepared through mesylation and subsequent reduction in $78 \%$ yield. Upon reaction with DIBAL-H, diol-cyclodextrin 176 was given in $75 \%$ yield ${ }^{109}$. In this case, the only drawback was the difficulty for the further functionalization of the methyl groups.

## "Frustration" strategy

Cyclodextrin derivatives bearing a hydroxyl or an azido group, facilitated the de- $O$-benzylation on the diametrically opposed positions because of steric hindrance (a, Figure II-8); in sharp contrast, vinyl- or deoxy-cyclodextrins were inclined to form cyclodextrin derivatives with free alcohols on the clockwise adjacent sugar units taking advantage of steric decompression effect (b, Figure II-8).

Given that, if the benzyloxy group on the diametrically opposed positions of a hydroxyl or an azido was replaced by a deoxy or a vinyl group, which frustrates the normal debenzylation, presumably should orient the deprotection on the clockwise units to give a tetradifferentiated pattern.
Sulfate-bridged cyclodextrin 108a was prepared using Bol's method ${ }^{110}$. After opening the sulfate bridge with lithium aluminum hydride and the subsequent hydrolysis, deoxy-cyclodextrin 177 was synthesized in $51 \%$ yield bearing a deoxy and a hydroxyl groups on the diametrically opposed positions. The alcohol on cyclodextrin 177 was converted into an azido group using conventional procedures to give cyclodextrin 178 in an excellent yield. When cyclodextrin $\mathbf{1 7 7}$ underwent the action of DIBAL-H ( 30 eq. 1 M ), surprisingly, a tridifferentiated triol-cyclodextrin 179 was obtained, rather than the expected diol. Using

[^42]similar conditions, the reaction on cyclodextrin 178 gave a consistent result, with debenzylation on both sides of the sterically decompressed position ${ }^{106}$ (Scheme II-40).
An unambiguous NMR study and a kinetic study deciphered that both sides of the decompression site undergo the first mono-debenzylation to give a mixture of monol-isomers. Then each isomer leads to the same final product.


Scheme II-40: Regioselective debenzylation of monol/azido-deoxy- $\alpha$-cyclodextrins

The same reaction sequence was also applied on vinyl-functionalized cyclodextrins 182 and 183, without surprise, triol-cyclodextrin 184 and amino-diol-cyclodextrin 185 were afforded with yields of $71 \%$ and $50 \%$, respectively (Scheme II-41).


Scheme II-41: Regioselective debenzylation of monol/azido-vinyl- $\alpha$-cyclodextrins

Therefore, this frustration strategy, combining two delineated deprotection methods could be used to access tridifferentiated cyclodextrins, and also can give new tetradifferentiated cyclodextrin motifs in a highly selective fashion.

## Bridging strategy

The methods using capping reagents have been employed to get functionalized cyclodextrins, albeit normally through extensive chromatographical purification and with low yields. Based on DIBAL-H debenzylation, a new method of functionalization of cyclodextrins called "bridging strategy" was developed. Herein this strategy will be detailed in two parts, i.e. symmetrical bridge strategy and unsymmetrical bridge strategy.
The symmetrical bridge was synthesized from $C_{2}$-symmetrical diol- $\alpha$-cyclodextrin 107a, which was obtained by the in-house debenzylation. The two free alcohols were functionalized by allyl groups with allyl bromide in the presence of sodium hydride in $95 \%$ yield. Ring-closing metathesis gave bridged cyclodextrin 186 employing the Grubbs ${ }^{1}$ catalyst with an excellent yield. DIBAL-H reacted with cyclodextrin 186 under usual conditions, giving a unique di-debenzylated cyclodextrin 187 in regioselective manner ${ }^{108,111}$ (Scheme II-42), as in the case of divinyl or dideoxy cyclodextrins $\mathbf{1 7 0}$ and $\mathbf{1 7 5}$. In this case, the clockwise adjacent deprotection can also be explained by steric decompression effect. The released diametrically opposed alcohols were then protected by TBS group, it was followed by a ring-opening metathesis to restore allyl groups in $70 \%$ yield. The allyl protected cyclodextrin 189 was submitted to the action of $\mathrm{Pd}^{0}$ in the presence of zinc chloride and tributyltin hydride to afford tridifferentiated cyclodextrin 190 with three pairs of orthogonal functions, or performing the same method on cyclodextrin 188 gave cyclodextrin 190 in a single step. Because of the toxicity of tin derivative, triethylsilane was another alternative.

The bridged cyclodextrin can also be formed in a single step. Using 3-chloro-2-(chloromethyl) prop-1-ene in the presence of sodium hydride, methallyl bridged cyclodextrin 191 was reached in $89 \%$ yield 112 . The following DIBAL-H-mediated debenzylation gave diol-cyclodextrin 192 in the clockwise manner ${ }^{113}$ (Scheme II-43).


Scheme II-43: Regioselective di-debenzylation of methallyl bridged cyclodextrin

Under milder conditions, the debenzylation can be stopped at the monol stage, albeit at the cost of reducing the yield slightly. As shown in Scheme II-44, bridged-monol-cyclodextrin 192a was obtained in $52 \%$ yield. Then, further functionalization gave tridifferentiated cyclodextrin 193 through a sequence of TBS protection and $\mathrm{Pd}^{0}$-mediated bridge opening. The direct bridge opening afforded ACD triol-cyclodextrin $\mathbf{1 7 4}$ which has been prepared from cyclodextrin $\mathbf{1 7 2}$ by the reductive ozonolysis (Scheme II-38).

The symmetrically bridged cyclodextrins, synthesized from diol-cyclodextrin 107a, which underwent DIBAL-H debenzylation, giving the tridifferentiated cyclodextrin motif. Since amino-alcohol cyclodextrin 157 can be prepared easily by means of tandem azide-reduction/debenzylation, unsymmetrically bridged cyclodextrin 194 (Scheme II-45) was then obtained in $54 \%$ yield by the direct alkylation of amine and alcohol ${ }^{107}$ as in the case of cyclodextrin 191 (Scheme II-43).


Scheme II-45: Mono/di-debenzylation of unsymmetrical bridged cyclodextrins

If comparing the results obtained with the symmetrically bridged cyclodextrin 191, cyclodextrin 194 under the action of DIBAL-H should give C, F-diol-cyclodextrin 200. In order to discriminate between these two positions, a bulky group was utilized for the
protection of the amine side to prevent debenzylation on sugar $\mathbf{F}$. To reach this goal, the amine on sugar A was benzylated to give cyclodextrin 196 in $96 \%$ yield. Disappointingly, after the action of DIBAL-H, diol-cyclodextrin 198 was obtained in $65 \%$ yield corresponding to a bis clockwise debenzylation (Scheme II-45). Then, another bulkier protection group: 3, 5-di-tert-butylbenzyl, was used, but frustratingly, it did not induce the mono-deprotection, preferentially giving diol-cyclodextrin 199 in $73 \%$ yield. On the contrary, the mono-debenzylation was carried out mostly on sugar C, giving cyclodextrin 195 in $62 \%$ yield, when unprotected cyclodextrin 194 was submitted to the action of DIBAL-H. The corresponding diol cyclodextrin 200 could also be obtained only under stronger reaction conditions with a moderate yield. On account of this phenomenon, a hypothesis was proposed that, DIBAL-H reacted with secondary amine to generate a sterically hindered complex, which prevented the clockwise deprotection.

## 4. Functionalization of the secondary rim of cyclodextrins

Selective functionalization of the secondary rim of cyclodextrins seems challenging to chemists due to its steric crowding caused by the very high density of hydroxyl groups (twice as much as on the primary rim) on the secondary rim. In addition, hydrogen bondings between hydroxyl groups of position 2 and 3 make the secondary rim rigid and less flexible compared to primary alcohols. Nevertheless, some methods or strategies have been uncovered in the literature for selective functionalization of the secondary alcohols, either on position 2 or on position 3 .

As mentioned above, hydroxyls on position 2 are more acidic than the others, so a straightforward method to functionalize OH-2 can be fulfilled by employing a strong base to form 2 -alkoxide ions which react with alkyl or sulfonyl chlorides. Using sodium hydride in anhydrous DMSO, native cyclodextrins were deprotonated on positions 2 , giving much more nulecophilic alkoxides, which then reacted with methyl iodide or tosyl chloride to afford per-2-methylated or tosylated cyclodextrins ${ }^{114}$ (Scheme II-46).

[^45]However, with the increase of functionalized positions, this selectivity becomes weaker because of the steric hindrance of the secondary rim. The electrophiles can then react with the primary alcohols. In order to solve this problem, the primary alcohols were masked in advance. In the presence of weak base, such as imidazole, the primary rim can be protected with TBS groups, the hydroxyls on position 2 were thereafter methylated using a strong base, giving cyclodextrins 203 and 204 in acceptable yields ${ }^{74}$ (Scheme II-47).

A group transfer strategy based on supramolecular inclusion was applied to the functionalization of secondary alcohols at times. Cyclodextrin 69 reacts with meta-nitrophenyl tosylate in DMF/water buffer to form an inclusion complex owing to the hydrophobic interaction. Then the orientation of the reagent inside the cavity enables only the position 2 to be functionalized ${ }^{115}$ (Scheme II-48). This compound was then used to prepare 3 -functionalized cyclodextrin. It was fulfilled by intramolecular $\mathrm{S}_{N} 2$ epoxidation and the following nucleophilic attack on position 3. In the course of these sequential reactions, the inversion of configuration ${ }^{68,116}$ happened on the both of positions 2 and 3.

Capping reagents such as disulfonate chloride have been broadly employed for the functionalization of the primary rim of cyclodextrins, they can also be utilized on the

[^46]secondary rim. Imidazole was an alternative for chloride as a leaving group ${ }^{117}$. By optimization of linker in capping reagents, Teranishi demonstrated that $2^{\mathrm{A}}, 2^{\mathrm{B}} ; 2^{\mathrm{A}}, 2^{\mathrm{C}}$ or $2^{\mathrm{A}}$, $2^{\text {D }}$ disulfonates were obtained selectively (Table II-5). Using 1 equivalent of reagent 206 in DMF, AB-isomers were synthesized in approximately $30 \%$ yield without other isomers ${ }^{117}$ (Entry 1, Table II-5). To access AC-isomers ${ }^{118}$, capping reagent 207 was utilized with a longer linker, giving the desired products with yields of 40\%-50\% (Entry 2, Table II-5). Apart from the AB- and AC-isomers, AD-isomers ${ }^{119}$ were also obtained in approximately $30 \%$ yield under the action of reagent 208 (Entry 3, Table II-5).

Besides disulfonate caps, another reagent a, a'-dibromo-o-xylene was used. The difference was that it can be installed selectively on the secondary alcohols of the same sugar unit (Scheme II-49). Treatment of native cyclodextrins with the above reagent in DMSO with the assistance of lithium diisopropylamide (LDA) afforded 2A, 3A-O-(o-xylylene) cyclodextrins 209 and 211 in about $30 \%$ yields ${ }^{120}$. Then methylation and Pd-mediated catalytic hydrogenolysis provided cyclodextrins having two vicinal free secondary alcohols for further functionalization.

Alternatively, benzylidene group can be used in the functionalization of the secondary rim of cyclodextrins by bridging between two contiguous position 2 and 3 hydroxyls. The per-6-pivaloylated cyclodextrins were treated with 2 molar equivalents of benzaldehyde dimethylacetal in DMF at $60^{\circ} \mathrm{C}$ under reduced pressure ( 2 kPa ) in the presence of CSA as the catalyst, giving cyclic mono-benzylidene acetal cyclodextrins in $37-54 \%$ yields ${ }^{121}$. It is noteworthy that the yields of the interglycosidic benzylidene acetals are dependent on the ring size of the native cyclodextrins (Scheme II-50). It was followed by a sequence of chemical transformations to give diol-cyclodextrin 220 in $60 \%$ yield. The reductive cleavage of the interglycosidic benzylidene group with lithium aluminum hydride/aluminum chloride in $\mathrm{DCM}-\mathrm{Et}_{2} \mathrm{O}$, afforded cyclodextrin 221 with only one unprotected position 2.

[^48]The hydroxyls on position 3 are the least reactive probably due to the participation in hydrogen bonding. Normally, functionalization on position 3 was achieved only when the other hydroxyls have been protected. Under the treatment of dimethylsulfate or allyl bromide in the presence of $\mathrm{BaO} / \mathrm{Ba}(\mathrm{OH})_{2}$, native cyclodextrins were permethylated or perallylation on positions 2 and 6. ${ }^{122}$ At a higher temperature, TBS protected cyclodextrins 223 and 224 were afforded in the presence of pyridine and DMAP ${ }^{123}$ (Scheme II-51). The obtained TBS protected cyclodextrins were then transformed to per-(2-benzyl-3,6-di-O-TBS)-cyclodextrins 226 and 227 by treatment of sodium hydride and benzyl bromide in dry THF ${ }^{124}$. The migration of TBS group from position 2 to position 3 is an intramolecular process and involves a five-membered ring intermediate containing a pentacovalent silicon atom. The allylated cyclodextrin $\mathbf{2 2 5}$ can be converted into per-3-methylated cyclodextrin $\mathbf{2 2 9}$ in 3 steps. The remaining free $\mathrm{OH}-3 \mathrm{~s}$ were methylated firstly by the conventional procedure, then the labile enol ether was obtained by the isomerization mediated with $t \mathrm{BuOK}$. It was followed by the mild acid hydrolysis to remove the allyl groups, giving cyclodextrin 229 with a yield of $72 \%$ in 3 steps ${ }^{125}$.

Direct selective funtionalization of position 3 of cyclodextrins is a difficult task, because of the existing more reactive 2 - or 6 -hydroxyl groups. A method initially used for $O$ - 3 -debenzylation of poly- $O$-benzylated mono- and disaccharide ${ }^{126}$, was employed for the selective funtionalization of position 3 of cyclodextrins. Combining of triethylsilane and idodine at low temperature $\left(-60\right.$ to $\left.-35^{\circ} \mathrm{C}\right)$, perbenzylated $\alpha$-cyclodextrin 128 underwent the

[^49]$O$-3-debenzylation reaction to give per-2,6-benzylated cyclodextrin 230 in $58 \%$ yield ${ }^{127}$ (Scheme II-52). This method was also applied to monol and diol-cyclodextrins 130 and 107a, giving the same results in about $45 \%$ yield.

DIBAL-H mediated de-O-benzylation has proved to be a method of choice for the functionalization of cyclodextrins. Similar method was used as well in the selective deprotection of methyl ethers, giving gratifying results (Scheme II-53).

Unlike perbenzylated cyclodextrins, the lower steric hindrance of methyl groups enables de- $O$-methylation to proceed on the secondary rim of cyclodextrins, although with a minor of

[^50]6A-monohydroxy cyclodextrin ${ }^{128}$. When permethylated $\alpha$ - or $\beta$-cyclodextrin 233 and 234 were subjected to the action of DIBAL-H (6 or 7 equivalents) at $50^{\circ} \mathrm{C}$, de- $O$-methylation took place on positions 2 and 3 of two adjacent sugar units, giving 2A,3B-diol cyclodextrins 235 and 236 in $55 \%$ yields (Path A, Scheme II-53). As the quantity of DIBAL-H increased to 50 equivalents, regioselective tetra-de- $O$-methylation was observed at room temperature, affording 2A, 3B, 2D, 3E-tetrahydroxy-cyclodextrins 237 and 238 in approximately $50 \%$ yield (Path B, Scheme II-53) ${ }^{129}$. In this case, another tetrol isomer 239 was also formed in $19 \%$ yield ${ }^{130}$. Upon prolongation of reaction time to $28 \mathrm{~h}, 2 \mathrm{~A}, 3 \mathrm{~B}, 2 \mathrm{C}, 3 \mathrm{D}, 2 \mathrm{E}, 3 \mathrm{~F}$-hexahydroxy cyclodextrin 240 was formed in $45 \%$ yield (Path C, Scheme II-53) ${ }^{129}$.
In order to clarify the above results, a mechanism was proposed ${ }^{131}$. As in the debenzylation reaction, two molecules of aluminum reagents were proposed to participate. The first one was chelated on the oxygens of position 2 and adjacent position 3, the second aluminum species was thereafter coordinated on the less hindered position 3 oxygen, where the dealkylation happened. Sequentially, the anomeric oxygen then got involved the aluminum coordination to leave more space for DIBAL-H to approach the position 2 oxygen, which leads to the demethylation occured on this position. The following formation of tetrol and hexol was directed by the steric crowding of aluminum adducts just as happened in the case of perbenzylated cyclodextrins.

## 5. Conclusion

In summary, the methods reviewed in this chapter pave the way to diversify cyclodextrin polyfunctionalization, which thereafter can be applied to various areas. By means of the traditional methods, taking advantages of different reactivities of alcohols, reagents, intrinsic structure of cyclodextrins or others new emerged method ${ }^{132}$, a limited amount of cyclodextrin motifs were achieved with the compromise of yield, regioselectivity or time-consuming chromatography. Nevertheless, DIBAL-H mediated debenzylation seems to be an attractive and promising approach. To highlight the versatility of this method, a number of cyclodextrin patterns of much higher complexity, such as tri- or tetradifferentiated cyclodextrins have been accessed with high efficiency (Figure II-9). Although much progress has been made in recent years, the higher level of complexity in cyclodextrin functionalization have not yet been obtained. Accordingly, in the next chapter we envisaged the possibility to access the penta-, or even hexadifferentiated $\alpha$-cyclodextrins.

## CHAPTER III

## SITE-SELECTIVE HEXA-HETEROFUNCTIONALIZATION OF $\alpha$-CYCLODEXTRIN

## 1. Introduction

In Chapter II, we have shown a myriad of cyclodextrin derivative patterns synthesized either by the traditional methods, or by DIBAL-H-mediated strategies. The following Figure III-1 gives us an explicit demonstration of which kind of patterns are already reached.


Figure III-1: Functionalization patterns

According to Figure III-1, several cyclodextrin derivatives ${ }^{100-113}$ have been achieved by means of DIBAL-H-mediated debenzylation strategies. However, the patterns with higher level of complexity such as penta- or hexadifferentiated patterns, are still out of reach, which need a synthetic strategy that should meet some requirements: 1) during a single debenzylation reaction, only one benzyl group should be removed in a regioselective manner; 2) the new functional group introduced should be capable of orienting the following debenzylation reaction regioselectively. Consequently, to meet this challenge, it is necessary to delineate a set of site-directing methods introduced in Chapter II.

## 2. Strategy of the synthesis

DIBAL-H mediated de- $O$-benzylation of cyclodextrins ${ }^{100}$ is a well-defined reaction and the mechanism has been clarified unambiguously. The steric hindrance of the aluminum species plays an important role on the regioselectivity of the reactions.
Based on this attractive approach, an ensemble of site-directing rules (Figure III-2) have been established and well applied to polyfunctionalization of cyclodextrins.

1) Coupled azide-reduction/debenzylation reaction (Figure III-2a): DIBAL-H reduces the azide firstly, and then orients the debenzylation on the diametrically opposed position due to the steric hindrance of the aluminum complex ${ }^{104}$;
2) Steric decompression on the primary rim of cyclodextrins (Figure III-2b): introduction of a deoxy or a vinyl group on sugar unit $\mathbf{A}$, induces an adjacent clockwise deprotection on sugar unit $\mathbf{F}^{105}$. This site-directing decompression can also be realized by bridging the diametrically opposed sugar units A and D (Figure III-2c) to proceed a double-deprotection on both the sterically decompressed ether sides ${ }^{108}$;
3) "Frustration" strategy devised by a combination of both methods $\mathbf{1}$ and 2 (Figure III-2d). Changing the benzyloxy group on sugar unit $\mathbf{D}$ by a less crowded vinyl group, the azide-derived sugar unit $\mathbf{A}$ direct the debenzylation to give an unexpected tetradifferentiated cyclodextrin with free alcohols on both sides of sterically decompressed position ${ }^{106}$. Although this method displays a very good regioselectivity, it is a dead-end towards hexadifferentiation of $\alpha$-cyclodextrin, which need a mono-debenzylation during a single debenzylation reaction.
4) Unsymmetrical bridge strategy (Figure III-2e): introduction of a methallyl bridge on an amino-alcohol cyclodextrin orients the debenzylation just on the sterically decompressed ether side, affording a tetradifferentiated cyclodextrin derivative.

The understanding of the site-directing effects and mechanisms on cyclodextrins enables the access to diverse cyclodextrin derivatives. Thus combining the existing rules, we devised a synthetic route to reach hexadifferentiated cyclodextrin 246, possessing six different functions on the primary rim of $\alpha$-cyclodextrin. It is an important challenge in the functionalization of $C_{\mathrm{n}}$-symmetric concave cycles.
Perbenzylated $\alpha$-cyclodextrin 128 is submitted to the action of DIBAL-H to form monol-cyclodextrin 130, which is converted into vinyl-cyclodextrin 165. Cyclodextrin 165
undergoes the action of DIBAL-H to give vinyl-monol-cyclodextrin $\mathbf{1 6 6}$ by the virtue of steric decompression. Then the alcohol $\mathbf{1 6 6}$ can be transformed into azido-cyclodextrin $\mathbf{2 4 1}$ which mediates azide-reduction/debenzylation to form amino-alcohol cyclodextrin 242. After introduction of the bridge group (243), the unsymmetrical bridge will orient DIBAL-H debenzylation to give cyclodextrin 244. Finally duplication of azide-reduction/debenzylation will produce the ultimate hexadifferentiated cyclodextrin 246 (Scheme III-1). Therefore, hexadifferentiation of $\alpha$-cyclodextrin will be accessed through five successive DIBAL-H mediated debenzylation by using appropriate chemical groups. In the following part of this chapter, the detailed description will be presented for this kind of total synthesis.

## 3. Successive debenzylations towards hexadifferentiated $\alpha$-cyclodextrin

### 3.1 Fisrt debenzylation by DIBAL-H

Native $\alpha$-cyclodextrin 67 was converted into cyclodextrin 128 in quantitive yield ${ }^{133}$. The first debenzylation offered monol- $\alpha$-cyclodextrin 130 in $64 \%$ yield (Scheme III-2) ${ }^{100}$. Because of the steric hindrance on the secondary rim, debenzylation only occurred on the primary rim. Careful attention should be paid to this reaction, since with more equivalents of DIBAL-H, higher concentration and temperature would lead to a second debenzylation on the diametrically opposed sugar unit $\mathbf{D}$.
Then the hydroxyl of $\alpha$-cyclodextrin 130 was converted into a vinyl group in $90 \%$ yield by Dess-Martin oxidation and followed Wittig olefination. Using Dess-Martin periodinane, the free alcohol was oxidized to the corresponding aldehyde at room temperature in DCM. Vinyl-cyclodextrin 165 was obtained in the following olefination by using methylphosphonium salt in the presence of $n$-butyllithium at $-40^{\circ} \mathrm{C}$.

### 3.2 Second debenzylation by steric decompression effect

With A-vinyl- $\alpha$-cyclodextrin 165 in hand, the second DIBAL-H-mediated debenzylation gave A-vinyl-F-alcohol- $\alpha$-cyclodextrin 166 as the major product in $41 \%$ yield, as well as $22 \%$ of starting material 165 and $20 \%$ of diol-cyclodextrin ${ }^{105}$ (Scheme III-3). In the course of this reaction, the steric decompression caused by a vinyl group on unit $\mathbf{A}$ favored the debenzylation on unit $\mathbf{F}$, clockwise adjacent to sugar $\mathbf{A}$ (165-I). Similarly to the first debenzylation (Scheme III-2), the equivalent of DIBAL-H, the concentration and the temperature should be carefully controlled to avoid the formation of diol-cyclodextrin. Through two successive DIBAL-H debenzylations, tridifferentiated $\alpha$-cyclodextrin 166 was obtained with a free alcohol on sugar unit $\mathbf{F}$.

### 3.3 Third debenzylation by azide-reduction/debenzylation

As we know, introduction of an azide can induce a regioselective debenzylation and release of only one hydroxyl, so the free hydroxyl on cyclodextrin 166 was then converted into an azido group using MsCl in the presence of $\mathrm{Et}_{3} \mathrm{~N}$, followed substitution by azide sodium in DMF at $80^{\circ} \mathrm{C}$.

The F-azido-A-vinyl-cyclodextrin 241 underwent a tandem azide-reduction/debenzylation reaction to give tetradifferentiated cyclodextrin 242 in $78 \%$ yield, bearing a free hydroxyl located on sugar unit C, diametrically opposed to sugar unit F ${ }^{104}$ (Scheme III-4). This reaction proceeded through two sequential steps: firstly, the reduction of azide by DIBAL-H generated a sterically crowded aluminum derivative (241-I), which then forced the de- $O$-benzylation on the farthest position, i.e. sugar unit $\mathbf{C}$ in this case.

Since tetradifferentiated cyclodextrin 242 with C-alcohol, F-amine was prepared, the following work is functionalization of these two functions and removal of another benzyl group selectively.

### 3.4 Fourth debenzylation by unsymmetrical bridge strategy

According to our previously established site-directing rules, a symmetrical methallyl capped cyclodextrin can undergo a double-debenzylation reaction (Figure III-2c), in contrast, an unsymmetrical bridge (Figure III-2e) induced a mono-debenzylated reaction on the sterically decompressed side.
Thus, the two functions amine and alcohol underwent direct alkylations to afford bridged cyclodextrin 243 in $72 \%$ yield by using 3 -chloro- 2 -(chloromethyl) prop-1-ene in the presence of sodium hydride. Then the following DIBAL-H debenzylation reaction gave an inedited pentadifferentiated $\alpha$-cyclodextrin 244 with an acceptable yield ${ }^{107}$ ( $56 \%$, Scheme III-5). In this reaction, mono-debenzylation occurred only on sugar unit B, clockwise adjacent to the ether moiety of unit $\mathbf{C}$. To explain this result, it was assumed that the secondary amine on unit $\mathbf{F}$ can chelated with DIBAL-H crowding the region surrounding the amine (243-I). The clockwise deprotection was then prevented on the amine side, while favored on the ether side.

To confirm this proposal, a secondary amino-cyclodextrin 249 was synthesized from monoazido-cyclodextrin 155. Using Staudinger reaction, amino-cyclodextrin 247 was obtained, it was followed by the Boc protection, methylation and acid-mediated Boc deprotection to give secondary amino-cyclodextrin 249 with a yield of $60 \%$ in four steps. It was then submitted to the action of DIBAL-H, affording an expected mono-debenzylated cyclodextrin 250 bearing a free alcohol on the diametrically opposed sugar unit D (Scheme

III-6). This regioselectivity confirmed our assumption that DIBAL-H reacted with the secondary amine on sugar A to form an aluminum complex (249-I), which induced the usual steric orientation of DIBAL-H on the diametrically opposed sugar unit D.

Now we have accessed pentadifferentiated $\alpha$-cyclodextrin 244 unreached before, through sequential four DIBAL-H-mediated debenzylation reactions. The last debenzylation, i.e. the fifth debenzylation can be proceeded by another tandem azide-reduction/debenzylation to give cyclodextrin 246.

### 3.5 The fifth debenzylation by azide-reduction/debenzylation

As shown previously (Scheme III-4), the free alcohol was firstly transformed into an azide. To avoid the interaction of F -amine with mesyl group, the amine was protected temporarily with a Boc group. A sequence of mesylation, azidation and the followed acid-mediated deprotection of Boc group, gave cyclodextrin $\mathbf{2 4 4} \mathbf{c}$ bearing an azido group on sugar unit $\mathbf{B}$ with a yield of $83 \%$ in three steps (Scheme III-7). To avoid the association of F-amine with aluminum, it should
be protected by an appropriate group which is immune to the action of DIBAL-H and is not so bulky to prevent the clockwise adjacent debenzylation. Herein benzyl group was chosen according to the above mentioned rules ${ }^{107}$. Firstly, the benzyl bromide was tried, but disappointedly, the benzylation didn't work. Therefore, the more reactive benzyl iodide ${ }^{134}$ was used in the benzylation reaction, giving cyclodextrin $\mathbf{2 4 5}$ in $73 \%$ yield. It was followed by the tandem reaction to afford exclusively the diametrically opposed B-amino-E-hydroxyl cyclodextrin 246 in $70 \%$ yield (a total yield of $2.2 \%$ from native $\alpha$-cyclodextrin, Scheme III-7), which was the first hexadifferentiated cyclodextrin bearing six different chemical groups on position 6 of each unit.

The structure of hexadifferentiated cyclodextrin 246 was characterized thoroughly using NMR spectroscopy. As shown in Figure III-3, the C-1s and H-1s were identified through HSQC with characteristic chemical shifts of the acetal carbons around 100 ppm (Figure III-3a). Combining COSY and TOCSY 2D experiments, all the other protons of each unit were attributed since we identified all the H-1s. For example, Figure III-3b showed the protons of sugar $\mathbf{A}$. The different functions installed on the primary rim can be identified individually. For instance, cycle A was identified through the correlation of $\mathrm{H}-5$ with a vinylic proton in TOCSY and COSY (Figure III-3b). In cycle C, HMBC indicated a cross-correlation between C-6 and allylic protonsof the bridge (Figure III-3d). A similar correlation was found in cycle F, but an additional correlation was observed with the benzylic protons (Figure III-3d and III-3c). Another correlation with benzylic protons was observed in cycle D (Figure III-3c). Finally, cycles $\mathbf{B}$ and $\mathbf{E}$ were identified because they do not cross-correlate with any substituent, C-6B and C-6E were differentiated through their characteristically different

[^54]chemical shifts ( 42 and 62 ppm respectively). Finally the order of all sugar cycles was determined through NOE cross coupling between $\mathrm{H}-4 \mathrm{~s}$ and $\mathrm{H}-1 \mathrm{~s}$ of adjacent sugars, confirmed by cross-correlation in HMBC between H-4s and C-1s (Figure III-3e).

## 4. Post-functionalization of penta- and hexadifferentiated cyclodextrins

Through five successive DIBAL-H mediated debenzylations, the ultimate hexadifferentiated cyclodextrin 246 was accessed. In addition, we also synthesized another pentadifferentiated
cyclodextrin 245 unreached before and obtained two new tetradifferentiated patterns. But it is not a dead-end. Consequently, we envisage the possibility to synthesize the corresponding derivatives, bearing six orthogonal functions: amine, alkene, azide, alcohol, ether and chloride from the penta- and hexadifferentiated cyclodextrins through further chemical transformations.
To achieve this goal, a set of reactions were tested. During this process, the key point is to open the methally bridge smoothly using a reliable method. To adjust this problem, palladium-mediated bridge opening ${ }^{113}$ was applied. This method has been used on ether bridged cyclodextrin 192 (Scheme III-8). So it was optimized on unsymmetrically bridged cyclodextrin analogue 196. Using $\mathrm{Pd}_{( }\left(\mathrm{PPh}_{3}\right)_{4}$ in the presence of zinc chloride and triethylsilane, the benzyl protected amino-alcohol cyclodextrin 251 was obtained in $65 \%$ yield (Scheme III-8).

We also submitted chloride-cyclodextrin and vinyl-cyclodextrin to this reaction, demonstrated that these two functions are tolerate during the process of bridge opening. Based on the above results, a series of chemical transformations were combined to carry out the post-functionalization.

### 4.1 Post-functionalization of pentadifferentiated cyclodextrin 245

For the post-funtionalization of cyclodextrin 245 to another hexadifferentiated motif, six sequential chemical transformations were included (Scheme III-9). The first step was to remove the methallyl group. Using depicted method, the functionalizable secondary amine and alcohol were formed in $78 \%$ yield. But surprisingly, the azide on sugar unit B was also reduced to an amine. Therefore, the next step was to restore the azide function. This reaction was executed by a lab-made reagent, Imidazole-1-sulfonyl azide hydrochloride $\left(\operatorname{ImSO}_{2} \mathrm{~N}_{3}\right)^{135}$.

[^55]With the copper catalyst, the primary amine was reconverted into azide in $79 \%$ yield. Then after the protection of secondary amine via reductive amination and chlorination of hydroxyl on unit $\mathbf{C}$, the azide-reduction/debenzylation and the following azidation gave hexadifferentiated cyclodextrin 256, bearing six orthogonal functions: amine, alkene, azide, chloride, ether and alcohol.

### 4.2 Post-functionalization of hexadifferentiated cyclodextrin 246

It is also possible to synthesize another regioisomeric hexadifferentiated cyclodextrin 260 in a shorter sequence (Scheme III-10). Using thionyl chloride in the presence of pyridine, the already existing alcohol on sugar unit $\mathbf{E}$ was chlorinated after protection of primary amine with Boc group. It was followed by the methallyl bridge removal and the azidation of amine, giving hexadifferentiated cyclodextrin 260.

## 5. Conclusion

In this chapter, based on our well-established site-directing debenzylation rules, the ultimate hexadifferentiation of $\alpha$-cyclodextrin was accomplished, as well as pentadifferentiation and two new tetradifferentiation unreached before (Figure III-4). This illustrated that the DIBAL-H-mediated debenzylation and the attached site-directing rules have the capacity to realize the poly-hetero-functionalization of cyclodextrins with high efficiency. We believe that this achievement on cyclodextrins should give the inspiration on the functionalization of this class of $C_{\mathrm{n}}$ concave cycles.

## CHAPTER IV

DIBAL-H INDUCED SELECTIVE FUNCTIONALIZATION OF SULFURAND SELENIUM-DERIVED $\alpha$-CYCLODEXTRINS: NEW SITE-DIRECTING RULES

## 1. Introduction

DIBAL-H-mediated debenzylation is an efficient method for the functionalization of cyclodextrins, by which, benzyl groups on perbenzylated $\alpha$-cyclodextrin or monol- $\alpha$-cyclodextrin can be removed regioselectively, affording a unique diol-cyclodextrin 107a with excellent yields ${ }^{100}$ (Scheme IV-1).


Scheme IV-1: DIBAL-H-mediated de-O-benzylation on the primary rim of cyclodextrins

Monoacetate-cyclodextrin 261, was prepared from acetylation of monol-cyclodextrin 130 with acetic anhydride in pyridine. It was submitted to the action of DIBAL-H in toluene, as we imagined, giving diol-cyclodextrin 107a as a single product in $89 \%$ yield (Scheme IV-2).


Scheme IV-2: Diol-cyclodextrin formed from monoacetate-cyclodextrin 261 by DIBAL-H

In the case of the perbenzylated or monol-cyclodextrins, the reason for the debenzylation to take place on the diametrically opposed position (glucose unit D), is the steric hindrance of the aluminum chelation during the first debenzylation (for perbenzylated-CD) or the initial deprotonation (for monol-CD). Similarly, in the case of monoacetate-cyclodextrin 261, the steric crowding is caused by ester reduction with DIBAL-H (261-Ib, Scheme IV-3).



Scheme IV-3: Proposed mechanism for the formation of diol-cyclodextrin from monoacetate-cyclodextrin 261 by DIBAL-H

Now, we can synthesize diol-cyclodextrin 107a from perbenzylated, monol or monoacetate-cyclodextrins in good yields. All these reactions result from the ability of oxygen atoms to coordinate with aluminum reagents. Sulfur and selenium are in the same group as oxygen, belonging to chalcogen, and to the best of our knowledge, the action of DIBAL-H on sulfur- or selenium-derived cyclodextrins is still underexplored. We therefore envisaged to employ the reactivity of DIBAL-H on sulfur- and selenium-derived cyclodextrins (Scheme IV-4).

## 2. DIBAL-H induced selective functionalization of sulfur-derived $\alpha$-cyclodextrins

### 2.1 Thioester-reduction/debenzylation

Introduction of the sulfur atom was firstly operated by nucleophilic substitution using thioacetate (Scheme IV-5). A mesyl group was introduced by reaction of cyclodextrin 130 with methanesulfonyl chloride in the presence of triethylamine. It was followed by a nucleophilic substitution reaction with potassium thioacetate in DMF at $50^{\circ} \mathrm{C}$, giving thioacetate-cyclodextrin 262 in 89\% yield.



Scheme IV-5: Synthesis of thioacetate-cyclodextrin 262

Once thioacetate-cyclodextrin 262 was prepared, a preliminary test demonstrated that AD-thiol-monol-cyclodextrin 263 was generated in $42 \%$ yield, with $12 \%$ yield of thiol-cyclodextrin 264 and a mixture of diol-cyclodextrins. Careful control of the reaction time (10 min), allowed to reach an excellent yield of $82 \%$ (Scheme IV-6). During this process, thioacetate was firstly reduced by DIBAL-H to form the sterically hindered aluminum complex (262-I), which oriented the debenzylation on the farthest position $\mathbf{D}$.


Scheme IV-6: Synthesis of thiol-monol-cyclodextrin by the action of DIBAL-H

Cyclodextrin 264 was prepared from cyclodextrin 262 by Zemplin deacetylation conditions. It then underwent the action of DIBAL-H to give cyclodextrin 263 in $42 \%$ yield. The mechanism resembles that in the case of monol-cyclodextrin 130. The steric hindrance was formed by deprotonation of thiol with DIBAL-H (Scheme IV-7).


Scheme IV-7: Synthesis of thiol-monol-cyclodextrin from thiol-cyclodextrin by DIBAL-H

Consequently, a new site-directing debenzylation rule was uncovered. The steric hindrance caused by ester reduction or thiol deprotonation of DIBAL-H, can orient the debenzylation selectively. This paves the way to prepare cyclodextrin patterns containing thiol and hydroxyl groups.

### 2.2 The difference of reactivity of SBn and OBn groups in DIBAL-H debenzylation

Gratifyingly, introduction of thiol or thioacetate groups on the primary rim of cyclodextrins, gave encouraging results during DIBAL-H-mediated debenzylation. Then, thiobenzyl group was imported to study the difference of reactivity between the $O$-benzyl and the $S$-benzyl groups.
Thiobenzyl-cyclodextrin 265 was prepared by benzylation of thiol-cyclodextrin 264 with benzyl bromide in the presence of sodium hydride in DMF. Then, cyclodextrin 265 was subjected to the action of DIBAL-H (Scheme IV-8). In the course of this reaction, mass spectrometry was employed to monitor the process of the reaction. When the di-debenzylated product was the major product, the reaction was quenched and a sequence of work-up and purification, gave a mixture of inseparable di-debenzylated regioisomeric products 265a and 265b.


Scheme IV-8: Synthesis of thiobenzyl-cyclodextrin and DIBAL-H debenzylation

In order to investigate this reaction, a series of NMR spectra were made. As shown in Figure IV-2, the benzyl group attached to the sulfur atom was untouched (Figure IV-2a). On the basis of ${ }^{1} \mathrm{H}$ NMR analysis, there were two products obtained with a ratio of 1:2 under the action of DIBAL-H (Figure IV-2b). Figure IV-2c showed that 4 alcohols were released according to the characteristical chemical shifts ( 62 ppm ) of primary carbons attached to the hydroxyls.

(a) Correlation of $S$-benzylic carbons and their protons; (b) ${ }^{1} \mathrm{H}$ spectrum of $\mathrm{H}-1 \mathrm{~s}$; (c) Correlation of $\mathrm{C}-6 \mathrm{~s}$ and the corresponding $\mathrm{H}-6 \mathrm{~s}$

Based on the NMR spectral analysis, we speculated that the benzyl group attached to the sulfur atom was immune to the action of DIBAL-H. To confirm this assumption, an alternative cyclodextrin 266 was synthesized with a methyl group attached to the sulfur atom.

Cyclodextrin 266 was synthesized using a method developed by Krief ${ }^{136}$. It was used initially in chemoselective reduction of organoselenocyanates to selenolates with metal hydrides. We tried this method on thioacetate-cyclodextrin 262, by reaction with sodium hydride in DMF at $70^{\circ} \mathrm{C}$ for 30 min to give the corresponding sodium thiolate, which was then involved in the subsequent alkylation with methyl iodide to produce thiomethyl-cyclodextrin 266 in $76 \%$ yield (Scheme IV-9).

Cyclodextrin 266 underwent the action of DIBAL-H using similar conditions as in the case of thiobenzyl-cyclodextrin $\mathbf{2 6 5}$. After being stirred for 30 min , mass spectrometry showed that di-debenzylated products were the major products. Importantly, at first glance, mass spectrum indicated that the methyl group attached to the sulfur atom was immune to the action of DIBAL-H. By means of chromatographical purification, together with mono-debenzylated cyclodextrin 266a, two di-debenzylated cyclodextrin 266b and 266c were obtained with a ratio of $3: 4$, in $20 \%$ and $26 \%$ yields, respectively (Scheme IV-10).


Scheme IV-10: The action of DIBAL-H on thiomethyl-cyclodextrin

The structures of these isomers were thoroughly characterized by NMR spectroscopy. Cyclodextrin derivative 266b bears a free hydroxyl on the counterclockwise position (sugar unit $\mathbf{B}$ ) to sugar unit $\mathbf{A}$ and another hydroxyl on the diametrically opposed position (sugar

[^56]unit $\mathbf{E}$ ) to sugar unit $\mathbf{B}$. On the contrary, cyclodextrin $\mathbf{2 6 6 c}$ was the pseudo-enantiomer of cyclodextrin 266b, with a hydroxyl on the clockwise position (sugar unit $\mathbf{F}$ ) and another one on the diametrically opposite position (sugar unit C) to the first hydroxyl. The structure of mono-debenzylated cyclodextrin 266a was verified by comparison with product formed by the selective benzylation of thiol group of cyclodextrin 263, indicating that a benzyl group was removed on the diametrically opposed position of sugar unit $\mathbf{A}$.
In order to explain this outcome, we proposed a plausible mechanism. Thiomethyl group has no coordination with aluminum reagents, perhaps because of the weak reaction between the soft base thiomethyl and the hard acid aluminum reagent. Thus the first debenzylation might happen simultaneously on five different positions, i.e. sugar units B, C, D, E and $\mathbf{F}$ to form intermediates Ia, Ib, Ic, Id and Ie (Scheme IV-11). Then due to the steric hindrance caused by the first debenzylation, the following aluminum reagents attach to the diametrically opposed positions. Intermediates $\mathbf{I a}$ and $\mathbf{I b}$ were thus transformed into the same intermediate IIa. Likewise, intermediate IIb was generated by the action of DIBAL-H with intermediates Ic or Id. Finally the hydrolysis gave cyclodextrin derivatives 266b and 266c. For aluminum complex Ie, the debenzylation just stopped at the monol stage because of its opposed thiomethyl group.

To verify this mechanistic proposal, a $C_{2}$-symmetrical cyclodextrin derivative 269 was prepared with two thiomethyl groups on diametrically opposed positions. Using Krief's method ${ }^{136}$, treatment of dithioacetate cyclodextrin 268 with sodium hydride and sequential methylation, gave cyclodextrin 269 with a yield of $60 \%$ in two steps (Scheme IV-12). Alternatively and more efficiently, dimesylated-cyclodextrin 267 , through $\mathrm{S}_{N} 2$ substitution reaction with sodium methanethiolate in DMF, gave yclodextrin 269 in $92 \%$ yield.


Scheme IV-12: Synthesis of dithiomethyl-cyclodextrin 269

Cyclodextrin 269 reacted with DIBAL-H for 10 min , and mass spectrometry showed that mono-debenzylated product and di-debenzylated product were generated. By chromatographical purification and NMR analysis, four products were obtained, two mono-debenzylated isomers 269a and 269b in $10 \%$ and $20 \%$ yields, two di-debenzylated isomers 269c and 269d in $14 \%$ and $24 \%$ yields, respectively (Scheme IV-13).
This reaction proceeded as in the case of thiomethyl-cyclodextrin 266, the first debenzylation reaction occurred on both sides (counterclockwise B and clockwise $\mathbf{F}$ sides) of thiomethyl group, giving mono-debenzylated isomers 269a and 269b, then the formed sterically hindered aluminum species forced the second debenzylation to take place on the diametrically opposed positions $\mathbf{E}$ and $\mathbf{C}$, affording isomeric diols 269c and 269d.


Scheme IV-13: The action of DIBAL-H on dithiomethyl-cyclodextrin

Until now, we disclosed that, 1) thioacetate group can orient the debenzylation on the farthest position due to the formation of the sterically hindered aluminum complex after ester reduction (Figure IV-4); 2) thiol-cyclodextrin behaves towards debenzylation as monol-cyclodextrin owing to the initial deprotonation by DIBAL-H (Figure IV-4); 3) thiomethyl and thiobenzyl are two functions immune to the action of DIBAL-H probably due to the weak interaction between the soft sulfur base and the hard aluminum acid.


Figure IV-4: Site-directing rule based on sulfur-derived cyclodextrins
Aluminum complex was formed either by thioester reduction with DIBAL-H or by DIBAL-H deprotonation of thiol-cyclodextrin.

### 2.3 A new "frustration" strategy based on sulfur-derived cyclodextrins

In Chapter II, we showed a "frustration" strategy ${ }^{106}$ which combined two strategies, using a deoxy or a vinyl function located on the diametrically opposed position to a free hydroxyl or an azido group. By means of this strategy, a tetradifferentiated cyclodextrin with high degree of complexity was reached (a, Figure IV-5). During the study of the action of DIBAL-H on sulfur-derived cyclodextrins, we found that groups $\mathrm{SCH}_{3}$ or SBn substituted benzyloxy group on position 6 were immune to the action of DIBAL-H. Inspired by the precedent "frustration" strategy, we speculated that such a strategy might be also operated on the sulfur-derived cyclodextrins (b, Figure IV-5).

To verify our hypothesis, two sulfur-derived cyclodextrins 266 a and 270 with $\mathrm{SCH}_{3}$ and SBn groups diametrically opposed to a free hydroxyl group were synthesized. Taking advantage of the acidic difference between thiol and hydroxyl ( $\mathrm{pKa} \approx 10$ for SH , and 15 for OH ), using weak base potassium carbonate in DMF, the thiols were selectively deprotonated, this was followed by their alkylations with $\mathrm{CH}_{3} \mathrm{I}$ or BnBr to give cyclodextrins $\mathbf{2 6 6 a}$ and $\mathbf{2 7 0}$ in $55 \%$ and $81 \%$ yields, respectively ${ }^{137}$ (Scheme IV-14). The action of DIBAL-H was then performed on cyclodextrin 266a under usual conditions ( 1 M DIBAL-H, 20 eq., $55^{\circ} \mathrm{C}$ ), when triol-cyclodextrin was the major product monitored by mass spectrometry, the reaction was stopped and chromatographical purification gave a unique product in $60 \%$ yield. To our delight, NMR spectral characterization indicated that a triol cyclodextrin 271 was obtained with two released free alcohols on both sides of thiomethyl function. Likewise, thiobenzyl-derived cyclodextrin $\mathbf{2 7 0}$ also gave the same result, another triol-cyclodextrin 272 in $74 \%$ yield.


Scheme IV-14: Synthesis of triol-cyclodextrins by new "frustration" strategy

Hence, these results expand the previously depicted "frustration" strategy, allowing the access to tridifferentiated cyclodextrins with three alcohols in a very regioselective manner.

## 3. DIBAL-H induced selective functionalization of selenium-derived $\alpha$-cyclodextrins

Some quite encouraging results have been afforded when sulfur-derived cyclodextrins underwent the action of DIBAL-H, allowing to reach different cyclodextrin derivatives. To highlight the versatility of this method, selenoacetate was introduced on the primary rim of cyclodextrin in several steps to see whether it had a similar site-directing effect as in the case

[^57]of thioacetate-cyclodextrin.
A sequence of reactions were carried out to access selenoacetate cyclodextrin. Bromo-cyclodextrin 273 was prepared in $88 \%$ yield by Appel Reaction ${ }^{73}$, using bromine in the presence of triphenylphophine at $60^{\circ} \mathrm{C}$. It was followed by a direct substitution reaction of selenocyanate in DMF, giving cyclodextrin 274 in $80 \%$ yield ${ }^{138}$ (Scheme IV-15).


Scheme IV-15: Synthesis of selenocyanate-cyclodextrin

The selenocyanate 274 was converted into the corresponding selenoacetate 275. By reduction with $\mathrm{LiBEt}_{3} \mathrm{H}$ (super-hydride) followed treatment with acetic anhydride, cyclodextrin 275 was obtained in $51 \%$ yield ${ }^{139}$. Then it was subjected to the action of DIBAL-H, the sole mono-debenzylated product 276 was obtained in $52 \%$ yield (Scheme IV-16). Through the NMR analysis, its structure was elucidated as A-selenol-D-alcohol cyclodextrin 276. Initially, the selenoester was reduced by DIBAL-H, which thereafter induced the debenzylation on the diametrically opposed position. In this case, although with a slightly lower yield, the outcome proved firmly that ester-reduction/debenzylation can be another site-directing method and efficiently applied to the functionalization of cyclodextrins.

We have indicated that, SBn group was immune to the action of DIBAL-H. When cyclodextrin 265 reacted with DIBAL-H, a mixture of inseparable isomers were obtained. Hence, we will study whether SeBn group has a similar behavior with regard to the action of DIBAL-H.
Selenobenzyl-cyclodextrin was synthesized using the same conditions ${ }^{136}$ as in the case of thiomethyl-cyclodextrin 266. Treatment of cyclodextrin 275 in the presence of sodium

[^58]hydride, and followed benzylation with benzyl bromide, gave cyclodextrin 277 in $69 \%$ yield (Scheme IV-17).

Cyclodextrin 277 underwent the action of DIBAL-H under the same conditions ( $1 \mathrm{M}, 20$ eq. $55^{\circ} \mathrm{C}$ ), after being reacted for 45 min , mass spectrum indicated that di-debenzylated products were the major components of the reaction mixture (Scheme IV-18). With the help of NMR characterization, we confirmed that benzyl group attached to selenium atom was untouched during the reaction of DIBAL-H. According to the previously disclosed mechanism, we proposed that the formed diol-cyclodextrins were a pair of pseudo-enantiomers 277a and 277b.

## 4. Conclusion

In conclusion, in this chapter a lot of research work were performed concerning sulfur- and selenium-derived cyclodextrins, and gratifyingly, gave some quite promising results. Besides many sulfur- and selenium-derived cyclodextrins were synthesized in a regioselective fashion, most importantly, two site-directing rules were disclosed:

1) Thioacetate or selenoacetate functions can orient a debenzylation on the farthest position due to the formation of sterically hindered aluminum complex after ester reduction (a, Figure IV-6). As well, thiol-cyclodextrin and selenol-cyclodextrin behavior in debenzylation is similar to that of monol-cyclodextrin owing to the initial deprotonation by DIBAL-H (a, Figure IV-6);
2) On the basis of the immunity of $\mathrm{SCH}_{3}$ or SBn to the action of DIBAL-H, a new "frustration" rule was depicted. The existing hydroxyl can induce a double-debenzylation on both sides of $\mathrm{SCH}_{3}$ or SBn functions (b, Figure IV-6). We believe that this site directing rule can also work on cyclodextrins with the hydroxyl group replaced by an azido group, or $\mathrm{SeCH}_{3}$ and SeBn derived cyclodextrins.

## CHAPTER V

## MULTIDIFFERENTIATION OF $\beta$-CYCLODEXTRIN, TOWARDS HEPTADIFFERENTIATED PATTERNS

## 1. Introduction

Functionalization of $\alpha$-cyclodextrin has progressed in the last decade, especially after the development of DIBAL-H-mediated debenzylation and the attached site-directing rules. Functionalized derivatives displaying up to hexadifferentiated patterns, have been reached and some of them have been used in diverse fields. However, functionalization of $\beta$-cyclodextrin is still a difficult task with few functionalization patterns (Figure V-1) accessible.

The difficulty of functionalization of $\beta$-cyclodextrin is well illustrated by combinatorial calculation. In the case of hexadifferentiation of $\alpha$-cyclodextrin, the combinatorial calculation demonstrates that when six different functional groups are introduced on the primary rim of $\alpha$-cyclodextrin, there are 120 arrangements, while for heptadifferentiation of $\beta$-cyclodextrin, much more arrangements (315 arrangements) are accessible (Figure V-2). Furthermore, the odd number of glucose units in $\beta$-cyclodextrin compared to $\alpha$-cyclodextrin also multiplies the difficulties of the functionalization patterns.


Figure V-2: Hexa- and heptadifferentiated patterns of cyclodextrins

In Chapter III, hexadifferentiation of $\alpha$-cyclodextrin has been fulfilled by well-delineated site-directing rules based on DIBAL-H-mediated debenzylation reaction, which highlighted the versatility of this method. Hence, in this chapter, taking advantage of this method and
combining the available site-directing rules, we envisage the possibility to access $\beta$-cyclodextrin derivatives with higher level of complexity, even towards heptadifferentiated $\beta$-cyclodextrin, with 7 different functional groups on its primary rim.

## 2. The amine strategy

Polydifferentiation of cyclodextrins relies on a single mono-debenzylation during a single DIBAL-H-mediated debenzylation reaction. On this basis, hexadifferentiation of $\alpha$-cyclodextrin has been realized by means of 5 successive debenzylation reactions. However, because of the odd number of glucose units and the bigger size of $\beta$-cyclodextrin, some site-directing rules are not well applicable, such as symmetrical bridge strategy, giving a mixture of regiosiomers ${ }^{111}$. Nevertheless, tandem azide-reduction/debenzylation strategy has proved to be a highly efficient site-directing method for the functionalization of cyclodextrins. Taking advantage of this method, we devised a synthetic strategy to achieve the heptadifferentiation of $\beta$-cyclodextrin (Scheme V-1). Cyclodextrin 158 is synthesized starting from native $\beta$-cyclodextrin 69 through two DIBAL-H-mediated debenzylation reactions ${ }^{104}$. The amine of cyclodextrin 158 could be functionalized by reductive amination ${ }^{140}$ with an aldehyde to form a tertiary amine, which is supposed to be inert to the action of DIBAL-H. Subsequent chemical transformations convert the free alcohol into an azide, would give cyclodextrin 278. Then a tandem azide-reduction/debenzylation (namely third debenzylation) will be performed, affording product 279 with a selective debenzylation on sugar unit $\mathbf{G}$ due to the inertness of the tertiary amine towards DIBAL-H. Subsequently, following a repetitive strategy of reductive amination with different aldehydes, azidation and tandem azide-reduction/debenzylation would afforded the ultimate heptadifferentiated $\beta$-cyclodextrin 280 possessing different amines on its primary rim.

### 2.1 Alkyl chain strategy based on tandem azide-reduction/ debenzylation

According to the devised strategy (Scheme V-I), different aldehydes will be used to transform the primary amines into tertiary inert ones. In this part, different aldehydes with straight alkyl chains were chosen.
Monoazido- $\beta$-cyclodextrin 156 was prepared according to our previously reported procedures ${ }^{104}$ : mesylation of $\beta$-monol cyclodextrin 131 and followed azidation. It was then submitted to the action of DIBAL-H, giving an inseparable mixture ( $\mathbf{1 5 8} \mathbf{- M}$ ) of amino-alcohol cyclodextrins in $89 \%$ yield with a ratio of $4: 1$ (Scheme V-2). This outcome was attributed to the odd number of glucose units of $\beta$-cyclodextrin. After protection of the amine with alkyls, the regioisomers could be isolated. The amine was protected by reductive amination ${ }^{140}$ with valeric aldehyde and $\mathrm{NaBH}(\mathrm{OAc})_{3}$ as the reducing agent, affording the major AD -isomer 281 (Scheme V-2).

As we mentioned in the synthetic strategy, cyclodextrin 281 was then converted into azido-cyclodextrin 282 in $78 \%$ yield (Scheme V-3). The following azide-reduction debenzylation would give D-amino-G-alcohol-cyclodextrin 284. Consequently, cyclodextrin 282 underwent the action of DIBAL-H under the usual conditions ( 20 equivalents of DIBAL-H, $1 \mathrm{~mol} / \mathrm{L}, \quad 55^{\circ} \mathrm{C}$ ). However, the reaction did not give the expected amino-alcohol-cyclodextrin, but rather get stuck at the azide-reduction stage. Rising the reaction conditions to 40 equivalents of DIBAL-H, afforded the unexpected amino-alcohol-cyclodextrin 283 in $56 \%$ yield (Scheme V-3).

Its structure was elucidated by a typical NMR characterization procedure: as shown in Figure V-3. Firstly, all the C-1s and H-1s were identified through HSQC with characteristic chemical shifts of the acetal carbons around 100 ppm (Figure V-3a). As shown in Figure V-3b, sugars $\mathbf{D}$ and $\mathbf{F}$ were identified through their C-6D and C-6F characteristically upfield shifted ( 43 and 60 ppm respectively, compared to 30 ppm ). Combining COSY and TOCSY 2D experiments, all the other protons of each unit were attributed since we identified all the H-1s. For example, Figure V-3c showed all the protons of sugars A and D. In sugar A, NOESY indicated a cross-correlation between H-6A and the secondary protons of pentyl groups (Figure V-3d). The correlations between C-6B, C-6C, C-6E, C-6G and their benzylic protons were observed in HMBC (Figure V-3e). Once all the protons of cyclodextrin were attributed, the order of all sugar cycles is determined through NOESY cross coupling between H-4s and H-1s of adjacent sugar units (Figure V-3f). Surprisingly, NOESY spectrum demonstrated that, the debenzylation did not occur on sugar unit $\mathbf{G}$, but on sugar unit $\mathbf{F}$. The steric hindrance and the flexibility of dipentyl chains might explain this result, hampered the debenzylation on sugar unit $\mathbf{G}$, adjacent to sugar unit $\mathbf{A}$.

The amine on tertadifferentiated $\beta$-cyclodextrin 283 was protected with ethyl groups by reductive amination using acetaldehyde, giving cyclodextrin 285 in $74 \%$ yield. It was followed by mesylation and azidation to afford azido-cyclodextrin 286 (Scheme V-4), which was subjected to further tandem azide-reduction/debenzylation reaction.

Cyclodextrin 286 was reacted with 40 equivalents of DIBAL-H at $55^{\circ} \mathrm{C}$ (Scheme V-5) and followed by mass spectrometry. The azide was reduced completely in 15 min , but after 45 min we did not observe any debenzylated product. Therefore, another 20 equivalents of DIBAL-H was added and after another 45 min , mass spectrometry indicated that, amino-cyclodextrin 287 was still the major product, together with traces of debenzylated product. To explain this result, we supposed that the introduction of pentyl and ethyl groups (286-I) might prevent the debenzylation because of their steric hindrance and flexibilities.

Hence, based on the obtained results, the introduction of larger linear alkyl chains might prevent adjacent debenzylation due to their steric hindrance and flexibilities.

### 2.2 Less hindered linear alkyl-amines and cyclic amines combined strategy

Linear alkyl chains produce an important steric hindrance because they can rotate freely, which might disturb the debenzylation on the primary rim of $\beta$-cyclodextrin. To overcome this problem, in this section fomaldehyde and glutaraldehyde were employed to form the less
hindered dimethyl protected amine or less flexible $N$-piperidine ring, which could facilitate the further tandem azide-reduction/debenzylation.
So amino-alcohol cyclodextrins 158 -M were modified by reductive amination using formaldehyde, giving AD-isomer 288 in $65 \%$ yield (Scheme V-6). Cyclodextrin 289 was prepared for the subsequent debenzylation reaction by the mesylation and azidation of cyclodextrin 288.

Cyclodextrin 289 underwent DIBAL-H-mediated debenzylation under the same conditions as in the case of dipentyl-cyclodextrin 282 (Scheme V-3), giving cyclodextrin 290 in $68 \%$ yield (Scheme V-7).

Its structure was confirmed by NMR spectral analysis (Figure V-4) as did in the case of cyclodextrin 283. The results demonstrated that debenzylation reaction took place on sugar unit $\mathbf{G}$ as we imagined, probably due to the lesser steric hindrance of methyl groups on sugar unit $\mathbf{A}$, compared to pentyl groups in cyclodextrin 282.

With cyclodextrin 290 in hand, a sequence of chemical transformations: reductive amination by glutaraldehyde, mesylation and azidation, gave azido-cyclodextrin 292 (Scheme V-8).

The tandem azide-reduction/debenzylation was then performed on cyclodextrin 292 (Scheme V-9). Initially, 50 equivalents of DIBAL-H was employed. After 30 min , mass spectrometry showed that amino-cyclodextrin 293 was the major product with traces of debenzylated product 294. Therefore, same amount of DIBAL-H was added and after another 1 h , the reaction did not progress. Finally, even total addition of 150 equivalents of DIBAL-H, amino-cyclodextrin 293 was still the major product. In this case, the steric hindrance of piperidine ring might be the reason that prevented the debenzylation.

Since piperidine ring on sugar unit D probably hampered the debenzylation (Figure V-5a), a new synthetic strategy was devised, switching the protection order of amines, i.e. using methyl as the protection for sugar unit $\mathbf{D}$, and piperidine ring for sugar unit $\mathbf{A}$ (Figure V-5b). Thus, the dimethyl protected amine on sugar unit $\mathbf{D}$ has less hindrance which might favor the subsequent debenzylation on sugar unit $\mathbf{C}$.

Cyclodextrin 296 (Scheme V-10) with piperidine ring was prepared in a sequence of reductive amination by glutaraldehyde, mesylation and azidation.

Subsequently, cyclodextrin 296 bearing an azide on sugar unit $\mathbf{D}$ was subjected to the action of DIBAL-H (Scheme V-11) under the conditions ( $1.0 \mathrm{M}, 50$ equivalents of DIBAL-H, $55^{\circ} \mathrm{C}$ ) as did in the case of cyclodextrin 282 (Scheme V-3). Mass spectrometry was employed to monitor the reaction process, demonstrating that amino-monol-cyclodextrin 297 was the major product together with amino-cyclodextrin and amino-diol-cyclodextrin. Because of the similar polarities of these three products, the pure product was isolated only after the Boc protection of the amine. Finally, removal of Boc group gave the desired cyclodextrin 297 with $25 \%$ yield in 3 steps.

The structure of cyclodextrin 297 was characterized as well by means of NMR spectroscopy, indicating that the debenzylation proceeded on sugar unit $\mathbf{G}$ as in the case of cyclodextrin 290 (Scheme V-7). As we supposed, larger linear alkyl chain (Figure V-5a) hampers the debenzylation on the clockwise adjacent position. In contrast, the less sterically hindered alkyl groups (Figutre V-5b, c) favor this kind of debenzylation.

The free amine of cyclodextrin 297 was then protected by methyl groups, and the free alcohol was transformed into an azide using conventional procedures to give cyclodextrin 298 (Scheme V-12). Afterwards, another tandem azide-reduction/debenzylation was attempted on cyclodextrin 298. Initially, 50 equivalents of DIBAL-H was employed. Frustratingly, as in the case of cyclodextrin 292, after 30 min , amino-cyclodextrin 299 was the major product with traces of debenzylated product. Another 50 equivalents of DIBAL-H was added and after another 1 h , the major product remains the amino-cyclodextrin 299, together with traces of amino-alcohol cyclodextrin. In the case of cyclodextrin 292 (dimethyl protection firstly), we attributed the frustration of debenzylation to the steric hindrance of the piperidine ring. We envisaged that the less hindered dimethyl group for the protection of amine on sugar unit $\mathbf{D}$ would favor the debenzylation reaction on sugar unit $\mathbf{C}$, diametrically opposed to unit $\mathbf{G}$. However, beyond our expectation, the debenzylation reaction was still unfavorable even under harsh conditions.

On the basis of the obtained results, we came to the conclusion that multi-alkyl protected amine strategies cannot afford expected heptadifferentiation on $\beta$-cyclodextrin. Instead, it gave the tetradifferentiated motif (Figure V-6). At the outset, we attributed this frustration to the steric hindrance and flexible rotation of the linear alkyl chains (pentyl or ethyl in Figure V-6a). However, when less sterically hindered methyl or less flexible piperidine ring (Figure V-6b and V-6c) were introduced, the same problem still existed. To explain this outcome, we envisage that, the lone electron pairs of the amine probably coordinate with DIBAL-H (Figure V-6d), increasing the whole hindrance on the primary rim of $\beta$-cyclodextrin, which is unfavorable to the further DIBAL-H-mediated debenzylation.

## 3. The thioether strategy

The amine-protection strategy is a dead-end towards heptadifferentiation of $\beta$-cyclodextrin, probably due to steric hindrance (in the case of dipentyl-amino-cyclodextrin 282) caused by the introduced protecting groups or coordination of aluminum reagents by the amines. To solve this problem, new functionalities are neccessary, which need to meet some requirements: 1) new functionalities have the capability of orienting debenzylation
regioselectively; 2) protecting groups must be less sterically hindered and immune to the action of DIBAL-H. In Chapter IV, we have shown that SAc group can induce debenzylation regioselectively (Figure $\mathrm{V}-7 \mathrm{a}$ ), and that $\mathrm{SCH}_{3}$ and SBn are immune to the action of DIBAL-H (Figure V-7b). Therefore, these site-directing groups could be applied on $\beta$-cyclodextrin to reach heptadifferentiation of $\beta$-cyclodextrin.

As usually, first debenzylation gave monol- $\beta$-cyclodextrin 131 in an excellent yield, which was then converted into thioacetate-cyclodextrin $\mathbf{3 0 0}$ in $93 \%$ yield (Scheme V-13). Cyclodextrin 300 underwent thioester-reduction/debenzylation to give an inseparable mixture ( $\mathbf{3 0 0} \mathbf{- M}$ ) of thiol-monol-cyclodextrin isomers in $72 \%$ yield, with a ratio of $2: 1$ on the basis of ${ }^{1} \mathrm{H}$ NMR analysis. In this case, asymmetry of $\beta$-cyclodextrin accounted for the formation of two regioisomers.

Since a mixture of cyclodextrin isomers was obtained, the free thiols of the two isomers were then protected using methyl iodide under weak basic conditions in $86 \%$ yield (Scheme V-14). It was followed by mesylation and subsequent thioacetate anion substitution to give a mixture (302-M) of cyclodextrin isomers in $85 \%$ yield, possessing site-directing group SAc on sugar unit $\mathbf{D}$ or $\mathbf{E}$. During each step of the chemical transformations, the regioisomeric products were submitted to chromatographical purification, trying to get a single pure product. To our disappointment, these two regioisomers could not be isolated.

The mixture of thioacetate cyclodextrins was subjected to the action of DIBAL-H (Scheme V-15). Gratifyingly, two pure mono-debenzylated products 301a and 301b were obtained, together with an inseparable mixture of thiol-cyclodextrins (20\%), which can also be used to prepare cyclodextrin 301a and 301b.

The structures of cyclodextrins 301a and 301b were elucidated by NMR analysis, demonstrating that cyclodextrin 301a was the isomer with a thiol and an alcohol on sugar units $\mathbf{D}$ and $\mathbf{G}$, respectively. Correspondingly, cyclodextrin 301b was the product with a thiol and an alcohol on sugar units $\mathbf{E}$ and $\mathbf{B}$. Based on this, it was reconfirmed that thioester-mediated debenzylation happened on the farthest position because of steric hindrance induced by ester reduction (Figure V-8).

The free thiol of tetradifferentiated cyclodextrin 301a was then benzylated in $78 \%$ yield (Scheme V-16). The followed mesylation and thioacetate anion substitution gave cyclodextrin 303a with a SAc group on sugar unit $\mathbf{G}$ to direct another thioester-reduction/debenzylation. The same chemical transformation performed on cyclodextrin 301b, giving cyclodextrin 303b with a SAc group on sugar unit B (Scheme V-16)

Introduction of a new SAc group would orient a regioselective debenzylation according to our previously established rule. Consequently, cyclodextrin 303a was submitted to the action of DIBAL-H. After 30 min , mass spectrometry demonstrated that mono-debenzylated product 304a was the major product, together with thiol-cyclodextrin 305a and a mixture of di-debenzylated products (Scheme V-17). As shown before, regioselectivity of this reaction can be explained by the formation of 303a-I after ester reduction. Although the yield of
cyclodextrin 304a is slightly lower, at least this reaction does work. We believe that the yield can be increased by controlling the reaction time.

The structure of cyclodextrin 304a was well characterized by typical NMR characteristically procedures (Figure V-9), demonstrating that the benzyl group was removed on sugar unit $\mathbf{C}$. Cyclodextrin 303b underwent the action of DIBAL-H, giving another pentadifferentiated cyclodextrin 304b (Scheme V-18) with removal of a benzyl group on sugar unit $\mathbf{F}$ because of the formation of hindered aluminum derivative and the immunity of SBn group to DIBAL-H (303b-I).

## 4. Conclusion

In this chapter, much efforts have been paid to polydifferentiate $\beta$-cyclodextrin, towards its heptadifferentiation. Two strategies were employed:

1) Based on tandem azide-reduction/debenzylation and using alkyl groups as the protection of the formed amine, only tetradifferentiated $\beta$-cyclodextrins (Figure V-10) were obtained. Further DIBAL-H-mediated debenzylations were prevented. We attributed these results to the coordination between lone electron pairs on nitrogen atoms and aluminum reagents (Figure V-10a).

2) To overcome this problem, another strategy was devised. In Chapter IV, we developed a new site-directing strategy, namely thioester-reduction/debenzylation. It is also well applicable to the functionalization of $\beta$-cyclodextrin. Using this site-directing rule and appropriate protecting groups, some different derivatives, even more complicated pentadifferentiated $\beta$-cyclodextrins $\mathbf{3 0 4 a}$ and $\mathbf{3 0 4 b}$ were synthesized, which was unreached before. In the future, the obtained cyclodextrin 304a should be subjected to two successive tandem thioester-reduction/debenzylations (Scheme V-19), to give the ultimate heptadifferentiated $\beta$-cyclodextrin 309a with 7 different chemical groups on its primary rim. By using similar methods, another regioisomeric heptadifferentiated cyclodextrin 309b could also be afforded starting from pentadifferentiated cyclodextrin 304b.

## GENERAL CONCLUSION

In this thesis, we aimed at the complete differentiation of $\alpha$ and $\beta$-cyclodextrins. We already realized: hexadifferentiation of $\alpha$-cyclodextrin, and establishment of new site-directing rules based on sulfur- and selenium-derived cyclodextrins. Finally, polydifferentiation of $\beta$-cyclodextrin was studied, which opens a route towards heptadifferentiated pattern.

Based on the DIBAL-H-mediated debenzylation, combining the previously delineated site-directing rules, unprecedented penta- and ultimate hexadifferentiated $\alpha$-cyclodextrins (Figure G-1) were reached. Further chemical transformations gave two regioisomeric products with six orthogonal functions: amine, alkene, azide, alcohol, ether and chloride.

Then in Chapter IV, a detailed study was performed on the action of DIBAL-H on sulfur- and selenium-derived cyclodextrins. Two new site-directing reactions were established:

1) Thio/selenoester-reduction/debenzylation (Figure G-2a). Thioacetate or selenoacetate has the capability to orient the debenzylation on the farthest position because of the formation of sterically hindered aluminum complexes after ester reduction;
2) New "frustration" strategy (Figure G-2b) based on the immunity of thioether to the action of DIBAL-H. Substituting a benzyloxy group on the diametrically opposed position of a hydroxyl group with a thioether, the existing hydroxyl can induce a double-debenzylation on both sides of the thioether.

Last, in Chapter V, polydifferentiation of $\beta$-cyclodextrin was studied, and some patterns (Figure G-3) with higher level of complexity were accessed. Concerning the heptadifferentiation of $\beta$-cyclodextrin, initially, tandem azide-reduction debenzylation was employed and different aldehydes were used for the protection of the amine. However, multi-alkyl protected amine strategies cannot give heptadifferentiated pattern possibly due to the coordination between lone pair electrons on nitrogen atoms and aluminum reagents (Figure G-4a). Nevertheless, using sulfur-derived site-directing strategy, some encouraging results were obtained, giving pentadifferentiated $\beta$-cyclodextrins unreached before. We believed that using this strategy, the ultimate heptadifferentiated $\beta$-cyclodextrins (Figure G-4b) with thioethers on its primary rim should be realized.

## 2. Characteristic analysis of hexadifferentiated a-cyclodexrtin 246 by NMR spectroscopy

Complete attribution was done as explained hereafter on the hexa-differentiated a-cyclodextrin in $\mathrm{CDCl}_{3}$ at 600 MHz and 300 K using ${ }^{1} \mathrm{H},{ }^{13} \mathrm{C}$, DEPT 135, HSQC, 2D COSY, 2D TOCSY, 2D NOESY and HMBC.

1. First, the H-1s protons were attributed using HSQC cross-correlation with C-1s whose chemical shifts are characteristic (ca. 100 ppm ).

4. Using HMBC cross-correlation, the allylic protons on the bridge can be determined by the correlations between the C-6F, C-6C and the protons respectively (Figure A-10). Besides, the correlation with the terminal alkene carbon can also attribute the allylic protons (Figure A-11). For the glycosidic unit F and D with the benzyl groups, they can be identified in HMBC by the correlation between the C-6 and the benzylic protons (Figure A-12)

Furthermore, it can be verified by cross-correlation between $\mathrm{C}-1 \mathrm{~s}$ and their vicinal $\mathrm{H}-4 \mathrm{~s}$ in HMBC .

## EXPERIMENTAL PART

## General information

Dichloromethane was freshly distilled from $\mathrm{P}_{2} \mathrm{O}_{5}$, toluene from sodium and THF from sodium/benzophenone. Reactants were purchased from commercial sources and used without further purification. HRMS were recorded on a Bruker microTOF spectrometer, using Tuning-Mix as reference. Optical rotations were measured on a Perkin-Elmer 341 digital polarimeter or a Jasco P-2000 polarimeter with a path length of 1 dm . NMR spectra were recorded on a Brüker Avance II 600 MHz or Brüker AM- 400 MHz using residual $\mathrm{CHCl}_{3}$ signal as internal reference $\left(\delta\left({ }^{1} \mathrm{H}\right)=7.26 \mathrm{ppm}\right.$ and $\left.\delta\left({ }^{13} \mathrm{C}\right)=77.16 \mathrm{ppm}\right)$. Assignments were aided by COSY, HSQC, NOESY, TOCSY and HMBC experiments.

DIBAL-H ( 1.5 M in toluene, $3.4 \mathrm{~mL}, 5.05 \mathrm{mmol}, 15$ eq.) was slowly added to a solution of bridge-a-cyclodextrin $243(800 \mathrm{mg}, 0.34 \mathrm{mmol}$, 1 eq.) in toluene ( 1.69 mL ) under nitrogen at r.t. The reaction mixture was stirred under nitrogen reflux at $45^{\circ} \mathrm{C}$. The formation of the monol as the major product was monitored by TLC ( 30 min ). Heating was stopped, diethyl ether ( 45 mL ) was added and the mixture was cooled down to $0^{\circ} \mathrm{C}$. $\mathrm{NaH}(60 \% \mathrm{w} / \mathrm{w}$ in oil, $13 \mathrm{mg}, 0.32 \mathrm{mmol}, 8$ eq.) was added to a solution of a-cyclodextrin 248 ( $100 \mathrm{mg}, 0.04 \mathrm{mmol}, 1$ eq.) in DMF $(1.5 \mathrm{~mL})$ under nitrogen at $0^{\circ} \mathrm{C}$. The reaction mixture was stirred for 30 min , then $\mathrm{CH}_{3} \mathrm{I}(5 \mu \mathrm{~L}, 0.08 \mathrm{mmol}, 2$ eq.) was added dropwise. A solution of $\mathrm{Boc}_{2} \mathrm{O}$ ( $11 \mathrm{mg}, 0.05 \mathrm{mmol}, 2$ eq.) in ethanol absolute $(0.5 \mathrm{~mL})$ was added to a solution of hexa-differentiated a-cyclodextrin 246 ( $56 \mathrm{mg}, 0.025 \mathrm{mmol}, 1$ eq.) in $\mathrm{CH}_{2} \mathrm{Cl}_{2}(2.0 \mathrm{~mL})$ at r.t.. The reaction mixture was stirred for 2 h , then evaporated under reduce pression. Silica gel flash chromatography of the residue ( $\mathrm{CyH} / E t O A c$ 4:1) gave the product 257 ( $43 \mathrm{mg}, 74 \%$ ) as a white foam.
Thionyl chloride ( $2 \mu \mathrm{~L}, 0.029 \mathrm{mmol}, 1.5$ eq.) was added to a solution of a-cyclodextrin 257 (43 $\mathrm{mg}, 0.019 \mathrm{mmol}, 1$ eq.) in pyridine ( 2 mL ) at r.t.. The reaction mixture was stirred at the same temperature overnight. Water ( 10 mL ) and EtOAc ( 10 mL ) were added, then the organic phase was extracted with $\mathrm{HCl}(1 \mathrm{M})$ and sat. $\mathrm{NaHCO}_{3}$. The combined organic layers were dried with $\mathrm{MgSO}_{4}$, filtered and concentrated. Silica gel chromatography column ( $\mathrm{CyH} / \mathrm{EtOAc}$ $5 / 1$ ) gave the a-cyclodextrin $258(20 \mathrm{mg}, 46 \%)$ as a white foam.

$\mathrm{Pd}^{0}\left(\mathrm{PPh}_{3}\right)_{4}(3 \mathrm{mg}, 0.002 \mathrm{mmol}, 0.3$ eq.) was added to a solution of cyclodextrin 258 ( $20 \mathrm{mg}, 0.008 \mathrm{mmol}, 1$ eq.) in degassed THF ( 2 mL ) at r.t. under argon, then a 1 M solution of anhydrous $\mathrm{ZnCl}_{2}$ in THF $(0.36 \mathrm{~mL}, 0.36 \mathrm{mmol}, 45$ eq.) was added and the reaction mixture was stirred for 10 min . After addition of $\mathrm{Et}_{3} \mathrm{SiH}(0.58 \mathrm{~mL}, 0.36$ $\mathrm{mmol}, 45$ eq.), the reaction mixture was refluxed at $80^{\circ} \mathrm{C}$ under argon overnight, diluted with EtOAc ( 5 mL ), poured on water ( 5 $\mathrm{mL})$. Layers were separated and the aqueous layer was extracted with EtOAc ( $3 \times 5 \mathrm{~mL}$ ). The combined organic layers were dried with $\mathrm{MgSO}_{4}$, filtered and concentrated. After removal of the solvent, the residue was diluted with water ( 5 mL ), acidified with $\mathrm{HCl}(1 \mathrm{M})$ and extracted with EtOAC ( $3 \times 5 \mathrm{~mL}$ ). The combined organic layers were dried with $\mathrm{MgSO}_{4}$, filtered and concentrated. Silica gel chromatography column (CyH/EtOAc 5/1) gave azido- $\alpha$-cyclodextrin $\mathbf{2 6 0}(6 \mathrm{mg}, 60 \%$ ) as a white foam.

Aqueous $\mathrm{HCl}(5 \mathrm{~mL}, 1 \mathrm{M})$ and $\operatorname{EtOAc}(5 \mathrm{~mL})$ were added, and the solution was stirred for 1 h . The aqueous layer was extracted with EtOAc ( $3 \times 5 \mathrm{~mL}$ ). The combined organic layers were dried over $\mathrm{MgSO}_{4}$, filtered, and concentrated in vacuum. Silica gel chromatography of the residue ( $\mathrm{CyH} / \mathrm{EtOAc}$ : 4/1) gave mono-debenzylated cyclodextrin 266a ( $9 \%$ ), BE-diol-cyclodextrin 266b ( $30 \mathrm{mg}, 20 \%$ ) and CF-diol-cyclodextrin 266c ( 35 mg , $26 \%$ ) as yellowish foams.

 Potassium carbonate ( $49 \mathrm{mg}, 0.357 \mathrm{mmol}, 3$ eq.) was added to a
 solution of thiol-monol-cyclodextrin $\mathbf{2 6 3}$ ( $290 \mathrm{mg}, 0.119 \mathrm{mmol}, 1 \mathrm{eq}$. in anhydrous DMF ( 5 mL ) under nitrogen at $0^{\circ} \mathrm{C}$. Methyl iodide $(0.022 \mathrm{~mL}, 0.357 \mathrm{mmol}, 3$ eq.) was added, and the reaction mixture was stirred for 2 h at r.t.. Until the TLC showed the reaction finished, Water ( 10 mL ) was added and the aqueous phase was extracted with $\mathrm{EtOAc}(3 \times 10 \mathrm{~mL}$ ). The combined organic layers were dried over $\mathrm{MgSO}_{4}$, filtered and concentrated. Silica gel flash chromatography of the residue ( $\mathrm{CyH} / \mathrm{EtOAc}: 4 / 1$ ) gave thiomethyl- $\alpha$-cyclodextrin 266a (160 $\mathrm{mg}, 55 \%$ ) as a yellowish foam.

DIBAL-H ( 1.5 M in toluene, $1.9 \mathrm{~mL}, 2.86 \mathrm{mmol}, 20$ eq.) was added to a solution of selenobenzyl-cyclodextrin 277 ( $379 \mathrm{mg}, 0.143 \mathrm{mmol}, 1$ eq.) in toluene ( 0.9 mL ) under nitrogen at r . t. The reaction mixture was stirred at $55^{\circ} \mathrm{C}$ with a nitrogen balloon reflux for 45 min , until Mass spectrum indicated formation of diol as a major product, and then cooled to r.t. and poured into ice/water. Aqueous $\mathrm{HCl}(5 \mathrm{~mL}, 1 \mathrm{M})$ and $\operatorname{EtOAc}(5 \mathrm{~mL})$ were added, and the solution was stirred for 1 h . To a solution of cyclodextrin $281(4.0 \mathrm{~g}, 1.34 \mathrm{mmol}, 1 \mathrm{eq}$.$) in$ pyridine ( 30 mL ) were added DMAP ( $327 \mathrm{mg}, 2.68 \mathrm{mmol}, 2$ eq.) and $\mathrm{MsCl}(416 \mu \mathrm{~L}, 5.36 \mathrm{mmol}, 4 \mathrm{eq}$.) at r.t. The reaction mixture was stirred for 2 h under nitrogen, then the solvent was reduced to dryness. The crude was dissolved in $\mathrm{CH}_{2} \mathrm{Cl}_{2}(30 \mathrm{~mL})$ and washed with water ( 30 mL ), then the aqueous layers were extracted with $\mathrm{CH}_{2} \mathrm{Cl}_{2}(3 \times 30 \mathrm{~mL})$. The combined organic layers were dried over MgSO 4 , filtered and concentrated. Silica gel flash chromatography ( $\mathrm{CyH} / \mathrm{EtOAc} 5 / 1$ ) afforded cyclodextrin 281a ( $4.1 \mathrm{~g}, 97 \%$ ) as a white foam.

DMAP ( $30 \mathrm{mg}, 0.246 \mathrm{mmol}, 2$ eq.) was added to a solution of dipentyl-diethyl-alcohol- $\beta$-cyclodextrin 285 ( $363 \mathrm{mg}, 0.123 \mathrm{mmol}$, 1 eq.) in pyridine ( 5 mL ) at r.t.. Then $\mathrm{MsCl}(38 \mu \mathrm{~L}, 0.492 \mathrm{mmol}, 4$ eq.) was added. The reaction mixture was stirred at r.t. for 2 h under nitrogen. TLC ( $\mathrm{CyH} / \mathrm{EtOAc}: 2 / 1$ ) showed that the reaction was finished. The solvent was removed in vacuuo. The residue was dissolved in $\mathrm{CH}_{2} \mathrm{Cl}_{2}(10 \mathrm{~mL})$, washed with water $(5 \mathrm{~mL})$. The aqueous layers were extracted by $\mathrm{CH}_{2} \mathrm{Cl}_{2}(3 \times 10 \mathrm{~mL})$. The combined organic layers were dried over $\mathrm{MgSO}_{4}$, filtered and concentrated. After dried in vacuum, $\beta$-cyclodextrin ( $240 \mathrm{mg}, 64 \%$ ) was obtained as a white foam.

Sodium azide ( $67 \mathrm{mg}, \quad 1.035 \mathrm{mmol}, 5$ eq.) was added to a solution of dipentyl-diethyl-mesylated-cyclodextrin ( $628 \mathrm{mg}, 0.207 \mathrm{mmol}, 1$ eq.) in DMF ( 10 mL ) at r.t.. The reaction mixture was stirred at $80^{\circ} \mathrm{C}$ for 3 h under nitrogen. TLC ( $\mathrm{CyH} / \mathrm{EtOAc}$ : 2/1) showed that the reaction was finished, then the heating was stopped and the solvent was removed in vacuum. The residue was dissolved in EtOAc ( 20 mL ), washed with water ( 10 mL ). The aqueous layers were extracted by EtOAc ( $3 \times 20 \mathrm{~mL}$ ). The combined organic layers were dried over $\mathrm{MgSO}_{4}$, filtered and concentrated. Silica gel flash chromatography ( $\mathrm{CyH} / \mathrm{EtOAc}$ : $4 / 1)$ afforded $\beta$-cyclodextrin 286 ( $440 \mathrm{mg}, 71 \%$ ) as a white foam.

The reaction mixture was stirred at r.t. for 2 h under nitrogen. Water $(30 \mathrm{~mL})$ was added and the aqueous layers were extracted by dichloromethane $(3 \times 30 \mathrm{~mL})$. The combined organic layers were dried over $\mathrm{MgSO}_{4}$, filtered and concentrated. Silica gel flash chromatography ( $\mathrm{CyH} / \mathrm{EtOAc}$ : 3/1, then $2 / 1$ ) afforded mesylated cyclodextrin ( $1.8 \mathrm{mg}, 83 \%$ ) as a white foam.

To a solution of previously formed mesylated cyclodextrin ( $1.8 \mathrm{~g}, 0.610 \mathrm{mmol}, 1$ eq.) in DMF $(20 \mathrm{~mL})$ were added $\mathrm{NaN}_{3}(159 \mathrm{mg}, 2.440 \mathrm{mmol}, 4 \mathrm{eq}$.) at r.t. The reaction mixture was stirred for 5 h at $80^{\circ} \mathrm{C}$ under nitrogen, then the solvent was reduced to dryness. The crude was dissolved in EtOAc ( 20 mL ) and washed with water $(20 \mathrm{~mL})$. Then the aqueous layers were extracted with EtOAc ( $3 \times 20 \mathrm{~mL}$ ). The combined organic layers were dried over $\mathrm{MgSO}_{4}$, filtered and concentrated. The reaction mixture was stirred at $80^{\circ} \mathrm{C}$ overnight under nitrogen. TLC ( $\mathrm{CyH} / \mathrm{EtOAc}$ : 2/1) showed that the reaction was finished, then the heating was stopped and the solvent was removed in vacuum. Formaldehyde ( $0.060 \mathrm{~mL}, 0.792 \mathrm{mmol}, 4 \mathrm{eq}.), \mathrm{NaBH}(\mathrm{OAc})_{3}(252$ $\mathrm{mg}, 1.188 \mathrm{mmol}, 6$ eq.) and $\mathrm{AcOH}(0.011 \mathrm{~mL}, 0.198 \mathrm{mmol}, 1$ eq.) were added to a solution of cyclodextrin $297(558 \mathrm{mg}, 0.198 \mathrm{mmol}$, 1 eq.) in DCM ( 10 mL ) under nitrogen at r.t. Triethylamine ( $0.125 \mathrm{~mL}, 0.896 \mathrm{mmol}, 2$ eq.) followed by methanesulfonyl chloride ( $0.070 \mathrm{~mL}, 0.896 \mathrm{mmol}, 2$ eq.) was added to a solution of cyclodextrins $301-\mathrm{M}(1.29 \mathrm{~g}, 0.448 \mathrm{mmol}, 1$ eq.) in DCM ( 20 mL ) under nitrogen at r . t. The reaction mixture was stirred at r.t. for 1 h 30 min . Water ( 20 mL ) was added, and the aqueous layer was extracted with dichloromethane $(3 \times 20$ mL ). The combined organic layers were dried over $\mathrm{MgSO}_{4}$, filtered, concentrated in vacuum and dried in oil pump to give the mesylated-cyclodextrins ( 1.3 g ) as yellowish foams.

DIBAL-H (1.5 M in toluene, $26.1 \mathrm{~mL}, 38.6 \mathrm{mmol}, 20 \mathrm{eq}$.) was added to a solution of cyclodextrin $\mathbf{3 0 2 - M}(5.7 \mathrm{~g}, 2.342 \mathrm{mmol}, 1$ eq.) in toluene ( 12.5 mL ) under nitrogen at r. the reaction mixture was stirred at $55^{\circ} \mathrm{C}$ with a nitrogen balloon reflux for 20 min , until Mass spectrum indicated formation of monol as a major product, and then cooled to r.t. and poured into ice/water. Aqueous $\mathrm{HCl}(70 \mathrm{~mL}, 1 \mathrm{M})$ and $\mathrm{EtOAc}(70 \mathrm{~mL})$ were added, and the solution was stirred for 1 h . The aqueous layer was extracted with EtOAc ( $3 \times 70 \mathrm{~mL}$ ). The combined organic layers were dried over $\mathrm{MgSO}_{4}$, filtered, and concentrated in vacuum.
