#### Abstract

Connectivity is expected to strongly influence the dynamics and persistence of marine Studying the development and maintenance of connectivity patterns populations. among marine populations is, thus, essential for spatial planning and the proper design and management of Marine Protected Areas (MPAs). However, understanding the complex processes driving marine population connectivity requires the use of tools that integrate bio-physical models with information regarding the demographic and genetic linkages resulting from the larval exchange among populations. Therefore, the aim of this PhD dissertation is to evaluate the patterns of genetic connectivity among gorgonian populations at a regional scale, and disentangle the processes that shape the observed connectivity by using model simulations accounting for hydrological, demographic and genetic connectivity. The first chapter presents a spatially explicit metapopulation model that, using stochastic connectivity matrices, assesses the effect of demography on allele frequencies in a marine metapopulation of sessile benthic species. The model is then used to evaluate the effect of demographic traits and connectivity structure on the genetic diversity of a marine metapopulation. The second chapter examines the patterns of genetic connectivity of two common and widely distributed gorgonian species at a regional scale: Paramuricea clavata in the Ligurian Sea, and Eunicella singularis in the Gulf of Lions. Both species exhibit strong patterns of genetic structure at a regional scale, although the dispersal capacity of each species does not seem limited (>100 m). The third chapter discerns among the potential processes shaping the realized connectivity of E. singularis in the Gulf of Lions by applying the model presented in Chapter 1, and comparing the modeled patterns of genetic structure to the results obtained from empirical genetic data in Chapter 2. Modeled and empirical results show similar patterns of genetic structure among populations of E. singularis in the region. Genetic and demographic differentiation among populations is demonstrated to result from the spatial structure of dispersal alone. The ability to evaluate the expected development of genetic structure among populations under different demographic and hydrological scenarios using the seascape model presented in Chapter 1 provides a useful tool with relevance for marine spatial planning and the persistence of marine populations.

#### Résumé

La connectivité est supposée influencer fortement la dynamique et la pérennité des populations d'organismes marins. Ainsi, étudier l'évolution et le maintien des patrons de connectivité au sein des populations marines semble essentiel pour la planification spatiale, la création et la gestion des Aires Marines Protégées (AMP). Cependant, comprendre la complexité des processus régissant la connectivité entre les populations marines nécessite l'utilisation d'outils, qui associent des modèles biophysiques et des informations caractérisant les relations entre démographie et génétique, résultant des échanges larvaires entre les populations. L'objectif de cette thèse de doctorat est donc, d'évaluer les patrons de connectivité génétique au sein des populations de gorgones à une échelle régionale et d'explorer les processus induisant la connectivité observée, grâce à des simulations de modèles prenant en compte les connectivités hydrologique, démographique et génétique. Le premier chapitre présente un modèle de métapopulation spatialement explicite qui, grâce à l'utilisation de matrices de connectivité stochastique, permet d'évaluer l'effet de la démographie sur la fréquence des allèles dans une métapopulation d'espèces marines benthiques sessiles. Le modèle est alors utilisé pour déterminer l'effet des traits démographiques et de la structure de connectivité sur la diversité génétique de la métapopulation. Le deuxième chapitre présente une analyse des patrons de connectivité génétique de deux espèces communes et largement répandues de gorgones, à une échelle régionale : Paramuricea clavata en mer de Ligure et Eunicella singularis dans le Golfe du Lion. Les deux espèces présentent de forts patrons de structure génétique à l'échelle régionale, bien que leur capacité de dispersion ne semble pas limitante (>100m). Le troisième chapitre vise à tester si la dispersion larvaire seule permet d'expliquer la connectivité réalisée d'E. singularis dans le Golfe du Lion, en appliquant le modèle présenté dans le Chapitre 1, et en comparant les patrons de structure génétique modélisés, aux résultats obtenus dans le Chapitre 2, par les méthodes empiriques d'analyse de données génétiques. Les patrons de structure génétique modélisés en ne prenant en compte que la structure spatiale de dispersion sont similaires à ceux observés entre les populations d'E. singularis dans cette région, suggérant le rôle prépondérant de la connectivité hydrologique dans la distribution régionale de l'espèce, tant au niveau démographique que génétique. La capacité d'évaluer le développement des structures génétiques entre populations, sous différents scénarios démographiques et hydrologiques, avec le modèle de paysage sous-marin présenté dans le Chapitre 1 s'avère donc un outil efficace pour la planification spatiale et la pérennité des populations marine.

#### Abstract

La connettività sembra influenzare fortemente la dinamica e la persistenza delle popolazioni marine. Comprendere l'evoluzione e il mantenimento dei pattern di connettività tra le popolazioni è perciò essenziale per la pianificazione spaziale marittima e per la creazione e la gestione delle Aree Marine Protette (AMPs). Ciononostante, analizzare la complessità dei processi che guidano la connettività delle popolazioni marine richiede l'utilizzo di strumenti che integrino modelli bio-fisici con informazioni derivanti dalle relazioni tra demografia e genetica che derivano dagli scambi larvali tra le popolazioni. Lo scopo di questa tesi di dottorato è quindi quella di valutare i pattern di connettività genetica tra popolazioni di gorgonie ad una scala spaziale regionale, e di comprendere i processi che determinano la connettività osservata attraverso simulazioni di modelli che tengano conto dei pattern idrodinamici, demografici e genetici. Il Primo Capitolo presenta un modello spazialmente esplicito di metapopolazione, che, attraverso l'utilizzo di matrici stocastiche di connettività, permetta di comprendere gli effetti della demografia sulle frequenze alleliche di una metapopolazione di specie marine bentoniche sessili. Il modello è stato poi utilizzato per valutare gli effetti delle caratteristiche demografiche e della connettività sulla diversità genetica di una metapopolazione marina. Il Secondo Capitolo esamina i pattern di connettività genetica su scala regionale di due specie di gorgonie ampiamente distribuite lungo le coste del Mar Mediterraneo: Paramuricea clavata nel Mar Ligure e Eunicella singularis nel Golfo del Leone. Entrambe le specie mostrano forti pattern di strutturazione genetica su scala regionale anche se la capacità dispersiva di tali specie non sembra essere particolarmente ridotta (>100 m). Il Terzo Capitolo cerca di comprendere quali sono i processi che determinano l'effettiva connettività tra le popolazioni di E. singularis del Golfo del Leone attraverso l'utilizzo del modello presentato nel Primo Capitolo e confrontando tali risultati con quelli ottenuti nel Capitolo 2 attraverso l'utilizzo di dati genetici empirici. I pattern di struttura genetica modellizzati prendendo in considerazione solo la struttura spaziale di dispersione sono simili a quelli osservati empiricamente. Questo suggerisce che la connettivita idrodinamica debba svolgere un ruolo importante nella distribuzione regionale della specie così come nella sua struttura genetica e demografica. La capacità di valutare l'evoluzione della struttura genetica tra le popolazioni sotto differenti scenari demografici e idrodinamici attraverso l'utilizzo del modello presentato nel Capitolo Primo rappresenta un ottimo strumento per la pianificazione spaziale marittima e per la persistenza delle popolazioni marine.

### Introduction



The world's oceans are increasingly threatened by multiple anthropogenic stressors. A large range of land and ocean-based activities, coupled with human population expansion and migration towards the coast, are rapidly causing the modification and/or degradation of the ocean's functions and biodiversity (Lubchenko 2003). Coral bleaching, fisheries collapse, changes in species composition and mass mortality events are a few among the severe consequences of the progressive alteration of the marine ecosystems around the world (Halpern *et al.*, 2008).

Within this context, the need of ensuring the persistence of marine species' populations becomes evident, as so does the realization that the resilience of these ecosystems will partly depend on our ability to establish appropriate management measures for conservation. As a consequence, growing concern regarding the number and efficiency of Marine Protected Areas (MPAs) has been evidenced in the scientific literature (Agardy 1994; Babcock *et al.*, 2010; Edgar *et al.*, 2014; Lagabrielle *et al.*, 2014). Furthermore, the Convention on Biological Diversity (CBD) has set a target of protecting 10% of the coastal and marine areas by 2020, which has led to a rapid increase in the creation of MPAs worldwide.

Our ability to effectively protect marine biodiversity, however, depends as well on our understanding of the species' ecology, dynamics, and its interactions with the environment. In the marine environment, species habitats are usually discontinuous either for natural reasons (e.g. coral reef patches, seagrass beds) or due to climatic or anthropogenic disturbances (e.g. hurricanes, coastal development). This discontinuity or fragmentation of habitat leads to the geographical separation of marine populations. The maintenance of the spatial distribution of these discrete populations suggest that they must be more or less connected by the exchange of individuals among them, forming what is commonly known as a metapopulation (Hanski 1999) (Figure 1).

The degree of connectivity, as well as the temporal and spatial scales of the connections among populations are, thus, key to the functioning of metapopulations. Theoretical studies suggest that population connectivity plays a fundamental role in



local and metapopulation dynamics, community dynamics and structure, genetic diversity, and the resilience of populations to human exploitation (Hastings and Harrison, 1994; Botsford *et al.*, 2009). Previous studies have demonstrated how connectivity may enhance the persistence of a metapopulation after disturbances, by enhancing their recovery and/or recolonization (Hastings and Botsford 2006; Guizien *et al.*, 2014). Therefore, understanding the degree and patterns of connectivity among populations is also central to the success of conservation management strategies, like the design of MPAs (Sale *et al.*, 2006).

#### Larval dispersal and marine connectivity

The exchange of individuals among populations can occur over different times during a species life cycle: dispersal of larvae, and movement of juveniles and/or adults. However, for benthic sessile species, dispersal can only take place during their larval phase. Therefore, larval dispersal defines the spatial scale of connectivity for these species (Cowen and Sponaugle 2009).

Several biophysical processes influence larval dispersal. Hydrodynamical features and environmental forcing at the location and timing of spawning will determine the



duration and direction of transport of larvae (Pineda 2000). Larval Pelagic Duration (PLD) and larval behavior may also alter the vertical distribution of the larvae in the water column, exposing it to different hydrodynamic conditions and potentially modifying their dispersal patterns (Butler *et al.*, 2011). Moreover, larval mortality can dilute the larval pool and limit connectivity (Paris *et al.*, 2007).

Connectivity patterns resulting from larval dispersal will also be affected by several processes acting at different temporal and spatial scales during the different stages of dispersion, from spawning to reproduction of the settled larvae (Pineda 2007) (Figure 2).





It is important to highlight that, after transport, not all of the arriving larvae will be able to settle. As highlighted by Pineda (2000), settlement rate is not a function of the number of larvae arriving. The availability of suitable substrate can also limit the exchange of individuals among populations. Also, post-settlement mortality will affect the effective connection among populations, as the larvae that successfully settle will



still face local biotic interactions and potential disturbances before it reaches sexual maturity and is able to reproduce (Chesson 1998). Furthermore, adult demography can vary reproductive output over time and space and thus control the number of larvae available to disperse.

Taking into account the variability in the spatial and temporal scales at which all of these processes act on population connectivity, it is then important to distinguish between the different types of connectivity that can be found according to the different processes that drive them. An understanding of larval dispersal can only determine population connectivity until the moment of larval settlement, which is known as *larval connectivity* or *potential connectivity* (Pringle 2003). Knowledge of larval connectivity may be useful for some objectives related, for example, to the persistence of a metapopulation. However, it only provides partial information regarding the exchange of individuals that will eventually reproduce (Pineda *et al.*, 2007).

For connectivity to enhance metapopulation persistence, the sum of births and immigration in a population must be equal or exceed the sum of deaths and emigration (Pineda *et al.*, 2007). When the contribution from the exchange of individuals among populations is large enough to influence the demographic parameters of a population, it is referred as *demographic connectivity* (Sale *et al.*, 2010). Within an ecological temporal scale, persistence is, therefore, only possible if the level of demographic connectivity among populations allows the replacement of an adult individual that is able to reproduce, even if its population of origin is not self-persistent (Burgess *et al.*, 2014).

In an evolutionary scale, on the other hand, when we refer to the exchange of genes among populations over several generations, we talked about *genetic connectivity*. The patterns of genetic connectivity in marine species will determine the level of genetic differentiation among populations, which could influence local adaptation and eventually speciation (Banks *et al.*, 2013). However, the level of exchange of individuals necessary to maintain genetic connectivity and even genetic homogeneity among populations, unlike demographic connectivity, are much lower (Greenbaum *et al.*, 2014).



Although all of aforementioned processes (biophysical and demographic) play a fundamental role in driving the connectivity patterns, their relative importance to connectivity and metapopulation dynamics can vary depending on the system and species-specific properties. For a long time, the relative homogeneity of the marine environment, coupled with a perceived lack of conspicuous barriers lead to the expectation that marine populations were highly connected (Caley et al., 1996). The characteristic of these "open" populations would, however, depend on the school of thought. For some researchers, they would be characterized by high recruitment of larvae coming from external sources, although at a level that would still allow populations to fluctuate below saturating capacity. While for others, density-dependent processes acting after settlement would control the excess of incoming larvae (Hixon et al., 2002). However, a growing body of evidence has revealed that patterns of dispersal can limit demographic exchange among populations and that, in fact, marine populations rarely constitute fully open or closed systems (Sponaugle et al., 2002). In 2000, Cowen et al, using numerical simulations of larval dispersal, showed that larval retention at a small scale was possible. An assertion that was later confirmed by field studies showing high levels of self-recruitment in coral reef systems (Almany et al., 2007; Planes *et al.*, 2009; Gilmour *et al.*, 2013).

As an attempt to discern the processes behind these observations, several studies evaluated the fit of Larval Pelagic Duration (PLD) as a proxy to explain the dispersal potential and population connectivity of marine species. However, the results have been contradictory. Shanks *et al.* (2003) and Siegel *et al.* (2003) found a strong correlation between PLD and inferred dispersal distance. Conversely, other studies demonstrated strong population subdivision in species with long PLD (Thomas *et al.*, 2013; Damerau *et al.*, 2014). Whether limited dispersal capacity, regional hydrodynamics, or perhaps local demography, are responsible for the high levels of larval retention and/or selfrecruitment observed in many marine species it is still unclear, and remains a scientific challenge. Quantifying the spatial scale of connectivity and identifying the factors that



regulate it has now become crucial for the establishment of appropriate management measures for the conservation of marine populations (Kritzer and Sale 2004; Pineda *et al.*, 2007; Jones *et al.*, 2009).

#### Methods to estimate marine connectivity

Our ability to measure connectivity by tracking larvae and following their movements between two populations is very limited. The classical techniques of physical tagging, although the most accurate, are just not feasible when dealing with such a large amount of very small size individuals (Thorrold *et al.*, 2002). Nonetheless, this type of direct tracking could not provide relevant information at an evolutionary time scale (Kool *et al.*, 2013). In order to overcome these limitations, other methods for estimating connectivity have been developed, which can be grouped into two main categories: empirical and modelling.

Within the empirical category of methods to assess connectivity among marine populations, chemical and genetic tools have been commonly used in a wide variety of fish and invertebrate species (Hedgecock *et al.*, 2007; Campana 1999). The chemical methods are based on the property of certain calcified tissues (e.g. shells and otoliths) to permanently incorporate chemical elements from the environment during their development. Notoriously among the techniques of chemical tagging, the method developed by Thorrold *et al.* (2006), allows the transgenerational transference of the chemical tag (a stable isotope of <sup>137</sup>Barium) from the mothers to their offsprings by an injection in the abdominal cavity of the individual. However, the use of this method is limited to species with calcified tissue, therefore, its application has been mostly limited to the analysis of otoliths in fish species.

Genetic tools, on the other hand, have been applied for the evaluation of population connectivity for a wide variety of marine taxa. Genetic inferences of gene flow among populations contribute to our understanding of the evolutionary consequences of dispersal. Furthermore, population genetics provides a mean to evaluate population connectivity integrated over many generations, which would not be



observable with other approaches (Lowe and Allendorf 2010). The methods used in population genetics allow both direct and indirect estimates of connectivity by assessing changes in the frequency of alleles (defined as alternative forms of a gene), and the assignment of individuals to their population of origin, respectively (Hedgecock *et al.*, 2007).

Changes in allele frequency are due to synergistic action of four main evolutionary forces: the mutation of genes, the stochastic fluctuations in finite populations called random genetic drift, the gene flow that results from the migration of individuals among populations, and selection. Over long periods of time, random genetic drift and selection can cause population differentiation, while migration acts to homogenize genetic diversity among populations (Roughgarden 1979). This effect of migration on allele frequencies is the basis of the usefulness of population genetics in inferring connectivity. However, it is important to highlight that the indirect methods estimate gene flow from the level and the pattern of genetic divergence among populations, under the assumption that the populations are at drift-gene flow equilibrium (Slatkin 1987). This assumption, of a balance between the influence of genetic drift driving the fixation on an allele in all populations, and the opposite effect of gene flow bringing new alleles to the populations, if not met, will generally lead to the overestimation of the current amount of gene flow (Lowe and Allendorf 2010).

In fact, most indirect methods used for inferring connectivity rely on theoretical models of population structure, like the Wright' Island Model (Wright 1931), an unrealistic model that assumes equal gene flow among populations of the same size. Therefore, it is important to understand the limitations of these indirect methods when inferring connectivity patterns. These methods can estimate connectivity over evolutionary scales, but are incapable of estimating contemporary exchange among populations (Hedgecock *et al.*, 2007). The most common metrics of genetic differentiation obtained from these methods are Fst (a standardize variance of allele frequencies among populations), and a variety of conceptually similar metrics like Gst,  $\Phi$ st, AMOVA, etc.).



More recently, in order to overcome some of the shortcomings from unrealistic model assumptions and take advantage of variable molecular markers, methods that allow the direct estimation of gene flow by assigning individuals to their populations of parents of origin have been developed, and are considered to be analogous to non-genetic approaches of estimating migration among populations (Lowe and Allendorf 2010). Based on the expected frequency of its multilocus genotype, the probability that an individual originated from a given population or set of parents can be calculated (Manel *et al.*, 2005). Maximum Likelihood and Bayesian approaches, assuming only Hardy-Weinberg equilibrium and Linkage disequilibrium and, therefore, providing higher accuracy estimates, can also calculate inferred rates of migration among populations (Wilson and Rannala 2003). Nonetheless, assignment tests are sensitive to sample size and do not work well at high levels of gene flow, when population differentiation becomes difficult (Hedgcock *et al.*, 2007).

Although empirical methods of assessing population connectivity can provide estimates of the spatial and temporal variability of the observed connectivity patterns, these approaches are costly and labor intensive, which limits their wide application over several scales. Moreover, the fact that the observed patterns of genetic connectivity are integrated over multiple generations brings additional challenges when attempting to discern the processes that influenced them over time. In that regard, the use of numerical simulations of larval dispersal and connectivity enhances the testing of hypothesis over multiple and large temporal and spatial scales (Kool *et al.*, 2013).

As any other field, modelling tools are not free of challenges and, as a consequence, the models used to assess marine connectivity have evolved and greatly improved over time. Currently, biophysical models allow to quantify connectivity by simulating larval dispersal at different temporal and spatial scales. The incorporation of 3-dimensional coastal circulation models and spatially-explicit Individual Based Models (IBMs) are used to project individual (Lagrangian) larval trajectories under realistic conditions while, in some cases, taking into account some biological traits of the larvae



as well (Guizien *et al.*, 2006; Werner *et al.*, 2007). Several modelling approaches exist to estimate connectivity from larval dispersal trajectories (Kool *et al.*, 2013). However, the most commonly used in the literature is the study of connectivity matrices (Figure 3).

The connectivity matrix resulting from a biophysical model can provide essential information for understanding persistence in a marine metapopulation. With origin locations along the columns and destination locations along the rows, each one of the cells represents the probability that an individual produced at a given origin location either settles in the same location or disperses to settle in a given destination location at any given time (Burgess *et al.*, 2014). However, the use and interpretation of data resulting from biophysical models depends on the spatial and temporal resolution of the model, as well as the biological characteristics attributed to the larvae (Paris *et al.*, 2007).

With so many different methods (empirical and modelling) available to estimate the different types of connectivity (larval, demographic and genetic) over a species life cycle, a true understanding of how spatial management can maintain the persistence of populations calls for a need to integrate multiple approaches. Furthermore, the



combination and comparison of connectivity patterns resulting from the use of different tools could allow to disentangle the relative role of the seascape processes shaping the observed connectivity patterns among marine populations.

The integration of ecological and genetic metapopulation models has been shown to be an important tool for understanding the complexities of population connectivity (Levin 2006; Epperson *et al.*, 2010). Previous studies have attempted to link biophysical dispersal models and population genetic structure (Galindo *et al.*, 2006; Foster *et al.*, 2012). However, these models do not seem to explain the observed connectivity patterns in sessile marine species at small spatial scales, a mismatch that could be explained by the lack of integration of the demographic dynamics of their populations, and/or the interaction between larval dispersal and population genetics.

Within this context, the objective of my research thesis is to discern the seascape processes responsible for driving and maintaining genetic connectivity in sessile invertebrate species at a regional scale, by confronting the observed realized connectivity to a combined approach of modelling methods that integrate connectivity over several stages of a species life cycle.

In **Chapter 1**, I present the development of a coupled seascape genetics model that allows to project the evolution of allele frequencies in a metapopulation over time, taking into account demographic traits and connectivity variability. With the application of this model I examine how: 1) demographic traits influence the development of genetic structure in closed populations over time, 2) different patterns of connectivity affect the loss or maintenance of genetic diversity at a regional scale in a metapopulation, 3) fluctuations in local population density help maintain genetic diversity over time and 4) local population demographic stability impacts genetic diversity to provide relevant information for conservation decisions in the Gulf of Lions, France.

In Chapter 2, I used a combination of direct and indirect genetic methods to evaluate the connectivity patterns of two gorgonian species in two regional scales. I analyse the genetic population structure of the red gorgonian (*Paramuricea clavata*) in the



Ligurian Sea, and the white gorgonian (*Eunicella singularis*) in the Gulf of Lions. Given the history of mass mortality events recorded for *P. clavata* in the Ligurian Sea, I attempt to answer: 1) whether disturbed populations show a signal of reduced genetic diversity, and 2) if connectivity may have played a role in the recovery of the populations. In the case of *E. singularis* in the Gulf of Lions, I aim to answer the following questions: 1) does *E. singularis* have dispersal capacity?, 2) is there genetic differentiation between the populations inside and outside the Gulf of Lions?, and 3) can the pattern of genetic population structure be explained by the regional hydrodynamics?.

In **Chapter 3**, I attempt to identify the underlying processes driving the observed patterns of genetic connectivity for *E. singularis* in the Gulf of Lions by comparing the observations to the modelled patterns of connectivity resulting from the coupled seascape genetic model presented in Chapter 1. The main question rose for this analysis was: can larval dispersal alone drive the patterns of genetic connectivity of *E. singularis* in the Gulf of Lions?

Modelling the effect of demographic traits and connectivity on the genetic structuration of marine metapopulations of sedentary benthic invertebrates

### 1.1 Abstract

The genetic structure of populations is commonly used to infer connectivity among distant populations. Accounting for connectivity is essential in marine spatial planning and the proper design and management of Marine Protected Areas (MPAs), given that their effectiveness depends on the patterns of dispersal and colonisation between protected and non-protected areas. Here, we present a spatially explicit coupled metapopulation gene flow model that simulates the effect of demographic fluctuations on the allele frequencies of a set of populations. We show that in closed populations, regardless of population growth rate, the maintenance of genetic diversity at the initial saturating population density increases with species life expectancy as a result of density-dependent recruitment control. Correlatively, at low initial population density, the time at which a population begins to loose its genetic diversity is driven by recruitment success - the larger the recruitment success, the quicker the genetic drift. Different spatial structures of connectivity established for soft bottom benthic invertebrates in the Gulf of Lions (NW Mediterranean, France) lead to very different results in the spatial patterns of genetic structuration of the metapopulation, with quick genetic drift in sites where the local retention rate was larger than 2%. The effect of recruitment failure and the loss of key source populations on heterozygosity confirm that transient demographic fluctuations have a major effect on the maintenance of genetic diversity in a metapopulation. The loss of a population with high betweenness values could be crucial in genetic differentiation and metapopulation subdivision, even more than the loss of source sites identified as key contributors for metapopulation persistence. The model provides a tool for evaluating different scenarios of conservation



spatial planning and the need for finding a compromise between species demographic persistence requirements and the conservation of genetic diversity, pleading for a MPAs network as opposed to isolated MPAs.

### 1.2 Introduction

Connectivity strongly impacts the dynamics and persistence of marine populations because it influences key processes, from short-term demography to longterm evolution, including resistance to disturbances and environmental changes. Therefore, understanding the development and maintenance of connectivity patterns is essential in marine spatial planning and the proper design and management of Marine Protected Areas (MPAs) (Palumbi 2004; Botsford *et al.,.* 2009). However, the quantitative study of connectivity and the identification of connectivity bottlenecks that could compromise the ability for populations to recover after disturbances are current scientific challenges (Pineda 2000; Burgess *et al.,* 2014).

For sedentary marine benthic species, understanding connectivity translates into understanding larval dispersal, given that it is during the pelagic larval stage that the exchange of individuals and genes among populations takes place (Pineda *et al.*, 2007; Cowen and Sponaugle 2009). Hence, to analyse the patterns of connectivity among populations and study, in more detail, the mechanisms that shape and maintain connectivity patterns through time, the dispersal of organisms should be taken into account (Hastings and Botsford 2006; Aiken and Navarrete 2011).

Different approaches have been undertaken to try to quantify dispersal and connectivity in marine ecosystems. Population genetics has been one of the most frequently used tools to provide direct and indirect measures of connectivity in several marine species (Hellberg *et al.*, 2002; Saenz-Agudelo *et al.*, 2009; Lowe and Allendorf 2010). The dispersal potential of the larvae produced by sedentary benthic species has usually correlated with gene flow and was even used as a predictor of population genetic structure (Siegel *et al.*, 2003).

Using estimates of Pelagic Larval Duration (PLD) as a proxy to measure realised



dispersal distance, several studies showed that the correlation between PLD and genetic Isolation by Distance (IBD) was consistent with the expectation that migration was the key factor driving the genetic structuration of marine populations (Hellberg 1996; Gilg and Hilbish 2003). However, recent data set reviews (Riginos *et al.*, 2011; Selkoe and Toonen 2011; Faurby and Barber 2012) have now shown that the relationship between PLD and genetic structuration might be weaker than previously thought.

The influence of several processes (e.g. larval behaviour, availability of suitable habitat, and biotic interactions) can cause the patterns of population connectivity to be different from what would be expected from flow integration along PLD alone (Pineda 2000; Guizien *et al.*, 2006). Among these processes, settlement or recruitment regulation of dispersal alters gene flow (Pineda *et al.*, 2007), in addition to the local demography. This temporal and spatial variability in the strength of gene and demographic flow due to bottlenecks during larval settlement and recruitment implies that there is a set of interacting processes operating across various scales, which introduces complexity into the system. Therefore, inferring connectivity by only one disciplinary approach (either genetic or bio-physic) does not provide the necessary information to properly describe population persistence in a network of MPAs (Hastings and Harrison 1994; Marko and Hart 2011).

It is therefore necessary, in order to efficiently inform conservation management decisions, to use tools that integrate bio-physical models with information regarding local demographic traits driving genetic linkages that result from larval exchange among populations (Werner *et al.*, 2007; Cowen and Sponaugle 2009). However, detecting the genetic signatures caused by the transient dynamics of demographic changes remains a challenge (Alcala *et al.*, 2013).

Although genetic models incorporating larval dispersal and demographic parameters have recently been developed to quantify connectivity among marine populations (Galindo *et al.,* 2006; Kool *et al.,* 2009; Munroe *et al.,* 2012), they have some limitations when attempting to understand connectivity patterns among non-



equilibrium populations. The model Galindo *et al.* (2006) developed, for example, does not take into account demographic variability, as population sizes were kept constant over time. The approach Kool (2009) developed, although allowing changes in population size, does not account for overlapping generations but, more importantly, being an Individual-Based Model (IBM), population sizes were limited to 10 individuals. Recently, Munroe *et al.* (2012), presented a modelling case study for Eastern oysters in Delaware Bay (USA) in which they relaxed population size limitations and assigned each population its own demographic dynamics.

In an attempt to generalise Munroe *et al.'s* (2012) approach, we present a spatially explicit coupled demographic gene flow model that assesses the effect of demography variability on allele frequencies in a marine metapopulation of sedentary benthic species with realistic population densities. The seascape model was used to examine how: 1) demographic traits influence the development of genetic structure in closed populations over time, 2) different patterns of connectivity affect the loss or maintenance of genetic diversity in a metapopulation, 3) fluctuations in local population density help maintain genetic diversity over time and 4) local population stability impacts genetic diversity to provide relevant information for conservation decisions in the Gulf of Lions, France.

## 1.3 Methods

### 1.3.1 A seascape genetic model for benthic invertebrates with a pelagic larval phase

To simulate the transient demographic effect on local allele frequencies arising from environmental variability modulating connectivity through time, a seascape genetic model was developed. The seascape model relies on the forcing of a spatially explicit dynamical model of allele probability by a spatially explicit metapopulation model (Guizien *et al.*, 2014, adapted from Hastings and Botsford 2006) (Fig. 1.1).





**Figure 1.1.-** Schematic representation of seascape genetic model. The frequency of each allele k is calculated at any given time in every site i, as a result of mixing between the surviving individuals with allele k in site i and to the input of new recruits with allele k, coming from any other site.

The combination of these models allows us to project the development of a population genetic structure through time, resulting from demography dynamics driven by local survival and larval transfer on a regional scale.

The spatially explicit metapopulation model simulates the population density  $N_i(t)$  at each site *i* at any time *t* resulting from the balance of adult survival and input of new recruits resulting from reproduction of adults present in the previous time step. Therefore, N<sub>i</sub> represents the adult census size per unit surface, and it is equal to the effective number of breeders per unit surface for the next reproductive event (as defined by Waples *et al.*, 2013). It is important to note that such formulation implicitly hypothesized that age at first reproduction and the time lapse between reproductive events are both equal to the model time step, ensuring that effective number of breeders does not vary with population age structure. Larval transfer rate among sites is estimated from a set of realistic connectivity matrices obtained using the larval dispersal model (Guizien *et al.*, 2012), and recruitment success (inter-specific competition) (Eq. 1 and 2) (Guizien *et al.*, 2014).

In the seascape genetics model, the frequency of each allele *k* is calculated at any given time in every site *i*, as a result of mixing between the surviving individuals with allele k in site i and the input of new recruits with allele k, coming from any other site (Eq. 5). Given the large number of larvae produced by each adult and the high recruitment success (i.e. larval and juveniles survival) values assigned (10%) compared to estimated regional retention rates (3%), genetic drift due to larval and juveniles mortality is neglected and, thus, a proportional and uniform loss was applied to the larval pool with allele k produced at each site embedded in the recruitment success parameter. The effect of genetic drift is therefore simulated by the random sampling of the alleles lost during two different periods in the life cycle: larval dispersal and settlement. Simplifying assumptions were that: 1) mating takes place randomly every year among diploid organisms, 2) allele frequencies are identical among sexes, 3) generations are discrete but overlapping, 4) populations are not age-structured, 5) given the relatively short period of time considered in the simulations (100 years), mutation is assumed to be negligible compared to genetic drift and migration, and thus set to zero and, 6) selection can be neglected.

During larval dispersal, the pool of larvae with allele *k* produced by each site, remaining in the region (accounting for regional retention rate), is randomly sampled before being re-distributed among the destination sites according to the connectivity matrix (Eq. 6 and 7). The number of larvae with allele *k* that will survive dispersal is computed by sorting out the rank of the allele carried by the surviving larvae. During settlement, saturating density limits the number of arriving larvae that can actually settle at each site, therefore, a random subset of alleles carried by the pool of larvae arriving at each site actually settle.

### 1.3.2 Test cases

The simulations were designed to evaluate the changes in allele frequencies due to variations in species demographic parameters and connectivity structure. Although this modelling approach applies to any sedentary species with a reproductive dispersive stage, to test the sensitivity of the model, we focused on marine benthic species with four different life expectancies (2, 5, 10 and 20 years) that reproduce each year. The values of recruitment success were varied in order to test the effect of maximum population growth in the maintenance of genetic diversity over time. Recruitment success was also the same in all populations (10%), although it was limited by saturating spatial density, which was set to Nmax=6250 individuals/m<sup>2</sup> per population.

Six groups of simulations were performed (Table 1.1). All simulations were run for 100 iterations, one iteration being the time lapse between two reproductive events. The initial genetic structure was described by ten different alleles present simultaneously in every site. In order to examine the variability due to specific initial conditions of genetic structure, simulations were repeated at least 100 times with different and random initial conditions of allele frequencies each time.

The first group consisted of simulations of a closed population (no larval inputs) in which life expectancy was raised from two to 20 years. Groups 2, 3A, 3B, 4A and 4B, consisted of simulations of a metapopulation of a species with a life expectancy of 10 years, distributed among 32 sites along the Gulf of Lions (northwestern Mediterranean) (Figure S1), in which spatial structure was driven by connectivity only. These groups of simulations correspond to the test case of dominating species of the soft-bottom benthic communities in the Gulf of Lions (polychaetes). The continuous sandy-bottom habitat of these polychaetes, which is delimited by the 10 and the 30 meters isobaths, was described by sites of approximately the same width (~ 20 km) contiguously distributed along the coast. Based on these criteria, the areas of the 32 sites ranged from 6.2 to 121 km<sup>2</sup>. Survival and fecundity rates were the same among populations within the metapopulation and were kept constant over time in all of the simulations.

Larval transfer between the 32 sites was computed from Lagrangian larval dispersal simulations based on regional hydrodynamic simulations performed with the coastal circulation model SYMPHONIE (Marsaleix *et al.,* 2008). Larval dispersal was simulated by releasing larvae at the average site depth (20 m). Connectivity matrices containing larval transfer probabilities were produced for 20 sets of 10-day long spawning periods in 2004 and 2006 with an average PLD of four weeks (Guizien *et al.,* 2014). A total of 20 different connectivity matrices were used for this analysis.

Simulations of Group 2 were performed to evaluate the effect of the distinct connectivity structure on heterozygosity. In this case, connectivity was set deterministically using the same connectivity matrix every year (either one of the 20 variants) and, thus, simulations were run 100 times.

Groups 3A, 3B, 4A and 4B were performed in order to test the effect of recruitment (3A and 3B) and habitat loss (4A and 4B) on metapopulation size and the maintenance of heterozygosity within a metapopulation over time. Metapopulation size was represented as average regional coverage, defined as the ratio between regional average population density and saturating density. Connectivity was set stochastically using a different connectivity matrix among the 20 variants every year and, thus, simulations were run 500 times to reach the convergence of the mean when combining stochasticity in connectivity and initial condition. Group 3A simulated gene flow among all populations, and recruitment success was constant every year. Group 3B explored a scenario where recruitment failure (no recruitment) occurred every three years. Group 4A simulated the loss of four populations (sites 17, 18, 19 and 20). These populations were identified as being essential for the regional persistence of species at minimum recruitment success in metapopulation modelling, comparing the vulnerability to habitat loss of four ports in the Gulf of Lions (Guizien et al., 2014). Nonetheless, it is important to mention that for the present simulations, the values of minimum recruitment success and fecundity were set to ensure long-term persistence of the metapopulation after removing those four sites, unlike in Guizien et al. (2014). Group 4B evaluated a scenario where only one population (site 21) was lost from the metapopulation. This site was characterised by consistently showing the highest values of betweenness in the metapopulation when applying graph theory analysis to connectivity matrices (Costa, pers. comm.).

## **1.3.3** *Metrics and statistics*

Heterozygosity and allelic richness are two measures of genetic diversity commonly used in the population genetics literature, and in the present study both were



used. Heterozygosity (He<sub>i</sub>), was estimated taking into account all individuals at each site *i* over time (Eq. 8).

where  $p_{ik}(t)$  = frequency of the *k*th allele of *n* alleles in site *i* at time *t* [no units].

However, heterozygosity and allelic richness describe the state of genetic diversity of a population at a particular time and not its dynamics. In order to measure the speed at which genetic diversity varied as a function of demographic parameters (regulating genetic drift) and connectivity structure, new metrics describing the initial and average slope of the evolution of genetic diversity over time are introduced: 1) Allele Drifting Time (Td), which is the moment at which allelic diversity starts decreasing, meaning the time when the first allele is lost from the population or the metapopulation. 2) Allele Fixation Time (Tf), which is the time lapse between the first loss of an allele (Td) and the fixation of any allele (Figure S2).

These metrics were defined on allelic richness rather than heterozygosity to avoid ambiguity in defining genetic diversity reference points and given the known sensitivity of allelic richness to the loss of rare alleles (Allendorf 1986).

### 1.4 Results

# 1.4.1 Do differences in demographic parameters affect genetic diversity in closed populations?

Figures 1.2A and 1.2B display the loss of genetic diversity in closed populations at saturating initial density as a function of the ratio between mortality (being complementary to unity of survival) and recruitment success. This ratio, having the dimensions of larvae/adult/year, depicts the origin of recruitment regulation (*sensu* by Hixon *et al.*, 2002) and informs on the relative contribution of intrinsic vs. extrinsic drivers: high values indicate recruitment regulation due to low recruitment success



driven by inter-specific competition or predation, while low ratio values indicate recruitment regulation due to space limitation at a high population density (intraspecific competition). It should be stressed here that, in closed populations, low recruitment success depicts not only limitation in larval and juveniles survival but it also includes limitation in the proportion of settlers by local retention rate. Therefore, the acceleration of the loss of genetic diversity (measured as Td) shown when recruitment success increases in these simulations, is also expected when local retention rate increases.



**Figure 1.2.-** Effect of different life expectancies on the loss of genetic diversity, measure as allele drifting time (Td), for an isolated population at initial saturating capacity (6250 individuals/m<sup>2</sup>). Adimentionalizing allele drifting time by the number of reproductive events (Td/Re) (A) represents the differences in the number of generations it takes for a species with different life expectancies to start loosing its genetic diversity as a function of the ratio between mortality and recruitment success. In contrast, adimentionalizing allele drifting time by the life expectancy (Td/Le) of a species (B) provides a different vision corresponding to population turnover.

Fig. 1.2A shows that the number of reproductive events after which the population begins to loose its genetic diversity (Td/Re) increases with the ratio between mortality and recruitment success. This demonstrates a reduction of genetic drift when recruitment success decreases for any given life expectancy. However, genetic drift is



inhibited at high levels of recruitment success, as depicted by low and almost constant Td/Re for the lowest values of the ratio between mortality and recruitment success. Such minimum Td/Re is of the order of magnitude of the number of reproductive events in a life expectancy. For a recruitment frequency of 0.18, short-lived species (two years) could start loosing their genetic diversity after three years, while it would take around 14 years for a long-lived species (20 years). This reflects the effect of genetic drift inhibition by the reduction of reproductive events due to the lack of space caused by the presence of adults as life expectancy increases.

Similarly, the maintenance of genetic diversity, measured by the number of reproductive events before allele fixation (Tf/Re), in closed populations at saturating initial density increases with life expectancy, regardless of whether the population growth rate is low (<2.5) or high (>2.5) (Fig. 1.3). This confirms that genetic drift is limited by population inertia due to recruitment inhibition as a result of space limitation, as neither fecundity nor recruitment success affects the relationship.

However, when dealing with overlapping generations, it must be taken into account that the reduction of genetic drift by space limitation during the first population turnover decreases with species longevity. This is exhibited by the different hierarchies between life expectancy curves when representing the time at which the population starts to loose its genetic diversity in terms of population turnover (adimensionalising Td by the life expectancy of the species) (Fig. 1.2B). Species with short life expectancies begin to experience a reduction of their genetic diversity after a higher number of population turnovers than do long-lived species, as fewer reproductive events occur during a short life expectancy compared to during a long one. This result confirms that genetic drift can be controlled by effective reproduction (which may be limited by long life expectancy or recruitment success intensity) and its frequency along the species lifespan in a context of finite population size.





**Figure 1.3.-** Effect of population growth rate over allele fixation time (Tf) for three different initial conditions of population abundance (50, 1000 and 6250 individuals per m<sup>2</sup>) as a function of species life expectancy (Le) in a closed population.

Different initial population densities also affect the time at which a population starts loosing genetic diversity (Fig. 1.4A) – for any value of the ratio between mortality and recruitment success, the lower the initial density of the population, the slower the loss of genetic diversity. This result points out that genetic drift is slower when considerable space is available for recruitment compared to at saturating density where space availability is regulated by mortality.

Quantifying space availability by the time it will take a population to reach saturating density (6250 individuals/m<sup>2</sup>) shows that it would take twice as long for a population with an initial density of 50 individuals/m<sup>2</sup> compared to a population with an initial density of 1000 individuals/m<sup>2</sup> (Fig. 1.4B). Allele drifting time increases linearly with the time necessary to reach saturating density.







**Figure 1.4.-** Effect of different initial population abundances (50, 1000 and 6250 indidivuals per m<sup>2</sup>) on the loss of genetic diversity, measured as allele drifting time (Td), as a function of A) the ratio between mortality and recruitment success ((1-s)/b), and B) the time to reach saturating capacity (T). Td is adimensionalized by the life expectancy (Td/Le) of a species that lives 10 years, thus representing the number of population turnovers to start loosing genetic diversity in an isolated population.

The population growth rate triggers the effect of initial population density when it comes to the maintenance of genetic diversity, measured as Tf (Fig. 1.3). While in fast growing populations, the maintenance of genetic diversity is not sensitive to initial density, in slow growing populations, the maintenance of genetic diversity lasts longer and is more variable when the initial population size is small (50 individuals/m<sup>2</sup>) compared to when it is at saturating density. Such sensitivity to initial population size is amplified at small life expectancies.

Overall, in closed populations, genetic drift is the quickest when the population is at saturating density with high recruitment success, slowing down at low recruitment success or when population size is lower than saturating density. This result demonstrates the importance of transient demography in regulating the speed of genetic drift.

1.4.2 Do different patterns of connectivity affect the maintenance of genetic diversity in a metapopulation?



Simulated heterozygosity patterns among populations forming а metapopulation varied according to each connectivity matrix. The two most contrasting spatial patterns with low heterozygosity values either in the west (A) or in the east (B) of the Gulf of Lions are shown in Fig. 1.5. A plausible explanation is the different spatial patterns of local retention (defined as the proportion of larvae produced locally that remain in the same spatial unit) vs. import (estimated as the proportion of all larvae produced among all sites that settled within the focal site). For connectivity matrix 1, the ratio between local retention and import was higher in the west than in the east (0.074 and 0.027, respectively). On the contrary, for connectivity matrix 2 the values of the same ratio were higher in the east compared to the west (0.069 and 0.0085, respectively). However, simulations demonstrated that the relationship between Td and import do not exhibit any trend with no linear correlation ( $R^2 = 0.011$ ; P < 0.01) (Figure S3).



**Figure 1.5.-** Spatial pattern of genetic diversity caused by distinct connectivity structures. Variability of heterozygosity for 32 sites forming a metapopulation in the case of a species with a life expectancy of five years.

Similarly, Td was not linearly correlated to local retention rate values obtained from the analysis of the 20 connectivity matrices ( $R^2 = 0.031$ ; P > 0.05). However, Td was delimited by a piecewise function enabling the discrimination between two groups (Fig. 1.6) – populations with low levels of local retention (< 2%) that show high variability in the time they begin to loose their genetic diversity (Td/Le ranging from 0.2 to 50) and



populations with high local retention (> 2%) where genetic drift is much quicker and less variable (Td/Le ranging from 0.2 to 12). This indicates that the speed of genetic drift is regulated locally only at a high local retention rate (larger than 2%) while, for local retention rates lower than 2%, the strength of genetic drift depends on the regional structure of connectivity. According to the direction of the transfer and the genetic characterisation of the contributing populations, genetic drift will then be accelerated or slowed down in the focal population.



**Figure 1.6.-** Relationship between local retention (LR) (defined as the proportion of larvae produced in one population that remain in the same population) and the number of population turnovers to start loosing genetic diversity (Td/Le), in a metapopulation over time. Values correspond to 20 connectivity matrices, and species with three different life expectancies (2, 5 and 20 years). Dashed arrow indicates the threshold at which the effect of LR on Td/Le begins to decrease.

## 1.4.3 *How does local population stability affect heterozygosity in a metapopulation?*

When looking into the variation of the average heterozygosity in the metapopulation through time for a species with a life expectancy of 10 years, it becomes clear that changes in population density have a major effect on the loss of genetic diversity in a metapopulation (Fig. 1.7). The rate at which a metapopulation reaches a



stable regional coverage influences its possibility to maintain genetic diversity over time, even in the presence of migration.



**Figure 1.7.-** Effect of fluctuations in local population stability on heterozygosity over time. Scenarios: A) Simulates gene flow among all of the populations forming a metapopulation with constant recruitment success every year. B) Simulates recruitment failure (no recruitment) every three years C) Simulates the loss of four source sites (sites 17, 18, 19 and 20) in the metapopulation, while keeping recruitment success constant every year. D) Simulates the loss of one key population (site 21) for maintaining genetic connectivity in the metapopulation.

Overall, we observe that as soon as regional coverage reaches 80%, heterozygosity values decrease rapidly and genetic diversity is lost. Scenario A shows how, with constant recruitment success, the effect of migration among populations



homogenises allele frequencies over time and leads to the fixation of the same allele in all populations over a relatively short period of time. Most interestingly, in Scenario B, we find that high variability in metapopulation regional coverage due to recurrent failures in recruitment actually helps maintain genetic diversity over time. Stochastic connectivity leading to demographical fluctuations in populations enables the maintenance of genetic diversity.

On the other hand, Scenario C exemplifies how, in the Gulf of Lions, removing populations (sites 17–20) responsible for bringing demographic persistence to the metapopulation at minimum recruitment success divides it into an eastern and western group, causing a slightly faster decrease of genetic diversity in the latter group than in the former. However, Scenario D shows how the loss of only one site, identified as essential for maintaining the integrity of the connectivity graph, indeed disrupts the genetic connectivity of the metapopulation by augmenting the differentiation between the eastern and western groups in terms of the loss of heterozygosity, with drifting starting earlier in the eastern part. In Scenarios C and B, recruitment success was set in order to ensure that the loss of sites within the metapopulation would still allow for species persistence. It should be noticed that in both scenarios, a similar constant metapopulation size was maintained, even if not at saturating density. The effect of migration in this case will also lead to the loss of genetic diversity in the metapopulation over time, although at a slower rate.

### 1.5 Discussion

The present study highlights that genetic drift increases considerably with settlement limitations by lack of space when the effective number of breeders approaches saturating capacity, causing a strong reduction of effective reproduction.

Early authors had extensively shown how changes in genetic diversity are related to effective population size (Wright 1931; Kimura 1955). Nonetheless, it has been

demonstrated theoretically that some life cycle processes, like overlapping generations (Jorde and Ryman 1995), and demographic parameters can also have an effect on the amount of temporal allele frequency change and should be taken into account (Ryman 1997). Our results highlight the role of life cycle processes, other than age at first reproduction (Lee *et al.*, 2011), in reducing effective reproduction in populations with large number of breeders and increasing the effect of genetic drift on a short evolutionary time scale. In closed populations with saturating density, actual recruitment regulates the speed of genetic drift, demonstrating the relevance of transient demography in shaping the genetic structuration of marine species. In open populations, genetic drift is slowed down as a result of larval exchange. The effect of recruitment failure and the loss of key source populations on heterozygosity confirm that transient demographic fluctuations, when remaining above the risk of regional extirpation and actually avoiding reaching saturating density, help maintain genetic diversity over time.

Recently, several meta-analyses and empirical studies evaluating the relationship between PLD and population genetic differentiation across different marine species indicated a weak correlation between the two (Selkoe and Toonen 2011; Faurby and Barber 2012). In some cases, the high uncertainty in the estimates of larval dispersal and measures of population differentiation were suggested as the main causes for the unexpected results, while other studies suggested that differential mortalities and levels of abundance among populations were more relevant (Munroe *et al.*, 2012). The results from our simulations support these findings, while further demonstrating that considering other demographic parameters (such as life expectancy and population growth rate) and the inclusion of transient dynamics caused by recruitment failure, would help explain better the variability of genetic connectivity in a metapopulation.

Dawson *et al.* (2014), found that differences in fecundity, population size and PLD could account for the differences in population genetic structure between eight codistributed rocky intertidal invertebrate species in the eastern North Pacific. They found that population size was positively related to population genetic structure and they



attributed the variability among species to differences in recruitment and demography. Furthermore, they highlighted that the differences in migration potential found between theoretical and empirical data could be attributed to the role of genetic drift and natural selection. Here, we corroborate their hypotheses by demonstrating how the strength of genetic drift is influenced by recruitment success, local retention and fluctuations in population density due to habitat fragmentation and recruitment.

The present study exhibits an acceleration of genetic drift when the number of reproductive adults increases in a population. Although counterintuitive, such acceleration depicts the strong decrease in effective reproduction when recruitment is reduced by lack of space. However, relating genetic drift acceleration explicitly to a strong reduction in effective adult population size was not possible in the present case given that the filter controlling effective reproduction. Yet, we demonstrate that a long life expectancy and low recruitment success regulate the temporal variation of allele frequencies and reduce the loss of genetic diversity over time. This provides an alternative explanation to empirical evidence of strong genetic structure in long-lived species, when recruitment success is likely limited by space availability (Costantini *et al.*, 2007).

Population regulation occurs when at least one demographic rate is densitydependent (Hixon *et al.,* 2002). Clear evidence of genetic drift acceleration due to recruitment regulation is observed in our simulations for closed populations at the saturating initial density. Furthermore, the evaluation of the ratio between mortality and recruitment success allowed for disentangling the relative contribution of intrinsic (intra-specific competition) vs. extrinsic drivers (inter-specific competition or predation).

In open systems, it was already suggested that the amount of local retention could have a strong influence on the relative importance of demographic vs. connectivity parameters in the dynamics of metapopulations (Figueira 2009). Our results confirm those findings and indicate that local retention rate values larger than 2%

diminish the influence of the connectivity structure over genetic drift, as genetic drift accelerates in those populations close to saturating density. This is particularly relevant for the spatial planning of MPAs. Whether an MPA is created for the conservation of biodiversity or for fishery management, its main purpose is to maintain the persistence of its populations. In the case of marine metapopulations, local retention is considered the currency of persistence: the higher the local retention, the closer the population is to its saturating capacity (Burgess *et al.*, 2014). Nonetheless, it is important to note that, as Figueira (2009) suggested, under the same flow structure, differences in PLD among species could cause distinct patterns of local retention for different species in the same place, making biodiversity conservation efforts even more difficult. In any case, the loss of genetic variability through genetic drift at a high local retention rate can diminish future adaptability to a changing environment, which might be detrimental to local conservation efforts, strongly advocating for a network of MPAs formed by sites with lower local retention rate.

The maintenance of genetic diversity in the metapopulation over at least 100 years in the case of regular recruitment failure, creating regional demographic fluctuations, was not unexpected. These results, incorporating realistic spatially explicit connectivity matrices, extend previous theoretical studies that found that demographic instability and fluctuations in migration produce major changes in the evolution of genetic variation and population differentiation (Whitlock 1992). Given that disturbances can cause variations in key demographic and biological processes, disturbance history may be one of the major drivers shaping the patterns of genetic diversity in many natural populations (Banks *et al.*, 2013). The pattern of genetic diversity maintenance over time observed in our simulations has been reported in an empirical study on natural populations of frogs, where no losses of genetic diversity after a disturbance were found when survival was high or when recovering populations recruited many individuals from multiple sources (Spear *et al.*, 2012). In addition, Larson *et al.* (1984) suggested, based on a survey of 22 species of salamanders, that historical



influences are much more important in describing genetic variation patterns than is recent migration. Exhibiting that recruitment limitation by lack of space can be a strong filter to gene flow, even when larval dispersal connects populations, the present study provides an explanation for the discrepancy between modelled and observed connectivity between coral populations in the Caribbean (Foster *et al.*, 2012).

Although demographic disturbances leading to population bottlenecks have also been shown to induce strong genetic drift, in the present study, demographic disturbances around saturating capacity can reversely reduce the effect of genetic drift. The present study, thus, highlights that demographic disturbances can have contrasting effects on genetic drift whether they affect populations with small or large size compared to their saturating capacity: 1) decelerating genetic drift when population census size is close to saturating capacity (release of recruitment limitation), or 2) accelerating genetic drift when population census size is low compared to saturating capacity (reduction of effective number of breeders).

Previous studies in the Gulf of Lions identified the spatial structuration of population vulnerability to habitat loss driven by hydrodynamical connectivity. Four sites essential for species regional persistence at minimum recruitment success were identified from metapopulation modelling around the port of Sète (sites 17–20, Guizien *et al.*, 2014). However, analysis of the same connectivity graph used in the metapopulation model depicted those four sites as high bridging centrality, spanning across the two subclusters of the region. Another site (site 21) was instead identified for maintaining network integrity, as depicted by the highest betweeness (Costa, *et al.*, *pers. comm*). Here, we show that both the loss of four essential populations and the loss of the highest betweenness site divide the metapopulation into two genetically distinct subpopulations (eastern and western). Nevertheless, the loss of only site 21 leads to a higher level of genetic differentiation in the metapopulation. This result suggests that the highest betweeness of hydrodynamical connectivity graph could be interpreted for relaying gene flow and maintaining genetic connectivity, similar to how Rozenfeld *et al.*

(2008) interpreted the highest betweenness of genetic distance. This example encourages further investigation of the potential of graph analysis of hydrodynamical connectivity matrices to identify sites important for conservation of genetic diversity.

By pinpointing the differential effect of demographic parameters and flow connectivity on population persistence and genetic diversity the present study opens a question for management: in order to protect species persistence and genetic diversity, should we be seeking a compromise between preserving populations that are low in terms of diversity but are also demographically stable vs. highly diverse but unstable populations? The present model, by combining demography and gene flow in realistic conditions allows to answer this question by 1) disentangling the relative contribution of local demography and environmental connectivity in shaping seascape genetics, and 2) performing *in silico* evaluations of different scenarios for marine spatial planning.

## CHAPTER 2

## Introduction

Multiple ecological and anthropogenic stressors are increasingly affecting a growing number of marine species around the world, causing diseases and mass mortalities particularly in tropical coral reefs (Hughes *et al.*, 2003; Hoegh-Guldberg and Bruno 2010). In the Mediterranean Sea, coralligenous concretions are the unique calcareous formations of biogenic origin that allow the formation of reefs and are considered to be one of the main biodiversity hotspots in the region (Ballesteros 2006). These coralligenous outcrops have been identified as Mediterranean 'priority habitats' by the European Union Habitats Directive (92/43/CE). Severe cases of mass mortality events of several sessile benthic organisms inhabiting these coralligenous communities, in particular gorgonian species, have been reported in the coasts of the Ligurian Sea and Gulf of Lions (NW Mediterranean Sea) (Cerrano *et al.*, 2000; Perez *et al.*, 2000; Bramanti *et al.*, 2005; Cupido *et al.*, 2008; Coma *et al.*, 2006; Garrabou *et al.*, 2009; Santangelo *et al.*, 2015).

Gorgonians are of great interest for conservation. As engineering species, they play a fundamental structural and functional role in benthic ecosystems, which makes them key to the persistence and stability of hundreds of other species in the Mediterranean Sea (Gili and Coma 1998; Ballesteros 2006). For this reason, the future of benthic coralligenous communities depends on the ability of gorgonians to respond to increasing climate change and human disturbance (Ponti *et al.*, 2014).

Out of approximately 20 different gorgonian species inhabiting the Mediterranean Sea (Carpine and Grasshoff 1975), the red gorgonian *Paramuricea clavata* (Riso, 1826) and the white gorgonian *Eunicella singularis* (Esper 1791) are the most frequent and conspicuous species in the rocky sublittoral zone (Weinberg 1978; Gili and Ros 1985; Harmelin 1995; Ballesteros 2006) (Figure 2.1). While *P. clavata* is mostly found in sciaphilic rocky walls, *E. singularis* is a zoonxanthellate species found in abundance on horizontal or subhorizontal rocky bottoms (Weinberg and Weinberg 1979). In the NW Mediterranean, particularly around the Gulf of Lions and Cap Creus, *E. singularis* is



commonly found in relatively higher densities than *P. clavata* (Gori *et al.,* 2011). Conversely, in the Ligurian Sea *P. clavata* is generally found in higher densities than *E. singularis* (Cocito 2002).

Regarding their reproductive ecology, these two species share some common traits: gonochoric (separate sex) colonies that reproduce sexually every year, with a long duration of oogenesis as compared to spermatogenesis, and releasing their offspring into the water column during summer (Coma *et al.*, 1995; Ribes *et al.*, 2007). Nonetheless, there are fundamental differences among *P. clavata* and *E. singularis*. *E. singularis* is an internal brooder species, in which embryogenesis takes place inside the female polyps and the mature planulae larvae is released from the polyp mouth (Weinberg and Weinberg 1979).

Conversely, *P. clavata* is a surface brooder and embryogenesis occurs on the surface of the female colonies (Coma *et al.*, 1995). It has been reported that its larvae presents a short swimming period (Coma *et al.*, 1995) and low energetic content (Viladrich 2015), suggesting that the species may have limited dispersal capacity and, thus, settle close to the maternal colonies. A short dispersal range of the larvae and settlement near parental colonies has also been observed in *E. singularis* (Théodor 1967). However, the presence of symbiotic algae in the larvae (Weinberg and Weinberg 1979), and the high energetic content found in it (Viladrich 2015), has led to believe that the larvae of this species may have high dispersal capacity. Nonetheless, a true understanding on the dispersal capacity of these species is still limited by the lack of precise knowledge regarding their Pelagic Larval Duration (PLD) and competency period.

Many studies have focused their interest on evaluating the causes and consequences of the mortality events that affected both *E. singularis* and *P. clavata* populations in the NW Mediterranean. Multiple comparisons of the demographic structure of these populations before and after the climate-related disturbances have demonstrated their ability to recover after relatively short periods of time (Perez *et al.,* 2000; Coma *et al.,* 2006; Santangelo *et al.,* 2007; Cupido *et al.,* 2009; Santangelo *et al.,* 2015). Nonetheless, population recovery has been usually attributed to the species' life history traits and/or local population dynamics (e. g. high reproductive output and high recruitment rates) (Cerrano *et al.,* 2005; Santangelo *et al.,* 2015), disregarding the potential connectivity among populations at small regional scales arising from larval dispersal.

Under these circumstances, the use of genetic tools to evaluate the patterns of connectivity among populations seems an appropriate approach for assessing the realized dispersal of *E. singularis* and *P. clavata* (Hellberg 2002; Lowe and Allendorf 2010). However, because connectivity for marine species is the product of a series of filters driving population structure, starting by the production and dispersal of the larvae, followed by their settlement and survival, analysis of population genetic



structure can only be seen as proxy for characterizing connectivity (Jones *et al.*, 2009; Treml *et al.*, 2015). Our ability to discern patterns will also be affected by the spatial and temporal scales of the analysis.

Previous studies have evaluated the genetic structure among populations of *E. singularis* and *P. clavata* at different spatial scales in the NW Mediterranean (Calderón *et al.*, 2006; Cataneo 2011; Mokhtar-Jamaï *et al.*, 2011; Mokhtar-Jamaï *et al.*, 2013; Arizmendi-Mejía *et al.*, 2015). Using mitochondrial DNA (COI), Calderón *et al.* (2006) showed no genetic differentiation among sampled populations of *E. singularis*, not even allowing its distinction from a closely related species, *E. cavolinii*. On the other hand, using five polymorphic microsatellite loci, the work of Cataneo (2011) showed somewhat contradictory results in the analysis of the genetic structuration of *E. singularis* within the Mediterranean basin: although a weak pattern of IBD was found at the regional scale, populations separated by 100s of kilometers (France and Algerie) were grouped into the same genetic cluster (Cataneo 2011). Conversely, assessments of genetic population structure of *P. clavata*, using microsatellite loci, have evidenced strong genetic structure among populations separated by less than 30 meters (Mokhtar-Jamaï *et al.*, 2011; Arizmendi-Mejía *et al.*, 2015).

Nonetheless, the spatial scale of these studies has been either too small  $(5 \text{ m}^2)$  or too large (Mediterranean basin) to provide a clear understanding of how connectivity may enhance population resilience at a metapopulation scale. Indeed, at the large scale, their findings of strong genetic differentiation among populations are not very surprising, given that each one of the genetic clusters identified correspond to different hydrodynamic provinces, which, as defined by Rossi *et al.* (2014), are areas that are well connected internally but with limited exchange of larvae among them. Therefore, to evaluate what could be the processes involved in shaping connectivity within a hydrodynamic province, and the importance of distant connectivity in population functioning of these two abundant and widely distributed gorgonian species, the objective of this chapter was to evaluate the genetic structuration of *P. clavata* and *E.*

*singularis* at a regional scale, relying on a common approach and sampling design considering spatial scales from meters to kilometers. This chapter is thus structured in two sections to explicitly evaluate: 1) the role of genetic connectivity on the recovery of disturbed *P. clavata* populations in the Ligurian Sea; and 2) Genetic structure of *E. singularis* in the Gulf of Lions and Spanish Catalan Coast and its relationship with the local hydrodynamics.

Connectivity helps marine coastal populations recover from climate-induced mass mortality events

## 2.1.1 Abstract

Climate-induce threats are increasingly affecting marine populations worldwide. For benthic sessile species depending on a larval stage to disperse, the connection among populations may be key to ensure their persistence. Several mass mortality events have been recorded to affect multiple benthic species in the NW Mediterranean, particularly gorgonian species. Although previous studies have evaluated the demographic effect of these climate-related disturbances, the ability of population connectivity within the seascape to mitigate the loss of genetic diversity of benthic species has not been investigated empirically in the Mediterranean Sea. In this study, we examine the genetic diversity and population genetic structure of *P. clavata* among affected and non-affected populations in the Ligurian Sea using six polymorphic microsatellite loci, as a proxy to understand the patterns of realized connectivity in the region and their potential role in the recovery of its populations. Strong genetic differentiation was found between sites for *P. clavata* in the Ligurian Sea. We did not detect evidence of severe bottlenecks in all affected populations. The analysis of migration over several generations revealed that all populations are well connected in both directions. Patterns of surface currents in the



region seem to explain the spatial heterogeneity in the levels of gene flow. Although no temporal comparisons can be made given the lack of data on the genetic structure before the mass mortality events of *P. clavata* in the Ligurian Sea, our results suggest that the contribution of immigration could have helped the fast recovery of the genetic diversity and density of recruits in the most affected populations.

### 2.1.2 Introduction

Marine biodiversity at a global scale is under increasing pressure from environmental change caused by human activities, including climate change (Hoegh-Guldberg and Bruno 2010). Trends in rising sea temperatures, decreasing ocean pH and sea level rise, along with climate perturbations increasing the frequency and magnitude of extreme events (storms and heat waves) have already threatened several marine species and communities (Doney *et al.*, 2012). However, the threshold of populations and communities' resilience to climatic disturbances is still an open question in contemporary ecology and biodiversity conservation (Wernberg *et al.*, 2014). Among the threats affecting community structure and population persistence, mass mortality events and coral cover decline related to warming ocean temperatures are threatening the integrity of reef habitats and their associated high biodiversity (Pandolfi *et al.*, 2011; Selig *et al.*, 2012; Johns *et al.*, 2014; Riegl and Purkis 2015).

Severe and sudden reductions in population size (demographic bottleneck) are expected to lead to a loss of genetic diversity, particularly allelic diversity, causing a genetic bottleneck (Lacy 1987). Furthermore, populations that have suffered a genetic bottleneck and which remain of small size during a long period of time could loose additional genetic variation as a consequence of genetic drift, and eventually be affected by inbreeding (Nei *et al.*, 1975). However, the loss of genetic diversity caused by a population collapse can rapidly be offset or reversed by immigration (Crow and Kimura 1970; Keller *et al.*, 2001). Therefore, connectivity among populations could be an important asset for the mitigation of the loss of genetic diversity.

In marine benthic populations, connectivity between distant populations ensured by larval dispersal should allow the recovery of populations after disturbances and is expected to be a key aspect of their resilience (Almany *et al.*, 2009). Nonetheless, the efficacy of connectivity in the recovery after disturbance is controversial: while biophysical modeling approaches forecast wide potential connectivity through larval dispersal (Shanks *et al.*, 2003; Lipcius *et al.*, 2008), realized connectivity assessed by genetics is often more restricted in stable populations, as expected from the filtering due settlement and recruitment limitations (Pineda 2007). Yet, within the framework of the interaction between climate change and connectivity, most attention has been put to investigating how potential connectivity may be affected by climate change (Munday *et al.*, 2009; Lett *et al.*, 2010), while there is almost none empirical evidence on how realized connectivity may influence the response of marine species and confer resilience to disturbances caused by climate change (Vollmer and Palumbi 2007; Underwood *et al.*, 2007; Gilmour *et al.*, 2013; Caplins *et al.*, 2014; Magris *et al.*, 2014).

Determining the genetic diversity and genetic structure of marine populations can provide an understanding of the natural genetic variability of the populations, as well as their ability to withstand perturbations, their potential resistance to local extirpation and their natural rate of recovery (van Oppen and Gates 2006; Kovach *et al.*, 2015). In particular, the use of tests that allow the assignment of individuals to their population of origin can provide more detailed estimates of gene flow among populations, enabling the inference of contemporary migration patterns (Waser and Strobeck 1998).

In temperate waters, several mass mortality events coinciding with anomalous temperature increases have also affected benthic sessile species along the rocky shores of the north-western Mediterranean during the last two decades (Cupido *et al.*, 2008). Among the sessile invertebrates species concerned, gorgonian corals' populations particularly suffered the most damaging effects, resulting in the loss of more than 50% in density and biomass of different species (Cerrano *et al.*, 2000; Bramanti *et al.*, 2005;



Cupido et al., 2008; Coma et al., 2009; Garrabou et al., 2009; Santangelo et al., 2015).

Gorgonian corals are long-lived, slow-growing, habitat-forming species considered to be one of the main components of the Mediterranean coralligenous assemblages (Ballesteros 2006). They are of great interest for conservation given their role in the persistence and stability of several associated species. At the same time, their slow dynamics make them particularly vulnerable to disturbances (Linares *et al.*, 2008). Therefore, the future of the communities of Mediterranean coralligenous assemblages depends on the capability of gorgonian species to respond to increasing climate change and human disturbances (Ponti *et al.*, 2014).

Among the gorgonian species affected by sea temperature anomalies, the red gorgonian *Paramuricea clavata* (Risso 1826) suffered the most drastic reductions in density and biomass over a broad spatial scale. The impact of mass mortality events on the demographic structure and dynamics of this species has been assessed in detail, providing valuable information and tools to understand the species' ability to respond to perturbations in the face of climate change (Santangelo *et al.*, 2007; Cupido *et al.*, 2009; Santangelo *et al.*, 2015). However, the role of connectivity on the observed recovery of the affected populations has been ignored, attributing the increase of recruits after adult mortality events to local replenishment by the high reproductive output of surviving colonies (Santangelo *et al.*, 2015). An assumption motivated by the low dispersal potential attributed to *P. clavata* based on high genetic differentiation at small spatial scales (less than 30 meters) observed in non-impacted populations (Mokthar-Jamaï *et al.*, 2011; Arizmendi-Mejía *et al.*, 2015).

In this study, we examine the genetic diversity, genetic structure and contemporary migration patterns of *P. clavata* among populations affected and non-affected by mass mortality events related to heat waves in the Ligurian Sea. In particular, we attempt to answer the questions: 1) do disturbed populations show a signal of reduced genetic diversity? and 2) did connectivity play a role in the recovery of the affected populations?

Furthermore, this study represents a regional baseline for future comparative studies of genetic variation of the species in the face of increasing environmental change and potential disturbances induced by climate variability.

### 2.1.3 Material and Methods

### 2.1.3.1 Sampling

Colonies of the red gorgonian *P. clavata* were sampled by SCUBA diving at seven different locations (depth ranging from 25 to 40 meters) along the Ligurian Sea during May of 2014 (Figure 2.1.1), following a hierarchical sampling design. Colonies height varied from 30 to 60 cm, with most of them measuring between 35-45 cm, thus being older than 15 years (Cupido *et al.*, 2012). Small (< 3 cm) branch fragments from 26 to 37 colonies were collected in two different sites (separated by a distance of 30 m - 1 km) within each location, except in Punta Mesco and Cerboli Island. In Punta Mesco and Cerboli Island, colonies were sampled only at one site due to restricted sampling permission (Table 2.1.1). All samples were preserved in 95% ethanol and stored at 4 °C.

In the Ligurian Sea, mass mortality events due to heat waves were reported in 1999 and 2003. The sampling design included two populations of *P. clavata* in which those events have been investigated: Portofino (POF1 and POF2) (Cerrano *et al.*, 2005;) and Portovenere (POV1 and POV2) (Cupido *et al.*, 2008; Santangelo *et al.*, 2015). A reduction of 78.3% in density was recorded in Portovenere, while up to 50% of the colony density was lost in Portofino. After the mass mortality events in Portovenere, recruitment increased five-fold with respect to pre-mortality values, with recruits becoming the dominant class (Santangelo *et al.*, 2015). In Portofino, Cerrano *et al.* (2005) observed a two-fold increase in recruitment inducing significant population recovery after three years, even reaching higher densities than before the mortality event. Although mass mortality events of *P. clavata* were not reported in other locations within the Ligurian Sea, other sessile invertebrates were affected by the increases in water temperature at same time in the area of Bergeggi (Parravicini *et al.*, 2010).

## 2.1.3.2 Microsatellite genotyping

Total genomic DNA was extracted from a total of 372 colonies using the DNA extraction kit NucleoSpin Tissue by Macherey-Nagel. All individuals were genotyped at six polymorphic microsatellite loci developed for *P. clavata*, as used in Mokhtar-Jamaï *et al.*, (2011): Parcla 09, Parcla 10, Parcla 12, Parcla 14, Parcla 17 (Molecular Ecology Resources Primer Development Consortium *et al.*, 2010) and Par\_d (Agell *et al.*, 2009). Genotyping was carried out on an ABI 3130 Genetic Analyzer using an internal size standard (GeneScan 600 LIZ; Applied Biosystems), and allele scoring was performed using Peak Scanner Software version 1.0 (Applied Biosystems).

### 2.1.3.3 Genetic diversity

Observed and Nei's (1987) unbiased expected heterozygosity (Ho and HE, respectively) were estimated using Genetix v.4.05 (Belkhir et al., 2004). Allelic richness (Na) was estimated using FSTAT v.2.9.3.2 (Goudet 2001), while rarefied allelic (Ar) and private allelic richness (Ap) were calculated with a rarefaction procedure using the HP-Rare software (Kalinowski 2005). Linkage disequilibrium was tested for all loci using Genepop v.4.2 (Rousset 2008) as implemented for online use (http://genepop.curtin.edu.au). The test for Hardy-Weinberg equilibrium was computed for each locus using the null hypothesis of no heterozygote deficiency, and the level of significance was calculated with a Markov Chain algorithm with parameters set as default (100 batches and 1000 iterations per batch). Single and multilocus Fis were estimated using Weir and Cockerman's (1984) fixation index using Genepop. The presence of null alleles was estimated using the Expectation Maximization (EM) algorithm of Dempster et al., (1977) in Freena software (Chapuis and Estoup 2007).

Due to the mass mortality events that affected *P. clavata* populations in the region during the past decade (Santangelo *et al.*, 2015), evidence of recent changes in effective population size was tested using Bottleneck v.1.2.02 following the Step-wise Mutation Model (SMM) (Piry *et al.*, 1999).

### 2.1.3.4 *Population genetic structure*

Population genetic structure was estimated using the *Fst* estimates of Weir and Cockerham (1984) with Genepop, and following the Excluding Null Allele (ENA) method in Freena. The significance of pairwise genetic differentiation among samples was computed with an exact test using the default parameters in Genepop (100 batches and 1000 iterations per batch).

For linkage disequilibrium and *F*<sub>ST</sub> estimates, FDR corrections (Benjamini and Hochberg 1995) were applied in order to adjust significance levels for false discovery rates.

Isolation by Distance (IBD) was tested at a regional scale through the correlation between pairwise  $F_{ST}/(1-F_{ST})$  values and the geographical distance between populations with a Mantel test (Mantel 1967) using the Isolde program implemented in Genepop. Geographical distances were measured in Google Earth by using set points (determined as the center of the area of distribution were the samples were collected) and measuring both straight-line and along the coast distances. Significance level of correlation between genetic differentiation and geographical distance among samples was computed using 10,000 permutations.

To estimate the extent of gene diffusion, multilocus genotypes were autocorrelated within spatial distance classes using the kinship coefficient of Loiselle as implemented in Spagedi v.1.4 revealing the distance at which the random effects of genetic drift, not gene flow, are the primary determinants of genetic composition (Hardy and Vekemans 2002). Significant positive coefficients suggest that colonies within a specific distance class are more genetically related than colonies randomly taken from any distance class. The first x-intercept of the autocorrelogram, which corresponds to the average distance at which the genetic similarity between any two quadrats drops below 0.0, is termed the 'genetic patch size' (Sokal and Wartenberg 1983). Spatial distance intervals for kinship comparisons were constructed in such a way that the number of pairwise comparisons within each distance interval was approximately constant (between 3000 and 8000 pairs among distance classes). A total of 13 distance classes were considered: class 1: 0 – 1 km; class 2: 2 – 23 km; class 3: 23 – 28 km; class 4: 28 – 40 km; class 5: 40 – 75 km; class 6: 75 – 89 km; class 7: 89 – 104 km; class 8: 104 – 125 km; class 9: 125 – 153 km; class 10: 153 – 177 km; class 11: 177 – 229 km; class 12: 229 – 251 km; class 13: 251 - 283 km. Significance of the observed coefficients relative to the expected was tested for each class using 10,000 random permutations of locations.

To evaluate the number of clusters (K) in the dataset without prior information regarding the geographic location of the samples, a Bayesian method implemented in Structure v.2.3.4 (Pritchard *et al.*, 2000; Falush *et al.*, 2003, 2007) was used. Structure was



run under the admixture model, choosing the assumption of correlated allele frequencies and the option of recessive alleles to cope with null alleles, as suggested by Falush (2007). Mean and variance of log likelihoods were estimated for the number of clusters, K=1 to K=12. Ten runs were performed for each K with 500,000 iterations and a burn-in period of 50,000. In order to identify the number of clusters that best fit the data, the resulting output files were then analyzed using the Evanno method in Structure Harvester v.0.6.94, implemented for online as use (http://taylor0.biology.ucla.edu/structureHarvester/) (Earl and vonHoldt 2012). For the chosen K, the results were averaged using Clumpp v.1.1.2 (Jakobsson and Rosenberg, 2007), and the graphical representation was performed in Distruct v.1.1 (Rosenberg 2004).

### 2.1.3.5 Migration and genetic drift

Recent average migration rates and first generation migrants were estimated as proxies of contemporary connectivity among populations. The amount and direction of gene flow over the last several generations among locations was estimated by performing a maximum-likelihood-based analysis. Migrate-n v.3.6 was used to estimate  $\Theta$  and M based on microsatellite data (Beerli and Felsenstein 2001). Theta is defined as 4Neµ for a diploid system with nuclear microsatellite loci, where Ne is the effective population size and µ is the mutation rate per generation and site. M is the mutation scaled migration rate, defined as  $m/\mu$ , representing the relative contribution of immigration and mutation to the variability brought into the population, whereas *m* is the fraction of new immigrants found in the population per generation. On the other hand, first generation migrants were detected with a threshold of 95% confidence using the Bayesian computation of Rannala and Mountain (1997) (n=10000;  $\alpha = 0.05$ ) in Geneclass v.2.0 (Piry *et al.*, 2004).

The level of genetic drift was estimated using the standard linkage disequilibrium method (Hill 1981) with Waples' (2006) correction to compute a contemporary value of the effective population size (Ne). The computations were



performed with NeEstimator v. 2.01 (Do *et al.,* 2014) under the random mating model, excluding rare alleles with frequencies of less than 0.02 and using the jackknife option to estimate confidence intervals.

### 2.1.4 Results

## 2.1.4.1 Genetic diversity

All of the microsatellite loci were polymorphic with POF1 showing the highest number of alleles (11), while BER1 presented the lowest (7). Mean allelic richness (Na), rarefied allelic richness (Ar) and private allelic richness (Ap) among populations were  $8.98 \pm 1.25$ ,  $5.96 \pm 0.52$  and  $0.40 \pm 0.15$ , respectively. Rarefied allelic richness ranged from 4.96 for BER1 to 6.55 for POV2. The private allelic richness varied from 0.08 for SES2 to 0.58 for POV1. Observed (Ho) and unbiased expected heterozygosity (HE) ranged from 0.49 for CER to 0.71 for SES2 with a mean value of  $0.59 \pm 0.06$ , and from 0.67 for BER1 to 0.76 for POF1, with a mean value of  $0.70 \pm 0.03$ , respectively (Table 2.1.2). No significant linkage disequilibrium was found among loci (P > 0.05 after FDR correction).

Estimates of null allele frequencies varied between 0 for Parcla09, Parcla10, Parcla12, Parcla14 and Par\_d to 0.26 for Parcla12.

Multilocus estimates of  $F_{15}$  ranged between 0.04 (BER1) to 0.33 (CAL1 and CER). All the values were significantly different from zero (P < 0.001) with the exception of BER1, meaning that this population does not show significant levels of heterozygosity deficiency. All loci showed significant deviations from Hardy-Weinberg expected genotype frequencies.

Recent changes in effective population size were evidenced in BER2 and POV1 due to an excess of the heterozygosity expected from the observed number of alleles, given the sample size under the assumption of mutation-drift equilibrium for the Stepwise Mutation Model (SMM) (P = 0.008 and P = 0.015, respectively). Despite the fact that the sites in Portofino (POF1 and POF2) were affected by mass mortality events, no recent changes in effective populations size were observed (P > 0.05).

## 2.1.4.2 Population genetic structure

Global multilocus  $F_{ST}$  indicated strong genetic differentiation between sites for *P*. *clavata* in the Ligurian Sea ( $F_{ST} = 0.154$ ; P = 0.0001). Pairwise  $F_{ST}$  values ranged from 0 to 0.181, and all but three pairwise comparisons (BER1 vs. BER2, SES1 vs. SES2 and PME vs. POV1) were significant after FDR correction (Table 2.1.3). No significant differences were found between pairwise  $F_{ST}$  and pairwise  $F_{ST}$  corrected for null alleles (t-test, P = 0.163), which suggests that the effect of null alleles is negligible. A significant but weak pattern of Isolation by Distance (IBD) was detected for both measures of distance: straight-line (R<sup>2</sup> = 0.22; P < 0.01) and along the coast (R<sup>2</sup> = 0.17; P < 0.001).

Six genetic clusters were identified by the Bayesian clustering analysis (K = 6,  $\Delta$ K = 12.26) (Fig. 2.1.2): 1) BER1 and BER2 composed the BER cluster; 2) POF1 and POF2 formed the POF cluster; 3) SES1 and SES2 composed the SES cluster; 4) PME, POV1 and POV2 were grouped in the PMP cluster; 5) CAL1 and CAL2 formed the CAL cluster; and 6) CER was designed as the CER cluster.

## CHAPTER 2.1

The kinship coefficient of Loiselle was positive and significant for the 0-23 km (P < 0.001), 23 – 28 km (P < 0.001) and 28 – 41 km (P < 0.001) distance classes (Fig. 2.1.3). The genetic patch size was estimated to be 40 km.

### 2.1.4.3 Migration and genetic drift

Maximum likelihood-based analysis using Migrate-n revealed that values of M (=  $m/\mu$ ; migration/mutation) were >1 in all populations, meaning that the effect of migration (m) is larger than the effect of mutation ( $\mu$ ). Overall, migration was found to be bi-directional among closely distributed sites (less than 1 km), and unidirectional (westward) among distant sites. Migration rate decreased as distance between sites increased, finding still evidence of migration among the most distant locations (> 250 km). The cluster that received most immigrants over multiple generations was PMP



(mean M = 18.21 ± 5.53), which comprises one of the populations affected by mass mortality due to heat waves in the region (Portovenere). The cluster POF, corresponding to the other affected population (Portofino) showed a mean value of M = 10.50 ± 7.92. The cluster of CER was identified as the one receiving the lowest amount of immigrants (mean M =  $6.14 \pm 3.02$ ). In terms of contribution of migrants, the cluster of PMP showed the highest value (mean M =  $18.02 \pm 8.16$ ), and the cluster of CAL the lowest (mean M =  $6.15 \pm 3.02$ ). The effective number of migrants per generation Nem (=  $\Theta$ M/4) was > 0.22 in all sites.

The analysis of first generation migrants revealed that the clusters of populations affected by mass mortality events were the largest contributor of migrants (PMP = 40.62% and POF = 28.12%). On the other hand, the clusters of BER and CAL were identified as the smallest contributors of immigrants with 3.12% in both cases (Fig. 2.1.4). In terms of reception of immigrants, the clusters CAL and PMP received the highest proportion of migrants (15.9% and 14.81%, respectively), with the latter receiving immigrants for almost all other clusters (except BER). On the contrary, the cluster BER received the lowest amount of immigrants (3.33%), all coming from the neighboring cluster POF.

The harmonic mean estimates of Ne ranged from 36.2 for POV1 to 4707.4 for POF2, with a negative value obtained for CAL2 (Table 2.1.2), indicating that the effect of drift would be different for each population (Waples and Do 2010). There is no indication that disturbed populations exhibited the lowest values of Ne.

## 2.1.5 Discussion

We present genetic evidence that supports the role of connectivity in the recovery of marine populations affected by climate-induced disturbances. Although no



temporal comparisons can be made given the lack of data on the genetic structure of *P. clavata* before the mass mortality events in the Ligurian Sea, our results suggest that the contribution of immigration and gene flow within a network of connected populations helped the fast recovery of the affected populations by increasing the density of recruits and maintaining their genetic diversity (see Santangelo *et al.*, 2015).

### 2.1.5.1 Do disturbed populations show a signal of reduced genetic diversity?

Among the affected populations, evidence of a genetic bottleneck was only observed in Portovenere. No sign of a reduction in effective population size was found in Portofino. In fact, the largest value of Ne was estimated for that population. However, as reported by Waples and England (2011), it is likely that the estimated Ne values are upwardly biased given the high migration rates (m > 0.2) found among populations. Values of observed and expected heterozygosity (Ho and H<sub>E</sub>, respectively), allelic richness (Na) and effective population size (Ne) were smaller in Portovenere than in Portofino. However, given that the population of Portofino significantly recovered after three years, showing higher densities than before the mortality event (Cerrano *et al.*, 2005), it is not surprising to find a faster recovery of genetic diversity in this population.

Several authors had previously shown that bottleneck tests can fail to detect well-known population collapses in several species of conservation concern due to a combination of factors like the timing and duration of the bottleneck, immigration and the amount of pre-bottleneck genetic diversity (Spong and Hellborg 2002; Aguilar *et al.*, 2008; Henry *et al.*, 2009). Also, model simulations have demonstrated that when settlement is limited by space availability, population disturbances can lead to opposite effects of drift on genetic diversity depending on the conditions of the population prior to the disturbance: accelerating genetic drift when population census size is high with recruitment limitation, or decelerating genetic drift when population census size is low with no recruitment limitation (Padrón and Guizien, 2015).

Evidence of a population bottleneck was also found in the cluster of Bergeggi. Although, to our knowledge, no reports of mass mortality events exist for *P. clavata* in



that area, we believe that the observed signal may be also due to the heat waves that affected other sessile invertebrate species in the area (Parravicini *et al.*, 2010). In addition, the cluster of Bergeggi is characterized by the lowest contribution and reception of migrants from other populations, thus, with the lowest values of allelic richness, the retention of a genetic bottleneck signature in this site and its high genetic differentiation is not unexpected.

## 2.1.5.2 Did connectivity play a role in the recovery of the affected populations?

The analysis of migration over several generations revealed that all neighbouring populations are connected in both directions. In all populations, the effective number of migrants per generation suggests that, even though migration brings additional genetic variability into populations, local populations will continue diverging due to the combined effects of mutation and genetic drift, with the population of Bergeggi being the most noted case.

As observed by Arizmendi-Mejía *et al.*, (2015) when analyzing the genetic structure of *P. clavata* in the Balearic Islands (Spain), contemporary migration seems to play a major role in shaping the genetic structure of *P. clavata* populations in the Ligurian Sea. However, the percentage of individuals identified as migrants in our analysis was larger than previously reported and not limited to neighboring clusters, indicating that effective connectivity, even among distant clusters, is not negligible. The two populations affected by mass mortality events (Portofino and Portovenere) were found to be the most important contributors of migrants in the region, with Portovenere also receiving most of the migrants coming from all of the other populations. A possible explanation for the larger contribution of migration observed in this study maybe due to a combination of the increased reproductive output of the surviving colonies (Santangelo *et al.*, 2015), along with the sudden availability of suitable habitat after the mass mortality events (e.g. Bramanti *et al.*, 2015).

According to our results, spatial heterogeneity in the levels of gene flow coincide with the predominant pattern of surface currents recorded in the region during the


spawning period of *P. clavata*, which is characterized primarily by westward surface currents, and eastward currents around the areas of Portovenere and Calafuria creating a small gyre (Istituto Idrografico della Marina 1982; Cupido *et al.*, 2012). As an example, we found that the population of Bergeggi receives five times less migrants than the Calafuria population and, in general, it seems that the populations on the eastern part of the Ligurian Sea tend to receive more migrants than the populations on the western part of the region.

The genetic patch size for *P. clavata* was estimated to be 40 km in the Ligurian Sea. A size much larger than the continuous extent of suitable habitat (rocky bottom) around the seven locations sampled (see Table 2.1.1). The extension of the genetic patch size found in our study, compared to previous findings in other regions (Mokhtar-Jamaï *et al.*, 2011), suggests that dispersal limitation for *P. clavata* depends on local hydrology, demography and ecology rather than being related only to the life history trait of the species.

#### 2.1.5.3 Implications of connectivity in a climate change scenario

This study represents a case in which, a species that has previously shown high genetic structuration and very limited dispersal, seems to exhibit higher connectivity after disturbances induced by climate change. This is particularly relevant now that the paradigm shift from "open" to "closed" marine populations has been nourished recently by growing evidence on the ability of populations to recover in isolation, due to high values of local retention (Gilmour *et al.*, 2013; Beger *et al.*, 2014). Nonetheless, model simulations have shown that high rates of local retention can weaken connectivity among populations (Figuereido *et al.*, 2014) and reduce their genetic diversity (Padrón and Guizien 2015).

Seascape genetic inference can be strongly influenced by the recent demographic history of populations. Without knowledge of the recent demographic collapse of some of the studied populations, the same results could have been ascribed to high isolation among populations, disregarding the effect of the seascape on the observed pattern of

spatial genetic structure. Therefore, our study highlights the importance of integrating demographic and genetic data in order to accurately assess the impact of climateinduced disturbances. Particularly with the application of population genetic tools that allow the estimation of contemporary migration in order to evaluate different scales of connectivity, and its role on populations' resilience.

According to climate change projections, extreme events will increase in frequency in the future (Meehl *et al.*, 2000), causing more frequent and severe demographic fluctuations, especially in small and isolated habitat patches. According to our results, this could drive the loss of genetic variability in sessile marine populations, with selection most likely acting within a context of increasing influence of genetic drift. This study increases our understating on the scale of connectivity of *P. clavata* in the Ligurian Sea, and helps identify key populations in need of protection. Our results provide empirical evidence on the role of connectivity in maintaining genetic diversity in unstable populations affected by climate change, and should be taken into account in effective marine spatial planning.

Genetic connectivity of the white gorgonian, *Eunicella singularis,* in the NW Mediterranean

#### 2.2.1 Abstract

Understanding the development and maintenance of connectivity patterns is essential in marine spatial planning and the proper design of Marine Protected Areas (MPAs). However, the mapping of past and future connectivity is a current scientific challenge. Population genetics has been one of the most frequently used tools to provide direct and indirect measures of connectivity given that, for benthic sedentary species, it has been assumed that the dispersal potential of the larvae was correlated with gene flow. Here we present an analysis of the genetic population structure and regional migration patterns for *Eunicella singularis* in the Gulf of Lions and Spanish Catalan Coast using eight polymorphic microsatellite loci. Our results show that *E. singularis* is able to disperse over 200 km. Nonetheless, high levels of genetic population structure were observed at various spatial scales: a strong separation was observed between populations of the Gulf of Lions and the Spanish Catalan Coast, in agreement with the hydrodynamical isolation of the Gulf of Lions by the Northern Current. Moreover, within the Gulf of Lions, genetic structuration of *E. singularis* populations could be explained by flow structuration.



#### 2.2.2 Introduction

For marine sessile benthic organisms with a pelagic larval phase, dispersal is crucial for the maintenance of demographic and genetic connection among populations. Long dispersal facilitates gene flow among distant populations, contributing to outcrossing and reducing genetic differentiation among populations. Conversely, limited dispersal increases the probability of inbreeding and leads to high genetic differentiation among populations (Hellberg *et al.*, 2002). Furthermore, the scale and patterns of connectivity will determine the ability of these sessile species to withstand severe disturbances (Cowen and Sponaugle 2007). The resilience of some populations may depend on the supply of larvae from distant and/or undisturbed populations. In some other cases, local production may be the only source of recruitment and could lead to slow and limited recovery (Almany *et al.*, 2009).

Given the difficulties in assessing patterns of dispersal through direct empirical data, genetic methods are frequently used to estimate population connectivity, by quantifying gene flow and barriers to gene flow (Lowe and Allendorf 2010). The existence of tests that allow the assignment of individuals to their populations of origin through the use of highly variable DNA markers (e.g. microsatellites) also enables the inference of current migration patterns and can reveal additional information about the effect of seascape processes on the reproductive success of immigrants (Hedgecock *et al.,* 2007; Underwood *et al.,* 2007; Baguette *et al.,* 2012).

Ecosystem engineers, such as gorgonian corals, play a fundamental ecological role in maintaining the diversity, biomass and structural complexity of hard-bottom communities in the Mediterranean Sea (Weinberg 1978; Ballesteros 2006). Several anthropogenic and climate-related disturbances, such as destructive fishing practices (Bavestrello *et al.*, 1997) and seawater temperature increases have severely affected gorgonian species causing multiple mass mortality events along the northwestern Mediterranean (Perez *et al.*, 2000; Cerrano *et al.*, 2005; Coma *et al.*, 2006, 2009). From these gorgonian species, the white gorgonian *Eunicella singularis*, is the most abundant and



widely distributed in the north western Mediterranean (Weinberg 1978; Linares *et al.,* 2008; Gori *et al.,* 2011).

*E. singularis* is an internal brooder species that reproduces annually, which means that every year its larvae are produced sexually through internal fertilization of the eggs, brooded within the polyp, and then released into the water column during the summer months of June and July (Weinberg and Weinberg 1979; Ribes *et al.*, 2007). The larvae of *E. singularis* exhibit high activity frequency and energetic content (Villadrich 2015). Furthermore, the presence of symbiotic algae may supply them extra energy (Weinberg and Weinberg 1979), suggesting that the species may have high dispersal capacity.

Being such an abundant and widely distributed species, identifying the factors that drive the patterns of population structure is not straightforward. The variability in spatial distribution and density of *E. singularis* populations across the NW Mediterranean are believed to be related to the requirement for hard bottom substrates (Gori *et al.*, 2011), and other factors (e.g. predation, interspecific competition, disturbances) rather than intraspecific competition (Linares *et al.*, 2008). Although Cataneo (2011) studied the population genetic structure of *E. singularis* in the Mediterranean basin, discerning the pattern of realized connectivity among populations was not possible, probably due to the limited number of microsatellite loci analyzed. Therefore, the processes shaping the population density and spatial distribution of the species at a regional scale have not yet been revealed.

The Gulf of Lions (NW Mediterranean Sea) is one of the most productive areas of the Mediterranean. Characterized by high concentration of nutrients, low temperature and low salinity due the influence of the Rhône river (the largest river of the basin), the waters of the Gulf of Lions are confined over the shelf by a density front, which is in dynamic equilibrium with Liguro-Provençal current (UNEP-MAP-RAC/SPA 2013). This area has been identified as an isolated hydrodynamic province in larval dispersal studies (Guizien *et al.*, 2012, 2014; Rossi *et al.*, 2014), and in biogeochemistry studies



(Nieblas *et al.*, 2014), suggesting it would be the scale of closure of metapopulation for benthic sessile invertebrates. Although an area of interest for studies of genetic structuration on commercial fish species (Lenfant and Planes 1996; García de León *et al.*, 1997; Morat *et al.*, 2014), no analysis of population genetic structure has been carried out for other widely distributed sessile invertebrate species in the region.

Therefore, by assessing the genetic population structure and regional migration patterns using eight polymorphic microsatellite loci for *E. singularis* in the Gulf of Lions and along the Spanish Catalan Coast, this work represents the first analysis of genetic connectivity for a non-commercial species in the region, and aims to answer the following questions: 1) does *E. singularis* have dispersal capacity? 2) does genetic differentiation enables to identify the Gulf of Lions as the closure scale of a metapopulation?, and 3) can the pattern of genetic population structure be explained by the regional hydrodynamics?.

#### 2.2.3 Material and Methods

#### 2.2.3.1 Study area and regional hydrodynamics

The Gulf of Lions (hereafter GoL) is a large, microtidal continental shelf of 100 km radius located in northwestern Mediterranean Sea (Figure 2.2.1). It is mostly covered by soft sandy sediment down to 30 m depth. However, fragmented patches of hard bottom substrate can be found in the eastern (Marseille), central (Leucate and Agde), and western (Banyuls and Cap de Creus) parts of the Gulf (Guizien *et al.*, 2012). Circulation in the GoL is driven by three main forcings: 1) Strong continental winds (the Mistral and the Tramontane) that frequently generate upwellings and downwellings along the coast, as well as transient currents and eddies 2) the Northern Current (NC), which usually flows along the shelf break of the GoL from the Ligurian Sea to the Catalan Sea; 3) several rivers, particularly the Rhône, that provide freshwater and important quantities of nutrients and organic matter (Millot 1990; Hu *et al.*, 2009; Campbell *et al.*, 2013).



A general westward circulation characterizes the GoL, with the NC acting as a barrier limiting the transport of particles and larvae across the shelf break. In fact, numerical simulations have shown that the only successful way for anchovy larvae to escape the GoL is in front of Cap de Creus (Nicolle *et al.*, 2009). During summer (spawning period of *E. singularis*), both simulated and empirical data have shown the presence of a persistent anticyclonic circulation in the southwestern part of the GoL. During the LAgrangian Transport EXperiment (LATEX), this eddy was observed between mid-July to mid-August, at which point it finally approaches the Northern Current and interacts with it (Hu *et al.*, 2009). Further south, along the Catalan shelf, intense and persistent eddies have also been registered in summer. These so called Catalan eddies are believed to originate in the GoL, in the lee of Cap de Creus (Rubio *et al.*, 2009; Garreau *et al.*, 2011). It has been hypothesized that the continuity between the LATEX and Catalan eddies, along with the presence of a northward coastal current off the Cap de Creus could transport passive larvae from the Catalan Sea towards the Gulf of Lions (Garreau *et al.*, 2011).

#### 2.2.3.2 Sampling

Small apical fragments (<3 cm) of 13-36 colonies of *E. singularis* were randomly collected by scuba divers in 30 different sites along the NW Mediterranean, from Marseille (France) to Blanes (Spain) (Figure 2.2.1; Table 2.2.1). The sites were distributed from less than 1 km to over 300 km apart. A total of seven locations were visited (Côte Bleue, Plateau des Aresquiers, Cap d'Agde, Côte Vermeille, Cap de Creus, Montgri and Costa Brava) and the number of sites sampled in each location varied according to the density of *E. singularis* and the size of the patch with suitable habitat (rocky bottom). In France, four locations were visited (Côte Bleue, Plateau des Aresquiers, Cap d'Agde, Côte Vermeille). In Côte Bleue, the location with the lowest density of colonies, three

sites were sampled; four sites in Plateau des Aresquiers and Cap d'Agde, while six sites were sampled in the Côte Vermeille due to the extensive coverage of rocky bottom in the area. In Spain three locations were visited (Cap de Creus, Montgri and Costa Brava). In



Cap de Creus, the location with the highest frequency of occurrence and the highest densities of *E. singularis* (Gori *et al.*, 2011) eight sites were sampled; while, given the lower occurrence of *E. singularis* in the Costa Brava (Linares *et al.*, 2008), only two sites were sampled. All of the samples were preserved in 95% ethanol and kept at -20 °C until DNA extraction.

#### 2.2.3.3 DNA extraction and microsatellite genotyping

Total genomic DNA was extracted from 793 colonies of *E. singularis* using the Promega's DNA extraction kit Wizard. All individuals were genotyped at eight polymorphic microsatellite loci specifically developed for *E. singularis*: C21, C30 and C40 (Molecular Ecology Resources Primer Development Consortium 2010) and *E. verrucosa*: Ever003, Ever004, Ever009, Ever013 and Ever014 (Holland *et al.*, 2013). All the loci were amplified using the PCR protocol described in Holland *et al.*, (2013). PCR products were analyzed on an ABI 3130 Genetic Analyzer using an internal size standard (GeneScan 500 LIZ; Applied Biosystems). The scoring of alleles was carried out with GeneMapper v.3.5 software (Applied Biosystems).

#### 2.2.3.4 *Genetic diversity*

We analyzed the genetic diversity of *E. singularis* samples by estimating observed heterozygosity (H<sub>o</sub>) and Nei's (1973) unbiased expected heterozygosity (H<sub>e</sub>) with Genetix v.4.05 (Belkhir *et al.*, 2004).

Allelic richness (Na) was estimated using Genodive v.2.0b.27 (Meirmans and van Tienderen 2004), while rarefied allelic (Ar) and private allelic richness (Ap) were calculated with a rarefaction procedure using the HP-Rare software (Kalinowski 2005) with the minimum number of genes set to 20. In order to investigate levels of inbreeding in each site, single and multilocus F<sub>IS</sub> were estimated using Weir and Cockerman's (1984) fixation index using Genepop.

#### 2.2.3.5 *Genetic structure*

Population structure was calculated using different approaches: measure of genetic differentiation (F<sub>ST</sub>), which estimates levels of genetic differentiation among populations based on the variance of allele frequencies; a Bayesian clustering method, which by sorting individuals into Hardy–Weinberg/linkage equilibrium populations, creates clusters of individuals that share similar patterns of variation; and a hierarchical analysis of molecular variance (AMOVA), which allows to estimate the partition of molecular variance (F-statistics) into its components, among groups of populations,



among populations within groups and within populations.

Global and pairwise population genetic differentiation was measured with Weir and Cockerman's  $\theta$  estimator of FsT in Genepop, and its significance was computed with the exact test of genic differentiation using the default parameters. Pairwise FsT estimates were also calculated following the excluding null allele (ENA) method in Freena (Chapuis and Estoup 2007). In order to visualize the genetic relationships among sites, a genetic distance matrix derived from the pairwise FsT was used to construct a graph of principal coordinates analysis (PCA) in Genalex.

The spatial genetic structure was analyzed by testing the presence of a pattern of Isolation By Distance (IBD). A linear regression between pairwise F<sub>ST</sub> / (1-F<sub>ST</sub>) values and the linear geographical distances between samples was performed, and the significance of the regression was tested with a Mantel test (n=10,000) (Mantel 1967) using the Isolde program implemented in Genepop. For all analyses, significance levels were corrected using a false discovery rate (FDR) correction for multiple tests (Benjamini & Hochberg 1995) when necessary.

Unlike Cataneo (2011), the Bayesian clustering method implemented in Structure v.2.3.4 (Pritchard et al., 2000; Falush et al., 2003, 2007) was used to evaluate the number of clusters (K) in the dataset without prior information regarding the geographic location of the samples. As suggested by Falush (2007) when dealing with non-discrete populations, we selected the admixture model and chose the assumption of correlated allele frequencies and the option of recessive alleles to cope with null alleles. Mean and variance of log likelihoods were estimated for the number of clusters, K=1 to K=30. Ten runs were performed for each K with 1,000,000 iterations and a burn-in period of 100,000. In order to identify the number of clusters that best fit the data, the resulting output files were then analyzed using the Evanno method in Structure Harvester v.0.6.94, implemented for online as use (http://taylor0.biology.ucla.edu/structureHarvester/) (Earl and vonHoldt 2012). The clustering observed for K=2 were then retained to subdivide the samples in two groups



and evaluate additional sub-structuring within each cluster. Clumpp v.1.1.2 (Jakobsson and Rosenberg, 2007) was used to average the results for the chosen K, and the graphical representation was performed in Distruct v.1.1 (Rosenberg 2004).

A hierarchical analysis of molecular variance (AMOVA) (1,000 permutations) was performed with Arlequin v.3.5 (Excoffier *et al.*, 2005) using the clusters (K=2) and subclusters (K=3) defined by Structure.

#### 2.2.3.6 Migration patterns

Contemporary connectivity among populations was analyzed by estimating first generation migrants and average migration rates over the last several generations. The amount and direction of gene flow over the last several generations among sites was estimated by performing a Bayesian analysis using BayesAss 1.3 (Wilson and Rannala 2003). First generation migrants were detected using the Bayesian computation of Rannala and Mountain (1997) (n=10,000;  $\alpha$  = 0.01) in Geneclass v.2.0 (Piry *et al.*, 2004).

In order to complement the information on contemporary connectivity and estimate the extent of gene diffusion, multilocus genotypes were autocorrelated with spatial distance classes using the kinship coefficient of Loiselle, as implemented in Spagedi v.1.4 (Hardy and Vekemans 2002). The kinship coefficient of Loiselle (Loiselle *et al.*, 1995) provides a relative index of relatedness between each pair of individuals. Significant positive coefficients suggest that colonies within a specific distance class are more genetically related than colonies randomly taken from any distance class. Spatial distance intervals for kinship comparisons were constructed in such a way that the number of pairwise comparisons within each distance interval was approximately constant (around 30000 pairs among distance classes). A total of 11 distance classes were considered: class 1: < 1 km; class 2: 1 – 5 km; class 3: 6 – 22 km; class 4: 23 – 30 km; class 5: 31 – 48 km; class 6: 49 – 90 km; class 7: 91 – 105 km; class 8: 106 – 121 km; class 9: 122 – 135 km; class 10: 136 – 178 km; class 11: 179 – 260 km. Significance of the observed coefficients relative to the expected was tested for each class using 10,000 random permutations of locations.



#### 2.2.4 Results

#### 2.2.4.1 Genetic diversity

Observed heterozygosity (Ho) varied from 0.46 to 0.67 with a mean value of 0.53  $\pm$  0.05. Expected heterozygosity (He) ranged from 0.47 to 0.64 and presented a mean value of 0.56  $\pm$  0.03. The highest number of alleles (Na) was found in Montgri (MON3) (6.00), while Côte Bleue (CBL2) exhibited the lowest value (3.25). Rarefied allelic richness (Ar) and private allelic richness (Ap) among populations were 2.82  $\pm$  0.21 and 0.06  $\pm$  0.05, respectively. Rarefied allelic richness ranged from 2.35 for Cap d'Agde (AGD2) to 3.74 for Montgri (MON1). The private allelic richness varied from 0.01 for Cap d'Agde (AGD3) and Cap de Creus (CCR6) to 0.20 for Montgri (MON1). No significant differences were found in the values of number of alleles, rarefied allelic richness and private allelic richness among the clusters identified by Structure (Kruskal-Wallis, P-values > 0.05). Multilocus F<sub>15</sub> values ranged from -0.136 for Plateau des Aresquiers (PAR3) to 0.251 for Cap de Creus (CCR2). Significant differences in F<sub>15</sub> were found among clusters (Kruskal-Wallis, P-value < 0.001) (Table 2.2.2).

### 2.2.4.2 Genetic structure

Overall Fst value was high (0.185) and statistically significant (P-value < 0.001). Pairwise Fst values (Table S1) ranged from -0.004 for PAR1 vs. PAR2 to 0.305 for MON2 vs. CBL2. No significant differences were found between pairwise Fst and pairwise Fst corrected for null alleles (t-test, P > 0.05). Almost all pairwise differentiation tests were significant (after FDR correction). The non-significant comparisons included some sites separated by 10 km or less (PAR1 vs. PAR2, PAR1 vs. PAR4, PAR2 vs. PAR3, AGD2 vs. AGD3, CVE4 vs. CVE6, CCR6 vs. CCR2 and CCR8 vs. CCR2), while others involved one site in Côte Vermeille separated by over 100 km (CVE5 vs. PAR1, CVE5 vs. PAR3, CVE5 vs. PAR4 and CVE5 vs. AGD1).

The Bayesian clustering analysis identified two genetic clusters (K = 2) (Figure 2.2.2A): one cluster grouping all of the sites within the Gulf of Lions (17 sites), and another cluster composed of all the sites sampled along the Spanish Catalan Coast (13 sites). The results of the AMOVA confirmed the clustering structure (P < 0.001) (Table S2). Analysis of sub-structuration within each cluster, on the other hand, showed contrasting results. The cluster of Gulf of Lions exhibited significant levels of genetic structuration (P < 0.001), identifying three genetic sub-clusters (K=3) corresponding to the geographic origin of the samples (Figure 2.2.2B; Table S3). Conversely, although the results from Structure indicated genetic subdivision within the cluster of the Spanish Catalan Coast as well (K=3), the pattern of structuration was not statistically significant (P > 0.05) (Figure 2.2.2C; Table S4).

The PCA analysis illustrated the close relationship among sites within each location for the Cluster of France, and the overall distinctiveness of each site in the



cluster of Spain (Figure 2.2.3). A positive and significant correlation between  $F_{ST}$  /(1- $F_{ST}$ ) and linear geographic distances was found for the GoL and Spanish Catalan Coast ( $R^2 = 0.19$ ; P-value < 0.01; Figure S1). A pattern of IBD was also observed within each genetic cluster, although a stronger relationship was found for the cluster of the GoL, relative to the cluster of the Spanish Catalan Coast ( $R^2 = 0.39$ ,  $R^2 = 0.20$ , respectively; P-value < 0.01 in both cases; Figure S1). However, the slope of the linear regression suggests that the pattern of IBD is weak.

### 2.2.4.3 Migration patterns

The analysis of first generation migrants identified 22 colonies (2.77% of all individuals; Figure S2) as originating from a site different to the one they were collected at. This result revealed a higher intra-cluster migration than inter-cluster migration between the two genetic clusters (Gulf of Lions and Spanish Catalan Coast), and showed that inter-cluster migration is uni-directional and only takes place in a westward fashion (from France to Spain), although over very long distances. Two colonies in Montgri (MON3) were identified as immigrants coming from Côte Vermeille (CVE4) (>50 km) and Côte Bleue (CBL2) (>200 km) (Figure 2.2.4). Within each cluster, on the other hand, migration can be bi-directional and also over long distances (> 150 km). In the cluster of France, for example, first generation migrants found in two different sites of Côte Vermeille (CVE1 and CVE2) were identified as coming from Côte Bleue (CBL1 and CBL2). While in the cluster of the Spanish Catalan Coast, one first generation migrant found in the northernmost population of Cap de Creus (CCR1) was identified as originating from the southernmost population of Costa Brava (CBR2).

The kinship coefficient of Loiselle was positive and significant for the first three distance classes: < 1 km (P < 0.001), 1 - 5 km (P < 0.001) and 2 – 22 km (P < 0.001) distance classes (Figure 5). The genetic patch size, based on the first x-intercept of the autocorrelogram, was estimated to be 30 km.

Recent migration rates among *E. singularis* populations were mainly unidirectional in the NW Mediterranean, with some cases of bi-directional migration at low rates. Highest values of migration rate were found between Cap d'Agde and Plateau des Aresquiers within the Gulf of Lions, and between Cap de Creus and Costa Brava along the Spanish Catalan Coast (Table S5).

#### 2.2.5 Discussion

The present study supports the expectation of dispersal capacity for *E. singularis*, commonly within 30 km of their natal colony, as demonstrated by spatial autocorrelation analysis, and supplemented by successful migrants over very long distances (> 200 km).



The dispersal distance found for *E. singularis* in this study is much larger than those reported for other common gorgonian species, like the red coral (*Corallium rubrum*) and the red gorgonian (*Paramuricea clavata*) (Costantini *et al.*, 2007; Mokhtar-Jamaï *et al.*, 2013; Ledoux *et al.*, 2010). The variability of inferred dispersal distances based on genetic studies of gorgonian species suggests that regional hydrodynamics may play an important role in filtering the dispersive potential of a species, causing the size of genetic patches to be related to the sites rather than the species. Nonetheless, it must be taken into account that gene flow between distant localities does not necessarily take place over one generation. It may also occur over multiple generations following a steppingstone model, as it has been observed in other invertebrate species (Kimura and Weiss 1964; Crandall *et al.*, 2012). And even if long distance migration did take place over one generation, as evidenced by the first generation migrant identified in Montgri (MON3) as coming from Côte Bleue (CBL2), it does not mean that it is a recurrent event.

It is well known that only a few successful larvae may be enough to provide sufficient genetic connectivity across broad spatial scales over evolutionary time (Hedgecock *et al.,* 2007). Successful dispersal of *E. singularis* over such long distances in the NW Mediterranean could actually be a rare event happening only once during the lifetime of the species.

Strong genetic differentiation was found between the Gulf of Lions and Spanish Catalan Coast genetic clusters. Unlike the few studies of population genetic structure in the region, which found no genetic differentiation among populations of commercial fishes in the Gulf of Lions and the Catalan Sea (Lenfant and Planes, 1996; García de León *et al.*, 1997; Morat *et al.*, 2014), this study evidences a clear discontinuity of gene flow between populations north and south of Cap de Creus, separated by only ~20 km. The influence of the NC may be a good explanation for the genetic discontinuity among populations along the French and Spanish coasts.

This study confirms the presence of a biophysical barrier that seems to interrupt gene flow for sessile benthic invertebrates across the north and the south of Cap de



Creus, at least when larval dispersal takes place during summer, as shown by Mokhtar-Jamaï *et al.* (2011). Guizien *et al.* (2014) identified the Gulf of Lions as the scale of closure for metapopulation simulations of soft-bottom species based on arguments regarding hydrodynamical isolation by the NC and habitat spatial distribution. The present study suggests that metapopulation modelling for *E. singularis* could also be performed within the Gulf of Lions, although hard bottom substrate extends south of Cap de Creus.

Similarly, patterns of population genetic connectivity within each cluster may be well explained by the local hydrodynamics. The observed pattern of genetic population structure of E. singularis in the NW Mediterranean has a weak relationship with geographic distance. Overall, our results are evidence of the strong influence of regional hydrodynamics on the dispersal, successful recruitment and genetic connectivity of E. singularis. In the GoL, the potential interaction of the LATEX and Catalan eddies, along with the general circulation patterns may explain the observed structuration. The patterns of genetic connectivity of *E. singularis* presented here confirm the findings of Guizien et al., (2014), in which numerical simulations of a metapopulation model for benthic invertebrate species in the GoL showed that hydrological connectivity could spread individuals over the entire region. They identified areas of the western tip of the GoL as sink sites given that low retention rates did not allow for local persistence, while the center of the Gulf was characterized by areas that enhance metapopulation resistance by creating loops of persistence (Hastings and Botsford 2006). Moreover, low levels of larval retention, which would limit outcrossing among populations, may explain the high genetic differentiation of Côte Vermeille, relative to other locations in the GoL.

A strong pattern of genetic structure subdividing the cluster of France into three subgroups: Côte Bleue, Cap d'Agde and Côte Vermeille, evidence the possibility of finding genetic structuration even in the presence of the migration. Within the cluster of France, samples from Côte Vermeille seem to be more genetically distinct when compared to all other sites. The only exception was the site CVE5, which did not show significant differences when compared to most of the sites in Plateau des Aresquiers



(except PAR2) and one site in Cap d'Agde (AGD1), indicating that the LATEX eddy may indeed facilitate the transport of larvae between Plateau des Aresquiers and Côte Vermeille. Furthermore, the presence of first generation migrants found in two sites of Côte Vermeille that were identified as originating from Côte Bleue, in addition to the lack of immigrants found in Côte Bleue, evidences the influence of the general westward circulation in the GoL. Bi-directionality in the direction of immigration was only observed between the sites of Plateau des Aresquiers and Côte Vermeille.

Within the cluster of the Spanish Catalan Coast, all sites were found to be significantly different from each other, although no spatial pattern of structure was observed. First generation migrants were found both upstream and downstream from their natal colony, demonstrating that the local pattern of present-day migration in this cluster is bi-directional. A pattern that also reflects the local hydrodynamics and suggest that the Catalan eddy influences the transport of larvae of *E. singularis*, retaining most of the larvae in that region and limiting its transport north of Cap de Creus.

Even though this study allows making inferences on the seascape processes driving the genetic structuration of *E. singularis* in the NW Mediterranean, which seems to be primarily the regional hydrodynamics, we cannot discard the influence of local demography, nor disentangle the role and relative contribution of hydrology and demography in the shaping of the observed patterns of genetic connectivity. Differences in patterns of genetic structure and IBD observed for *E. singularis* among different spatial scales may also influenced by ecological and environmental factors over gene flow. Processes disrupting dispersal or selecting on post-settlement survival are well recognized as potential drivers of genetic differentiation among populations, which becomes particularly relevant when dealing with in non-equilibrium populations (Sexton *et al.*, 2013). Observed patterns of genetic population structure could be driven by local recruitment regulation, temporal variability of dispersal patterns or equilibrium between local recruitment and immigration. Their influence on genetic structure has been inferred from previous empirical studies on species with larval dispersal (White *et* 



*al.*, 2010; Nanninga *et al.*, 2014). Numerical simulations have demonstrated that high local retention can lead to high genetic drift, despite the presence of immigration, as a result of quick convergence to saturating density (Padrón and Guizien 2015).

Although several gorgonian species exhibit low and episodic recruitment (Lasker 1990; Coma *et al.*, 2004; Linares *et al.*, 2008), Lasker and Porto-Hannes (2015) found no difference in the genetic population structure of recruits and adults of the gorgonian *Antillogorgia elisabethae*, suggesting that limited variation in recruitment patterns could explain the adult population structure of a gorgonian species in the Caribbean Sea. In the NW Mediterranean, small colonies of *E. singularis* have been usually found in high proportions relative to adult colonies, which has led to indications that the species is characterized by high recruitment rates (Linares *et al.*, 2008; Gori *et al.*, 2011). Nonetheless, temporal variability has also been reported with an alternative dominance of recruits vs. adult colonies (Linares *et al.*, 2008). Furthermore, low recruitment rates have been found as a result of mortality events (Coma *et al.*, 2006).

It would be therefore necessary to combine approaches that integrate biophysical, demographic and genetic data to truly understand the seascape dynamics in the region and its influence on the evolutionary history of *E. singularis*. Nonetheless, the present results have important implications for the recovery and management of *E. singularis* in the face of increasing climate change by identifying the GoL as the appropriate scale of closure for the metapopulation of *E. singularis*. We provide an important baseline for the understanding of genetic connectivity among populations of one of the most common gorgonian species in the northwestern Mediterranean Sea.

## **CHAPTER 3**

Testing processes of genetic structuration for *Eunicella singularis* in the Gulf of Lions

#### 3.1 Abstract

Understanding the complex processes driving marine population connectivity is a challenge that requires the use of tools that integrate bio-physical models with information regarding the demographic and genetic linkages resulting from the larval exchange among populations. To identify the most relevant processes driving demographic and genetic differentiation among populations of the white gorgonian (*Eunicella singularis*) in the Gulf of Lions, genetic structure patterns were simulated at the metapopulation scale, and compared to empirical analysis of genetic population structure using eight polymorphic microsatellite loci. The comparison between the modeled pattern of genetic structure of *E. singularis* with and without connectivity and the observations, suggests that migration structure in the Gulf of Lions induces both demographic and genetic differentiation among populations. However, some discrepancies persist.

#### 3.2 Introduction

The declining health of marine ecosystems around the world has lead to an increasing concern about the organization of uses of the marine space in order to balance human development with the protection of marine ecosystems, which is commonly known as marine spatial planning (Douvere 2008). However, given the complexity in the heterogeneity of marine populations and ecosystems, marine spatial planners cannot assume that populations will recover once the stressors are reduced. Hence, there is a



need to understand the processes that drive and maintain the spatial distribution of marine biodiversity (Crowder and Norse 2008).

Connectivity, understood as the exchange of individuals between populations (Cowen *et al.*, 2000), is a key characteristic affecting the dynamics, demography and genetics of marine metapopulations (Hanski 1999; Kritzer and Sale 2004). The effectiveness of Marine Protected Areas (MPAs) is thought to be dependent on the connectivity that exists among populations (Almany *et al.*, 2009; Gaines *et al.*, 2010). The demographic effect of the movement of individuals from one population to another is related to the potential rescue and re-colonization of disturbed populations, while the exchange and mixing of genes among populations enhances genetic diversity within populations and reduces the erosion of genetic variability (Baguette *et al.*, 2013).

For sessile benthic species with a pelagic larval phase, connections between populations are possible through larval dispersal only, which is also the time at which gene flow takes place. Therefore, connectivity among MPAs depends on the patterns and strength of larval dispersal. However, connectivity is not only a function of larval dispersal, but also of post-larval survival, which implies multiple spatial and temporal scales that are variable between and within species and locations (Pineda *et al.*, 2007).

Given the difficulties in conducting field studies of larval stages and their movements, due to the small size and tracking difficulty of larvae, inferences about levels of larval connectivity have commonly resulted from the use of two different approaches: biophysical modelling and population genetics (Paris *et al.*, 2007; Werner *et al.*, 2007). Modelling tools allow Lagrangian particle tracking driven by hydrological models to simulate the potential patterns and levels of dispersal among populations based in oceanographic and climatic data (Cowen *et al.*, 2006). The method using forecast of ocean currents in different climate change scenarios also has the potential to forecast larval connectivity in the future (Werner *et al.*, 2007). This approach allows us to make inferences on demographic connectivity, which has been defined as the degree to which population growth and vital rates are affected by dispersal (Lowe and Allendorf 2010).

The genetics approach, on the other hand, allows inferring aspects of realized connectivity integrated over many generations from empirical genetic data. The degree to which gene flow affects evolutionary processes within populations is known as genetic connectivity (Lowe and Allendorf 2010). Nonetheless, both approaches present limitations: neither larval post-settlement nor survival, which can significantly affect demographic connectivity, are considered explicitly in larval dispersal modelling (Armsworth 2002). Similarly, genetic methods are not capable to discern between dispersal and settlement bottlenecks in realized connectivity, and have no predictability potential in a changing ocean (Lowe and Allendorf 2010). Furthermore, population genetic models assume a mutation-drift equilibrium that is rarely reached in marine species, and thus, gene flow patterns can be strongly influenced by past population expansions and contractions (Benzie 1999). Therefore, none of the approaches on itself can provide all the information necessary to understand population connectivity and properly describe population persistence in a network of MPAs (Hastings and Harrison 1994; Marko and Hart 2011).

Despite the unsuitability of larval dispersal modelling and population genetic approaches to fully determine marine connectivity on their own, their complementary nature calls for an integration. A combination of ecological, demographic and genetic metapopulation models can provide an important tool for understanding the complexity of population connectivity (Levin 2006; Epperson *et al.*, 2010). Clarification of the influence that environmental and demographic factors have on connectivity and the patterns of genetic structuring are essential for the design of MPAs.

Recently, models that couple biophysical data with demography and population genetics have been developed (Galindo *et al.*, 2006; Kool *et al.*, 2009; Munroe *et al.*, 2012; Padrón and Guizien *in press*). Using these spatially-explicit models, it is possible to project the development of population genetic structure through time, resulting from demographic dynamics driven by local survival and larval transfer on a regional scale. However, these tools have rarely been applied in order to disentangle the seascape



processes driving the observed patterns of genetic structure in marine metapopulations of benthic sessile species (but see Foster *et al.*, 2012). Furthermore, reconciling the factors that are believed to be responsible for generating modeled genetic structure with the observed genetic patterns will lead to a better understanding of what the important processes actually are, and what would be the expected consequences if they were to change.

Gorgonian corals are an ideal study case for applying this approach. They have a sessile adult stage and a larval pelagic phase that allows the use of modelling tools to simulate their dispersal trajectories, without the confounding effect of adult migration. They are long-lived and slow-growing organisms, which facilitate the sampling of the same cohorts over different years. Their spatial distribution in discrete habitats allows the assessment of connectivity among separated sites. In this chapter, I test the effect of larval dispersal on the realized connectivity of the white gorgonian, Eunicella singularis, in the Gulf of Lions (northwestern Mediterranean Sea), as observed from empirical genetic data (Chapter 2). By combining realistic connectivity matrices resulting from a Lagrangian model of larval dispersal (Guizien et al., 2012), and a theoretical seascape demo-genetic model that projects the development of genetic structure for benthic sessile marine invertebrates (Padrón and Guizien 2015; Chapter 1), I evaluate the expected development of genetic structure among populations, and compare it to the observed patterns of genetic structure of *E. singularis* in the region. In particular, I ask the question: can larval dispersal alone explain driving the patterns of genetic connectivity observed in E. singularis within the Gulf of Lions?

#### 3.3 Methods

In order understand how populations of *E. singularis* are connected in the Gulf of Lions, I used a seascape genetic approach that combines the results obtained from three different levels of integration along a species life cycle of assessing connectivity (Figure 3.1). Firstly, larval connectivity was examined by using connectivity matrices that result



from a biophysical model, which incorporates a coastal circulation model and a Lagrangian model of larval dispersal. Then, demographic connectivity among populations was studied by using a spatially-explicit metapopulation dynamics model parameterized for the species. Finally, the genetic connectivity of *E. singularis* populations was assessed by analyzing empirical data and comparing the results to those obtained by the modelling approach.



Figure 3.1.- Conceptual model of the seascape genetic approach.

#### 3.3.1 Larval connectivity

Lagrangian larval dispersal simulations based on regional hydrodynamic simulations performed with the coastal circulation model SYMPHONIE, with a horizontal resolution of 750 meters (Marsaleix *et al.*, 2008). The fragmented rocky-bottom habitat of the white gorgonian in the Gulf of Lions, which is delimited by the 10 and the 30 meters isobaths, was described by sites of approximately the same width (~ 20 km) patchily distributed along the coast (Figure 3.2). Based on these criteria, larval transfer between eight sites was computed.

Larval dispersal was simulated by releasing larvae at the average site depth (20 m). Connectivity matrices containing larval transfer probabilities were produced for 20



sets of 10-day long spawning periods in spring 2004 and 2006 (Guizien *et al.*, 2014). Given the uncertainty on the Pelagic Larval Duration (PLD) of *E. singularis*, simulations were run for three different PLDs (two, three and four weeks). A total of 20 different connectivity matrices for each PLD were used for this analysis. In each connectivity matrix, columns represent source populations, rows represent destination populations, and cell contents describe the probability with which a given larvae migrates from a source population to a destination. Elements along the diagonal of the matrix correspond to levels of self- recruitment within a population.

To estimate the hydrological distance among populations using the realistic connectivity matrices from the rocky sites in the Gulf of Lions, I calculated a weighted average of 20 replicate connectivity matrices for two different years (2004 and 2006), for the three different PLDs (2, 3 and 4 weeks duration). In order to reverse the hierarchy of transfer probabilities among sites into distance, while maintaining linearity, the conversion of probability values into a measure comparable to distance of the mean connectivity matrices for each PLD, was done using the equation developed by Costa *et al.*, (in prep) (Figure 3.3):

where,

 $\alpha_{ij}$  = connectivity probability given by the connectivity matrices used in the metapopulation model.

#### 3.3.2 *Demographic connectivity*

A spatially-explicit metapopulation dynamics model that incorporates realistic connectivity matrices, and where recruitment success is limited by saturating population density was used to evaluate the fate of *E. singularis* in the Gulf of Lions (Eq. 1 and 2) (Guizien *et al.*, 2014).

Based on values obtained from previous demographic studies of *E. singularis*, the life expectancy of the species was set to 18 years. Considering a mean fecundity value of 27.8 larvae per cm, with an average colony branch length of 50 cm, total fecundity was set to 1400 propagules per individual. Saturating density was set to 40 individuals per m<sup>2</sup>.

In order to test the effect of larval dispersal (larval connectivity) on demographic connectivity, all demographic parameters in each site were the same and two groups of simulations were run: 1) One group that simulated a metapopulation, where the connectivity matrices resulting from the Lagrangian model of larval dispersal were used



to run the model for 100 years (sorting out randomly one of the 20 connectivity variants), and evaluate the fate of the metapopulation due to larval connectivity; 2) A second group simulating isolated populations, with the same procedure except that no connectivity (all diagonal terms) was set to zero. In this way the fate of the metapopulation could be explained by the demographic traits of the species and local retention alone.

Population abundance in each site was then compared among group of simulations.

#### 3.3.3 Seascape genetics model

The seascape genetics model (Chapter 1, Padrón and Guizien 2015), simulates the frequency of each allele k at any given time in every site i, as a result of mixing between the surviving individuals with allele k in site i and the input of new recruits with allele k, coming from any other site. All simulations were run for 100 iterations, one iteration being the time lapse between two reproductive events. The initial condition of genetic structure was defined by ten different alleles present simultaneously in every site. Simulations were repeated at least 200 times with different and random initial conditions of allele frequencies each time in order to evaluate output variability due to specific initial conditions.

As one of the most common measures of genetic diversity, Heterozygosity (He<sub>i</sub>), was estimated taking into account all individuals at each site i over time following the equation:

where  $p_{ik}(t)$  = frequency of the *k*th allele of *n* alleles in site *i* at time *t* [no units].

The values of heterozygosity were then compared to the ones obtained from the analysis of microsatellite data. Nei's standard genetic distance among sites was also calculated and used to construct a graph of principal coordinates analysis (PCA) in Genalex, also to be compared with the results obtained by the empirical analysis of



genetic data.

#### 3.3.4 Realized connectivity: genetic population structure

The patterns of genetic population structure of *E. singularis* in the Gulf of Lions were studied using eight polymorphic microsatellite loci (see Chapter 2.2 for detailed description of methods). For this particular analysis, a subset of the dataset presented in Chapter 2.2 was used, as the closure boundary of the *E. singularis* metapopulation was identified within the Gulf of Lions. A total of 413 colonies from 17 sites distributed along four different locations in the Gulf of Lions were examined (Côte Bleue, Plateau des Aresquiers, Cap d'Agde and Côte Vermeille).

Different analysis were carried out to compare the results obtained from model simulations of hydrological, demographic and genetic connectivity to the observed pattern of genetic structure of *E. singularis* in the Gulf of Lions, respectively:

1) Larval connectivity vs. realized connectivity: To test the influence of larval connectivity on the spatial genetic structuration of *E. singularis* in the region I assessed the presence of a pattern of Isolation By Distance (IBD). A linear regression between pairwise Fst / (1-Fst) values and both the linear geographical and hydrological distances between populations was performed, and the significance of the regression was tested with a Mantel test (n=10,000) (Mantel 1967) using the Isolde program implemented in Genepop. Geographical distances were measured between all sampled locations using Google Earth. Hydrological distances were calculated from the larval connectivity matrices, as it was previously described.

The resulting patterns of migration among populations were compared to the simulations on larval connectivity. Additionally, the results from the Bayesian clustering method implemented in Structure v.2.3.4 (Pritchard *et al.*, 2000; Falush *et al.*, 2003, 2007) (see Methods Chapter 2.2) were used to evaluate if the observed patterns of population structure corresponded to the patterns of larval exchange resulting from the connectivity matrices.

2) Demographic connectivity vs. realized connectivity: First generation migrants of E.



*singularis* were estimated as proxies of contemporary connectivity among populations in the Gulf of Lions (see Methods Chapter 2.2). Effective population size (Ne) was calculated using the NeEstimator software (Do *et al.*, 2014) and compared to the modeled values of density in each population.

3) *Modeled genetic connectivity vs. realized connectivity*: Modeled and observed levels of genetic diversity of *E. singularis* in the different populations along the Gulf of Lions were estimated and compares based on heterozygosity (H<sub>e</sub>) metrics. It is important to mention that, due to the spatial resolution of the connectivity matrices used to run the seascape genetics model, heterozygosity values could not be calculated for all three sites in each location. Instead, values were obtained for only one site in Cap d'Agde, Plateau des Aresquiers and Côte Bleue. Furthermore, in order to visualize the genetic relationships among sites, a genetic distance matrix derived from Nei's standard genetic distance measures, for both modeled and empirical genetic data, was used to construct a graph of principal coordinates analysis (PCA) in Genalex.

#### 3.4 Results

#### 3.4.1 Larval connectivity vs. realized connectivity

The analysis of larval connectivity among populations of *E. singularis* in the Gulf of Lions, showed that local larval retention can vary according to the different PLDs (two, three and four weeks). For a PLD of two weeks, the mean probability of local retention ranged from  $0.02 \pm 0.09\%$  in Côte Vermeille to  $1.03 \pm 1.2\%$  in Plateau des Aresquiers. For a PLD of three weeks, mean values ranged from 0 to  $0.05 \pm 0.04\%$  also for Côte Vermeille and Plateau des Aresquiers, respectively. While the mean values of local retention when considering a PLD of four weeks varied from  $0.01 \pm 0.01$  in Côte Vermeille, to  $0.56 \pm 0.13\%$  in Cap d'Agde. Overall, the highest probability of larval retention was found in the sites along the central part of the Gulf, between Cap d'Agde and Plateau des Aresquiers. On the two extremes of the diagonal of the connectivity



matrices (Côte Bleue and Côte Vermeille), the second highest values of larval retention were observed in Côte Bleue, while the sites of Côte Vermeille showed the minimum values of local retention, regardless of PLD (Figure 3.4).

The observed patterns of hydrological distance obtained from the connectivity matrices indicate that the shortest hydrological distances between sites are also found along the central region of the Gulf of Lions, between Plateau des Aresquiers and Cap d'Agde (Figure 3.4). Matrices of hydrological distances are not symmetric: hydrological distances are lower from east to west, than from west to east. The hydrological distance between Côte Bleue and all of the other sites in the Gulf of Lions is shorter than the distance between Côte Vermeille and any other site, whatever the PLD values. Furthermore, it seems that the hydrological distance between Côte Bleue and Côte Vermeille is also shorter than the distance from Côte Bleue to any other site within the Gulf, even to the closest site in terms of geographical distance (Plateau desAresquiers).

Regarding the genetic population structure of *E. singularis* in the Gulf of Lions, the Bayesian clustering analysis identified three genetic clusters (K = 3) which, although not completely isolated, allows the differentiation between Côte Bleue, Côte Vermeille and the grouping of Plateau des Aresquiers and Cap d'Agde (Figure 3.5).

Black lines represent the division among sampled populations.

The analysis of contemporary connectivity resulted in the identification of five recent migrants, which corresponds to 1.84% of the total number of samples analyzed. The origin of all the first generation migrants was identified: two immigrant colonies were found in Cap d'Agde, one originating from Côte Bleue and the other being native of Plateau des Aresquiers. The remaining three immigrants were found in Côte Vermeille, each one coming from a different population: Cap d'Agde, Plateau des Aresquiers and Côte Bleue. On the other hand, migration rates obtained from the Bayesian analysis revealed a bi-directional pattern of migration among all populations, except Côte Bleue, which did not show evidence of receiving migration from any other population within the Gulf of Lions. Also, although bi-directional migration was observed, migration rate values were generally higher from east to west (Figure 3.6).

A positive and significant correlation between  $F_{ST}$  /(1- $F_{ST}$ ) and linear geographic distances was found ( $R^2 = 0.43$ ; P-value < 0.01). The correlation increased when Fst/(1-Fst) was related to hydrological distances, for all the PLDs considered (Figure 3.7).

#### 3.4.2 Demographic connectivity vs. realized connectivity

The analysis of the metapopulation dynamics of *E. singularis* with and without connectivity scenario, showed how population density fluctuates and is maintained over time in all sites of the Gulf of Lions (Figure 3.8).

In the absence of connectivity (isolated populations), the populations of Plateau des Aresquiers and Cap d'Agde displayed population density close to saturation, while the sites in Côte Vermeille, Leucate and Côte Bleue exhibited local extirpation. When connectivity was incorporated, the populations from Plateau des Aresquiers, Leucate, Cap d'Agde and Côte Vermeille exhibited similar values of population density, while the lowest values were found in Côte Bleue

Values of effective population size (Ne) were higher in Côte Vermeille (305) and Côte Bleue (204), relative to Plateau des Aresquiers and Cap d'Agde (142 and 100, respectively). In all case the effective population size, although not represented in terms of density, were lower than the estimated number of individual colonies of *E. singularis* in each population.



#### 3.4.3 Modeled genetic connectivity vs. realized connectivity

Observed heterozygosity (Ho) varied from 0.53 to 0.59 with a mean value of 0.54  $\pm$  0.05. Modeled values of heterozygosity, after one population turnover (14 years), were very different between the two different connectivity scenarios (metapopulation vs. isolated populations). In the case of isolated populations, heterozygosity values remained high in all populations, and the variability around each value was relatively small among simulations (except in the cases of Cap d'Agde and Plateau des Aresquiers). Conversely, for the metapopulation scenario, modeled values of heterozygosity were similar to the ones obtained by the analysis of microsatellite data for *E. singularis*, except for Côte Bleue (Figure 3.9). However, variability around the mean was much higher for all populations in this latter case except, again, in the case of the Côte Bleue.

The PCA analysis of empirical genetic data revealed grouping among sites within each location, reflecting the genetic differentiation of three major clusters: eastern (Côte Bleue), central (Cap d'Agde and Plateau des Aresquiers) and western (Côte Vermeille) areas of the Gulf of Lions (Figure 3.10A). The sum of the two principal coordinates explained 83.81% (observations) and 99.42% (model) of the variability. The results from the PCA analysis from the modeled data also showed genetic differentiation among populations, which partially match the pattern obtained from the empirical genetic data (Figure 3.10B).

#### 3.5 Discussion

The use of a combined modelling-observation approach to evaluate the genetic structuration of *E. singularis* in the Gulf of Lions, enable to test the relative importance of the processes driving demographic and genetic patterns of *E. singularis* in the region. Larval connectivity alone was necessary and sufficient to reproduce the demographic hierarchy in the Gulf of Lions, with comparable density from Plateau des Aresquiers to Côte Vermeille, and lower density in Côte Bleue (Guizien and Bramanti *pers. comm*). Without connectivity, populations at the extremities of the Gulf of Lions would have been exterminated, which is not the case. Contemporary migration patterns inferred from the population genetic structure of *E. singularis* agree very well with larval connectivity hindcast in recent years, although based on spring ocean circulation. Thus highlighting potential connectivity of other benthic sessile invertebrate species with high dispersal capabilities in the region.

Recent migration observations suggest that connectivity between the central and western populations (Plateau des Aresquiers, Cap d'Agde and Côte Vermeille) to Côte Bleue is low. However, on a longer term, the inference of migration rates suggest bidirectional migration between Côte Vermeille and the populations in the central part of the Gulf (Plateau des Aresquiers, Cap d'Agde), which were not present in simulated hydrological matrices. Yet, such reversal flow may happen in the Gulf of Lions depending on the wind curls in the region (Tramontane and Mistral) (Estournel *et al.*, 2003), or when anticyclonic eddies form in stratified conditions (Hu *et al.*, 2009). This latter possibility should be further explored by simulating how connectivity evolved considering a spawning time in late spring-early summer, as observed off the Catalan coast (Gori *et al.*, 2007).

The estimation of effective population sizes (Ne), which determines the rate at which the change of the genetic composition of population caused will take place due to genetic drift, was lower than the census population size in the Gulf of Lions. However,



these results are no unexpected, violations of the assumptions of Hardy-Weinberg equilibrium, like inbreeding, overlapping generations, fluctuating population density and spatial structure are expected to reduced Ne and thus, induce a stronger effect of genetic drift (Charlesworth 2009). More interestingly is the finding that the relative values of Ne among *E. singularis* populations in the Gulf of Lions is in accordance with theoretical expectations (Charlesworth 2009; Padrón and Guizien 2015): lowest values of Ne found in populations characterized by highest levels of local retention (Cap d'Agde and Plateau des Aresquiers), and higher Ne estimates for populations with low values of local retention.

The results of this study have relevant implications for regional conservation and the spatial management of marine biodiversity at a regional scale. Both modeled and empirical genetic data indicates the presence of three genetically distinct clusters of *E. singularis* characterizing the eastern, central and western parts of the Gulf of Lions. Furthermore, the contemporary patterns of migration, with the support of the simulations of demographic dynamics, allow the identification of populations that are key to the persistence of the metapopulation: 1) being sustained mainly by self-recruitment and able to persist without connectivity, Cap d'Agde and Plateau des Aresquiers act as source populations for the region; 2) with the highest level of genetic diversity and high contribution of immigrants to all the sites in the Gulf of Lions the population; 3) exhibiting local extirpation without connectivity and the lowest levels of contribution of immigrants, the population of *E. singularis* in Côte Vermeille is a sink in the dynamics of the metapopulation.

Presently, three MPAs have been designed in the extreme tips of the Gulf of Lions: Parc Marin de la Côte Bleue, the Réserve Naturelle Marine de Cérbere-Banyuls (both targeted for the protection of hard-bottom species mainly) and, more recently, the Parc Naturel Marin de Golfe du Lion. The patterns of connectivity of *E. singularis* presented here suggest a low value of conservation for the Réserve Naturelle Marine de

Cérbere-Banyuls, while providing evidence of the importance of the Parc Marin de la Côte Bleue in protecting a source of genetic diversity.

Guizien *et al.*, (2014), based on numerical simulations of larval dispersal of polychaete species in the Gulf of Lions, had already identified the western and central areas of the Gulf as sink and source regions based on their values of retention rate, respectively. The findings of this thesis confirm their suggestions, while further demonstrating the genetic consequences of this pattern of connectivity in the metapopulation of a fragmented distributed gorgonian species in the region. Furthermore, it becomes evident that it is possible to observe genetic differentiation among populations even in the presence of migration. Overall, the modeled patterns of genetic structure are consistent with the field-based observations of genetic connectivity for *E. singularis* in the Gulf of Lions.

It is well known that larval dispersal does not necessarily equals to gene flow, given that migrants after successful settlement may fail to reproduce (Pineda *et al.*, 2007; Hedgecock *et al.*, 2007). A clear understanding of population connectivity should consider not only larval dispersal, but also include factors that affect post-recruitment survival (Munroe *et al.*, 2012). Numerical simulations have already shown how recruitment limitation enhances the strength of genetic drift when population size reaches saturating density (Padrón and Guizien 2015). This effect, for example, could explain the low values of genetic diversity observed in Cap d'Agde and Plateau des Aresquiers, which approach saturating density. Reversely, population density far from saturation seems to preserve a higher genetic diversity in Côte Bleue. Here, by incorporating aspects of density dependence, size structure and small-scale factors affecting dispersal and recruitment success (Armsworth 2002), I present a seascape genetics approach that provides a more realistic understating of the seascape processes driving connectivity and allows to disentangle their relative influence in driving patterns of realized connectivity.

It is important to mention that the model provides explanations rather than



predictions. One of the main objectives of the seascape genetics model used is to test whether a given set of parameters is consistent with the observed results, which, in the case of a positive confirmation, would indicate that the assumptions that were taken regarding the system are correct. Here, the assumption was that larval connectivity driven by the local hydrodynamics and habitat location and size was the only force shaping the genetic structuration of populations of *E. singularis* in the Gulf of Lions. Although in this case the potential connectivity of the species matched its realized connectivity, the results could be different for other sessile invertebrate species in the region, or even for the same species in a different geographical area. Furthermore, it must be noted that the temporal and spatial scales of the biophysical model used to simulate the potential trajectories of larval dispersal in the region influence the projected connectivity patterns. Increasing the horizontal spatial resolution of the hydrodynamical model, for example, extending spawning period to late spring or incorporating larval behavior could improve the description of hydrodynamic features that potentially affect larval transport in the western part of the Gulf of Lions (Guizien *et al.*, 2006).

Nonetheless, the use of seascape genetic approaches like the one presented here, which projections can be validated by field observations, provides a useful and effectively tool for understanding the processes that produce and maintain connectivity among marine populations.

## CONCLUSION

Within a context of growing concern regarding the conservation of marine biodiversity and the maintenance of population persistence in the face of increasing human and natural disturbances to the marine ecosystems (Lubchenko 2003), the aim of this thesis was to improve our understanding on the patterns of connectivity among populations of sessile invertebrate species and the processes driving their spatial structure at a regional scale. Connectivity, understood as a fundamental factor in the dynamics and genetic structure of metapopulations, affects the ability of marine populations to mitigate ecological perturbations (Hastings and Botsford 2006). However, with the variety and variability of the processes shaping the patterns of connectivity over a species life cycle being integrated over time, how can we identify the underlying processes that create and maintain the patterns of realized connectivity, observed from empirical genetic data?

This question is the yarn that threads the connection among the different chapters of the present work. Although different methods that allow estimating different types of connectivity (e.g. hydrological, demographic and genetic) have been developed by several researchers in the past (Kool *et al.*, 2013), the challenge remained in the integration of the results obtained from different approaches (Cowen and Sponaugle 2009; Burgess *et al.*, 2014). Chapter 1 examined how demographic traits and dispersal structure affect the genetic diversity and patterns of genetic differentiation among populations of benthic sessile invertebrate species. Presenting a novel 'seascape' genetics model that can be used as a tool for disentangling the relative contribution of seascape processes (e.g. hydrology and demography) on the genetic differentiation among apopulations, it is shown how pre- and settlement limitations have a strong influence on the genetic structure. Furthermore, this chapter exhibits how local disturbances may affect genetic diversity over a relatively short period of time, highlighting the role of transient demography in the genetic structuration of marine populations.

In Chapter 2, an assessment of the patterns of genetic connectivity of two common and widely distributed gorgonian species is presented as case studies for



evaluating the potential processes driving population genetic structure at a regional scale. The results from this chapter highlight the role of connectivity in the potential recovery of populations after ecological disturbances. For *Paramuricea clavata* in the Ligurian Sea, frequent migration was found within 40 km. *Eunicella singularis* in the NW Mediterranean Sea exhibited strong spatial patterns of genetic structure at a regional scale, allowing the identification of the limit of closure of a metapopulation formed by fragmented rocky habitats within the Gulf of Lions. Levels of migration demonstrated the dispersal capabilities of both species over long geographic distances (>100 km). However, the inference of population connectivity from genetic data alone cannot reveal the underlying processes that create and maintain the patterns of genetic structure (Lowe and Allendorf 2010).

It is in Chapter 3 where an attempt to discern the seascape processes responsible for the observed pattern of genetic connectivity of a benthic sessile species is presented. Given the lack of a high-resolution hydrodynamical model for the Ligurian Sea, the assessment was only possible for the case of *E. singularis* in the Gulf of Lions. To test whether larval dispersal alone could lead to the realized connectivity of this species, a comparison of the modeled vs. empirical patterns of population genetic structure was carried out. The results from this chapter put in evidence the possibility of observing high levels of genetic differentiation among populations even in the presence of migration in the Gulf of Lions. Moreover, it is shown that both genetic and demographic differentiation among populations of *E. singularis* can be explained by the regional spatial structure of dispersal alone.

The integrative and quantitative approach employed in this thesis, involving regional hydrodynamics, larval dispersal, demography and population genetics goes significantly beyond the qualitative measures typically used to evaluate the effect of some aspects of life history of marine species on genetic structuring, such as PLD (Selkoe and Toonen 2011). The lack of a consistent fit with expectations (the longer the PLD the weaker the genetic differentiation among populations) is a proof of the complexity of



factors influencing settlement and the overestimation of genetic metrics used as proxies to infer genetic connectivity, such as Fst.

Within the context of metapopulations, it is also important to consider that one of the characteristics that differentiate a metapopulation from a set of discrete populations with high levels of connectivity is the asynchrony in the dynamics of each one of the subpopulations that constitute it (Sale *et al.*, 2006). A property that must be evaluated in order to understand how its temporal variability could influence management and have potential implications for conservation. Asymmetrical dispersal within a metapopulation may result in source-sink population dynamics that are particularly relevant in the design of MPAs (Crowder *et al.*, 2000).

The model presented in Chapter 1, as has been demonstrated in Chapter 3, provides a tool for quantitatively assessing the genetic response of a metapopulation due to changes in some of the seascape processes that are assumed to influence the system, which is particularly relevant in marine spatial planning. The results from this type of sensitivity analysis can help identify key populations for conservation. In the case of *P. clavata* in the Ligurian Sea, the populations of Punta Mesco and Portovenere seem to act as a source of migrants potentially contributing to the genetic diversity of the metapopulation. For E. singularis in the Ligurian Sea, on the other hand, from the viewpoint of demographic connectivity, the populations of Cap d'Agde and Plateau des Aresquiers are identified as a source of larvae enhancing the persistence of the metapopulation. While from the genetics point of view, the population of Carry-le-Rouet seems to be the source of genetic diversity. Interestingly, the sink dynamics of the Côte Vermeille in the Gulf of Lions is congruent in both demographic and genetic approaches. Nonetheless, there are many ways in which further research could improve the sensibility of the model and, thus, our capacity to discern the relative contribution of the processes shaping the patterns of genetic structure at smaller spatial scales.

From the modeling perspective, higher spatial and temporal resolution data could enhance our understanding on the fine-scale hydrodynamic features that affect



near shore processes, and influence the estimated levels of local retention in the populations of interest. Some of the discrepancies found between the modeled and observed patterns of genetic differentiation among populations may, in fact, be due to this issue. The spatial resolution of the model used in this work may not be high enough to accurately estimate the levels of local retention in areas with high geographic heterogeneity. For example, levels of local retention in Côte Vermeille may be underestimated, given that high levels of genetic differentiation (as observed from the analysis of empirical genetic data in Chapter 2.2) are usually expected from sites with higher levels of local retention. In addition, the lack of knowledge about the behavior of the larvae as well as the PLD of the species (*E. singularis*) constrained a more realistic simulation of the larval trajectories in the region.

In terms of demography, one important limitation of the model is that, although taking into account overlapping generations, it does not incorporate distinct age/size classes. Temporal variability of settlement in gorgonian species has been previously reported (Linares *et al.*, 2008; Gori *et al.*, 2011), which could potentially lead to different patterns of connectivity among cohorts. Sensitivity analysis carried out by Bramanti *et al.* (2015) showed that variation of demographic parameters have different effects on the fate of a metapopulation depending on the size classes affected. Furthermore, although much difficult to estimate, field measurements of population size, survival and fecundity within subpopulations could also improve the accuracy of the model outputs.

The potential temporal variability of connectivity patterns among cohorts could be examined by other empirical estimates of genetic data. Although genetic assignment tests have been proven very useful to evaluate contemporary migration among populations (Lowe and Allendorf 2010), parentage analysis provides a direct measure of pedigree. The advantage of this method is that allows identifying the parents of the recruits collected in the population, permitting to determine the relationship between dispersal and the demographic structure of the population. However, to establish these relationships it is necessary to collect an exhaustive number of samples, representative

of the studied population. An interesting alternative approach would be to evaluate the patterns of genetic connectivity for each age/size class in order to identify if the relative contribution of the processes shaping connectivity changes over time and/or during the lifetime of the species (Goffredo and Lasker 2006). However, the complex growth trajectories of gorgonian species can mask the relationship between size and age (Lasker and Porto-Hannes (2015) assessed and compared the genetic structure of recruits and adults over several years for the gorgonian *Antillogorgia elisabethae* in the Caribbean, however, they did not find significant differences among them.

The selection of an appropriate metric to infer genetic connectivity among populations must be highlighted as well. The most common measures of population differentiation (e.g. Fst and Gst) could be misleading due to the effect of variance in effective population size and the non-equilibrium conditions of most natural populations (Waples and Gaggiotti 2006). Furthermore, analysis of population genetic structure and the identification of genetically distinct clusters, does not allow inferring the degree of 'isolation' or 'connectedness' of marine populations. Populations identified as being genetically distinct, like the case of Côte Vermeille from Chapter 2.2, may, in fact, not be able to persist over time without connectivity, as observed in Chapter 3. The use of direct methods, like assignment tests and parentage analysis, should then be the priority in studies attempting to evaluate genetic connectivity among marine populations.

Overall, it becomes clear that, given the complexity of the processes that drive and maintain marine population connectivity over time, there is no reason to believe that two similar patterns of connectivity will be the result of the exact same processes. Disentangling their relative contribution to the realized connectivity of benthic sessile species should be approached with careful regards of the species' life history and the region it inhabits. In this study, genetic and demographic differentiation of *E. singularis* in the Gulf of Lions seemed to be explained by larval dispersal alone. However, a



different scenario may be found for the same species in another region, or for a different species in the same region.

Nonetheless, the sensitivity of genetic structure to the patterns of hydrological connectivity has important implications for genetic connectivity in a changing world. Climate change is expected to influence PLD, local retention and thus, connectivity patterns among marine populations in the Mediterranean (Andrello *et al.*, 2014). Predictions on the potential effect are, however, complicated by the synergetic (additive or compensating) effects of increasing seawater temperature on environmental (current velocity and direction) and biological (survival, reproductive output, etc.) factors. An increase of the hydrological distance among populations may reduced gene flow and, thus, augments their genetic differentiation. Conversely, increased dispersal may enhance gene flow among populations and lead to a reduction of population differentiation and potential for local adaptation.

To reach a more realistic integration of connectivity on conservation planning within a context of changing marine ecosystems, it would be then necessary to integrate through modelling the potential effect of multiple demographic traits and spatial structure of dispersal for several marine sessile species and how they will be influenced by human activities and climate change at a regional scale. A challenging task that calls for a collaborative multi-disciplinary approach that could greatly influence marine spatial planning for the persistence of marine populations over time.
