Résumé

Les ressources génétiques naturelles du Tilapia du Nil (Oreochromis niloticus) se trouvent en Afrique. Ces ressources sont menacées en raison de modifications des habitats naturels des poissons et des introductions incontrôlées d'espèces ou de souches exotiques. Les populations de tilapia du Nil qui vivent dans des habitats extrêmes sont emblématiques de cette situation. Elles représentent des ressources génétiques originales et potentiellement utiles pour l'aquaculture. Cependant, les populations sont menacées soit par des modifications fortes de l'environnement soit par l'introduction d'espèces exotiques dans La caractérisation de ces populations constitue la première étape de leur protection et par conséquent leur utilisation en aquaculture. Dans notre étude, nous nous sommes concentrés sur deux populations différentes de tilapia du Nil. L'une d'entre elles vie dans le lac alcalin 'Crocodile Lake' (10 590 S / cm, pH 10) qui est un lac de cratère situé dans Central Island, au milieu du lac Turkana. La deuxième population (ou groupe de population) vie dans les sources chaudes (Hot Springs) du marais de Loboi (Loboi Swamp) près du lac Bogoria au Kenya. Ces poissons vivent dans une eau caractérisée par des températures élevées, autour de 36 ° c. Toutes les populations ci-dessus (Crocodile Lake et Loboi swamp Hot Springs) ont connu ou connaissent un certain nombre de pressions sélectives de la part de leurs environnements difficiles. Pour le lac Crocodile, les poissons ont certainement du trouver un moyen d'excréter leurs déchets azotés car à pH 10, l'excrétion n'est pas possible par simple diffusion. Pour les populations de sources chaudes, la plupart des individus devraient être des mâles car les hautes températures sont connues pour induire une masculinisation chez O. niloticus. Cette population doit avoir accumulé des mutations nécessaires pour lui permettre de surmonter les effets masculinisants des températures élevées. Pour étudier ces populations, nous avons utilisé la morphométrie géométrique et des marqueurs génétiques (microsatellites et 16 ADNmt) et nous les avons comparés à d'autres populations proches de la région. En outre, trois gènes liés au sexe (Cyp19a, Wt1b, AMH) ont été analysés en utilisant des marqueurs SNP dans trois populations de tilapia du Nil habitant les sources chaudes du marais de Loboi, et nous les avons comparés à ceux que l'on observe chez huit autres populations de l'Afrique de l'Est, la région soudano-sahélienne et éthiopiennes. Des différences morphologiques significatives ont été observées entre toutes les populations étudiées, y compris entre les trois populations voisines du marais Loboi, et entre les deux populations génétiquement liées du Crocodile Lake et du lac Turkana. Nous concluons de cette analyse que les différences morphologiques observées peuvent avoir comme origine pour une part des différences génétiques et pour une autre part des facteurs environnementaux. De même, toutes les populations étudiées sont génétiquement différenciées, et nous avont montré que les populations du marais Loboi et celle du lac Baringo ont été introgresséess par des gèes de O. leucostictus. Les analyses des gènes liés au sexe ont révélé que le gène AMH est un gène candidat pour la détermination du sexe chez le tilapia du Nil, avec 12 SNPs montrant de fortes associations avec le sexe phénotypique des individus. Néanmoins, il n'existe pas de modèle général de la détermination du sexe, il semble plutôt que les mécanismes de détermination du sexe sont différents suivant les populations de cette espèce et qu'il n'existe pas de mécanisme unique pour l'espèce entière.

Abstract

Nile tilapia (Oreochromis niloticus) natural genetic resources are found in Africa. These resources are threatened due to modifications of the natural habitats of fishes and uncontrolled introductions of alien species or strains. Nile tilapia populations living in extreme habitats are emblematic of this situation. They represent original and potentially useful genetic resources for Aquaculture. However, the populations are threatened either by strong modifications or introduction of alien species in their habitats. Characterizing these populations constitutes the very first step of their protection and consequently their utilization in aquaculture. In our study we concentrated on two different populations of Nile Tilapia. One living in the alkaline Crocodile Lake (10,590 uS/cm, 10 pH) which is a Crater Lake located in the central Island of Lake Turkana. The second group of population inhabit the hot springs of Loboi Swamp near Lake Bogoria in Kenya. These fish are living in water characterized by high temperatures. around 36°C. All above populations (Crocodile Lake and Loboi Swamp Hot springs) may have experienced some selective pressures to cope with their challenging environments. For Crocodile Lake, fish may have found a way to excrete their nitrogenous wastes because at pH 10, excretion is not possible by simple diffusion. For the hot spring populations, most individuals should have been males as high temperature is known to induce masculinization in O. niloticus. This population may have accumulated adequate mutations to enable them overcome masculinizing effects of high water temperature. To study these populations we used geometric morphometrics and genetic markers (16 microsatellites and mtDNA) and compared them with other related populations from the region. In addition, three sex-linked genes (Cyp19a, Wt1b, amh) were analysed using SNP markers in three populations of Nile tilapia inhabiting hot springs of Loboi Swamp, and compared them to eight other populations from East Africa, Sudano-Sahelian and Ethiopian regions. Significant morphological differences were observed in all populations studied, including three closely related populations of Loboi Swamp, and two genetically related populations from Lake Turkana basin. Both genetic differences and environmental factors were responsible for the observed morphological differences. Similarly, all studied populations were genetically differentiated, and we demonstrated that populations from Loboi Swamp and Lake Baringo have been introgressed by O. leucostictus genes. Analyses of the sex-linked clustered revealed that amh gene is a candidate gene for sex determination in Nile tilapia, with 12 SNPs showing strong associations to phenotypic sex. Nevertheless there is no general pattern of sex determination, rather it seems that sex determination mechanisms are different with respect to populations, but is not characteristic or unique for the entire species.

1. General introduction

1.1 Context of the research

Nile tilapia (*Oreochromis niloticus*, Linnaeus 1758) is a member of the family *Cichlidae* (3000 species), which are mainly distributed within tropical and sub-tropical regions of the world. The Nile tilapia has been a major source of proteins in developing and emerging countries, but is now also a prime fish commodity in developed countries (Fitzsimmons, 2001). As a result, the fish has successfully been introduced and cultured in more than 100 countries around the world. From the pioneer work of Trewavas (1983), a number of studies have tried to document the variety of natural populations of Nile tilapia, especially their genetic characterisation (Rognon *et al.*, 1996; Agnèse *et al.*, 1997; Nyingi *et al.*, 2009; Bezault *et al.*, 2011). However, knowledge on their genetic structure still remains insufficient. In addition, some natural populations are poorly known (Lake Tanganyika for example) or unknown as evidenced by the recent discovery of a natural population in Kenya (Nyingi *et al.*, 2009).

Most if not all of the genetic natural resources of Nile tilapia exists in Africa and plays a major role in improvement of its cultured strains in other parts of the world. For example, the Genetically Improved Farmed Tilapia (GIFT) strain was developed from founder populations of Nile tilapia obtained from both wild populations and cultured strains (Eknath *et al.*, 1995; Eknath and Acosta, 1998). They used wild Nile tilapia germplasm acquired from Egypt, Ghana, Kenya and Senegal, and farmed strains of germplasm derived from Israel, Singapore, Taiwan and Thailand (Gupta and Acosta, 2004).

Even though Nile tilapia is an invasive species in many river drainages and has sometimes been accused of being behind the disappearance of some fish species (Ogutu-Ohwayo, 1990), its natural populations are also under threat (Nyingi *et al.*, 2007; Nyingi and Agnèse 2011). The main threat is certainly hybridization with other species or populations. This situation is becoming even more critical, especially after the recent introduction of Genetically Improved Farmed (GIFT) Strains of *O. niloticus* into Africa (Ansah *et al.*, 2014).

1.2 Natural populations of Nile tilapia

Trewavas (1983) was the first to study natural populations of Nile tilapia. Based on the study of their morphological characteristics, she described seven subspecies: *O. n. niloticus* from

West-Africa and River Nile, *O. n. baringoensis* from Lake Baringo, *O. n. sugutae* from River Suguta (Kenya), *O. n. eduardianus* from Lakes Edward, Albert, George and Tanganyika, *O. n. vulcani* from Lake Turkana, *O. n. cancellatus* from River Awash and Lake Tana, and *O. n. filoa* from hot springs in the Awash system.

This work has served as a reference for many years, and even now it is still considered as an important work on Nile and other tilapia species. However, a careful analysis of data provided on differentiation of the subspecies of the Nile tilapia reveals that Trewavas (1983) did not rely on large differentiations and also sometimes is very subjective. For instance, she used genital papilla and proteins of serum as differentiating characteristics between *O. n filoa* and *O. n. vulcani*, while she does not refer to these traits in the other subspecies. In several instances, she used dorsal fin formula (number of spines and rays of the fin) as a differentiating trait and yet these characteristics overlap largely between the subspecies (see table 35 page 144-145 in Trewavas, 1983). This is probably the reason why the author did not provide an identification key to the subspecies.

More problematic is the absence of any consideration or definition of what is or what should be a subspecies. Are they equivalent to Evolutionary Units (Ryder, 1986; Waples, 1991) or do they simply represent morphologically differentiated populations without any evolutionary significance? It is thus not easy to understand what was the "subspecies concept" adopted by this author. For example, *O. n. cancellatus* and *O. n. filoa* are present in the same drainage, the Awash River. This situation obviously would better fit into a classification of two entirely different species or two different eco-phenotypes of the same species. The same situation is found with *O. n. eduardianus* in Lake Edward, which is in contact with *O. n. niloticus* in the Nile River. Finally it appeared that the author observed some amount of variability between populations and found it "convenient to provide them with names, if only to preserve their identity for any further experimenter or fish manager" (citation from page 141, last sentence).

Hence there has been a need to carry out phenotypic studies to investigate morphological differentiation in Nile tilapia. New and more powerful techniques for morphological studies have been employed in fish studies including landmark-based geometric morphometric methods (Bookstein, 1991). With geometric morphometric, shape variations in different taxa or even populations can efficiently be compared. This technique involves collection of two or three-dimensional coordinates of biologically definable landmarks, elimination of non-shape variations through superimposition and performing statistical analysis of the resulting data on

shape variables (Dean *et al.* 2004). The technique also generates images of centroid shape, which represents the form of the sample, and can be used to infer morphological differences between different groups of organisms being studied.

The technique has been successfully used by Firmat *et al.* (2011, 2012) to differentiate 15 populations of Mozambique tilapia (*Oreochromis mossambicus*) from its native range in Mozambique, and feral populations in New Caledonia and Guadeloupe after their acclimatization to new environments. In Tanganyika, a study to differentiate four wild populations of cichlid *Tropheus moorii* from their pond raised F1 offspring was carried out using geometric morphometrics (Kerschbaumer and Sturmbauer, 2011). The wild populations of *T. moorii* were previously presumed not to differ in their morphology but only in coloration. However, the authors were able to observe clear morphological differentiations between these populations hence demonstrating that geometric morphometric analysis is able to differentiate even closely related populations.

In our study, we decided to employ the use of geometric morphometrics to determine morphological differences between some natural populations of *O. niloticus* in Kenya based on the fact that previous studies by traditional morphometrics had failed to reveal any discrete morphological variations. The main goals were: 1) to demonstrate that this technique can be a useful tool in assessing morphological diversity in this species at a large scale; 2) to investigate the morphological plasticity by comparing two populations of *O. niloticus* with same genetic background but living under different environmental conditions; and 3) to evaluate the impact of temperature on morphology.

More recently, the use of genetic techniques (allozymes, mtDNA sequences, microsatellites) has enabled more detailed and reliable description of different populations of the Nile tilapia. For example, Agnèse *et al.* (1997) studied 17 natural populations representing all seven subspecies described by Trewavas (1983), and clustered them into three major groups; West African populations, Ethiopian Rift-Valley populations, and Nile and Kenyan Rift-Valley populations.

Other genetic studies have been conducted on wild populations of Nile tilapia described by Trewavas (1983). Rognon *et al.*, (1996) carried out studies on different populations of Nile tilapia and found clear genetic differentiation between western (Niger, Senegal and Volta populations) and eastern (Manzala and Turkana) populations. To further assess their geographical differentiation, Rognon *et al.* (1997) studied the same populations using

mtDNA. These two studies provided evidence that morphological similarities between the Nile River and West African populations reflects convergence, common ancestral morphology or non-genetic environmental relatedness rather than derived phylogenetic relatedness. This implies that *O. niloticus niloticus* as defined by Trewavas (1983) is not valid. The same authors (2003) studied gene flow between a wild population of *O.niloticus* and *O. aureus*. Other recent studies were carried out by Hassanien and Gilbey (2005), Nyingi and Agnèse (2007), Nyingi *et al.* (2009), Angienda *et al.* (2011) and Bezault *et al.* (2011) using mitochondrial and/or microsatellite markers. All these studies, though not exhaustive considering the Rivers and Lakes having natural populations of *O. niloticus*, constitute a valuable documentation of genetic resources of Nile tilapia. Additionally, comparison between these studies and earlier studies by Trewavas's classification have shown discrepancies, hence the need for further phylogenetic relationships studies especially on the East African populations of Nile tilapia. Based on these laid down foundation, this study seeks to characterize some of *O. niloticus* populations found in East Africa using mtDNA and 16 microsatellite markers.

More recently, a new population of *O. niloticus* was discovered in Lake Bogoria Hotel Spring in Kenya (Nyingi et al., 2009) (Fig. 1). This hot spring (~36 °C) flows into Loboi Swamp, which is thought to have formed during a period characterised by high rainfall and high water levels in East African lakes at about 700 years BP (Mohammed et al. 1995; Verschuren et al., 2000). At this period, the swamp is thought to have been connected to L. Baringo. However, important climatic shifts that reduced rainfall and increased evaporation (Hay, 1976; Cerling, 1979), together with landform changes in the region led to their isolation (Ashley et al. 2004). Currently, the swamp is endoreic, with most of its waters being used to irrigate surrounding agricultural farms. Based on genetic evidences, the population was considered as natural and not introduced. It is characterized by new (unknown) private genetic markers (microsatellites and mtDNA) that make this population close, but differentiated, to the Lake Baringo population (Nyingi et al., 2009). Moreover, Nyingi et al., 2007 demonstrated that O. niloticus from Lake Baringo had been recently introgressed by mtDNA of O. leucostictus. This latter species is not autochtonous in Kenya (native to Lake Albert in Uganda) but was first introduced in Lake Naivasha (Kenya) from the ponds around Lake Victoria in 1956 (Siddiqui, 1977a, 1979). There are two hypotheses to explain how O. leucostictus may have been introduced into Lake Baringo, either to counterbalance the decrease of natural Nile tilapia catch in the lake, or from individuals that may have escaped from local aquaculture farms within the Lake's catchment. In this first study it appeared that the mtDNA introgression of *O. leucostictus* genes within *O. niloticus* was not accompanied by any nuclear introgression. Two other hot springs exist in this swamp, and host Nile tilapia populations, which have not as yet been investigated.

However, due to increased developments in aquaculture projects within the Lakes Baringo and Bogoria drainages (Mumba, 2008; Nyingi and Agnèse, 2011; The Fish Site, 2011), it is necessary to carry out a more complete survey of the natural populations from the Lake Baringo and from the Loboi swamp hot springs in order to characterize any hybridization events.

Therefore, in order to better genetically characterize the new hot spring populations and to evaluate the introgression by *O. leucostictus* genes, we studied mtDNA sequences (Dloop) and 16 microsatellites in the three Loboi hot spring populations, Lake Baringo population as well as in other natural populations of Nile tilapia in the region.

This study is particularly important because these populations represent important genetic resources for the species. In Kenya, the natural populations of Nile tilapia within the Rift-Valley represent a large portion of the species genetic resources. The most important populations among these genetic resources are the three populations of Loboi Swamp. In order to understand and appreciate the usefulness, it is necessary to consider how the culture of *O. niloticus* is undertaken.

In spite of all the favourable qualities that Nile tilapia offers as a culture fish and the technological advances in its aquaculture, the viability of this commercial production is greatly affected by its prolific breeding which frequently results to overcrowding and stunted growth in the ponds (Hickling, 1960). This led to the introduction of all male mono-sex cultures with the aim of improving productivity, and also to benefit from the faster growth of males as compared to females (Mélard, 1986; Toguyéni *et al.*, 1996; Baras and Mélard, 1997). Additionally, rearing of male mono-sex populations is more advantageous compared to females as the former can allocate more energy towards growth (instead of reproduction) thus increasing productivity (Oldfield, 2005). As a result, several methods of producing monosex populations have been established including: manual sexing, which involves separating males from females; hybridization to produce male monosex populations, hormonal treatment of fry with synthetic male hormone (17 alpha methyltestestorone); genetic manipulation to produce YY 'supermales' or treatment of fry with high temperatures (≈36°C) (Hicklings, 1960; Mair

et al. 1997; Shelton, 2002; Baroiller et al. 1996a; Baras et al. 2001). Because hormonal sex reversal is by far the most efficient and the cheapest treatment, it is the main technique used by the farmers to produce male monosex populations. However, there are growing concerns with the elimination of 17alpha-methyltestosterone and its metabolites from the treated fry, their presence in waters (ponds, rivers) or in the soil, their potential effects on wild fish sex differentiation (masculinisation) and/or gametogenesis as well as their effects on other aquatic organisms and finally their putative toxicity. This is why steroid treatments are not allowed in the EU for direct production of monosex populations, and more and more unpopular for consumers in the countries where its use is still allowed. In the framework of a sustainable aquaculture, monosex populations should be produced through environmentally-friendly procedures. In this respect, the most promising approaches are probably the use of YY males or the use of temperature treaments (Baroiller et al., 1995; Baroiller and D'Cotta, 2001; Tessema et al., 2006; Bezault et al., 2007; Wessels and Hörstgen-Schawark, 2007; Baroiller et al., 2009). However, YY males failed to systematically produce all-male populations due to the complex sex determination system of tilapia. Besides, the masculinizing effects of high temperatures on a progeny depend on genetic factors brought by the two parents. This thermosensitivity, as a heritable trait, can be selected in the Nile tilapia (Baroiller and D'Cotta, 2001; Tessema et al., 2006; Bezault et al., 2007; Wessels and Hörstgen-Schwark, 2007; Baroiller et al., 2009). However, because sex determination combines both genetic and environmental factors, it is still difficult to develop these sustainable approaches for sex control.

Most of studies on sex determination in the species have been conducted on domestic stocks used for aquaculture (Bezault *et al.* 2007). Based on observations that sex determination systems can be very diverse even between closely related taxa (Chevassus, 1998), there is a need to carry out sex determination studies on wild populations of Nile tilapia under their natural environments in order to provide a better understanding on temperature-dependent sex determination mechanisms in Nile tilapia.

Bezault *et al.*, (2007) carried out sex determination studies on wild populations of Nile tilapia adapted to three different thermal regimes (extreme stable cold temperatures from Lake Koka, extreme stable warm temperatures from Metahara, and a highly variable environment in Kpandu, Lake Volta). The progenies of these populations were also reared under controlled laboratory conditions (27 °C and 36 °C). Progenies from these three populations exhibited a clear thermosensitivity with large variations in the temperature-induced sex ratios depending

on the parents but also on the populations (Bezault *et al.*, 2007). This study was the first to demonstrate that both genetic and environmental factors are also involved in the sex determination of natural populations of Nile tilapia; it also highlights the importance of field investigations to better understand sex determination in tilapia.

In this regard, the Loboi Hot spring populations become very important. Normally, at temperatures above 32°C (as is the case in hot springs with temperature at 36°C) sex ratios have been observed to be biased towards males. Obviously, this has not been the case in the Loboi Swamp hot springs where the sex ratio is close to 1 male for 1 female. It is then very likely that this population "have found a way" to overcome the temperature problem, a fact that therefore presents a great opportunity to study the mechanisms by which temperature acts on sex differentiation.

Such wild progenies where temperature influences have been probably eliminated (i.e which might be the case for the Kenyan hot springs) will be the best resources for the selection of tilapia strains that can be used for a strict genetic sex control. Conversely, wild populations for which high temperatures can strongly change the sex-ratio towards males are potential resources for selection of tilapias using temperature as a means to produce all-male progenies. In both cases, further study and characterisation of wild populations is therefore essential.

Temperature and genetic influences on sex may be the result of allelic variations on sex-differentiating genes. We therefore studied Single Nucleotide Polymorphism (SNP) in three major genes (anti-Mullerian hormone, *amh*; aromatase, *Cyp19a*; Wilm's tumor, *Wt1b*) that have previously been linked to sex determination in *O. niloticus* in order to understand the adaptations of these populations against the masculinizing effect of the elevated temperatures.




Figure 1: Map showing location of Lake Bogoria Hotel Spring in Loboi Swamp, Kenya

(I) An important natural genetic resource of *Oreochromis niloticus* (Linnaeus, 1758) threatened by aquaculture activities in Loboi drainage, Kenya

Abstract

The need to improve food security in Africa through culture of tilapias has led to transfer of different species from their natural ranges causing negative impacts on wild fish genetic resources. Loboi swamp in Kenya is fed by three hot springs: Lake Bogoria Hotel, Chelaba and Turtle Springs, hosting natural populations of *Oreochromis niloticus*. The present study aimed at better genetic characterization of these threatened populations. Partial mtDNA sequences of the D-loop region and variations at 16 microsatellite loci were assessed in the three hot spring populations and compared with three other natural populations of O. niloticus in the region. Results obtained indicated that the hot spring populations had mitochondrial and nuclear genetic variability similar to or higher than the large closely related populations. This may be attributed to the perennial nature of the hot springs, which do not depend on rainfall but rather receive permanent water supply from deep aguifers. The study also revealed that gene flow between the three different hot spring populations was sufficiently low thus allowing their differentiation. This differentiation was unexpected considering the very close proximity of the springs to each other. It is possible that the swamp creates a barrier to free movement of fish from one spring to the other thereby diminishing gene flow. Finally, the most surprising and worrying results were that the three hot spring populations are introgressed by mtDNA genes of O. leucostictus, while microsatellite analysis suggested that some nuclear genes may also have crossed the species barrier. It is very likely that the recent intensification of aquaculture activities in the Loboi drainage may be responsible for these introgressions. Taking into account the importance of these new genetic resources, protection and management actions of the Loboi swamp should be accorded top priority to prevent the loss of these spring populations.

1. Introduction

Tilapias are some of the most important species for fisheries and aquaculture in Africa. This has contributed to their massive transfer not only within Africa, but to other countries around the world [1,2,3]. These transfers are a major concern because of the invasive nature of tilapia species and their ability to hybridize with local species [3,4,5]. Introgression of alien genes can leads to disruption of specific allele combinations responsible for adaptation of the populations to their environments hence reducing their fitness [6,7].

Within tilapias, *Oreochromis niloticus* (Linnaeus, 1758), the Nile tilapia, is the most economically important species, with a wide natural distribution in Africa. Its natural range covers the entire Nilo-Sudanian province (Senegal to Nile), Ethiopian Rift-Valley province, Kivu province, North Tanganyika Province (Ruzizi) and the Northern part of the East African Rift-Valley [8,9]. Currently, Nile tilapia is cultured in more than 100 countries and its production estimated at 2,790,350 metric tonnes in 2011, and valued at 4.52 billion USD [10]. This species is favoured by fish farmers due to its fast growth rate and its ability to tolerate a wide range of environmental conditions [11]. Resistance to diseases and good consumer acceptance has further promoted its culture worldwide [12].

Seven subspecies of Nile tilapia have been described based on morphological characteristics [8]: *O. n. niloticus* from West-Africa and River Nile, *O. n. baringoensis* from Lake Baringo, *O. n. sugutae* from River Suguta (Kenya), *O. n. eduardianus* from Lakes Edward, Albert,

George and Tanganyika, *O. n. vulcani* from Lake Turkana, *O. n. cancellatus* from River Awash, and Lake Tana and *O. n. filoa* from hot springs in the Awash system. Recently, Nyingi *et al* [5] discovered a natural population from Lake Bogoria Hotel Spring (Kenya). This spring that drains into Loboi swamp is characterized by an elevated water temperature (36°C) and pH ranging from 6.4–6.9 [13]. This population of *O. niloticus* was characterised by 10 private microsatellite alleles and five private mtDNA haplotypes. Both extents of mitochondrial and microsatellite differentiations were in the range of those observed among other naturally occurring discrete populations in the region (Lakes Baringo and Turkana, and River Suguta). These observations indicated that the Lake Bogoria Hotel Spring population was not as earlier hypothesised, introduced from other neighbouring East African natural populations, but represents a previously unknown natural population.

This population offers new opportunities for aquaculture due to various adaptations including its ability to survive in relatively high temperatures (approx. 36°C). The fish may therefore have developed hypoxic resistance mechanisms since dissolved oxygen levels are generally low in warm waters. In addition, special adaptations may also be present that regulate sex determination mechanisms known to involve temperature [14,15]. This population may in this regard potentially offer a model for the study of sex determination in tilapine fishes.

In a first study [5] samples from a single hot spring in the Loboi drainage, the Lake Bogoria Hotel Spring were analysed. At least two other springs with similar ecological conditions exist, each hosting O. niloticus population, the Chelaba Spring that is located close to the Lake Bogoria Hotel Spring and the Turtle Spring located at the border of the papyrus marsh of Loboi Swamp. In order to protect these populations from various anthropogenic and environmental threats, there is an urgent need to characterise their natural genetic diversity as a first step of a future action plan for sustainable management. The Loboi Swamp itself has receded in size by over 60% over a short period of 30 years due to expansion of irrigation via a ditch constructed in 1970 [13,16] and conversion of wetlands for agriculture. Another anthropogenic threat is due to the rapid expansion of aquaculture activities in the Rift Valley region enhancing fish transfer from one drainage system to another, and allowing mixing between populations and or species. It has been demonstrated [17], using mtDNA (D-loop) and microsatellite studies, that the O. niloticus population from Lake Baringo has been introgressed by O. leucostictus from Lake Naivasha. However, even though mtDNA introgression was clearly established, no nuclear introgression was apparent. These introgressions have been attributed to possible introduction of O. leucostictus into Lake Baringo to boost tilapia fisheries caused by the decline of O. niloticus population by unsustainable high fishing pressure. Another possible explanation for this may have been the expansion of aquaculture in the region, which has been a continuous threat to wild populations of the Nile tilapia in Kenya. The human population of Lakes Baringo and Bogoria, mainly composed of small-scale crop farmers, have begun to diversify their livelihoods by construction of earthen ponds along the rivers and streams in the region [17,18]. Fish farmers are now breeding different tilapia species with fingerlings from a diversity of sources within East Africa. Most of these ponds are not isolated from streams and wetlands, thus farmed fish can easily escape and hybridize with autochthonous *O. niloticus*. In order to characterize the three hot spring populations of the Loboi Swamp, we carried out a study of their genetic variation in mtDNA (sequence of partial D-loop region) and microsatellites together with other *O. niloticus* populations from the region: Lake Albert, Lake Turkana, Lake Baringo, River Suguta and *O. leucostictus* from Lake Naivasha.

2. Materials and methods

2.1 Sampling design

Oreochromis niloticus is not an endangered or protected species in Kenya. Seven populations (Figure 1, Table I) were studied and compared, three from the hot springs of the Loboi drainage (Turtle Spring, Chelaba Spring and Lake Bogoria Hotel Spring) (Figures S1-S3), while other populations were from Kenyan Lakes or Rivers (Baringo, Turkana, Suguta). Authorization to collect and sacrifice fish within the protected areas in Lake Turkana was provided by the means of a permit (number KWS/BRM/5001). All fishing and processing of tissue and whole fish specimens was carried out under existing collaborative arrangements with the Kenya Wildlife Service (KWS) and the National Museums of Kenya (NMK) for purposes of biodiversity research. For the other locations outside protected areas, no special authorization was necessary.

As there is no Institutional Animal Care and Use Committee or equivalent animal ethic committee in Kenya, no formal approval was obtained for this work. To minimize suffering of individuals studied, specimens were captured using seine nets and immediately anaesthetized and killed using an overdose of MS-222 (Tricaine-S, Western Chemicals Inc). After death, a fragment of muscle or fin tissue was taken from each specimen and immediately preserved in 95% ethanol for later DNA analyses. Voucher whole fish specimens were fixed in 4% formalin and later preserved in 70% ethanol, and are presently curated at the National

Museums of Kenya (NMK) in Nairobi. Other voucher specimens whose sequences were obtained from Genbank are curated at the Musée Royal de l'Afrique Centrale (MRAC) in Tervuren, Belgium or at the Institut des Sciences de l'Evolution de Montpellier (ISEM), France (Table I).

2.2 DNA extraction, sequencing and microsatellite analysis

Approximately 50 mg of the sample tissue was sheared into fine pieces before being digested at 55 °C overnight using 10 μl proteinase K (10 mM / ml) in 190 ml of an extraction buffer solution (1 M Tris, 0.5 M NaCl₂, 1 % SDS). DNA was then extracted from each sample following the protocol described for genomic DNA extraction for PCR-based techniques [19]. The extracted DNA was suspended in sterile double distilled water and stored in -20 °C until PCR amplification. A 450 bp fragment in the 5′ region of the D-loop was amplified in each sample using two primers: 5′-ACCCCTAGCTCCCAAAGCTA-3′ (forward) and 5′-CCTGAAGTAGGACCAGATG-3′ (reverse). Amplifications were performed in a final volume of 50 μl containing 0.25 mM MgCl₂, 0.2 mM of each dNTP, 1 μM of each primer, 5μl of 10x buffer and 10 units of Taq polymerase (Promega). PCR reaction conditions were: 3 minutes pre-heating at 93 °C followed by 40 cycles of 30 seconds at 93 °C, 30 seconds at 62 °C and 1 minute at 72 °C, with a final elongation phase of 72 °C for five minutes.

A total of 16 microsatellite loci were analysed in this study: PRL1AC and PRL1GT [20], UNH104 (GenBank reference number G12257), UNH115 (G12268), UNH129 (G12282), UNH142 (G12294), UNH146 (G12298), UNH154 (G12306), UNH162 (G12314), UNH189 (G12341), UNH211 (G12362), UNH860 (G68195), UNH874 (G68202), UNH887 (G68210), UNH995 (G68274) and UNH1003 (G68280). Amplifications were carried out using Qiagen Multiplex PCR Kit and following manufacturer's protocol. Reaction conditions were: 5 minutes at 95 °C pre-heating followed by 30 cycles of 30 seconds at 95 °C, 90 seconds at 60 °C (except for UNH115, UNH154, UNH860 and UNH1003 for which the temperature was 50 °C) and 1 minute at 72 °C, with a final elongation phase of 5 minutes at 72 °C. 3 μl of PCR products were diluted in 12 μl of HiDi formamide and 0.2 μl of 500 LIZ size standard added. Electrophoresis was thereafter carried out in an ABI 3730 XL automated sequencer. GeneMapper software was used to analyse the electrophoregrams and allele sizes.

2.3 Data analysis

2.3.1 Sequence analyses

Sequences were aligned manually using BioEdit 5.09 [21]. Additional sequences obtained from Genbank were also included in the analysis (Table I). Genetic diversity was calculated using DnaSP 5 [22]. Aligned sequences were analysed using Maximum Likelihood (ML) and Distance Method (DM) using MEGA (Molecular Evolutionary Genetics Analysis) version 5.1 [23]. Prior to analysis, an evolutionary model for ML was selected by MEGA 5.1 [24] using the Bayesian information criterion (BIC) [25]. Models with the lowest BIC scores are considered to describe the substitution pattern the best. Pair-wise sequence divergences between unique mtDNA haplotypes were calculated using the Kimura two-parameter model [26], followed by Neighbor Joining methods [27] to construct trees. Supports for inferred clades were obtained through the non-parametric bootstrap [28] with 2000 replicates for both methods.

Genetic diversity estimates were computed using DnaSP version 5.10.01 [29] and involved analysis of π , the average number of nucleotide differences per site between two sequences [30], and k, the average number of nucleotide differences between sequences [31].

2.3.2 Genotype analyses

Microsatellite data were checked for scoring errors due to stuttering or large allele dropout and presence of null alleles, using MICRO-CHECKER software [32]. Intra-population genetic variability was measured by estimating observed heterozygosity (H_O), expected heterozygosity (H_E) and the inbreeding coefficient (F_{IS}) using GENEPOP version 3.4 [33]. F_{ST} and associated probabilities were estimated using a Markov chain method following [34]. The length of the Markov chain involved a burn in period of 1000 iterations and 100 batches of 1000 iterations thereafter.

A Factorial Correspondence Analysis (FCA) was carried out with GENETIX Version 4.05 [35], in order to investigate the relationships between individuals. This type of analysis can explain a maximal amount of genetic variation using a minimal number of factors and can provide the means for visualizing the genetic relationships between populations or species. We first carried out an analysis of all the specimens studied from both species, *O. niloticus* and *O. leucostictus*, in order to visualize differentiation at the species level. Thereafter, individuals from Lake Baringo and the three hot springs were compared to individuals of *O. leucostictus* in order to observe possible introgression. Finally, genotypes of individuals from

the hot springs and the neighbouring Lake Baringo were compared to establish their relationship.

A Bayesian cluster approach as implemented in STRUCTURE version 2.3.4 [36] was used to assess genetic admixture between O. leucostictus and O. niloticus at microsatellite loci assuming two populations (K=2). The admixture model with correlated allele frequencies was chosen [36,37]. Three different runs to estimate q(i), the fraction of the genome of an individual i of a given species (O. niloticus or O. leucostictus), inherited from the other species, three different runs were done for 500,000 generations after discarding 200,000 generations as burn-in. The 90% probability intervals around the different q(i) were calculated.

To confirm occurrence of nuclear introgression, we used Bayesian method implemented in NEWHYBRIDS 1.1 [38]. This method is designed to identify new hybrids between populations or species, and unlike STRUCTURE, NEWHYBRIDS model takes into account the predictable patterns of gene inheritance in hybrids [38,39]. An analysis was carried out for 100,000 iterations of Markov Chain Monte Carlo (MCMC) after 100,000 burn-in steps. Affinity of an individual to respective genotype class was assessed by posterior probability values.

3. Results

3.1 mtDNA differentiation

Forty-two new partial D-Loop sequences were obtained during this study (GenBank accession numbers are given in Tab. II). Thirty different haplotypes were identified using these and an additional 58 sequences from GenBank (Tab. II). All populations studied were polymorphic except for River Senegal (O. niloticus) and Lake Naivasha (O. leucostictus), where a single haplotype was present in 20 and five specimens examined respectively. Sample size (n), number of observed haplotypes (Hob), number of polymorphic sites (p), average number of nucleotide differences (k) and nucleotide diversity (π) are presented in Table II. Out of the 30 haplotypes detected, 22 were unique to specific sample localities: 14 were observed only in Lake Turkana (total number of haplotypes sequenced n=23), two in Lake Albert (n=20), one in River Suguta (n=9), five in Lake Bogoria Hotel Spring (n=24). Furthermore, two other haplotypes were only found in hot springs populations.

Surprisingly, the haplotype of *O. leucostictus* from Lake Naivasha, which had been previously

described to occur in *O. niloticus* from Lake Baringo population [17] was also detected in all three hot spring populations: one in Turtle Spring, two in Chelaba Spring and 1 in Lake Bogoria Hotel Spring.

According to the different values of the corrected Akaike Information Criterion (AIC) obtained with MEGA 5.1, the optimal model of sequence evolution was HKY model [40]. This model was used in the ML analysis. Phylogenetic relationships among all haplotypes observed based on ML or DM methods were congruent. Fig. 2 presents a consensus NJ tree where bootstrap values obtained with ML and DM have been indicated. [4,17] reported that *O. niloticus* from West Africa (from River Senegal to the Nile) has been naturally introgressed with mtDNA from *O. aureus*. The haplotype observed in the River Senegal sample corresponds to this alien haplotype. Consequently, the network has been rooted using the single haplotype from River Senegal.

All other haplotypes observed, except one clustered in a single highly supported group (bootstrap value=97% for ML and MD methods). The outlier haplotype present in Lake Baringo, the three hot springs populations and *O. leucostictus* from Lake Naivasha, belongs to *O. leucostictus* as demonstrated earlier [17]. This haplotype was previously observed in the *O. niloticus* population from Lake Baringo, and considered introgressed, but was not observed in the Lake Bogoria Hotel Spring [5], as is the case in the present study. These results gave evidence that introgression by *O. leucostictus* mtDNA has also occurred in all the hot spring populations of the Loboi swamp.

The 28 remaining haplotypes are divided in three groups. The first one (I), supported by high bootstrap values (99% for ML and MD), is the sister group of the two others (II and III) and is composed of two different haplotypes present only in the hot spring populations. The four haplotypes of group II (bootstrap 97% for ML and 96% for DM) are found only in the three hot spring populations and in Lake Baringo. The other 22 haplotypes composed group III, which was supported by important bootstrap values: 72% for ML and 86% for DM. All the populations studied possess at least one haplotype in this group.

3.2 Microsatellite analysis

A total of 197 individuals from seven localities were genotyped at 16 microsatellite loci. All loci were polymorphic in all populations with the number of alleles ranging from nine to 44. Locus UNH154 was the most polymorphic with 44 alleles, while UNH129 was the least polymorphic with nine alleles. Lake Turkana population recorded the highest mean number of

alleles (12.9±1.3, 217 allele observed; X±SE where SE is standard error), while Lake Naivasha population (*O. leucostictus*) had the least (5.0±0.5, 80 allele observed). The three hot spring populations had mean number of alleles ranging from 8.4±0.6, (Chelaba Spring), 8.6±0.5 (Turtle Spring) to 8.9±0.9 (Lake Bogoria Hotel Spring), and total number of alleles ranging from 134, 138 to143 at Chelaba, Turtle and Lake Bogoria Hotel Springs, respectively. Distribution of alleles within the populations is shown in table III.

Using Micro-Checker, the presence of null alleles could not be rejected in the following loci and populations: PRL1AC in all three springs and Lake Baringo populations, UNH154 in Turtle Spring and River Suguta populations, UNH995 in Lake Bogoria Hotel and Chelaba Springs, PRL1GT and UNH115 in Lake Naivasha population, UNH1003 in Lake Bogoria Hotel population, UNH146 in Lake Baringo population, and UNH189 and UNH860 in River Suguta and Lake Turkana populations. No scoring error was detected in the data due to either stuttering or large allele dropout.

All populations had high observed heterozygosities ranging from 0.5828 in Lake Naivasha population to 0.7935 in Lake Baringo. F_{IS} values indicated heterozygote deficiencies in all populations studied. A total of 23 (24.15%) F_{IS} values out of the 105 calculated indicated significant heterozygote deficiencies (Table III).

Pairwise F_{ST} values among the seven populations ranged from 0.0177 to 0.3522 (Table IV) and were all highly significant (P<0.001), indicating that all the samples can be considered genetically differentiated. F_{ST} values between Turtle Spring population and the other two hot spring populations (Lake Bogoria Hotel and Chelaba Springs), were relatively higher (0.0689 and 0.0749, respectively) than the F_{ST} observed between the latter two populations (0.0177). As expected, the highest F_{ST} values were observed for interspecific comparisons between O_{ST} and O_{ST} leucostictus populations, and ranged between 0.2653 at Chelaba Spring to 0.3522 at River Suguta.

All populations had private microsatellite alleles as shown in figure 3. The highest number of private alleles was observed in Lake Turkana population (91). Lake Bogoria Hotel Spring population had the highest number of private alleles (12) within the hot spring populations, while Chelaba Spring and Turtle Spring had nine and three private alleles, respectively.

FCA of all the genotypes observed (Figure 4) highlighted the differences between the two species *O. niloticus* and *O. leucostictus*. Based on the first axis (5.06% of total genetic variations), two main clusters corresponding to the two different species were identified. Within the *O. niloticus* cluster, two distinct groups were observed which correspond on one

hand to populations from Lake Bogoria Hotel Spring, Chelaba Spring, Turtle Spring and Lake Baringo (A), and on the other hand to Lake Turkana and River Suguta populations (B).

Taking into account that some populations have been introgressed by mtDNA from *O. leucostictus*, we carried out another FCA (Figure 5) of all three introgressed populations (the three hot springs and Lake Baringo) and *O. leucostictus* from Lake Naivasha. This enabled a clear separation between populations from *O. niloticus* and the one from *O. leucostictus* based on the first axis (62.24% of the total genetic variation). The fact that mtDNA of the introgressed individuals did not appear related to *O. leucostictus*, and the absence of any intermediate individuals between these two groups suggested that there has been no nuclear introgression between the two species.

Finally, an FCA analysis including the three hot spring populations and the Lake Baringo populations was run (Figure 6). The individuals were separated into four different clusters corresponding to the four populations. The axis 1 (43.34% of the genetic variation) discriminated individuals from Lake Bogoria Hotel and Chelaba Springs from Turtle Spring and Lake Baringo. The second axis (32.05% of the genetic variation) discriminated on one hand Chelaba Spring population from Lake Bogoria Hotel Spring population and on the other hand, Turtle Spring population from Lake Baringo population. It is noticeable that Lake Bogoria Hotel Spring and Chelaba Spring populations which are geographically closer to each other than to Turtle Spring are also genetically close, leading to a genetic isolation by distance pattern.

Further analysis of genotypes from introgressed populations was carried out using STRUCTURE in order to determine the proportions of nuclear genetic admixtures between O. niloticus and O. leucostictus. No F1 hybrid genotypes were detected from the analysis; this means there were no individuals with O values around 0.5 (Figure 7). All individuals of O. leucostictus had O values 0.003 (estimated fraction proportion of their genome inherited from any other species, in this case, O. niloticus) and could be considered as pure (not introgressed). All individuals of O. niloticus from Lake Turkana and River Suguta, and most of those from the hot springs and Lake Baringo could also be considered as pure (were characterized by O0 values 0.010. Eleven individuals had O0 values 0.010 (five from Chelaba Spring, three from Turtle Spring, two from Lake Bogoria Hotel Spring and one from Lake Baringo) and this number rises to 30 when considering the 90 % probability intervals (13, 6, 6, 5, respectively). Only one individual from Chelaba Spring had a O0 value 0.011 and ten when considering the 90% intervals (4, 3, 2, 1 respectively).

When analysing individual genotypes with NEWHYBRIDS, all specimens of O. leucostictus

had a posterior probability of being pure *O. leucostictus* greater or equal to 0.9989. In *O. niloticus* populations, seven specimens had a posterior probability of being pure *O. niloticus* inferior to 0.9574, and could be considered as possible hybrids. For all the concerned specimens, the probability to be F2 hybrid backcrossed with *O. niloticus* was higher than 0.0416 (Table S1).

It is important to take into account that all the specimens identified by NEWHYBRIDS as potential F2 backcrossed hybrids have been considered as hybrids according to their *Q* values obtained with STRUCTURE (Fig. 7).

Only one specimen from Turtle Spring population was considered as a hybrid by all three methods of analysis used; mtDNA haplotype identification and nuclear genotypes composition analysed by STRUCTURE and NEWHYBRIDS (Table S1).

4. Discussion

In a survey of *O. niloticus* populations in East Africa, the occurrence of a new (previously unknown) native population of *O. niloticus* in Loboi Swamp (Lake Bogoria Hotel Spring), Kenya has been documented [5]. This population was initially assumed to have been introduced from other localities within the region. However, its native status was confirmed due to its significant and unique genetic variability with a large number of private microsatellite alleles and mtDNA haplotypes (partial D-loop). The presence of tilapia in two other hot springs in the Loboi Swamp namely Turtle and Chelaba Springs, prompted us to investigate these fish. The present study clearly establishes that these two hot springs also host native fish closely related to those from Lake Bogoria Hotel Spring and that all three hot spring populations are in addition also closely related to the Lake Baringo population of the Nile tilapia. They share the most common haplotype in group II, and one haplotype in group III (Figure 2). Nevertheless, the three hot spring populations are also characterized by the private haplotypes of group I.

Lake Baringo is considered a modern representation of a much larger middle to upper Pleistocene Lake Kamasia [41], whose shores extended to Kapthurin River to the west and Bogoria River (which Loboi system is part of) headwaters to the south. This may explain the close relationship between the hot springs and the Lake Baringo, as observed in our study.

The analysis of partial mtDNA sequences of the D-loop region showed that the haplotype of *O. leucosticus* from Lake Naivasha previously confirmed to be present in Lake Baringo [17],

is also present in the three *O. niloticus* populations of the springs. The microsatellite study and visual observations of fish specimens during their capture confirmed that the spring populations were composed of a single species, *O. niloticus*. It is therefore evident that some of the fish in each of the hot springs have been introgressed by *O. leucostictus* mitochondrial genome.

The first studies of the Loboi swamp spring population [5,17] detected introgressed specimens in Lake Baringo by *O. leucostictus* but none from the Lake Bogoria Hotel Spring. However, it is possible that the authors failed to detect any introgression of the Lake Bogoria Hotel Spring population due to the low number of hot spring specimens available for their study (16 specimens).

If these introgressions originated from aquaculture practices *i.e.* escapees of *O. leucostictus* specimens or from *O. niloticus* introgressed beforehand in aquaculture farms within the Loboi swamp drainage, as it was hypothesized, then it is possible that these introgressions may have occurred after 2007.

Indeed, fish-farming activities within the region has been enhanced as a result of funding by Kenyan government through the Economic Stimulus Programme (ESP) introduced in 2009. The aim of the ESP project was to construct 200 fishponds worth 10.6 million euros in 140 constituencies by June 2013, with each constituency receiving 70,000 € [42]. Eight fishponds have been constructed between 2012 and 2013, in close proximity to the Loboi Swamp (within a range of 230 − 700 metres), and some stocked with Nile tilapia fingerlings from unspecified sources. Other fishponds in the Baringo-Bogoria catchment are located along the main rivers and streams in the region. Fingerlings used to stock the ponds within the region are produced by Omega Fish Farms located at Ol Kokwe Island on Lake Baringo. The farm was established to produce fingerlings for the local fish farmers [43]. Broodstock for the establishment was obtained from the Lake Baringo, hence may have acted as a source of introgressions observed in the Loboi Swamp fish.

At a first glance, it appears that these introgressions only concern mitochondrial DNA as earlier concluded in the study of Lake Baringo population [17]. Indeed, the results of the Factorial Correspondence Analysis (Figure 5) based on individuals microsatellites genotypes (16 loci) showed a clear separation between the three hot spring populations on one hand and on the other hand, the Lake Baringo, and population of *O. leucostictus* from Lake Naivasha. In case of large amount of introgression, individuals with intermediate genotypes were expected.

Recently STRUCTURE has been used [44,45] to quantify in more details the proportion of individual's genome originating from a different hybridizing species in tilapia from Lake Victoria and in Cichlids from Lake Tanganyika, respectively. Results obtained by these authors concern tilapia species from the Lake Victoria region: *O. niloticus* and *O. esculentus*. These two species are suspected to hybridize even though no mitochondrial introgression has so far been observed in samples (30 individuals of *O. niloticus* from Lakes Victoria, Kanyaboli, Namboyo and Sare, and 30 individuals of *O. leucostictus* from Lakes Kanyaboli and Namboyo). Results of this microsatellite study (eight loci) allowed the separation of both species using a Factorial Correspondence Analysis. However, using STRUCTURE, eight individuals (six *O. esculentus* and two *O. niloticus*) appeared to have 90% probability intervals that extend more than 30% out of a pure species *Q* value which suggested that these individuals had an important degree of genetic introgression.

In the present study, all O. leucostictus had Q values ≤ 0.003 and may be considered as not introgressed by O. niloticus genes (Figure 7). At least ten O. niloticus specimens (representing 11% of the individuals studied in the three hot springs and Lake Baringo populations) when considering the 90 % probability intervals had 10% of their genes or more that may be considered to have originated from O. leucostictus (three in Lake Bogoria Hotel Spring, five in Chelaba Spring, one in Turtle Spring and one in Lake Baringo).

Results obtained with NEWHYBRIDS are congruent with these findings and indicated that seven individuals (as observed using STRUCTURE) may have been introgressed. Taking into account that *O. niloticus* populations are genetically more variable than the *O. leucostictus* population, it is possible that this hybridization pattern was induced by a high genetic variance of the *O. niloticus* samples from the hot springs and Lake Baringo rather than introgression with *O. leucostictus*.

Nevertheless, by assessing the specimens supposed to be hybrids, all seven specimens determined by NEWHYBRIDS were also pointed out by STRUCTURE. It is also worth noting that even if there is a poor correspondence between specimens with mtDNA introgression and specimens designated by the two Bayesian programs as hybrids (only one specimen is concerned), with the FCA analysis, all the mtDNA introgressed individuals appeared within their respective *O. niloticus* cluster, but closer to the *O. leucostictus* cluster (Fig. 5). Lastly, specimens from Lake Turkana population which is the most genetically variable, is clearly composed of non-hybridized individuals (Fig. 7). This suggests that hybrids identified by both STRUCTURE and NEWHYBRIDS are not artefacts due to genetic variance in the *O. niloticus* populations.

All of these observations are congruent and confirm with more detail the previous conclusions [17] pointing out the nuclear introgression of the *O. niloticus* populations from the hot springs of Loboi Swamp and Lake Baringo by nuclear *O. leucostictus* genes.

Even if the extent of the hot spring biotopes are small, and consequently the size of the effective populations, native mtDNA diversity was higher in the hot springs populations than in Lake Baringo and River Suguta populations. Nine different haplotypes were found in the hot springs (36 pure individuals analysed) while three were found in Lake Baringo (eight pure individuals analysed) or River Suguta (nine pure individuals analysed). Differences in samples sizes may partially account for the observed differences but when one considers Chelaba Spring on its own with four haplotypes for six individuals or Turtle Spring with five haplotypes for seven individuals, one can conclude that haplotype diversity in the hot spring is high.

This does not seem to be congruent with the very small size of the biotopes. The hot springs are located within a small swamp of about 1.5 km². The swamp itself is not expected to be a favourable biotope for fish survival as it is completely covered with macrophytes of which the most dominant are *Typha domingensis* and *Cyperus papyrus* [46]. This unexpected high mtDNA diversity can be explained if we consider that the characteristics of the hot springs are not directly related to pluvial water. The hot springs originate from faults and fractures that allow water from deep aquifers to rise to the surface [13,47,48] hence maintaining their perennial existence throughout the year, regardless of climatic changes. The high mtDNA diversity may have been favoured by the stable environmental conditions and consequently decreased levels of environmental stress in the hot springs.

Moreover, gene flow between the three hot spring populations is not enough to prevent their differentiation, as shown by F_{ST} values that were all statistically significant between populations (Table IV), and the FCA analysis (Figure 6). Even if there are only three populations, it seems that the genetic differentiation is congruent with the genetic differentiation through isolation by distance. This was also unexpected considering that the springs are very close to each other. When they join the swamp, Lake Bogoria Hotel and Chelaba Springs are separated only by a few hundred metres, and Turtle Spring is separated from Lake Bogoria Hotel and Chelaba Springs by approximately one kilometre.

To explain this amount of observed genetic differentiation between the springs, the first hypothesis is to consider that the swamp may create a barrier to free movement of fish from one spring to another thereby diminishing gene flow.

Both water temperature and dissolved oxygen concentration within the swamp are lower than within the springs mainly due to the shading effect provided by the dense vegetation and organic decomposition from the decaying matter, respectively. This situation has been described in a study of cichlid fishes from Lake Victoria [49,50]. It has been demonstrated that differences in eco-physiological properties of water can limit gene flow as a result of adaptation or physiological avoidance. Our observations are also congruent with the apparent lack of gene flow between two populations of both O. esculentus and O. niloticus from different satellite lakes of Lake Victoria separated by a wetland and papyrus swamps [44]. However, if the swamp represents an impenetrable barrier to free movement of fish so that F_{ST} values are statistically significant, it is difficult to explain how O. leucostictus or introgressed O. niloticus could have crossed the swamp, from fish ponds connected to the swamp drainage, and subsequently hybridized with native fish of the hot springs. It is still possible, though very unlikely, that someone may have directly introduced fish into each hot spring. Whereas this hypothesis cannot be rejected without consideration, there is simply no objective reason to carry out such fish translocation. Even though the exact way by which fishes have been introgressed is still unknown, the reality of the introgression has clearly been demonstrated and that aquaculture activities played a role in this process.

It was also apparent that the three populations of *O. niloticus* in the hot springs are distinct from other related populations by the presences of private alleles and haplotypes. This differentiation could be the consequence of their local adaptations to the extreme thermal conditions of their habitat. Studies indicate that exposure of *O. niloticus* to water temperatures of more than 36°C at an early stage of their development (10 days post fertilization) influences sex ratios towards males [14, 41]. These characteristics are of utmost importance to aquaculture, as they can be utilised to inexpensively produce all-male cultures. Tilapia farming mainly relies on male mono-sex culture in order to avoid overcrowding in the ponds due to breeding, and to benefit from fast growth of males [51,52,53]. Hence the rich genetic diversity and adaptations to masculinizing effect of water temperature makes these populations an important aquaculture resource, and an important natural model for understanding sex determination in Nile tilapias.

These populations and the genetic resources they represent need to be conserved. The conservation and management of Loboi swamp system should thus be accorded top priority in order to safeguard its critical genetic resource that has great potential in development of tilapia aquaculture.




Figure 1: Map of Loboi Swamp showing the location of the three springs and the fish ponds constructed by the end of 2011.





Figure 2: Phylogenetic tree representing the genetic relationships between the 30 haplotypes studied. The network was rooted using haplotype observed in the River Senegal population naturally introgressed by *O. aureus. O. niloticus* haplotypes have been clustered in three groups (I, II and III). Numbers above branches indicate bootstrap values (in percentage) based on 2000 replicates for ML and DM methods. The bar represents 0.05 units divergence, TS, Turtle spring, CS, Chelaba Spring, BS, Lake Bogoria Hotel Spring, BA, Lake Baringo, LT, Lake Turkana, SU, Suguta River and AL, Lake Albert. Values inside the circles represent number of haplotype.






Figure 3: Number of private microsatellite alleles and private mtDNA haplotypes present in six populations of *O. niloticus* and one population of *O. leucostictus* (mtDNA not included for Naivasha population).




Figure 4: Factorial Correspondence Analysis (GENETIX 4.05) based on individual microsatellite genotypes at 16 loci showing differentiation of the seven populations into two distinct groups corresponding to *Oreochromis leucostictus* and *O. niloticus*. *O. niloticus* populations further clustered into two groups; individuals from Lake Baringo Hotel Spring, Chelaba Spring, Turtle Spring and Lake Baringo (A), and Lake Turkana and River Suguta (B).




Figure 5: Factorial Correspondence Analysis (GENETIX 4.05) based on individual microsatellite genotypes at 16 loci showing no intermediate genotypes between mtDNA introgressed populations, the three hot springs and Lake Baringo populations, and *O. leucostictus* from Lake Naivasha. Individuals of *O. niloticus* that have *O. leucostictus* mtDNA are highlighted in red. TS, Turtle Spring; BA, Lake Baringo; BS, Bogoria Spring; OL, *Oreochromis leucostictus* from Lake Naivasha. Note: only two introgressed individuals from Lake Baringo are shown instead of eight (Fig. 1) because sequences of the six omitted individuals were obtained from Genbank hence not genotyped.




Figure 6: Factorial Correspondence Analysis (GENETIX 4.05) based on individual microsatellite genotypes at 16 loci showing clear separation of the four populations, the three hot spring populations and the lake Baringo population, using the two first axis. CS, Chelaba Spring; BS, Bogoria Hotel Spring; TS, Turtle Spring; BA, Lake Baringo.




Figure 7: Distribution of specimen membership Coefficient (Q±90% probability intervals) based on genotypes of *O. niloticus* and *O. leucostictus* in the hot springs and lakes Baringo and Naivasha, identified through microsatellite analysis using STRUCTURE. Each sample along the x axis represents an individual.

(II) Population differences in the SNPs associated to sex found in the *amh* gene of Nile tilapia and identification of sex-reversed fish

Abstract

The Nile tilapia has a complex sex determination system not only dominated by a XX/XY genetic system, but is also influenced by minor genetic factors as well as temperature. Sex-reversed XX males and XY females were found amongst breeders in some wild populations suggesting either influences of temperature or minor genetic factors or both these factors. Temperature and/or genetic influences on sex may be the result of allelic variations on sex-differentiating genes. The aim of the current study was to investigate allelic polymorphisms associated with phenotypic sex in nine wild populations of Nile tilapia living in different thermal regimes, and compare them with two domesticated strains: the Manzala strain for which genotypic sex was known for XX females, XY and YY males and sex-inverted phenotypic males (XX males), and the Bouaké strain. SNP search was performed on three genes (*cyp19a*, *wt1b* and *amh*) implicated in the cascade of sex differentiation in the gonad. These genes are located on two linkage groups LG1, and LG23 which have both been shown to be sex-linked in Nile tilapia. Four SNPs were found in the *cyp19a1a* promoter and the *wt1b*

gene, and correlated with populations but not with sex. SNPs in the amh gene are abundant (n=33) and widely distributed along the gene, with some strongly correlated with the phenotypic sex found in exons 2, 6 and 7 and intron 6. Several of these SNPs results in synonymous changes. The sex-linked SNPs appeared population-specific implying that sex determination in Nile tilapia should be analysed at the population rather than at the species level. They were more strongly related to the phenotypic sex in the Kenyan hot spring populations than in the Sudano-Sahelian and Ethiopian populations. Using the recently published amh markers, we identified sex-reversed XX males and XY females in several wild populations except in the Turtle hot spring. The amhy deleted form of the amh is not the universal Y male-marker for Nile tilapia since it is absent in all the males collected from the Ethiopian Rift populations (Lakes Metahara, Hora and Koka). Multivariate analysis conducted across all SNPs show a clustering of the studied populations into four distinct groups suggesting that sex chromosomes in Nile tilapia are still in a continuous state of evolution, with possibly evolution of different sex-linked haplotypes across the entire natural distribution of the species.

1. Introduction

Teleosts have extremely diverse mechanisms by which ovarian or testis differentiation are controlled. Sex determination is the initial decision for this development while sex differentiation is the downstream process generating the testis or ovary phenotypes. Genetic Sex Determination (GSD) triggered by a gene on the sex chromosomes and Environmental Sex Determination (ESD) involving an array of environmental cues including temperature, have evolved numerous times amongst teleost lineages (Baroiller *et al.*, 2009a; Heule *et al.*, 2014) and can even coexist in the same species (Yamamoto *et al.*, 2014). Recently, five male sex-determining genes have been identified on Y chromosomes of different fish species. In four of these cases, the gene has evolved from a duplication of a downstream gene of the sex-differentiating cascade. In the medaka (*Oryzias latipes*), *dmy/dmrt1bY* has been duplicated from *dmrt1*, a conserved testis sex-differentiating gene (Matsuda *et al.*, 2002; Nanda *et al.*, 2002). In a closely related species *O. curvinotus*, the transforming growth factor *gsdf*^Y has been recruited (Myosho *et al.*, 2012). *Amhy* a duplicated gene of the anti-müllerian hormone gene *amh*, has taken the role of master-gene in the Patagonian pejerrey *Odontesthes hatcheri* (Hattori *et al.*, 2012) and even in the temperature-dependent sex determining (TSD) *O.*

bonariensis species (Yamamoto et al., 2014). In three species of *Takifugu*, a single nucleotide polymorphism (SNP) found in the *amh* receptor gene *amhr2*, has been found to be linked to males (Kamiya et al., 2012). In contrast in rainbow trout, the Y testis-triggering gene sdY gene has not appeared from a duplicated downstream gene but rather from a duplicated form of the immune gene interferon regulatory factor 9 *Irf9* (Yano et al., 2012).

In the cichlid Nile tilapia (Oreochromis niloticus), sex determination and differentiation have been the focus of extended research due to male-growth dimorphism and the need to control sex in this major aquaculture species. Sex determination in this species has proven to be a complex mechanism under the control of various factors, which can broadly be divided into three groups: the sex chromosomes considered as major genetic factors, minor genetic factors and temperature factors (Baroiller et al., 2009b). No sex-determining genes have so far been found in tilapia fish. There is an absence of dimorphic differences between any chromosome pair in male or in female karyotypes (Bezault et al., 2011). Nevertheless, indirect approaches such as progeny testing have demonstrated that O. niloticus has a predominant XX/XY sexdetermining system while its sister species O. aureus has a ZZ/ZW system (Baroiller and Jalabert, 1989). Even so, there is still controversial evidence of which is the sex chromosome pair in tilapia. Foresti et al. (1993) and then Carrasco et al. (1999), when analysing synaptonemal complex found a terminal non-pairing of the largest pair of bivalents (chromosome 1) only in heterogametic males (XY) and not in the homogametic ones (XX or YY) and suggested that it corresponded to the sex chromosome pair in the Nile tilapia. This large pair of chromosomes presents signs of differentiation into sex chromosomes with accumulation of repetitive elements (Bezault et al., 2011; Martins et al., 2004; Cnaani et al., 2008) as well as sex-segregation differences (Lee et al., 2003; Cnaani et al., 2008). The role of this pair as sex chromosomes has been reinforced by the discovery of an inverted region associated to the genotypic sex (D'Cotta et al., unpublished data). However, the linkage analysis has associated a Y-haplotype dominant locus of males on linkage group 1 (LG1) in the Nile tilapia (Lee et al., 2003; 2004, Cnaani et al., 2008; Lee et al., 2011) located on a small chromosome (Cnaani et al., 2008). Using Restriction Association DNA (RAD) in two families of Manzala, Palaiokostas et al. (2013) found two SNPs that explained 96% of the phenotypes, narrowing the SD region to 2cM of LG1. Nevertheless, several variations in segregation patterns have been shown between strains and tilapia species with influences also of LG3 (located on the large chromosome pair) (Lee et al., 2003; Cnaani et al., 2008). In addition, a sex-linked QTL has been found in LG23 and fine-mapping has located the sexdetermining region in an area comprising scaffold 101 assembled from the tilapia genome (Brawand *et al.*, 2014).

Several studies have shown that temperature can override genetic sex determination in the Nile tilapia as has been demonstrated in both domestic and wild populations (Baroiller *et al.*, 1995; Bezault *et al.*, 2007; Baroiller *et al.*, 2009a). In the Bouaké domestic strain, temperature >32°C caused complete masculinisation of some genetic female fries into phenotypic males (Baroiller *et al.*, 1995). The natural distribution of the Nile tilapia represents a very large region across Africa, including Western, Nilo-Sudanian and part of the East African Rift regions, with distinct temperature regimes ranging from Mediterranean, stable tropical climates to cold or extremely hot lakes in Ethiopia and hot springs in Kenya (Baroiller *et al.*, 2009; Bezault *et al.*, 2011; Trewavas, 1983; Nyingi *et al.*, 2009). Detection of masculinisation by high temperature was evidenced using breeders from several wild populations adapted to different thermal regimes but variations amongst populations and families were encountered in the proportion of males achieved by thermal treatment (Baroiller *et al.*, 2009). Progeny testing under controlled conditions provided indirect evidence of the existence of XX males as well as XY females in a wild population of the Volta basin (Bezault *et al.*, 2007).

Family-specific QTLs were associated to temperature-masculinised XX tilapia on LG1, LG3 and LG23 (Wessels *et al.*, 2011). LG23 contains scaffold 101 in which is located the Nile tilapia *amh* gene. Very recently, a deletion of a male-specific duplicated form of the *amh* gene lacking the TGF-β domain has been identified and proposed as the possible sex-determining gene in Nile tilapia referred to as *amhy* (Eshel *et al.*, 2014). *Amh* does indeed have male-specific features. It is expressed in the brain of tilapia in a sex-dimorphic manner at early stages (Poonlaphdecha *et al.*, 2011), followed by a sustained expression in the testes (Ijiri *et al.*, 2008; Poonlaphdecha *et al.*, 2011). Furthermore, it is one of the major genes rapidly upregulated in temperature-masculinisation (Poonlaphdecha *et al.*, 2013). In addition, allelic differences were found in the *amh* gene with higher effects for the phenotypic males obtained by elevated temperatures (Wessels *et al.*, 2014).

The interaction of genetic and temperature influences on sex determination in the Nile tilapia might stem from SNP variations of sex-differentiating genes such as found for the allelic variant specific for males found in the *amhr2* gene of fugu (Kamiya *et al.*, 2012). In the present study, allelic association to sex was analysed in several wild populations of Nile tilapia living in different thermal regimes including some inhabiting natural hot lakes characterized by high temperatures above 32°C, with newly discovered populations living in

hot springs of the Loboi Swamp in Kenya (Nyingi et al., 2009; Nyingi and Agnèse, 2012; Ndiwa et al., 2014). Such environment exposes the fish to critical masculinizing temperatures, which would under normal circumstances radically affect the sex ratios of these populations. In spite of this, these populations continue to have normal sex-ratios, which indicate that they have most likely adapted to this situation. To better understand how a thermal regime exerts its effect on wild populations, we performed a SNP screen in specific genes implicated in sexdetermination or sex-differentiation, located in two linkage groups associated to sex, LG1 and LG23. One of the genes studied is the gonadal aromatase gene cyp19a1a which encodes the enzyme catalysing the conversion of androgens into oestrogens, and which is down-regulated in temperature-masculinisation (D'Cotta et al., 2001). A second gene selected was the Wilms Tumor 1 gene Wt1b, which is a fish duplication of the vertebrate wt1 gene implicated in gonad development (Brennan and Capel, 2004). Both wt1b and cyp19a1a are located on LG1 and SNP variations were found in the heterogametic sex (Lee and Kocher, 2007). Finally, extensive analysis was also performed on the amh gene located on LG23. We have also taken advantage of the amhy as a marker to identify putative XX phenotypic males (absence of amhy) or XY phenotypic females (presence of amhy) amongst the wild populations of Nile tilapia in Africa in order to search for sex-reversed fish. We then compared them to the domesticated strains whose phenotypes and genotypes have been well studied for their sex determination systems.

2. Materials and Methods

2.1 Fish sampled and phenotypic sex identification

Eleven populations of Nile tilapia have been investigated; nine are natural populations while two, the Bouaké (Ivory Coast) and the Manzala (Egypt) are domesticated strains (Table 1). From the Kenyan Rift-Valley (Fig. 1), a total of 5 populations have been studied, three from hot springs (Lake Bogoria Hotel Spring, Chelaba Spring and Turtle Spring) and two from middle/standard temperature habitats (Lakes Baringo and Turkana). Also three populations are from the Ethiopian Rift-Valley region, one from a hot spring (Lake Metahara) and two from cold altitude lakes (Hora and Koka). This has been completed by three populations adapted to standard tropical temperature regime from the Nilo-Sudanian area: one population from Sudano-Sahelian region (Kpandu) and one from the Nile basin (Manzala), while the Bouaké is a synthetic strain composed initially with individuals from both Volta and Nile

rivers populations. These populations have been chosen because they experience different thermal conditions (Bezault *et al.*, 2007; Nyingi *et al.*, 2009 and Ndiwa *et al.*, 2014). The three hot springs populations are exposed to high water temperatures of approximately 36 °C, conditions previously associated with masculinisation of XX females (Baroiller *et al.*, 1995). The population of Lake Metahara connected to the Awash River, is also possibly adapted to high temperature as the lake is supplied by hot water from a hot spring at a temperature of 43 °C (Goërner *et al.*, 2005). In the hot springs, temperatures vary between 32 °C and 39 °C. The Lake Baringo is located between the Loboi hot springs and Lake Turkana and is relatively shallow and has water temperatures around 25 °C. Lake Turkana population lives in medium water temperatures (25 °C) that are slightly saline with pH of 9.3 (Yan *et al.*, 2002). Under experimental conditions both the Bouaké and Manzala domesticated strains resist temperatures of 36 °C with male proportion varying between offspring.

Fish were caught a few meters from the shore of all lakes and hot springs using dip nets. Individual phenotypic sex was determined by macroscopic observation of the gonads. For each population, an average of five individuals characterized as phenotypic males or females were considered for the study, totalling 192 fish analysed. On each fish, a fin clip was collected and preserved in absolute ethanol for DNA analysis.

2.2 Genomic DNA extraction, PCR amplification and sequencing

DNA was isolated from approximately 50mg of fin samples by first digesting at 55°C overnight using 10 μl proteinase K in 180 μl of extraction buffer solution (1M Tris, 0.5M NaCl₂, 1% SDS). The DNA was then extracted using either a phenol/chlorophorm procedure as previously described by Bezault *et al.*(2011) or by the salting-out protocol described by Aljanabi and Martinez (1997). The concentration of the extracted DNA was quantified using NanoDrop spectrophotometer (NanoDrop, Technologies) and concentration of each sample standardized to 30 ng/μl.

PCR reactions were performed using 60 ng of genomic DNA in a total reaction volume of 50 μ l containing 5 μ l of 10×MP Biomedicals buffer (Tris Cl, KCl, (NH₄)₂SO₄, 15 mM MgCl₂), 2 μ l of 10 mM dNTP (0.2 mM of each dNTP), 1 μ M of each primer, and 0.5 units of Taq polymerase. PCR Tm amplifications and cycle timing varied depending on the primer pair used (table 2), with primers ordered from Eurogentec (Belgium).

PCR conditions involved an initial denaturing for 5 minutes at 95°C, followed by 40 cycles of amplification, consisting in a denaturing for 1 minute, annealing for 1 minute, and elongation for 3 minutes at 72°C, and ending with 10 minutes elongation at 72°C. After agarose verification of PCR product, they were column purified and then a Sanger sequencing was carried out on an ABI-3130 or privately by Eurofins genomics (Germany), on both the forward and reverse strands using their corresponding specific primers.

2.3 Sequence analysis to identify SNP differences

Chromatogram verification was performed manually where sequencing inconsistencies were found. Sequences were then aligned using both MUSCLE (Edgar, 2004) as well as CLUSTALW with Seaview Version 4.3.5 software (Gouy and Gascuel, 2010). Alignments were corrected manually. SNPs were then manually identified using BioEdit 5.09 software (Hall, 1999). Comparisons and alignments were performed using several reference genes (Figures S1-S3) obtained from: GenBank (table 2), available on Nile tilapia Genome at Ensembl (www.ensembl.org, release 76 last accessed Ago. 2014) as well as from the Bouillabase (gbrowse:http://cichlid.umd.edu/cgi-

bin/gb2/gbrowse/Tilapia broad anchored v1/).

The expected number of male and female phenotypes for each population was calculated based on Hardy-Weinberg Equilibrium (HWE). We then calculated the relationship between sex-linked SNPs and phenotypic sex using Chi-Square test with p value based on Monte Carlo (Hope, 1968). The obtained SNPs data was coded and analysed using Factorial Correspondence Analysis (FCA) on Genetix Version 4.05 (Belkhir et al., 2004) to examine the relationship between the populations with respect to SNP markers. Lastly, linkage disequilibrium between allele pairs was calculated using Genetix version 4.05.2 (Belkhir et al. 2004).

2.4 Use of X and Y markers to identify genotypic sex

PCR amplifications were performed on all the individuals using primers Amh-F2443 and Amh-R3490 (table 2) allowing discrimination between XX individuals, and XY/YY individuals (Eshel et al., 2014). PCR reactions were performed using 60 ng of genomic DNA in a total reaction volume of 25 µl containing 2.5 µl of 10×MP Biomedicals buffer (Tris Cl,

KCl, (NH₄)₂SO₄, 15 mM MgCl₂), 2 μl of 10 mM dNTP (0.2 mM of each dNTP), 1 μM of each primer, and 0,75 U of Taq polymerase. PCR conditions involved an initial denaturing for 5 minutes at 95 °C, followed by 38 cycles of amplification, consisting in a denaturing at 95 °C for 30 second, annealing at 58 °C for 30 seconds and elongation for 2 minutes at 72 °C ending with a 10 minute elongation at 72 °C.

An additional discrimination to define the genotypic sex was performed using the X-specific and Y-specific primer couples (table 2) as described by Sun *et al.* (2014). The PCR reaction was performed as above and conditions similar with an annealing at 60°C for 35 cycles. All PCR products were migrated on a 1.5% agarose gel.

3. Results and Discussion

It is well known that in Nile tilapia the genetic sex determination XX/XY can be switched due to high temperature influences (Baroiller *et al.*, 2009a). Sex-reversed XX males and XY females were found amongst breeders in some wild populations (Bezault *et al.*, 2007) suggesting either influences of temperature or minor genetic factors. However, how these influences occur and how frequently the temperature exerts its masculinizing effect in the wild remain unknown. Temperature and genetic influences on sex may be the result of allelic variations on sex-differentiating genes. The current study was carried out in nine wild populations in order to investigate allelic polymorphisms related to the phenotypic sex of Nile tilapia, on three sex-differentiating genes (*cyp19a1a*, *wt1b* and *amh*) previously found to have allelic variants linked to males (Lee & Kocher, 2007; Eshel *et al.*, 2014; Wessels *et al.*, 2014). The *cyp19a1a* and *wt1b* genes are located on linkage groups LG1 (Lee and Kocher, 2007), while *amh* is located on LG23 (Shirak *et al.*, 2006). Studies have shown that these two LGs are associated to sex (Lee *et al.*, 2003; 2004; Cnaani *et al.*, 2008; Eshel *et al.*, 2012).

The nine wild populations cover a large portion of the natural distribution of Nile tilapia in Africa, as well as the entire spectrum of thermal regime encountered by the species in the wild. A selection of 192 individuals were analysed with 99 classed as phenotypic males. Specific sex genotypes produced by chromosome manipulation (Baroiller and Jalabert, 1989; Scott *et al.*, 1989) were also used for the Manzala domesticated-strain, amongst which were included 5 XX males, 5 YY supermales and 1 YY female. Individuals (n=5-7) with poor sequence reads were discarded. We identified a total of 41 SNPs of which 33 allelic variants were found in the *amh* gene, 4 in the aromatase *Cyp19a* promoter and 4 in the *Wt1b* gene. In

addition, our study also found insertions and deletion varying in size for the *cyp19a1a* promoter and *amh* gene, some of which were unique to certain populations.

3.1 SNP identified on the cyp19a1a promoter region

Our previous studies performed on the domesticated Bouaké and Manzala strains have shown that the sex-differentiating gene aromatase *cyp19a1a* is implicated in the molecular mechanism of ovarian differentiation (D'Cotta *et al.*, 2001) and temperature masculinisation of XX female fries causes a down-regulation of this gene (Poonlaphdecha *et al.*, 2013). The present study was focused on a 499 bp fragment of the 5' flanking region of the tilapia *cyp19a1a* gene in which an allelic variant was previously identified g.2124G>A with males being heterozygotes (AG), and females homozygotes (AA) (Lee & Kocher, 2007). This SNP was one of the four polymorphisms found in the *cyp19a1a* promoter region (Table 3) but we detected here no polymorphism associated to the phenotypic sex. It was heterozygous (Cyp_2124GA) with a 38.50 % frequency in all Lake Kpandu individuals and in all fish belonging to the Ethiopian Rift Valley, Lakes of Hora, Metahara and Koka, and in 9 fish out of 13 in the Bouaké strain. All fish from Lake Turkana and the Turtle hot spring were homozygous *Cyp_*2124AA. Although some individuals had the G allele, the majority of the Chelaba and Bogoria hot springs fish and the domesticated Manzala strain had the A variant.

The three other SNPs (Table 3) showed much higher polymorphism between the hot spring populations of the Loboi swamp and Lake Baringo compared to all the other populations. However, none of these SNPs were correlated with sex. In the hot springs, the Cyp_2016C>T variant predominated together with the Cyp_2175A>G showing a 18.28 % frequency of heterozygous Cyp_2175AG. An exhaustive analysis of the 5' flanking region of *cyp19a1a* was recently performed in tilapia (Böhne *et al.*, 2013). Based on this analysis, the Cyp_2175 SNP was located in a binding site for SF-1, a transcription factor implicated in the activation or repression of the aromatase *cyp19a1a* gene. We can therefore hypothesize that this SNP might be exerting a repressive action on the *cyp19a1a* gene in some of the hot springs fish.

In addition to SNPs, we detected three nucleotide deletions (table 4) when comparing sequences between our populations with those of Genbank AF472620 and Ensembl ENSONIG00000000155. Two of these deletions (Cyp_1988 and Cyp_1993) involved a single nucleotide each, while one (Cyp_2036-37) involved two nucleotides. The G deletion at Cyp_1988 was observed only in the three Ethiopian populations (Metahara, Hora and Koka)

and might be a specificity of this region since it was observed in both the subspecies *O. n. cancellatus* and *O. n. filoa*. The A deletion located on Cyp_1993 was only seen in the Bogoria and Chelaba hot springs (11/40) with one SNP A>T change seen in 3 individuals. Lastly, deletion on Cyp_2036-37 was observed in every studied population of *O. niloticus* with respect to the references.

Pairwise analysis of the SNPs and deletions identified in the cyp19a1a promoter showed linkage disequilibrium (table 5) elevated for the Bogoria and particularly for the Chelaba populations between Cyp_1992, Cyp_2016, Cyp_2124 and Cyp_2308.

The first analysis performed on the *cyp19a1a* promoter identified SNPs and deletions shared between the Manzala strain and the Lake Turkana population indicating a close affinity of Turkana fish to fish of Nilotic origin, with some affinities also visible in fish from the Ethiopian Rift Valley.

3.2 SNPs identified on the wt1b gene between exon 5 and 7

A sex-linked SNP was previously detected by Lee and Kocher (2007) on the wt1b gene with females being homozygous (g.686CC) and males being heterozygous (g.686CG). Because of this, we restricted the SNP search to a 899 bp fragment comprising exon 5 to exon 7. Four SNPs were found on the wt1b gene but the 686CC named wt1b 684 in our study (table 6) was not amongst these. Three SNPs were located on intron 6, while the wt1b 649 SNP was located in the codon between exon 5 and exon 6 causing a non-synonymous substitution. There was a clear population-associated polymorphism found for the Wt1b 398 SNP. Wt1b 398GG was found in 22 out of 23 Kpandu fish, while in contrast all the Ethiopian Rift Valley fish as well as the Turkana fish were found to be homozygous Wt1b 398AA. A higher variability was observed for the Bogoria, Chelaba, Turtle and Baringo fish with Wt1b 398AA, Wt1b 398GG or Wt1b 398AG. The Manzala YY males were mostly Wt1b 398AA whereas the XX males or females were Wt1b 398GG or Wt1b 398AG (also found for the Bouaké fish). Similarly, high polymorphism was observed on SNP Wt1b 464 with specimens from six populations (Bouaké, Kpandu, Manzala, Chelaba, Baringo and Turkana) being homozygous (Wt1b 464AA or Wt1b 464GG), while two hot spring populations (Bogoria and Turtle) were either homozygous (Wt1b_464AA) or heterozygous (Wt1b 464AG). Similarly, the three Ethiopian populations (Metahara, Koka and Hora) were homozygous (Wt1b 464AA). The SNPs Wt1b 466 and Wt1b 649 were less heterozygous

than Wt1b_398 and Wt1b_464. Heterozygous SNPs were observed on only three populations (Bouaké, Kpandu, Manzala) for Wt1b_466, and two (Manzala and Baringo) for the Wt1b_649. No deletions and insertions were observed on this gene. Like *cyp19a1a*, SNPs observed in the wt1b region segregated across populations but was not linked to phenotypic sex.

A linkage disequilibrium was seen between Wt1b_308, Wt1b_464, Wt1b_464 and Wt1b_649 for the Baringo population as well as the Bouaké strain (table 7).

3.3 High amount of SNPs identified on the amh gene

We identified an astonishing large amount of SNPs (n=33) in the *amh* gene. These SNPs were found throughout the gene (table 8), but were particularly concentrated in intron 6 (13), exon 6 (4) and exon 7 (8). Out of the 19 SNPs located on the coding region of the *amh* gene (different exons), 6 involved changes on the amino acids while the rest were synonymous (Table 8). The occurrence of deletions and insertions in the *amh* gene was also observed on different populations of *O. niloticus* as shown on Table 9. All observed insertions and deletions occurred on intron 6. Two deletions located from 2677 to 2694 of 17 nt and from 2895 to 2914 of 18 nt were particularly noticeable since they only occurred in the three Kenyan hot spring populations together with Lake Baringo fish. Furthermore, these deletions had strong linkage disequilibrium.

3.4 Finding of SNPs in the amh gene associated with the phenotypic sex

In addition to presenting the highest number of SNPs, the *amh* gene also showed SNPs with strong relationship to the phenotypic sex. The initial search for SNPs associated to sex was grouped, but we found large population differences. Even though these associations were observed in most populations studied, stronger associations were observed on the Kenyan populations. A strong correlation was observed for the amh_202 SNP for both the Kpandu population and the Bouaké and Manzala strains with XX fish being homozygous amh_202AA while males were amh_202GG or amh_202GA. This polymorphism was not seen in the other populations. Likewise, females from the Kpandu, Manzala and Metahara populations had a C allele on the amh_754, while the males were mostly heterozygous amh_754TC (including the YY Manzala fish) or homozygous amh_754TT. Within the Kenyan populations (Bogoria,

Chelaba, Turtle, Baringo and Turkana), 12 SNPs were observed on the *amh* gene that had strong association to phenotypic sex (table 10). Analysis of these SNPs indicated significant deviations from the HWE of some populations. For instance, three populations (Bogoria, Chelaba and Turtle) showed significant deviations on amh_2509, while four SNPs (amh_597, amh_611, amh_2586, amh_2807) deviated significantly in two populations each. Interestingly, the SNP amh_597 G>T caused a change in amino acid with females having the T variant while males had the G variant thereby, changing from Glutamic acid to Aspartic acid. Likewise, the SNP amh_611 females had the G variant while males had the A allele changing the amino acid from Serine to Asparagine, respectively. The remaining two SNPs (*amh*_2618 and *amh*_2655) recorded significant deviation from HWE each in one population (Table 10).

Very recently, two studies have shown SNPs linked to sex in the amh gene of Nile tilapia. Eshel et al., (2014) revealed a 233 bp deleted form of the amh gene specific to males when carrying the Y chromosome, on XY and YY individuals, which the authors refer to as amhy. In the sequencing of both amh and amhy they identified a SNP at position 1274 (corresponding to amh 2992 in the current study) with a T allele present in XX female fish, a C in XY males and both C/T in YY individuals. This SNP was also found in our study but no T and C sex-association was noted in our Manzala strain which is from the same origin as the one used by Eshel et al., (2014). We found XX female fish with the C allele and with both C/T alleles (Fig. 2). Likewise, we found XY males carrying the T allele as well as C/T combination, while YY fish had the T variant. Similar observations were recorded for the Bouaké strain, with females either carrying the C or the C/T alleles. In wild populations such as Lake Turkana, some females had the C allele while others a T allele, as well as both C/T alleles. These combinations were also seen in males. We did not find the A>G substitution at position 1275 found in the amhy form since all our fish had only the G allele. We did not find either the SNP at position 1403 (corresponding to amh-3112) with a G allele for the amhy vs the T for the *amh*.

Another important SNP identified (ss831884014) was associated with temperature masculinisation and autosomal sex-reversal (Wessels *et al.*, 2014). This SNP located at position 2183 in our study was not polymorphic in the individuals studied from different populations or strains.

Considering the different results obtained from SNP analysis, there is existence of significant deviations that varied among populations on many SNPs. These results confirm previous

findings by Baroiller *et al.* (2009a; 2009b) and Cnaani *et al.* (2008), that the associations to phenotypic sex are population-specific. Therefore, determination of sex in *O. niloticus* should be analysed at a population level.

3.5 FCA analysis of SNPs

A Factorial Correspondence Analysis (FCA) including all SNPs observed in the three sex-linked genes clustered *O. niloticus* populations into four distinct groups (Fig. 3). The first group comprised the three Kenyan hot spring populations of Bogoria, Chelaba and Turtle as well as the Lake Baringo population. The second group included exclusively the Lake Turkana population, separating it from all other Kenyan as well as Nilotic populations. The third group comprised two of the three Ethiopian populations (the hot spring of Lake Metahara and cold Lake Koka populations), and the fourth group consisted in all Nilo-Sudanian *sensu lato* populations (the Nilotic Manzala strain, the Sahelo-Sudanian Kpandu population as well as the synthetic Bouaké strain), but also, less expectedly, the Ethiopian population of the cold crater lake of Hora. This observation suggests that sex chromosomes in Nile tilapia are still in a continuous state of evolution, with possibly evolution of different sex-linked haplotypes across the entire natural distribution of the species, hence the observed differences between the studied populations.

3.6 Use of X and Y markers to identify sex-reversal individuals

We found association of the SNPs in the *amh* gene with the phenotypic sex. However, this can be different from the genotypic sex since sex-reversal in tilapias is under the influence of both high temperatures and minor genetic factors (Baroiller *et al.*, 2009a). We therefore, exploited the recent published "amhy" markers as described in Eshel *et al.* (2014) which discriminates two bands, a ~1000 bp size band present in XX females and a second ~800 bp band only present in males carrying the Y chromosome, XY and YY individuals. In the domesticated Manzala strain, the *amh* markers identified correctly all our genetic XX females, XY males, the five YY supermales as well as an YY female (Fig. 4). It also allowed the identification of sex-reversed XX males and an XY female. A XY male that gave biased sexratios in progeny testing was in fact identified as an XX male. For the Bouaké strain the 800 bp markers identified a number of individuals which did not correspond to the supposed genotype. When using the markers in the wild populations, they indicated the presence of several sex-reversed XX males although no XY females. A close look at the different

populations evidenced that none of the males from the Ethiopian populations of Lake Metahara, Lake Koka and Lake Hora had the 800 bp band considered to be an *amhy* form (Eshel *et al.*, 2014). These results suggest that the *amhy* markers do not discriminate males in all Nile tilapia populations.

We then analysed the amhy markers in the Kenyan wild populations (Fig. 5) and here the majority of males possessed both the XY and YY specific 800 bp band as well as the 1000 bp band. Females in contrast had mostly the unique 1000 bp band, which indicated that the amhy most likely discriminated correctly the genotypic sex. Contrary to other populations, the Kenyan populations had five fish out of 97 individuals that were found to be sexually reversed females (phenotypic females that had XY genotypes), while ten phenotypic males had supposedly XX genotypes. Both Chelaba Spring and Lake Baringo populations had three reversed males each, while Lake Bogoria Hotel Spring and Lake Turkana populations had two reversed males each. Considering females only, Lake Baringo had 2 inversions while Lake Bogoria Hotel Spring, Chelaba Spring and Lake Turkana had 1 inversion each. Surprisingly, no sex-reversal was detected in males and females from the Turtle Spring. A possible explanation for this occurrence is that individuals from this population may have been less sensitive to masculinising effect of high temperature compared to individuals from the other two hot springs. This hypothesis seems to agree with the findings of Baroiller and D'Cotta (2001) who observed that some progenies of Nile tilapia displayed higher sensitivity to temperatures resulting in high proportions of males in their sex ratios, while others showed insensitive balanced sex ratios. Lack of inversion may have also resulted from lower water temperature experienced by this population (32-34 °C) compared to the other two hot spring populations (36 °C). Our earlier studies using FISH (unpublished data), which showed presence of reversed individuals within the hot spring (Supporting information Figure S1) disputes this theory. An alternative explanation to this finding is that the markers used in our study failed to identify reversed individuals from Turtle spring population.

We wanted to further validate the presence of these sex-reversed individuals by also using very recently published X and Y specific markers also located on scaffold 101 of LG23, with one of the markers tightly linked to the SD locus, permitting the distinction between normal XY males and YY males (both viable in tilapia) (Sun *et al.*, 2014). However these markers could not be used due to complications in the PCR testing. Nevertheless, these additional markers should be tested in all our wild populations to see whether they discriminate the genotypic sex in a similar manner as the duplicated *amh* form.

The presence of sex-reversed XX males and XY females in several wild populations in this study coincides with our previous studies in which both XX males and an XY female were indirectly identified *via* progeny testing of wild breeders (Bezault *et al.*, 2007). We are however, surprised by the elevated number of sex-reversed individuals encountered. An alternative hypothesis is that the *amhy* is not the sex determining gene but that the *amh* gene is in close proximity to the sex determining locus and in some individuals recombination does not occur. The fact that the *amh* markers did not show a second *amh* form (*amhy*) with a deletion in all the Ethiopian males indicates that this is not an universal male sex-marker (or sex-determinant) in Nile tilapia populations. In addition, other deletions were found amongst the Kenyan populations that were in intron 7 but their presence suggests that a more detailed analysis of all the *amh* gene sequences should be carried out to detect more regions of deletions or insertions between sexes and populations.

Sex reversal of both males and females was observed in two populations of O. niloticus from the hot springs (Bogoria and Chelaba Springs). These hot springs are characterized by water temperature of ~36 °C and do not undergo significant changes annually since the springs are served by faults and fractures that allow water from deep aquifers to rise to the surface (Deocampo, 2002; Ashley et al., 2004). The possible presence of XX males amongst our different populations living in varying temperature regimes in the present study and that of Bezault et al., (2007) and Baroiller et al., (2009a) suggests that some wild individuals were sensitive to the effects of high temperatures, causing masculinisation of XX females. Environmental sex reversal is the modification of primary sex during ontogeny into a sex opposite to that coded by the genotype (Bull, 1993; Valenzuela et al., 2003). According to Baras et al. (2001) sex reversal is a conservative process that enables the species to not produce sex ratios that can jeopardize its survival. Progeny differences for temperature masculinisation have been detected previously with some progenies or individuals not being sensitive to temperature (Baroiller et al., 1995; Baroiller et al., 2009a). It is therefore, not surprising that for the survival of a population living particularly in hot springs, both genetic and temperature influences coexist so that the sex-ratios are not biased.

The existence of several sex-reversed XY females in wild populations detected in the present study is rather astonishing although it correlates with the finding of an XY female in a previous progeny testing of wild breeders (Bezault *et al.*, 2007). We think that these individuals may result from additional autosomal genetic factors influencing sex which we called minor genetic factors.

In conclusion, our study has detected several SNPs in three sex-differentiating genes cyp19a1a, wt1b and amh amongst wild populations living in different temperature regimes as well as in domesticated strains. Several deletions and insertions were found on cyp19 and amh genes particularly in populations living in hot springs above 34°C constant temperatures, known to cause masculinization and leading to male biased sex ratios. We hypothesized that these deletions and insertions may be responsible for adapting the populations against the effects of high water temperature. Our study shows SNPs in the amh gene strongly associated to the phenotypic sex notably in the Kenyan Hot spring populations. The SNPs associated to sex varied depending on the population. In addition, by using amh markers we have detected sex reversed XX males as well as XY females in all populations except in the Turtle hot spring. Because none of the males in three Ethiopian populations could be discriminated, the amh deleted form is most likely not the tilapia master sex-determinant, but may be in close proximity to the sex-determining locus.




Figure 1: Map showing the locations of studied areas within the Kenyan Rift-Valley, Sudano-Sahelian and Ethiopian regions




Figure 2: Chromatograms obtained from the domesticated strains and one of the wild population showing that our polymorphism does not coincide with the study of Eshel et al. (2014) in which XX females had a T, XY males a C and YY males both





Figure 3: FCA analysis of all the SNPs identified from the amh, cyp19a1a and the wt1b genes








Figure S2: Cyp19&1 gene sequence








Figure S3: Amh gene sequence of O. niloticus




Figure S4: Sex inversion on fish from Turtle Spring based on BAC and FISH

# (III) Morphological variations of wild populations of Nile tilapia living in extreme environmental conditions in the Kenyan Rift-Valley

#### **Abstract**

In this study, we use geometric morphometric to establish morphological differences between natural populations of Nile tilapia from two extreme environmental conditions (high temperature and salinity) in Kenya, and compare them to two populations from regions experiencing less extreme conditions. The study observed significant morphological differences between all studied populations, including three closely related hot spring populations (Bogoria, Chelaba and Turtle Springs), and two populations with similar genetic background inhabiting saline environments in Lake Turkana basin (Turkana and Crocodile Lake populations). In addition, allometric growth patterns of the seven populations differed significantly, demonstrating that developmental changes (plastic or adaptive) operated between these populations. All observed differences were attributed either to genetic and/or environmental factors, which seemed to play a major role in influencing morphology of wild Nile tilapia populations. We recommend further studies to be carried out under controlled conditions to confirm the role of temperature, pH and salinity in morphological diversification of Nile tilapia.

### 1. Introduction

Cichlids are tropical freshwater fishes well known for their high rates of speciation often resulting in rapid radiation. They exhibit remarkably high levels of diversity that affect their morphology, ecology, behaviour and genomes (Nelson, 1994; Barlow, 2000; Chakrabarty, 2005). A large extent of cichlid diversity is observed in three main East African Lakes (Victoria, Tanganyika and Malawi) where 1800 to 2000 species (60% of all cichlid species

worldwide) are present in species flocks (Meyer et al., 1990; Stiassny and Meyer, 1999; Kerschbaumer and Sturmbauer, 2011). These cichlid species flocks are primarily monophyletic groups of closely related species inhabiting the same ecosystem, and evolved from a single ancestral species (Greenwood, 1974). Within these three East African Lakes, some cichlid species went through rapid morphological diversification and speciation, leading to formation of many new species within a few thousand generations (Sage et al., 1984; Meyer et al., 1990; Owen et al., 1990). In Lake Victoria for instance, the radiation of monophyletic haplochromine species occurred within a geologically short time of about 750,000 years and resulted to the emergence of approximately 500 cichlid species flocks (Greenwood, 1984; Abila et al., 2004; Kerschbaumer and Sturmbauer et al., 2011). Additionally, evolutionary older cichlid assemblages of Lake Tanganyika have shown the highest degree of morphological differentiations (Salzburger et al., 2002).

Under the ecological theory of diversification (Schluter, 2000), a strong relationship exists between speciation events and colonization of new environments, or niche diversification, which may in turn induce changes in organism's behaviour, morphology and physiology (Price *et al.*, 2003). Generally, selection pressures that exist in new environments favour divergence of populations from their ancestral forms. A classic example is provided by the case of the three spined sticklebacks (*Gasterosteus aculeatus*) in Canada, where two sympatric forms (limnetic and benthic) emerged as a consequence of ecological divergence (Schluter and McPhail, 1993). This example among others has provided evidence of morphological diversifications as a result of environmental variations. However, Gagnaire *et al.* (2013) proposed that ecological divergence may actually involve multiple facets of species divergence on which divergent selections may operate, hence the need for an integrative approach to study the process of speciation. Some of the factors proposed to influence divergence include variations in quantitative phenotypic traits, regulation in gene expression and differential transmission of particular allelic combinations (Gagnaire *et al.*, 2013).

The Nile tilapia (*Oreochromis niloticus*), the subject of our study, is a teleost fish of the family Cichlidae, has its native range in Africa and is widely known for its importance in aquaculture. This species has been recognized for its ability to tolerate a wide range of salinity, dissolved oxygen and temperature (Avella *et al.*, 1993; Farmer and Beamish, 1969), a high fecundity and a rapid growth rate (Liti *et al.*, 2005) and an omnivorous mode of feeding (El-Sayed, 1999; Peterson *et al.*, 2005). Due to these attributes, the species has the ability to adapt rapidly to new environments, showing a wide range of biological responses to different

environmental conditions both in culture and in nature (Seehausen, 2006; Schofield *et al.*, 2011). As a result of this plasticity (or of the high degree of physiological tolerance found in the Nile Tilapia), the species has been able to successfully establish itself in extreme environmental conditions such as temperate winter conditions (Peterson *et al.*, 2005; Grammer *et al.*, 2012), hot springs (Trewavas, 1983; Nyingi *et al.*, 2009) and saline waters (Schofield *et al.*, 2011). Nile tilapia has in addition been reported to consistently out-compete other species of fish even in areas beyond its natural ranges, especially as colonisers of newly emerging lacustrine ecosystems (Boulenger, 1898). Studies by Collyer *et al.*, (2005) in pupfish (*Cyprinodon tularosa*) noted that the geographical spread of species across a broad range of ecological conditions is accompanied by equally diverse morphological variations, which are strongly correlated to the environmental conditions.

Within the Kenyan Rift Valley, Nile tilapia has colonized numerous newly formed habitats within a system characterised by a number of drainages comprising a series of rivers, springs and lakes. This complex system is a host to four out of the seven described sub-species of *Oreochromis niloticus* by Trewavas (1983): *O. n. baringoensis* from Lake Baringo; *O. n. sugutae* from River Suguta; *O. n. vulcani* from Lake Turkana. Recently Nyingi *et al.* (2009) discovered a natural population from Lake Bogoria Hotel genetically differentiated from but nevertheless close to the Lake Baringo population. The purpose of this current study is to investigate whether populations of the Nile Tilapia have diverged significantly morphologically from each other, and whether these differences can be related to environmental factors (either as the result of phenotypic plasticity or adaptive evolution).

According to Collyer *et al.* (2005, 2007), variations in salinity have the potential of affecting fish body shape. These authors reported a general decrease in body circumference to overall body size at high salinity on pupfish (*Cyprinodon Tularosa*). Similarly, high water temperatures can also influence both the growth rate and development rate of an organism (Atkinson, 1995). In Zebra fish (*Danio rerio*) for instances, raising of juveniles under four different developmental temperatures resulted to highly variable phenotypes (Sfakianakis *et al.*, 2011). A similar study by Georgakopoulou *et al.* (2007) on European seabass (*Dicentrarchus labrax*, L) showed that samples reared under lower temperatures (15 °C) were more slender than those reared under higher temperature (20 °C). Even though no studies have been carried out to establish the effect of water pH on fish shape, extreme changes in water pH have been reported to cause fish deaths by altering other aspects of water chemistry,

for instance increase in pH increases toxicity of ammonia (Schofield, 1976; Wurts and Durborow, 1992).

Taking into consideration the local genetic variations observed in three recently discovered populations of *O. niloticus* within the hot springs (Chelaba, Lake Bogoria Hotel and Turtle) of Loboi Swamp (Nyingi, *et al.*, 2009; Ndiwa *et al.*, 2014), we hypothesized that these fish populations may also differ in shape due to the influence of high salinity and high temperature. In addition to the Loboi Swamp fish, another population of *O. niloticus* found in the northern part of the Kenyan Rift-Valley also experiences extreme environmental conditions. The Crocodile Lake, one of the three Lakes located on the Central Island of Lake Turkana is saline, with electrical conductivity as high as 10,590 μS/cm and alkaline with a pH of around 10.0 (Avery, 2010). Depending on the level of Lake Turkana, Crocodile Lake can either be submerged or emerged. During high water level the lake has been known to disappear (Hay, 1976; Cerling, 1979) while in low water levels, it remains isolated. The last time the two lakes were reported to have connected was in 1902 (Hopson *et al.*, 1982). So far only three species of fish have been reported to survive in Crocodile Lake namely: *Clarias gariepinus*, *Haplochromis sp*, and *O. niloticus*.

Both the Loboi and Crater Lake populations have adapted to extreme conditions, high temperature and high salinity levels respectively, while other closely related populations (Lakes Baringo, Turkana and Victoria) do not experience such conditions. These populations thus present an opportunity to observe how extreme conditions affect the morphology of the fish. To achieve this goal, we compared individuals from seven populations, four with extreme conditions (hot springs; Lake Bogoria Hotel Spring, Chelaba Spring, Turtle Spring and saline; Crocodile Lake populations), and three that experience more favourable environmental conditions (Lakes Baringo, Turkana and Victoria).

The study provides an insight into morphological responses of these fish populations to extreme temperature and salinity. Occurrence of phenotypic differences between the populations studied will confirm that the environment or/and the genetic background play an important role in evolution of cichlids, while lack of phenotypic differences will imply that the high degree of tolerance in Nile Tilapia is related to its propensity to invade new environment, and in keeping a very canalized phenotype.

#### 2. Materials and methods

# 2.1 Study areas

Specimens from three hot spring populations of Loboi swamp drainage system (Chelaba, Lake Bogoria Hotel and Turtle) and other three Lakes (Baringo, Turkana and Crocodile) were studied (Table 1; Figure 1). The three hot springs are characterised by elevated water temperatures (approximately  $36^{\circ}$ C), low dissolved oxygen concentration ( $3.5 - 3.9 \text{ mgl}^{-1}$ ) and slight acidity pH (6.4 - 6.9) (Ashley et al., 2004). The springs drain into Loboi swamp of about 1.5 Km², which is covered by dense vegetation of Typha domingensis and Cyperus papyrus. As the water exits the swamp, it is poorly aerated (Dissolved Oxygen (DO) = 0.2 -1.1 mgl⁻¹) and has a higher pH (7.4 - 8.3) (Ashley et al., 2004). Comparatively, Crocodile Lake is a crater formed Island lake within the Lake Turkana. It is characterised by relatively higher water pH (10) and almost three times higher salinity (conductivity, 10,590 μS/cm) than Lake Turkana, which has pH and a conductivity of 9.3 and 3,420 μS/cm respectively (Avery, 2010). Lake Baringo, a fresh water Lake located about 52 Km from the Loboi swamp has D.O. concentration ranging from 5.89-6.7 mg/L, temperature range of 22.1 - 31.8 °C, pH~8.5 and conductivity of about 580 µS/cm (Omondi et al., 2014). Lake Victoria, also fresh water body is characterized by water temperatures ranging from 23.8 to 31.5 °C, pH 6.2 - 9.2, and conductivity of approximately 170 µS/cm (Ochumba, 1990; Crul, 1995).

#### 2.2 Collection of samples

Fish specimens were collected from the hot springs (Chelaba, Lake Bogoria Hotel and Turtle) and Lakes Baringo, Victoria, Turkana and Crocodile using seine nets and scoop nets. Fish were anaesthetised and killed using an overdose of MS-222 before fixing in 4% formalin solution for seven days. The formalin was washed and voucher specimens preserved in 70% ethanol, and are curated as reference material at the National Museums of Kenya. The standard lengths (SL) of the fish were measured using a digital Vernier calliper in order to estimate their sizes.

### 2.3 Geometric morphometrics

Body shape of the samples was quantified using landmark based geometric morphometric method (Rohlf and Marcus, 1993). Images of preserved samples of fish were obtained by using a flatbed scanner (Herler *et al.*, 2007) and imported into the program tpsUtil version 1.53 (Rohlf, 2012). A total of 14 landmarks (figure 2) were chosen based on their capacity to

capture overall body shape, and their coordinates (x,y) digitized on the left hand side of each sample using the program tpsDig version 2.16 (Rohlf, 2010).

A total of 237 fish specimens from seven wild population of Nile tilapia (Bogoria Hotel, 41; Chelaba, 30; Turtle 24; Baringo, 43; Victoria, 33 Crocodile, 28 and Turkana, 38) were analysed. Their standard sizes ranged from 40mm to 207mm.

The measurement error was estimated by re-scanning and land-marking of 11 randomly chosen fish samples from Lake Turkana. The size and shape measurement Error (ME) was then estimated using ANOVA and Procrustes ANOVA following the procedure of Yezerinac *et al.* (1992), as explained in Claude (2008; 2013). In this approach, the measurement error is compared to among fish variations, and measurement error variation.

### 2.4 Data analysis

Data analysis was carried out using R software program packages (Claude, 2008; 2013). In order to establish morphological variations between the different populations of fish, we used principal component analysis (PCA) of the superimposed coordinates of the landmarks. Variations were visualised by plotting multivariate ordination of specimens on the first two principal component (PC) axes. Contribution of original variables on corresponding eigenvectors or PC loadings were analysed to establish shape features that had the greatest influence on each PC.

Nested MANCOVA models were conducted on the principal components (PC) of shape data in order to assess the influence of locality, and environmental factors. Habitat and locality were considered as explanatory variables and centroid size as a covariate in the model. Size was added as a covariate to understand the effect of habitat and locality on allometric growth patterns.

Response ~ Size + Habitat + Habitat:Size + Habitat:locality + Habitat:Locality:Size

To represent and appraise morphological differences between the localities, a linear discriminant analysis was performed on the dataset of the Procrustes coordinates.

A mantel test analysis (Mantel, 1967) was also performed on Fst Values and Mahalanobis distance in order to confirm the influence of genetic factors on the morphology. Lastly, minimum spanning network based on Mahalanobis distance was constructed in order to visualize phenotypic relationship between the seven wild populations of Nile tilapia.

#### 3. Results

#### 3.1 Measurement error

In the current study, we estimated the size and shape measurement Error using ANOVA and Procrustes ANOVA. The percentage measurement error was less than 1 % for the centroid size and 60 % for shape.

#### 3.2 Size variation

Comparison of fish sample sizes between the seven populations of Nile tilapia (Fig. 3) indicated minimal variations between specimens from Lake Baringo, Chelaba Spring, Crocodile Lake and Turtle Spring. However, greater sample size differences were observed between the latter populations and populations from Bogoria Spring, Lake Turkana and Lake Victoria. Size comparison among individuals of same population showed least variations within Crocodile Lake (Fig. 3).

#### 3.3 Shape variation (pca)

The first shape PC accounted for 23% of the observed variations. This PC was mostly related with the variation of the head, caudal peduncle and anal fin (Fig 4). The PC2 on the other hand accounted for 14.5% of variation mostly within the depth of the body and caudal peduncle (Fig. 4).

Even though there were overlaps between most of the populations under study, significant morphological differences were observed between all populations. A strong separation was observed between the hot spring populations and both Crocodile Lake, and Lake Turkana populations based on PC1. However, PC2 showed greater differentiation between Lakes Turkana and Crocodile populations than the latter (Fig 4).

Surprisingly, we observed that populations of Lakes Turkana and Victoria were close morphologically. These results were unexpected since the two systems have different ecological characteristics.

#### 3.4 Differences between populations (and eventually habitats)

Both differences in habitats and localities significantly explained the shape variations between the seven populations of Nile tilapia studied (Table 2). Linear discriminant analysis based on the sampling locations correctly assigned 84.8 % of the individuals to their respective localities. All samples from Lake Victoria were assigned to their real group (table 3). However, most of individuals from the hot springs populations that were not correctly assigned to their respective localities were either assigned to another hot spring population(s), or to L. Baringo (table. 3). Assignment of individuals from other localities is shown on table 3.

Linear discriminant analysis (LDA) clustered the seven populations of *O. niloticus* into two distinct groups. The first cluster consisted entirely of individuals from Lake Victoria, while the second cluster comprised the other six populations (Fig. 5).

However, partial separations were observed among the hot spring populations and also among Lakes Turkana and Crocodile populations (Fig. 5). Shape variations related with both LDA1 and LDA2 were attributed to differences within the head and the caudal region.

Because we observed a significant interaction of locality with size, we compared small sized individuals to large sized individuals from each locality in order to establish their differences and similarity in growth. Generally, we observed a decrease in head size and length of the mouth with increase in size in all the six populations except Crocodile Lake, where no marked differences were observed between the heads of the small and large sized samples (Fig 6).

The closely related hot spring populations displayed different patterns of growth irrespective of their close spatial relationship. In Bogoria spring, small sized individuals were characterized by more elongated mouths compared to the other two spring populations. On the other hand, the heads of small sized individuals from Chelaba Spring showed slight elongation with greater dorsal displacement of their mouths. We also observed posterior displacement of the anal fin as individuals increase in size for Bogoria and Chelaba populations. Finally, large sized samples from Chelaba and Turtle Springs had elongated caudal peduncle length compared to small sized individuals, while no differences were observed for Lake Bogoria Hotel Spring population (Fig. 6).

Growth patterns of the Lake Turkana system (Turkana and Crocodile) populations differed significantly among themselves, and among other *O. niloticus* populations. For instance, great change in shape was observed between the small sized samples and the large sized samples involving drastic decrease of the depth of the body and caudal peduncle. Dorsal displacement of the mouth and anterior displacement of the eye, dorsal fin and operculum were also noted.

Smaller differences were observed between small and large samples in Lake Turkana; anterior elongation of the mouth for small sized individual, anterior displacement of the lower jaw and pelvic fin of mature individuals, and slight elongation of the caudal peduncle (Fig. 6).

Within the two control populations (Lakes Victoria and Baringo), marked differences were observed between small and large sized samples. Comparison between their growth patterns showed that Lake Victoria samples had deeper caudal peduncles that increased in length with maturity of the fish, while Lake Baringo samples had slender caudal peduncles, which also increased in length with fish growth (Fig. 6).

Additionally, correlation of Fst values and Mahalanobis distance based on Mantel test analysis showed existence of significant relationship (P<0.05) (Fig. 7).

Minimum spanning network computed from Mahalanobis distances between localities showed close proximity between the three hot spring populations. Additionally, Lake Turkana population showed close relationship to Lake Victoria population, while Crocodile Lake and Lake Turkana populations were separated (Fig. 8).

#### 4. Discussion

Morphological analysis revealed that specimens studied were first differentiated by their sizes. Fishes from Lakes Turkana and Victoria were the largest with a mean size of 122.8±4.38 mm (mean ± standard error) and 163.3±4.40 mm, respectively. The smallest specimens were from Turtle Spring and Crocodile Lake, and exhibited mean sizes of 76.6±6.11 mm and 70.1±1.72 mm, respectively. Differences were also observed in terms of variability of sizes; some samples had higher size range (Lake Victoria) than others (Crocodile Lake). These observed differences may partly represent artefacts due to sampling, and may not completely reflect the actual differences of fish sizes in different localities despite the knowledge that Lakes Turkana and Victoria host large specimens of *O. niloticus* (Trewavas, 1983) due to their larger sizes and greater depths, compared to biotopes investigated in the present study.

The shape measurement error reported by our study is relatively higher than expected. This can partly be explained by the fact that it comprises measurement error, didgitization error, and variations among the digitizing and scanning devices. Additionally, the study considered a single population in determing shape measurement error implying that the value of among

fish variations (which divides the measurement error variations during calculations of shape measurement error) was low hence contributing to a higher shape measurement error value.

In our study, we observed different allometric patterns of growth in all the seven populations of Nile tilapia. Considering the fact that most of the localities differ greatly in their environmental conditions, the observed allometries may be partly attributed to environmental differences, which might have acted on developmental stages, and shaped the differences observed between *O. niloticus* populations. Whether differences are adaptive or the byproduct of phenotypic plasticity is still speculative at that stage but could be tested by doing experimental reciprocal transplantation of fish (see however the end of the discussion).

Shape changes found in our study could be functional and environmentally related. Indeed, our observations are congruent to findings by Ramler *et al.* (2014) who investigated the effect of different temperatures on body size and shape on stickleback (*Gastrerosteus aculeatus*). The authors reported significant differences between individuals across different temperature groups. A similar study on zebrafish (*Danio rerio*) juveniles reported occurrence of highly variable phenotypes induced by diverse thermal conditions during the early ontogenic stages (Sfakianakis *et al.*, 2011). However, results obtained by Fujimura and Okada (2008) comparing (during their developmental stages) the lower jaw bones of a cichlid fish (*Haplochromis chilotes*) from Lake Victoria and another Riverine cichlid (*O. niloticus*) contradicted our findings. Irrespective of the habitat differences, the authors noted that most shape changes had a similar pattern during the growth of the two species showing that the development of these fish were relatively robust.

The PC analysis revealed a large amount of shape differences whereby variations of the head, caudal peduncle and anal fin accounted for 23% (Fig. 4). These variations allowed discrimination of the Lake Victoria specimens from those of other Lakes (Baringo, Turkana and the hot springs). Within these latter populations, fishes from Lake Turkana were placed between the two groups of fishes.

Differentiation of the Lake Victoria population from all other population based on linear discriminant analysis was even clearer (Fig. 5). There was also a clear separation between the hot springs specimens on one hand, and Lake Turkana and Crocodile Lake specimens on the other hand. Specimens from Lake Baringo appeared to fall between these two groups of specimens. All observed variations on both LDA1 and LDA2 were related to differences within the head and the caudal region.

These results are congruent with the genetic variation observed by Agnèse *et al.* (1997), who demonstrated that fishes from Lake Baringo and Lake Turkana are genetically close. Later on, Nyingi *et al.* (2009) and Ndiwa *et al.* (2014) observed that fishes from the hot springs are even more closely related to fishes from Lake Baringo. If one assumes that fishes from Crocodile Lake should have a genetic background identical to the fishes of Lake Turkana, and that fishes from Lake Victoria introduced from Lake Albert (Fryer and Iles, 1972, Trewavas, 1983) should be less genetically related to the other fish studied, then morphological differentiation seems to be congruent with genetic differentiation. Indeed, our studies based on mantel test confirmed the role of genetic factors in influencing morphology. In addition, links between morphological and genetical differentiation have been reported by Stewart and Albertson (2010), who integrated both genetic and geometric morphometric approaches in studying scale eating cichlids of Lake Tanganyika, which had been reported to show frequency balanced polymorphism in the left-handedness and right-handedness of the mouth, an adaptation previously reported by Takahashi *et al.* (2007). Their morphometric results strongly supported the genetic basis of jaw laterality.

When looking at closely genetically related populations, one can observe a certain amount of morphological differentiation. The first case concerned specimens from the three hot springs. Specimens from Bogoria and Chelaba or Bogoria and Turtle springs were unevenly distributed along the first and second axis of the LDA analysis respectively (Fig. 5). Differences between Chelaba and Bogoria Springs were mainly due to variations in body length and body depth, while differences between Bogoria/Chelaba and Turtle were as a result of variations in head length and body depth.

If we consider that the genetic background of these three populations is the same (Ndiwa et al, 2014), then these observed morphological differentiations could be attributed to phenotypic plasticity of the species. Very likely, environmental characteristics of these hot springs are slightly different. Bogoria Spring is the biggest of the three hot springs and runs a few hundred meters before entering the swamp. The two others have a smaller flow rate and enter in the swamp after only few meters. Nevertheless, as only a few genes can strongly act on morphological differentiation, one cannot exclude that morphological differences observed between the three hot spring populations was due to genetic differences. Ndiwa et al. (2014) observed that gene flow between these populations is limited by the swamp, which is covered by a dense vegetation of *Typha domingensis* and *Cyperus papyrus*. Decomposition of organic matter, and shading provided by these vegetation is responsible for low oxygen concentration

and low temperatures, which act as barriers to free movement of the fish from one place to another. Similarly, Ndiwa *et al.* (2014) also observed that these fish are slightly introgressed by *O. leucostictus* genes from escapees of this species originating from aquacultural ponds within the drainage. The account of possible introgression of alien genes acting on morphological differentiation cannot be excluded. Similar study by Zaccara *et al.* (2013) on three cichlid species (*Alcolapia* spp.) based on 13 populations inhabiting lagoons and hot springs of Lake Natron (located between Kenya and Tanzania), like in the current study also showed significant morphological differences beween studied populations.

The second case of genetically related populations in our study concerns fish from Lakes Turkana and Crocodile. There was also a clear morphological differentiation between these two groups of fish as shown in Fig. 5. Specimens from Crocodile Lake were generally smaller than those from Lake Turkana, and differed in body depth, head size and caudal length.

These two populations are genetically very close (unpublished results) since Crocodile Lake population originated from Lake Turkana about one century ago. Most likely, the observed differences can be as a result of phenotypic plasticity. These lakes offer two quite different environments to the fish. Lake Turkana is a large alkaline (pH 9.3) and slightly saline lake (conductivity 3,420 μS/cm) hosting numerous fish species (48 following Hopson *et al.*, 1982). Comparatively, Crocodile Lake is a small size lake (about 0.32 Km²), with high alkalinity (pH 10) and salinity (conductivity 10,590 μS/cm). Only three species of fish are present, two Cichlids (*Aplochromis* sp, *O. niloticus*) and one Clariid (*Clarias gariepinus*).

In conclusion, our study provided evidence that both genetic and environmental factors play an important role in influencing morphological development of *O. niloticus* populations. Despite the findings, further laboratory studies are necessary in order to confirm the importance of these environmental factors. This can be achieved by breeding genetically identical siblings in different environmental conditions: first under low versus high salinity, and secondly under low versus high temperature.




Figure 1: Map showing the location of all the seven natural populations of O. niloticus: Lake Turkana at Lake Turkana drainage system, Crocodile Lake in the Central Island of Lake Turkana, Lake Baringo at Lake Baringo drainage system, Turtle Spring, Chelaba Spring and Bogoria Hotel Spring in the Loboi Swamp, and Lake Victoria at L. Victoria drainage system.




Figure 2: Position of 14 different landmarks used in the study: (1) anterior tip of the snout with mouth closed, (2) centre of the eye, (3 & 4) anterior and posterior insertions of the dorsal fin, (5) dorsal origin of caudal fin, (6) point halfway between dorsal and ventral origin of caudal fin, (7) ventral origin of caudal fin, (8) posterior insertion of anal fin, (9) anterior origin of anal fin, (10) anterior origin of pelvic fin, (11) juncture of the ventral edge of operculum with the ventral outline, (12) most posterior end of the mouth, (13) anterior origin of pectoral fin and (14) most posterior end of operculum.




Figure 3: Size distribution of the fish samples collected from the seven localities.




Figure 4: Differentiation of the seven populations of Nile tilapia based on Principal Component Analysis (PCA). On fish shape images (PC 1, 2), red = mature (large samples) and blue small (young) samples. In the scatterplot, cro=crocodile, Tur =Turkana, Che=Chelaba, Bog=Bogoria, Trt =Turtle, Bar=Baringo, Vic=Victoria.




Figure 5: Differentiation of the seven populations of Nile tilapia using Linear Discriminant Analysis (LDA). On fish shape images (LDA 1, 2), red = mature (large samples) and blue small (young) samples. In the scatterplot, cro=crocodile, Tur =Turkana, Che=Chelaba, Bog=Bogoria, Trt =Turtle, Bar=Baringo, Vic=Victoria.




Figure 6: Growth patterns in the seven populations of Oreochromis niloticus. Red colour represents the shape of the large samples while the blue colour represents the shape of the small sized individuals.




Figure 7: Mantel test of Fst values against Mahalanobis distance showing positive correlation




Figure 8: UPGMA dendrogram showing overall similarity in body shape among the O. niloticus populations

## (IV) General discussion

Nile Tilapia is an emblematic fish from Africa which has been introduced in most if not all the tropical countries. Its ability to adapt to new environments allowed it to colonize most river basins in the countries where it was introduced for farming. One would have thought that culture of this species would have been simple like rearing of either chickens or pigs, both considered as part of the pantheon of domesticated species. However, there are many not well-known characteristics of *Oreochromis niloticus* that still excite scientists and fish farmers.

We know from the pioneer work of Trewavas (1983) that the species is naturally variable, and widely spread in Africa. The author defined seven groups based on morphological differences (meristic and morphometric characters) and called them subspecies. However, we must recognize that this work had a lot of discrepancies, and for a long time needed to be revised, not only with new morphometric methods (as geomorphometrics), but also with genetic tools (sequences of mtDNA, microsatellites) and with evolutionary considerations more in line with the modern view of evolution.

*Oreochromis niloticus* is an economically important fish species whose worldwide popularity has risen rapidly over the recent past. Its development in aquaculture is partially hindered by the fact that it is difficult to produce male mono-sex fingerlings. Indeed, there are differences in growth rates of males and females, and males tend to grow faster than females on one hand. On the other hand, use of mixed sex cultures sharply reduces growth of fish as a result of reproduction activities that occur within the grow-out ponds. Despite sex determination having been studied extensively in the Nile tilapia, genetic control to produce males is still unreliable. Therefore, the production of male monosex population mainly relies upon sex reversal treatment using 17alpha-methyltestosterone with important concerns about environment and food safety. Sex in this species (as in many other fish species) is determined by the interactions between major (sex chromosomes) and minor (brought by both parents) genetic factors as well as environmental factors. The environmental factor influencing sex in the Nile tilapia is temperature. High temperatures (>32°C) have a strong masculinizing effect on XX female tilapia (Baroiller et al., 1995; Baroiller et al., 2009). This temperature sensitivity of sex differentiation is under genetic control, carried by both parents in an additive way (Baroiller and D'Cotta, 2001; Baroiller et al., 2009; Wessels et al., 2011). Thermosensitivity can be rapidly selected (in three generations) under laboratory conditions

giving breeders which produce ~93% males in their offspring (Wessels *et al.*, 2011). Hence, high temperatures could be exploited in a larger scale for tilapia farming as a way to produce all male progenies. Therefore, further research on sex determination and particularly the effects of temperature in *O. niloticus* is of utmost importance in the context of aquaculture.

One of the most popular strains of *O. niloticus*, especially in Asia, is the GIFT strain. The strain was developed using germplasm obtained from both domestic strains, and wild populations obtained from Egypt, Ghana, Kenya and Senegal (Eknath *et al.*, 1995; Eknath and Acosta, 1998). The success of this strain is certainly due to the selection program employed in its production. However, this success would not have been achieved if the genetic basis of the original strains would have been poor. In other words, it is because the original strain was made from a mixture of different natural genetic resources of *O. niloticus* that the selection was so successful. This provides evidence of the importance of these natural genetic resources for aquaculture.

With the use of genetic tools, these genetic resources are now more studied than before (Rognon *et al.*, 1996; Agnèse *et al.*, 1997; Nyingi and Agnèse, 2007; Nyingi *et al.*, 2009, 2012; Bezault *et al.*, 2011). However, it is clear that some of *O. niloticus* natural resources are on one hand not fully studied and some are even not yet identified. For example fishes from Lake Tanganyika are yet to be studied and some natural populations may still be waiting to be discovered (like the recent population of Loboi Swamp). On the other hand, these natural genetic resources are threatened by fish farming activities through hybridization with other tilapias species (Ndiwa *et al.*, 2014) or strains (Ansah *et al.* 2014).

In this context, we take the opportunity that Kenya is a hot spot of *O. niloticus* biodiversity in order to study some of these natural populations. From all the possible populations, we focused on those that live in extreme environmental conditions since they could represent cases of specific genetic adaptation, possible morphological differentiation and are under strong anthropogenic threats.

#### 1.1 New genetic resources under threat, the case of Loboi Swamp hot spring populations

In a survey of *O. niloticus* populations in East Africa, the occurrence of a new (previously unknown) native population of *O. niloticus* in Loboi Swamp (Lake Bogoria Hotel Spring), Kenya has been documented (Nyingi *et al.* 2009, 2012). This population was initially

assumed to have been introduced from other localities within the region. However, its native status was confirmed due to its significant and unique genetic variability with a large number of private microsatellite alleles and mtDNA haplotypes (partial D-loop). The presence of tilapia in two other hot springs in the Loboi Swamp namely Turtle and Chelaba Springs, prompted us to investigate these fish. The present study clearly establishes that these two hot springs also host native fish closely related to those from Lake Bogoria Hotel Spring.

Moreover, partial mtDNA sequences of the D-loop region analysis showed that the haplotype of *O. leucosticus* from Lake Naivasha previously confirmed to be present in Lake Baringo, is also present in the three *O. niloticus* populations of the springs thus providing evidence that some of the fish in each of the hot springs have been introgressed by *O. leucostictus*. The previous study of Lake Bogoria Hotel Spring specimens (Nyingi *et al.*, 2007, 2012) did not detect any introgression. This can be due to insufficient number of specimens studied (16) or as a result of very recent introgression events. Indeed, if these introgressions originated from aquaculture practices *i.e.* escapees of *O. leucostictus* specimens or from *O. niloticus* introgressed beforehand in fish farms within the Loboi swamp drainage, as it was hypothesized, then it is possible that these introgressions may have occurred after 2007. The second hypothesis is more likely than the first.

Indeed, fish farming activities within the region have been enhanced as a result of funding by Kenyan government through the Economic Stimulus Programme (ESP) introduced in 2009. The aim of the ESP project was to construct 200 fishponds worth 10.6 million euros in 140 constituencies by June 2013, with each constituency receiving 70,000 € (Nyingi *et al.* 2011). Eight fishponds have been constructed between 2012 and 2013, in close proximity to the Loboi Swamp (within a range of 230–700 metres), and some stocked with Nile tilapia fingerlings from unspecified sources. Other fishponds in the Baringo-Bogoria catchment are located along the main rivers and streams in the region. Fingerlings used to stock the ponds within the region are produced by Omega Fish Farms located at Ol Kokwe Island on Lake Baringo. The farm was established to produce fingerlings for the local fish farmers. Broodstock for the establishment was obtained from the Lake Baringo, hence may have acted as a source of introgressions observed in the Loboi Swamp fish.

Our results based on the 16 microsatellites loci studied clearly indicated that alien nuclear genes are present in *O. niloticus* in the hot springs and Lake Baringo populations. Within these populations, most of the individuals exhibited no or a very small amount of nuclear introgression, and a few specimens appeared to have 90% probability intervals that extended

more than 30% out of a pure species Q value which suggested that these individuals had an important degree of genetic introgression.

Taking into account that the hot spring biotopes are small, and consequently the size of the effective populations, native mtDNA diversity was higher in the hot springs populations (four haplotypes for six individuals in Chelaba Spring; five haplotypes for seven individuals in Turtle Spring) than in Lake Baringo and River Suguta populations. This high diversity may have been favoured by the stable environmental conditions and consequently decreased levels of environmental stress in the hot springs (Ashley *et al.*, 2002, 2004; Deocampo, 2007).

The present ecological situation is now breaking this millenary equilibrium in two ways. We first discussed the threats of aquaculture activities, but there is another important menace: water catchment. The Loboi Swamp receded in size by about 60% over a short period of 30 years due to expansion of irrigation via a ditch constructed in 1970 (Ashley *et al.*, 2004; Owen *et al.*, 2004). In addition, periodic avulsion events have caused changes to river courses in this region. The most recent was during the El-Nino that induced heavy rains of 1997 that caused changes to the course of Loboi River. The river that used to feed Lake Baringo partially changed its course and now also flows to Lake Bogoria. Changes in flow were also influenced by intensive encroachment by local farmers leading to weakening of stream banks (Harper *et al.*, 2003, Owen *et al.*, 2004).

If it was apparent that the three populations of *O. niloticus* in the hot springs are distinct from other related populations by the presences of private alleles and haplotypes, at least partly, this differentiation could be the consequence of their local adaptations to the extreme thermal conditions of their habitat. Studies indicate that exposure of *O. niloticus* to water temperatures of 36 °C or more at an early stage of their development (10 days post fertilization) can influence sex ratios towards males (Baroiller and D'Cotta, 2001; Baroiller *et al.* 2009b). These characteristics are of utmost importance to aquaculture, as they can be utilised to inexpensively produce all-male cultures. Tilapia farming mainly relies on male monosex culture in order to avoid overcrowding in the ponds due to breeding, and to benefit from fast growth of males (Baroiller *et al.* 2009b; Baroiller and Jalabert, 1989; Beardmore *et al.* 2001). Hence the rich genetic diversity and adaptations to masculinizing effect of water temperature makes these populations 1) an important aquaculture resource, and 2) an important natural model for understanding sex determination in Nile tilapias.

# 1.2 Sex determination in *O. niloticus*: The usefulness of the Loboi Hot Springs populations to disentangle the complex role of temperature.

Temperature and genetic influences on sex may be the result of allelic variations on sex-differentiating genes. Moreover, how these influences occur and how frequently does temperature exert an effect in the wild remain unknown. Our study was carried out in order to investigate allelic polymorphisms related to the phenotypic sex of Nile tilapia in nine wild populations and compare these to two domesticated strains (the Bouaké strain produced in Ivory Coast and the Manzala strain from Egypt). The nine wild populations cover a large portion of the natural distribution of Nile tilapia in Africa, as well as the entire spectrum of thermal regime encountered by the species in the wild. A selection of 192 individuals were analysed with 99 classed as phenotypic males. SNPs were searched on three sex-differentiating genes (*cyp19a1a*, *wt1b* and *amh*) previously found to have allelic variants linked to males (Lee & Kocher, 2007; Eshel *et al.*, 2014; Wessels *et al.*, 2014). The *cyp19a1a* and *wt1b* genes are located on linkage groups LG1 (Lee and Kocher, 2006) while *amh* is located on LG23 (Shirak *et al.*, 2006) for which the linkage analysis of these LGs showed segregation with sex (Lee *et al.*, 2003; 2004; Cnaani *et al.*, 2008; Eshel *et al.*, 2012).

Our study revealed a total of 41 SNPs of which 33 allelic variants were found in the amh gene, 4 in the aromatase Cyp19a promoter and 4 in the Wt1b gene region studied. In addition we also found insertions and deletion varying in size for the cyp19a1a promoter and amh gene, some of which were unique to certain populations. One of the SNPs was Cyp 2124 which had previously been linked to sex with females being homozygotes (AA) and males heterozygotes (AG) (Lee and Kocher, 2007). In our study we found no polymorphism associated to sex but rather segregation according to populations. No association to sex was found for the other three SNPs found in the cyp19a1a promoter. These four SNPs were strongly polymorphic in Lake Baringo and the Loboi fish particularly in the Chelaba hot spring showing linkage disequilibrium between the SNPs. Interestingly, one of the SNPs (Cyp 2175) was found in the binding site for SF1, an important transcription factor responsible for either the activation or repression of the cyp19a1a gene. An hypothesis could be that this SNP may be one of the factors causing a repressive action on the cyp19a1a gene (reducing the amount of estrogens and causing masculinisation) in temperature sensitive fish or perhaps the reverse, activating the gene and thus increasing the amount of estradiol causing ovarian differentiation (in fish where temperature causes no masculinisation). Likewise, no polymorphism was seen with sex for the four SNPs identified in the region of the *wt1b* gene studied, but all segregated across populations.

The most interesting result is that in addition to presenting the highest number of SNPs, the amh gene also exhibits SNPs with strong relationship to the phenotypic sex. Even though these associations were observed in most populations studied, stronger associations were observed on the Kenyan populations. Within these populations (i.e. Bogoria, Chelaba, Turtle, Baringo and Turkana), 11 SNPs were observed on the amh gene that had strong association to phenotypic sex. Analysis of these SNPs indicated significant deviations from the HWE of some populations. For instance, three populations (i.e. Bogoria, Chelaba and Turtle) showed significant deviations on amh 2509, while four SNPs (amh 597, amh 611, amh 2586, amh 2807) deviated significantly in two populations each. Interestingly, the SNP amh 597 G>T caused a change in amino acid with females having the T variant while males had the G variant thereby changing from Glutamic acid to Aspartic acid. Likewise, the SNP amh 611 females had the G variant while males had the A allele changing the amino acid from Serine to Asparagine respectively. SNPs amh 2618 and amh 2655 recorded significant deviation from HWE each in one population. Of the 11 SNPs linked to sex, two imply nucleotide changes causing amino acid changes (are synonymous) which might significantly modify the function/activity of the hormone. The other 9 SNPs are all located in intron 6, and why and how they affect the gene is not clear.

Other precedent studies have shown SNPs linked to sex in the *amh* gene in domestic strains of Nile tilapia (Eshel *et al.*, 2014) with some also found in intron 6 (Wessels *et al.*, 2014). Association to sex of these SNPs was not found in our study despite having also used the Manzala strain which might be due to laboratory specific selections. Our results show that SNPs linked to sex are population-specific reinforcing previous findings by Baroiller *et al.*, (2009a; 2009b) and Cnaani *et al.*, (2008), that the LGs associations to phenotypic sex are population-specific. Therefore, determination of sex in *O. niloticus* should be analysed from a population point of view.

Another interesting result from this thesis was the clustering of all the SNPs identified in the sex-linked genes of the *O. niloticus* populations in four distinct groups: (1) the three Kenyan hot spring populations of Bogoria, Chelaba and Turtle as well as the Lake Baringo population, (2) Lake Turkana population, (3) two of the three Ethiopian populations (*i.e.* the hot spring of Lake Metahara and cold Lake Koka populations), (4) and the fourth group consisted in all Nilo-Sudanian *sensu lato* populations (*i.e.* the Nilotic Manzala strain, the Sahelo-Sudanian

Kpandu population as well as the synthetic Bouaké strain), but also, less expectedly, the Ethiopian population of the cold crater lake of Hora. This observation suggests that sex chromosomes in Nile tilapia are still in a continuous state of evolution, with possible evolution of different sex-linked haplotypes across the entire natural distribution of the species, hence the observed differences between the studied populations.

We also wanted to address the question of whether the phenotypic sex of the fish studied was the same as the genotypic sex. In other words how many sex-reversed fish could be found amongst our wild populations since tilapia sex is under the influence of both high temperatures and minor genetic factors (Baroiller *et al.*, 2009a). We exploited the recent published "amhy" markers as described in Eshel *et al.*, (2014) which discriminates two bands, a ~1000 bp size band present in XX females and a second ~800 bp band only present in males which carry the Y chromosome, XY and YY individuals. We observed the presence of sexinverted XX males as well as XY females in several wild populations. A finding which correlates with previous studies in which both XX males and an XY female were indirectly identified *via* progeny testings of wild breeders (Bezault *et al.*, 2007). Nevertheless, as observed in the SNPs, it clearly appeared that the "*amhy*" markers do not discriminate correctly genetic males and females in all populations. The *amhy* form which has a 2XX deletion was not found in any of the male fish from Lake Metahara, Lake Koka and Lake Hora, meaning that *amhy* does not exist in fish from the Ethiopian Rift Valley. This indicates that the *amhy* is not the universal male-determinant of tilapia.

It would be very informative to use, in all the populations studied, other recently identified X and Y markers (Sun *et al.*, 2014) to see whether the genotypes identified coincide. Unlike *amhy*, these markers can differentiate XY from YY fish. We do not know the origin of the Chinese strain used for the analysis but considering our studies it would not be surprising to find that these markers do not discriminate males from the Ethiopian populations.

Another way to identify sex-reversed fish from the Kenyan populations would be the use of Bacterial Artificial Chromosomes (BAC) markers. An inverted region of more than 1,5 Mb has recently been identified in a region near the centromere in linkage group 3 which corresponds to the large bivalent pair. Using two BAC probes, Fluorescent *In Situ* Hybridizations (FISH) were compared in Nile tilapias between XX females, XY males and YY supermales, showing an inverted region in one of the large chromosomes in XY males with both chromosomes being inverted in YY males (Ozouf *et al.* 2008; D'Cotta *et al.*, 2014). In order to identify the genotypic sex of the Kenyan wild populations and see whether

temperature may be causing a masculinization, we attempted to perform a FISH analysis using the two BACs on metaphase spreads of males and females. The FISH signals seem to be inverted in some individuals such as a TSF7 (female from Turtle Spring) shown in supporting Fig. 1, suggesting the existence of sex-reversed tilapias. However, the FISH analysis was not conclusive because the quality and number of metaphases were low. It would therefore be interesting to continue this study further increasing the number of individuals and the quality of metaphases.

# 1.3 Morphological differentiation in O. niloticus: Genetic versus plasticity, what do we learn from populations living in extreme environments?

East Africa exhibits the largest extent of cichlid diversity with more than 2000 species (60% of all cichlid species worldwide) present, mainly in species flocks (Meyer *et al.*, 1990; Stiassny and Meyer, 1999; Kerschbaumer and Sturmbauer, 2011). Within the three East African Lakes some cichlid species went through rapid morphological diversification and speciation, leading to formation of many new species within a few thousand generations (Sage *et al.*, 1984; Meyer *et al.*, 1990; Owen *et al.*, 1990). Additionally, evolutionary older cichlid assemblages of Lake Tanganyika have shown the highest degree of morphological differentiations (Salzburger *et al.*, 2002).

A strong relationship exists between speciation events and colonization of new environments, or niche diversification, which may in turn induce changes in organism's behaviour, morphology and physiology (Price *et al.*, 2003). Indeed, there are many evidences of morphological diversifications as a result of environmental variations.

Oreochromis niloticus can be a model to studies aiming at determining the role of genetic versus environment in morphological differentiation of fish. On one hand natural populations are morphologically differentiated as demonstrated by the pioneer work of Trewavas (1983). On the other hand these populations are genetically differentiated as many authors observed (Rognon et al., 1996; Agnèse et al., 1997; Nyingi et al., 2009; Bezault et al., 2011). Moreover, O. niloticus was able to colonize extreme environments like hyper-saline lakes (Crocodile Lake) or hot springs (Loboi swamp).

Our study on such remarkable populations revealed that morphological differentiation in *O. niloticus* is both determined by genetic and environmental factors. Genetically close

populations (Lake Turkana and Crocodile Lake on one hand, and Hot Springs and Baringo on the other hand) tend to be morphologically closely related when considering the overall populations. Closer examination revealed that within these groups of populations, a certain amount of morphological differentiation exists. Very likely, the origin of morphological differentiations between Crocodile and Turkana populations could be due to phenotypic plasticity rather than genetic differentiation. The two populations are assumed to share the same genetic background, but live under different environmental conditions (varying in pH and salinity). On the contrally, slight morphological differentiation between Chelaba, Bogoria and Turtle Hot spring populations could be due to genetic factors. Even though the three hot spring populations had similar genetic background, their subsequent separation and low gene flow seems to have played a major role in their differentiation since they live in habitats with very small environmental differences.

Despite the confirmation that the two factors (genetics and environment) play a major role in morphological differentiation, some laboratory experiments are necessary to further confirm these results. Genetically identical fish (siblings) could be bred in different environments (low *versus* high saline concentrations, low *versus* high temperatures) in order to determine the importance of pH, salinity and temperature.

#### 1.4 Future research perspective

The current study clearly established occurrence of genetic introgression between *O. leucostictus* and *O. niloticus* populations of the three hot springs of Loboi Swamp. It will be interesting to monitor and precisely elucidate the origin of this introgression. In addition, follow up studies are necessary in order to establish how the introgressed populations will evolve over time.

Despite their close proximity and connection via the swamp, low gene flow was observed between the three hot spring populations. It is therefore necessary to conduct further studies using more powerful approaches involving high number of loci i.e SNP. This will enable accurate evaluation of gene flow between the three hot spring populations.

Our morphological study clearly established that both genetic and environmental factors play a major role in influencing morphology. It will be interesting to carry out further morphological studies on fish raised under controlled conditions in order to establish the role of various environmental factors such as temperature, pH and salinity in influencing morphology.

Understanding of sex determination in the hot spring populations can be achieved by pursuing the SNP analysis studies in the inverted region of LG3 notably on the *dmrt4* gene implicated in fish development, which is found in this LG3 region. A first SNP analysis was performed in this thesis in scaffold 88 corresponding to part of the inverted region of LG3. Although some SNPs had allelic variations, it is still early to know if they are associated to the populations and to the phenotypic sex because not all the wild populations could be analyzed, and the number of individuals was reduced in some populations.

Finally, if the sex-reversed individuals result from a temperature effect on sex differentiation, it will then suggest that 2 mechanisms of sex determination are still present in populations living under high thermal regimes. The persistence of these two mechanisms could be associated to an adaptive role of thermosensitivity in these populations. In order to answer this question, it will be necessary to estimate the frequency of sex reversed individuals in a population, and then, to compare the fitness of sex reversed *versus* classic individuals. In addition, Bacterial Artificial Chromosomes (BAC) markers can be used to further confirm our sex-reversed results in Kenyan populations.

#### Résumé détaillé de la thèse

Le tilapia du Nil (*Oreochromis niloticus*, Linné, 1758) fait partie de la famille des Cichlidae qui regroupe environ 3000 espèces principalement distribuées dans les régions tropicales et sub-tropicales du monde. Cette espèce, originaire d'Afrique, a été introduite dans plus de 100 pays à travers le monde pour y être élevée. Depuis le premier travail de Trewavas (1983), un certain nombre d'études ont tenté de documenter la diversité des populations naturelles d'*O. niloticus*, en particulier leur caractérisation génétique (Rognon *et al*, 1996; Agnèse *et al*, 1997; Nyingi *et al*. 2009; Bezault *et al*, 2011). Cependant, la connaissance de leur diversité génétique reste encore insuffisante. En outre, certaines populations naturelles sont mal connues comme celle du lac Tanganyika par exemple, ou peut être même encore inconnues comme en témoigne la récente découverte d'une population naturelle au Kenya (Nyingi *et al*., 2009).

La plupart, sinon toutes, des ressources naturelles génétiques du tilapia du Nil se trouvent en Afrique et jouent un rôle majeur dans l'amélioration des souches cultivées dans d'autres parties du monde. Par exemple, le tilapia GIFT (Genetically Improved Farmed Tilapia) souche génétiquement améliorée a été développée à partir de populations fondatrices du tilapia du Nil provenant de populations sauvages et de souches cultivées (Eknath, 1995; Eknath et Acosta, 1998). Notamment, des poissons en provenance d'Egypte, du Ghana, du Kenya et du Sénégal ont été utilisés, ainsi que des souches d'élevage provenant d'Israël, de Singapour, de Taiwan et de Thaïlande (Gupta et Acosta, 2004).

Même si le tilapia du Nil est une espèce envahissante dans de nombreux bassins fluviaux et a parfois été accusé d'être à l'origine de la disparition de certaines espèces de poissons (Ogutu-Ohwayo, 1990), ses populations naturelles sont aussi menacées (Nyingi *et al*, 2007; Nyingi et Agnèse 2011). La principale menace est certainement l'hybridation avec d'autres espèces ou populations. Cette situation devient de plus en plus critique, surtout après la récente introduction de souches synthétiques comme celle du tilapia GIFT en Afrique (Ansah *et al.*, 2014).

Trewavas (1983) fut la première à étudier les populations naturelles du tilapia du Nil. A partir de l'étude de leurs caractéristiques morphologiques, elle a décrit sept sous-espèces: *O. n. niloticus* d'Afrique de l'Ouest et du Nil, *O. n. baringoensis* du lac Baringo, *O. n. sugutae* de la rivière Suguta (Kenya), *O. n. eduardianus* des lacs Edouard, Albert, George et Tanganyika,

O. n. vulcani du lac Turkana, O. n. cancellatus de la rivière Awash et du lac Tana, et O. n. filoa de sources d'eau chaude dans le système de la rivière Awash.

Ce travail a servi et sert encore de nos jours de référence sur *O. niloticus* et les autres espèces de tilapia. Cependant, une analyse minutieuse des données fournies sur la différenciation des sous-espèces du tilapia du Nil révèle que Trewavas (1983) a utilisé a plusieurs reprises des arguments bien faibles et très subjectifs. Parfois elle a utilisé des caractères comme le nombre de rayons des nageoires comme caractère de différenciation alors que l'éventail des valeurs observées pour ce caractère entraine des chevauchements entre les sous-espèces (voir par exemple le tableau 35 pages 144-145). Ceci explique sans doute pourquoi l'auteur n'a pas fourni une clé d'identification des sous-espèces.

Plus problématique est l'absence de toute considération ou de définition de ce qui est ou ce qui devrait être une sous-espèce. Sont-elles équivalentes à des unités évolutives (Ryder, 1986; Waples, 1991) ou représentent-elles simplement des populations morphologiquement différenciées sans signification évolutive? Il est difficile de comprendre quel était le concept de "sous-espèce" adopté par cet auteur. Par exemple, *O. n. cancellatus* et *O. n. filoa* sont présents (paraâtrique) dans le même bassin, celui de la rivière Awash. Cette situation laisse plutôt penser que l'on a affaire soit à deux espèces différentes soit à deux éco-phénotypes différents de la même espèce. La même situation se retrouve avec *O. n. eduardianus* dans le lac Edouard, qui est en contact avec *O. n. niloticus* dans le Nil. A la lecture de son ouvrage, il apparait que son auteur a observé une certaine quantité de variabilité entre les populations et a trouvé "pratique de leur fournir des noms, pour préserver leur identité pour sévir aux futurs expérimentateurs ou gestionnaires des pêches" (citation de la page 141, dernière phrase).

Depuis Trewavas (1983) peut d'avancées on été faites sur la différentiation phénotypiques des populations sauvages du tilapia du Nil, ce qui nous a amené à réaliser des études sur la différenciation morphologique des populations à l'aide de techniques à la fois nouvelles et plus puissantes comme les analyses géomorphométriques (Bookstein, 1991). Avec ces analyses les variations de formes entre les différents taxons ou même les différentes populations peuvent efficacement être appréhendées.

La technique a été utilisée avec succès par exemple par Firmat *et al.* (2011, 2012) pour différencier 15 populations de tilapia du Mozambique (*Oreochromis mossambicus*) de son aire de répartition naturelle au Mozambique, des populations sauvages de Nouvelle-Calédonie et de la Guadeloupe après leur acclimatation dans ces nouveaux environnements. L'analyse

géomorphométrique est également capable de différencier les populations même étroitement liés comme (Kerschbaumer et Sturmbauer, 2011) l'ont montré en étudiant des populations sauvages de *Tropheus moorii*.

Bien après Trewavas (1983), l'utilisation de techniques génétiques (étude des allozymes, des séquences d'ADN mitochondrial, des microsatellites) a permis une description plus détaillée des différentes populations de tilapia du Nil. Par exemple, Agnèse *et al.* (1997) ont étudié 17 populations naturelles représentant les sept sous-espèces décrites par Trewavas (1983), et les ont regroupées en trois grands groupes: 1) populations d'Afrique occidentale, 2) les populations éthiopiennes de la vallée du Rift, et 3) les populations du Nil et de la vallée du Rift du Kenya.

D'autres études génétiques ont été menées comme celles de Rognon *et al.* (1996, 2003) Hassanien et Gilbey (2005), Nyingi et Agnèse (2007), Nyingi *et al.* (2009), Angienda *et al.* (2011) et Bezault *et al.* (2011). Toutes ces études constituent une précieuse documentation des ressources génétiques du tilapia du Nil mais restent malgré tout encore incomplètes.

Récemment par exemple, une nouvelle population naturelle d'*O. niloticus* a été découverte dans une source chaude du marais de Loboi (Nyingi *et al.*, 2009).

Cette population méritait amplement qu'on s'y intéresse par le double fait qu'elle représente une ressource génétique originale et hautement intéressante pour l'élevage d'*O. niloticus* et d'autre part parce qu'elle est en danger.

La productivité des élevages d'*O. niloticus* repose en grande partie sur la possibilité de pouvoir réaliser des cultures mono-sexe mâles. Plusieurs méthodes existent pour y parvenir : sexage manuel, hybridation, traitement hormonal, manipulations génétique. Aucune ne donne pleinement satisfaction. Par ailleurs On connaît les effets masculinisants des températures élevées (Baroiller *et al.*, 2009a) et le fait que les populations varient de ce point de vue, par des thermosensibilité différentes et donc génétiquement déterminées (Bezault *et al.*, 2007). La population des sources chaudes du marais de Loboi est très vraisemblablement adaptée aux hautes températures et par conséquent offre l'opportunité d'étudier ce phénomène de thermosensibilisation sur une population naturelle.

Par ailleurs, cette population est en danger. Comme la population du lac Baringo (toute proche), elle peut craindre l'introduction d'espèces étrangères au sein de son bassin hydrographique en raison des activités aquacoles dans la région. En outre, la taille du marais

s'est considérablement réduite ces dernières années (Fuch, 19950; Nyingi *et al.*, 2009) mettant en danger l'existence même de la rivière.

Pour ces raisons, nous avons mis en place deux types d'études, d'une part l'étude de la caractérisation génétique de cette population du marais Loboi, et d'autre part l'étude de la variabilité génétique au niveau des SNP situés dans des régions génomiques connues pour avoir des liens avec la différenciation du sexe chez *O. niloticus* (Baroiller *et al.*, 2009b).

Notre travail se compose donc de trois parties, d'une part l'analyse géomorphologique de certaines populations naturelles de *O. niloticus* afin de mettre en évidence leur diversité morphologique, leur plasticité phénotypique et l'effet environnemental sur les phénotypes, d'autre part, nous avons caractérisé génétiquement ces populations afin d'évaluer leur originalité et leur intégrité génétique. Enfin nous avons cherché à mettre en évidence des phénomènes adaptatifs qui concerne le rôle de la température dans la détermination du sexe.

# Variations morphologiques au sein des populations naturelles de tilapia du Nil vivants dans des conditions environnementales extrêmes dans la vallée du Rift du Kenya.

Les échantillons provenant de trois populations de sources chaudes du marais de Loboi, Chelaba, Lake Bogoria et Turtle Springs, de trois autres localités, les lacs Baringo, Turkana et Crocodile, et du lac Victoria, ont été étudiés.

Chaque spécimen a été scanné à l'aide d'un scanner à plat (Herler *et al.*, 2007) les images ont été ensuite importées dans le programme tpsUtil la version 1.53 (Rohlf, 2012). La forme du corps des poisson a été appréhendée à l'aide de la méthode des repères morpho-géométrique (Rohlf et Marcus, 1993). Un total de 14 points (repères) ont été choisis en fonction de leur capacité à capter forme générale du corps, et leurs coordonnées (x, y) numérisées sur le côté gauche de chaque poisson en utilisant le programme tpsDig la version 2.16 (Rohlf, 2010).

Un total de 237 spécimens provenant de sept populations naturelles du tilapia du Nil (Bogoria hôtel spring, 41 individus; Chelaba spring, 30; Turtle spring, 24; lac Baringo, 43; Lac Victoria, 33; Lac Crocodile, 28 et lac Turkana, 38) ont été analysés. Leurs dimensions standard ont varié de 40 mm à 207 mm.

L'analyse des données a été réalisée à l'aide de progiciels de logiciels R (Claude, 2008; 2013). Afin d'établir les variations morphologiques entre les différentes populations de poissons, nous avons utilisé l'analyse en composantes principales (ACP) des coordonnées superposées des points de repère. Les variations ont été visualisées en traçant les représentation des coordonnées multivariées des échantillons sur les deux premières composantes principales (PC) axes.

Sans surprise, l'analyse morphologique a révélé que les échantillons étudiés ont été tout d'abord différenciés par leurs tailles. Les poissons des lacs Turkana et Victoria ont les tailles moyennes les plus importantes 122,8 ± 4,38 mm (moyenne ± écart-type) et 163,3 ± 4,40 mm, respectivement. Les plus petits spécimens provenaient de Turtle Spring et du lac Crocodile (76,6 ± 6,11 mm et 70,1 ± 1,72 mm, respectivement). Les différences ont également été observées en termes de variabilité des tailles. Certains échantillons avaient une plus grande gamme de taille (lac Victoria) que d'autres (lac Crocodile). Ces différences observées peuvent représenter des artefacts en partie dus à l'échantillonnage et peuvent ne pas refléter complètement les différences réelles de la taille des poissons dans les différentes localités en dépit du fait que l'on sait que les lacs Turkana et Victoria accueillent de grands spécimens de *O. niloticus* (Trewavas, 1983) en raison de leurs grandes tailles et de leurs plus grandes profondeurs, par rapport aux autres biotopes étudiés au cours de ce travail.

Dans notre étude, nous avons observé différents modèles allométriques de croissance dans chacune des sept populations étudiées. Compte tenu du fait que la plupart des localités diffèrent grandement de par leurs conditions environnementales, les allométries observées peuvent être attribuées en partie aux différences environnementales (température et salinité), qui auraient agi sur certains stades de développement. Il est encore trop tôt à ce stade pour dire si les différences observées sont d'ordre adaptatives ou simplement dues à la plasticité, mais ces deux hypothèses pourraient être testées en faisant par exemple des transplantations réciproques expérimentales de poissons.

Les analyses ont montré un grand nombre de différences de forme parmi lesquelles les variations de la tête, du pédoncule caudal et de la nageoire anale représentaient 23%. Ces variations ont permis de discriminer les spécimens du lac Victoria de ceux des autres populations (lacs Baringo, Turkana et les sources d'eau chaude). Au sein de ces autres populations, les poissons du lac Turkana ont été clairement différenciés et occupent une place intermédiaire entre la population du lac Victoria et les autres. Ces résultats sont en accord

avec les relations génétiques observées par Agnèse *et al.* (1997). En effet, ces auteurs ont montrés que les poissons du lac lac Baringo et ceux du lac Turkana sont génétiquement proches. Par la suite, Nyingi *et al.* (2009) et Ndiwa *et al.* (2014) ont observé que les poissons des sources chaudes sont encore plus étroitement liés aux poissons du lac Baringo. Si l'on suppose que les poissons du lac Crocodile doivent avoir une base génétique identique aux poissons du lac Turkana, et que les poissons du lac Victoria qui ont été introduites à partir de poissons originaires du lac Albert (Fryer et Iles, 1972, Trewavas, 1983) devraient être moins liés génétiquement à tous les autres poissons étudiés, la différenciation morphologique des populations est congruente avec leur différenciation génétique

Lorsque l'on regarde de plus près les populations génétiquement liées, on peut tout de même observer une certaine quantité de différenciation morphologique. Le premier cas concerne des spécimens des trois sources d'eau chaude. Les échantillons de Bogoria et Chelaba ou Bogoria et Turtle spring sont morphologiquement différenciées. Par exemple, les individus de Chelaba et Bogoria Springs varient en ce qui concerne les proportions longueur du corps et profondeur du corps. Les individus des populations Bogoria / Chelaba et Turtle spring se différencie au niveau de la longueur de la tête et la hauteur du corps.

Si l'on considère que la base génétique de ces trois populations est la même (Ndiwa *et al*, 2014), ces différenciations morphologiques observées pourraient être attribuées à la plasticité phénotypique de l'espèce. Les caractéristiques environnementales très probables de ces sources chaudes sont légèrement différentes. Bogoria spring est la plus grande des trois sources d'eau chaude et coule pendant quelques centaines de mètres avant d'entrer dans le marais. Les deux autres ont un débit plus faible et entrent dans le marais après seulement quelques mètres. Néanmoins, seuls quelques gènes peuvent agir fortement sur la différenciation morphologique, on ne peut exclure que les différences morphologiques observées entre les trois populations thermales soient tout de même dues à des différences génétiques.

Ndiwa *et al.* (2014) ont observé que les flux de gènes entre ces populations est limité par le marais, qui est couverte d'une végétation dense de *Typha domingen*sis et *Cyperus papyrus*. De plus, Ndiwa *et al.* (2014) ont également observé que ces poissons sont légèrement introgressés par des gènes de *O. leucostictus* échappés de fermes aquacoles toutes proches. L'action de gènes étrangers issus de ces introgressions agissant sur la différenciation morphologique ne peut être exclue.

Le deuxième cas de populations génétiquement liés dans notre étude porte sur les poissons des lacs Turkana et Crocodile. Il y avait aussi une différenciation morphologique claire entre ces deux groupes de poissons qui diffèrent par la hauteur du corps, la proportion de la tête et la longueur de la caudale.

Ces deux populations sont génétiquement très proches (résultats non publiés) puisque la population du lac Crocodile tire son origine, il ya environ un siècle, de celle du lac Turkana. Très probablement, les différences observées peuvent être attribuées à de la plasticité phénotypique. Ces lacs offrent deux environnements très différents pour les poissons. Le lac Turkana est un grand lac alcalin (pH 9,3) et légèrement salé (conductivité 3420 µS / cm) qui hébergement de nombreuses espèces de poissons (48 d'après Hopson *et al.*, 1982). En comparaison, le lac Crocodile est un petit lac (environ 0,32 km2), avec une alcalinité (pH 10) et une salinité (conductivité 10 590 uS / cm) plus élevées. Seules trois espèces de poissons sont présents, deux cichlidés (*Aplochromis sp* et *O. niloticus*) et un Clariidae (*Clarias gariepinus*). La réduction observée de la forme du corps peut être une réponse adaptative aux niveaux élevés de salinité dans l'habitat. Cette hypothèse soutient les conclusions de Collyer *et al.* (2005; 2007) qui ont noté une réduction de taille chez les « pupfish » (*Cyprinodon tularosa*) en fonction de l'augmentation du niveau de salinité.

En conclusion, notre étude tend à montrer qu'à la fois des facteurs génétiques et environnementaux jouent un rôle important en influençant le développement morphologique de *O. niloticus*. D'autres études, en laboratoire notamment, seront nécessaires pour confirmer l'importance de ces facteurs environnementaux. Ceci pourra être obtenu par reproduction de fratries génétiquement identiques dans des conditions environnementales différentes, d'abord dans des conditions de salinités différentes, puis dans des conditions de températures différentes.

## Des populations naturelles, ressources génétiques importantes d'*Oreochromis niloticus* (Linnaeus, 1758), mises en danger par des activités aquacoles dans le basin de la Loboi au Kenya

Sept populations ont été étudiées et comparées : trois populations des sources d'eau chaude du bassin de la rivière Loboi (Turtle, Chelaba et lac Bogoria Hôtel springs), et celles des lacs Baringo, Turkana et de la rivière Suguta auxquelles nous avons ajouté une population de *O. leucostictus* du lac Naivasha.

Les travaux ont portés sur les séquences d'une portion de l'ADN mitochondrial (Dloop) et l'analyse du polymorphisme à 16 microsatellites.

En premier lieu, l'analyse de l'ADN mitochondrial a confirmé ce que Nyingi *et al.* (2007) avaient montré, la population d'*O. niloticus* du marais de Loboi est bien une population naturelle de Tilapia du Nil, génétiquement proche de celle du lac Baringo. L'étude des deux nouvelles populations des sources chaudes de Turtle et Chelaba spring, confirme donc ces résultats.

En revanche, il apparaît, contrairement aux résultats obtenus en 2007 et 2009 (Nyingi *et al.*, 2009) que les populations du marais de Loboi sont, comme l'était déjà la population du lac Baringo, introgressées par de l'ADN mitochondrial de *O. leucostictus*.

Il est probable que cette introgression soit très récente et date de l'entrée en vigueur d'un plan de développement de l'aquaculture dans le bassin de la Loboi en 2009.

L'analyse des 16 locus microsatellites a elle aussi dans un premier temps confirmé les résultats de Nyingi *et al.* 2007. Les populations du marais de la Loboi sont bien génétiquement originales et proches de celle du lac Baringo. Une analyse sommaire par Analyse Factorielle des Correspondance sur la base des génotypes observés, comme celle qui avait été faite par Nyingi *et al.* en 2007, pourrait laisser penser que l'introgression mitochondriale ne s'est pas accompagnée d'une introgression de gènes nucléaires. Une analyse plus attentive, utilisant le logiciel Structure, révèle sans ambigüité la présence d'allèles provenant d'*O. leucosticus* dans la population du lac Baringo et dans les trois sources chaudes du marais de Loboi.

Par contraste, et comme indice supplémentaire de la réalité de cette introgression, aucun échange de gène n'est détecté avec les populations de la rivière Suguta et du lac Turkana. Une analyse avec le programme NEWHYBRIDS suggère que les 7 individus introgressés sont des F2 issus de backcross avec *O. niloticus*.

Même si l'étendue des biotopes de sources chaudes sont de petites tailles, et par conséquent aussi la taille de leurs populations efficaces, la diversité de l'ADNmt est élevée dans les sources chaudes avec par exemple 9 haplotypes différents chez 36 individus (en dehors des individus introgressés).

Cette observation semble paradoxale si l'on considère que les sources chaudes se jettent dans un petit marais d'environ 1,5 km2. Le marais lui-même ne constitue pas un biotope favorable à la survie des poissons car il est entièrement couvert de macrophytes dont les plus dominantes sont Typha domingensis et Cyperus papyrus. Pour expliquer cette diversité mitochondriale, il faut considérer que ces sources chaudes sont approvisionnées par des failles et fractures qui permettent à l'eau des aquifères profonds de remonter à la surface. Ces sources sont donc insensibles aux changements climatiques et sans doute stables sur de très longues périodes. Par ailleurs, il est remarquable d'observer que, même si ces populations se trouvent proches les unes des autres de quelques dizaines à quelques centaines de mètres, il existe un certain degré de différentiation génétique qui est proportionnel à la distance géographique. Pour expliquer cette structuration génétique, il faut admettre que le marais crée un obstacle à la libre circulation des poissons d'une source à l'autre. En effet, la concentration en oxygène dissous au niveau du marais est plus faible que dans les sources, principalement en raison de la décomposition de la matière organique. Cette situation a été déjà décrite au niveau du lac Victoria (Deocampo, 2002; Ashley et al. 2002). Nos propres observations sont congruentes avec l'isolement observé entre d'une part des populations lacustres de O. esculentus vivant dans les lacs satellites du lac Victoria, et d'autres part des population d'O. niloticus séparés par des zones humides constituées par de marais à papyrus (Nyingi et al. 2011. Toutefois, si le marais représente une barrière infranchissable pour les poissons il devient alors difficile d'expliquer comment O. leucostictus a pu introgresser O. niloticus en traversant le marais à partir des étangs d'élevage en connexion avec la rivière Loboi. Il est possible, bien que peu probable, que quelqu'un ait directement introduit des poissons dans chaque source chaude. Même si cette hypothèse ne peut être rejetée simplement, il faut noter qu'il n'y a tout simplement aucune raison objective pour réaliser de telles translocations de poisson. Même si les modalités précises par lesquelles les poissons ont été introgressés ne sont pas encore connues, il n'en reste pas moins que la réalité de l'introgression a clairement été démontrée et que les activités aquacoles jouent très certainement un rôle dans ce processus.

Ces populations et les ressources génétiques qu'elles représentent doivent être préservées. La conservation et la gestion des Marais de la Loboi devraient être prioritaires dans un programme de gestion des ressources génétiques de *O. niloticus*.

### Les SNP du gene amh lies aux sexes sont différents suivant les populations de Tilpia du Nil.

La détermination du sexe est la prédisposition initiale de son développement tandis que la différenciation sexuelle est le processus en aval qui va générer les testicules ou les ovaires. La détermination Génétique du sexe (DGS) qui est induite par un ou des gènes sur les chromosomes sexuels et la détermination environnementale du sexe (DES) impliquant une série de signaux environnementaux comme la température, ont évolué de nombreuses fois entre lignées de téléostéens (Baroiller *et al*, 2009a; Heule *et al*, 2014).

Chez le tilapia du Nil, la détermination du sexe et la différenciation ont fait l'objet de longues recherches en raison de dimorphisme de croissance et la nécessité de contrôler le sexe dans ce principales espèces aquacoles. La détermination du sexe chez cette espèce est un mécanisme complexe sous le contrôle de divers facteurs, qui peuvent être divisés en trois groupes: Les facteurs génétiques majeurs portés par des chromosomes sexuels, les facteurs génétiques mineurs et les facteurs environnementaux (Baroiller *et al.*, 2009b ). Bien qu'il n'existe pas de chromosomes sexuels différenciés, les approches indirectes, telles que les tests de descendance ont démontré que *O. niloticus* dispose d'un système prédominant de détermination du sexe XX / XY alors que par exemple, son espèce sœur *O. aureus* a un système ZZ / ZW (Baroiller et Jalabert, 1989).

En utilisant la technique de RAD sequencing dans deux familles de la souche Manzalla, Palaiokostas *et al.* (2013) ont trouvé deux SNP qui expliquent 96% des phénotypes dans le groupe de liaison LG1. Cependant il a été montré dans d'autres souches des influences du groupe de liaison LG3 et des analyses QTL ont également indiquées des liaisons avec le sexe dans le groupe LG 23.

Plusieurs études ont montré que la température peut être un facteur dominant par rapport à la détermination génétique du sexe (Baroiller *et al.*, 1995, 2009a ; Bezault *et al.*, 2007). Dans la souche domestique Bouaké, une température > 32 °C provoque la masculinisation complète des femelles génétiques en mâles. La répartition naturelle du tilapia du Nil amène cette espèce à se trouver dans des eaux dont la température peut largement dépasser les 35°C

Au cours de notre étude, nous avons cherché à savoir dans quelle mesure, des populations sauvages de tilapia du Nil vivant dans différents régimes thermiques, y compris certaines sources chaudes, présentent des différences significatives au niveau des SNP situés dans des zones connues pour être liées à la différentiation sexuelle.

Pour cela, nous avons étudié des SNP qui se trouvent au niveau des gènes wt1b et cyp19a1a qui sont situés sur LG1 et au niveau du gène de l'AMH situé sur LG23.

Onze populations d'*O. niloticus* ont été étudiés, neuf sont des populations naturelles, tandis que deux, Bouaké (Côte-d'Ivoire) et Manzala (Egypte) sont des souches domestiques. Les populations naturelles du Kenya étaient au nombre de cinq, trois des sources chaudes (Lake Bogoria Hôtel, Chelaba et Turtle spring) et deux de milieu / habitats de température standard (lacs Baringo et Turkana). Nous avons également étudié trois populations de la Vallée du Rift éthiopien, un d'une source d'eau chaude (lac Metahara) et deux de lacs d'altitude froids (Hora et Koka).

Parallèlement aux SNP, nous avons amplifiés par PCR une portion du génome qui permet de discriminer les individus XX, XY et individus / YY.

Le résultat le plus intéressant est que, en plus de présenter le plus grand nombre de SNP, le gène amh présente également SNP avec une forte relation avec le sexe phénotypique. Même si ces associations ont été observées dans la plupart des populations étudiées, des associations plus fortes ont été observées sur les populations kenyanes. Au sein de ces populations (Bogoria, Chelaba, Turtle, Baringo et Turkana), 11 SNP ont été observés sur le gène de l'amh qui avaient une forte association au sexe phénotypique. L'analyse de ces SNP indique des écarts importants aux fréquences attendues sous l'hypothèse de Hardy-Weinberg dans certaines populations. Par exemple, trois populations (Bogoria, Chelaba et Turtle) ont montré des écarts importants sur amh_2509, tandis que quatre SNP (amh 597, amh 611, amh 2586, amh 2807) ont dévié de manière significative dans deux populations chacun. Fait intéressant, le SNP amh 597 G> T provoqué un changement de l'acide aminé avec des femelles ayant la variante T tandis que les mâles ont la variante G de ce fait, entrainant le changement de l'acide glutamique par l'acide aspartique. Parmi les 11 SNP liés au sexe, deux impliquent des changements nucléotidiques entraînant des changements d'acides aminés qui pourraient modifier de manière significative la fonction ou l'activité de l'hormone amh. Les 9 autres SNP sont tous situés dans l'intron 6 leurs rôles et leurs importances restent largement à déterminer.

Nos résultats montrent que les SNP liés au sexe sont spécifiques à certaines populations et cette observation vient confirmer les précédents résultats (Baroiller *et al.*, 2009a; 2009b). Il en résulte que la détermination du sexe chez *O. niloticus* devrait être analysée en priorité au niveau populationnel.
