## 1 Introduction

The principal objective of this thesis is to generalize multiple Zeta values to the case when the ground field $\mathbb{Q}$ is replaced by an arbitrary number field. The motivation behind the construction comes from the work of A. Goncharov on Hodge correlators and the plectic philosophy of J. Nekovář and A. Scholl.

We start by constructing the higher plectic Green functions. Hecke once proved that the integral of the restriction of a suitable Eisenstein series over $\mathbb{Q}$ to the idele class group of a given number field multipled an idele class character of finite order is equal to the L-functions of this charator. By replacing Eisenstein seris with our higher plectic Green functions, a similar integration gives new results, which give the generalization of classical multiple zeta values and multiple polyloarithms.

According to the plectic principle, a non-trivial subgroup of the ring of integers of a given number field plays an essential role in this work.

### 1.1 Generalizations of classical Zeta Values

Classically, multiple Zeta values(MZVs) are the periods of mixed Tate motives, namely the MZVs are iterated integrals on $\mathbb{P}^{1} \backslash\{0,1, \infty\}$. Mixed motives and their realizations related to classical modular forms were studied by various mathematicians (Beilinson, Beilinson-Levin, Manin, Goncharov, F. Brown, ...) Moreover, there exist mysterious modular phenomena in the ring of MZVs related to the depth filtration. A good geometric understanding of these phenomena seems that we should put MZVs and modular forms for $S L_{2}(\mathbb{Z})$ in a common framework. Recently, F. Brown proposed so-called multiple modular values and mixed modular motives.

On the other hand, A. Goncharov used ideas from quantum physics on Hodge theoretical setting to construct so-called Hodge correlators, which provide a new method to describe the corresponding variations of real mixed Hodge structures and a new way to understand periods of motives. He proved that classical polylogarithms, elliptic polylogarithms and their generalizations are all Hodge correlators.

However, all the work mentioned above is built up over the rational field $\mathbb{Q}$. What the situation will be if $\mathbb{Q}$ is replaced by an arbitary number field $K$ is still largely open. One natural but non-trivial question is

## Question 1.1 How should we define multiple Zeta values over arbitary number fields?

In this thesis, we propose a potential method to answer this question, inspired by A. Goncharov's theory on Hodge correlators [10] and by the plectic principle due to J. Nekovár and A. Scholl [13]. The starting point is to generalize the Hecke formula.

### 1.2 Hecke's Formula

Hecke [12] proved that the integral of the restriction of a suitable Eisenstein series over $\mathbb{Q}$ to the idele class group of a given number field multipled by an idele class character $\chi$ of finite order is
equal to the $L$-functions of $\chi$, up to some $\Gamma$ factors. In fact, Hecke's formula is one of the typical examples within the theory of automorphic periods.

More precisely, Let $K$ be a number field of degree $[K: \mathbb{Q}]=r_{1}+2 r_{2}$.

$$
K_{\mathbb{R}}=K \otimes \mathbb{R} \xrightarrow{\sim} \mathbb{R}^{r_{1}} \times \mathbb{C}^{r_{2}} .
$$

Define the norm map

$$
N=N_{K / \mathbb{Q}} \otimes i d: K_{\mathbb{R}}^{\times} \longrightarrow \mathbb{R}^{\times} .
$$

In order to state Hecke's formula, we will need the following data:
(1) Let $U \subset O_{K,+}^{\times}$be a subgroup of finite index, where

$$
O_{K,+}^{\times}=O_{K}^{\times} \cap\left(K_{\mathbb{R}}^{\times}\right)_{+}, \quad\left(K_{\mathbb{R}}^{\times}\right)_{+}=\left(\mathbb{R}_{+}^{\times}\right)^{r_{1}} \times\left(\mathbb{C}^{\times}\right)^{r_{2}} .
$$

(2) Let $I \subset K$ be a fractional $O_{K}$-ideal.
(3) $\exists m \in \mathbb{N} \backslash\{0\}, \quad \phi: I / m I \longrightarrow \mathbb{C}$ be a function such that

$$
\forall \varepsilon \in U, \quad \forall \alpha \in I \backslash\{0\}, \quad \phi(\varepsilon \alpha)=\phi(\alpha)
$$

We consider the following embedding (defined up to a conjugation)

$$
G L_{K}(1) \hookrightarrow G L_{\mathbb{Q}}([K: \mathbb{Q}]) .
$$

Let $E(g, s, \phi)$ be the Eisenstein series defined by

$$
E(g, s, \phi)=\sum_{x \in I \backslash\{0\}} \frac{\phi(x)}{\|g \cdot x\|^{s}},
$$

where $g \in G L_{\mathbb{Z}}(I)(\mathbb{R}) \cong G L_{[K: \mathbb{Q}]}(\mathbb{R})$ and $\|\cdot\|$ is a scalar product on $K_{\mathbb{R}}$.
Hecke proved the following formula. [12]

$$
\int_{U_{\mathbb{R}} / U} E(u, s, \phi) \mathrm{d}^{\times} \mu(u)=C\left(r_{1}, r_{2}, s, \mathrm{~d}^{\times} \mu(u)\right)\left(\sum_{x \in I \backslash\{0\}} \frac{\phi(x)}{\left|N_{K / \mathbb{Q}}(x)\right|^{s /[K: \mathbb{Q}]}}\right),
$$

where

$$
U_{\mathbb{R}}=\operatorname{Ker}\left(N_{K / \mathbb{Q}} \otimes 1:\left(K_{\mathbb{R}}^{\times}\right)_{+} \longrightarrow \mathbb{R}_{+}^{\times}\right),
$$

and $C\left(r_{1}, r_{2}, s, \mathrm{~d}^{\times} \mu(u)\right)$ is some $\Gamma$ factor and $\mathrm{d}^{\times} \mu(u)$ is a Haar measure. In fact we can also make the formulation in an adelic setting.

In a more concrete setting, we can rewrite Hecke's formula as follows.

## Theorem 1.2 (Hecke's Formula)

$$
\int_{U_{\mathbb{R}} / U}\left(\sum_{\alpha \in I \backslash\{0\}} \frac{\phi(\alpha)}{\|u \alpha\| \|^{[K: \mathbb{Q}] s}}\right) \mathrm{d}^{\times} \mu(u)=\frac{2 \pi^{r_{2}}}{[K: \mathbb{Q}] 2^{r_{1}}} \frac{\Gamma(s / 2)^{r_{1}} \Gamma(s)^{r_{2}}}{\Gamma([K: \mathbb{Q}] s / 2)} \sum_{\alpha \in(I \backslash\{0\}) / U} \frac{\phi(\alpha)}{\left|N_{K / \mathbb{Q}}(\alpha)\right|^{s}} .
$$

One of the objectives of this thesis is to try to generalize this formula in order to produce suitable "secondary"arithmetic objects. First of all we would like to precise the meaning of "secondary".

The generalization of Hecke's formula begins with replacing the Eisenstein series by some nontrivial objects, namely so-called higher plectic Green functions, which depend on one basic plectic Green function $g_{I}^{v}(x, u)$ (Definition 4.1) and on some combinatorial data. We will give the details about the construction of higher plectic Green functions in the fourth and fifth chapters.

Now it is natural to ask

Question 1.3 What are we going to obtain if we integrate these new objects over $U_{\mathbb{R}} / U$ ?

This thesis will answer this question. We would like to give the simplest example by integrating the basic plectic Green function.

Theorem 1.4 (Reinterpretation of Hecke's formula) Let $F$ be a totally real field of degree $r=[F$ : $\mathbb{Q}]$ and $\mathscr{D}$ the different ideal of $F$. If I is a fractional ideal of $F$, let

$$
I^{*}=\{x \in F \mid \operatorname{Tr}(x I) \subset \mathbb{Z}\}=\mathscr{D}^{-1} I^{-1}
$$

If $x \in F_{\mathbb{R}}=F \otimes \mathbb{R}$, if $U \subset O_{F,+}^{\times}$a subgroup of finite index and if $\forall \varepsilon \in U,(\varepsilon-1) \cdot x \in I$, which is equivalent to

$$
x I \in\left(F_{\mathbb{R}} / I\right)^{U}
$$

and if $v: \operatorname{Hom}(F, \mathbb{R}) \longrightarrow\{0,1\}$, consider

$$
g_{I}^{v}(x, u)=\lim _{\eta \rightarrow 0^{+}} \sum_{n \in\left(I^{*} \backslash\{0\}\right) / U} \operatorname{sgn}(n)^{v} \frac{e^{2 \pi i \operatorname{Tr}(n x)}}{\|u n\|^{r+\eta}}
$$

where $u \in U_{\mathbb{R}}=\operatorname{Ker}\left(N:\left(F_{\mathbb{R}}^{\times}\right)_{+} \longrightarrow \mathbb{R}_{+}^{\times}\right)$and $\|\cdot\|$ is the standard scalar product on $F_{\mathbb{R}} \cong \mathbb{R}^{r}$.

$$
\forall \varepsilon \in U, \quad g_{I}^{v}(x, \varepsilon u)=g_{I}^{v}(x, u)
$$

By integration in a similar way as Hecke did, we obtain

$$
\int_{U_{\mathbb{R}} / U} g_{I}^{v}(x, u) d u=\frac{2^{r-1} \Gamma(1 / 2)^{r}}{\Gamma(r / 2)} \lim _{\eta \rightarrow 0^{+}} \sum_{n \in\left(I^{*} \backslash\{0\} / U\right)} \operatorname{sgn}(n)^{v} \frac{e^{2 \pi i \operatorname{Tr}(n x)}}{\prod_{j=1}^{r}\left|n_{j}\right|^{(r+\eta) / r}} .
$$

Note that

$$
N(n)=N_{F / \mathbb{Q}}(n)=\prod_{j=1}^{r} n_{j},
$$

hence

$$
\int_{U_{\mathbb{R}} / U} g_{I}^{v}(x, u) d u=\frac{2^{1-r} \Gamma(1 / 2)^{r}}{r \Gamma(r / 2)} \lim _{\eta \rightarrow 0^{+}} \sum_{n \in\left(I^{*} \backslash\{0\}\right) / U} \operatorname{sgn}(n)^{v} \frac{e^{2 \pi i \operatorname{Tr}(n x)}}{|N(n)|^{(r+\eta) / r}}
$$

It is easy to see that we recover the Hecke formula, the righthand side is a linear combination of special values $L\left(1, \chi_{F}\right)$ for certain Dirichlet characters $\chi_{F}$ of $F$ of signature $v$.

For other more complicated higher plectic Green functions, the results are highly non-trivial, some non-trivial iterated integrals make their appeareance in a subtle way. However, if the number field $K$ is just the rational field $\mathbb{Q}$, the integration $\int_{U_{\mathbb{R}} / U}$ is trivial and we prove that the higher plectic Green functions deliver linear combinations of classical zeta values.

### 1.3 Inspiration

Before giving our main results, we will fist talk about two sources of inspiration of our construction in the next section and give some simple examples in order to illustrate our strategy.

### 1.3.1 Goncharov's Hodge correlators

In A. Goncharov's recent work [10], he constructed so-called Hodge correlators from just one fundamental object, namely the Green function, and certain Feynman diagrams, as in perturbative quantum field theory. In fact, the Green function contributes as the propagator which in Feynman diagrams serves to calculate the rate of collisions in quantum field theory.

Goncharov introduced such an idea to a Hodge-theoretic setting. He discovered that the socalled Hodge correlators are the coefficients of twistor connections, which describe the corresponding variations of real mixed Hodge structures. He proved that classical polylogarithms, elliptic polylogarithms and their generalizations are all Hodge correlators.

For example, over $\mathbb{C}^{\times}$, the Green function $G(x, y)$ is $\log |x-y|^{2}$. Applying a non-trivial integral formula of Levin, Goncharov proved that the usual polylog can be writen as a Hodge correlator. Based on such a construction, he obtained higher multipolylogarithms, more precisely, he proved that the generating series of cycle multiple polylogarithms is a Hodge correlator, with the generating series of classical polylogarithms serving as a Green function. His construction of Hodge correlators on $\mathbb{C}^{\times}$gives a variant of multiple polylogs, but a precise relation to the classical definition is not made explicit.

### 1.3.2 Plectic Philosophy

Over a totally real field $F$, J. Nekovár and A. Scholl [13] formulated what they call the plectic conjecture. The geometric objects in this conjecture are Shimura varities/stacks whose definition groups are restrictions of scalars from an algebraic group over $F$. More concretely, they work with abelian varieties with real multiplication by $O_{F}$, where $O_{F}$ is the ring of integers of $F$. We will try to explain the plectic principle in the following.

If $B$ is a connected complex manifold. Let $X / B$ be a family of abelian varities with real multiplication, and $s: B \longrightarrow X$ a nonzero torsion section fixed by a subgroup of finite index $U \subset O_{F,+}^{\times}$. This subgroup $U$ acts naturally on $X$ and acts trivally on $B$, then we should consider the following diagram

where $E U$ is the total space over the classifying space $B U$ of the group $U$ and $B \times_{U} E U=B \times E U / U$. When $B=\{p t\}$, then $X$ is a variety, we have the following situation


Nekovár and Scholl [13] constructed in their work a $U$-equivariant current $\tilde{\theta}$ on $\tilde{X}=X \times U_{\mathbb{R}}$, where $U_{\mathbb{R}}=E U$. In fact $\tilde{\theta}$ is a plectic generalisation of the (slightly modified) $\log |\theta(\tau, z)|$ of the absolute value of the standard Theta function on the elliptic curve $E=\mathbb{C} / \mathbb{Z} \tau+\mathbb{Z}$, which is the Green function on $E$.

So $s^{*}(\tilde{\theta})$ is $U$-equivariant on $\tilde{B}=B \times U_{\mathbb{R}}$. Then $s^{*}(\tilde{\theta})$ can descend to a current on $B \times U_{\mathbb{R}} / U$, and we can compute the trace

$$
\pi_{*}\left(s^{*}(\tilde{\theta})\right)=\int_{U_{\mathbb{R}} / U} s^{*}(\tilde{\theta})
$$

which gives very interesting functions, such as generalized Eisenstein-Kronecker-Lerch series.
The above integral, as well as its variants involving more complicated functions than $\tilde{\theta}$, can be computed by integrating suitable expressions depending on $\|u x\|$ over $U_{R}$. For this purpose, the Hecke transform is introduced and used in their work. Here is a typical example.

Proposition 1.5 (Hecke transform)[14]
Let $U_{\mathbb{R}} \subset\left(\mathbb{R}_{+}^{\times}\right)^{r}$ be the subgroup

$$
U_{\mathbb{R}}=\left\{\left(u_{j}\right) \mid \prod u_{j}=1\right\}
$$

with the measure $\mathrm{d}^{\times} u=\frac{d u_{1}}{u_{1}} \wedge \cdots \wedge \frac{d u_{r-1}}{u_{r-1}}$. Let $\|\cdot\|$ be the Euclidean norm on $\mathbb{C}^{r}$, on which $U$ acts by multiplication. Let $\left(p_{j}\right) \in \mathbb{Z}^{r}, p=\sum p_{j}$. Then for any $x \in\left(\mathbb{C}^{\times}\right)^{r}$ and $s \in \mathbb{C}$ with $\operatorname{Re}(s)>0$,

$$
\int_{U_{\mathbb{R}}}\|u x\|^{-2 s} \prod_{j} u_{j}^{-2 p_{j}} \mathrm{~d}^{\times} u=\frac{2^{r-1}}{\Gamma(s)} \prod_{j} \Gamma\left(\frac{p+s}{r}-p_{j}\right)\left|x_{j}\right|^{2\left(p_{j}-(p+s) / r\right)} .
$$

### 1.4 Main results

In our work, we consider a generalisation of $\log \left|1-e^{2 \pi i x}\right|^{2}$ on the compact real torus

$$
S^{1}=\left\{e^{2 \pi i x} \mid x \in \mathbb{R} / \mathbb{Z}\right\} \subset \mathbb{C}^{\times}
$$

This function is the restriction of the Green function $G(1, y)=\log |1-y|^{2}$ of the origin of $\mathbb{C}^{\times}$to $S^{1}$. We are going to consider corresponding objects on tori with real multiplication.

Let $F$ be a totally real field of degree $r=[F: \mathbb{Q}]$, we have the trace map $\operatorname{Tr}=\operatorname{Tr}_{F / \mathbb{Q}}$ and the norm map $N=N_{F / \mathbb{Q}}$. Let $\mathscr{D}$ be the different and let $I$ be a fractional ideal of $F$ and

$$
I^{*}=\{a \in F \mid \operatorname{Tr}(a I) \in \mathbb{Z}\}=\mathscr{D}^{-1} I^{-1} .
$$

Let $\|\cdot\|: F_{\mathbb{R}}=F \otimes \mathbb{R} \xrightarrow{\sim} \mathbb{R}^{\operatorname{Hom}(F, \mathbb{R})} \longrightarrow \mathbb{R}_{+} \cup\{0\}$ be the standard euclidean norm. As above, let

$$
U_{\mathbb{R}}=\operatorname{Ker}\left(N:\left(F_{\mathbb{R}}^{\times}\right)_{+} \longrightarrow \mathbb{R}_{+}^{\times}\right)=\left\{\left(u_{1}, \ldots, u_{r}\right) \in \mathbb{R}_{+}^{r} \mid u_{1} \cdots u_{r}=1\right\} .
$$

Then we can define the "plectic" Green function associated to the ideal $I$

## Definition 1.6 (Plectic Green function)

$$
g_{I}(x, u)=\lim _{\eta \rightarrow 0^{+}} \sum_{n \in I^{*} \backslash\{0\}} \frac{e^{2 \pi i \operatorname{Tr}(n x)}}{\|u n\|^{r+\eta}}, \quad x \in F_{\mathbb{R}} / I, u \in U_{\mathbb{R}}
$$

which can also be defined as $\sum_{n \in I^{*} \backslash\{0\}} \frac{e^{2 \pi \pi T r(n x)}}{\|u n\|^{r}}$, viewed as a distribution on $\left(F_{\mathbb{R}} / I\right) \times U_{\mathbb{R}}$.
We can also add an additional choice of multisigns $\boldsymbol{v} \in\{0,1\}^{\operatorname{Hom}(F, R)}$. Then the modified "plectic" Green function becomes

$$
g_{I}^{v}(x, u)=\lim _{\eta \rightarrow 0^{+}} \sum_{n \in I^{*} \backslash\{0\}} \operatorname{sgn}(n)^{v} \frac{e^{2 \pi i \operatorname{Tr}(n x)}}{\|u n\|^{r+\eta}}, \quad x \in F_{\mathbb{R}} / I, u \in U_{\mathbb{R}} .
$$

There is also a second method to add a multisign

$$
g_{I, v}(x, u)=\lim _{\eta \rightarrow 0^{+}} \sum_{\substack{n \in I^{*} \backslash\{0\} \\ \operatorname{sgn}(n)=(-1)^{v}}} \frac{e^{2 \pi i \operatorname{Tr}(n x)}}{\|u n\|^{r+\eta}}, \quad x \in F_{\mathbb{R}} / I, u \in U_{\mathbb{R}} .
$$

By using just this "plectic" Green function, we will construct a function (or a distribution) $\mathscr{G}_{I, \Gamma, S}(\cdot, \cdot)$ on

$$
O_{F,+}^{\times} \backslash\left(F_{\mathbb{R}} / I\right)^{S} \times U_{\mathbb{R}}=\left(F_{\mathbb{R}} / I\right)^{S} \times_{O_{F,+}^{\times}} E O_{F,+}^{\times},
$$

which depends on a given graph $\Gamma$ and a subset $S$ of the set of its vertices.
Definition 1.7 (Higher plectic Green function over a totally real field)
Let $\Gamma$ be a finite connected non-oriented graph, $V(\Gamma)$ the set of vertices and $E(\Gamma)$ the non-empty set of edges. Let $S \subset V(\Gamma)$ be a subset of the set of vertices. Loops are forbidden here (i.e. the endpoints of each edge are distinct), but multiple edges are allowed. For each vertex $v \in V(\Gamma)$, let $x_{v} \in F_{\mathbb{R}} / I$ be a variable which decorates the vertex $v$; for each edge $e \in E(\Gamma)$, we give an orientation $\vec{e}=\left(v_{0}(e) \longrightarrow v_{1}(e)\right)$ and we associate a variable $n_{e} \in I^{*} \backslash\{0\}$.

Then the higher plectic Green function attached to $(\Gamma, S)$ is defined as

$$
\mathscr{G}_{I, \Gamma, S}\left(\left\{x_{v}\right\}_{v \in S}, u\right)=\int_{\left(F_{\mathbb{R}} / I\right)^{V(\Gamma) \backslash S}} \prod_{e \in E(\Gamma)} g_{I}\left(x_{v_{1}(e)}-x_{v_{0}(e)}, u\right) \prod_{v \in V(\Gamma) \backslash S} d x_{v}
$$

where $x_{v} \in F_{\mathbb{R}} / I, u \in U_{\mathbb{R}}$ and dx is a fixed Haar measure en $F_{\mathbb{R}}$, and

There are variants of these functions (and numbers) depending on an additional choice of multisigns $v(e) \in\{0,1\}^{\operatorname{Hom}(F, \mathbb{R})}$ (and an orientation) for each edge $e$, which means that we can replace $g_{I}(\cdot, \cdot)$ by $g_{I, v}(\cdot, \cdot)$ (or $g_{I}^{v}(\cdot, \cdot)$ ).

Moreover, we can replace each $e \in E(\Gamma)$ by a chain of $k_{e} \geq 1$ edges (which is equivalent to that we add $k_{e}-1 \geq 0$ new vertices to each edge $e \in E(\Gamma)$ ) to get a new graph $\Gamma(k)$ with $|V(\Gamma(k))|=$ $|V(\Gamma)|+\sum_{e}\left(k_{e}-1\right)$ and the subset $S$ is unchanged.

For example, the case of $k_{e}=3$ is as follows.


Figure 1: The subdivision of the edge $e$.
Hence we have defined a subdivision map:

where $x \in F_{\mathbb{R}} / \mathbb{R}, u \in U_{\mathbb{R}},|k|=\sum_{e \in E(\Gamma)}\left|k_{e}\right|, n=\left(n_{e}\right)_{e \in E(\Gamma)}$,

and $\sum^{\prime}$ means that $\partial n$ is supported at $S$ and each $n_{e}$ is nonzero.

Remark 1.10 We can also add multisigns here, there are two methods. The first way is to associate each edge a multisign $v_{e}=\left(v_{e}^{1}, \ldots, v_{e}^{r}\right)$, then the formula in 4.9 will then contain terms $\operatorname{sgn}\left(n_{e}\right)^{v(e)}$ :

The second method to add mutisigns by taking into account the $n_{e} \in I^{*} \backslash\{0\}$, such that $\operatorname{sgn}\left(n_{e}\right)=$ $(-1)^{v_{e}}$ for a given multisign $v_{e}$ to each edge $e$. Then

In fact, we usually prefer the second definition $\mathscr{G}_{I, v, \Gamma(k), S}\left(\left\{x_{v}\right\}_{v \in S}, u\right)$.
Similarly, we can generalize the definition of plectic Green functions to any number field.
Definition 1.11 (Plectic Green functions for arbitary number fields)
Let $K$ be a number field with $r_{1}$ real places $\left(v_{i}\right)_{1 \leq i \leq r_{1}}$ and $r_{2}$ complex places $\left(w_{j}\right)_{1 \leq j \leq r_{2}}$ and of degree $[K: \mathbb{Q}]=r_{1}+2 r_{2}$. We have the trace map $\operatorname{Tr}=\operatorname{Tr}_{K / \mathbb{Q}}$

and we have a Hermitian product

which is a distribution on $\left(K_{\mathbb{R}} / I\right) \times U_{\mathbb{R}}$.

### 1.4.1 Generalized MZV for totally real fields

If we suppose that there exists a subgroup $U \subset O_{F,+}^{\times}$of finite index stabilising $\left\{x_{v}\right\}$ for each $v \in S$, we can apply the Hecke transform to define a new function as follows.

where $d^{\times} u=\frac{d u_{1} \cdots d u_{r-1}}{u_{1} \cdots u_{r-1}}, \prod_{j=1}^{r} u_{j}=1$ and $U_{\mathbb{R}} / U=B U \cong(\mathbb{S})^{r-1}$ is the classifying space of $U \cong \mathbb{Z}^{r-1}$.

Remark: In the same way, we can define $\mathscr{F}_{I, \Gamma, S}^{V}\left(\left\{x_{v}\right\}_{v \in S}\right)$ and $\mathscr{F}_{I, v, \Gamma, S}\left(\left\{x_{v}\right\}_{v \in S}\right)$.
Then the generalized multiple zeta value is defined as

## Definition 1.13 (Generalized multiple zeta values)

### 1.4.2 The case $F=\mathbb{Q}$.

In this case we can give an explicit relation to the classical definition.
Theorem 1.14 (Relation to multiple zeta values) (4.16)
Let $F$ be the rational field $\mathbb{Q}$ and $\Gamma$ any tree with rank $d=\operatorname{rank}\left(H_{1}(\Gamma, S)\right) \geq 2$, where $S=\partial \Gamma$. Assume that we are given a "sign" map $v: E(\Gamma) \longrightarrow\{0,1\}$ and a subdivision map $k: E(\Gamma) \longrightarrow \mathbb{N} \backslash\{0\}$ as in Remark 4.10 and in Definition 4.8, respectively. Then the generalized multiple zeta value $\mathscr{Z}_{I, v}(\Gamma(k), \partial \Gamma(k))(I=\mathbb{Z})$ can be expressed as a finite $\mathbb{Z}$-linear combination of classical multiple zeta values (MZVs) of depth $d$ and weight $|k|=\sum_{e} k_{e}$.

Moreover, we have an explicit relation to multiple polylogarithms.

## Theorem 1.15 (Relation to multiple polylogarithms)

If $F=\mathbb{Q}, I=\mathbb{Z}, x_{v} \in \frac{1}{N} \mathbb{Z} / \mathbb{Z}$, then $\mathscr{G}_{I, v, \Gamma, \partial \Gamma}\left(\left\{x_{v}\right\}_{v \in \partial \Gamma}, 1\right)$ is a finite $\mathbb{Z}$-linear combination of the values of multiple polylogarithms evaluated at some $N$-th roots of unity.

Let us see one simple example.
Example 1.16 Let $\Gamma_{1}$ be the graph in Figure 2.


Figure 2: A plane trivalent tree with one internal vertex
The rank of $\Gamma_{1}$ is $2=\operatorname{rank}\left(H_{1}\left(\Gamma_{1}, \partial \Gamma_{1}\right)\right)$. To each edge $e_{i}(i=1,2,3)$ we add $\sigma_{i}-1 \geq 0$ points. The only internal vertex is denoted by $y$, each external vertex $v_{i}$ is decorated by the variable $x_{v_{i}}$. For each $e_{i}(i=1,2)$, the given sign $v_{i}$ equals 0 . For the edge $e_{3}$, the sign $v_{3}=1$. In fact, the constraint $n_{1}+n_{2}+n_{3}=0$ and $v_{1}=v_{2}=0$ imply that $v_{3}=1$.

$$
\mathscr{G}_{I, v, \Gamma_{1}, \partial \Gamma_{1}}\left(\left\{x_{v}\right\}_{v \in \partial \Gamma_{1}}, 1\right)=\sum_{\substack{n_{1}+n_{2}+n_{3}=0, n_{i} \in \mathbb{Z} \backslash\{0\} \\ \operatorname{sgn}\left(n_{i}\right)=(-1)^{v_{i}}}} \frac{e^{2 \pi i\left(n_{1} x_{v_{1}}+n_{2} x_{v_{2}}+n_{3} x_{v_{3}}\right)}}{\left|n_{1}\right| \sigma_{1}\left|n_{2}\right| \sigma_{2}\left|n_{3}\right|^{\sigma_{3}}}
$$

where $v_{1}=v_{2}=0, v_{3}=1$. Then

\operatorname{sgn}\left(n_{i}\right)=(-1)^{v_{i}}}} \frac{1}{\left|n_{1}\right| \sigma^{\sigma_{1}}\left|n_{2}\right| \sigma_{2}\left|n_{3}\right|^{\sigma_{3}}}=\sum_{n_{1}, n_{2} \in \mathbb{N} \backslash\{0\}} \frac{1}{\left|n_{1}\right| \sigma^{\sigma_{1}}\left|n_{2}\right|^{\sigma_{2}}\left|n_{1}+n_{2}\right|^{\sigma_{3}}} \\
\mathscr{Z}_{I, v}\left(\Gamma_{1}, \partial \Gamma_{1}\right)=\sum_{n_{1}, n_{2} \in \mathbb{N} \backslash\{0\}} \frac{1}{n_{1}^{\sigma_{1}} n_{2}^{\sigma_{2}}\left(n_{1}+n_{2}\right)^{\sigma_{3}}} .
\end{gathered}
$$

We show in Example 4.22 that

Here $\zeta\left(s, r+\sigma_{3}\right)$ is a classical double zeta value of weight $r+s+\sigma_{3}=\sigma_{1}+\sigma_{2}+\sigma_{3}$, which means that $\mathscr{Z}_{I, v}\left(\Gamma_{1}, \partial \Gamma_{1}\right)$ can be expressed as a $\mathbb{Z}$-linear combination of double zeta values of this weight.

### 1.4.3 The case of a general totally real field

If $[F: \mathbb{Q}]=r>1$, then the generalized multiple zeta value $\mathscr{Z}_{I}(\Gamma, S)$ is highly non-trivial.
Let us see the case of $r=2$, we have the following theorem
Theorem 1.17 Given $\underline{k}=\left(k_{1}, \ldots, k_{d}\right)$ and $|\underline{k}|=k_{1}+\ldots+k_{d}$.
(1)If $2+|\underline{k}|$, then after several differentiation with respect to the coefficients $\alpha_{j}, \beta_{j}$, the essential part of the definition of higher plectic Green function

can be written as product of $\pi$ and an element of $\mathbb{Q}\left(\alpha_{1}, \ldots, \alpha_{d}, \beta_{1}, \ldots, \beta_{d}\right)$.
(2) If 2 divides $|\underline{k}|$, then $I_{2}(d, \underline{k})$ can be written as

Example 1.18 Consider the case $d=3, m=0$ and $n=1$. Then

=-\frac{\pi}{2} \sum_{j=1}^{3} \frac{\alpha_{j} \beta_{j}}{\prod_{k=1, k \neq j}^{3} \Delta_{k j}}=-\frac{\pi}{2}\left(\frac{\alpha_{1} \beta_{1}}{\Delta_{12} \Delta_{13}}-\frac{\alpha_{2} \beta_{2}}{\Delta_{21} \Delta_{23}}+\frac{\alpha_{3} \beta_{3}}{\Delta_{12} \Delta_{23}}\right) \\
=\frac{\pi}{2\left(\alpha_{1} \beta_{2}+\alpha_{2} \beta_{1}\right)\left(\alpha_{1} \beta_{3}+\alpha_{3} \beta_{1}\right)\left(\alpha_{2} \beta_{3}+\alpha_{3} \beta_{2}\right)} .
\end{gathered}
$$



Figure 3: The graph $\Gamma$.

If we are given the graph $\Gamma$ and $S=\left\{v_{1}, v_{2}, v_{3}\right\}$, there are $k_{j} \in \mathbb{N}_{+}$edges with given $\lambda_{j}=\left(\alpha_{j}, \beta_{j}\right) \in$ $I^{*}, 1 \leq j \leq 3$.

Then there exist differetials $D_{\alpha_{j}, \beta_{j} ; k_{j}}$ such that the corresponding higher plectic Green function can be written as

For general $r$, we have the following theorem.
Theorem 1.19 (Main result over general totally real field-vague version) Let $F$ be a totally real field of degree $[F: \mathbb{Q}]=r>1$. Given a graph and a subdivision map defined as before. By the reciprocity Proposition 5.8, we can assume the rank of the graph $d \geq r$. Moreover, we assume that if $2+r$, the subdivision map is given by $k_{e} \in 2 \mathbb{N}$ for each edge. According to the two reduction theorems Theorem 5.27, Theorem 5.33 and the theorem about the basic integral of the Hecke transform Theorem 5.61, we have the following expression of our generalized multiple zeta value

C(d, r)}} \sum_{1 \leq m \leq r-1} \sum_{j}\left(\alpha_{j}\left(n_{e}\right)\right) \mathscr{L}_{m}\left(\beta_{j}\left(n_{e}\right)\right),
$$

where $\mathscr{L}_{m}(\cdot)$ is an generalized m-logarithm which is a non-trivial iterated integral, and $\alpha_{j}\left(n_{e}\right)$ and $\beta_{j}\left(n_{e}\right)$ are rational functions of the conjugates of $n_{e}$ with coefficients in $\mathbb{Q}$ and the sum $\sum_{C(d, r)}$ comes from the reduction theorem. Every sum here is finite.

### 1.5 Final remarks

The classical polylogarithms have been interpretated by Deligne in the language of variations of Hodge structures. It is natural to ask what kind of geometric objects or motivic avatar should correspond to our generalized polylogarithms ? Moreover, Classical multiple zeta values are periods of $\pi_{1}\left(\mathbb{G}_{m} \backslash\{0,1, \infty\}\right)$, i.e. periods of mixed Tate motives. For generalized multiple zeta values there should be a relation to some plectic invariant of $\mathbb{G}_{m} \otimes I \backslash\{1\}$. More generally, the analogue of the values of multiple polylogarithms at roots of unity should be related to some plectic object attached to $\pi_{1, \cdots, 1}^{\text {plec }}\left(\mathbb{G}_{m} \otimes I \backslash(N\right.$-torsion $\left.)\right)$. We will continue to study these problems after this thesis.

## 2 Goncharov's Theory of Hodge correlators

In this section, we will explain the idea of A. Goncharov's theory of Hodge correlators, where we are inspirated for the construction. This theory provides a new point of view of periods. Our explanation is based on several simple examples.

### 2.1 Introduction

In Goncharov's recent work [10], he constructed so-called Hodge correlators from just one fundamental object, namely the Green function, and certain Feynman diagrams, as in perturbative quantum field theory. In fact, the Green function contributes as the propagator which in Feynman diagrams serves to calculate the rate of collisions in quantum field theory.

Goncharov introduced such an idea to a Hodge-theoretic setting. He discovered that the socalled Hodge correlators are the coefficients of twistor connections, which describe the corresponding variations of real mixed Hodge structures. He proved that classical polylogarithms, elliptic polylogarithms and their generalizations are all Hodge correlators.

For example, over $\mathbb{C}^{\times}$, the Green function $G(x, y)$ is $\log |x-y|^{2}$. Applying a non-trivial integral formula of Levin, Goncharov proved that the usual polylogarithm can be writen as a Hodge correlator. Based on such a construction, he obtained higher multipolylogarithms, more precisely, he proved that the generating series of cycle multiple polylogarithms is a Hodge correlator, with the generating series of classical polylogarithms serving as a Green function. His construction of Hodge correlators on $\mathbb{C}^{\times}$gives a variant of multiple polylogs, but a precise relation to the classical definition is not made explicit.

In addition, there are motivic correlators in the motivic Lie algebra, whose periods are given by the Hodge correlators. For a modular curve and its cusps, the Hodge correlators generalize the Rankin-Selberg intergrals. In fact, the simplest case of them is the Rankin-Selberg convolution of two cuspidal Hecke eigenforms. The motivic correlators on a modular curve give Beilinson's elements in motivic cohomology, hence the Beilinson-Kato Euler system. The motivic correlators on the limit of the tower of modular curves give an automorphic adelic description of the Hodge correlators on modular curves.

### 2.2 Definition of Hodge correlators after Goncharov

Let $X$ be a smooth compact complex curve and $S$ a subset of $X$. There is a Green function $G(x, y)$ associated on $X^{2}$ provided by a volume form. Given a tree $T$, each edge $e$ of $T$ contributes a Green function on $X^{\{\text {vertices of } e\}}$, which we lift to a function on $X^{\{\text {vertices of } T\}}$. Moreover, there is a canonical poly differential map

$$
\omega_{m}: \wedge^{m+1} \mathscr{A}_{X}^{0} \longrightarrow \mathscr{A}_{X}^{m},
$$

where $\mathscr{A}_{X}^{k}$ is the space of smooth $k$-forms on $X$. Then applying this poly differential map to the Green functions assigned to the edge of $T$, we get a differential form of the top degree on $X^{\{\text {internal vertices of } T\}}$. Integrating such differential form, we get the integral assigned to $T$. If we decorate the external vertices by elements $a_{0}, \ldots, a_{n}\left(a_{i} \in S\right)$, see Figure 4 . By taking the sum over all trees $T$, that is decorated by $a_{0}, \ldots, a_{n}$, we obtain the Hodge correlator associated to the cyclic word $W=\mathcal{C}\left(\left\{a_{0}\right\} \otimes \cdots \otimes\left\{a_{n}\right\}\right)$.

For the rigorous definition in details, one should refer to the work of Goncharov [10].


Figure 4: A plane trivalent tree decorated by $\mathcal{C}\left(\left\{a_{0}\right\} \otimes \cdots \otimes\left\{a_{5}\right\}\right)$.
Remark 2.1 Compared to Goncharov's setting, we will work on number field, therefore we should find an analogue of Green's function over number field, which is also the starting point of our construction.

### 2.3 Examples of Hodge correlators

Correlators on $\mathbb{P}_{\mathbb{C}}^{1} \backslash S$ and polylogarithms Let $X=\mathbb{P}^{1}, S=\{\infty\}$. Given the following cyclic word

the unique $W_{n}$-decorated Feynman diagram with no internal vertices incident to two $\{0\}$ 's, see Figure 5


Figure 5: The Feynman diagram for the classical $n$-logarithms.
We denote by $\mathbf{L}_{n}(z)$ the corresponding correlator [10]. Let $L i_{n}(z)$ be the classical $n$-polylogrithm on $\mathbb{C P}^{1} \backslash\{0,1, \infty\}$. Further there is a single-valued version

where $\beta_{k}=\frac{2^{k} B_{k}}{k!}, B_{k}$ is the Bernoulli number.
Then the Levin formula gives us

\mathbb{L}_{n}^{*}(z)=4^{-(n-1)} \sum_{\substack{n \in 2 \mathbb{Z} \\ 1 \leq k \leq n-2}}\binom{2 n-k-3}{n-1} \frac{2^{k+1}}{(k+1)!} \mathcal{L}_{n-k}(z) \log ^{k}|z|
$$

If we take

\mathbb{L}_{n}(z)=4^{n-1}\binom{2 n-2}{n-1}^{-1} \mathbb{L}_{n}^{*}(z)
$$

Then Goncharov showed that the Hodge correlator can be related to the classical polylogrithms as follows

## 3 Plectic Principle

### 3.1 Equivariant plectic Green Currents

As we have explained in the introduction, the plectic principle, we just repeat the main idea here.
Let $X / B$ be a family of abelian varities with real multiplication, and $s: B \longrightarrow X$ a nonzero torsion section fixed by a subgroup of finite index $U \subset O_{F,+}^{\times}$. This subgroup $U$ acts naturally on $X$ and acts trivally on $B$, then we should consider the following diagram

where $E U$ is the total space over the classifying space $B U$ of the group $U$ and $B \times_{U} E U=B \times E U / U$. When $B=\{p t\}$, then $X$ is a variety, we have the following situation


Nekovár and Scholl [13] constructed in their work a $U$-equivariant current $\tilde{\theta}$ on $\tilde{X}=X \times U_{\mathbb{R}}$, where $U_{\mathbb{R}}=E U . \tilde{\theta}$ is a plectic generalisation of the (slightly modified) $\log |\theta(\tau, z)|$ of the absolute value of the standard Theta function on the elliptic curve $E=\mathbb{C} / \mathbb{Z} \tau+\mathbb{Z}$, which is the Green function on $E$.

So $s^{*}(\tilde{\theta})$ is $U$-equivariant on $\tilde{B}=B \times U_{\mathbb{R}}$. Then $s^{*}(\tilde{\theta})$ can descend to a current on $B \times U_{\mathbb{R}} / U$, and we can compute the trace

$$
\pi_{*}\left(s^{*}(\tilde{\theta})\right)=\int_{U_{\mathbb{R}} / U} s^{*}(\tilde{\theta}),
$$

which gives very interesting functions, such as generalized Eisenstein-Kronecker-Lerch series.
The above integral, as well as its variants involving more complicated functions than $\tilde{\theta}$, can be computed by integrating suitable expressions depending on $\|u x\|$ over $U_{R}$. For this purpose, the Hecke transform is introduced and used in their work. Here is a typical example.

In the speculative plectic conjecture[13], they consider a framework :

where $L$ is a totally imgainary quadratic extension of $F$. The diagram above gives rise to a Shimura stacks:


As in the previous remarks, $Y$ is just an open Hilbert modular variety attached to $G L_{2, F}$, while $\mathscr{A}$ is the universal oject (in the sense of stacks) of Y. Morally $\mathscr{A}$ is the quotient [ $U \backslash A$ ], where $A$ is the non-exsitent universal Hilbert-Blumenthal abelian scheme over $Y$ (the reason is (2) of the
remarks), $U \subset O_{F,+}^{\times}$is a subgroup of finite index in the group of totally positive units of $F$. If we consider that the group $U$ acts trivially on $Y$, then we can get a stack $\mathscr{Y}=[U \backslash Y]$, which gives us a bigger diagram:


### 3.2 Some explanation of the philosophy

In this subsection, we would like to give some geometric explanations about the reason that the subgroup $U \subset O_{F,+}^{\times}$plays a non-trivial role in plectic principle.

In fact a universal Hilbert-Blumenthal abelian scheme over $Y$ doesn't exist. First of all, we will try to explain something about the difference between two moduli problems associated to two groups. The picture is as follows:


For an typical example, we take $G=\operatorname{Res}_{F / \mathbb{Q}} G L_{2, F}$, and $G^{*}$ is defined by Cartien product (fiber product).

$$
G^{*}=\left\{g \in G \mid \operatorname{det}(g) \in \mathbb{G}_{m}\right\}
$$

Usually, we have the moduli problem $\mathscr{M}_{G^{*}}\left(\right.$ resp. $\left.\mathscr{M}_{G}\right)$ associated to $G^{*}$ (resp. $G$ ). The fact is that the functor $\mathscr{M}_{G^{*}}$ is representable, which means that there is an universal abelian variety (scheme) $\mathscr{A}_{G^{*}}$ over $\mathscr{M}_{G^{*}}$. The group of integers of $O_{F,+}^{\times}$acts on $\mathscr{M}_{G^{*}}$,

$$
O_{F,+}^{\times} \subset \mathscr{M}_{G^{\star}}, \quad \mathbb{Z}^{[F: \mathbb{Q}]-1} \cong O_{F,+}^{\times} .
$$

The action of $O_{F,+}^{\times}$on the connected components is trivial. The reason is that:

$$
\mathcal{H}^{d}=G(\mathbb{R}) /\left(K_{\infty} \backslash Z(\mathbb{R})\right),
$$

where $d=[F: \mathbb{Q}]$ and

$$
Z_{G^{*}}(\mathbb{R}) \subset \mathcal{H}^{d} / G^{*}(\mathbb{Z})
$$

where $Z_{G^{*}}$ is the center of $G^{*}$. Therefore the center $Z_{G^{*}}$ acts trivially on $\mathcal{H}^{d} / G^{*}(\mathbb{Z})$.
But the functor $\mathscr{M}_{G}$ is just a coarse moduli space(un espace grossier in french). If we write,

$$
\mathscr{M}_{G}^{\text {gross }}=\mathscr{M}_{G^{*}} / O_{F,+}^{\times}
$$

(i) The neutrial component of $\mathscr{M}_{G}^{\text {gross }}=$ the neutrial component of $\mathscr{M}_{G^{*}}$.
(ii) But the set $\{$ the connected components $\}$ of $\mathscr{M}_{G}^{\text {gross }} \neq$ the set $\{$ the connected components $\}$ of $\mathscr{M}_{G}$.

Remark 3.1 We know that the action of $O_{F,+}^{\times}$permutates the connected components of $\mathscr{M}_{G}^{\text {gross }}$.

where $p$ is a covering map (revetement).
Now we consider the previous moduli problems in the setting of stacks.

$$
\mathscr{M}_{G}^{c h p}=\left[\mathscr{M}_{G^{*}} / O_{F,+}^{\times}\right]
$$

Remark 3.2 Attention: $\mathscr{M}_{G}^{c h p}$ is not an algebraic stack, because the group $O_{F,+}^{\times}$is not a finite group.

But over $\mathscr{M}_{G}^{c h p}$, we still have a stack :

$$
\begin{gathered}
{\left[\mathscr{A} / O_{F,+}^{\times}\right]} \\
f \downarrow \\
\left.\downarrow \mathscr{M}_{G}^{c h p}\right]
\end{gathered}
$$

where $f$ is a representable morphism, involving a tautological abelian variety.
Now we turn to toroial compactifications. We have a diagram of compactifications for $\mathscr{M}_{G^{*}}$.


Similarly, there is another diagram for $\mathscr{M}_{G}^{c h p}$


In conclusion :
$\mathscr{M}_{G^{*}}=G^{*}(\mathbb{Q}) \backslash G^{*}(\mathbb{A}) / Z_{G^{*}}(\mathbb{R}) K_{\infty}$ has a universal abelian variety.
$\mathscr{M}_{G}^{\text {gross }}=G(\mathbb{Q}) \backslash G(\mathbb{A}) / Z_{G}(\mathbb{R}) K_{\infty}$ does not have a universal abelian variety.

$$
\mathscr{M}_{G}^{c h p}=\left[G(\mathbb{Q}) \backslash G(\mathbb{A}) / Z_{G}(\mathbb{R}) K_{\infty}\right] .
$$

## 4 Generalization of Multiple Zeta Values (I): General construction and results over $\mathbb{Q}$

### 4.1 General construction

### 4.1.1 Plectic Green currents

In our work, we consider a generalisation of $\log \left|1-e^{2 \pi i x}\right|^{2}$ on the compact real torus

$$
S^{1}=\left\{e^{2 \pi i x} \mid x \in \mathbb{R} / \mathbb{Z}\right\} \subset \mathbb{C}^{\times}
$$

This function is the restriction of the Green function $G(1, y)=\log |1-y|^{2}$ of the origin of $\mathbb{C}^{\times}$to $S^{1}$. We are going to consider corresponding objects on tori with real multiplication.

Let $F$ be a totally real field of degree $r=[F: \mathbb{Q}]$, we have the trace map $\operatorname{Tr}=\operatorname{Tr}_{F / \mathbb{Q}}$ and the norm map $N=N_{F / \mathbb{Q}}$. Let $\mathscr{D}$ be the different and let $I$ be a fractional ideal of $F$ and

$$
I^{*}=\{a \in F \mid \operatorname{Tr}(a I) \in \mathbb{Z}\}=\mathscr{D}^{-1} I^{-1}
$$

Let $\|\cdot\|: F_{\mathbb{R}}=F \otimes \mathbb{R} \xrightarrow{\sim} \mathbb{R}^{\operatorname{Hom}(F, \mathbb{R})} \longrightarrow \mathbb{R}_{+} \cup\{0\}$ be the standard euclidean norm. As above, let

$$
U_{\mathbb{R}}=\operatorname{Ker}\left(N:\left(F_{\mathbb{R}}^{\times}\right)_{+} \longrightarrow \mathbb{R}_{+}^{\times}\right)=\left\{\left(u_{1}, \ldots, u_{r}\right) \in \mathbb{R}_{+}^{r} \mid u_{1} \cdots u_{r}=1\right\} .
$$

Then we can define the "plectic" Green function associated to the ideal $I$
Definition 4.1 (Plectic Green function)

$$
g_{I}(x, u)=\lim _{\eta \rightarrow 0^{+}} \sum_{n \in I^{*} \backslash\{0\}} \frac{e^{2 \pi i \operatorname{Tr}(n x)}}{\|u n\|^{r+\eta}}, \quad x \in F_{\mathbb{R}} / I, u \in U_{\mathbb{R}}
$$

which can also be defined as $\sum_{n \in I^{*} \backslash\{0\}} \frac{e^{2 \pi i T(n x)}}{\|u n\|^{r}}$, viewed as a distribution on $\left(F_{\mathbb{R}} / I\right) \times U_{\mathbb{R}}$.
We can also add an additional choice of multisigns $v \in\{0,1\}^{\operatorname{Hom}(F, R)}$. Then the modified "plectic" Green function becomes

$$
g_{I}^{v}(x, u)=\lim _{\eta \rightarrow 0^{+}} \sum_{n \in I^{*} \backslash\{0\}} \operatorname{sgn}(n)^{v} \frac{e^{2 \pi i \operatorname{Tr}(n x)}}{\|u n\|^{r+\eta}}, x \in F_{\mathbb{R}} / I, u \in U_{\mathbb{R}}
$$

There is also a second method to add a multisign

$$
g_{I, v}(x, u)=\lim _{\eta \rightarrow 0^{+}} \sum_{\substack{n \in I^{*} \backslash\{0\} \\ \operatorname{sgn}(n)=(-1)^{v}}} \frac{e^{2 \pi i \operatorname{Tr}(n x)}}{\|u n\|^{r+\eta}}, x \in F_{\mathbb{R}} / I, u \in U_{\mathbb{R}} .
$$

Remark 4.2 ( $O_{F,+}^{\times}$-equivariance)
$\forall \varepsilon \in O_{F,+}^{\times}$, we have

$$
g_{I}(\varepsilon x, \varepsilon u)=g_{I}(x, u)
$$

This is also true for $g_{I}^{V}(\cdot, \cdot)$ and $g_{I, v}(\cdot, \cdot)$.
Remark 4.3 (Dependence on I)

1. If $\alpha \in F_{+}^{\times}$and $N(\alpha)=1$, then $(\alpha I)^{*}=\alpha^{-1} I^{*}$. Hence

$$
g_{\alpha I}(\alpha x, \alpha u)=g_{I}(x, u) .
$$

2. $\forall \alpha \in F_{+}^{\times}, g_{\alpha I}(\alpha x, u)=N(\alpha) g_{I}(x, u)$. Therefore up to rescaling, $g_{I}(\cdot, \cdot)$ depends only on the class of $I$ in the class group $C l_{F}^{+}$. This is also true for $g_{I}^{v}(\cdot, \cdot)$ and $g_{I, v}(\cdot, \cdot)$.

### 4.1.2 Higher plectic Green currents

By using just this "plectic" Green function, we will construct a function (or a distribution) $\mathscr{G}_{I, \Gamma, S}(\cdot, \cdot)$ on

$$
O_{F,+}^{\times} \backslash\left(F_{\mathbb{R}} / I\right)^{S} \times U_{\mathbb{R}}=\left(F_{\mathbb{R}} / I\right)^{S} \times_{O_{F,+}} E O_{F,+}^{\times},
$$

which depends on a given graph $\Gamma$ and a subset $S$ of the set of its vertices.

## Definition 4.4 (Higher plectic Green function)

Let $\Gamma$ be a finite connected non-oriented graph, $V(\Gamma)$ the set of vertices and $E(\Gamma)$ the non-empty set of edges. Let $S \subset V(\Gamma)$ be a subset of the set of vertices. Loops are forbidden here (i.e. the endpoints of each edge are distinct), but multiple edges are allowed. For each vertex $v \in V(\Gamma)$, let $x_{v} \in F_{\mathbb{R}} / I$ be a variable which decorates the vertex $v$; for each edge $e \in E(\Gamma)$, we choose an orientation $\vec{e}=\left(v_{0}(e) \longrightarrow v_{1}(e)\right)$ and we associate an element $n_{e} \in I^{*} \backslash\{0\}$.

Then the higher plectic Green function attached to $(\Gamma, S)$ is

$$
\mathscr{G}_{I, \Gamma, S}\left(\left\{x_{v}\right\}_{v \in S}, u\right)=\int_{\left(F_{\mathbb{R}} / I\right)^{V(\Gamma) \backslash S}} \prod_{e \in E(\Gamma)} g_{I}\left(x_{v_{1}(e)}-x_{v_{0}(e)}, u\right) \prod_{v \in V(\Gamma) \backslash S} d x_{v},
$$

where $x_{v} \in F_{\mathbb{R}} / I, u \in U_{\mathbb{R}}$ and dx is a fixed Haar measure en $F_{\mathbb{R}}$, and

$$
g_{I}\left(x_{v_{1}(e)}-x_{v_{0}(e)}, u\right)=\lim _{\eta \rightarrow 0^{+}} \sum_{n_{e} \in I^{*} \backslash\{0\}} \frac{\left.\left.e^{2 \pi i \operatorname{Tr}\left(n _ { e } \left(x_{v_{1}}(e)\right.\right.}-x_{v_{0}(e)}\right)\right)}{\left\|u n_{e}\right\|^{r+\eta}} .
$$

There are variants of these functions (and numbers) depending on an additional choice of multisigns $v(e) \in\{0,1\}^{\operatorname{Hom}(F, R)}$ (and an orientation) for each edge $e$, which means that we can replace $g_{I}(\cdot, \cdot)$ by $g_{I, v}(\cdot, \cdot)$ (or $g_{I}^{v}(\cdot, \cdot)$ ).

Remark 4.5 By the very definition, $\mathscr{G}_{I, \Gamma, S}(\cdot, \cdot)$ inherits a $O_{F,+}^{\times}$-invariant property. $\forall \varepsilon \in O_{F,+}^{\times}$, we have

$$
\mathscr{G}_{I, \Gamma, S}\left(\left\{\varepsilon x_{v}\right\}_{v \in S}, \varepsilon u\right)=\mathscr{G}_{I, \Gamma, S}\left(\left\{x_{v}\right\}_{v \in S}, u\right) .
$$

Therefore, our higher plectic Green function $\mathscr{G}_{I, \Gamma, S}(\cdot, \cdot)$ is a function (or distribution) on

$$
O_{F,+}^{\times} \backslash\left(F_{\mathbb{R}} / I\right)^{S} \times U_{\mathbb{R}}=\left(F_{\mathbb{R}} / I\right)^{S} \times_{O_{F,+}^{\times}} E O_{F,+}^{\times},
$$

which depends on the given graph $\Gamma$ and the subset $S$ of the set of its vertices. Here $E O_{F,+}^{\times}$is the total space of the group $O_{F,+}^{\times}$.

Lemma 4.6 (Convolution on $\left.F_{\mathbb{R}} / I\right)$ On $F_{\mathbb{R}} / I$ we have a formal convolution. Let $\chi_{n}(x)=e^{2 \pi i \operatorname{Tr}(x n)}$. If $A(x)=\sum_{m \in I^{*}} a(m) \chi_{m}(x)$ and $B(y)=\sum_{n \in I^{*}} b(n) \chi_{n}(y)$, then

\int_{F_{\mathbb{R}} / I} A(x-y) B(y) d y=\int_{F_{\mathbb{R}} / I} \sum_{m, n \in I^{*}} a(m) b(n) \chi_{m}(x-y) \chi_{n}(y) d y=\operatorname{vol}\left(F_{\mathbb{R}} / I\right) \sum_{n \in I^{*}} a(n) b(n) \chi(n)
$$

Proof 4.1.1 The Proof of Lemma 4.6 is straightout.

$$
\begin{gathered}
\int_{F_{\mathbb{R}} / I} A(x-y) B(y) d y=\int_{F_{\mathbb{R}} / I} \sum_{m, n \in I^{*}} a(m) b(n) e^{2 \pi i \operatorname{Tr}((x-y) m)} e^{2 \pi i \operatorname{Tr}(y n)} d y \\
=\int_{F_{\mathbb{R}} / I} \sum_{m=n} a(m) b(n) e^{2 \pi i \operatorname{Tr}(x m)} e^{2 \pi i \operatorname{Tr}(y(n-m))} d y+\int_{F_{\mathbb{R}} / I} \sum_{m \neq n} a(m) b(n) e^{2 \pi i \operatorname{Tr}(x m)} e^{2 \pi i \operatorname{Tr}(y(n-m))} d y
\end{gathered}
$$

If $m \neq n$, then

\int_{F_{\mathbb{R}} / I} b(n) e^{2 \pi \operatorname{Tr}(y(n-m))} d y=0
$$

## Therefore we obtain

& \int_{F_{\mathbb{R}} / I} A(x-y) B(y) d y=\int_{F_{\mathbb{R}} / I} \sum_{m=n} a(m) b(n) e^{2 \pi i \operatorname{Tr}(x m)} e^{2 \pi \operatorname{Tr}(y(n-m))} d y \\
= & \int_{F_{\mathbb{R}} / I} \sum_{n \in I^{*}} a(n) b(n) e^{2 \pi i \operatorname{Tr}(x n)} \cdot \int_{F_{\mathbb{R}} / I} 1 d y=\operatorname{vol}\left(F_{\mathbb{R}} / I\right) \sum_{n \in I^{*}} a(n) b(n) e^{2 \pi i \operatorname{Tr}(x n)} .
\end{aligned}
$$

By the definition of $g_{I}(\cdot, \cdot)$, we can rewrite the higher plectic Green function as
$\mathscr{G}_{I, \Gamma, S}\left(\left\{x_{v}\right\}_{v \in S}, u\right)=\lim _{\eta \rightarrow 0^{+}} \sum_{n: E(\Gamma) \rightarrow I^{*} \backslash\{0\}} \prod_{e \in E(\Gamma)}\left\|u n_{e}\right\|^{-r-\eta} \int_{\left(F_{\mathbb{R}} / I\right)^{v(\Gamma) \backslash S}} e^{2 \pi i \operatorname{Tr}\left(\sum_{e \in E(\Gamma)} n_{e}\left(x_{v_{1}(e)}-x_{v_{0}(e)}\right)\right)} d \mu_{V(\Gamma) \backslash S}$,
where we define the following map

$$
n: E \longrightarrow I^{*} \backslash\{0\} ; \quad n: e \longmapsto n_{e} \in I^{*} \backslash\{0\} .
$$

Let us define the chain complex for the graph $\Gamma$.

$$
\delta: C_{1}(\Gamma)=\mathbb{Z}[E(\Gamma)] \longrightarrow C_{0}(\Gamma)=\mathbb{Z}[V(\Gamma)],
$$

where $\delta:\left(v_{0} \rightarrow v_{1}\right) \longmapsto\left[v_{1}\right]-\left[v_{0}\right]$ is the boundary map of the chain complex and $\mathbb{Z}[X]$ denotes the free abelian group on a set X . We can also define the relative chain complex for $(\Gamma, S)$, namely,

C_{1}(\Gamma) \longrightarrow C_{0}(\Gamma) / C_{0}(S) .
$$

We can associate to $n$ the following element $c(n)$ in $C_{1}(\Gamma) \otimes_{\mathbb{Z}} I^{*}$ of the graph $\Gamma$.

c(n)=\sum_{e \in E(\Gamma)} n_{e} \cdot \vec{e} \in C_{1}(\Gamma) \otimes_{\mathbb{Z}} I^{*} .
$$

If we let

\pi_{v}=\sum_{e \in E(\Gamma), v_{1}(e)=v} n_{e}-\sum_{e \in E(\Gamma), v_{0}(e)=v} n_{e}, \tag{2}
\end{equation*}
$$

then

e^{2 \pi i \operatorname{Tr}\left(\sum_{e \epsilon E(\Gamma)} n_{e}\left(x_{v_{1}(e)}-x_{v_{0}(e)}\right)\right)}=e^{2 \pi \operatorname{Tr}\left(\sum_{v \in V(\Gamma)} \pi_{v} x_{v}\right)} .
$$

We define the boundary map

\begin{gathered}
\partial n: V(\Gamma) \longrightarrow I^{*}, \\
\partial n(v)=\left.\delta c(n)\right|_{v}=\pi_{v} .
\end{gathered}
$$

By using the previous convolution formula, we obtain that only the terms with $\left.\partial n\right|_{V(\Gamma) \backslash S}=0$ (which means that

\left.\forall v \in V(\Gamma) \backslash S, \quad \pi_{v}=0\right)

contribute to the integral in (1). Note that

Then we get a formal Fourier convolution description of $\mathscr{G}_{1, \Gamma, S}(\cdot, \cdot)$.

Proposition 4.7 (Formal Fourier Expansion)

\mathscr{G}_{I, \Gamma, S}\left(\left\{x_{v}\right\}_{v \in S}, u\right)=\operatorname{vol}\left(F_{\mathbb{R}} / I\right)^{|V(\Gamma) \backslash S|} \lim _{\eta \rightarrow 0^{+}} \sum_{\left\{n, c(n) \in H_{1}(\Gamma, S) \otimes I^{*}\right\}}^{\prime} \frac{\exp ^{2 \pi i \operatorname{Tr}\left(\sum_{v \in S}(\partial n)_{v} x_{v}\right)}}{\prod_{e \in E(\Gamma)}\left\|u n_{e}\right\|^{r+\eta}},
$$

where $\sum^{\prime}$ means that we consider only $n$ such that $c(n) \in H_{1}(\Gamma, S) \otimes I^{*}$ and $\forall e \in E(\Gamma), n_{e} \in I^{*} \backslash\{0\}$.

## Proof 4.1.2

We can replace each $e \in E(\Gamma)$ by a chain of $k_{e} \geq 1$ edges, which is equivalent to that we add $k_{e}-1 \geq 0$ new vertices to each edge $e \in E(\Gamma)$ to get a new graph $\Gamma(k)$ with $|V(\Gamma(k))|=|V(\Gamma)|+$ $\sum_{e}\left(k_{e}-1\right)$ and the subset $S$ is unchanged.

For example, the case of $k_{e}=3$ is as follows.


Figure 6: The subdivision of the edge $e$.
Hence we have defined a subdivision map:
Definition 4.8 (Subdivision map)

Combining a subdivision of edges and formal Fourier expansion, we get
Proposition 4.9 (Subdivision of edges)

\mathscr{G}_{I, \Gamma(k), S}\left(\left\{x_{v}\right\}_{v \in S}, u\right)=\operatorname{vol}\left(F_{\mathbb{R}} / I\right)^{|V(\Gamma)| S|+|k|-|E(\Gamma)|} \lim _{\eta \rightarrow 0^{+}} \sum_{\left\{n, c(n) \in H_{1}(\Gamma, S) \otimes I^{*}\right\}}^{\prime} \frac{e^{2 \pi i \operatorname{Tr}\left(\sum_{v \in S}(\partial n) x_{1} x_{v}\right)}}{\prod_{e \in E(\Gamma)}\left\|u n_{e}\right\|^{k_{e}(r+\eta)}},
$$

where $x \in F_{\mathbb{R}} / \mathbb{R}, u \in U_{\mathbb{R}},|k|=\sum_{e \in E(\Gamma)}\left|k_{e}\right|, n=\left(n_{e}\right)_{e \in E(\Gamma)}$,

$$
\partial n(v)=\sum_{e \in E(\Gamma), v_{1}(e)=v} n_{e}-\sum_{e \in E(\Gamma), v_{0}(e)=v} n_{e},
$$

and $\sum^{\prime}$ means that $\partial n$ is supported at $S$ and each $n_{e}$ is nonzero.
Remark 4.10 We can also add multisigns here, there are two methods. The first way is to associate each edge a multisign $v_{e}=\left(v_{e}^{1}, \ldots, v_{e}^{r}\right)$, then the formula in 4.9 will then contain terms $\operatorname{sgn}\left(n_{e}\right)^{v(e)}$ :
$\mathscr{C}_{I, \Gamma(k), S}^{v}\left(\left\{x_{v}\right\}_{v \in S}, u\right)=\operatorname{vol}\left(F_{\mathbb{R}} / I\right)^{|V(\Gamma) \backslash S|+|k|-|E(\Gamma)|} \lim _{\eta \rightarrow 0^{+}} \sum_{\left\{n, c(n) \in H_{1}(\Gamma, S) \otimes I^{*}\right\}}^{\prime} \operatorname{sgn}\left(n_{e}\right)^{v(e)} \frac{e^{2 \pi i \operatorname{Tr}\left(\sum_{v \in S}(\partial n)_{v} x_{v}\right)}}{\prod_{e \in E(\Gamma)}\left\|u n_{e}\right\|^{k_{e}(r+\eta)}}$.
The second method to add mutisigns by taking into account the $n_{e} \in I^{*} \backslash\{0\}$, such that $\operatorname{sgn}\left(n_{e}\right)=$ $(-1)^{v_{e}}$ for a given multisign $v_{e}$ to each edge $e$. Then

\mathscr{G}_{I, v, \Gamma(k), S}\left(\left\{x_{v}\right\}_{v \in S}, u\right)=\operatorname{vol}\left(F_{\mathbb{R}} / I\right)^{|V(\Gamma)| S|+|k|-|E(\Gamma)|} \lim _{\eta \rightarrow 0^{+}} \sum_{\substack{\left\{n, c(n) \in H_{1}(\Gamma, S) \otimes I^{*}\right\} \\ \operatorname{sgn}\left(n_{e}\right)=(-1)^{v(e)}}}^{\prime} \frac{e^{2 \pi i \operatorname{Tr}\left(\sum_{v \in S}(\partial n)_{v} x_{v}\right)}}{\prod_{e \in E(\Gamma)}\left\|u n_{e}\right\|^{k_{e}(r+\eta)}} .
$$

In fact, we usually prefer the second definition $\mathscr{G}_{1, v, \Gamma(k), S}\left(\left\{x_{v}\right\}_{v \in S}, u\right)$.

### 4.1.3 Generalized MZV for totally real fields

If we suppose that there exists a subgroup $U \subset O_{F,+}^{\times}$of finite index stabilising $\left\{x_{v}\right\}$ for each $v \in S$, we can apply the Hecke transform to define a new function as follows.

## Definition 4.11

\mathscr{F}_{I, \Gamma, S}\left(\left\{x_{v}\right\}_{v \in S}\right)=\left(O_{F,+}^{\times}: U\right)^{-1} \int_{U_{\mathbb{R}} / U} \mathscr{G}_{I, \Gamma, S}\left(\left\{x_{v}\right\}_{v \in S}, u\right) d^{\times} u
$$

where $d^{\times} u=\frac{d u_{1} \cdots d u_{r-1}}{u_{1} \cdots u_{r-1}}, \prod_{j=1}^{r} u_{j}=1$ and $U_{\mathbb{R}} / U=B U \cong(\mathbb{S})^{r-1}$ is the classifying space of $U \cong \mathbb{Z}^{r-1}$.
Remark: In the same way, we can define $\mathscr{F}_{I, \Gamma, S}^{V}\left(\left\{x_{v}\right\}_{v \in S}\right)$ and $\mathscr{F}_{I, v, \Gamma, S}\left(\left\{x_{v}\right\}_{v \in S}\right)$.
Then the generalized multiple zeta value is defined as

## Definition 4.12 (Generalized Multiple Zeta Values)

$$
\mathscr{Z}_{I}(\Gamma, S)=\mathscr{F}_{I, \Gamma, S}\left(\{0\}_{v \in S}\right) .
$$

Remark 4.13 Similarily, we have

$$
\mathscr{Z}_{I}^{v}(\Gamma, S)=\mathscr{F}_{I, \Gamma, S}^{v}\left(\{0\}_{v \in S}\right)
$$

and

$$
\mathscr{Z}_{I, v}(\Gamma, S)=\mathscr{F}_{I, v, \Gamma, S}\left(\{0\}_{v \in S}\right)
$$

Remark 4.14 In fact, the construction for $\mathscr{G}_{I, v, \Gamma(k), S}\left(\left\{x_{v}\right\}_{v \in S}, u\right)$ also works for arbitary number fields. If a complex place exists, we can just replace the Euclidean norm by Hermitian norm and we can add signs just for the real places. For an imaginary quadratic field, there is no Hecke transform.

### 4.1.4 Generalized MZV for arbitary number fields

## Definition 4.15 (Plectic Green functions for arbitary number fields)

Let $K$ be a number field with $r_{1}$ real places $\left(v_{i}\right)_{1 \leq i \leq r_{1}}$ and $r_{2}$ complex places $\left(w_{j}\right)_{1 \leq j \leq r_{2}}$ and of degree $[K: \mathbb{Q}]=r_{1}+2 r_{2}$. We have the trace map $\operatorname{Tr}=\operatorname{Tr}_{K / \mathbb{Q}}$

K_{\mathbb{R}} \cong \mathbb{R}^{r_{1}} \times \mathbb{C}^{r_{2}}
$$

and we have a Hermitian product

$$
\begin{gathered}
\langle\mid\rangle: K_{\mathbb{R}} \times K_{\mathbb{R}} \longrightarrow \mathbb{C} \\
\left\langle\left(x_{v}, z_{w}\right) \mid\left(x_{v}^{\prime}, z_{w}^{\prime}\right)\right\rangle=\sum_{v} x_{v} x_{v}^{\prime}+\sum_{w} z_{w} z_{w}^{\prime}
\end{gathered}
$$

where

x=\left(x_{v}, z_{w}\right)
$$

Let

\|\cdot\|=\langle\cdot \mid \cdot\rangle^{1 / 2}
$$

then the plectic Green function can be defined as

g_{I}(x, u)=\sum_{n \in I^{*} \backslash\{0\}} \frac{e^{2 \pi i \operatorname{Tr}(n x)}}{\|u n\|^{r_{1}+2 r_{2}}}, \quad x \in K_{\mathbb{R}} / I, u \in U_{\mathbb{R}},
$$

which is a distribution on $\left(K_{\mathbb{R}} / I\right) \times U_{\mathbb{R}}$.

### 4.2 Relation to classical MZVs

### 4.2.1 Relation to MZVs and examples

In order to give an explicit relation to the classical definition, we obtain the following result.

Theorem 4.16 (Relation to multiple zeta values) Let $F$ be the rational field $\mathbb{Q}$.
Let $\Gamma$ be any tree with rank $d=\operatorname{rank}\left(H_{1}(\Gamma, S)\right) \geq 2$, where $S=\partial \Gamma$. Assume that we are given $a$ "sign" map $v: E(\Gamma) \longrightarrow\{0,1\}$ and a subdivision map $k: E(\Gamma) \longrightarrow \mathbb{N} \backslash\{0\}$ as in Remark 4.10 and in Definition 4.8, respectively. Then the generalized multiple zeta value $\mathscr{Z}_{I, v}(\Gamma(k), \partial \Gamma(k))(I=\mathbb{Z})$ can be expressed as a finite $\mathbb{Z}$-linear combination of classical multiple zeta values (MZVs) of depth $d$ and weight $|k|=\sum_{e} k_{e}$.

Remark 4.17 Before proving this result in general we consider first the case when $\Gamma$ is a plane trivalent tree, i.e., a tree whose internal vertices are of valency 3. A plane trivalent tree $\Gamma$ with $m+1$ external vertices has $2 m-1$ edges and $m-1$ internal vertices. The rank of $\Gamma$ is $d=\operatorname{rank}\left(H_{1}(\Gamma, \partial \Gamma)\right)=$ m. A tree is a connected graph with no loops, no multiple edges and $H_{1}(\Gamma, \mathbb{Z})=0$.


Figure 7: The simplest examples of plane trivalent trees of small ranks.

Remark 4.18 In this theorem we only consider the situation that the subset $S=\partial \Gamma$. We would like to explain that such choice is quite general. In fact, $\mathscr{Z}_{1, v}(\Gamma, S)=0$ if $\partial \Gamma \phi S$, therefore we must have $\partial \Gamma \subset S$. If one internal vertex is contained in $S$, namely $\partial \Gamma \subsetneq S$, the situation can be reduced to a new tree with fewer internal vertices.

When $F=\mathbb{Q}$ and the ideal $I=\mathbb{Z}$, the Hecke transform is trivial. The generalized multiple zeta values are given by

$$
\mathscr{Z}_{I, v}(\Gamma, S)=\mathscr{G}_{I, v, \Gamma, S}\left(\{0\}_{v \in S}, 1\right) .
$$

Before giving the proof in full generality, we will illustrate the statement of Theorem 4.16 by several examples.

## Some Examples.

Remark 4.19 In Theorem 4.16 and 4.38, we will take into account all arbitary trees, and we prove the theorems when the valency of any internal vertex val $\left(v_{\text {internal }}\right) \geq 3$. We will now explain the case: $\operatorname{val}\left(v_{\text {internal }}\right)=2$.


Figure 8: All internal vertices have valency 2

Let $\widetilde{\Gamma}$ be one of the trees in Figure 8.
We fix the signature $v_{1}=0$ for $n_{1}$, then implicitly all other signatures are also determined.

$$
\begin{gathered}
\mathscr{G}_{\mathbb{Z}, v, \widetilde{\Gamma}, \partial \widetilde{\Gamma}}\left(\left\{a_{1}, a_{2}\right\}, 1\right)=\int_{(\mathbb{R} / \mathbb{Z})^{k}}{ }_{\substack{n_{1}, \cdots, n_{k+1} \in \mathbb{Z}\{0\} \\
\sin \left(n_{j}\right)=(-1)^{v j} \\
n_{j}=n_{j+1}, 1 \leq j \leq k}} \frac{\left.e^{2 \pi i\left(\sum_{2 \leq j \leq k} n_{j}\left(x_{j}-x_{j-1}\right)\right)+n_{1}\left(x_{1}-a_{1}\right)+n_{k+1}\left(a_{2}-x_{k}\right)}\right)}{\prod_{j=1}^{k+1}\left|n_{j}\right|} d x_{1} \cdots d x_{k} \\
=\sum_{n_{1} \in \mathbb{N} \backslash\{0\}} \frac{e^{2 \pi i n_{1}\left(a_{2}-a_{1}\right)}}{n_{1}^{k+1}} . \\
\mathscr{Z}_{\mathbb{Z}, v}(\widetilde{\Gamma}, \partial \widetilde{\Gamma})=\mathscr{G}_{\mathbb{Z}, v, \widetilde{\Gamma}, \partial \widetilde{\Gamma}}(\{0,0\}, 1)=\sum_{n_{1} \in \mathbb{N} \backslash\{0\}} \frac{1}{n_{1}^{k+1}}=\zeta(k+1) .
\end{gathered}
$$

This result tells us that such a graph delivers the same result as the subdivision map of adding $k$ points for the tree with one edge and two external vertices $a_{1}, a_{2}$.

Non-tree case. We will show some examples for graphs which are not trees.
Example 4.20 Let $\widehat{\Gamma}$ be the graph in Figure 9.
We fix the signature $v_{1}=0$ for $n_{1}$ and the signature $\mu_{1}=0$, then other signatures are implicitly determined by the constraint at each internal vertex because of the formal Fourier convolution.

\mathscr{G}_{\mathbb{Z}, v, \widehat{\Gamma}, \partial \widehat{\Gamma}}\left(\left\{y_{1}, y_{2}\right\}, 1\right)=\int_{(\mathbb{R} / \mathbb{Z})^{6}} \sum_{\begin{array}{c}

\operatorname{snn}\left(n_{k}\right)=(-1)^{v_{k}} \\
\operatorname{sgn}\left(m_{l}\right)=(-1)^{\prime} \\
n_{1}+n_{2}+m_{1}-m_{6} \\
m_{l}=m_{l+1}, 1 \leq l \leq 5
\end{array}} \frac{e^{2 \pi i\left(\sum_{l=1}^{5} m_{l}\left(x_{l+1}-x_{l}\right)+m_{6}\left(x_{1}-x_{6}\right)+n_{1}\left(y_{1}-x_{1}\right)+n_{2}\left(y_{2}-x_{1}\right)\right)}}{\prod_{l=1}^{6}\left|m_{l}\right| \cdot\left|n_{1}\right| \cdot\left|n_{2}\right|} d x_{1} \cdots d x_{6} .
$$

By formal Fourier convolution,

\mathscr{G}_{\mathbb{Z}, v, \widehat{\Gamma}, \partial \widehat{\Gamma}}\left(\left\{y_{1}, y_{2}\right\}, 1\right)=\sum_{n_{1}, m_{1} \in \mathbb{N} \backslash\{0\}} \frac{e^{2 \pi i\left(n_{1}\left(y_{1}-y_{2}\right)\right)}}{m_{1}^{6} n_{1}^{2}}=\zeta(6) \sum_{n=0}^{\infty} \frac{e^{2 \pi i n\left(y_{1}-y_{2}\right)}}{n^{2}},
$$



Figure 9: The graph $\widehat{\Gamma}$.
and

$$
\mathscr{Z}_{\mathbb{Z}, v}(\widehat{\Gamma}, \partial \widehat{\Gamma})=\sum_{n_{1}, m_{1} \in \mathbb{N} \backslash\{0\}} \frac{1}{m_{1}^{6} n_{1}^{2}}=\zeta(6) \zeta(2) .
$$

By the shuffle relation, we get

\mathscr{Z}_{\mathbb{Z}, v}(\widehat{\Gamma}, \partial \widehat{\Gamma})=\sum_{r+s=8}\left(C_{r-1}^{5}+C_{r-1}^{1}\right) \zeta(s, r) .

The result is equal to the value of

\mathscr{Z}_{\mathbb{Z}, v}\left(\Gamma_{b},\left\{s_{1}, s_{2}\right\}\right)=\sum_{\substack{n_{1}, m_{1} \in \mathbb{N} \backslash\{0\} \\ n_{2}=-n_{1}}} \frac{e^{2 \pi i\left(n_{1} y_{1}+n_{2} y_{2}\right)}}{m_{1}^{6} n_{1}^{2}}=\sum_{n_{1}, m_{1} \in \mathbb{N} \backslash\{0\}} \frac{e^{2 \pi i\left(n_{1}\left(y_{1}-y_{2}\right)\right)}}{m_{1}^{6} n_{1}^{2}},
$$

given by Figure 10.


Figure 10: The graph $\Gamma_{b}$.
From the discussion above, we can see that different graphs can deliver the same value.
The case of trees of internal valency $\geq 3$.
Example 4.21 Let $\Gamma$ be the graph in Figure 11.
The graph $\Gamma(k)$ is just a chain obtained after adding $k-1$ points to $\Gamma$. The given sign is $v_{i}=v$, $1 \leq i \leq k$. Then

\mathscr{G}_{I, v, \Gamma(k), \partial \Gamma(k)}\left(\left\{x_{v}\right\}_{v \in \partial \Gamma(k)}, 1\right)=\sum_{\substack{n \in \mathbb{Z} \backslash\{0\} \\ \operatorname{sgn}(n)=(-1)^{v}}} \frac{e^{2 \pi i n\left(x_{2}-x_{1}\right)}}{|n|^{k}},
$$



Figure 11: A plane trivalent tree of rank 1.
and

$$
\mathscr{Z}_{I, v}(\Gamma(k), \partial \Gamma(k))=\sum_{\substack{n \in \mathbb{Z} \backslash\{0\} \\ \operatorname{sgn}(n)=(-1)^{v}}} \frac{1}{|n|^{k}}=\zeta(k) .
$$

Moreover, we even do not need sign $v$, then one obtain

\mathscr{Z}_{I}(\Gamma(k), \partial \Gamma(k))=\sum_{n \in \mathbb{Z} \backslash\{0\}} \frac{1}{|n|^{k}}=2 \zeta(k) .
$$

Example 4.22 Let $\Gamma_{1}$ be the graph in Figure 12.


Figure 12: A plane trivalent tree with one internal vertex
The rank of $\Gamma_{1}$ is $2=\operatorname{rank}\left(H_{1}\left(\Gamma_{1}, \partial \Gamma_{1}\right)\right)$. To each edge $e_{i}(i=1,2,3)$ we add $\sigma_{i}-1 \geq 0$ points. The only internal vertex is denoted by $y$, each external vertex $v_{i}$ is decorated by the variable $x_{v_{i}}$. For each $e_{i}(i=1,2)$, the given sign $v_{i}$ equals 0 . For the edge $e_{3}$, the sign $v_{3}=1$. In fact, the constraint $n_{1}+n_{2}+n_{3}=0$ and $v_{1}=v_{2}=0$ imply that $v_{3}=1$.

$$
\mathscr{G}_{I_{1}, \Gamma_{1}, \partial \Gamma_{1}}\left(\left\{x_{v}\right\}_{v \in \partial \Gamma_{1}}, 1\right)=\sum_{\substack{n_{1}+n_{2}+n_{3}=0, n_{i} \in \mathbb{Z} \backslash \\ \operatorname{sgn}\left(n_{i}\right)=(-1)^{v_{i}}}} \frac{e^{2 \pi i\left(n_{1} x_{v_{1}}+n_{2} x_{v_{2}}+n_{3} x_{v_{3}}\right)}}{\left|n_{1}\right| \sigma_{1}\left|n_{2}\right|^{\left.\left|\sigma_{2}\right| n_{3}\right|^{\sigma_{3}}},}
$$

where $v_{1}=v_{2}=0, v_{3}=1$. Then

$$
\begin{gathered}
\mathscr{Z}_{I, v}\left(\Gamma_{1}, \partial \Gamma_{1}\right)=\sum_{\substack{n_{1}+n_{2}+n_{3}=0, n_{i} \in \mathbb{Z}\left\{0 \\
\operatorname{sgn}\left(n_{i}\right)=(-1)^{v_{i}}\right.}} \frac{1}{\left.\left|n_{1}\right|\right|^{\sigma_{1}}\left|n_{2}\right|^{\sigma_{2}}\left|n_{3}\right|^{\sigma_{3}}}=\sum_{n_{1, n} \in \mathbb{N} \backslash\{0\}} \frac{1}{\left|n_{1}\right|^{\sigma_{1}\left|n_{2}\right|^{\sigma_{2}}\left|n_{1}+n_{2}\right|^{\sigma_{3}}}} \\
\mathscr{Z}_{1, v}\left(\Gamma_{1}, \partial \Gamma_{1}\right)=\sum_{n_{1}, n_{2} \in \mathbb{N}\{\{0\}} \frac{1}{n_{1}^{\sigma_{1}} n_{2}^{\sigma_{2}}\left(n_{1}+n_{2}\right)^{\sigma_{3}}} .
\end{gathered}
$$

Recall the following Eisenstein's trick

where $C_{b}^{a}=\binom{b}{a}$. Hence

=\sum_{r+s=\sigma_{1}+\sigma_{2}}\left\{C_{r-1}^{\sigma_{1}-1}\left(\sum_{n_{1}, n_{2} \in \mathbb{N} \backslash\{0\}} \frac{1}{\left(n_{1}+n_{2}\right)^{r+\sigma_{3}} n_{2}^{s}}\right)+C_{r-1}^{\sigma_{2}-1}\left(\sum_{n_{1}, n_{2} \in \mathbb{N} \backslash\{0\}} \frac{1}{\left(n_{1}+n_{2}\right)^{r+\sigma_{3} n_{1}^{s}}}\right)\right\} .

& =\sum_{r+s=\sigma_{1}+\sigma_{2}}\left(C_{r-1}^{\sigma_{1}-1}+C_{r-1}^{\sigma_{2}-1}\right) \zeta\left(s, r+\sigma_{3}\right) .
\end{aligned}
$$

Here $\zeta\left(s, r+\sigma_{3}\right)$ is a classical double zeta value of weight $r+s+\sigma_{3}=\sigma_{1}+\sigma_{2}+\sigma_{3}$, which means that $\mathscr{Z}_{I, v}\left(\Gamma_{1}, \partial \Gamma_{1}\right)$ can be expressed as a $\mathbb{Z}$-linear combination of double zeta values of this weight.

Example 4.24 Let $\Gamma_{1}^{\prime}$ be the diagram as in Figure 2. The rank of $\Gamma_{1}^{\prime}$ is $\operatorname{rank}\left(H_{1}\left(\Gamma_{1}^{\prime}, \partial \Gamma_{1}^{\prime}\right)\right)=3$. In

fact, the $\Gamma_{1}^{\prime}$ is no longer a plane trivalent tree. For each edge $e_{i}(1 \leq i \leq 4)$, we add $\sigma_{i}-1\left(\sigma_{i} \geq 1\right)$ points. The only internal vertex is denoted by $y$, each external vertex $v_{i}$ is decorated by $x_{v_{i}}$. For each $e_{i}(i=1,2,3)$, the given sign $v_{i}$ equals 0 ; for $e_{4}$ the sign $v_{4}=1$.

The rank is equal to $\operatorname{rank}\left(H_{1}\left(\Gamma_{2}, \partial \Gamma_{2}\right)\right)=3$. For each external edge $e_{i}(1 \leq i \leq 3)$, the given sign $v_{i}$ equals 0 , therefore $v_{4}=1$.

Remark: By careful observation, we can see that on the factorisation factors (without the exponent) of the denominators of these six terms (a)...(T), there is an action of the symmetric group $S_{3}$. For example, to pass from the factors of the denominator of (a) (without considering the power) to that of © $\mathfrak{C}$, we let $\sigma=\sigma(123)$ acting on $\left(n_{1}+n_{2}+n_{3}\right)\left(n_{1}+n_{2}\right) n_{2}$ by $\left(n_{\sigma \cdot 1}+n_{\sigma \cdot 2}+n_{\sigma \cdot 3}\right)\left(n_{\sigma \cdot 1}+\right.$ $\left.n_{\sigma \cdot 2}\right) n_{\sigma \cdot 2}$, which also explains why there are $6=\left|S_{3}\right|$ terms.

In conclusion, since $\mathscr{Z}_{I, v}\left(\Gamma_{3}, \partial \Gamma_{3}\right)$ is just the summation of the 6 sums as Sum ${ }_{1}$, therefore $\mathscr{Z}_{I, v}\left(\Gamma_{3}, \partial \Gamma_{3}\right)$ is indeed a $\mathbb{Z}$-linear combination of quadruple zeta values of weight $\sigma_{1}+\sigma_{2}+\sigma_{3}+$ $\sigma_{4}+\sigma_{5}+\mu_{1}+\mu_{2}$.

## Proof of Theorem 4.16

## Proof 4.2.1 (I). The graph $\Gamma$ is a plane trivalent tree.

Inspired by the previous examples, we will prove the theorem 4.16 by induction on the number of internal vertices of a given tree. For simplicity, we will first consider only plane trivalent trees. Later we will prove this theorem for any tree.

Step 1: Let $\Gamma$ be a given plane trivalent tree with $N$ internal vertices $w_{j}(1 \leq j \leq N), N+2$ external vertices $v_{i}(1 \leq i \leq N+2), N-1$ internal edges and $N+2$ external edges. The subdivision map $k$ is given by $k_{e_{i}}=\sigma_{e_{i}}\left(\sigma_{e_{i}} \geq 1\right)$ if $e_{i}(1 \leq i \leq N+2)$ is an external edge with endpoint $v_{i}$, and $k_{f_{j}}=\mu_{f_{j}}\left(\mu_{f_{j}} \geq 1\right)$ if $f_{j}(1 \leq j \leq N-1)$ is an internal edge. Recall that for each edge, we give a sign $v_{e} \in\{0,1\}$.

Remark: In fact, we can see that the orientation of each edge has no importance by changing the sign for each edge. Moreover, we can also assume that for each external edge $e_{i}$ with the sign $v_{e_{i}}=0,1 \leq i \leq N+1$ (we shall see that this forces $v_{e_{N+2}}=1$ ). It is easy to see that we will lose no generality.

By the results of the above examples, we know that Therem 4.16 holds when $N=1,2,3$. Now our inductive hypothesis is that if $N=n(n \geq 1)$, the theorem is true. Moreover, we assume that:

Let $\Gamma$ be a plane trivalent tree with $N(N \leq n)$ internal vertices and rank $d=\operatorname{rank}\left(H_{1}(\Gamma, \partial \Gamma)\right)$. Then we have a relation $d=N+1$. The generalized multiple zeta value associated $\mathscr{Z}_{1, v}(\Gamma, \partial \Gamma)$ can be written as follows

where $S_{d}$ is the symmetric group, $C_{\gamma, t_{i}^{\gamma}} \in \mathbb{Z}$ is a constant depending on $\gamma$ and $t_{i}^{\gamma}$. The upper mute symbol $\gamma$ of ${ }_{j}^{\gamma}$ implies the dependence of $\gamma$, and

For a plane trivalent tree, if the number of internal vertices is increased by 1, then the rank of the tree is increased by 1 , too.

Now we give a clockwise order for all external vertices $v_{i}$. We will also give an order for all internal vertices, such that the internal vertex $w_{N}$, decorated by the variable $x_{N}$, is connected with the two external vertices $v_{N+1}$ and $v_{N+2}$ by external edges $\overrightarrow{e_{N+1}}=\left(w_{N} \longrightarrow v_{N+1}\right)$ and $\overrightarrow{e_{N+2}}=\left(w_{N} \longrightarrow\right.$ $v_{N+2}$ ).


Figure 16: the internal vertex $w_{N}$ is connected with the two external vertices $v_{N+1}$ and $v_{N+2}$.


Figure 17: cutting down the internal edge $f_{N-1}$ to get a new tree $\Gamma^{\prime}$.

In order to deduce the case $N=n+1$ from the case $N-1=n$, we do an operation: we cut down the internal edge $f_{N-1}$, one of whose ends is the internal vertex $w_{N}$ and associate a new external vertex denoted as $v_{N+1}^{\prime}$ and denote the new external edge as $e_{N+1}^{\prime}$ to which we associate $n_{e_{N+1}^{\prime}}=m_{N-1}$ and the subdivision $\mu_{N-1}$, then we build a new plane trivalent tree $\Gamma^{\prime}$ with $N-1=n$ internal vertices and whose rank is $d-1$, where $d$ is the rank of $\Gamma$.

In the definition of

The demonstration is quite similar to the previnous proof for any plane trivalent tree. Let $\Gamma$ be an arbitrary plane tree with $N$ internal vertices. For each internal vertex $w_{j}(1 \leq j \leq N)$, the valency $\operatorname{val}\left(w_{j}\right)=3+\beta_{j}, \quad \beta_{j} \geq 0$. Then $\Gamma$ has $N-1$ internal edges, $N+2+\sum_{1 \leq j \leq N} \beta_{j}$ external edges and $N+2+\sum_{1 \leq j \leq N} \beta_{j}$ external vertices $v_{i}$. Therefore the rank $d=\operatorname{rank}\left(H_{1}(\Gamma, \partial \Gamma)\right)$ is not equal $N+1$ any more, but we have

Then the sign $v_{3+\beta}$ is forced to be 1 .

Remark 4.37 Eisenstein's trick has been formalized by Sczech in his theory of Eisenstein cocycles. It also appears in one of the proofs of the shuffle relations for MZV's. This is probably no coincidence.

\mathscr{G}_{I, v, \Gamma, \partial \Gamma}\left(\left\{x_{v}\right\}_{v \in \partial \Gamma}, 1\right)=\sum_{\gamma \in S_{d}}\left(\sum_{\substack{\gamma_{j}^{\gamma} \\ 1 \leq j \leq d}} C_{\gamma, t_{j}^{\gamma}} L i_{t_{1}^{\gamma}, \cdots, t_{d}^{\gamma}}\left(z_{\gamma \cdot 1}, \cdots, z_{\gamma \cdot d}\right)\right) .
$$

In conclusion, $\mathscr{G}_{I, v, \Gamma, \partial \Gamma}\left(\left\{x_{\nu}\right\}_{\nu \in \partial \Gamma}, 1\right)$ is indeed a finite $\mathbb{Z}$-linear combination of multiple polylogarithms evaluated at some $N$-th roots of unity.

## 5 Generalization of Multiple Zeta Values (II): Results for general totally real fields

If $[F: \mathbb{Q}]=r>1$, then the generalized multiple zeta value $\mathscr{Z}_{I}(\Gamma, S)$ is highly non-trivial.
From the definition of

$$
\begin{gathered}
\mathscr{F}_{I, v, \Gamma, S}\left(\left\{x_{v}\right\}_{v \in S}\right)=\left(O_{F,+}^{\times}: U\right)^{-1} \int_{U_{\mathbb{R}} / U} \mathscr{G}_{I, v, \Gamma, S}\left(\left\{x_{v}\right\}_{v \in S}, u\right) d^{\times} u, \\
\mathscr{Z}_{I, v}(\Gamma, S)=\mathscr{F}_{I, v, \Gamma, S}\left(\{0\}_{v \in S}\right),
\end{gathered}
$$

where $d^{\times} u=\frac{d u_{1} \cdots d u_{r-1}}{u_{1} \cdots u_{r-1}}, \prod_{j=1}^{r} u_{j}=1$ and $U_{\mathbb{R}} / U=B U$ the classifying space of $U=\mathbb{Z}^{r-1} . B U \cong\left(S^{1}\right)^{r-1}$, the isomorphism is independent of the choice of $U$, the calculation of the integral plays an important role to get the precise expression of our $\mathscr{Z}_{I, v}(\Gamma, S)$. For example, Given a graph $\Gamma_{1}$ as in Figure 12 Let us compare the difference as follows.


Figure 18: A plane trivalent tree with one internal vertex
If the ground field is $\mathbb{Q}$, then

\mathscr{Z}_{\mathbb{Q}, I, v}\left(\Gamma_{1}, \partial \Gamma_{1}\right)=\sum_{\substack{n_{1}+n_{2}+n_{3}=0 \\ n_{1} \in \mathbb{Z} \\ n_{1}, n_{2}>0}} \frac{1}{\left|n_{1}\right|^{k_{1}\left|n_{2}\right|^{k_{2}}\left|n_{3}\right|^{k_{3}}}}=\sum_{n_{1}, n_{2} \in \mathbb{N} \backslash\{0\}} \frac{1}{n_{1}^{k_{1}} n_{2}^{k_{2}}\left(n_{1}+n_{2}\right)^{k_{3}}} .
$$

If the ground field is $F,[F: \mathbb{Q}]=r>1$. By the definition

$$
\mathscr{F}_{I, v, \Gamma, S}\left(\left\{x_{v}\right\}_{v \in S}\right)=\left(O_{F,+}^{\times}: U\right)^{-1} \int_{U_{\mathbb{R}} / U} \mathscr{G}_{I, v, \Gamma, S}\left(\left\{x_{v}\right\}_{v \in S}, u\right) d^{\times} u,
$$

then the generalized multiple zeta value

$$
\mathscr{Z}_{I, v}(\Gamma, S)=\mathscr{F}_{I, v, \Gamma, S}\left(\{0\}_{v \in S}\right) .
$$

Therefore for the given graph $\Gamma_{1}$, we have

$$
\mathscr{Z}_{F, I, v}\left(\Gamma_{1}, \partial \Gamma_{1}\right)=\sum_{\left(n_{1}, n_{2}\right) \in\left(I^{\star},\{0\}\right)^{2} / U} \int_{U_{\mathbb{R}}} \frac{\mathrm{d}^{\times} u}{\left\|n_{1} u\right\|^{k_{1}}\left\|n_{2} u\right\|^{k_{2}}\left\|\left(n_{1}+n_{2}\right) u\right\|^{k_{3}}} .
$$

So we need to understand integrals such as

$$
\int_{U_{\mathbb{R}}} \frac{\mathrm{d}^{\times} u}{\left\|n_{1} u\right\|^{k_{1}}\left\|n_{2} u\right\|^{k_{2}}\left\|\left(n_{1}+n_{2}\right) u\right\|_{3}^{k_{3}}} .
$$

More generally, we need to understand the following integral

$$
\begin{equation*}
\int_{U_{\mathbb{R}}}\left(\prod_{j=1}^{d}\left\|n_{j} u\right\|^{-k_{j}}\right) \mathrm{d}^{\times} u . \tag{4}
\end{equation*}
$$

For this purpose, we have to introduction the calculation of the Hecke transform.
Remark 5.1 The work to understand integrals mentioned above will be done for totally real field $F$. For a general number field $K$ of degree $r_{1}+2 r_{2}$,

$$
K_{\mathbb{R}} \cong \mathbb{R}^{r_{1}} \times \mathbb{C}^{r_{2}}
$$

one can use polar coordinates on each factor of $\mathbb{C}^{r_{2}}$. This reduces the integral (4) to an analogous integral for totally real fields of degree $r_{1}+r_{2}$.

### 5.1 The Hecke transform

All the notations are defined as before.
Proposition 5.2 (The Hecke transform) [14]
Let $U_{\mathbb{R}} \subset\left(\mathbb{R}_{+}^{\times}\right)^{r}$ be the subgroup

$$
U_{\mathbb{R}}=\left\{u=\left(u_{1}, \ldots, u_{r}\right) \mid \prod_{j=1}^{r} u_{j}=1\right\}
$$

with the measure $d^{\times} u=\frac{d u_{1}}{u_{1}} \wedge \cdots \wedge \frac{d u_{r-1}}{u_{r-1}}$. Let $\|\cdot\|$ be the Euclidean norm on $\mathbb{C}^{r}$, on which $U_{\mathbb{R}}$ acts by multiplication. Let $(p)_{j} \in \mathbb{Z}^{r}, p=\sum p_{j}$. Then for any $x=\left(x_{1}, \ldots, x_{r}\right) \in\left(\mathbb{C}^{\times}\right)^{r}$ and $s \in \mathbb{C}, \operatorname{Re}(s)>0$.

$$
\int_{U_{\mathbb{R}}}\|u x\|^{-2 s} \prod_{j} u_{j}^{-2 p_{j}} d^{\times} u=\frac{2^{1-r}}{r \Gamma(s)} \prod_{j} \Gamma\left(\frac{p+s}{r}-p_{j}\right)\left|x_{j}\right|^{2\left(p_{j}-(p+s) / r\right)} .
$$

Proof 5.1.1 Firstly we will give a more general set-up. Change of variable:

H_{+}^{n-1}=\left\{u=\left(u_{1}, \cdots, u_{n}\right) \mid u_{j}>0, u_{1} \cdots, u_{n}=1\right\} \\
H_{+}^{n-1} \times \mathbb{R}_{+} \simeq \mathbb{R}_{+}^{n-1} ;\left(\left(u_{1}, \cdots, u_{n}\right), t\right) \longrightarrow x=\left(x_{1}, \cdots, x_{n}\right)=\left(t u_{1}, \cdots, t u_{n}\right) . \\
x_{1} \cdots x_{n}=t^{n}, \quad t=\left(x_{1} \cdots x_{2}\right)^{1 / n}, \quad u_{i}=\frac{x_{i}}{t}=\frac{x_{i}}{\left(x_{1} \cdots x_{n}\right)^{1 / n}}, \\
\sum_{1}^{n} \frac{d u_{i}}{u_{i}}=0,
\end{gathered}
$$

then,

\begin{gathered}
d x_{1} \wedge \cdots \wedge d x_{n}=\frac{d x_{1} \wedge \cdots \wedge d x_{n}}{u_{1} \cdots u_{n}}=\frac{d x_{1}}{u_{1}} \wedge \cdots \wedge \frac{d x_{n}}{u_{n}}=\left(t \frac{d u_{1}}{u_{1}}+d t\right) \wedge \cdots\left(t \frac{d u_{n}}{u_{n}}+d t\right), \\
d x_{1} \wedge \cdots \wedge d x_{n}=t^{n} \wedge_{i=1}^{n} \frac{d u_{i}}{u_{i}}+t^{n-1} \sum_{i=1}^{n}\left(d u_{1} / u_{1} \wedge \cdots \wedge \frac{d u_{i-1}}{u_{i-1}} \wedge d t \wedge \frac{d u_{i+1}}{u_{i+1}} \wedge \cdots \wedge \frac{d u_{n}}{u_{n}}\right)=\omega \wedge n t^{n-1} d t .
\end{gathered}
$$

where

\omega=(-1)^{n-i} \frac{d u_{1} \wedge \cdots \wedge \widehat{u_{i}} \wedge \cdots \wedge d u_{n}}{u_{1} \cdots \widehat{u}_{i} \cdots u_{n}}
$$

$\omega$ is independent of $i$, so we fix a standard form

$$
\mathrm{d}^{\times} u=\omega=\frac{d u_{1} \wedge \cdots \wedge d u_{n-1}}{u_{1} \cdots u_{n-1}}
$$

then for every function with $n$-variables, we have

$$
\int_{\mathbb{R}_{+}^{n}} g\left(x_{1}, \cdots, x_{n}\right) d x_{1} \cdots d x_{n}=\int_{\mathbb{R}_{+}}\left(\int_{H_{+}^{n-1}} g\left(t u_{1}, \cdots, t u_{n-1}\right) \frac{d u_{1} \cdots d u_{n-1}}{u_{1} \cdots u_{n-1}}\right) n t^{n-1} d t .
$$

Recall the following $\Gamma$-integrals: $\lambda, a, b>0$, and $\operatorname{Re}(s)>0$ and $d^{\times} \lambda=\mathrm{d} \lambda / \lambda$,

$$
\Gamma(s) a^{-s}=\int_{\mathbb{R}_{+}} \mathrm{e}^{-a \lambda} \lambda^{s} d^{\times} \lambda=2 \int_{\mathbb{R}_{+}} \mathrm{e}^{-a x^{2}} x^{2 s} \mathrm{~d}^{\times} x
$$

where $\lambda=x^{2}$. Moreover $a=b^{2}$, we get

\frac{\Gamma(s / 2)}{2 b^{s}}=\int_{\mathbb{R}_{+}} \mathrm{e}^{-(b x)^{2}} x^{s} \mathrm{~d}^{\times} x .
$$

Now if we take $z=\left(z_{1}, \ldots, z_{n}\right) \in\left(\mathbb{C}^{\times}\right)^{n},\|z\|^{2}=\sum_{j=1}^{n}\left|z_{j}\right|^{2}, u=\left(u_{1}, \cdots, u_{n}\right) \in H_{+}^{n-1}, u z=\left(u_{1} z_{1}, \cdots, u_{n} z_{n}\right)$,

$$
\Gamma(s)\|u z\|^{-2 s}=\int_{\mathbb{R}_{+}} \mathrm{e}^{-\lambda\|u z\|^{2}} \lambda^{s} \mathrm{~d}^{\times} \lambda=2 \int_{\mathbb{R}_{+}} \mathrm{e}^{-\|t u z\|^{2}} t^{2 s} \mathrm{~d}^{\times} t
$$

where we take $\lambda=t^{2}$ for the last equality. if $\left(a_{1}, \cdots, a_{n}\right) \in \mathbb{Z}^{n}, a=\frac{a_{1}+\cdots+a_{n}}{n}$,

$$
\begin{gathered}
I(s)=\frac{\Gamma(s)}{2} \int_{H_{+}^{n-1}} \frac{u_{1}^{a_{1} \cdots u_{n}^{a_{n}}}}{\|u z\|^{2 s}} \frac{d u_{1} \cdots d u_{n-1}}{u_{1} \cdots u_{n-1}}=\int_{H_{+}^{n-1} \times \mathbb{R}_{+}} u_{1}^{a_{1} \cdots u_{n}^{a_{n}} \mathrm{e}^{-\|t u z\|^{2}} t^{2 s} \frac{d u_{1} \cdots d u_{n-1}}{u_{1} \cdots u_{n-1}} \frac{d t}{t} .} \begin{array}{c}
I(s)=\int_{\mathbb{R}_{+}^{n}} \frac{x_{1}^{a_{1} \cdots x_{n}^{a_{n}}}}{\left(x_{1} \cdots x_{n}\right)^{\left(a_{1}+\cdots+a_{n}\right) / n}} \mathrm{e}^{-\|x z\|^{2}}\left(x_{1} \cdots x_{n}\right)^{2 s / n / n} \frac{d x_{1} \cdots d x_{n}}{n x_{1} \cdots x_{n}} \\
I(s)=\frac{1}{n} \prod_{j=1}^{n} \int_{\mathbb{R}_{+}} x_{j}^{a_{j}-\frac{a_{1}+\cdots+a_{n}}{n}+\frac{2 s}{n}} \mathrm{e}^{-\mid z j^{2} x_{j}^{2}} \mathrm{~d}^{\times} x_{j}=\frac{1}{n} \prod_{j=1}^{n} \frac{1}{2} \frac{\Gamma\left(\frac{s}{n}+\frac{a_{j}-a}{2}\right)}{\left|z_{j}\right|^{a_{j}-a+\frac{2 s}{n}} .}
\end{array} . . .
\end{gathered}
$$

In conclusion: $\left(a_{1}, \ldots, a_{n}\right) \in \mathbb{Z}^{n}, z \in \mathbb{C}, a=\left(a_{1}+\cdots+a_{n}\right) / n, \forall j, a_{j}-a+\operatorname{Re}(2 s / n)>0$, we have the Hecke transform

$$
\int_{H_{+}^{n-1}} \frac{u_{1}^{a_{1} \cdots u_{n}^{a_{n}}}}{\|u z\|^{2 s}} \frac{d u_{1} \cdots d u_{n-1}}{u_{1} \cdots u_{n-1}}=\frac{2^{1-n}}{n \Gamma(s)} \prod_{j=1}^{n} \frac{\Gamma\left(\frac{s}{n}+\frac{a_{j}-a}{2}\right)}{\left|z_{j}\right|^{a_{j}-a+\frac{2 s}{n}}} .
$$

Then we get what we want to prove by taking $a_{i}=-2 p_{i}$.
Remark 5.3 This formula works also for any $\left(a_{1}, \cdots, a_{n}\right) \in \mathbb{C}^{n}$ and $s \in \mathbb{C}$ such that $\forall j=1, \cdots, n$, $2 \operatorname{Re}(s)+n a_{j}>a_{1}+\cdots+a_{n}$.

Example 5.4 First of all, we will see one special example, namely the Hecke transform of our plectic Green current

$$
g_{I}^{v}(x, u)=\lim _{\delta \rightarrow 0^{+}} \sum_{n \in I^{*} \backslash\{0\}} \operatorname{sgn}(n)^{v} \frac{e^{2 \pi i \operatorname{Tr}(n x)}}{\|u n\|^{r+\delta}}, \quad x \in F_{\mathbb{R}} / I, u \in U_{\mathbb{R}} .
$$

Theorem 5.5 (Hecke's formula) If $U \subset O_{F,+}^{\times}$is a subgroup of finite index and if $\forall \varepsilon \in U,(\varepsilon-1) \cdot x \in I$, which is equivalent to

$$
x I \in\left(F_{\mathbb{R}} / I\right)^{U},
$$

then

$$
\forall \varepsilon \in U, \quad g_{I}^{v}(x, \varepsilon u)=g_{I}^{v}(x, u) .
$$

Therefore we get

\int_{U_{\mathbb{R}} / U} g_{I}^{v}(x, u) d u=\lim _{\delta \rightarrow 0^{+}} \sum_{n \in\left(I^{*} \backslash\{0\}\right) / U} e^{2 \pi i \operatorname{Tr}(n x)} \int_{U_{\mathbb{R}}} \frac{1}{\|u n\|^{r+\delta}} d u .
$$

By the Hecke transform, we obtain

$$
\int_{U_{\mathbb{R}} / U} g_{I}^{v}(x, u) d u=\frac{2^{r-1} \Gamma(1 / 2)^{r}}{\Gamma(r / 2)} \lim _{\delta \rightarrow 0^{+}} \sum_{n \in\left(I^{*} \backslash\{0\} / U\right)} \operatorname{sgn}(n)^{v} \frac{e^{2 \pi i \operatorname{Tr}(n x)}}{\prod_{j=1}^{r}\left|n_{j}\right|^{(r+\delta) / r}} .
$$

Note that

$$
N(n)=N_{F / \mathbb{Q}}(n)=\prod_{j=1}^{r} n_{j},
$$

hence

$$
\int_{U_{\mathbb{R}} / U} g_{I}^{v}(x, u) d u=\frac{2^{1-r} \Gamma(1 / 2)^{r}}{r \Gamma(r / 2)} \lim _{\delta \rightarrow 0^{+}} \sum_{n \in\left(I^{+} \backslash\{0\}\right) / U} \operatorname{sgn}(n)^{v} \frac{e^{2 \pi i \operatorname{Tr}(n x)}}{|N(n)|^{(r+\delta) / r}} .
$$

It is esay to see that the Hecke transform of the basic plectic Green function with signature delivers a linear combination of special values $L\left(1, \chi_{F}\right)$ for certain Dirichlet characters $\chi_{F}$ of $F$ of signature $v$.

Remark 5.6 From the above theorem, we can see that the Hecke transform can give a natural reinterpretation of Hecke's formula. That is why such a formula is called by Nekovăr̆ and Scholl the Hecke transform.

For any given graph $\Gamma$ and given multiple-signs $v$, the Hecke transform of the higher plectic Green function $\mathscr{I}_{I, v, \Gamma, S}\left(\left\{x_{v}\right\}_{v \in S}, u\right)$ is quite interesting. More revelent details will be presented in the next section.

### 5.2 Reciprocity formula for the Hecke transform

From the expression of the Hecke transform, we observe that when the degree of $F$ is bigger, the higher plectic Green function(current) associated to a given graph becomes more compliqued. However we can always reduce to the case that the rank of the given graph is smaller than the degree of $F$, due to the duality given by the following formula.

Let $L_{1}(u), \ldots, L_{d}(u)$ be linear forms, $u=\left(u_{1}, \ldots, u_{r}\right)$

$$
L_{i}(u)=\sum_{j=1}^{r} L_{i j} u_{j}, \quad L_{i j}>0 .
$$

The dual linear forms

$$
L_{j}^{\star}(t)=\sum_{i=1}^{d} L_{i j} t_{i} .
$$

such that

$$
\sum_{i=1}^{d} L_{i}(u) t_{i}=\sum_{j=1}^{r} L_{j}^{\star}(t) u_{j} .
$$

Definition 5.7 Denote $U_{\mathbb{R}}=\left\{u=\left(u_{1}, \ldots, u_{r}\right) \mid u_{1} \cdots u_{r}=1, u_{j}>0\right\}$, we define

$$
{ }_{d} I_{r}\left(\left\{L_{i}\right\},\left\{\alpha_{i}\right\},\left\{\beta_{j}\right\}\right)=\int_{U_{\mathbb{R}}} \prod_{i=1}^{d} L_{i}(u)^{-\alpha_{i}} \prod_{j=1}^{r} u_{j}^{\beta_{j}} d^{\times} u
$$

Proposition 5.8 (Reciprocity formula for the Hecke transform) [14]

$$
\frac{1}{d}\left(\prod_{i=1}^{d} \Gamma\left(\alpha_{i}\right)\right)\left({ }_{d} I_{r}\left(\left\{L_{i}\right\},\left\{\alpha_{i}\right\},\left\{\beta_{j}\right\}\right)\right)=\frac{1}{r}\left(\prod_{j=1}^{r} \Gamma\left(\beta_{j}^{*}\right)\right)\left(r I_{d}\left(\left\{L_{j}^{*}\right\},\left\{\beta_{j}^{*}\right\},\left\{\alpha_{i}^{*}\right\}\right)\right),
$$

where

$$
\beta_{j}^{*}=\beta_{j}+\frac{|\alpha|-|\beta|}{r}, \quad|\alpha|=\sum_{i=1}^{k} \alpha_{i}, \quad|\beta|=\sum_{j=1}^{r} \beta_{j} .
$$

Example 5.9 If $d=1, L_{1}(u)=\sum_{j=1}^{r} l_{j} u_{j}, l_{j}>0 . \beta_{j}^{*}=\beta_{j}+\frac{\alpha-|\beta|}{r} ; L_{j}^{*}(t)=l_{j} t$. Then by the reciprocity formula, we obtain

\int_{U_{\mathbb{R}}} L_{1}(u)^{-\alpha} \prod_{j=1}^{r} u_{j}^{\beta_{j}} d^{\times} u=\frac{1}{r \Gamma(\alpha)} \prod_{j=1}^{r} \frac{\Gamma\left(\beta_{j}^{*}\right)}{l_{j}^{\beta_{j}^{*}}} .
$$

If $\beta_{j}=0, \forall 1 \leq j \leq r$, then

$$
\int_{U_{\mathbb{R}}} L_{1}(u)^{-\alpha} d^{\times} u=\frac{\Gamma(\alpha / r)^{r}}{r \Gamma(\alpha)}\left(l_{1} \cdots l_{r}\right)^{-\alpha / r} .
$$

Example 5.10 If $d=2, \beta_{j}=0$, for all $j$, then $\beta_{j}^{*}=\frac{\alpha_{1}+\alpha_{2}}{r}$. The reciprocity formula gives us

\int_{U_{\mathbb{R}}} L_{1}(u)^{-\alpha_{1}} L_{2}(u)^{-\alpha_{2}} d^{\times} u=\frac{2 \Gamma\left(\frac{\alpha_{1}+\alpha_{2}}{2}\right)^{r}}{r \Gamma\left(\alpha_{1}\right) \Gamma\left(\alpha_{2}\right)} \int_{\mathbb{R}_{+}}\left(\prod_{j=1}^{r}\left(L_{1 j} s+L_{2 j} s^{-1}\right)^{-\frac{\alpha_{1}+\alpha_{2}}{r}}\right) s^{\alpha_{1}-\alpha_{2}} d^{\times} s .
$$

Relation to Higher Plectic Green functions. In our definition of higher plectic Green function, we use the standard Euclidean norm. Now we will explain how to apply the reciprocity formula to study higher plectic Green functions.

Let $\lambda^{(i)}=\left(\lambda_{1}^{(i)}, \cdots, \lambda_{r}^{(i)}\right) \in \mathbb{R}_{+}^{r}, 1 \leq i \leq d$. If we take $L_{i}(u)=\sum_{j=1}^{r}\left(\lambda_{j}^{(i)}\right)^{2} u_{j}$ and $L_{j}^{*}(s)=\sum_{i=1}^{k}\left(\lambda_{j}^{(i)}\right)^{2} s_{i}$,

$$
L_{i}\left(u^{2}\right)=\sum_{j=1}^{r}\left(\lambda_{j}^{(i)}\right)^{2} u_{j}^{2}=\left\|\lambda^{(i)} u\right\|^{2} .
$$

The following integral appears naturally in the definition of higher plectic Green function associated to a general graph:

$$
\int_{U_{\mathbb{R}}} \prod_{i=1}^{d}\left\|\lambda^{(i)} u\right\|^{-r \sigma_{i}} d^{\times} u=\int_{U_{\mathbb{R}}} \prod_{i=1}^{d} L_{i}\left(u^{2}\right)^{-r \sigma_{i} / 2} d^{\times} u .
$$

Since $d^{\times}\left(u^{2}\right)=2^{r-1} d^{\times} u$, then

\int_{U_{\mathbb{R}}} \prod_{i=1}^{d}\left\|\lambda^{(i)} u\right\|^{-r \sigma_{i}} d^{\times} u=\frac{d}{2^{r-1} r} \frac{\Gamma\left(\frac{\sigma_{1}+\cdots+\sigma_{r}}{2}\right)}{\prod_{i=1}^{d} \Gamma\left(r \sigma_{i} / 2\right)} \int_{s_{1} \cdots s_{k}=1}\left(\prod_{j=1}^{r} L_{j}^{*}(s)\right)^{-\frac{\sigma_{1}+\cdots+\sigma_{r}}{2}} \prod_{i=1}^{d} s_{i}^{r \sigma_{i} / 2} d^{\times} s
$$

Example $5.12 d=1$. Let $\lambda=\left(\lambda_{1}, \cdots, \lambda_{r}\right)$, then

$$
\int_{U_{\mathbb{R}}}\|\lambda u\|^{-r \sigma} d^{\times} u=\frac{\Gamma(\sigma / 2)^{r}}{2^{r-1} r \Gamma(r \sigma / 2)} \frac{1}{\left(\lambda_{1} \cdots \lambda_{r}\right)^{\sigma}}=\frac{\Gamma(\sigma / 2)^{r}}{2^{r-1} r \Gamma(r \sigma / 2)} N(\lambda)^{-\sigma} .
$$

This result has already been seen in Theoem 5.5 of the Hecke formula.
Example 5.13 (1) $d=2, L_{j}^{\star}(s)=\left(\lambda_{j}^{(1)}\right)^{2} s+\left(\lambda_{j}^{(2)}\right)^{2} s^{-1}$.

\int_{U_{\mathbb{R}}}\left\|\lambda^{(1)} u\right\|^{-r \sigma_{1}}\left\|\lambda^{(2)} u\right\|^{-r \sigma_{2}} d^{\times} u=\frac{\Gamma\left(\frac{\sigma_{1}+\sigma_{2}}{2}\right)}{2^{r-2} r \Gamma\left(r \sigma_{1} / 2\right) \Gamma\left(r \sigma_{2} / 2\right)} \int_{\mathbb{R}_{+}}\left(\prod_{j=1}^{r}\left(\left(\lambda_{j}^{(1)}\right)^{2} s+\left(\lambda_{j}^{(2)}\right)^{2} s^{-1}\right)\right)^{-\frac{\sigma_{1}+\sigma_{2}}{2}} s^{r\left(\sigma_{1}-\sigma_{2}\right) / 2} d^{\times} s
$$

(2) If $r=2, F$ is a real quadratic field.

$$
\int_{U_{\mathbb{R}}} \prod_{i=1}^{d}\left\|\lambda^{(i)} u\right\|^{-2 \sigma_{i}} d^{\times} u=\frac{1}{2} \int_{U_{\mathbb{R}}} \prod_{i=1}^{d} L_{i}(u)^{-\sigma_{i}} d^{\times} u=\int_{\mathbb{R}_{+}} \prod_{i=1}^{d}\left(\left(\lambda_{1}^{(i)}\right)^{2} u+\left(\lambda_{2}^{(i)}\right)^{2} u^{-1}\right)^{-\sigma_{i}} d^{\times} u .
$$

From the two cases above, it is easy to observe the duality between $d=2$ and $r=2$, by the explicit expression of the two integrals. Therefore we can easily interchange $d$ and $r$ for getting the case of $d \geq r$.

Moreover, in next paragraph we will explain that we only need to take into account the case of $d=r$, thanks to a formula of Sczech generalizing Eisenstein's trick for $G L_{n}$.

### 5.3 Sczech's rational functions and Eisenstein cocycles

### 5.3.1 Introduction

R. Sczech [16] constructed a group cocycle $\Psi$ on the unimodular group $G L_{n} \mathbb{Z}$, called the Eisenstein cocycle, which represents a nontrivial cohomology class in $H^{n-1}\left(G L_{n} \mathbb{Z}, M\right)$ with values in a function space $M$. Restricting $\Psi$ on some subgroup $W$ of totally positive units and evaluating the elements of $M$ on $W$-invariant points, one get obtain a sequence of rational cohomology classes $\eta(b, f ; s) \in H^{n-1}(W, \mathbb{Q}), s=1,2, \ldots$ By evaluation on some fundamental cycle in $H_{n-1}(W, \mathbb{Z})$, these rational classes $\eta(b, f ; s)$ give rise to the numbers of partial zeta function associated with the ray class $b \bmod f$

$$
\zeta(b, f ; 1-s)=\sum_{a \equiv b(f)} N(a)^{-(1-s)}, \quad \operatorname{Re}(s)>1,
$$

where $a$ runs over all integral ideals in the ring of integers $O_{F}$ of a totally real field $F$, such that $a b^{-1}$ is a principal ideal generated by a totally positive number in the coset $1+f b^{-1}$. The Eisenstein cocycle $\Psi$ is universal in the sense that it parametrizes all the special values of Hecke L-functions in every totally real number field of degree $r$, which are known to be either an algebraic number or an algebraic number times a power of $\pi$.

Sczech's construction begins with the rational function

$$
f(\xi)(x)=\frac{\operatorname{det}\left(\xi^{(1)}, \cdots, \xi^{(r)}\right)}{\left(x, \xi^{(1)}\right) \cdots\left(x, \xi^{(r)}\right)},
$$

where $x=\left(x_{1}, \ldots, x_{r}\right) \in \mathbb{R}^{r}$ is a row vector and $\xi^{(i)} \in \mathbb{R}^{r}$ are $r$ nonzero column vectors and $\left(x, \xi^{(i)}\right)=$ $\sum x_{j} \xi_{j}^{(i)}$. This function is well-defined outside the hyperplanes $\left(x, \xi^{(i)}\right)=0$. Given a homogenous polynomial $P\left(X_{1}, \cdots, X_{r}\right)$, we apply the differential operator $P\left(-\partial_{x_{1}}, \cdots,-\partial_{x_{r}}\right)$ to $f(\xi)(x)$.

Definition 5.14 We define the general national function

$$
f(\xi)(P, x)=P\left(-\partial_{x_{1}}, \cdots,-\partial_{x_{r}}\right) f(\xi)(x),
$$

where $\partial_{x_{j}}$ denotes the partial derivative with respect to the variable $x_{j}$.
Sczech gave several elementary observations about this national function.
Lemma 5.15 [16]

$$
\sum_{i=0}^{r}(-1)^{i} f\left(\xi^{(0)}, \cdots, \widehat{\xi^{(i)}}, \cdots, \xi^{(r)}\right)=0 .
$$

For $A \in G L_{r}(\mathbb{R})$,

$$
\begin{gathered}
f\left(A \xi^{(1)}, \cdots, A \xi^{(r)}\right)(x)=\operatorname{det}(A) f\left(\xi^{(1)}, \cdots, \xi^{(r)}\right)(x A), \\
A f(\xi)=f(A \xi) .
\end{gathered}
$$

Formula 5.16

$$
P\left(-\partial_{x_{1}}, \cdots,-\partial_{x_{r}}\right) \sum_{i=0}^{r}(-1)^{i} f\left(\xi^{(0)}, \cdots, \widehat{\xi^{(i)}}, \cdots, \xi^{r}\right)(x)=0
$$

therefore

$$
\sum_{i=0}^{r}(-1)^{i} f\left(\xi^{(0)}, \cdots, \widehat{\xi^{(i)}}, \cdots, \xi^{(r)}\right)(P, \cdot)=0 .
$$

In fact, we will recover the Eisenstein trick from the above formulas in the case $r=2$. Now we will explain the relation between Sczech's rational function $f(\xi)(x)$ and our higher plectic Green function $\mathscr{G}_{1, v, \Gamma, S}\left(\left\{x_{v}\right\}_{v \in S}, u\right)$, and will explain how to reduce to the case of $d=r$ of the integral

$$
\begin{equation*}
\int_{U_{\mathbb{R}}} \prod_{i=1}^{d}\left\|\lambda^{(i)} u\right\|^{-r \sigma_{i}} d^{\times} u=2^{1-r} \int_{U_{\mathbb{R}}} \prod_{i=1}^{d} L_{i}(u)^{-r \sigma_{i} / 2} d^{\times} u \tag{5}
\end{equation*}
$$

as we have mentioned at the end of previous section.
We always assume that $r \sigma_{i} / 2 \in \mathbb{N}$ for all $1 \leq i \leq d$. So if $r \in 2 \mathbb{N}$, then $\sigma_{i} \in \mathbb{N}$; if $r \in 2 \mathbb{N}+1$, then $\sigma_{i} \in 2 \mathbb{N}_{+}$.

Before that, we will give a more general definition of Sczech's rational function.
Definition 5.17 Let $\underline{a}=\left(a_{1}, \cdots, a_{r}\right) \in \mathbb{N}_{+}^{r}, b \in \mathbb{N}_{+}$. We define

$$
f(\xi)(x ; \underline{a}, b)=\frac{\left(\operatorname{det}\left(\xi^{1}, \cdots, \xi^{r}\right)\right)^{b}}{\left(x, \xi^{1}\right)^{a_{1} \ldots\left(x, \xi^{r}\right)^{a_{r}}}}
$$

In fact, we can show that $f(\xi)(x ; \underline{a}, b)$ can be realized as $f(\xi)\left(P_{l}, x\right)$ for a carefully chosen homogenous polynomial $P_{l}$.

First of all, we will consider the simple case when $r=2$.
Example 5.18 We define two homogenous polynomials of degree 2.

\end{aligned}

& f(\xi)\left(P_{1 ; \xi}, x\right)=P_{1 ; \xi}\left(-\partial_{x_{1}},-\partial_{x_{2}}\right) f(\xi)(x)=\frac{\left(\operatorname{det}\left(\xi^{(1)}, \xi^{(2)}\right)\right)^{2}}{\left(x, \xi^{(1)}\right)^{2}\left(x, \xi^{(2)}\right)}=f(\xi)(x ;(2,1), 2), \\
& f(\xi)\left(P_{2 ; \xi}, x\right)=P_{2 ; \xi}\left(-\partial_{x_{1}},-\partial_{x_{2}}\right) f(\xi)(x)=\frac{\left(\operatorname{det}\left(\xi^{(1)}, \xi^{(2)}\right)\right)^{2}}{\left(x, \xi^{(1)}\right)\left(x, \xi^{(2)}\right)^{2}}=f(\xi)(x ;(1,2), 2) .
\end{aligned}
$$

Therefore we obtain that

\frac{P_{1 ; \xi}^{a_{1}}\left(-\partial_{x_{1}},-\partial_{x_{2}}\right)}{a_{1}!} \frac{P_{2 ; \xi}^{a_{2}}\left(-\partial_{x_{1}},-\partial_{x_{2}}\right)}{a_{2}!} f(\xi)(x)=\frac{\left(\operatorname{det}\left(\xi^{1}, \xi^{2}\right)\right)^{a_{1}+a_{2}+1}}{\left(x, \xi^{1}\right)^{a_{1}+1}\left(x, \xi^{2}\right)^{a_{2}+1}}=f(\xi)\left(x ;\left(a_{1}+1, a_{2}+1\right), a_{1}+a_{2}+1\right) .
$$

If we denote

P_{a_{1}-1, a_{2}-1 ; \xi}\left(X_{1}, X_{2}\right)=\frac{P_{1}^{a_{1}-1}}{\left(a_{1}-1\right)!} \frac{P_{2}^{a_{2}-1}}{\left(a_{2}-1\right)!},
$$

then

f(\xi)\left(x ;\left(a_{1}, a_{2}\right), a_{1}+a_{2}-1\right)=P_{a_{1}-1, a_{2}-1 ; \xi}\left(-\partial_{x_{1}}, \partial_{x_{2}}\right) f(\xi)(x)=f(\xi)\left(P_{a_{1}-1, a_{2}-1 ; \xi}, x\right)
$$

For general $r$. Let

$$
\xi=\left(\xi^{(1)}, \xi^{(2)}, \cdots, \xi^{(r)}\right)
$$

be the invertible matrix with columns $\xi^{(i)}$, then denote a new column vector $\left(y_{1}, \cdots, y_{r}\right)^{\top}$, where

y_{l}=\frac{\operatorname{det}(\boldsymbol{\xi})}{\left(x, \boldsymbol{\xi}^{(1)}\right) \cdots\left(x, \boldsymbol{\xi}^{(l)}\right)^{2} \cdots\left(x, \boldsymbol{\xi}^{(r)}\right)} .
$$

We have a linear equation

\xi \cdot\left(y_{1}, \cdots, y_{r}\right)^{\top}=\left(-\partial_{x_{1}} f(\xi)(x), \cdots,-\partial_{x_{r}} f(\xi)(x)\right)^{\top} .
$$

This equation has a unique solution, then we can a unique expression of each $y_{l}$, namely

\left(y_{1}, \cdots, y_{r}\right)^{\top}=\xi^{-1} \cdot\left(-\partial_{x_{1}} f(\xi)(x), \cdots,-\partial_{x_{r}} f(\xi)(x)\right)^{\top} . \\
\xi^{-1}=\frac{1}{\operatorname{det}(\xi)} C_{\xi}^{\top},
\end{gathered}
$$

where $C_{\xi}=\left(C_{\xi}(i j)\right)_{1 \leq i, j \leq r}$ is the adjoint matrix of $\xi$.
Therefore there exist $r$ homogenous polynomials of degree 1

P_{1 ; \xi}\left(X_{1}, \cdots, X_{r}\right), \ldots, P_{r ; \xi}\left(X_{1}, \cdots, X_{r}\right),
$$

where

$$
P_{l ; \xi}\left(X_{1}, \cdots, X_{r}\right)=\frac{C_{\xi}(1 l) X_{1}+\cdots+C_{\xi}(r l) X_{r}}{\operatorname{det}(\xi)}, \quad 1 \leq l \leq r .
$$

which depend on the matrix $\xi$ and such that

$$
y_{l}=\frac{\operatorname{det}(\xi)}{\left(x, \xi^{1}\right) \cdots\left(x, \xi^{l}\right)^{2} \cdots\left(x, \xi^{r}\right)}=P_{l ; \xi}\left(-\partial_{x_{1}}, \cdots,-\partial_{x_{r}}\right) f(\xi)(x)=f(\xi)\left(P_{l ; \xi}, x\right), \quad \forall 1 \leq l \leq r .
$$

Continuing the calculation, denote

$$
P(\underline{X} ; \underline{a} ; \xi)=\frac{P_{1 ; \xi}^{a_{1}-1}(\underline{X})}{\left(a_{1}-1\right)!} \frac{P_{2 ; \xi}^{a_{2}-1}(\underline{X})}{\left(a_{2}-1\right)!} \cdots \frac{P_{r ; \xi}^{a_{r}-1}(\underline{X})}{\left(a_{r}-1\right)!},
$$

where $\underline{X}=\left(X_{1}, \cdots, X_{r}\right)$. Hence we obtain

## Formula 5.19

f(\xi)(x ; \underline{a}, 1)=\frac{\operatorname{det}(\xi)}{\left(x, \xi^{(1)}\right)^{a_{1}}\left(x, \xi^{(2)}\right)^{a_{2}} \ldots\left(x, \xi^{(r)}\right)^{a_{r}}}=P\left(-\partial_{x_{1}}, \cdots,-\partial_{x_{r}} ; \underline{a} ; \xi\right) f(\xi)(x) .
$$

Now we consider $r+1$ column vectors $\xi^{(0)}, \ldots, \xi^{(r)}$. By Lemma 5.15,

hence we obtain
Lemma 5.20
where $\underline{a}=\left(a_{1}, \ldots, a_{r}\right) \in \mathbb{N}_{+}^{r}$.
The right hand side of the formula in Lemma 5.20 can be written as a finite linear combination of

(\text { Constant }) \times \frac{\operatorname{det}\left(\xi^{(\hat{i})}\right)}{\left.\left(x, \xi^{(0)}\right)^{b_{1} \ldots\left(x, \boldsymbol{\xi}^{(i)}\right.}\right)^{b_{i} \ldots\left(x, \xi^{(r)}\right)^{b_{r}}}}, \quad i \geq 1, \quad b_{i} \in \mathbb{N}_{+} .

### 5.3.2 Sczech's rational function and higher plectic Green functions.

Now we denote $\left(\lambda^{(i)}\right)^{2}=\left(\left(\lambda_{1}^{(i)}\right)^{2}, \cdots,\left(\lambda_{r}^{(i)}\right)^{2}\right)^{\top} \in \mathbb{R}_{+}^{r}$ as a column vector and denote $\underline{\lambda}^{2}=\left(\left(\lambda^{(1)}\right)^{2}, \cdots,\left(\lambda^{(d)}\right)^{2}\right) \epsilon$ $\operatorname{Mat}_{r \times d}\left(\mathbb{R}_{+}\right)$and $u=\left(u_{1}, \cdots, u_{r}\right) \in \mathbb{R}_{+}^{r}$ with $u_{1} \cdots u_{r}=1$ as a row vector. Hence

L_{i}(u)=\sum_{j=1}^{r} u_{j}\left(\lambda_{j}^{(i)}\right)^{2}=\left(u,\left(\lambda^{(i)}\right)^{2}\right) .

In general for the definition for our higher plectic Green function, we have

\left.\prod_{i=1}^{r} L_{i}(u)^{-r \sigma_{i} / 2}=\frac{1}{\prod_{i=1}^{r}\left(u,\left(\lambda^{(i)}\right)^{2}\right)^{r \sigma_{i} / 2}}=\operatorname{det}\left(\left(\lambda^{(1)}\right)^{2}, \cdots,\left(\lambda^{(r)}\right)^{2}\right)\right)^{-1}\left(f\left(\underline{\lambda}^{2}\right)(u ; r / 2 \underline{\sigma}, 1)\right),
$$

where $\underline{\sigma}=\left(\sigma_{1}, \cdots, \sigma_{r}\right)$.
Moreover if $\sigma_{i}=\sigma \quad(\forall 1 \leq i \leq d=r)$, then

\left.\prod_{i=1}^{r} L_{i}(u)^{-r \sigma / 2}=\operatorname{det}\left(\left(\lambda^{(1)}\right)^{2}, \cdots,\left(\lambda^{(r)}\right)^{2}\right)\right)^{-r \sigma / 2}\left(f\left(\underline{\lambda}^{2}\right)(u)\right)^{r}
$$

## By the reciprocity of $d$ and $r$, we can assume that $d \geq r$.

## Now we will show that we can reduce to the case $d=r$.

Remark 5.21 There are several method to do such a reduction. We can do the reduction in a general setting, for arbitray linear forms $L_{i}(u)=\sum_{j=1}^{r} L_{i j} u_{j}, \quad 1 \leq i \leq d$ and for arbitary exponents $\underline{m}=\left(m_{1}, \ldots, m_{d}\right)$. However for now we will only focus on the reduction for $L_{i}(u)=\left(u,\left(\lambda^{(i)}\right)^{2}\right)$ and for $\underline{m}=(r / 2) \underline{\sigma}$ as in the begining of this section.
(1) Method I (a) If $d=r+1$.

$$
\prod_{i=1}^{r+1} L_{i}(u)^{-r \sigma_{i} / 2}=\frac{1}{\prod_{i=1}^{r+1}\left(u,\left(\lambda^{i}\right)^{2}\right)^{r \sigma_{i}}} .
$$

By Lemma 5.20, we have the following relation

\frac{\operatorname{det}\left(\xi^{\hat{1}}\right)}{\left(x, \xi^{2}\right)^{a_{2}}\left(x, \xi^{3}\right)^{a_{3}} \cdots\left(x, \xi^{r+1}\right)^{a_{r+1}}}=\sum_{i=2}^{r+1}(-1)^{i} P\left(-\partial_{x_{1}}, \cdots,-\partial_{x_{r}} ; a ; \xi^{\hat{1}}\right) f\left(\xi^{1}, \cdots, \widehat{\xi}^{i}, \cdots, \xi^{r+1}\right)(x) .
$$

Take

\xi=\underline{\lambda^{2}}, \quad x=u=\left(u_{1}, \cdots, u_{r}\right), \quad \underline{a}=(r / 2) \underline{\sigma^{0}}=(r / 2)\left(\sigma_{2}, \cdots, \sigma_{r+1}\right) .
$$

then we obtain

\frac{\left.\operatorname{det}\left(\left(\lambda^{2}\right)^{2}, \cdots,\left(\lambda^{r+1}\right)^{2}\right)\right)}{\prod_{i=2}^{r+1}\left(u,\left(\lambda^{i}\right)^{2}\right)^{r \sigma_{i} / 2}}=\sum_{i=2}^{r+1}(-1)^{i} P\left(-\partial_{u_{1}}, \cdots,-\partial_{u_{r}} ;(r / 2) \underline{\sigma^{0}} ;\left(\lambda^{2}\right)^{\hat{1}}\right) f\left(\left(\lambda^{1}\right)^{2}, \cdots, \overline{\left(\lambda^{i}\right)^{2}}, \cdots,\left(\lambda^{r+1}\right)^{2}\right)(u) .
$$

Therefore

$$
\prod_{i=1}^{r+1} L_{i}(u)^{\frac{-r \sigma_{i}}{2}}=\sum_{i=2}^{r+1}(-1)^{i} \frac{1}{\left.\operatorname{det}\left(\left(\lambda^{2}\right)^{2}, \cdots,\left(\lambda^{r+1}\right)^{2}\right)\right)} \frac{P\left(-\partial_{u_{1}}, \cdots,-\partial_{u_{r}} ; \frac{r}{2} \underline{\sigma^{0}} ;\left(\underline{\lambda^{2}}\right)^{\hat{1}}\right) f\left(\left(\lambda^{1}\right)^{2}, \cdots, \overline{\left(\lambda^{i}\right)^{2}}, \cdots,\left(\lambda^{r+1}\right)^{2}\right)(u)}{\left(u,\left(\lambda^{1}\right)^{2}\right)^{\frac{\sigma \cdot l_{1}}{2}}} .
$$

Now combining with Formula 5.11 and 5, we have

\left.\int_{U_{\mathbb{R}}} \prod_{i=1}^{r+1}\left\|\lambda^{(i)} u\right\|^{-r \sigma_{i}} d^{\times} u=2^{1-r} \sum_{i=2}^{r+1}(-1)^{i} \int_{U_{\mathbb{R}}} \frac{P\left(-\partial_{u_{1}}, \cdots,-\partial_{u_{r}} ; \frac{r}{2} \underline{\sigma}^{0} ;\left(\lambda^{2}\right)^{\hat{1}}\right) f\left(\left(\lambda^{1}\right)^{2}, \cdots, \overline{\left(\lambda^{i}\right)^{2}}, \cdots,\left(\lambda^{r+1}\right)^{2}\right)(u)}{\left(u,\left(\lambda^{1}\right)^{2}\right)^{\frac{r_{0}}{2}}} \operatorname{det}\left(\left(\lambda^{2}\right)^{2}, \cdots,\left(\lambda^{r+1}\right)^{2}\right)\right) .
$$

It is easy to see that RHS is a finite linear combination of case $d=r$.

## (b) If $d>r+1$.

It is not difficult to obtain the same result by induction using $(d-r)$ times Lemma 5.20.

Remark 5.22 Even though, this method can give a resolution for the reduction. But it increases the complexity of calculation of Hecke transform. Now we will the second method, which simply bases on Sczech's cocycle relation.

on the left branch of the tree, $(a, b, c)$ (which signifies $\left.\frac{1}{L_{1}^{a}(u) L_{2}^{b}(u) L_{3}^{c}(u)}\right) \longrightarrow(a-1, b, c+1)$ ( which denotes $\left.\frac{1}{L_{1}^{a-1}(u) L_{2}^{b}(u) L_{3}^{c+1}(u)}\right)$ and the final fraction should be multiplied by $(-1) C_{2}$; on the right branch, $(a, b, c) \longrightarrow(a, b-1, c+1)$ and the final fraction should be multiplied by $C_{1}$. The $i$-depth of the tree describes the situation after i-times appliction of the cocyle relation. For example, the first depth of the tree gives us

Further reduction. It turns out that the essential part in the definition of Higer plectic Green function

Remark 5.29 For this further reduction, we will begin with a general setting, which means we can begin with $d \geq r$ linear forms with arbitary exponents and reduce to the case of trivial exponents. Our first reduction theorem built upon cocycle relations can give another point of view, and also make a connection with our traitement for $F=\mathbb{Q}$.

In the next section, we will give the details of the calculation, and therefore give an expression for higher plectic Green functions and generalized multiple zeta values for general totally real fields.

### 5.4 Generalized multiple zeta values for general $F(\mathbf{I})$ : special cases

For a general $F$, already the Hecke transform in Definition 4.11 leads to non-trivial integral formulas. The resulting numbers are given by the usual $L$-values of $F$ in the simplest possible case when $\Gamma$ is a chain (thanks to Proposition 4.9). After that, everything turns out to be much more complicated than any naive attempt at defining MDZV would produce. For example, if $F$ is a real quadratic field ( $r=2$ ), then the terms of the infinite series defining $Z_{I}(\Gamma, S)$ do not necessarily involve only rational functions of the components of the $n_{e} \in I^{*}$, but sometimes also their logarithms. If $F$ is a cubic field, there are also terms involving dilogarithm, and for higer rank field, some non-trivial iterated integrals make their appeareance.

Before illustrating how the Hecke transform produces these new functions, we will give a very vague version of our main theorem.

Theorem 5.36 (Main result over general totally real field-vague version) Let $F$ be a totally real field of degree $[F: \mathbb{Q}]=r>1$. Given a graph and a subdivision map defined as before. By the reciprocity, we can assume the rank of the graph $d \geq r$. Moreover, we assume that if $2+r$, the subdivision map is given by $k_{e} \in 2 \mathbb{N}$ for each edge. According to the two reduction theorems Theorem 5.27 and Theorem 5.33 and Theorem 5.61, we have the following expression of our generalized multiple zeta value

C(d, r)}} \sum_{1 \leq m \leq r-1} \sum_{j}\left(\alpha_{j}\left(n_{e}\right)\right) \mathscr{L}_{m}\left(\beta_{j}\left(n_{e}\right)\right),
$$

where $\mathscr{L}_{m}(\cdot)$ is an generalized m-logarithm which is a non-trivial iterated integral, and $\alpha_{j}\left(n_{e}\right)$ and $\beta_{j}\left(n_{e}\right)$ are rational functions of the conjugates of $n_{e}$ with coefficients in $\mathbb{Q}$ and the sum $\sum_{C(d, r)}$ comes from the reduction theorem. Every sum here is finite.

## Calculation of a special integral.

When we take $m=|\underline{k}|$, we will get the result of $I_{2}(d, \underline{k})$.
Now let us give one simplest example of $2+|\underline{k}|$.

Remark 5.56 The passage from the result of case $r=3$ to the case of $r=4$ can be generalized to any $r \geq 2$. Such a recurrence relation inspires us to do a general calculation for any general $r \geq 2$. We will theorefore give a definition of so-called generalized m-polylogarithms over a totally real field $F$. However, the coefficients such as $R_{i j k}^{(4)}$ are very inconvenient for general $r$, thus we will give a general definition of these coefficients in a uniform way.

### 5.5 Generalized multiple zeta values for general $F$ (II): general case

In this section we assume that a totally real field $F$ is of degree $r>2$. Let us begin the preparation for the general calculation and the definition of generalized polylogarithms over $F$.

### 5.5.1 Preliminaries

Definition 5.57 Let us define the set

## Theorem 5.61 (General expression of the basic integral of the Hecke transform)

Proof 5.5.2 We will prove this theorem by mathematical induction.
The first step. Theorem 5.39, Theorem 5.45 and Theorem 5.52 imply this theorem when $r=2,3$, 4, respectively.

The inductive step. We suppose that the theorem holds when $r \leq k-1$, now we will prove when $r=k(k \geq 3)$. From Theorem 5.60 and the inductive hypothesis, we can deduce that

## 6 The values $\mathscr{Z}_{I, F}(\Gamma, S)$ and the cohomology of congruence subgroups of $S L_{m}\left(O_{F}\right)$

Francis Brown formulated a program about the modularity of mixed motives [3], with the purpose to generalize multiple zeta values and special values of $L$-functions of modular forms at all integers. In Brown's observation, there exsits a modular phenomena in the ring of multiple zeta values relating a mysterious depth filtration. He proposed that a geometric understanding of these phenomena should put multiple zeta values and modular form for $S L_{2}(\mathbb{Z})$ in the same framework.

where $\Gamma$ is a subgroup of $S L_{2}(\mathbb{Z})$ with finite index, and $\mathscr{G}_{\Gamma}$ is relative completion of $S L_{2}$ respect to $\Gamma$. MMVs signifies multiple modular values, which are regularized iterated integrals of modular forms on an orbifold $\Gamma \backslash \backslash \mathcal{H}$ and are also periods of the hypertherical Tannakian category $\mathscr{M} \mathscr{M} \mathscr{M}_{\Gamma}$ of mixed modular motives.
$\mathscr{M} \mathscr{T}(\mathbb{Z})$ is the mixed Tate motives over $\mathbb{Z}$, and the category $\mathscr{M} \mathscr{M} \mathscr{M}_{\Gamma}$ should be generated by iterated extension of motives of modular forms.

Remark 6.1 We want to give some remarks on Brown's MMVs and Goncharov's Hodge correlators. If $g$ is a cusp form for $S L_{2}(\mathbb{Z})$, then the special value $L(g, n) \times(2 \pi i)^{?}$ is a multiple modular value for $S L_{2}(\mathbb{Z})$, and is also a period in the sense of Kontsevich- Zagier. Goncharov's Hodge correlators contain the special values $L(f, n)$ of modular forms for $G L_{2}(\mathbb{Q})$ of weight $k \geq 2$, outside of critical strip. In fact the simplest Hodge correlators in this case coincide with the Rankin-Selberg integrals for $L(f, n)$.

We could ask if our generalized multiple zeta values can be immerged into such a program.
We begin with the classical problem, studied by Gangl-Kaneko-Zagier and Goncharov.
Recall the work of Gangl-Kaneko-Zagier and Goncharov's results. For this section we suppose that the field $F$ is an imaginary quadratic field. We will show that our generalized multiple zeta value, for an imaginary quadratic field, could also be a good candidant as being multiple Eisenstein series, with the hope to be related to some non-holomorphic new modular forms. We recall the theorem 6 in [4].
