### Abstract

*Actinobacteria* are important bacterial group participating in various ecosystem processes particularly in the decomposition of complex organic compounds. Their abilities enable them to surviving in harsh conditions of oligotrophic habitats like lakes, deserts, cave walls or recalcitrant and resistant litter in soil, where *Actinobacteria* often dominate. Although certain biotic and abiotic factors were recognized to modulate *Actinobacteria* incidence in such habitats, the influence of anthropogenic pressure on their communities is scarcely known. The main objective of this thesis is therefore to determine differences of *Actinobacteria* communities under the direct (the human visitors changing microenvironment of caves, **part 1**) and indirect (climate change factors like altered precipitation or plant litter quality, **part 2**) anthropogenic influence in two habitats, plant litter in soil and cave walls, where *Actinobacteria* play important roles and dominate.

In a first part of the thesis we monitored *Actinobacteria* communities in French limestone caves walls differently affected by humans (pristine versus anthropized caves). For identification of important species like potential pathogens or pigments producing *Actinobacteria* using amplicon sequencing of environmental DNA (Illumina MiSeq), we firstly used a molecular marker gene *hsp*65 coding for heat shock protein specific for *Actinobacteria*. Special attention was payed to anthropogenically most affected Lascaux Cave with Paleolithic paintings. There, a comparison of different rooms differently affected by a human-derived intervention as well as between visual dark marks and unmarked areas on the wall paintings were compared (**paper I**). In the second part, we monitored litter *Actinobacteria* communities during a decomposition process under manipulated precipitation (**paper IV**), on different litter type, quality and origin (**papers II**, **III**, **IV**) in different forests including Mediterranean oak and pine forests (**paper IV**), mountainous spruce and beech forests (**paper III**), a beech temperate forest (**paper II**) and also one grassland (**paper II**).

Our results show that *Actinobacteria* communities were strongly dependent to anthropized/pristine status of caves (**Part 1**) as well as climatic and litter quality changes during the decomposition (**Part 2**). In caves (**Part 1**), *Actinobacteria* community structure indicated the anthropogenic disturbance, because typical pristine and anthropogenic taxa identified according to the *hsp*65 marker were recovered in relation to an anthropization status (**paper I**). Moreover, the dominance of *Streptomyces* was found in the area with visual dark marks

suggesting the marked areas were factor influencing this group (paper I). During decomposition (part 2), we found that *Actinobacteria* were i) affected by litter type regardless its origin but their dominance on recalcitrant litter type did not result in faster decomposition (papers II, III, IV), ii) not directly affected by climatic conditions (paper III, IV) but were site-specific (papers II, III, IV) with a potential to dominate introduced coniferous forests (papers III, IV), and iii) in decomposition process had opposite strategies to fungi, since were influenced by different conditions than fungi (papers II, III, IV). Overall, *Actinobacteria* respond to anthropogenic pressure on a community and species level and are also able to adapt to harsh conditions and thus, these changes leading to *Actinobacteria* persistence in ecosystems. Consequently, *Actinobacteria* might be considered as stress-tolerant microbes, which may also benefit from man-made disturbances.

#### Abstrakt (In Czech)

*Actinobacteria* jsou významnou bakteriální skupinou účastnící se různých ekosystémových procesů, zejména při rozkladu komplexních organických sloučenin. Jejich schopnosti jim umožňují přežít v drsných podmínkách oligotrofních habitatů, jako jsou jezera, pouště, stěny jeskyní nebo odolný a nerozložitelný rostlinný opad v půdě, kde aktinobakterie často dominují. Ačkoliv jsou známy určité biotické a abiotické faktory ovlivňující výskyt aktinobakterií v těchto habitatech, vliv antropogenního tlaku na jejich společenstvo je zřídka znám. Hlavním cílem této práce je tedy určit rozdíly v aktinobakteriálních společenstvech pod přímým (lidští návštěvníci měnící mikroenvironmentální prostředí jeskyň, **část 1**) a nepřímým (faktory klimatické změny jako jsou změny srážek nebo kvality rostlinného opadu, **část 2**) vlivem člověka ve dvou habitatech, rostlinném opadu v půdě a stěnách jeskyň, kde aktinobakterie hrají významnou roli a kde dominují.

V první části disertace jsme sledovali aktinobakteriální společenstva na zdech francouzských vápencových jeskyní odlišně ovlivněných člověkem (přírodní versus antropizované jeskyně). K identifikaci významných druhů (např. potenciálních patogenů nebo pigmenty produkujících aktinobakterií) pomocí amplikonového sekvenování environmentální DNA (Illumina MiSeq), jsme poprvé použili gen molekulárního markeru *hsp*65 kódující protein teplotního šoku (heat shock protein) specifický pro aktinobakterie. Zvláštní pozornost byla věnována antropogenně nejvíce zasažené jeskyni Lascaux s Paleolitickými malbami. V této jeskyni byly porovnány různé místnosti odlišně ovlivněné zásahem člověka a také byly porovnány tmavá místa mikrobiálního původu nacházející se na nástěnných malbách (článek I). Ve druhé části jsme se zaměřili na společenstva aktinobakterií během rozkladného procesu pod vlivem změny srážek (článek IV), na různém typu opadu s odlišným původem a s různou kvalitou (články II, III, IV) v různých lesích včetně středozemního bukového lesa mírného pásma (článek II) a také stepi (článek II).

Naše výsledky ukazují, že aktinobakteriální společenstvo bylo silně závislé na antropogenním/přirodním stavu jeskyň (část 1) stejně jako na klimatických změnách a změnách v kvalitě opadu během rozkladu (část 2). Struktura společenstva aktinobakterií v jeskyních (část 1) indikovala antropogenní narušení, protože typické přírodní a antropogenní skupiny byly identifikované (pomocí *hsp*65 markeru) právě ve vztahu k antropogennímu/přírodnímu

stavu jeskyň (článek I). Navíc bylo zjištěno, že *Streptomyces* dominují v oblastech s tmavými místy což naznačuje, že tato tmavá místa jsou faktorem ovlivňujícím tuto skupinu aktinobakterií (článek I). Během rozkladného procesu (část 2) jsme zjistili, že aktinobakterie i) byly ovlivněny typem opadu nehledě na jeho původu, ale jejich dominance na nerozložitelném opadu nevedla k rychlejšímu rozkladu (články II, III, IV), ii) nebyly přímo ovlivněny klimatickými podmínkami (články II, IV), ale byly habitat-specifické (články II, III, IV) s potenciálem dominovat zavlečeným jehličnatým lesům (články III, IV), a iii) během rozkladného procesu měly opačné strategie než houby, jelikož byly ovlivněny jinými podmínkami prostředí (články II, III, IV). Aktinobakterie reagují na antropogenní tlak na úrovni společenstva i druhu a jsou také schopné adaptovat se na nehostinné podmínky, a proto tyto změny vedou k perzistenci aktinobakterií v ekosystémech. V důsedku toho mohou být aktinobakterie považovány za mikroorganismy tolerantní vůči stresu, které mohou mít výhodu ze změn způsobených člověkem.

#### **Résumé (In French)**

Les actinobactéries sont un groupe bactérien important participant dans plusieurs processus écosystémiques comme la décomposition de composés organiques. Les actinobactéries possèdent des nombreuses capacités leur permettant de survivre dans des conditions difficiles comme celles retrouvées dans des habitats oligotrophes tels que les lacs, déserts, parois des grottes ou la litière végétale récalcitrante du sol où les actinobactéries dominent. Bien que certains facteurs biotiques et abiotiques ont été reconnus comme modulateurs de l'incidence des actinobactéries dans ces écosystèmes, l'influence des conditions changeantes provoquées par la pression anthropique sur leurs communautés reste inconnue. L'objectif principal de cette thèse est donc de déterminer des différences dans les communautés d'actinobactéries sous l'influence anthropique directe (visiteurs humains modifiant le microenvironnement des grottes, partie 1) et indirecte (facteurs liées à des changements climatiques : précipitations ou qualité de la litière végétale, partie 2) dans deux habitats : litière végétale du sol et parois des grottes, où les actinobactéries jouent un rôle important et prédominent.

Dans une première partie de la thèse, nous avons suivi les communautés d'actinobactéries dans des parois de grottes calcaires françaises affectées différemment par l'homme (grottes vierges ou anthropisées). Pour la détection d'espèces potentiellement pathogènes ou productrices de pigments à partir d'ADN environnemental (Illumina MiSeq), nous avons utilisé le marqueur moléculaire *hsp65* spécifique pour le genre *Actinobacteria*. Une attention particulière a été portée à la grotte de Lascaux, abritant des peintures paléolithiques et étant une des plus affectées d'un point de vue anthropique. Une comparaison au niveau de plusieurs salles affectées de façon différente par l'intervention humaine ainsi qu'entre zones des mêmes salles avec des marques visuelles d'origine microbienne sur les peintures murales a été faite dans cette grotte (**article I**). Dans la deuxième partie, nous avons surveillé les communautés d'actinobactéries de la litière végétale au cours d'un processus de décomposition sous conditions modifiées prévues (précipitation modifiée (**article IV**), différents types, qualités et origines de litière, (**articles II, III, IV**) dans différentes forêts (chêne méditerranéen et pin (**article IV**)), épicéa de montagne et hêtre (**article III**), forêt tempérée de hêtre (**article II**) et prairie (**article II**).

Nos résultats montrent que les communautés d'actinobactéries étaient fortement dépendantes du statut anthropisé/vierge des grottes (partie 1) ainsi que des changements climatiques et de qualité des litières pendant la décomposition (partie 2). Dans les grottes (partie 1), la structure des communautés d'actinobactéries a indiqué des perturbations anthropiques, où des taxons typiques d'environnements vierges ou anthropiques comprenant des espèces potentiellement pathogènes (identifiées selon le marqueur hsp65) ont été trouvés ayant un rapport avec l'anthropisation (article I). De plus, la domination du genre Streptomyces a été trouvée dans les zones avec des marques visuelles suggérant que les zones marquées sont un facteur affectant ce groupe (article I). Lors de la décomposition (partie 2), nous avons constaté que les actinobactéries i) étaient affectées par le type de litière quel que soit son origine, mais leur dominance sur de la litière récalcitrante n'a pas entraîné une décomposition plus rapide (articles II, III, IV), ii) n'étaient pas directement affectés par les conditions climatiques (article III, IV) mais plutôt spécifiques au site (articles II, III, IV) avec du potentiel pour dominer dans des forêts de conifères introduites (articles III, IV), et iii) étaient influencées par des conditions différentes à celles des champignons (articles II, III, IV). Dans l'ensemble, les actinobactéries répondent principalement aux changements anthropiques au niveau de communautés ou d'espèces et sont capables de s 'adapter á ces changements conduisant á leur persistance dans les écosystèmes. Les Actinobactéries peuvent être mentionnées comme des microorganismes tolérants au stress et, dans une certaine mesure, comme bénéficiant des perturbations d'origine humaine.

## Aim and outline of the thesis

The thesis focuses on communities of terrestrial *Actinobacteria* under the anthropogenic influence in French caves and during plant litter decomposition in forests and grassland habitats in the Czech Republic, France and Austria. The first part describes the direct influence of humans on *Actinobacteria* inhabiting wall surfaces of caves in France under different human impact. The aim was to show how *Actinobacteria* react to human disturbance and coincide with the stability of these habitats. Such intervention as a biocide treatment but also the high frequency of visitors, which represent the alteration of microclimate due to their metabolism and introduction of allochthonous microbes and nutrients, represent direct anthropogenic factors affecting autochthonous microbial inhabitants. The second part focuses on the indirect consequences of global climate changes on communities of soil and litter *Actinobacteria*. The aim was to show how forest and grassland *Actinobacteria*, as an important part of soil decomposer community, will respond to changes in litter quality and habitat properties but also to the reduction of rainfall as expected from the climate change. For more complex insight, the other important microbial decomposers within the community were also analyzed to see possible relationships typical for the respective environmental and substrate conditions.

The overall aim of the thesis was to uncover the ecology of *Actinobacteria* in habitats modified by human activities directly or indirectly. Using a combination of environments, where *Actinobacteria* play the dominant role we were able to determine the sensitivity of this group to anthropogenic changes in open and less stable (plant litter) versus isolated and relatively more stable (caves) habitats. Using the novel marker gene *hsp*65 for analysis of *Actinobacteria* communities from eDNA, we were able to overcome the problem of unculturable strains in identifying the cave *Actinobacteria* to the species level in French caves, Lascaux, Rouffignac, Mouflon and Reille. That helped us to identify in detail the part of the community that was affected by human interventions or by the presence of visual dark marks (black stains and dark areas on cave walls) of microbial origin in the Lascaux Cave (**part 1**). In the part two, where we quantitatively and qualitatively measured the reaction of *Actinobacteria* to other decomposers and environmental factors, we firstly showed the abiotic but also biotic ones driving *Actinobacteria* activities during decomposition (**part 2**). The work further demonstrates the necessity to include *Actinobacteria* into environmental monitoring and prediction models as a one of the indicative microbial groups.

We focus on the following subjects:

- Detailed analysis of *Actinobacteria* communities of four French caves and also individual rooms within the Lascaux Cave. The questions were: 1) Are *Actinobacteria* in caves shaped according to the anthropization status (presence of visitors, application of chemicals)? 2) Can we identify with a novel marker (*hsp*65) *Actinobacteria* species related specifically to anthropized/pristine habitats, for example potentially pathogenic and novel species?
- 2) Comparison of *Actinobacteria* between dark visual marks and unmarked areas on wall paintings within the Lascaux Cave. The questions were: Are visual marks in the highly anthropized Lascaux Cave a factor affecting *Actinobacteria* communities?
- 3) Quantitative and qualitative analysis of changes in *Actinobacteria* communities in relation to altered litter type in different forests and grassland. The questions were: Are *Actinobacteria* affected by changes in precipitation, litter quality and origin at the studied sites? Are *Actinobacteria* able to adapt to altered litter quality regardless of the environment or time of decomposition?
- 4) Determination of *Actinobacteria* successional patterns over the decomposition process and comparison with the other important microbial decomposers, especially fungi. The questions were: Are *Actinobacteria* initial, middle or late-stage decomposers? Do they have similar or opposite colonization patterns to other decomposers? Could be these patterns affected with changes in litter and environmental conditions?

After a short introduction which is divided into two sections (**part 1, part 2**), the thesis is concluded by general summary and conclusions of the obtained results. The main part of the thesis is also divided into two sections (**part 1, part 2**) and consists of four original research papers. In the appendix, my curriculum vitae containing all my publications and trainings can be found.

#### **Outline of the original papers**

This thesis consists of four papers (I-IV). The **paper I** focused on communities of *Actinobacteria* in French caves differently affected by anthropization (visited versus non-visited caves) with closer focus on Lascaux cave, which was disturbed to a high extent and thus already closed to visitors. Three papers (II-IV) focused on microbial communities during litter decomposition with closer focus on *Actinobacteria*. Within that, **paper II** describes one-year decomposition experiment with litters of different origin and quality at beech forest and grassland sites, while the **paper III** is focused on later stage decomposition (15 to 29 months of decomposition) of two highly recalcitrant litters in beech (native) and spruce (introduced) mountainous forests. The **paper IV** describes recalcitrant oak (native) and pine (introduced) litter decomposition under the altered precipitation conditions in Mediterranean forests.

Paper I (Buresova et al., in prep, Molecular Ecology) focused on Actinobacteria communities colonizing walls in French caves differently affected by humans (Lascaux, Rouffignac - anthropized, Mouflon, Reille - pristine). In addition, in Lascaux cave, samples of different rooms (entrance Sas-1, Passage banks, Passage inclined planes, Apse, Diaclase) were picked wall from visual marks (black stains and dark area) and unmarked area. DNA was extracted and amplicons of heat shock protein gene hsp65 and 16S rRNA gene fragments were sequenced (Illumina MiSeq). The taxonomical database for assignment of hsp65 amplicons was designed. Comparison of 16S rRNA and hsp65 markers showed higher variability of hsp65 than 16S rRNA gene enabling higher resolution of Actinobacteria at species level especially for Nocardia, Mycobacteria, Streptomyces and others. Actinobacteria communities differed between Lascaux, Rouffignac and both pristine caves. The results showed that anthropization level affected Actinobacteria community structure where high diversity of Nocardia was typical for visited Rouffignac and *Mycobacteria* for already closed Lascaux cave. Both caves contained potentially pathogenic species which were identified thanks to the hsp65 reference database. Pristine caves harbored high proportions of typical pristine caves dwellers Gaiellales similarly to Diaclase, which is considered as pristine part within the anthropized Lascaux cave. Concerning the visual marks in Lascaux cave, Actinobacteria were shaped according to these micro-habitats and domination of Streptomyces were the predominating group in the visual marks.

Paper II (Buresova et al. 2019, Applied and Environmental Microbiology) described Actinobacteria communities over the decomposition process of autochthonous and allochthonous litter at beech forest and grassland sites. Over the transplant litterbag decomposition experiment the mass loss of litter (Fagus sylvatica - lowest quality defined by C, N, P, autochtonous in beech forest and allochtonous in grassland; Carex humilis and Astragalus exscapus - middle and highest litter quality, respectively, autochtonous in grassland and allochtonous in beech forest), C, N and P changes, and hydrolytic and oxidative extracellular enzymes activities were measured. Bacterial community structure was determined by 16S rRNA gene amplicon sequencing (Illumina MiSeq), and quantities of fungi ( as 18S rRNA gene copy numbers), Actinobacteria (16S rRNA gene), Alphaproteobacteria (16S rRNA gene) and Firmicutes (16S rRNA gene) were measured using quantitative real-time PCR. Extracellular enzyme activities were higher at forest site, where also decomposition was faster, but where Actinobacteria 16S rRNA genes were less abundant. Actinobacteria, contrary to fungi, preffered the litter regardless its quality and origin. The fastest decomposed litter at both sites was the most nutritious one, which however was not the preferred one for neither fungi nor Actinobacteria. Dynamics (i.e. variation over time) of Actinobacteria and fungi was highly litter specific but not site specific. Actinobacteria 16S rRNA gene abundance increased in later stages, similarly as for Firmicutes, and differing from fungi and Alphaproteobacteria. Actinobacteria and fungi were differently influenced by litter or site conditions, but had similar strategies in colonizing the litter over time. Actinobacteria should be more and fungi less affected by changes in complex site conditions, because Actinobacteria were site specialists and fungi site generalists. But Actinobacteria adapted to decompose the litter regardless its quality, and may be potentially less affected by changes in vegetation cover and resulting litter quality.

**Paper III (Buresova et al., under revision, European Journal of Soil Biology)** built on our previous results where *Actinobacteria* increased over the decomposition. This paper focused on late stage decomposition of recalcitrant beech (native) and spruce (introduced) litter under the mountainous climate. All abiotic conditions like a parent rock and climate were identical at for both sites since the forests were located next to each other on the hillside. A litterbag experiment was set and a later stage was determined to months 15, 19 and 29. Bacterial community structure (16S rRNA gene, Illumina Miseq), fungal and bacterial abundance (ITS region and 16S rRNA

gene, respectively, ddPCR), micronutrients, macronutrients and characteristics of organic matter were measured over that period in the litter. Nutrients were also measured in soil profiles. Our results showed that fungal and bacterial abundance did not change between the sites with different litter and was therefore affected by other than litter characteristics, for example site conditions. Contrary to *Proteobacteria*, *Actinobacteria* dominated in late stages on the more recalcitrant introduced spruce litter which however did not lead to a higher decomposition rate.

**Paper IV (Pereira et al 2019, FEMS Microbiology Ecology)** focused on *Actinobacteria* community changes under the reduction of rainfall during decomposition of allochtonous and autochtonous litter in Mediterranean two deciduous and one coniferous forests. The results show that, contrary to fungi, *Actinobacteria* abundances (16S rRNA gene, qPCR) were not affected by reduced precipitation. *Actinobacteria* dominated at each site in deciduous litter, while coniferous litter was colonized by fungi with higher preference, especially in deciduous forests (18S rRNA gene, qPCR). In coniferous forest, both microbial groups dominated on deciduous litter with lower lignin content and the highest availability of nutrients. It suggests that in coniferous forest both groups had similar strategies and colonized the more nutritious deciduous litter. *Actinobacteria* were not affected by rainfall reduction but were affected by litter quality.

## Introduction

Microbes in a changing world

Human derived changes on earth resulted in a new geological epoch called the Anthropocene, which consists of three stages called paleoanthropocene, industrial revolution and great acceleration (Gillings and Paulsen, 2014). During those stages the widespread of agriculture and industry together with the high population growth, consumption of energy and resources represented a new selection pressure for the natural ecosystems. Consequently, the loss of biodiversity, elevated production of greenhouse gases and chemical pollution are some of the main outcomes challenging the stability of the nature nowadays (Gillings and Paulsen, 2014; Zhu and Penuelas, 2020).

The human impact influenced microbial communities across many biomes and might be reflected in various measures, such as stability, diversity and functioning of microbial communities (Zhu and Penuelas, 2020). Such human impacts might have direct and indirect influences. For example, the pollution of environment by toxic substances (Abdu et al., 2017) and eutrophication (Schobben et al., 2016) can directly negatively affect microbes. On the contrary, the changes in vegetation cover (Prieto et al., 2019), precipitation events and temperature (Suseela et al., 2014) due to a climate changes like increase  $CO_2$  production are examples how human affect microbes indirectly.

The alteration of temperatures and precipitation regimes represented one of the predicted effects of climate change with direct consequences to microbes. It was suggested that the warming and higher frequencies of freeze/thaw cycles might promote animal and plant pathogens and suppress decomposers of organic carbon compounds as well as those involved in N-cycling (Garcia et al., 2020). Another finding revealed that thawing of permafrost might unleash danger pathogens and promote carbon release from soil, which has in turn a negative feedback for the climate change (Gross, 2019). The promotion of long drought with more intense rain events were expected also in arid habitats and might promote further soil degradation together with decrease of microbial diversity (Maestre et al., 2012; Meisner et al., 2018).

On the other hand, plant diversity and biomass alteration changes are another indirect consequences of climate change which can modulate the activity, biomass and structure of microbial communities (Lange et al., 2015). The plant diversity decreased and proportions of structural components of plant tissues might slow down the decomposition. The climate change scenarios through warming and drought might affect the nutrient content in plant tissues and thus palatability for microbes (Rosenblatt, 2018). These and other climate-related changes might in turn result in settlement of stress tolerance communities (Garcia et al., 2020).

Human activity might directly affect microbial communities by organic and inorganic pollution by biocides, heavy metals but also excess of nutrients. The high concentration of heavy metals (Lee et al., 2002; Száková et al., 2016) or pesticides (Pose-Juan et al., 2017) in soil might decrease of microbial biomass together with enzymatic activities as a reaction to toxic stress. However, although some microbes might be sensitive to heavy metals, others are resistant or adapt over time (Chen et al., 2020). Simultaneously, pesticide amendments might shift microbial community towards high proportions of microbes capable to degrade the respective organic pollutant (Bragança et al., 2019). Also, the excess of nutrients reached by fertilization was associated with shifts in microbial diversity as a reaction to eutrophication. In soil, nitrogen fertilization might shift the microbial community towards dominance of copiotrophic like *Acidobacteria* (Francioli et al., 2016). Moreover, high nutrient amendments might promote mineralization of stable and recalcitrant organic matter, which is known as a "priming effect", (Meier and Bowman, 2008) and thus promote emission of CO2 and CH4 to the atmosphere.

Some studies focused only on diversity indices of bacterial or fungal community or overall microbial biomass (Száková et al., 2016; Wagg et al., 2019), which however could not be a sufficient indicator of which changes we can expect in relation to anthropogenic pressure. We apply as a fact, that more diverse community maintain more functions (Delgado-Baquerizo et al., 2016) but since microbes are not functionally equivalent (Bray et al., 2012; Wertz et al., 2006) the crucial question should be, if such diverse community contain specific taxa responsible for respective modulations in ecosystems. Moreover in this context arise a question what are the main microbial groups to which these changes are significant (McGuire and Treseder, 2010). At the same time, does these groups maintain key roles in ecosystems? If so, which feedbacks can be expected through modulation of their abundances, proportions and interactions in community and activity? Then, we have to consider such key groups jointly with other community members, since with the interactions in the community we can completely gain the biotic and abiotic factors affecting their functioning (Bani et al., 2018).

#### Actinobacteria in terrestrial ecosystems

Actinobacteria are phylogenetically diverse and ubiquitous gram positive class of bacteria further characterized by high content of cytosine a guanine in their genomic DNA (Barka et al., 2016). Actinobacteria sustain important ecosystem functions since among other activities they participate in carbon cycling and nutrient transformation. They possess useful enzymes and also produce metabolites of various functions, for example antiobitics and thus have broad applications in biotechnology and biomedicine (Sharma et al., 2014). Since we face the problems of antibiotic resistance and new diseases, which call for exploration of novel searching for unknown Actinobacteria especially from underexplored habitats with capacity to produce new metabolites are one of the main goals nowadays (Rangseekaew and Pathom-Aree, 2019). Due to Actinobacteria high application potential many studies focus on Actinobacteria production of therapeutics, antifungal substances, enzymes or degradation of pollutants but much fewer are concerned about their ecological demands affecting their distribution and functioning in natural habitats.

High frequencies of *Actinobacteria* were monitored in various types of terrestrial, aquatic ecosystems and in the atmosphere. In terrestrial ecosystems, free living *Actinobacteria* are highly abundant especially in soil, where they count 10 <sup>6</sup> to 10 <sup>9</sup> cells per gram (Barka et al., 2016). Since *Actinobacteria* have broad adaptations to live in oligotrophic conditions *Actinobacteria* live epilithically and endolithically on building surfaces, rocks, stone monuments and statues (McNamara et al., 2006; Mihajlovski et al., 2017). Their advantages include the capability to produce resistant spores as a reaction to harsh conditions (B.-Z. Fang et al., 2017; Makhalanyane et al., 2015). Moreover, *Actinobacteria* produce pigments like melanin to be protected against high radiation, temperature extremes and free radicals (Manivasagan et al., 2013). That enables their survival in extreme habitats such as deserts and semideserts (Makhalanyane et al., 2015), alkaline saline soils (Shi et al., 2019), polluted soils (Alvarez et al., 2017), permafrost soils (Aszalós et al., 2020; Hansen et al., 2007), subterranean habitats (De Mandal et al., 2017; Hershey et al., 2018).

Besides that, *Actinobacteria* are important symbionts but also pathogens of plants and humans. In plants they can for example caused potatoes common scabs for which the *Streptomyces* genera are responsible (Marketa Sagova-Mareckova et al., 2015). Within the *Clavibacter* genera are plant pathogenic species like *C. michiganensis subsp. sepedonicus* causing bacterial root rot of potatoe or *C. michiganensis subsp. michiganensis* causing bacterial wilt and canker of tomato (Bentley et al., 2008). For humans, many diseases including tuberculosis, cystic fibrosis, pulmonary disease, nocardiosis and others caused *Actinobacteria* genera like for example *Nocardia* (*N. pneumoniae*, *N. farcinica*, *N. asteroides*) (Boiron et al., 1992; Taj-Aldeen et al., 2020). *Rhodococcus equi* is an example of animal pathogen, namely of horses, ruminants and pigs, that might causes opportunistic infections for humans (Vázquez-Boland and Meijer, 2019).

#### Environmental factors driving Actinobacteria communities

Actinobacteria, their diversity, activity and abundance are highly dependent on pH, moisture and temperature. The pH was considered to be the main factor affecting Actinobacteria community. In the study performed in different soils of temperate forest and meadow Actinobacteria abundance negatively correlated to pH (Sagova-Mareckova et al., 2011). Some Actinobacteria were considered acidophilic including the new species Trebonia kvetii isolated from highly acidic soil (Rapoport et al., 2020). Similarly, acidic soil pH favorited some Actinobacteria genera for example Acidimicrobium, but alkaline soil pH favorited genera such as Nocardia, Micrococcus and Mycobacterium (Jenkins et al., 2009). In addition, another study based on Actinobacteria from rock surfaces suggested they most grew on media with neutral pH (B.-Z. Fang et al., 2017).

Aquatic *Actinobacteria* were found in free water and sediments of saline and fresh water habitats where pH (Newton et al., 2007), UV-radiation (Rasuk et al., 2017), nutrients (Holmfeldt et al., 2009) and various other factors affected their community structure (Kurtbóke, 2017; Sharma et al., 2014). Therefore, *Actinobacteria* have also adaptation to live in aquatic ecosystems, but these are not the subject of the thesis. Terrestrial *Actinobacteria* prefer humid habitats but well oxidized since they are generally considered as aerobes or microaerophiles since their counts in waterlogged habitats declined to about 10<sup>2</sup> or 10<sup>3</sup> per dry gram of soil (Kurtbóke, 2017). Yet, hydration of arid soil after the dry period was linked to *Actinobacteria* abundance decline with subsequent increase after the habitat recovery as the oxygen availability increased (Št'ovíček et al., 2017). Similarly in the Mediterranean forest, *Actinobacteria* abundance were not influenced by the rainfall exclusion (Pereira et al., 2019). That suggested terrestrial *Actinobacteria* were well adapted to dry conditions because their proportions significantly increased with dryness but not only in warm but also in cold climates including Arctic soil (Rego et al., 2019). Yet, some *Actinobacteria* dominated waterlogged habitats (Kopecky et al., 2011).

Optimal growth temperature for *Actinobacteria* is between 25 – 30°C however, thermophilic and psychrophilic *Actinobacteria* also exist (Barka et al., 2016; Li et al., 2010). The temperatures might have determining effect on the size and composition of *Actinobacteria* communities not only directly but also indirectly through the litter quality and substrate availability (Jenkins et al., 2009; Kurtbóke, 2017). *Actinobacteria* seasonal changes between winter and summer showed, that higher diversity with higher proportions of unknown taxa were found in winter (M. Sagova-Mareckova et al., 2015). Similar results were found in deciduous forest, where the known *Actinobacteria* taxa were higher in winter in upper horizons where the highest amount of organic matter was located (Kopecky et al., 2011). For example, in the grassland and forest sites *Actinobacteria* proportions increased especially in July and then in January more visibly in grassland, however it again seemed to be dependent on nutrients availability (Buresova et al., 2019). *Actinobacteria* might dominate high nutritious habitat (Francioli et al., 2016), but as was mentioned earlier, their competitive advantage represented also the capability to overcome oligotrophic conditions and to utilize recalcitrant substrates (Barton and Jurado, 2007).

Although it is certain that *Actinobacteria* communities are driven by environmental forces, different factors affect *Actinobacteria* and a single resolute pattern cannot be recognized. Above that *Actinobacteria* participated in many biotic interactions so might be suppressed by fungal pathogen or facilitated by the assembly of microbes or plants, for which *Actinobacteria* mediated available sources of energy by degradation of resistant compounds (Radha et al., 2017). Cooperation or competition of *Actinobacteria* with other microbial community members might be mediated by secondary metabolites production, however in nature has been scarcely investigated (Miao and Davies, 2010).

#### Techniques for in situ Actinobacteria determination

Culture dependent analyses of microbial diversity represented a big problem in the past since only the cultivable bacteria were recovered (Penny R. Hirsch et al., 2010). The cultivation approach is limited not only due to missing knowledge on requirements of the microbes for growth conditions and nutrients but also for the absence of cooperating microbes or their metabolites, which allow growth of the other ones (Lewis, 2009). Moreover, these techniques are time-consuming contrary to culture independent methods (Penny R. Hirsch et al., 2010).

With the expansion of *in situ* molecular techniques, the ecological role and community structure of microorganisms including *Actinobacteria* can be done *in situ* (Barka et al., 2016). The gene coding the small ribosomal subunit (16S rRNA gene) is the most frequently used molecule for description of prokaryotic microbial communities and molecular taxonomy. Currently, the next generation sequencing is the preferred sequencing method but even its high throughput capacities generally cannot resolve individual sequences at the species level (Fox et al., 1992; Penny R Hirsch et al., 2010). Moreover, this gene cannot be used for issuing abundance because for example in *Actinobacteria* there are on average  $3.1\pm1.7$  16S rRNA copies per genome depending on the particular genus/species, while in *Firmicutes* it is on average  $5.8\pm2.8$  copies and in *Proteobacteria* from  $2.2\pm1.3$  copies in *Alphaproteobacteria* to  $5.8\pm2.8$  copies in *Gammaproteobacteria* (Větrovský and Baldrian, 2013). Above that a single bacterium can harbor diverse copies of the gene, while identical gene copies can be found in different bacteria, which complicates the molecular taxonomical identification especially to the species level (Pei et al., 2010).

Alternatively, highly conserved protein coding genes from primary metabolism were proposed for identification of closely related bacteria including *Actinobacteria*. Generally, genes coding *rpoB* (beta subunit of RNA polymerase), *gyrA*, *gyrB* (A, B subunit of DNA gyrase), *secA* (ATPase secretory preprotein translocase), *atpD* (beta subunit of ATP synthase F1), *gap* (glyceraldehyde-3-phosphate dehydrogenase), *pnp* (polyribonucleotide nucleotidyltransferase), *ftsZ* (tubulin-like GTP-binding protein) or *dnaK* (chaperone Hsp70 in DNA biosynthesis), as well as the 23S rRNA gene are used (Gtari et al., 2015; Martens et al., 2008). *rpoB* coding beta subunit of DNA polymerase exists in a single copy, but it is not conserved enough to be amplified by universal primers (Ogier et al., 2019; Vos et al., 2012). For *Actinobacteria*, *sodA*, *hsp*65, the *recA* gene encoding DNA recombination and repair systems were used (Adékambi and Drancourt, 2004). DNA gyrase subunit B encoding gene *gyrB* was used for differentiation of *Nocardia* species, however only some species were more distinct according to *gyrB* than 16S rRNA (Takeda et al., 2010). Simultaneously, *hsp*65 gene coding heat shock protein is present in genome in a single copy and has been used as a molecular marker for identifying a large number of *Actinobacteria* isolates (Rodríguez-Nava et al., 2007, 2006), but has never been sequenced from *in situ* samples (from environmental DNA). Although such markers might employed drawbacks like lacking databases for assigning the taxonomy, they might be used in combination with other housekeeping genes in Multi Locus Sequence Analysis (MLSA) studies (Diancourt et al., 2005; Ogier et al., 2019). Usually five or more genes were sequenced for definition species within the genus as for example for *Frankia alni* gene markers *atp1, ftsZ, dnaK, gyrA* and *secA* were used (Nouioui et al., 2019). For genetic relatedness between *Ensifer* species (*Alphaproteobacteria*) ten genes encoding *atpD, dnaK, gap, glnA, gltA, gyrB, pnp, recA, rpoB* and *thrC* were used (Martens et al., 2008). However, recently is more reliable method for species identification the whole genome sequencing (Verma et al., 2013).

#### Part 1: Cave environments and microbial inhabitants

Caves are underexplored habitats unique in its stable microclimatic conditions and isolation from the surrounding environment. The isolation from the sunlight results in the absence of phototrophic primary production (Tomczyk-Żak and Zielenkiewicz, 2015). The chemoheterotrophic or chemolithotrophic microbes living in caves are under the pressure due to nutrient deficit, to which they are adapted by alternative nutrient acquisition strategies (Barton and Jurado, 2007; Ortiz et al., 2014). This selective pressure consequently resulted in unique microbial communities (De Mandal et al., 2017). Microbes might face harsh conditions, which might cause high DNA damage due to high calcium content, which resulted in overabundance of DNA-repair enzymes (Ortiz et al., 2014). Cooperative microbiological interactions predominate over competition in such habitats, since the limited inorganic and complex organic nutrients are unlikely to be acquired by a single organism due to high energy demand versus little energy gain in those processes. Those living conditions consequently explain the high microbial diversity (Barton and Jurado, 2007), and low microbial biomass (<10<sup>6</sup> cells/g) observed in caves (Hershey and Barton, 2018).

In caves, the microbial communities are driven by the type of habitat like the rock wall, sediment, water, air (Wu et al., 2015). It was even suggested that the sample type is a stronger determinant of the variability of cave microbial communities than the differences between caves (Zhu et al., 2019). The most ubiquitous bacterial phyla in caves were found *Proteobacteria* and *Actinobacteria* (Tomczyk-Żak and Zielenkiewicz, 2015) while other highly abundant groups were *Firmicutes*, *Verrucomicrobia* or *Acidobacteria* (De Mandal et al., 2017; Zhu et al., 2019). The presence of Archaea were frequently found in caves, such as *Thaumarchaeota*, most likely thanks to their various CO<sub>2</sub> fixation pathways (Ortiz et al., 2014). Fungi in caves were found to be parasites of animals or decomposers especially of organics, which entered the cave externally. In that case, the organics were covered by conidia of such fungi like *Aspergillus*, *Penicillium* or *Mucor*, which were at the same time generally the most frequently reported genera from caves together with *Histoplasma* or *Geomyces* (Vanderwolf et al., 2013).

Some of the most ubiquitous cave taxa could be also found in soil, which is explained by the seeding hypothesis suggesting that these microbes were carried by the percolating water into a newly created cave. However, the long-time impact and selective pressure sorted for microbes with unique adaptations (Hershey and Barton, 2018) and precisely those adaptations lead to the high proportions of unknown and endemic microbes observed in caves (Lavoie et al., 2017). Those included for example *Actinobacteria* species *Hoyosella altamirensis* and *Nocardia altamirensis*, which were firstly isolated from Altamira cave wall (Jurado et al., 2009, 2008) and *Nocardia jejuensis* from a Korean cave (Lee, 2006). More recently, *Nonomurea cavernae* and *Bacillus antri* were examples of bacteria isolated from a karst cave of China (B. Z. Fang et al., 2017; Rao et al., 2019). Also, novel fungal species were isolated from caves like three highly oligotrophic fungal species *Cephalotrichum guizhouense*, *Cephalotrichum laeve* and *Cephalotrichum oligotriphicum* (Jiang et al., 2017) or filamentous fungi with high cellulolytic activity (Paula et al., 2019).

Some cave microbes represent a source of novel secondary metabolites used as therapeutics. *Cervimyxin, Xiakemycin, Hypogeamicin* and *Huanglongmycin* are examples of new antibiotic and anticancer metabolites produced by *Actinobacteria* (Rangseekaew and Pathom-Aree, 2019). Interestingly, some caves are also reservoirs of antibiotic resistance or pathogenic microbes. Their presence was in the past attributed to the human activity, which later became controversial since they were found also in natural and isolated caves without any human intervention (Bhullar et al., 2012; Jurado et al., 2010).

The microbial inhabitants of caves are driven by biotic and abiotic conditions and in turn modify the inner environment since some act as constructive or destructive agents. More specifically, microbial mineral precipitation in caves resulted in the formation of speleothems, calcium carbonate, iron precipitation and others are driven by number of processes (Banerjee and Joshi, 2013; Tomczyk-Żak and Zielenkiewicz, 2015). In the Altamira cave, the mineral deposits were found to be associated with microbial colonies, while the biomineralization was driven by microenvironmental conditions like high humidity, temperature and CO<sub>2</sub> production (Cuezva et al., 2009). Also, the pH of biofilm strongly influenced calcium carbonate dissolution and precipitation. The pH increase was associated with precipitation and thus carbonate formation, while pH decrease caused carbonate dissolution (Banerjee and Joshi, 2013).

Some studies suggest *Actinobacteria* and fungi to be one of the crucial microbes inducing mineral deposition (Tomczyk-Żak and Zielenkiewicz, 2015; Vanderwolf et al., 2013). However, although *Actinobacteria* and *Proteobacteria* dominated speleothems of Karstic caves, metabolically dominating groups associated with calcium carbonate precipitation were

*Proteobacteria* and *Firmicutes* (Dhami et al., 2018). Another study pointed on the most important role in mineral deposition of those cyanobacteria, algae and fungi able to create biofilms and mats (Banerjee and Joshi, 2013).

Microbes might colonize cave surfaces and create a biofilm, which is made of microbial consortia held together by polymers leading to their protection and effective use of energy sources (Mulec et al., 2015). The biofilms may be colorless but also highly pigmented, which might indicate its functional composition and reflect the microenvironmental factors driving its creation (Banerjee and Joshi, 2013). The green biofilm consists of green algae and cyanobacteria in the areas where light, artificial or natural light in the entrance of cave are present (Urzì et al., 2010). The yellow biofilm in lava tubes was linked to percolation of organic matter originated from lignin degradation containing yellow colored phenolic compounds. In this type of biofilm, Proteobacteria followed by Actinobacteria dominated, however, the latter group was metabolically more active (Gonzalez-Pimentel et al., 2018). Black and white pigmented biofilms were found to have alkaline pH and thus, are contrary to yellow biofilms responsible for speleothems induced by precipitation (Portillo and Gonzalez, 2010). Dark color of biofilms might be caused by algae producing black pigments like Nostoc and melanized fungi like Aspergillus niger, Acremonium or Ochroconis (Alonso et al., 2018; Popović et al., 2015). Althought these dark pigments like melanin might have protective functions for example against free radicals their roles in cave biofilms are not completely clear (Agustinho and Nosanchuk, 2017; Mulec et al., 2015).

#### Human derived changes in show caves

Pristine caves are fragile habitats, where human derived intervention might cause disruption of structure and functioning of microbial communities. However, microbes are to some extend resilient to the influence from human activity and are able to mitigate the impact (Tomczyk-Żak and Zielenkiewicz, 2015). That was demonstrated for example by the effect of human urine, which represented enrichment of nitrogen as well as introduction of commensal organisms (Johnston et al., 2012). As a result, the indigenous cave microbiome including the endemic species took an advantage of nitrogen and organic compounds enrichment without alteration of their community composition (Johnston et al., 2012). Another study suggested,

that microbial community composition remained unchanged, but the enrichment by exogenous nutrients in show caves increased microbial biomass (Adetutu et al., 2012).

Unfortunately, the situation was changing rapidly once the cave became open to public suggesting that the level of anthropization might be the crucial determinant of the cave microbiome over other environmental factors (Moldovan et al., 2020). Extensive physical human impact can also began with installation of walkways, lights and other utilities and more drastically continued with high frequency of visitors (Bercea et al., 2019). The visitors directly changed the inner microclimate by their metabolism, including production of CO<sub>2</sub>, H<sub>2</sub>O, and heat and by consumption of O<sub>2</sub> (Hoyos et al., 1998). Moreover, each visitor brought to a cave not only external organic and inorganic matter on their shoes or clothes but also exogenous microbes like human or animal-associated commensals or pathogens, representing new potential colonisators and thus, aliens for true microbial cave dwellers (Leuko et al., 2017). At the end, the remediation of human impact by physico-chemical and biological treatments might even more drastically affect the cave microbiome in a negative way (Martin-Sanchez et al., 2015).

Some cave microbes might react to the human induced changes by coloration, creation of microbial mats and by deterioration of rock walls and historical paintings induced by pH decrease, production of acids and enzymes (Banerjee and Joshi, 2013; Carlo et al., 2016). Indeed, the problem with wall paintings endanger by bacteria and fungi try to deal with such world renowned caves like Altamira, Roman tombs, Lascaux and others (Martin-Sanchez et al., 2015; Schabereiter-Gurtner et al., 2002). The secondary calcium deposits of white color (moonmilk) endangered the Etruscan wall paintings in Italian tomb, where *Proteobacteria*, *Acidobacteria* and *Actinobacteria* dominated (Cirigliano et al., 2018). It was a similar case for moonmilk deposits on wall paintings of Altamira cave, where *Proteobacteria* and *Actinobacteria* dominated (Portillo and Gonzalez, 2011). The paintings of ancient Egyptian tombs suffered from color changes performed by *Actinobacteria* species, namely *Streptomyces*, by oxalic and citric acids, pigments like melanin, karotenoids and hydrogen sulphide production (Abdel-Haliem et al., 2013). On the contrary to that study, the melanin in black stains on wall Paleolithic paintings of Lascaux Cave were found to originated from fungi, namely from species from *Ochroconis* genera (De La Rosa et al., 2017).

The human contamination can also resulted in presence of bacterial, fungal and viral opportunistic pathogens, which can affect the health especially of immunosuppressed visitors or those with lower defense (Carlo et al., 2016; Jurado et al., 2010). The anthropogenically contaminated species such as *Escherichia* and *Lysinibacillus* might enter the cave with heavy rains (Davis et al., 2020), others can enter the cave with visitors (Bercea et al., 2019) or with animals (Jurado et al., 2010). Bacterial opportunistic pathogens caused various skin, brain and/or lung infections including for example those from groups Actinobacteria (Nocardia, Kribella), *Mycobacterium*, Rhodococcus. *Alphaproteobacteria* (*Aurantimonas*) and Spirochaete (Jurado et al., 2010). Known human pathogens Staphylococcus aureus and Bacillus spp. were detected in one of the largest show cave in Japan (Ando and Murakami, 2020). In Chinese cave, fungi related species associated with human and animal mycotoxicosis was isolated from dead bats (Karunarathna et al., 2020). Also Vanderwolf et al., (2013) mentioned in his review some cave pathogenic fungi like Histoplasma capsulatum and Geomyces destructans. Histoplasma capsulatum produce pulmonary histoplasmosis which was relatively frequent in caves explorers while the species from a genus Geomyces cause skin and nails human diseases (Jurado et al., 2010; Nováková, 2009).

#### Problematic of Lascaux Cave

The example of drastic human induced alteration of a cave microbiome is a case of Lascaux Cave in France (Martin-Sanchez et al., 2015). The Lascaux Cave is located in Dordogne department in south-western France and contain wall Paleolithic paintings. The cave was discovered in 1940 and in 1948 was open to public. In 1955 increased amount of CO<sub>2</sub>, humidity and temperature in the cave due to high number of visits per day so the air conditioning machine was installed. In 1960 the green colonies with green algae and a calcite film coating from water condensation appeared along the walls. since the microbial colonization progressed, the cave was closed in 1963 to a public. Consequently, the biocide treatment containing formaldehyde solution was applied, followed by antibiotic spraying which suppressed green colonies for some time. Interestingly, in 1966 lichens appeared in cave but bacteria and fungi remain stable (Bastian et al., 2010; Martin-Sanchez et al., 2015). However, in 2001 white fungal mycelia appeared at the walls while the treatment of 50% benzalkonium chloride dissolved in ethanol or water was unsuccessful for suppression of their proliferation (Martin-Sanchez et al.,

2015). More aggressive treatments were applied, which however resulted only in proliferation of white mucus of *Pseudomonas fluorescens* and five month later first black microbial colonies appeared on the walls of the cave (Bastian et al., 2007). The mechanical cleaning and new biocide treatments were used against the black stains, however without a long lasting success (Bastian et al., 2010).

Black stains represent recently the major problem for preservation of cave paintings. The microbial composition was therefore studied to use successful treatment for their elimination. Black stains were considered as most likely fungal origin, since the Dematiaceous hyphomycetes producing olivaceous to black colonies, together with species from genera Verticillium and Scolecobasidium were firstly isolated from stains (Fabiola Bastian et al., 2009). The melanin producing fungi *Scolecobasidium tshawytschae* appeared in stains most likely as a reaction to previous organic treatment since is typical for oil-contaminanted soils (Bastian et al., 2010). More recently, the novel fungal species of the genus Ochroconis, O. lascauxensis and O. anomala, which produced melanin were isolated from the stains (De La Rosa et al., 2017). Based on sequencing approach, strong interactions between fungal and bacterial species (for example between Aspergillus, Janibacter and Streptomyces) were found in the black stains (Alonso et al., 2018), pointing on a possibility that more complex microbial relationships play a role in stains creation. The microbial concentration in islands of nutrients in the oligotrophic cave walls might lead to increase competition linked to antibiotic production, which stress fungi to melanin production. However, if these fungi are during the creation of the black stains influenced by other microbes or how they in turn affect microbiology of the caves remain unclear but might be crucial for a definitive black stain suppression.

#### Actinobacteria roles in caves

Actinobacteria are highly abundant in many caves worldwide (Tomczyk-Żak and Zielenkiewicz, 2015). The suggestion that harsh conditions of caves are for this group highly favorable over the surrounding habitat was supported by a study where Actinobacteria dominated lava caves bacterial community contrary to the aboveground soil (Lavoie et al., 2017). Moreover, Actinobacteria advantage lie in the abilities to adapt to starving conditions, which for them represent a strong selection factor leading to an evolution of novel species. It
was supported by the study from Hamedi et al., (2019) who found that the highest number of novel *Actinobacteria* species were associated with the most oligotrophic part of the cave. *Actinobacteria* could fight against oligotrophy by production of extracellular hydrolytic and oxidative enzymes enable them to degrade even very recalcitrant organic compounds coming to the cave (Hamedi et al., 2019; Le Roes-Hill and Prins, 2016). However, another effect of some oxidative enzymes like laccase might be oxidation of phenolic molecules with subsequent polymerization into dark melanin-like pigments (Al Khatib et al., 2018). Indeed, some *Actinobacteria* like *Streptomyces* (Abdel-Haliem et al., 2013; Cuezva et al., 2012; Mitova et al., 2017), *Pseudonocardia* (Porca et al., 2012) or *Nocardioides* (Groth et al., 1999) were found to be responsible for pigmented stain formation on walls of caves.

The caves harbor unique *Actinobacteria* communities, some *Actinobacteria* were mentioned to be typical for pristine caves like *Gaiellales* (Zhu et al., 2019) while other for anthropized caves, like *Pseudonocardiaceae* (Lavoie et al., 2017). However, some genera like *Streptomyces* were also found typical for both types of caves (Maciejewska et al., 2017). *Nocardiaceae* might be also considered typical pristine cave members (De Mandal et al., 2017), however some species from that genera are known human pathogens and might be introduced into cave by visitors (Jurado et al., 2010). Also other pathogenic *Actinobacteria* species like *Dietzia maris* or *Kocuria rosea* were recovered from the air of visited Slovenian cave (Mulec et al., 2017). Therefore, the presence and proportions of potential pathogens in the community associated with visited caves is important to be monitored in relation to visitor's health.

# Part 2: Decomposition of plant litter and the climate change

Soil is the largest reservoir of organic carbon in terrestrial ecosystems and plant litter decomposition is a dynamic process where nutrients from litter are sequentially returning back to the soil (Berg, 2018; Moorhead and Sinsabaugh, 2006). This process is to a large extent affected by climate (temperature, precipitation) (Glassman et al., 2018; Jin et al., 2013), soil quality (pH, bedrock material, fertility) (Delgado-Baquerizo et al., 2015), litter characteristics (quality, quantity, accessibility) (Prieto et al., 2019) and decomposer organisms like soil fauna (Frouz et al., 2015) and microbes (Baker et al., 2018). Climate was the most important factor especially when considering its effect on a regional scale, while the litter played more prominent role on a lower spatial scale (Berg, 2000). However, some studies denied the climate factor as a primary control on the decomposition process (Bradford et al., 2014) or assumed that its role was dependent only with combination with other factors as for example microbial communities or litter quality (Glassman et al., 2018; Thiessen et al., 2013).

More specifically for the climate, microbial communities were differently affected by temperature, where bacteria shifted more strongly in relation to changes in climate characteristics than fungi (Glassman et al., 2018). Temperature sensitivity also depended on a litter recalcitrancy according to Arrhenius theory: the more recalcitrant the litter was, the more dependent it was on temperature (Thiessen et al., 2013). However, the more recent study in a field experiment showed that the more the organic matter was stabilized, the less it was sensitive to temperature, which directly contrasted with the Arrhenius theory (Moinet et al., 2020). Also a precipitation was found to have a predominant effect on the decomposition, since it eliminated the moisture limitation of microbes and stimulated their activity (Jarvis et al., 2007; Smith et al., 2010).

Concerning the litter quality, the litter of higher quality (i.e. high diversity of more nutritious litter, lowe C:N:P ratio) was colonized by more diverse microbial decomposers contrary to lower quality litter (high proportions of structural polymers like hemicellulose and lignin, higher C:N:P ratio) and resulted in faster decomposition (Bray et al., 2012; McDaniel et al., 2014). The litter quality changed over time and microbial decomposers reflected these changes (Buresova et al., 2019). According to the general point of view, first stages of decomposition were accompanied with a loss of nutrients and r-selected microbial taxa, while

the recalcitrant debris remained in late stages and were associated with K-selected microbial taxa (F Bastian et al., 2009; Philippot et al., 2010). Other study suggested that mostly earlier stages of decomposition (especially C and N loss) were regulated by biotic factors - microbial but also nematodes community, while late stages were driven by abiotic factors - initial litter quality and soil moisture (García-Palacios et al., 2016). More specifically for litter quality, the initial stage of decomposition was driven by P-related characteristics, while later stages were mostly controlled by C:N, phenolics:N, phenolics:P and lignin:N ratios (Ge et al., 2013). Other studies suggested that N and P might stimulated decomposition in earlier stages and inhibit decomposition in later stages due to creation of unavailable complexes (Ge et al., 2013; Vitousek et al., 2010). However, as mentioned in the study by Bani et al., (2018), the decomposition was a very complex and complicated process where all factors needed to be considered jointly for more reliable application of decomposition models.

The climatic models predicted changes in temperature as a reaction to greenhouse gas emissions and included temperature increase with rainfall reduction, however with more extreme precipitation events (Field et al., 2012). As a result, plant litter production and litter quality would be modified, which would have consequences on decomposition dynamics. As decomposition dynamics affected the nutrients availability in soil, the litter quality of new litter would be in turn modified, which shifted the balance of nutrient and C cycling (Prieto et al., 2019). However, it was indicated that direct climate changes in rainfall controlled the C and N mineralization to a greater extent than the indirect ones, namely CO<sub>2</sub>-induced changes in litter quality (Jin et al., 2013). The impacts of climate changes might also directly affect decomposition, for example by inhibition of enzyme activities due to soil drought as a reaction to warming and reduced rainfall (Suseela et al., 2014). Although the rain event in dry soil increased decomposition activity more than intense rain event in wet soils (Lee et al., 2014), too high intensity of rain might reduce oxygen availability for decomposers (Schwartz et al., 2007) and slow down the decomposition. The direct changes in climate conditions influenced more bacterial than fungal litter community, which specifically impacted decomposition rates but also a type of degraded carbon (Glassman et al., 2018).

## Microbial colonizers of litter

#### Fungi

Although soil fauna might contribute to a large extent to physical fragmentation of litter and its mixing with organic and mineral horizons (Frouz et al., 2013), microbes were the main mediators of plant litter decomposition (Bani et al., 2018). Fungi were always considered crucial in decomposition since they produced variety of extracellular enzymes including those which were able to decompose even very recalcitrant polymers like lignin from plant litter (Purahong et al., 2014). Fungi were divided into subcommunities according to different stages and function in decomposition. The early-stage subcommunity produced hydrolytic and oxidative enzymes while the later stage subcommunity contributed to laccase and peroxidase production (Purahong et al., 2016a). At the same time, earlier stages fungi were mostly identified as *Ascomycota* and later stages fungi as *Basidiomycota* (Purahong et al., 2016b). Concerning the abiotic factors affecting fungi during decomposition, fungal communities were less responsible to climate changes than bacteria (Glassman et al., 2018). It was contradictory to a study where a fungal community structure was alternated with changes in a high and a low soil moisture, however it did not affect the litter decomposition (Kaisermann et al., 2015).

In our study (Buresova et al., 2019), fungi were concluded as site generalists, but substrate specialists since they preferentially colonized one litter type. Indeed, fungi were mostly known to be driven by a litter quality since they could select for a certain litter type thanks to their colonizing abilities and selective translocation of potentially limiting nutrients by fungal hyphs (Song et al., 2010). Generally, fungi were known as dwellers of typical recalcitrant litter, like deadwood (Johnston et al., 2016). It was in accordance with a study, where fungi were explored to be earlier colonizers and their decomposition of leaf litter might facilitate a bacterial decomposition (Purahong et al., 2014). In spite of this, it was found that fungi were associated to a high quality C source, which contrasted the generally known hypothesis of their K-strategist orientation (Rousk and Frey, 2015). Simultaneously, high quality litter stimulated the production of fungal but not bacterial hydrolytic enzymes (Schneider et al., 2012).

Bacteria

As opposed to fungi, bacteria were believed to be r-strategic decomposers but latest studies showed that some bacteria were able to be K-strategists (Bani et al., 2018). Many bacteria including Proteobacteria, Acidobacteria, Actinobacteria, Firmicutes and Bacteroidetes were recovered from deadwood, where they most likely cooperated or competed during decomposition with fungi (Johnston et al., 2016). Although some bacterial groups might utilize easily accessible low-molecular weight compounds or scavenge the products of decomposition from other microbes (Snajdr et al., 2011), others were able to directly participate in the process by a production of hydrolytic and oxidative enzymes (Větrovský et al., 2014). For example, glycoside hydrolases  $\beta$ -1,4-endoglucanase, cellobiohydrolase and  $\beta$  -dglucosidase were produced by isolates from groups Actinobacteria, Proteobacteria and Firmicutes suggesting they were able to completely hydrolytically decompose cellulose (Woo et al., 2014). Within that, oxidases and peroxidases were highly active in Gordonia (Actinobacteria) and less active in Aquitalea (Proteobacteria), suggested these strains were able to degrade lignin although with different efficiency (Woo et al., 2014). Production of chitinase might be linked to N-rich substrates including fungal biomass. With this enzyme, bacteria might mediate decomposition of death fungal biomass (Tlaskal et al., 2016) or actively inhibited fungal growth (Lacombe-Harvey et al., 2018).

## Actinobacteria as one of the main litter decomposers

*Actinobacteria* were one of the most dominating bacterial group during the plant litter decomposition in different ecosystems (Glassman et al., 2018; Johnston et al., 2016). Soil and litter dwelling *Actinobacteria* were advantageous during decomposition due to their abilities to better colonize the litter thanks to their mycelial growth (De Boer et al., 2005), extracellular enzymes (Le Roes-Hill and Prins, 2016) and secondary metabolites production. Secondary metabolites might serve as inhibiting or communicating molecules, which might modulate the relationships of community during the decomposition (Polkade et al., 2016).

Actinobacteria were known to be litter and soil quality dependent, which was supported by a study where Actinobacteria but not a fungal biomass increased after complex organic fertilizers addition to a soil (Jenkins et al., 2009). Actinobacteria were also promoted by inorganic inputs including external S supply (Xu et al., 2016). However, N amendment in the late stages down-regulated *Actinobacteria* but not fungal abundance. It might be caused by limitation of C because *Actinobacteria* were found to regulate CO<sub>2</sub> emission derived from litter and were thus more than fungi dependent on C availability (Xu et al., 2016). Generally, it was presumed that *Actinobacteria* colonize low nutritious and recalcitrant substrates (Kurtbóke, 2017). Since the decomposition process was sorted into different stages according to actual quality of decomposing litter, *Actinobacteria* should therefore be associated with the later stages when recalcitrant residues remained (F Bastian et al., 2009). Some study indeed found *Actinobacteria* as late-stage decomposers, however they explained it as a result of *Actinobacteria* slow growth, which might indicate low contribution to C flow through microbial food web (López-Mondéjar et al., 2018).

Concerning the direct effect of climate change during decomposition, although *Actinobacteria* were generally considered highly seasonally responsible (Kopecky et al., 2011; M. Sagova-Mareckova et al., 2015), they could be stable during the altered climatic conditions. The example is a study by Tikhonova et al., (2019) where *Actinobacteria* dominated in a part of the microbial decomposers community, which remained stable during temperature increase. However, more studies are necessary to understand how *Actinobacteria* are during decomposition responsible to direct or indirect climate changes. Since they are subjected to variety of factors, including pH, the complexity of factors is necessary to take into account for understanding how climate change affects *Actinobacteria* community structure and biomass.

#### Extracellular hydrolytic and oxidative enzymes

Actinobacteria were found to produce variety of extracellular hydrolytic (Lacombe-Harvey et al., 2018) and oxidative enzymes (Le Roes-Hill and Prins, 2016; Woo et al., 2014). Production of such enzymes like for example chitinases, cellulases,  $\beta$ -glucanases and xylanases aided them in existing under different conditions thus enable them to inhabited multiple niches (Bennur et al., 2015). In recent years, *Actinobacteria* were interestingly found producing oxidative enzymes like peroxidases and laccase with potential application in biotechnological processes or bioremediation (Le Roes-Hill and Prins, 2016). Especially laccases have attracted much attention recently, because, contrary to fungal laccase, *Actinobacteria* laccases were active in a wider range of abiotic factors like pH and temperature (Fernandes et al., 2014). With laccase and other oxidases and peroxidases, *Actinobacteria* could decompose lignin, although it was assumed that with lower efficiency than fungi (Bugg et al., 2011). With hydrolytic enzymes like cellobiohydrolase,  $\beta$ -glucosidase and  $\beta$ -xylosidase they could degrade the lowmolecular weight compounds containing lignocellulosic polymers and potentially cooperated on a lignin degradation with other microbes like fungi (Johnston et al., 2016; Větrovský et al., 2014). Concerning other types of enzymes, *Actinobacteria* might acquire phosphate from organic esters by production of phosphatases (Lladó et al., 2017) or nitrogen from N-rich polymers like fungal hyphs by chitinases (Lacombe-Harvey et al., 2018). Moreover, some studies suggested that with chitinases *Actinobacteria* might suppress fungal growth (Gasmi et al., 2019).

The enzymology of bacteria in general is less explored and one study contemplated that bacteria break the lignin by oxidative enzymes and laccase due to protection against toxicity of phenolic compounds rather than to decompose lignin (Lladó et al., 2017). These questions might be important in relation to other stress like situations including environmental factors changes and low nutrient contents. Therefore, understanding enzyme production under stress conditions might be crucial in determining how carbon storage in soil would be affected under amplified climate conditions.

#### Relationship of main decomposers

Since the results predicting how abiotic factors explain *Actinobacteria* community structure and abundance are not always consistent, the biotic factors such as interaction with other community members might explain the rest of the unknown variability driving *Actinobacteria* (Bani et al., 2018; De Boer et al., 2005; Purahong et al., 2016b). If different microbial groups have a similar role in decomposition, their niches overlap. The mutual cooperation or competition, but also different sensitivity to environmental conditions and other variables, which regulated microbes, resulted in niche separation (Kielak et al., 2016; Leibold and McPeek, 2006). For example, *Actinobacteria* abundance decreased over decomposition from winter to spring, which was contrary to *Proteobacteria*. It might point on *Actinobacteria* seasonality over decomposer (Schneider et al., 2012). Similarly, *Actinobacteria* increased the most among other bacteria after litter addition to the soil, but more in a case, where fungi did not dominate (Malik et al., 2016). Simultaneously, it was found that when *Actinobacteria* 

increased, especially after organic input to soil, a fungal abundance falls (Jenkins et al., 2009). It suggested a negative relationship between these two groups, a niche separation and a potential inhibition of fungi by *Actinobacteria*. On the contrary, *Actinobacteria* colonizing organic substrate might also facilitate a growth of microbes already present in the substrate suggesting a synergistic interaction (Rousk et al., 2008; Zhao et al., 2016). The mutual relationship between *Actinobacteria* and fungi has rarely been studied in a single experiment although *Actinobacteria* the main fungal competitors (De Boer et al., 2005).

# **Summary and conclusions**

#### Actinobacteria community in anthropized and pristine caves

The thesis shows that *Actinobacteria* may serve as indicators of human derived contamination in caves since *Actinobacteria* community structure differed between anthropized and pristine caves (**paper I**). More precisely, *Actinobacteria* indicated the least affected caves (Mouflon, Reille) and one room within the Lascaux Cave (Diaclase) by high proportions of typical pristine taxa from the order *Gaiellales* (Zhu et al., 2019), the environmental clone *MB-A2-108\_fa* (Kumar De, 2019; Zhang et al., 2019) and unknown *Actinobacteria* taxa (Rangseekaew and Pathom-Aree, 2019). Rouffignac Cave was identified as being under intermediate human-derived pressure due to the coexistence of *Actinobacteria* groups, which were earlier recognized as typical for pristine caves, namely *Jiangellaceae* (Rangseekaew and Pathom-Aree, 2019)) as well as typically anthropized, namely by observation of high richness but low eveness of *Nocardia* including potentially pathogenic species (Jurado et al., 2010; Modra et al., 2017). These findings point to the shift of *Actinobacteria* community towards high diversity and proportions of potential human pathogens in the visited caves.

#### Use of the novel marker gene hsp65 for identification of Actinobacteria species

In the thesis, it is demonstrated that the *hsp*65 gene marker had higher nucleotide polymorphism and higher molecular distances than the 16S rRNA gene especially on the lowest taxonomic level of *Actinobacteria* (**paper I**). We designed a database, where sequences of paralogous genes were recognized and marked but only groups from the class *Actinobacteria* were targeted by selective primers and were thus, successfully identified by the database (Telenti et al., 1993). Although the 16S rRNA marker identified more groups on higher taxonomic ranks than *hsp*65 marker, the *hsp*65 marker identified more species. Therefore, the *hsp*65 gene could be used as a supportive marker complementary to the 16S rRNA based studies where identification of *Actinobacteria* to the species level is needed. However, the identification of *Actinobacteria* with the *hsp*65 gene marker has a limitation because the

database has only a limited number of deposited sequences compared to the 16S rRNA reference databases and primers were not complementary to all *Actinobacteria* taxa.

Visual dark marks on walls of the highly anthropized Lascaux Cave in relation to Actinobacteria communities

The differences of *Actinobacteria* community between visual marks (black stains and dark areas) and unmarked areas on cave walls were demonstrated, while higher diversity was measured in visual marks (**paper I**). Furthermore, higher proportions of *Streptomyces* with the highest proportion of *S. mirabilis* were identified in the visual marks especially at the cave entrance. *Streptomycetes* might contribute to pigment production as was monitored in other studies (Abdel-Haliem et al., 2013; Cuezva et al., 2012). Moreover, *Streptomycetes* were dominating in pigmented areas of other caves like Altamira, Spain (Groth et al., 1999). These findings suggest that *Streptomyces* were influenced by visual marks and potentially, might be involved in the visual marks formation. However, more detailed studies on the pigment production or interaction with the pigment forming fungi with *Streptomyces* is needed for understanding their role.

#### Actinobacteria communities in relation to litter changes during decomposition

Concerning the decomposition process in temperate climate, *Actinobacteria* abundance was not favorized by any studied litter type or its origin. but their dynamics over one year were dependent on litter type and their abundance increased in later stages of decomposition (**paper II**). It implies that *Actinobacteria* were functionally redundant since their decomposition strategies function according to the litter quality rather than the litter type and origin (Glassman et al., 2018) (**paper II**). In the Mediterranean climate, *Actinobacteria* preferred deciduous litter with the highest nutrient content but also with structural compounds such as lignin, cellulose, hemicellulose regardless of its origin (**paper IV**). Similarly, in a mountainous forest, *Actinobacteria* dominated later-stage bacterial community on the more resistant spruce litter compared to the beech litter (**paper III**).

These results show that *Actinobacteria* were mostly favorized by a recalcitrant litter or stages, when the litter became recalcitrant (F Bastian et al., 2009; Bray et al., 2012; Bugg et al.,

2011; Fierer et al., 2007). Moreover, *Actinobacteria* were able to adapt to changes in a litter, however, their dominance did not lead to an increased rate of decomposition (**paper III, IV**). It shows that *Actinobacteria* were adaptable to litter alteration with a potential to dominate the recalcitrant litter but the changes did not promote decomposition and thus also carbon and nutrients release.

#### Actinobacteria adaptability to changes in habitat properties

In the thesis, *Actinobacteria* occurring in the litter were not affected by rainfall reduction in Mediterranean forests (**paper IV**) and also in the temperate mountainous forest, other than climate characteristics affected their abundance (**paper III**). The comparison of temperate grassland and beech forest showed that the grassland harbored higher abundance of *Actinobacteria* but the decomposition was overall faster at the forest site (**paper II**).

Therefore, not only climatic characteristics, but also another factor or complex site conditions affected *Actinobacteria* in these habitats (**paper II, III, IV**). *Actinobacteria* were considered slow-growing thus, their response to actual weather changes might be retarded (López-Mondéjar et al., 2018) or they might be resistant to weather changes due to the spore formation (Acosta-Martínez et al., 2014; B.-Z. Fang et al., 2017). When comparing the forest habitats, *Actinobacteria* were able to adapt to introduced coniferous forests in both Mediterranean and temperate mountainous climate since they finally dominated the spruce or pine bacterial community in comparison to the native beech or oak deciduous forests, respectively (**papers III, IV**). Generally, acidic and nutrient-limited coniferous forest might enable the increase of *Actinobacteria* proportions because they are more than other community members adaptable to such harsh conditions, again suggesting *Actinobacteria* as oligotrophic and adaptable taxa.

However, the dominance of *Actinobacteria* at the respective sites (grassland (**paper II**), coniferous forests (**papers III**, **IV**)) did not lead to more intense decomposition of litter contrary to deciduous forests (**paper II**, **III**, **IV**). These results suggest that climate change would affect *Actinobacteria* indirectly through habitat alteration and the altered habitats dominated by *Actinobacteria* might be linked to slower carbon release from the litter.

#### Actinobacteria as late-stage decomposers with opposite patterns to other decomposers

The succession of microbial decomposers during decomposition with closer focus on *Actinobacteria* and fungi has been rarely investigated. In the temperate beech forest and grassland, *Actinobacteria* were similarly to fungi driven by a litter quality but an overall abundance of fungi was comparable between the sites while *Actinobacteria* abundance was site specific. Moreover, *Actinobacteria* were similarly to *Firmicutes* late-stage colonizers but fungi and *Alphaproteobacteria* were initial stage litter colonizers (**paper II**). In the Mediterranean climate, *Actinobacteria* were not affected by rainfall reduction contrary to fungi (**paper IV**). There, *Actinobacteria* were favorized by deciduous litter, while fungi mostly by coniferous litter except for the coniferous forest, where both groups coexisted in a high abundance at the same litter (**papers IV**). These findings point to the niche separation between *Actinobacteria* and fungi but also *Actinobacteria* and other decomposers during litter decomposition (*Firmicutes, Alphaproteobacteria*) (**paper II**).

Concerning the *Actinobacteria* and fungi, they had opposite strategies driven by different factors (**paper II**, **III**, **IV**) and their succession over time was opposite (**paper II**). However, in certain situations such as on the most palatable litter type in the coniferous forest (**paper IV**), intermediately recalcitrant litter type in the grassland (**paper II**)) their niches were overlapping (**paper II**, **IV**), which might point to a synergistic interaction (Meidute et al., 2008). Overall, *Actinobacteria* and fungi were litter quality dependent however, fungi seemed to be affected more by direct climatic factors (**papers III**, **IV**) and *Actinobacteria* more by indirect climatic factors such as habitat alteration (**papers II**, **III**, **IV**). Therefore, the climate derived changes leading to altered litter or precipitation might shift the fungal to actinobacterial ratio and thus the relationship between the two groups potentially leading to an altered decomposition process and carbon cycling.

### Concluding remarks

From the results described above, I conclude that *Actinobacteria* communities might play important roles in anthropogenic and natural habitats and are directly and indirectly influenced by human-derived changes. The thesis might help in improving the study of *Actinobacteria* with a novel marker gene *hsp*65. We also suggest that *Actinobacteria* are adaptable members of microbial communities, particularly to man-induced changes in caves

and during decomposition processes on a plant litter. Consequently, this taxonomic group might be proposed as a bioindicator in monitoring of environmental quality or in prediction models. Thus, *Actinobacteria* deserve a closer attention and more studies showing how their activity is modified by human derived changes. Moreover, our results show that interactions between *Actinobacteria* and other microbial members, especially fungi, might play an important role in driving the ecology of *Actinobacteria* in the studied environments. Thus, new experiments that would uncover the positive or negative interactions between *Actinobacteria* and fungi are proposed for understanding their combined contribution to decomposition and carbon cycling.

#### 17 Abstract

Actinobacteria are important cave inhabitants, but knowledge of how anthropization and 18 anthropization-related visual marks affect this community on cave walls is missing. We compared 19 20 Actinobacteria communities among four French limestone caves (Mouflon, Reille, Rouffignac, and Lascaux) ranging from pristine to anthropized and within Lascaux Cave between marked and 21 unmarked areas on walls in different rooms (Sas-1, Passage, Apse, and Diaclase). In addition to 22 23 the 16S rRNA gene marker, 441-bp fragments of a heat shock protein gene (hsp65) were used for the identification of Actinobacteria to the species level by Illumina MiSeq analysis. The hsp65 24 marker revealed higher resolution for species and richness (at 99% OTUs cutoff) assessment than 25 did 16S rRNA, which on the other hand identified more taxa on higher taxonomic ranks. 26 Actinobacteria communities varied between Mouflon and Reille (both pristine), Rouffignac 27 28 (anthropized/visited), and Lascaux (strongly anthropized and now closed to the public). 29 Rouffignac displayed high diversity of Nocardia, including species with potential pathogeny (i.e. N. carnea, N. paucivorans, N. abscessus), and Lascaux high Mycobacterium abundance, whereas 30 Gaiellales were typical in pristine caves and the Diaclase i.e. the least affected room of Lascaux 31 Cave. Within Lascaux, the Pseudonocardiaceae dominated on unmarked walls and the 32 Streptomycetaceae (especially Streptomyces mirabilis) on marked surfaces, raising questions on 33 the possible role of S. mirabilis in the formation of visual marks. Our results show how the use of 34 the hsp65 marker, well beyond the resolution provided by 16S rRNA sequences, enabled for the 35 first time to document species-level variations of the Actinobacteria community according to the 36 extent of anthropogenic pressure. This approach proved effective when comparing different 37 limestone caves or specific conditions within a cave. 38

#### 40 Introduction

Limestone caves are considered to be rather isolated habitats that are extremely limited in 42 organic carbon (Barton et al., 2007), which leads to the development of microbial strategies 43 enabling adaptation to oligotrophic conditions and a high calcium content (Barton & Jurado, 2007; 44 De Mandal, Chatterjee, & Kumar, 2017; Ortiz et al., 2014). Some of these caves contain Paleolithic 45 artwork and thus are frequently visited by tourists (Alonso et al., 2019; Schabereiter-Gurtner, Saiz-46 Jimenez, Pinar, Lubitz, & Rölleke, 2002). As a result, human-derived dispersion of endogenous as 47 well as exogenous nutrients and microorganisms inside the caves together with the human 48 metabolism may change their internal microclimatic and microbiological conditions (Hoyos, 49 Cañaveras, Sánchez-Moral, Sanz-Rubio, & Soler, 1998; Mulec, 2014). Microorganisms can be 50 resilient to changes to some extent (Johnston, Muench, Banks, & Barton, 2012; Tomczyk-Żak & 51 52 Zielenkiewicz, 2016). Community shifts may also take place, which deserves attention if it could favor microorganisms with biodeterioration ability (F. Bastian, Jurado, Novakova, Alabouvette, & 53 Saiz-Jimenez, 2010; Fernandez-Cortes et al., 2011; Sánchez-Moral et al., 1999) or increase the 54 proportion of species harboring strains with pathogenic potential (Bercea, Năstase-Bucur, 55 Moldovan, Kenesz, & Constantin, 2019; Neral, Rajput, & Rai, 2015; Rajput, Rai, & Biswas, 2012). 56 If it were the case, such shifts could represent a threat for cave conservation and the health of 57 visitors, respectively. 58

*Actinobacteria* represent an important cave taxonomic group, from which many potentially
pathogenic (Valme Jurado et al., 2010), biotechnologically relevant (Bhullar et al., 2012; Hamedi,
Kafshnouchi, & Ranjbaran, 2019; Syiemiong & Jha, 2019) and novel (Fang et al., 2017; V. Jurado
et al., 2008; Valme Jurado, Kroppenstedt, et al., 2009; Rangseekaew & Pathom-aree, 2019) species
have been found in these environments. *Actinobacteria* can dominate both in anthropized

(Gonzalez-Pimentel et al., 2018) and pristine caves (De Mandal et al., 2017), but some 64 actinobacterial taxa are specific only one type of cave. For example, Pseudonocardiaceae are 65 known as indicators of urban contamination (Miller et al., 2018) and dominate in some anthropized 66 caves, but this dominance is most likely due to their ability to degrade exogenous organic 67 compounds (Lavoie et al., 2017; Porca, Jurado, Žgur-Bertok, Saiz-Jimenez, & Pašić, 2012). This 68 is partially true as well for Streptomycetaceae, which were also found among pristine cave 69 inhabitants (Maciejewska et al., 2017). Furthermore, these taxonomic groups seem to be prominent 70 in pigment-forming communities on the walls of certain show caves (Cuezva et al., 2012; Porca et 71 al., 2012). In contrast, Euzebyales (Gonzalez-Pimentel et al., 2018), Nocardiaceae (De Mandal et 72 73 al., 2017) and Gaiellales (Zhu et al., 2019) represent oligotrophic taxa that dominate in pristine caves, most likely because of their ability to degrade complex compounds which are indigenously 74 75 present in the cave or fix CO<sub>2</sub>.

76 Actinobacteria taxonomic identification in these environments has largely been based on culture-dependent approaches and 16S rRNA sequencing (De Mandal et al., 2017; Yasir, 2018). 77 78 The culture-dependent approaches limits the coverage of the community and thus should be used only as a supportive determinant with molecular approaches (Hamedi et al., 2019; Long et al., 79 2019). The 16S rRNA gene is the marker most frequently used for bacterial systematics but 80 generally cannot resolve individual sequences at the species level (Fox, Wisotzkey, & Jurtshuk, 81 1992; Hirsch, Mauchline, & Clark, 2010). In addition, identical 16S rRNA gene sequences can be 82 found in different taxa or different 16S rRNA gene sequences in a single species (Větrovský & 83 Baldrian, 2013). Other protein-coding genes with high sequence polymorphisms (i.e., *rpoB*, *gyrB*, 84 hsp65) permit the distinction between closely-related strains. However, some of these protein-85 coding markers may also have their limits as it is the case of rpoB gene who is present twice is 86

some genus belonging to Actinobacteria, they only target limited number of Actinobacteria or no 87 appropriate reference database is available for taxonomic identification (Gao & Gupta, 2012; 88 Takeda, Kang, Yazawa, Gonoi, & Mikami, 2010; Vos, Quince, Pijl, de Hollander, & Kowalchuk, 89 2012). Nevertheless, the gene of a molecular chaperone, the 65-kDa heat-shock protein (hsp65), 90 when amplified by specific primers (Telenti et al., 1993), has been used as a molecular marker for 91 identifying a large number of Actinobacteria isolates (Rodríguez-Nava et al., 2006, 2007). This 92 gene is present in Actinobacteria genomes as a single copy, unlike the 16S rRNA gene marker 93 (Colaco & MacDougall, 2014), and hsp65 is considered to be a good candidate for making detailed 94 Actinobacteria community assessments from environmental DNA. Additionally, the amplified 95 fragment length of *hsp*65 (441 bp) is sufficient for amplicon sequencing. 96

Lascaux Cave underwent several events of microbial outgrowth since the 1960s, as well as 97 98 (sometimes unsuccessful) chemical treatments, which resulted in the formation of various visual 99 marks (including stains) and threatened Paleolithic artwork (F. Bastian et al., 2010; Martin-Sanchez, Miller, & Saiz-Jimenez, 2015). For the sake of cave conservation, Lascaux was closed 100 101 to the public in 1963. Although the few microbiological studies conducted in this cave suggest that Actinobacteria is one of prevalent groups (Alonso et al., 2018, 2019; Martin-Sanchez, Nováková, 102 Bastian, Alabouvette, & Saiz-Jimenez, 2012), a more complete investigation of the Actinobacteria 103 community is lacking, especially at the species level. If we consider that key functional traits can 104 be related to precise species within the Actinobacteria, we can hypothesize that such an assessment 105 would allow a better discrimination of Actinobacteria communities according to ecological 106 conditions. 107

108 The objective of this work was to assess the usefulness of *hsp*65 marker (as a complement 109 to 16S rRNA sequence data) for a deeper, species-level appraisal of the *Actinobacteria* community in caves, and to show variations according to cave conditions and especially human-induced
disturbances (Mammola, 2019). These aims were achieved by comparing *Actinobacteria*communities in pristine limestone caves (Reille and Mouflon Caves) and anthropized caves
(Lascaux and Rouffignac Caves), and within Lascaux Cave of marked and unmarked areas in
different rooms (i.e., Sas-1, Passage, Apse, and Diaclase). To this end, *Actinobacteria* were
identified for the first time to the species level in cave environments, using metabarcoding analysis
of the *hsp*65 gene marker.

#### **118** Materials and methods

#### 119 Study site description and sample collection

Samples were collected in May - June 2016 from the walls of four limestone caves located
in the Dordogne department of southwestern France: Lascaux (45°03'13" N 1°10'12"E, 235 m
length); Rouffignac (45°00'31"N 0°59'16"E, 8,000 m length); Reille (45°07'09.5"N 1°07'11.2"E,
2,000 m length) and Mouflon (44°55'N 1°5'E, 280 m length) (Fig. 1A).

Lascaux and Rouffignac caves contain Paleolithic wall paintings and engravings and are listed as UNESCO World Heritage Sites. Both caves are anthropized, Rouffignac being open for touristic visits since 1959 (with up to 500 visitors per day) (5) and Lascaux being closed after 15 years of tourism (with up to 2000 visitors per day). Various visual marks have developed at different times in Lascaux Cave, and extensive chemical treatments have been applied (13,42, 44, 45). Mouflon and Reille Caves are in a pristine state (5). The entrance of Mouflon Cave was locked
shortly after discovery, whereas Reille is occasionally explored by seasoned speleologists.

In Lascaux Cave, samples were taken from the walls of four distinct rooms representing 136 different cave environments that were located progressively farther from the entrance in the 137 following order: Sas-1, Passage, Apse and Diaclase (Fig. 1B). Sas-1 is a man-made, calcareous 138 airlock entrance and is isolated by doors from the cave interior and exterior. The Passage is a 139 central alley connecting different rooms of Lascaux Cave. In the Passage, samples were taken from 140 two mineral substrates: clay deposits (banks, later referred to as Passage B) and near-vertical 141 limestone walls (inclined planes, later referred to as Passage IP). In the Apse, samples were 142 143 collected from limestone inclined planes. The Diaclase is a distinct compartment located below the main part of the cave and was least-affected by humans. It is separated from the Apse by a trap 144 145 door, received limited biocide treatments, and was never open to tourists. Samples originated from 146 limestone walls located immediately below the Apse, in an area of the Diaclase termed the Shaft of the Dead Man. 147

Within each room, samples were collected from visual marks and unstained surfaces, as 148 described (Alonso et al., 2018). Approximately 50 mg of wall material samples (3-6 replicates) 149 were collected using sterile scalpels and placed in liquid nitrogen for transportation to the 150 laboratory, where they were stored at -80°C until DNA extraction. Overall, six samples from 151 Rouffignac, six from Mouflon, five from Reille and 41 from Lascaux (five from Sas-1, six from 152 Passage B, six from Passage IP, 18 from Apse and six from Diaclase) were used for subsequent 153 154 microbial analysis (Table S1). Sampling was performed in accordance with the caves' rules and regulations. 155

### 157 DNA extraction and amplicon sequencing

DNA extraction was performed using the FastDNA SPIN Kit for Soil (MP Biomedicals,
Illkirch, France) following the manufacturer's instructions and was adapted to the low sample
amounts, as described (Alonso et al., 2018). The elution step was achieved using two volumes of
50 μl elution buffer for each sample.

For bacterial 16S rRNA gene amplification, we used the primers 341F (CCTACGGGNGGCWGCAG) and 805R (GACTACHVGGGTATCTAATCC), which target the V3-V4 region (428-bp fragments) (Herlemann et al., 2011). Amplification and sequencing were carried out by the Fasteris Company (Geneva, Switzerland) using the Illumina MiSeq Reagent Kit v3 (600 cycles) with the paired-end mode, resulting in  $2 \times 300$  bp sequence reads, as described by *Alonso* et al. (Alonso et al., 2018).

The 441-bp fragments of the 65-kDa heat shock protein gene (hsp65) were amplified by 168 169 PCR using the specific primers TB11 (ACCAACGATGGTGTGTCCAT) and TB12 (CTTGTCGAACCGCATACCCT) from Telenti et al. (Telenti et al., 1993). Amplification was 170 carried out in a reaction mixture with a total volume of 25 µl in packaged PCR tubes (Ready-to-171 Go PCR Beads; Amersham Biosciences, Piscataway, NJ) (2.5 U of Taq polymerase puRe Taq, 10 172 mM Tris-HCl [pH 9], 50 mM KCl, 1.5 mM MgCl<sub>2</sub>, and 200 µM of each deoxynucleoside 173 triphosphate) with primers  $(0.2 - 0.4 \mu M, \text{depending on the template concentration})$  and DNA (1 174 - 40 ng). The PCR cycling protocol consisted of an initial denaturation at 94°C for 5 min, then 35 175 cycles of denaturation (94°C for 60 s), annealing (55°C for 60 s), and elongation (72°C for 60 s) 176 177 (Rodríguez-Nava et al., 2006). Sequencing was carried out (together with purification and quality control) by the Biofidal Company (Biofidal, Vaulx-en-Velin, France - http://www.biofidal-178 lab.com) using the Illumina MiSeq Flow Cell V3 with the paired-end mode, resulting in 2 x 300 179

bp sequence reads. Overall, 50 samples for 16S rRNA gene and 45 samples for *hsp*65 were
successfully sequenced, but sequences for both markers were obtained for only 37 samples (Table
S1).

# 184 Processing and analysis of sequence data

The paired sequence reads from sequencing were merged using FLASh (Fast Length 185 Adjustment of Short reads (Magoč & Salzberg, 2011)) with a maximum of 25% mismatches in the 186 overlapping region. The sequences were then filtered and aligned using reference alignments of 187 the *hsp*65 gene sequences (this work) or using the 16S rRNA gene sequences from the Silva 188 database (Quast et al., 2012). Chimeric sequences were removed using the integrated Vsearch tool 189 (Rognes, Flouri, Nichols, Quince, & Mahé, 2016) according to the MiSeq standard operating 190 procedure (MiSeq SOP, February 2018) (Kozich, Westcott, Baxter, Highlander, & Schloss, 2013) 191 in Mothur v. 1.39.5 software (Schloss et al., 2009). Taxonomical assignments of sequence libraries 192 were performed in Mothur using the hsp65 reference database for the hsp65 sequences and the 193 recreated SEED database subset of the Silva Small Subunit rRNA Database, release 132 (Yilmaz 194 et al., 2014), adapted for use in Mothur (https://mothur.org/w/images/a/a4/Sylva.seed v132.tgz), 195 as the reference database for the 16S rRNA gene sequences. 196

197 The sequences of plastids and mitochondria and those not classified in the domain Bacteria 198 (from the 16S rRNA sequence library), as well as sequences identified as homologs for *hsp*65 199 (*groEL*, in the database renamed as GROESL; see the *hsp*65 reference database design section) 200 (from the *hsp*65 sequence library), were discarded. The sequence library was clustered into 201 operational taxonomic units (OTUs) using the Uparse pipeline in Usearch v10.0.240 software 202 (OTUs at a 97% cutoff) (35) and Mothur (OTUs at a 99% cutoff). The OTU table was further 203 processed using tools implemented in Mothur. For 16S rRNA genes, only sequences
204 corresponding to *Actinobacteria* were used.

For comparison of Actinobacteria among the caves, 25 samples for hsp65 and 24 samples 205 for 16S rRNA genes were used. Apse and Diaclase (both unmarked areas) were chosen as 206 representative samples for Lascaux Cave except for core microbiome analysis, for which all the 207 Lascaux Cave samples were included. To test the differences among locations in Lascaux Cave, 208 209 33 samples for hsp65 and 38 samples for 16S rRNA were used. Among those, from marked areas 16 samples for hsp65 and 20 samples for 16S rRNA were used. From unmarked areas 17 samples 210 for hsp65 and 18 samples for 16S rRNA were used (Table S1). For 16S rRNA marker, Sas-1 211 212 unmarked area samples are missing for the analysis, because low number of replicates were successfully sequenced. To obtain the highest number of replicates per sample, all samples, even 213 214 when they were not common to both markers, were included in the analysis. 37 common samples 215 for both markers were used for analyses comparing the usefulness of both makers (rarefaction analysis, comparison of diversity indices and number of taxa recovered at different taxonomy 216 217 ranks).

Rarefaction analysis was performed to analyze the richness of the *Actinobacteria* OTUs based on two cutoffs (i.e., 97% and 99%) as a function of sample number. The alpha diversity indices (richness: Chao 1, evenness: Simpson Evenness, and diversity: Inverse Simpson) were calculated in Mothur (97%, 99% OTU cutoff). Significant differences among samples were calculated by ANOVA with Tukey's post hoc test (P < 0.05; Caves and locations in Lascaux Cave), t tests and F tests (P < 0.05; marked/unmarked areas) in Past 4.02 software (Hammer, Harper, & Ryan, 2001). Bray-Curtis distance matrices describing the differences in bacterial community composition among individual samples were calculated. The *Actinobacterial* communities in the caves, in the different locations of Lascaux Cave, and between marked and unmarked areas within each location were compared by nonmetric multidimensional scaling (NMDS) according to both gene markers (97% OTU cutoff). Analysis of molecular variance (AMOVA) and homogeneity of molecular variance (HOMOVA) were calculated in Mothur with 100,000 iterations for the same factors (97% OTU cutoff).

Pairwise comparisons with Metastats (Segata et al., 2011) and biomarker searching 232 analysis with Lefse (Segata et al., 2011) were calculated to identify the Actinobacteria OTUs that 233 234 were significantly different among the respective caves, locations and marked/unmarked areas in Lascaux Cave (99% OTU cutoffs). Metastats was also used to compare the relative abundances of 235 Streptomyces sequences among the marked/unmarked areas (hsp65 marker). Venn diagrams were 236 237 created in Mothur to test the number of OTUs that encompassed the core microbiome for the different caves and four rooms (e.g., Sas-1, Passage, Apse, and Diaclase) in Lascaux Cave (99% 238 OTU cutoff). 239

Taxonomical classification of OTUs was performed with Mothur by using the *hsp*65 and 16S rRNA reference databases, and the *hsp*65 marker was verified by BLASTN in the online databases of the National Center for Biotechnology Information (NCBI; U.S. National Library of Medicine, MD, USA). The taxonomical composition of the core microbiome was constructed using the Krona tool (Ondov, Bergman, & Phillippy, 2011). The number of taxa recovered with the common samples by *hsp*65 and 16S rRNA at different taxonomic ranks were calculated and displayed by Venn diagrams.

Co-occurrence networks were used to predict how marked/unmarked areas and different 247 locations influenced the relative abundances of Actinobacteria in Lascaux Cave. Spearman 248 correlation coefficients were computed in Mothur for Lascaux Cave OTUs and were categorized 249 according to their significantly different proportions in the marked/unmarked areas regardless of 250 the location in Lascaux Cave (Metastats) or for the Lascaux Cave locations (Lefse) (99% OTU 251 cutoff). Only significant (P < 0.03) correlations higher than 0.8/0.8 and lower than -0.35/-0.5 for 252 253 the hsp65/16S rRNA markers, respectively, were visualized in Gephi 0.9.2. (M. Bastian, Heymann, & Jacomy, 2009) by Fruchterman-Reingold spatialization (Fruchterman & Reingold, 254 1991). The average degree, eigenvector centrality and modularity were computed, and the 255 256 minimum number of links was filtered to 5 (using a degree range filter).

Figures were plotted using the vegan package (Oksanen et al., 2018) in the R computing environment (R Core Team, 2018) and in Inkscape (v0.92; <u>http://www.inkscape.org</u>).

The Illumina MiSeq 16S rRNA and *hsp*65 gene amplicon sequences were deposited in the
NCBI Sequence Read Archive (www.ncbi.nlm.nih.gov/sra).

#### 262 In silico analysis

Determination of the differences in the variability of the *hsp*65 and 16S rRNA partial gene sequences between pairs of *Actinobacteria* strains at different taxonomical levels (e.g., intraclass, intraorder, intrafamily, and intragenus) was performed on genomes retrieved from the Integrated Microbial Genomes and Microbiomes database (IMG; University of California, CA, USA, https://img.jgi.doe.gov/). For the analysis, sequences from the available genomes of 47 species from the order *Streptomycetales* (*Streptomyces, Kitakatospora*, Table S2) and 58 species from the order *Corynebacteriales* (family *Corynebacteriaceae: Corynebacterium*; family *Gordoniaceae:*  *Gordonia*; family *Mycobacteriaceae: Mycobacterium*; family *Nocardiaceae: Nocardia*, *Rhodococcus*; Table S2) were used. Sequences were aligned and trimmed to the amplified length
of both gene markers in BioEdit 7.2.5 software (Hall, Biosciences, & Carlsbad, 2011). The
pairwise distances between sequences were calculated in Mothur v. 1.39.5 software (Schloss et al.,
2009).

275

### 276 *hsp*65 reference database design

For taxonomic assignment using the hsp65 marker, the reference database of the 277 Actinobacteria hsp65 gene was constructed similarly to that of the rpoB marker in the study of 278 279 Ogier et al. (2019) (Ogier, Pagès, Galan, Barret, & Gaudriault, 2019). Sequences homologous to the 65-kDA heat shock protein (hsp65) of the reference strain Nocardia asteroides ATCC 14759 280 (Rodríguez-Nava et al., 2006) amplified by the TB11 and TB12 primers (Telenti et al., 1993) were 281 282 collected in the online databases of IMG and NCBI. Paralogs of heat shock proteins, such as groEL genes from Escherichia coli (Colaco & MacDougall, 2014; Duchêne, Kieser, Hopwood, 283 Thompson, & Mazodier, 1994; C. M. S. Kumar, Mande, & Mahajan, 2015), were identified using 284 maximum-likelihood, FastTree 2.1 (Price, Dehal, & Arkin, 2010) and were kept in the reference 285 database (renamed as GROESL sequences) as an outgroup that enabled amplified sequences 286 belonging to this variant to be discarded. 287

The *hsp*65 database contained 5,165 sequences, of which 1,782 sequences were denoted as GROESL at the time of the analysis. Evaluation of the TB11 and TB12 primer complementarity with the sequences from the reference database was performed using the OligoAnalyzer 3.1 tool (<u>http://www.idtdna.com/calc/analyzer</u>). The percent coverage of the primers of *Actinobacteria* genomes from different classes and orders was determined with primer BLAST using the RefSeq

- reference genomes (NCBI). Only targets with no mismatches for the last three nucleotides at the
- 294 3' end and no more than 4 overall mismatches were included.

#### 295 Results

# 296 Sequence polymorphism of *hsp*65 versus 16S rRNA genes for cave *Actinobacteria*

A total of 1,799,680 *hsp*65 and 1,919,236 16S rRNA gene sequence reads were obtained for cave *Actinobacteria*. They were mapped to 968 (97% cutoff) and 4,265 OTUs (99% cutoff) for *hsp*65, vs only 299 (97% cutoff) and 718 OTUs (99% cutoff) for 16S rRNA genes.

The curves of 16S rRNA genes for both cutoffs were more skewed and thus indicated an accumulation of identical OTUs due to their repeated sampling, which did not increase with a stricter cutoff, in contrast to *hsp*65 (Fig. 2A). These results are in accordance with the *in silico* analysis of *hsp*65 and 16S rRNA partial gene sequences downloaded from genomes available on IMG, where the pairwise distances between *hsp*65 sequences, even for closely related species, were higher than those between 16S rRNA genes (Fig. 2B).

The hsp65 primers targeted hsp65 sequences from the reference database with lower 312 numbers of mismatches compared to the outgroup (i.e., distant homologs renamed in the database 313 as GROESL, GroEl of Escherichia coli and Chloroflexi members) (Table S3). However, the 314 primers targeted only selected groups from the class Actinobacteria as can be seen from analysis 315 with representative genomes from online database (Table S4). Moreover, the number of taxa 316 identified at class or lower categories is shown in a Fig. 3. At the class level, 20% of the detected 317 318 class with hsp65 were also recovered with 16S rRNA, 32.3% it was for order 36.1% for family, 319 24.6% for genus-level taxa. Although the number of taxa detected uniquely by hsp65 marker had increasing trend with the lower taxonomic category, contrary to 16S rRNA, hsp65 detected overall 320 321 lower number of taxa. However, on a species level overall 168 species were recovered only by hsp65 marker, where the highest species number were found for Streptomyces, Mycobacterium 322 and Nocardia genera (Table S5). 323

This means that the 16S rRNA marker was more suited for broad taxonomic profiling of the *Actinobacteria* community. In comparison, the *hsp*65 marker could distinguish between selected *Actinobacteria* species, which the 16S marker failed to achieve, and thus it completed the results from the 16S rRNA marker (Table S5).

## 334 Actinobacteria diversity in caves based on hsp65 versus 16S rRNA genes

According to the diversity analysis based on 37 common samples of both markers, the *hsp*65 marker recorded higher richness (Chao-1 index) and eveness (Simpson evenness index) only when considering the 99% OTU cutoff than 16S rRNA marker (Table S6). The diversity analysis

based on all samples indicated that Rouffignac Cave exhibited the highest Actinobacteria richness 338 (Chao 1 index, for the hsp65 marker; Fig. S1) but lower evenness (Simpson evenness index; for 339 both markers; Fig. S1) as well as diversity (Inverse Simpson index; for the 16S rRNA marker; Fig. 340 S1) among other caves. In contrast, the Lascaux and Rouffignac Caves had lower evenness than 341 the pristine Reille (for the 16S rRNA marker) and the Mouflon Caves (for the hsp65 marker; Fig. 342 S1). When comparing locations within Lascaux Cave, only the difference in Actinobacteria 343 richness between Sas-1 and Passage B was significant (for the 16S rRNA marker; Fig. S1). The 344 average diversity of the unmarked areas was higher than that of the marked areas for both markers, 345 (Fig. S1). Therefore, when documenting diversity *hsp*65 might uncovered the high richness in 346 347 some of the samples which was not recorded by the 16S rRNA marker.

# 349 Actinobacteria community structure in caves based on hsp65 versus 168 rRNA genes

NMDS analysis was conducted to compare the Actinobacteria communities in caves (97% 350 351 OTU cutoff). These communities did not differ significantly between pristine caves Reille and Mouflon (AMOVA), based on hsp65 and 16S rRNA genes. NMDS distinguished three groups of 352 communities corresponding to Lascaux, Rouffignac, and the two pristine caves Reille and 353 Mouflon, which was further supported by AMOVA (Table S7 A). The AMOVA comparison of 354 two groups: anthropized (Lascaux and Rouffignac) and pristine (Reille and Mouflon) caves 355 showed, that they significantly differed according to both markers (hsp65: F= 3.986, p < 0.001, 356 16S rRNA: F=8.610, p < 0.001). Within Lascaux Cave, the Actinobacteria communities differed 357 largely according to all locations (i.e. Sas-1, Passage B, Passage IP, Apse, Diaclase) with both 358 markers, except that differences between Passage IP, Sas-1 (both markers) and Diaclase (hsp65) 359 were not significant due to the low number of samples (Table S7 A). Overall, the effect of surface 360

alterations (i.e. marked vs unmarked areas) in Lascaux Cave was significant for both markers
(Table S7 A), with higher *Actinobacteria* stability in unmarked than vs marked areas (Table S7
B). Passage B had the highest community stability compared to Passage IP, Apse and Diaclase
(Table S7 B), which was reflected in the NMDS plot, where the marked and unmarked areas in
Passage IP were the least separated from one another (Fig. 4).

373 Core and cave-specific Actinobacteria microbiomes based on hsp65 versus 16S rRNA genes

Venn diagrams indicated that the number of OTUs shared between different caves 374 (Rouffignac, Lascaux, Mouflon, Reille) was only 2 (0.04%) for the hsp65 marker vs 72 (11%) for 375 376 the 16S rRNA marker (Fig. S2). Similarly, the number of OTUs shared between different Lascaux rooms (Sas-1, Passage, Apse, Diaclase) reached 23 OTUs (0.89%) for the hsp65 marker vs as 377 many as 88 (15.9%) for the 16S rRNA marker. The core microbiome was constituted especially 378 by Pseudonocardiales and Streptomycetales, as determined by hsp65, and Gaiellales, 379 Pseudonocardiales and strain IMCC26256 ge, as determined by 16S rRNA genes (Fig. S3). 380 The pairwise comparison of cave conditions (Rouffignac, Lascaux's Apse and Diaclase, 381 Mouflon, Reille) using significantly different OTUs (Metastats) showed that Rouffignac (based on 382 hsp65) and Lascaux's Apse (based on 16S rRNA genes) were most enriched in OTUs, separating 383 384 them from the other caves (Fig. 5). Among them, Pseudonocardiaceae, Crosiella and Nocardia were the most abundant taxa that distinguished Rouffignac (for both markers), while Nocardioides, 385 Rhodococcus, Pseudonocardia distinguished Lascaux's Apse from the other caves and Diaclase. 386 Mycobacterium was uniquely found in Lascaux's Apse according to both markers. Pristine caves 387

388 were typified by *Streptomyces* (*hsp*65 marker), *Gaiellales, Pseudonocardiales* and the 389 environmental clones MB-A2-108 ge and IMCC26256 ge (16S rRNA genes)(Fig. 5).

# 395 Proportions of cave Actinobacteria in sequences libraries based on hsp65 versus 168 rRNA 396 genes

Taxonomical analysis showed that Jiangellaceae, Actinobacteria incertae sedis 397 398 Brevibacteriaceae, Nocardiopsaceae and Gordoniaceae were uniquely identified by hsp65 marker 399 but not by 16S rRNA marker. Nocardioidaceae, Streptomycetaceae and Pseudonocardiaceae dominated the sequence libraries of both gene markers, when considering all cave conditions 400 together. Nocardioidaceae and Streptomycetaceae (according to hsp65) while Nocardiaceae and 401 Streptomycetaceae (according to 16S rRNA marker) were redundant especially in Lascaux Cave. 402 According to both gene markers, Streptomycetaceae were in a higher proportion in marked areas 403 than in unmarked areas of the Lascaux cave (Fig. 6). With a closer focus on Streptomyces using 404

only the hsp65 marker, which contrary to 16S rRNA can identify the species, S. mirabilis, S. 405 niveus, and S. fulvissimus were the three species, which dominated in marked areas within Lascaux 406 Cave (Metastats P < 0.005; Fig. S4). The opposite result was found for *Pseudonocardiaceae*, 407 which were more proportionally abundant in Lascaux's unmarked areas than in marked areas 408 except for Passage IP (by hsp65) and Passage B (by 16S rRNA marker) (Fig. 6). Mycobacteriaceae 409 were found to be highly abundant in Lascaux Cave, and the *hsp*65 marker also identified them in 410 Mouflon. Jiangellaceae was a group that was typical in Rouffignac and Passage IP (hsp65 marker). 411 Closer analysis of Nocardiaceae with the hsp65 marker uncovered the greatest richness of 412 Nocardia species in Rouffignac (including N. carnea, N. paucivorans, N. abscessus). Moreover, 413 414 high proportions of N. jejuensis in Lascaux and Mouflon, and N. cummidelens in Rouffignac, Apse and Reille were found (Fig. S5). Both pristine caves had similar compositions of Actinobacteria 415 416 communities, especially Gaiellaceae, taxa related to the environmental clones MB-A2-108 fa and 417 IMCC26256 fa (16S rRNA marker), and high proportions of unclassified Actinobacteria (hsp65), High proportions of unclassified Actinobacteria were similarly to pristine caves observed in 418 419 Diaclase (Fig. 6).

#### 429 Co-occurrence of *Actinobacteria* in Lascaux Cave based on *hsp*65 versus 16S rRNA genes

Co-occurrence networks showed the Spearman correlations between the relative abundances of the *Actinobacteria* OTUs in Lascaux Cave (Fig. 7). The co-occurrence networks identify OTUs significantly different for any of the Lascaux locations (calculated by Lefse) or for marked/unmarked areas (calculated by Metastats). More co-occurrence connections were found for *hsp*65 than for 16S rRNA marker. For *hsp*65 marker, more correlated OTUs were not indicated by Lefse or Metastats as typical for any of the Lascaux location or marked/unmarked area, respectively. Negative correlations between the OTUs revealed only 16S rRNA marker.

We found clusters of correlated OTUs dominating the unmarked areas that were also 437 significantly different in the Apse and Diaclase based on both gene markers (Fig. 7). Additionally, 438 OTUs clusters that dominated the marked areas were typical for the Diaclase and Sas-1 areas based 439 440 on the 16S rRNA marker. The OTUs from such distinct areas (Diaclase and Sas-1) correlated with each other, suggesting that the marked areas factors affected the Actinobacteria communities in 441 both locations (Fig. 7). However, the hsp65 gene marker showed that the OTU clusters typical of 442 marked areas were not typical for any of the Lascaux Cave locations. Finally, based on 16S rRNA 443 marker, the highest number of correlations between OTUs that did not differ between the marked 444 and unmarked areas was found for those that dominated in Passage B, Sas-1 and Diaclase (Fig. 7). 445 For those OTUs, the location factor was more influential than the marked/unmarked areas. 446 Networks based on both markers include variable actors (except the OTUs in unmarked areas of 447 Apse and in Diaclase regardless marked/unmarked areas) which show that each marker cover 448 different part of community and their interactions. 449

#### 459 **Discussion**

This study represents the first attempt to exploit the potential of hsp65 as a taxonomic 460 marker more discriminant than the 16S rRNA gene to document Actinobacteria diversity at the 461 species level in cave environments. Indeed, Venn results showed a higher variability for hsp65 462 sequences than for Actinobacteria 16S rRNA sequences, and a higher OTU richness (at the 99% 463 cutoff) of Actinobacteria was obtained. Moreover, thanks to hsp65 marker we evidenced 168 464 species which could not be identified by the same samples number of 16S rRNA marker. 465 Therefore, lower interspecific variation of 16S rRNA might underestimates the true diversity 466 which might be obtained by hsp65 marker as was similarly found for other protein-coding gene, 467 (namely rpoB) (Vos et al., 2012). However, overall more taxa on higher taxonomic ranks were 468 identified by 16S rRNA than hsp65 marker which might point on gaps in reference database which 469 470 prevent complete taxonomic assignment of *hsp*65 sequences. Another reason might be a problem 471 with mismatch primers. As was shown by in silico analysis, the primers amplify the gene from diverse Actinobacteria genomes, but targets without perfect homology might be amplified with 472 473 lower efficiency leading to underestimation of some taxa (Deagle, Jarman, Coissac, Pompanon, & Taberlet, 2014). It confirms that hsp65 marker is suitable complement for 16S rRNA in high 474 throughput sequencing methods, especially for specific taxonomic groups analysis into species 475 level, but possible primer biases might be take into account especially for community analysis at 476 higher taxonomic ranks. 477

In this study, the combination of *hsp*65 and 16S rRNA markers showed that *Actinobacteria* diversity could vary according to anthropization in caves, at both higher (i.e., between caves) and lower (i.e., between locations within one cave) spatial scales. Indeed, the actinobacterial communities of anthropized (Lascaux and Rouffignac) and pristine caves (Reille and Mouflon) differed. The occurrence of these caves in the same region and limestone vein probably facilitated this observation, as geographic distance (Barraclough, Balbi, & Ellis, 2012) and geological type (Zhu et al., 2019) are significant factors influencing cave communities. The core *Actinobacteria* microbiome was relatively small (especially for *hsp*65) but it included typical pristine cave taxa, indicating that at least part of the community was able to resist anthropogenic disturbances (Shade et al., 2012).

Mouflon and Reille are pristine caves with evenly distributed taxa in the Actinobacteria 488 community, possibly as a result of their stable environments without man-made disturbances 489 (Mammola, 2019). Typical pristine cave taxa were evidenced in Mouflon and Reille, such as 490 Gaiellales (Zhu et al., 2019) and Actinobacteria related to the environmental clone MB-A2-491 108 ge (A. DE Kumar et al., 2019; Zhang et al., 2019) according to the 16S rRNA marker.-vs 492 493 High proportions of Streptomyces and unclassified Actinobacteria based on hsp65 data suggest 494 that each marker selectively identify partly a different Actinobacteria community. Environmental selection in oligotrophic habitats may promote high molecular evolution (Kuo & Ochman, 2009a; 495 496 Sagova-Mareckova et al., 2015a) and result in a high number of novel species isolated from caves (A. DE Kumar et al., 2019). A similar result was also found for Streptomyces genera (Hamm et 497 al., 2017), whose genomes may undergo a high evolution rate (Cheng et al., 2015). Interestingly, 498 similar results (i.e. high proportions of Streptomyces) to those for pristine caves were obtained 499 from Diaclase, which is an isolated site within the anthropized Lascaux Cave (Kuo & Ochman, 500 2009b; Sagova-Mareckova et al., 2015b), suggesting that it has remained at least partially 501 protected from human impacts. Therefore, not only individual caves but also less-exposed 502 locations within anthopized caves maintained a typical Actinobacteria cave community, which 503 probably include novel taxa not described so far (Rangseekaew & Pathom-Aree, 2019). 504

Contrary to a previous study based on whole bacterial community (Alonso et al., 2019), we 505 found a high richness but low evenness of Actinobacteria in the visited Rouffignac Cave compared 506 to the pristine caves based on hsp65 marker. The high richness of Actinobacteria in this cave might 507 be a result of community response to a disturbance, since more diverse community is more resilient 508 to stressfull conditions (Shade et al., 2012). Our results are especially supported by the dominance 509 of Pseudonocardiaceae (based on 16S rRNA sequences), an indicator of human contamination 510 (Miller et al., 2018), as well as by the highest richness of Nocardia species (based on the hsp65 511 marker). More specifically, in Lascaux and Mouflon dominated N. jejuensis, the species firstly 512 isolated from a natural cave, while in Reille, Rouffignac and Apse dominated N. cummidelens, a 513 514 species previously isolated from rocks of Altamira cave (Valme Jurado, Fernandez-Cortes, et al., 515 2009). However, Nocardia in Rouffignac uniquely included species with pathogenic potential, 516 such as N. carnea (Boiron, Provost, Chevrier, & Dupont, 1992), N. paucivorans (Watanabe et al., 517 2006), N. testacea (Taj-Aldeen et al., 2013), and N. abscessus (Kageyama et al., 2004). Although we cannot know if these environmental bacteria present any pathogenic potential, as those found 518 in human hosts, the enrichment of these species in caves points to a possible allochthonous input 519 by tourists. In turn, it raises the issue of potential health concerns, as proposed previously (Valme 520 Jurado et al., 2010), even though Actinobacteria disease problems related to cave frequentation 521 have never been reported. In contrast, Jiangellaceae are a typical pristine cave family 522 (Rangseekaew & Pathom-aree, 2019) and are another important group in Rouffignac Cave. 523 According to the intermediate disturbance hypothesis (Roxburgh, Shea, & Wilson, 2004), the 524 525 coexistence of typical pristine and anthropized taxa in one habitat may suggest that the cave is under intermediate environmental pressure. 526

The actinobacterial communities in caves were highly specific even within very close 527 distances (81), since each Lascaux room hosted its own Actinobacteria populations. Lascaux Cave 528 was typified by high abundances of Mycobacterium. Similar to Nocardia in Rouffignac, this group 529 can signify external contamination (Valme Jurado et al., 2010; Modra et al., 2017). Confirming 530 the previous results from Alonso et al. (2018) that were based on the whole bacterial community 531 (Alonso et al., 2018), the different geological substrates of Lascaux's Passage had a stronger role 532 than the occurrence of marks, but marks there (black stains) had formed years before. However, 533 the effect of geological substrate contrasted with Diaclase and Apse because these two locations 534 contained significantly different Actinobacteria, especially in unmarked areas, as shown by 535 network analysis. It is possible that the isolation and distance from the cave entrance represent the 536 best filter for alien microorganisms and enable the maintenance of the cave oligotrophic 537 community, which is typical for unmarked areas (Cuezva, Sanchez-Moral, Saiz-Jimenez, & 538 539 Cañaveras, 2009; Mammola, 2019).

Our results show that the Actinobacteria community, mainly Streptomyces, varied 540 541 according to the presence of visual marks. Marked areas, where Streptomycetaceae dominated, exhibited much lower diversity than unmarked zones, where Pseudonocardiaceae were prevalent. 542 Similarly to our study, the group *Pseudonocardiaceae* was confirmed as true cave rock dwellers 543 (Zhu et al., 2019). However, contrary to our results, this group was typically found in pigmented 544 zones of pristine caves (Lavoie et al., 2017). In addition, the members from the group 545 Pseudonocardiaceae are degraders of complex molecules and indicators of anthropogenic 546 contamination (Lavoie et al., 2017; Porca et al., 2012), which suggests that the unmarked areas 547 were not completely oligotrophic (Tomczyk-Żak & Zielenkiewicz, 2016). However, the higher 548 community diversity in unmarked areas than in marked areas indicates the prevalence of 549

cooperative relationships, which are typical for oligotrophic cave environments (Tomczyk-Żak &
Zielenkiewicz, 2016).

In contrast, the diversity of marked areas might be reduced due to the competitive 552 advantage of invading species (Hamm et al., 2017; Van Elsas et al., 2012). In isolated cave 553 systems, invasions are expected from the cave entrance, similar to Altamira Cave, where 554 Streptomyces is the most dominant group, especially in st ains (Groth, Vettermann, Schuetze, 555 Schumann, & Saiz-Jimenez, 1999). Moreover, they are generally known to be competitively 556 effective because of their secondary metabolite production, which is supported by the prevalence 557 of the antimicrobial producers S. mirabilis, with gray mycelium (El-Sayed, 2012), S. niveus 558 (Kominek, 1972), and S. fulvissimus (Myronovskyi, Tokovenko, Manderscheid, Petzke, & 559 Luzhetskyy, 2013) in stains. Hypothetically, Streptomyces might also contribute to pigment 560 561 production, as indicated in different studies (Abdel-Haliem, Sakr, Ali, Ghaly, & Sohlenkamp, 562 2013; Cuezva et al., 2012), or might affect the pigment-forming fungi that are involved in black stain formation in Lascaux Cave (De La Rosa et al., 2017; Frey-Klett et al., 2011). Another study 563 showed that Streptomyces cooperation with fungi in stains promoted mycelial extension and 564 secondary metabolite production of fungi (Frey-Klett et al., 2011). A previous study showed the 565 correlation between Streptomyces and pigment-forming fungi Acremonium and Exophiala in 566 Lascaux Cave, although only in unmarked areas (Alonso et al., 2018). Therefore, Streptomyces 567 role in black stains should be studied in more detail to evaluate if this group may represent a 568 missing chain for understanding stain development in Lascaux Cave. 569

To conclude, the *hsp*65 marker can be reliably used for differentiating *Actinobacteria* species present in environmental samples. However, in environmental studies, *hsp*65 should functionate as a complement for 16S rRNA gene, since 16S rRNA gene encompass larger part of Actinobacteria community but cannot resolve species. the *Actinobacteria* community at different spatial levels reflected the natural quality of the caves and different locations within Lascaux Cave. Anthropization was shown to shape *Actinobacteria* communities, which altered typical cave communities and was exhibited by the indicator *Actinobacteria*. We first found that the marked areas of Lascaux Cave are an important factor shaping *Actinobacteria* communities, with particular reference to the *Streptomyces*. Finally, the study revealed the linkage between *Actinobacteria* in anthropized caves and marked areas and may help promote the conservation of

ABSTRACT Soil microorganisms are diverse, although they share functions during the decomposition of organic matter. Thus, preferences for soil conditions and litter quality were explored to understand their niche partitioning. A 1-year-long litterbag transplant experiment evaluated how soil physicochemical traits of contrasting sites combined with chemically distinct litters of sedge (S), milkvetch (M) from a grassland, and beech (B) from forest site decomposition. Litter was assessed by mass loss; C, N, and P contents; and low-molecular-weight compounds. Decomposition was described by the succession of fungi, Actinobacteria, Alphaproteobacteria, and Firmicutes; bacterial diversity; and extracellular enzyme activities. The M litter decomposed faster at the nutrient-poor forest site, where the extracellular enzymes were more active, but microbial decomposers were not more abundant. Actinobacteria abundance was affected by site, while Firmicutes and fungi by litter type and Alphaproteobacteria by both factors. Actinobacteria were characterized as late-stage substrate generalists, while fungi were recognized as substrate specialists and site generalists, particularly in the grassland. Overall, soil conditions determined the decomposition rates in the grassland and forest, but successional patterns of the main decomposers (fungi and Actinobacteria) were determined by litter type. These results suggest that shifts in vegetation mostly affect microbial decomposer community composition.

**IMPORTANCE** Anthropogenic disturbance may cause shifts in vegetation and alter the litter input. We studied the decomposition of different litter types under soil conditions of a nutrient-rich grassland and nutrient-poor forest to identify factors responsible for changes in the community structure and succession of microbial decomposers. This will help to predict the consequences of induced changes on the abundance and activity of microbial decomposers and recognize if the decomposition process and resulting quality and quantity of soil organic matter will be affected at various sites.

Microbial community structure and activity reflect changes of biotic (soil biota) and abiotic (climate, soil chemistry, and litter quality) factors as well as ecosystem functioning (1, 2). In particular, the complex environmental characteristics of a given site influence the pool of microbial species at the regional scale, while litter quality affects the dynamics of microorganisms coming from that pool at the local scale (3, 4).

It is still debatable whether environmental conditions or litter quality plays a larger role in decomposition (5). The transfer of litter between sites can differentiate between

Therefore, to understand the factors driving microbial decomposition, connections between local and regional scales need to be considered over time, together with various litter types and origin (5, 8).

The roles of biotic and abiotic factors change over time as the litter is sequentially decomposed. As the chemical composition of litter changes, the associated microbial community and extracellular enzyme activities also change (9–11). The differential response of microbes to the changing litter chemistry is the basis for sorting microbes into specific guilds (10, 12). More specifically, a nutritious organic substrate is connected to a wide range of nonspecialized microbes, while recalcitrant organic substrates are decomposed only by a limited number of taxa, which can break the resistant organic structures (3, 13). It has been proposed that the identification of microbes from the late stage and/or specialized guilds should be the first step in predicting the consequences of environmental change connected to decomposition processes in temperate areas (5, 14).

Fungi have long been considered the main microbial decomposers catalyzing the decomposition of complex substrates (9, 15). Most studies focused on their decomposing abilities, while factors affecting them were found to be variable (10, 16, 17). However, the role of bacteria in decomposition has also been recently highlighted (7, 11). Particularly, *Actinobacteria, Proteobacteria, Firmicutes*, and *Bacteroidetes* produce extracellular enzymes and are active in substrate degradation (5, 18). Moreover, *Actinobacteria* are able to produce lignolytic enzymes and secondary metabolites and form filaments, which are strategies similar to those of fungi (19–23). Therefore, *Actinobacteria* may compete with fungi (15), but those two groups have rarely been studied together during the decomposition process. Their coexistence patterns, such as niche overlap and/or separation (3, 15) under the influence of various abiotic factors, could be a missing biotic predictor of decomposition (5, 15, 24).

The aim of this study was to explore the interplay of factors affecting the abundances and succession of main decomposers. We hypothesized that main decomposers will be site specific but will selectively inhabit different litter and shift their enzyme activities during the decomposition stages. In particular, we wanted to determine the importance of cross-kingdom coexistence and successional patterns of microbial communities in influencing the effects of litter type and soil condition on decomposition processes.

#### RESULTS

Low-molecular-weight compounds (measured by high-performance liquid chromatography [HPLC]) shifted over time (Fig. 1A). In January and March 2011, compounds were separated according to litter type, while in later months they were separated according to sites. The HPLC profiles of the milkvetch (M) litter type in January and March 2011 significantly correlated with C content (R = 6.377, P < 0.001) and most extracellular enzymes, such as  $\beta$ -glucosidase (R = 7.491, P < 0.001), acid phosphatase (R = 7.776, P < 0.001), and chitinase (R = 6.152, P < 0.001), according to the permutation test. Of all bacterial groups, the abundance of *Actinobacteria* most strongly correlated with the late-stage HPLC profile (R = 10.569, P < 0.001). *Actinobacteria* significantly correlated with soil water potential (R = 2.347, P = 0.004) and temperature (R = 4.871, P < 0.001).

Bacterial communities on the beech (B) and sedge (S) litter types separated from that on the M litter type, especially in January and March 2011 (Fig. 1B). Bacterial communities also shifted from the initial to late stages of decomposition (confirmed by Sammon's multidimensional scaling; see Fig. S1 in the supplemental material). Bacterial communities from a later month of decomposition significantly correlated with the abundances of *Actinobacteria* (R = 2.5940, P < 0.001), *Firmicutes* (R = 1.2363, P < 0.001), and bacterial diversity (R = 0.9875, P < 0.001) according to the permutation test. From January

2011, bacterial communities on the M litter type were significantly correlated with C (R = 1.3441, P < 0.001) and most extracellular enzyme activities, such as  $\beta$ -glucosidase (R = 1.3134, P < 0.001), cellobiohydrolase (R = 0.5805, P < 0.001), chitinase (R = 0.5606, P < 0.001), and acid phosphatase (R = 0.4410, P = 0.007). Bacterial communities on the B and S litter types in January 2011 significantly correlated with laccase (R = 0.8082, P < 0.001). The bacterial communities on the M litter from March significantly correlated with N (R = 0.7699, P < 0.001) and P (R = 0.5463, P = 0.002). Late-stage bacterial communities significantly correlated with soil water tension (R = 0.7697, P < 0.001) and temperature (R = 0.3895, P = 0.007).

**Litter mass loss.** Loss of dry mass significantly differed between sites in all decomposition stages. At the forest site (F), the average residual dry mass was about 0.5 g lower than the grassland site (G) (ANOVA, P < 0.001) (see Table S1 in the supplemental material). Milkvetch (M) had the highest average mass loss (ANOVA, P < 0.001) (Table S1), while that of sedge (S) was significantly higher than beech (B) (ANOVA, P < 0.001) (Table S1) at both sites. Time courses of dry mass loss were similar for the same litter type regardless of the site (Fig. 2,  $P_{Perm}$  [i.e., the *P* value from permutational multivariate analysis of variance using distance matrices {PERMANOVA}] < 0.001, Table S1), while dispersion did not differ between the litter types (Fig. 2; Table S1) ( $P_{Disp}$  [i.e., the *P* value from homogeneity of multivariate dispersions using dissimilarity measures] = 0.382). No significant differences were observed between the indigenous and exogenous origin of the litter (i.e., M and S litters did not decompose faster than B litters in the forest).

**Carbon, nitrogen, and phosphorus contents in the litter.** Carbon (C), nitrogen (N), and phosphorus (P) contents in litter significantly differed between the forest and grassland sites during decomposition (see Fig. S2 in the supplemental material). The N and C contents in all litter types were significantly higher at the forest site than the grassland site (ANOVA, P < 0.001) (Table S1), while P content showed the opposite relationship (ANOVA, P = 0.001) (Table S1). C content did not differ between litter types

at both sites, while N and P contents significantly differed, with the highest content measured for the M litter (P < 0.001 for N, P < 0.001 for P) (Table S1).

**HPLC analysis of extractable low-molecular-weight compounds.** HPLC profiles significantly differed between sites and litter types within each site (P < 0.001 for all sampling times and litter types) (Table S2).

**Extracellular enzyme activities.** Overall, the activities of extracellular enzymes were significantly higher in the forest than in the grassland (ANOVA,  $\beta$ -glucosidase, P < 0.001; cellobiohydrolase, P = 0.001;  $\beta$ -xylosidase, P < 0.001; chitinase, P < 0.001; glucuronidase, P = 0.003; acid phosphatase, P < 0.001; arylsulfatase, P < 0.001;  $\alpha$ -glucosidase, P = 0.001; laccase, P = 0.007). Manganese peroxidase activity did not differ between the sites. Overall, higher enzyme activities were measured for the M than the S or B litters for  $\beta$ -glucosidase (M > B and S, P < 0.001), cellobiohydrolase (M > S, P < 0.001; S > B, P < 0.001; S > B, P < 0.001),  $\beta$ -xylosidase (M > S, P = 0.015; M > B, P < 0.001; S > B, P < 0.001), and acid phosphatase (M > B and S, P < 0.001). The activities on the M and S litters were not statistically different but were higher than those of the B litter for chitinase (P < 0.001), glucuronidase (P < 0.001), and  $\alpha$ -glucosidase (P < 0.001). The S litter had the highest laccase activity (P = 0.007) (Table S1; Fig. 3).

Time courses of enzyme activities for chitinase, arylsulfatase, laccase, and manganese peroxidase were similar for the same litter type regardless of the site, while dispersion did not differ between the litter types (chitinase,  $P_{Perm} = 0.005$ ,  $P_{Disp} = 0.914$ ; arylsulfatase,  $P_{Perm} = 0.004$ ,  $P_{Disp} = 0.052$ ; laccase,  $P_{Perm} = 0.009$ ,  $P_{Disp} = 0.796$ ; and manganese peroxidase,  $P_{Perm} < 0.001$ ,  $P_{Disp} = 0.385$ ) (Table S1).

**Bacterial communities.** A total of 9,366,330 16S rRNA gene sequences were obtained, of which 6,898,021 (i.e., 73.6%) were mapped to 13,987 operational taxo-

nomic units (OTUs). The numbers per sample ranged between 12,630 and 78,406 sequences, with a median at 41,137 sequences.

Bacterial communities differed significantly between the forest and grassland sites in the first two sampling months for the M litter (P = 0.009 in January 2011, P = 0.008in March) (Table S3) and in the last two sampling months for the B and S litters (P = 0.008 and P = 0.006, respectively, in July, and both species P = 0.009 in November 2011) (see Table S3 in the supplemental material). The bacterial community on the M litter significantly differed from that on the B and S litters (analysis of molecular variance [AMOVA], P < 0.001 and P = 0.003 at the grassland and forest sites, respectively, for both litter types) (see Table S4 in the supplemental material), with the bacterial communities not differing between the latter two litter types.

The proportions of phyla in the bacterial 16S rRNA gene amplicon sequence libraries were the highest for *Proteobacteria*, followed by *Actinobacteria*, *Bacteroidetes*, *Firmicutes*, and *Verrucomicrobia* (Fig. 4). These proportions increased over time for *Actinobacteria* (except on the B litter in November 2011 in the forest) and *Firmicutes* (especially from January to March 2011) and decreased for *Proteobacteria* and *Bacteroidetes* from January to November 2011 (Fig. 4). *Acidobacteria* proportions were the highest in the late sampling months on the M and S litters (Fig. 4) and in soil (see Fig. S3 in the supplemental material) in January and November 2011. *Verrucomicrobia* proportions were the highest in the middle sampling months (Fig. 4). Within the phylum *Actinobacteria* (see Fig. S4 in the supplemental material), the families *Streptomycetaceae* (mostly on S plants) and *Mycobacteriaceae* increased at both sites, while the proportions of *Pseudonocardiaceae*, *Gaiellaceae*, and *Promicromonosporaceae* increased mostly in the grassland, and the order *Frankiales* increased in the forest. The Trebon clade proportion increased in November 2011 on the S litter in the forest (Fig. 4).

The number of OTUs (cutoff, 97%) significantly contributing to differences between the sites was the lowest for the B litter and the highest for the M litter at both sites according to metastats (see Fig. S5 in the supplemental material). According to the rarefaction curves, the highest number of OTUs in January and March 2011 was found at the grassland site, especially for the B and S litter types. The number of OTUs was similar for all litter types for both sites in July, while the highest number of OTUs in November was measured for the M followed by S and B litter types at the grassland site (see Fig. S6 in the supplemental material). Rarefaction analysis showed that bacterial diversity differed between the sites (ANOVA; F = 12.86, P < 0.001). Bacterial diversity

increased on all litter types over decomposition except for the S and B litters in the forest, where the diversity declined from July to November 2011 (see Fig. S7 in the supplemental material).

**Abundance of soil microorganisms.** Overall, *Alphaproteobacteria* gene copies (16S rRNA) were more abundant in the grassland than at the forest but only for January and March 2011 (ANOVA, P = 0.009) (Table S1) and on the M than the B and S litters (both P < 0.001). *Actinobacteria* gene copies (16S rRNA) were more abundant in the grassland than at the forest (ANOVA, P < 0.001) (Table S1) but did not differ between litter types. Fungi (18S rRNA) and *Firmicutes* (16S rRNA) gene copies did not differ between the sites. *Firmicutes* were more abundant on the M than the B and S litters (ANOVA, both P < 0.001) (Table S1). Fungi were the least abundant on the B litter compared with both the S (ANOVA, P < 0.001) (Table S1) and M litters (P = 0.015) (Fig. 5).

The time courses of *Actinobacteria* ( $P_{Perm} = 0.021$ ;  $P_{Disp} = 0.387$ ) and fungi ( $P_{Perm} < 0.001$ ;  $P_{Disp} = 0.505$ ) were similar for the same litter type regardless of site, while dispersion did not differ between the litter types.

#### DISCUSSION

Decomposition rate, extracellular enzyme activities, and litter chemistry were specific according to sites and within both sites according to litter type but not litter origin. Fungi, *Actinobacteria*, *Firmicutes*, *Proteobacteria*, *Bacteroidetes*, *Acidobacteria*, and *Verrucomicrobia* each had its own role in the decomposition process. Their successional patterns differed based on their requirements for site conditions or litter type. *Actinobacteria* were identified as late-stage site-specific substrate generalists, which was the opposite pattern to fungi. The dynamics of these two groups together with bacterial community composition were driven by litter type and were synchronized with the mass loss of the most nutritious litter of milkvetch (M).

Overall, the forest site had higher decomposition rates and enzyme activities than the grassland site. The beech forest soils are considered to be an environment limited by low soil N and P (25). Thus, nutrient limitations might stimulate microbes to produce enzymes to gain the deficient nutrients from complex substrates (26). This is also supported by our finding that P acquisition for all substrates, as well as enzyme activities, was significantly higher at the forest site (27, 28). In contrast, the nutrient-rich but warmer and drier soil with diverse sources of litter at the grassland site (29) probably sufficiently covered the demands of soil microbes (30). Consequently, a higher diversity of bacterial communities was found on the grassland litter. (31).

The profiles of the low-molecular-weight compounds derived from the litter substrates represented the molecular environment during decomposition and were characteristic of each site (29) and as well as each decomposition stage within a site (32). Over time, the litter types separated mostly according to the site as opposed to the litter types (redundancy analysis [RDA]), which demonstrates how decomposition transforms litter to a humus type specific for a given site (33).

The bacterial communities for the sedge (S) and beech (B) litters considerably diverged between sites but only in the later stages of decomposition when they were composed mostly of bacteria representing the indigenous soil communities of the sites. In contrast, the associated bacterial communities on the M litter at the two sites converged over time as the nutrient-rich M litter was sequentially exhausted (4, 10). A uniform community, therefore, reflected the final stage of decomposition for the M litter, while it possibly represented only the initial depolymerization of lignin for the S and B litters (34). Furthermore, the higher-quality M litter showed the largest shifts in bacterial OTUs over time, as well as the higher decomposition rates and highest activity of hydrolytic enzymes compared with the B and S litters across both sites (35). Thus, local-scale decomposition was driven by the local community according to the litter type (33) without any effect of endogenous or exogenous litter origin (i.e., M and S litters originating at the grassland site and beech at the forest site), contrary to the home-field advantage theory (31).

Quantitative analysis based on 16S and 18S rRNA gene abundances suggested discriminating driving factors for various microbial groups during litter decomposition. Specifically, *Firmicutes* and *Alphaproteobacteria* preferentially colonized the M litter, but colonized *Firmicutes* at both sites and *Alphaproteobacteria* (only for January and March 2011) at the grassland site. Fungi were affected more and *Actinobacteria* less by litter quality, similarly as in boreal peat soil (36). Therefore, *Actinobacteria* are substrate generalists influenced by environmental conditions, and consequently, they can specifically reflect site soil characteristics (37). In contrast, the site generalism of fungi supports this group's resiliency to environmental factors (17). However, that contrasts with the generally acknowledged assumption of fungi sensitivity to soil pH (38). Thus, in this study, the relationship between fungi and bacteria was probably neutral because fungi were pH dependent only if they grew in competition with bacteria (39).

The dynamics of Actinobacteria and fungi, certain enzymatic activities (arylsulfatase, chitinase, laccase, and manganese peroxidase), and mass loss were more similar for one

litter type between sites than the three litter types were similar within each site. Most of those enzymes target complex organic substrates and were found to be (except manganese peroxidase) produced by both *Actinobacteria* and fungi (20, 40–42). The ability of different soil communities to carry out decomposition of the same substrate over time regardless of the site implies functional redundancy (43). Such dynamics were, however, not the case for *Alphaproteobacteria* and *Firmicutes*, which are, therefore, likely functionally distinct (7). The results indirectly suggest that the dynamics of *Actinobacteria* and fungi were driven by the same factor, i.e., litter type (19).

The decomposition process is often considered to be separated into three stages characterized by typical microbial guilds and their functions (11). In the present study, the initial stage (from January to March 2011) was characterized by high extracellular enzyme activities, especially at the forest site. The bacterial communities on the M litter type were positively affected by available N and P, suggesting that bacteria require a lower C:N but higher N:P ratio (44), especially after intense enzyme production which likely leads to substantial losses of C and N (9). In this stage, a specific form of low-molecular-weight compounds was recorded on the M litter (45). In addition, the nutrient-rich M litter had the most dynamic bacterial communities, with high incidences of fungi and *Alphaproteobacteria* are known for their ability to depolymerize recalcitrant compounds (46), their initial dominance may correspond with carbon depolymerization of the M litter. Meanwhile, *Bacteroidetes* (according to amplicon sequencing) occurred on all litter types at both sites. *Bacteroidetes* are also known for their decomposing activity, and their presence in all litter types suggested promotion by litter addition (47) regardless of its quality and origin.

The middle stage of decomposition was prevalently characterized by cellulose decomposition (48), even though in the current study it was documented only at grassland site from the increased activity of cellulolytic enzymes in May for the M litter and in July for the S litter. In this stage, *Verrucomicrobia* and *Proteobacteria* make up the highest proportion of taxa on all litter types, which suggests that they are substrate generalists and polysaccharide decomposers (49). Fungi decreased and were replaced by bacteria at both sites possibly because bacteria are scavengers benefitting from the initial cellulose degradation by fungi (48).

Finally, bacterial diversity increased especially on the M litter type over time, which suggested an increased number of ecological niches when the soil and litter communities combine (9, 50). The gradual incorporation of litter to the soil is supported by the relative increase of *Acidobacteria* and *Actinobacteria*, also increased later in the decomposition process, which corresponds to their relative abundance in soil, especially *Actinobacteria* (51). The increase of *Actinobacteria*, as well as *Firmicutes*, on the M and S litter types (according to both qPCR and relative proportion in sequence libraries) implies that late-stage decomposition is associated with Gram-positive K-strategist microbial groups (10, 52).

Actinobacteria were substrate generalists that adapt to litter of different decomposability (19, 53). Actinobacteria quantity, together with overall bacterial diversity, was positively correlated with the structure of the late-stage bacterial communities, suggesting they have a specific function in that decomposition stage. This conclusion was also supported by the late proportional increase of the Actinobacteria families Mycobacteriaceae and Streptomycetaceae, of which some genera are soil saprotrophs (54) or known for lignin breakdown (46). These families are also recognized for antimicrobial activity, which may be utilized for competitor suppression or as a synergic communication to overcome the small energetic return from recalcitrant compounds (15, 23). The relative abundance of Frankiales also increased in the late stages but only at the forest site, suggesting the advantage of the N fixation metabolism typical for this group in decomposing recalcitrant substrates in infertile soil (53). Interestingly, we also found an increase in the proportion of the Trebon clade later in decomposition at the forest site but only on the S litter, supporting previous findings of that clade's adaptation to low pH forest soil with recalcitrant humus (55). Finally, Actinobacteria might have a strong impact on litter-derived humus formation through modulation of the molecular environment and interactions within the decomposer community.

Niche partitioning is related to changes in environmental conditions (35) and might result from previous competition between species regulating their coexistence (56). This may be demonstrated by the different abundance maxima of the studied microbial groups, especially fungi and *Actinobacteria*, on the rich M litter (57). On the poorer B and S litters, the abundance curves of *Actinobacteria*, fungi, and *Alphaproteobacteria* were congruent, which may represent a synergistic interaction (58, 59). In spite of fungi being the initial decomposers, they dominated over *Actinobacteria* in the later stages at the forest site on the S litter, habitats favorable for fungi and unfavorable for *Actinobacteria*. This is in accordance with the higher fitness of specialists (fungi) at their optimal environmental conditions relative to generalists (*Actinobacteria*) at the same site (60). The S litter at the grassland site represents a niche overlap for *Actinobacteria* and fungi since it is the most favorable habitat of both. Interestingly, in this situation, *Actinobacteria* to ecosystem functioning (61).

Site conditions had the biggest impact on the progress of decomposition, measured as litter mass loss, litter chemistry, and enzyme activities. The site conditions also determined bacterial diversity, although the litter seemed to create specific niches according to the type and stage of decomposition. Finally, the site conditions were most important for the total abundance of *Actinobacteria*. In contrast, litter type determined the abundance of fungi, while the abundance of *Alphaproteobacteria* was related to both factors. Also, litter type influenced the succession of fungi and *Actinobacteria* regardless of the site. Consequently, the observed patterns revealed that the decomposition process is independent of litter type and, therefore, may be relatively stable with respect to shifts of vegetation due to disturbance. However, the niches created by various litter types and decomposition stages may have an impact on the dynamics of the main microbial decomposers and that may lead to changes in organic matter quality and sequestration.

#### **MATERIALS AND METHODS**

**Litterbag experiment.** A grassland site situated on the western slope of Oblik Hill in the Bohemian Massif Central, Czech Republic, and a forest site in Dorotheer Wald, Neustift near Vienna, Austria, were chosen for the litterbag experiment. Soil humidity and temperature differed between the sites (see Fig. S8 in the supplemental material). The forest site was dominated by beech (*Fagus sylvatica*), with acidic soil (pH 5.3) and soil organic matter content of 11.7%. The grassland site was dominated by diverse forbs (29), with alkaline soil (pH 7.9) and soil organic matter content of 11.0%.

For the litter transplant experiment, we used beech leaves (B), collected in November 2010 at the forest site from beech trees before litter fall, and aboveground parts of a sedge (S; *Carex humilis*) and milkvetch (M; *Astragalus exscapus*) both cut from living plants in November 2010 at the grassland site. We chose these litter types according to their quality and decomposability as described by their C:N:P ratio. B had the highest, M the lowest, and S an intermediate C:N:P ratio (Fig. S2). Polyester litterbags of size  $10 \times 10$  cm with a mesh size of 1 mm were filled with 7 g of dried litter, with 70 litterbags prepared for each litter type. The remaining litter was stored at  $-70^{\circ}$ C for future analysis and was considered the initial sampling time (initial). Overall, 105 litterbags (35 litterbags from each litter type) were placed under the top 5 cm of the soil organic layer at each site in November 2010 (Fig. 6).

A total of 50 ml of surrounding soil and litterbag samples were collected in 2-month intervals; overall, 7 samplings were performed (January, March, May, July, September, and November 2011; and January 2012). Each litterbag was weighed to assess the weight loss during the decomposition process. The M litter was completely decomposed by January 2012 and no material remained in the litterbags. Therefore, analysis of the M litter type for this sampling time is missing (Fig. 6).

The soil and litter samples were cooled during transportation and homogenized and divided into subsamples upon arrival at the laboratory. Litter water content was assessed by the gravimetric method with oven drying (62). For microbial analysis, the soil and litter samples were placed in 2-ml sterile plastic tubes and stored at  $-70^{\circ}$ C until further analysis. For high-performance liquid chromatography (HPLC) analysis, 100-ml glass bottles were filled with the soil and litter samples, overlaid with a methanol-water-acetic acid mixture (80:19:1 [vol/vol/vol]), and stored at  $-20^{\circ}$ C. The remaining soil and litter samples were placed in plastic bags for an analysis of pH; organic carbon content (soil samples); and C, N, and P contents (litter samples) (Fig. 6).

**Soil analysis.** Soil moisture tension and temperature were recorded at both sites by a Microlog SP1 datalogger (EMS, Brno, Czech Republic) equipped with a gypsum block sensor. From the recorded values, mean temperature and humidity were calculated for every month from November 2010 to March 2012. Soil pH was measured by a Multi 350 WTW glass electrode in a soil water extract (5 g of soil was extracted with 20 ml of distilled water and set for 12 hours at room temperature). Soil organic matter content was estimated by combustion in an oven at 550°C to a constant weight.

**Carbon, nitrogen, and phosphorus analysis in the litter.** Total phosphorus (P) content was determined colorimetrically in 20 mg of dried plant litter sequentially decomposed with  $HNO_3$  and  $HCIO_4$  using the ammonium molybdate-ascorbic acid method on a QuikChem 8500 flow injection analysis system (Lachat Instruments, Hach Company, Loveland, CO, USA) at the Botanical Institute in Třeboň, Czech Republic (63). Total carbon (C) and nitrogen (N) contents were determined in 2 g of dried litter by high-temperature combustion, followed by gas separation in a Vario Max CNS element analyzer (Elementar Analysensysteme, Hanau, Germany) by Aquatest a.s. (Prague, Czech Republic).

**HPLC analysis of soluble low-molecular-weight soil metabolites.** Low-molecular-weight compounds of the soil and litter samples were analyzed by high performance liquid chromatography (HPLC) (64). The compounds were extracted in methanol-water-acetic acid (80:19:1 [vol/vol/vol]) and then filtered and vacuum concentrated. The concentrated solution was fractionated using Amberlite XAD

1180 (5 g aqueous suspension; 2-cm-diameter glass column, equilibrated with water). A total of 50 ml of water (MilliQ quality) was used as the effluent for the first (hydrophilic) fraction and 50 ml of absolute ethanol for the second (lipophilic) fraction. The ethanolic fraction was evaporated and diluted in methanol at a concentration of 5 mg ml<sup>-1</sup>. The analysis was performed using the Acquity ultraperformance liquid chromatography (UPLC) system with a 2996 photodiode array (PDA) detector (Waters, Milford, MA, USA) with a Phenomenex Luna column (5 mm, C18[2], 100 Å, 100 × 4.6 mm) equipped with a SecurityGuard cartridge (C18, 4 × 3.0-mm internal diameter [ID]; Phenomenex, Torrance, CA, USA). The separation was run in an air-conditioned room at 20°C, with a flow rate of 1.0 ml min<sup>-1</sup>. Solvent A was ultrapure water, while solvent B was acetonitrile. The gradient started with 10% of solvent B for 1 min and then increased linearly to 100% of B within 8 min. The final concentration was held for a further 3.5 min. A total of 20  $\mu$ l of each sample was injected. The spectra were recorded from 194 to 800 nm in 1-nm intervals. Data points were recorded twice per second and downloaded using MassLynx software (Waters) in text format for further processing.

**Enzyme extraction and assays.** The activities of the extracellular hydrolytic enzymes  $\alpha$ -glucosidase (EC 3.2.1.3), 1,4- $\beta$ -xylosidase (EC 3.2.1.37), 1,4- $\beta$ -glucosidase (EC 3.2.1.21), acid phosphatase (EC 3.1.3.1), chitinase (EC 3.2.1.52), cellobiohydrolase (EC 3.2.1.91), glucuronidase (EC 3.2.1.31), and arylsulfatase (EC 3.1.6.1) were directly measured using methylumbelliferone-derived fluorogenic substrates in aliquots of litter samples homogenized in 50 mM sodium acetate buffer at pH 5.0 (65).

For the extracellular oxidative enzymes laccase (EC 1.10.3.2) and manganese peroxidase (EC 1.11.1.13), aliquots were desalted to separate inhibitory molecules. The activity of laccase was measured by monitoring the oxidation of 2,20-azinobis-3-ethylbenzothiazoline-6-sulfonic acid in a citrate-phosphate buffer (pH 5.0) (66). Manganese peroxidase activity was assayed in a succinate-lactate buffer (100 mM, pH 4.5) using 3-methyl-2-benzothiazolinone hydrazone and 3,3-dimethylaminobenzoic acid, which were oxidatively coupled by the enzyme. The results were compared to the activities of samples without manganese (for manganese peroxidase, the addition of manganese sulfate was substituted by an equimolar amount of EDTA). One unit of enzyme activity is defined as the amount of enzyme forming 1  $\mu$ M reaction product per minute. Enzyme activities were measured in three analytical replicates and expressed per gram of plant litter dry mass (48).

**DNA extraction and microbial community analysis.** DNA was extracted from litter and soil samples according to Sagova-Mareckova et al. (67). The method is based on bead beating and phenol-chloroform extraction. The samples were purified by incubation with acetyltrimethylammonium bromide, followed by chloroform extraction and incubation with CaCl<sub>2</sub>, and finally cleaned with the GeneClean turbo kit (MP Biomedicals, Santa Ana, CA, USA). DNA extracts were stored at -70°C until further analysis.

**Illumina MiSeq and data processing.** Bacterial 16S rRNA gene fragments, including the variable region V4, were amplified by PCR using universal primers with overhang adapters (Table 1) (68). The construction of amplicon libraries and sequencing using the MiSeq sequencer (Illumina, San Diego, CA, USA) were done at the DNA Services Facility, Research Resources Center, University of Illinois (Chicago, IL, USA). The resulting paired sequence reads were merged, filtered, and aligned using a reference alignment from the Silva database (69) and chimera checked using the integrated Vsearch tool (70) according to the MiSeq standard operation procedure (MiSeq standard operating procedure [SOP], February 2018 [68] in Mothur v. 1.39.5 [70]). A taxonomical assignment of sequence libraries was performed in Mothur using the nonredundant subset of the SILVA small subunit rRNA database, release 132 (71), adapted for use in Mothur (https://mothur.org/w/ images/3/32/Silva.nr\_v132.tgz), as the reference database. Sequences of plastids and mitochondria and those not classified in the domain *Bacteria* were discarded.

The sequence library was clustered into OTUs (97%) using Usearch v. 10.0.240 (72), and the OTU table was further processed using tools implemented in Mothur. Distance matrices describing the differences in community composition between individual samples were calculated using Bray-Curtis dissimilarity (73). Analysis of molecular variance (AMOVA) (74) was based on a matrix of the Bray-Curtis distances. Metastats (75) analyses were used to detect differentially represented OTUs. Rarefaction analysis was performed with the rarefaction.single function in Mothur, and areas under the rarefaction curves were

calculated using the trapezoidal rule in R version 3.4.4 (76). Figures were created using Inkscape (v. 0.92; http://www.inkscape.org).

**Quantitative real-time PCR.** Quantification of the 16S rRNA gene in *Actinobacteria, Alphaproteobacteria,* and *Firmicutes* and the 18S rRNA gene of fungi in the DNA extracted from litter samples was performed with the primers listed in Table 1 (77–79).

Quantitative PCR was performed using the StepOnePlus real-time PCR system (Applied Biosystems, Foster City, CA, USA) using 96-well plates with GoTaq qPCR master mix (Promega, Madison, WI, USA) containing SYBR green as a double-stranded DNA (dsDNA) binding dye. The reaction mixture contained in total a volume of 15  $\mu$ l with 1 $\times$  GoTaq qPCR master mix, primers (for concentrations see Table 1), and 2-ng DNA sample. For all microbial groups, the PCR cycling protocol consisted of initial denaturation at 95°C for 10 min, followed by 45 cycles of denaturation (95°C for 15 s), annealing (for respective temperature see Table 1), and elongation (72°C for 30 s). Standards containing a known number of copies of the target genes 16S rRNA from *Streptomyces europaeiscabiei* DSM 41802 (for *Actinobacteria*), *Bartonella*-like clone (for *Alphaproteobacteria*), and *Paenibacillus* clone (for *Firmicutes*) and 18S rRNA from a *Penicillium* sp. clone (for fungi) were serially diluted to calibrate each qPCR melting curve and were recorded to ensure qPCR specificity. Baseline and threshold calculations were performed with StepOne v. 2.2.2. Inhibition was tested by serial DNA dilutions from each site. All qPCR measurements were done in duplicate.

**Statistical analysis.** All statistical calculations were done in the R computing environment (76). The effect of sites and litter types on bacterial community composition and the litter molecular parameters during the decomposition process were measured as the relationship between the distance matrices of the HPLC profiles of low-molecular-weight compounds (HPLC) and bacterial communities using a generalized distance covariance (80). The HPLC profiles were baseline corrected using the PTW package (81), and distances between profiles were calculated using Manhattan metrics. The distance matrices of the HPLC profiles and bacterial communities (exported from Mothur) were plotted by RDA projection and Sammon's multidimensional scaling using the MASS package (82). Correlations between linear variables, bacterial community, and HPLC profiles were analyzed by permutation test for capscale under a reduced model using the Bray-Curtis (bacterial communities) and Manhattan (HPLC) dissimilarities (with 999 permutations) in the VEGAN package in R (83).

To analyze the overall quantitative differences of linear variabilities (dry mass loss; abundances of microbial groups; enzyme activities; and C, N, and P contents in litter) between sites and litter types (within sites), a linear model with the additive effect of time, site, and litter type was calculated (84).

We used two tests based on the distance between the profiles as measured by correlation coefficients (see p. 319 of reference 85) to analyze the qualitative similarities between the linear variables. Permutational multivariate analysis of variance (PERMANOVA; significance values denoted here as  $P_{Perm}$ ) (86) tests whether the within-group distances (same litter type) are on average shorter than the between-group distances (between different litter types, aimed at detection of different mean profiles). The dispersion test (significance values denoted here as  $P_{Disp}$ ), introduced in Gijbels and Omelka (87), checks whether the average within-group distances differ among groups (aiming at detecting different dispersions of the samples). For manganese peroxidase, a Manhattan distance instead of the distance based on the correlation coefficient was used due to zero values in some profiles.

All linear variables (dry mass loss; microbial gene quantities; C, N, and P content; and enzyme activities, except manganese peroxidase) were logarithmically transformed (with negative values of enzymes replaced by 1 before transformation) to make their distribution more similar to a normal distribution.

# **Supplementary Text**

#### **Materials and Methods**

#### Litterbag experiment

A grassland site (G) situated at the western slope of Oblik hill in Bohemian Massive Central, Czech Republic and a forest site (F) in Dorotheer Wald, Neustift near Wien, Austria were chosen for the litterbag experiment. Soil pH, vegetation, soil organic carbon content, soil humidity and temperature contrasted the sites (Fig. S1.). The F site was dominated by beech (*Fagus sylvatica*), with acidic soil (pH 5.3) and soil organic matter content 11.7%. The G site was dominated by diverse forbs (1), with alkaline soil (pH 7.9) and soil organic matter content 11.0%.

For the experiment, we used leaves of beech (B, *Fagus sylvatica*) from *Fagaceae* family (collected in November 2010 at the forest site), and aboveground parts of sedge (S, *Carex humilis*) from *Cyperaceae* family, and milkvetch (M, *Astragalus exscapus*) from *Fabaceae* family (both collected in November 2010 at the grassland site). We chose these litter types according to their quality and decomposability described by C:N:P ratio. B disposed of the highest, M the lowest and S the intermediate C:N:P ratio in its tissues (Fig. S2).

The soil and litterbag samples were collected in two-month intervals; overall 7 samplings were performed (January 2011, March 2011, May 2011, July 2011, September 2011, November 2011 and January 2012). Each litterbag was weighted to assess the weight loss during the decomposition process. M litter was completely decomposed in January 2012 and no material remained in the litterbags. Therefore, analysis for this sampling time for M litter type are missing.

The soil and litter samples were cooled during transportation, homogenized and divided into subsamples upon arrival to the laboratory. For microbial analysis, the soil and litter samples were placed in 2 ml sterile plastic tubes and stored at -70°C until a further analysis. For high performance liquid chromatography (HPLC) analysis 100 ml glass bottles were filled with the soil and litter samples, overlaid with a mixture of methanol-water-acetic acid (80:19:1, vol/vol/vol) and stored in -20°C. The remaining soil and litter samples were placed in plastic bags for analysis of pH, organic carbon content (soil samples) and C, N and P contents (litter samples).

#### Soil analysis

Soil moisture tension and temperature were recorded at both sites by a datalogger Microlog SP1 (EMS, Brno, Czech Republic) equipped with a gypsum block sensor. From recorded values, mean temperature and humidity for every month from November 2010 to March 2012 were calculated. The soil pH was measured by a Multi 350 WTW glass electrode in a soil water extract (5 g of soil was extracted with 20 ml of distilled water and set for 12 hours at a room temperature). The soil organic matter content was estimated by combustion in an oven at 550°C to the constant weight.

#### HPLC analysis of soluble low-molecular-weight soil metabolites

The extracts of soil and litter samples in a methanol-water-acetic acid were filtered and vacuum concentrated. The concentrated solution was fractionated using Amberlite XAD 1180 (5 g of aqueous suspension; 2 cm diameter of a glass column, equilibrated with water). 50 ml of water (MilliQ quality) was used as the effluent for the first (hydrophilic) fraction; 50 ml of absolute ethanol was used for the second (lipophilic) fraction. The ethanolic fraction was evaporated and diluted in a methanol at a concentration of 5 mg ml<sup>-1</sup>. The analysis was performed using Acquity UPLC system with the 2996 PDA detector (Waters, Milford, MA, USA). The column was a Phenomenex Luna 5 mm C18(2) 100 Å,  $100 \times 4.6$  mm, equipped with a SecurityGuard cartridge C18,  $4 \times 3.0$  mm ID (Phenomenex, Torrance, CA, USA). The separation was run in the air-conditioned room at 20°C, and the flow rate was 1.0 ml min<sup>-1</sup>. Solvent A was ultrapure water; solvent B was acetonitrile. The gradient started with 10% of solvent B for 1 min and then increased linearly to 100% of B within 8 min. The final concentration was held for further 3.5 min. 20 µl of each sample were injected. The spectra were recorded from 194 to 800 nm in 1 nm intervals. Data points recorded twice per second were exported from a MassLynx software (Waters) in a text format for further processing.

# Enzyme extraction and assays

The activities of extracellular hydrolytic enzymes  $\alpha$  – glucosidase (3.2.1.3), 1,4- $\beta$ - xylosidase (EC 3.2.1.37), 1,4- $\beta$ -glucosidase (EC 3.2.1.21), acid phosphatase (EC 3.1.3.1), chitinase (EC 3.2.1.52), cellobiohydrolase (EC 3.2.1.91), glucuronidase

(3.2.1.31) and arylsulphatase (3.1.6.1) were measured using methylumbellyferonederived fluorogenic substrates directly in aliquots of litter samples homogenized in 50 mM sodium acetate buffer at pH 5.0 (2).

For extracellular oxidative enzymes laccase (EC 1.10.3.2) and manganese peroxidase (EC 1.11.1.13), aliquots were desalted to separate inhibitory molecules. The activity of laccase was measured by monitoring the oxidation of 2,20-azinobis-3ethylbenzothiazoline-6-sulfonic acid in a citrate-phosphate buffer (pH 5.0) (3). The manganese peroxidase activity was assayed in a succinate-lactate buffer (100 mM, pH 4.5) using 3-Methyl-2-benzothiazolinone hydrazone and 3,3-dimethylaminobenzoic acid, which were oxidatively coupled by the enzyme. The results were corrected by activities of samples without manganese (for MnP) – the addition of manganese sulphate was substituted by an equimolar amount of EDTA. One unit of enzyme activity is defined as the amount of enzyme forming 1  $\mu$ M of reaction product per min. Enzyme activities were measured in three analytical replicates and expressed per g plant litter dry mass (4).

# **DNA extraction and purification**

DNA was extracted from 0.1 g of homogenized litter and 0.5 g of soil samples (only from those collected in January 2011 and November 2011) by method SK described by Sagova-Mareckova *et al.* (2008). The method is based on bead-beating and phenol/chloroform extraction. The samples were purified by incubation with acetyltrimethylammonium bromide followed by chloroform extraction and incubation with CaCl<sub>2</sub>, and finally cleaned with GeneClean Turbo kit (MP Biomedicals, Santa Ana, CA, USA). DNA extracts were stored at -70 °C until the further analysis.

### Quantitative real-time PCR

Quantification of 16S rRNA gene of *Actinobacteria*, *Alphaproteobacteria*, *Firmicutes* and 18S rRNA gene of fungi in the extracted DNA from litter samples were performed with primers listed in Table S1(6–8).

Quantitative PCR were performed using a StepOnePlus Real-Time PCR System (Applied Biosystems, Foster City, CA, USA) using 96-well plates with GoTaq qPCR Master Mix (Promega, Madison, WI, USA) containing SYBR Green as a doublestranded DNA (dsDNA) binding dye. The reaction mixture contained in a total volume of 15 µl: 1× GoTaq qPCR Master Mix, primers (for concentrations see Table S1.) and 2 ng DNA sample. For all microbial groups the PCR cycling protocol consisted of initial denaturation at 95°C for 10 min, followed by 45 cycles of denaturation (95°C for 15s), annealing (for respective temperature see Table S1.) and elongation (72°C for 30s). Standards containing known number of copies of the target genes 16S rRNA from *Streptomyces europaeiscabiei* DSM 41802 (for *Actinobacteria*), *Bartonella-like* clone (for *Alphaproteobacteria*), *Paenibacillus* clone (for *Firmicutes*) and 18S rRNA from *Penicillium sp.* clone (for fungi), were serially diluted to calibrate each qPCR melting curve and were recorded to ensure qPCR specificity. Baseline and threshold calculations were performed with the StepOne v. 2.2.2 software. The inhibition was tested by serial DNA dilutions from each site. All qPCR measurements were done in duplicate.

# Illumina MiSeq and data processing

Bacterial 16S rRNA gene fragments including the variable region V4 were amplified by PCR using universal primers with overhang adapters (Table S1.) (9). Construction of amplicon libraries and sequencing using the MiSeq sequencer (Illumina, San Diego, USA) were done at the DNA Services Facility, Research Resources Center, University of Illinois (Chicago, USA). The resulting paired sequence reads were merged, filtered, aligned using a reference alignment from the Silva database (10), and chimera checked using integrated Vsearch tool [12] according to the MiSeq standard operation procedure (Miseq SOP, February 2018; (9)) in Mothur v. 1.39.5 software (11). A taxonomical assignment of sequence libraries was performed in Mothur using the non-redundant subset of Silva Small Subunit rRNA Database, release 132 (12) adapted for use in Mothur (https://mothur.org/w/images/3/32/Silva.nr\_v132.tgz) as the reference database. Sequences of plastids, mitochondria, and those not classified in the domain *Bacteria* were discarded.

The sequence library was clustered into OTUs using the Usearch v10.0.240 software (13), and the OTU table was further processed using tools implemented in the Mothur software. Distance matrices describing the differences in community composition between individual samples were calculated using the Yue-Clayton theta calculator (14). Analysis of molecular variance (AMOVA; (15)) was based on a

matrix of Yue-Clayton theta distances. Metastats (16) analyses were used to detect differentially represented OTUs. Rarefaction analysis was performed with rarefaction.single function in Mothur, and areas under the rarefaction curves were calculated using trapezoidal rule in the R version 3.4.4 software (17). Figures were created using Inkscape (v0.92; <u>http://www.inkscape.org</u>).

The Illumina MiSeq 16S rRNA gene amplicon sequences have been deposited in the NCBI Sequence Read Archive under accession no. SRP158384 (<u>https://www.ncbi.nlm.nih.gov/sra/SRP158384</u>) and are available under BioProject no. PRJNA485178.

### 29 Abstract

30 The study was designed to see if naturally occurring beech forests uptake different nutrients than artificially planted spruce forests and if the structure of microbial communities participating in 31 32 decomposition corresponds to the soil types developed under the respective tree species. This corresponds 33 to previous observations that the soil under spruce forest is typically dominated by podzol, while the soil 34 under beech forest undergoes higher mineralization, which leads to moder humus and the development of 35 cambisol. A litterbag experiment was performed with beech and spruce litter placed respectively to beech 36 and spruce forests. In the beech forest, the observed litter decomposition rate reached the exponential faze 37 after 15 months, while in the spruce forest a steeper decrease was noted only 29 months after the litter 38 burial. Thus, the study focused on the period between 15 and 29 months to observe the exponential stages 39 of recalcitrant organic matter transformation. In this period, the chemical composition of two litters was 40 distinguished by higher contents of Mn and Ca in beech and higher content of Fe, S, N and P in spruce. 41 On top of that, the beech litter released higher amount of dissolved organic carbon and its associated 42 bacterial community was enriched with r-selected taxa, that correlated positively with organic acids and 43 cations. In contrast, the more acidic spruce litter was dominated by K-selected acidophilic community and 44 its turnover rate was slower, resulting in increased carbon sequestration. The higher pH and humus quality 45 of beech cambisol also correlates with its observed higher resilience to disturbances by acidification, pests 46 or climate change in mountainous environments.

## 52 1. Introduction

Human-introduced spruce forests are more vulnerable to environmental changes than natural beech forests in the Czech Republic. The spruce forests vulnerability is even increased in acidic soils, which are limited by availability of nutrients [1] and potential mobilization of toxic forms of Al [2,3]. In such environments, the litter represents a major source of Ca, K, Mg, P and organic carbon (OC) in the upper layer of soil [4].

The precise chemical composition of litter depends mostly on the requirements of particular plant species and its nutrient uptake and allocation to tissues [5,6]. The nutrient content and composition of organic compounds in litter further establish the microbial community corresponding to the litter type [7]. Microbial decomposers return the litter nutrients back to soil by activities mostly regulated by soil chemistry, but also by local climate, i.e. precipitation, which have further impact on soil development and environmental stability [8].

64 In particular, the elevated concentration of some litter components may speed up [9] or slow down 65 the decomposition rate [10]. For example, N and P stimulate decomposition rate in earlier stages but inhibit 66 its rate in later stages due to formation of complexes, which are recalcitrant for microbes [10,11]. Litter 67 decomposition is further dependent on the amount of dissolved organic carbon (DOC) released from litter 68 and its character, as the low level of DOC with its elevated aromaticity (A254; absorbance at 254 nm) and 69 complexity of organic compounds increase the litter recalcitrance [12]. Finally, the decomposition is also 70 predicted by humification index (HIX) of the decomposed litter, which determines how the particular litter 71 contributes to the humus formation [13].

Decomposition process over time may be illustrated as an asymptotic function. The upper threshold of the function - limit value of decomposition – represents the phase, when the substrate is no longer decomposed and remains stabilized in the soil [14]. The lag-time shows how long it takes a litter to enter the exponential stage of decomposition. The long lag-time eventually implicates that old organic matter is not necessarily stabilized and recalcitrant but that other mechanisms keep it from the decomposition [15]. Later stages of litter decomposition are typically less explored due to longer time required for experiments. Yet, they are needed mostly to evaluate chemical traits of recalcitrant litter and its contribution to humus and soil formation.

Consequently, the contribution of different biotic and abiotic factors to low limit value or long lagtime of recalcitrant litter is not well studied, although it is important for understanding which mechanism and microbial decomposers participate on the release of sequestrated nutrients. Furthermore, it is not known, what is the role of different tree species in creating specific soil chemical conditions, and their further influence on the composition and response of the decomposing microbial community [16,17].

Bacteria are generally less studied decomposers in forest soils compared to fungi, particularly in later stages of decomposition [18]. That might be due to the previous association of bacterial decomposition with readily degradable nutrient rich litter. However, some recent studies found that after the initial stage of decomposition, bacterial community showed increased diversity and different structure than in the early stages of decomposition [19]. Moreover, bacterial phyla *Actinobacteria* and *Firmicutes*, which represent K-selected decomposers, dominated in stages characterized by high proportion of a recalcitrant organic matter [20].

Thus, our study aimed in evaluating differences between chemical conditions and microbial communities of native beech and introduced spruce litter during the decomposition stage following the initial stage in two forests soils. The forests are located next to each other in the Jizera Mountains, Czech Republic. They share an acid bedrock (porphyric granite) and mountainous climate with intense precipitation of 800–1700 mm per year [16,21]. We hypothesized that the beech litter will promote faster decomposition with a more abundant and diverse microbial community. In contrast, the spruce litter will

98 be preserved against decomposition by relatively high acidity and sequestrated C, which will support less 99 abundant decomposers possibly dominated by a few taxa. The comparison consisted of detailed litter 100 chemical analyses (DOC, HIX, A254), low molecular mass organic acids (LMMOA), N, P, Ca, Mn, Fe 101 together with the observation of the microbial succession on beech leaves and spruce needles using 102 quantification of bacteria (16S rRNA, ddPCR) and fungi (ITS region, ddPCR) and bacterial community 103 composition (16S rRNA, Illumina MiSeq) after months 15, 19 and 29 of decomposition. That knowledge 104 was further applied to resolve factors which support higher decomposition rate and more diverse microbial 105 community in the beech forest soil and to find the basis of the humus quality and soil type formation at 106 the two sites.

#### 107 **2. Materials and Methods**

#### 108 **2.1. Litter bag experiment**

109 The litterbag experiment was carried out in a beech forest (European beech, Fagus sylvatica L.) 110 and a spruce forest (Norway spruce, *Picea abies* [L.] Karst.), which grow next to each other on the Palicnik 111 hill located in the Jizera Mountains (Czech Republic; 50.8673125N, 15.2544103E), affected by 112 acidification in the past [16]. The altitude of studied plots ranged from 635 (bottom limit) to 680 m a.s.l. 113 (upper limit). The bedrock of both forest types is a medium-grained porphyric granite and granodiorite of 114 the Upper Carboniferous age. The soil under spruce was classified as the Entic and Haplic Podzols and the soil under beech as the Aluminic Cambisol [22]. Mor or moder are respectively the prevailing types 115 of humus [23]. Mean annual temperatures 7.33 °C, 9 °C and 8.7 °C and mean annual precipitations 922 116 117 mm, 683 mm and 696 mm were measured in years 2013, 2014 and 2015, respectively, in Liberec region, 118 where the experiment was conducted [24]. Diameter at breast height of living trees was 534.6 ( $\pm 153.4$ ) 119 mm in beech forest and 405.8 ( $\pm$ 112.4) mm in spruce forest, canopy closure was 87 % in beech and 40 % in spruce forest and total area of rock was 811.9 m<sup>2</sup> in beech forest and 10.9 m<sup>2</sup> in spruce forest [23]. The 120 121 experimental layout is showed in Supplementary Fig. S1.

Soil samples were collected from the surface litter (L), fermentation (F), humified (H) organic and organo-mineral (humic, A) horizons. Samples from subsurface B horizons (cambic or spodic) were also collected. Each sample was thoroughly mixed. The soil samples were analyzed in a "fresh" state representing actual soil moisture and in dry and sieved (< 2mm) state. In total, 8 beech and 7 spruce soil pits were described and sampled in September 2015.

127 Newly fallen spruce needles and beech leaves were collected in November 2011. Part of the 128 collected litter was directly used for chemical analysis (denoted as the initial litter). Overall, 120 bags 129 were made of polyamide with 99 μm mesh size and 50 μm fibre diameter were filled with 5 g of dry beech 130 (BL) or spruce (SL) litter. Sixty bags with BL were placed in the beech forest and sixty with SL in the 131 spruce forest 1 m apart between litter (L) and fermentation (F) organic horizons in April 2013. Three 132 litterbags from each litter type were collected during each sampling period in May 2013, June 2013, July 2013, August 2013, September 2013, October 2013, November 2013, July 2014, November 2014 and 133 September 2015 (i.e. months 1, 2, 3, 4, 5, 6, 7, 15, 19 and 29 from the start of the experiment). After the 134 135 collecting, samples were weighed and frozen for further analysis. Mass loss of litter and chemical analyses 136 were assessed for all samples but only samples collected in months 15, 19 and 29 were chosen for further 137 microbiological analysis because at those dates, an increased rate of decomposition was observed. The 138 stage was thus termed exponential.

#### 140 **2.2. Chemical analysis**

### 141 **2.2.1. Soil analysis**

Fresh soil samples were extracted by deionised water and pH and DOC were measured according to Tejnecky et al. [16,17]. Cation exchange capacity (CEC) and exchangeable elements ( $Ca_{ex}$ ,  $Al_{ex}$ ,  $H^+_{ex}$ ) were determined according to Cools and De Vos [25] and base saturation (BS in %) was calculated as a ratio between CEC and base cations ( $Na^+$ ,  $K^+$ ,  $Ca^{2+}$  and  $Mg^{2+}$ ).

## 147 **2.2.2.** Litter analyses

Water extracts were made from each defrosted sample (1 g of thawed sample with 30 ml deionized
H<sub>2</sub>O). Water extraction represents easily available elements or substances and preserves sample matrices
[26]. The suspension was then centrifuged at 4000 g for 15 min; finally, extracts were filtered through a
0.45 µm nylon membrane filter (Sigma-Aldrich, MO, USA). In aqueous extracts, the following chemical

152 parameters were determined: pH, main inorganic anions (NO<sub>3</sub><sup>-</sup> w, NO<sub>2</sub><sup>-</sup> w, SO<sub>4</sub><sup>2-</sup> w and PO<sub>4</sub><sup>3-</sup> w, Cl<sup>-</sup> w, F<sup>-</sup> w) 153 and low-molecular mass organic acids (LMMOA, lactate w, acetate w, formate w and oxalate w) by means 154 of ion chromatography (IC, ICS 1600; Dionex; CA, USA) with suppressed conductivity. Cations (NH4<sup>+</sup> w, K<sup>+</sup> w, Mg<sup>2+</sup> w, Na<sup>+</sup> w, Ca<sup>2+</sup> w) were determined by means of ion chromatography (ICS 90, Dionex; CA, 155 156 USA) and the contents of selected elements (P w, Al w, Fe w, K w, Ca w, Mn w) by inductively coupled plasma-optical emission spectrometer (ICP-OES, DUO iCap 7000; Thermo Scientific, MA, USA). The 157 158 contents of Ntot, Ctot, Stot were determined by Elementary Analyzer Flash 2000 NCS (Thermo Scientific, 159 UK). For Ctot, Stot, Ntot, 9 replicates were used for SL but 7 replicates were used for BL. The respective 160 part of each sample was oven dried (40°C), homogenized and digested in Teflon vessels with the addition 161 of HNO<sub>3</sub> (0.5 g of samples and 5-10 ml 65 % HNO<sub>3</sub>). In the obtained solution, the contents of selected 162 elements (Ptot, Catot, Mgtot, Ktot, Altot, Fetot and Mntot) were determined by ICP-OES (DUO iCap 7000, Thermo Scientific, MA, USA). Quality of digestion and analysis were controlled using standard reference 163 164 materials (NIST SRM 1575a Pine Needles and NCS DC 73351 Tea). The contents of elements and 165 substances were calculated to dry mass.

166 Dissolved organic carbon (DOC), absorbance at 254 nm ( $A_{254}$ ) and humification index (HIX) were determined in water extracts of litter- using 0.2500 g of homogenized litter mixed with 12.5 ml of 167 deionized water incubated for 24 h at 4 °C on an orbital shaker. The 4 °C condition was selected to 168 minimize microbial DOM alteration during extraction [27]. Suspensions were centrifuged at 3000 g for 169 170 25 min before vacuum filtering through 0.4 µm polycarbonate membrane filter (Whatman, England). The 171 DOC concentration in the extracts was determined by high temperature catalytic oxidation using a Shimadzu TOC-V analyzer (Kyoto, Japan). UV A254 was obtained using a Shimadzu UV-1800 172 173 spectrophotometer and a 1-cm quartz cuvette.

174 All litter extracts were diluted with deionized water to set the absorbance at 254 nm to 0.10 to 175 minimize inner-filtration effects in obtaining the fluorescence spectra [28]. Fluorescence spectra were 176 obtained using a Hitachi F-4500 spectrofluorometer (Tokyo, Japan). The instrumental parameters were: excitation (EX) and emission (EM) slits, 5 nm; response time, 0.5 s; and scan speed, 2400 nm min<sup>-1</sup>. The 177 EM spectra were obtained using 240 nm for EX and EM recorded from 300 to 600 nm. Correction factors 178 179 were applied according to the manufacturer's instructions, emission scans were blank subtracted, then 180 Raman Normalized, and then corrected for dilution in R 3.5.0 [29]. The HIX was calculated as ratio of the 181 sum of fluorescence intensities from 435 to 480 nm divided by sum of intensities from 300 to 345 nm and 182 435 to 480 nm [28].

183 From initial litter samples, total contents of Catot, Mntot, Fetot, Ktot, Mgtot, Natot, Altot, DOC, A254 and
184 HIX were assessed.

# 186 **2.3. DNA extraction and amplicon sequencing**

187 DNA was extracted from 0.1 g of homogenized plant litter by method described in Sagova-188 Mareckova et al. [30]. The method is based on bead-beating and phenol/chloroform extraction. The 189 samples were purified by incubation with acetyltrimethylammonium bromide followed by chloroform 190 extraction and incubation with CaCl<sub>2</sub>. DNA samples were finally cleaned with GeneClean Turbo kit (MP 191 Biomedicals, CA, USA) and afterwards stored at -70 °C until further analysis. Fragments of the bacterial 192 16S rRNA gene including the variable region V3-V4 were amplified from the DNA samples by PCR, 193 using bacteria specific forward primer 341F (CCTACGGGAGGCAGCAG) and universal reverse primer 194 806R (GGACTACHVGGGTWTCTAAT). Construction of amplicon libraries and sequencing using 195 MiSeq sequencer (Illumina, San Diego, USA) were done at the DNA Services Facility, Research 196 Resources Center, University of Illinois (Chicago, USA).

197

198 **2.4. Processing of sequence data** 

The resulting paired sequence reads were merged, filtered, aligned using reference alignment from the Sylva database [31], and chimera checked using integrated Vsearch tool[32] following the MiSeq standard operation procedure (Miseq SOP, February 2018; [33]) in Mothur v. 1.39.5 software [34]. A taxonomic assignment of sequence libraries was performed in Mothur using the recreated SEED database subset of Sylva Small Subunit rRNA Database, release 132 [35] adapted for use in Mothur (https://mothur.org/w/images/a/a4/Sylva.seed v132.tgz) as the reference database.

205 Sequences of plastids, mitochondria, and those not classified in the domain *Bacteria* were discarded. The 206 sequence library was clustered into operational taxonomic units (OTUs) using the Uparse pipeline in 207 Usearch v10.0.240 software [36], and the OTU table was further processed using tools implemented in 208 the Mothur software. Rarefaction curves were used to detect observed OTUs for respective sequence 209 numbers. Bray-Curtis distance matrices describing the differences in bacterial community composition 210 between individual samples were calculated. The Illumina MiSeq 16S rRNA gene amplicon sequences 211 were deposited in the NCBI Sequence Read Archive (www.ncbi.nlm.nih.gov/sra) as BioProject No.: 212 PRJNA494609.

# 2.5. Quantification of bacteria and fungi

215 Quantification of bacteria (16S rRNA genes) and fungi (ITS region) from extracted DNA were 216 (ddPCR). by droplet digital PCR For gene amplification primers 16Seu27f done 217 (AGAGTTTGATCMTGGCKCAG) [37] and mixture of 783r-a, (CTACCAGGGTATCTAATCCTG), 218 783r-b (CTACCGGGGTATCTAATCCCG) and 783r-c (CTACCCGGGTATCTAATCCGG) [38] were

219 for quantification bacterial 16S rRNA ITS1F used of а gene and primers 220 (CTTGGTCATTTAGAGGAAGTAA) [39] and ITS4 (TCCTCCGCTTATTGATATGC) [40] were used 221 for quantification of a fungal ITS region. Reactions were prepared with QX200 EvaGreen Digital PCR Supermix (Bio-Rad Laboratories, CA, USA) with 400 µM final concentration of forward and reverse 222 primers. After generating droplets in QX200<sup>TM</sup> Droplet Generator (Bio-Rad Laboratories, CA, USA) the 223 224 PCR amplifications were performed (annealing temperatures: 56°C for bacteria and 54°C for fungi) and 225 droplets were detected fluorescently in Droplet Reader (Bio-Rad Laboratories, CA, USA). Results were 226 analyzed in QuantaSoft 1.7.4.0917 (Bio-Rad Laboratories, CA, USA).

### 228 **2.6. Statistical analysis**

229 Based on the observation of increased rate of decomposition, samples from months 15, 19 and 29 230 of each litter (n = 9) were used for statistical analysis (except for several analyses of mass loss and a few selected chemical traits in the Supplementary Material). The effect of litter type and time during the whole 231 232 course of the experiment (from months 1 to 29) on mass loss was calculated by two-way ANOVA. Pair-233 wise differences in mass loss between each month of decomposition for BL and SL were separately 234 calculated by ANOVA and Tukey's post-hoc test. Mass loss, chemical and microbiological variables 235 (abundance of bacteria 16S rRNA and fungi ITS region) from the three months of exponential stage decomposition period on the BL (n = 9) and SL (n = 9) litter and chemical variables from the initial litter 236 (n = 3) were compared by Welch version of the two-sample t-test [41], which does not require equal 237 238 variances for both groups. The effect of time was not statistically analyzed.

Rarefaction analysis was used to demonstrate bacterial diversity expressed as the number of observed OTUs with sequence numbers. Analysis of molecular variance (AMOVA) was calculated based on a matrix of Bray-Curtis distances [42]. Metastats [43] analysis was used to show differences between

242 bacterial communities of BL and SL and to detect the differentially represented OTUs between the two 243 litter types. The outcome was also visualized as heat maps. Maximum-likelihood phylogram of the OTU 244 representative sequences was constructed using FastTree 2 [44]. Figures were created using Interactive Tree of Life online tool (http://itol.embl.de; [45], and Inkscape (v0.92; http://www.inkscape.org).The 245 Bray-Curtis distance matrix was plotted by non-metric multidimensional scaling [46] using the Mass 246 247 package v. 7.3-51.5 [47]. Vectors of environmental variables which significantly correlated to bacterial 248 community were fitted to the nmds plot in R using function envfit from the package vegan v. 2.5-6 [48]. 249 All statistical calculations were done in the R computing environment [29] or in Mothur v. 1.39.5 software 250 [34]. Figures were plotted with the help of vegan package [49].

251 **3. Results** 

## **3.1. Soil chemical characteristics**

253 Spruce forest soils were more acidic (pH =  $3.82 \pm 0.29$ ) than beech forest soils (pH =  $4.08 \pm 0.27$ ) except for F horizons, where pH were not statistically different (Table 1). H<sup>+</sup><sub>ex</sub> represents exchangeable 254 255 pool of H<sup>+</sup> and significantly differed between beech and spruce soil profile except the B horizon (Table 1). In the uppermost L horizon, the content of  $Ca^{2+}_{ex}$ , base saturation (BS), cation exchange capacity (CEC) 256 and dissolved organic carbon (DOC) were significantly higher in the beech forest (Table 1).  $Al_{ex}^{3+}$  was 257 258 the lowest in L horizon and did not differ between the two forest soils (Table 1). Litter (L) organic horizons 259 thickness under beech was on average 2.7 cm and 1.8 cm under spruce and bulk density under beech was  $0.015 \text{ g.cm}^{-3}$  and  $0.048 \text{ g.cm}^{-3}$  under spruce. 260

## **3.2. Litter mass loss**

Litter mass loss was affected by factors of time as well as litter type (Table S1.) The average litter mass decreased from month 1 to month 29 by about 22.4 % in beech and 12.4 % in spruce forests (p < 0.001, Fig 1). In month 15, beech litter (BL) entered the exponential decomposition rate with the highest differences in mass loss between beech and spruce (SL) litter recorded in the last month 29 (Fig. 1). The mass loss most significantly differed from previous months in months 19 and 29 for BL and in month 29 for SL (Fig. 1). The mass loss was significantly different between BL and SL in months 15 to 29 (Table S2 A).

## **3.3.** Litter chemical characteristics

In the initial litter, significantly higher contents of Ca<sub>tot</sub>, Mn<sub>tot</sub>, K<sub>tot</sub>, Mg<sub>tot</sub> and Na<sub>tot</sub> were measured for BL, while higher, Al<sub>tot</sub>, S<sub>tot</sub>, N<sub>tot</sub>, C<sub>tot</sub> were measured for SL (Table S2 B). Differences for selected elements (N<sub>tot</sub>, S<sub>tot</sub>, P<sub>tot</sub>, Fe<sub>tot</sub>, Ca<sub>tot</sub>, Mn<sub>tot</sub>) from month 1 to month 29 were specific for each litter type (Fig. S2; Table S3). A particularly fast decrease of Ca and Mn was observed in beech, and P in spruce in the
beginning of the decomposition process (Fig. S2).

In the exponential stage litter, (month 15, 19 and 29) contents of Ca<sub>tot</sub>, Mn<sub>tot</sub> and pH were significantly higher for BL, while Fe<sub>tot</sub>, Fe<sub>w</sub>, P<sub>tot</sub>, S, N were significantly higher for SL (Table S2 A). Yet, most of the studied chemical parameters (NO<sub>3</sub><sup>-</sup>w, NO<sub>2</sub><sup>-</sup>w, SO<sub>4</sub><sup>2-</sup>w, PO<sub>4</sub><sup>3-</sup>w, Cl<sup>-</sup>w, F<sup>-</sup>w, NH<sub>4</sub><sup>+</sup>w, K<sup>+</sup>w, Mg<sup>2+</sup>w, Na<sup>+</sup>w, Ca<sup>2+</sup>w, lactate w, acetate w, formate w, oxalate w, Pw, Alw, Al<sub>tot</sub>, Mnw, Caw, Kw, K<sub>tot</sub>, DOC, HIX) did not significantly differ between the two litter types throughout the experiment (Table S2 A).

# 288 **3.4. Microbial characteristics**

Abundances of bacteria (16S rRNA gene copies) and fungi (ITS region gene copies) did not significantly differ between BL and SL in months 15, 19 and 29 of decomposition (Table S2 A) but composition of bacterial communities (Illumina MiSeq) differed significantly between BL and SL (Table S4).

More specifically, the bacterial community composition was analyzed using a total of 665,606 16S rRNA gene sequence reads were mapped to 2052 OTUs. Bacterial communities were represented by highest proportions of *Proteobacteria*, followed by *Actinobacteria*, *Firmicutes*, *Acidobacteria* and *Bacteroidetes* on BL and by *Actinobacteria*, followed by *Proteobacteria*, *Acidobacteria*, *Firmicutes* and *Bacteroidetes* on SL (Fig. 2). Proportions of *Acidobacteria*, *Actinobacteria*, *Bacteroidetes*, *Firmicutes*, *Patescibacteria* and *Proteobacteria* significantly differed between BL and SL (Table S4.)

302 Proportions of Proteobacteria families Acetobacteraceae and Burkholderiaceae were higher on 303 SL than on BL, while Bradyrhizobiaceae and unclassified Gammaproteobacteria were higher on BL than 304 on SL (Fig. S3). Proportions of all Actinobacteria families were higher on SL than on BL (Fig. S4). 305 Highest proportions of Solirubrobacteraceae, followed by Trebon clade, Mycobacteriaceae, were found 306 on both litter types, but proportionally lower were on BL (Fig. S4). Proportions of Firmicutes families 307 decreased in the following period with both litter types, while they were overall higher (especially in 308 month 15 and in month 29) on BL than on SL. The family Bacillaceae 1 followed by Bacillaceae 2, 309 Paenibacillaceae 1 and unclassified Bacillales dominated on BL, while Alicyclobacillaceae dominated 310 on SL (Fig. S5).

The phylogenetic tree was built from 839 OTUs differing significantly between communities associated with SL and BL (Metastats, p < 0.05). Out of those, proportions of 294 OTUs were higher on SL and 545 OTUs on BL. OTUs corresponding to *Actinobacteria*, *Acidobacteria*, *Firmicutes* and *Cand*. *Saccharibacteria* were proportionally higher on SL, while *Proteobacteria*, *Bacteroidetes*, *Verrucomicrobia*, *Planctomycetes* and *Parcubacteria* on BL (Fig. 3).

321 Changes in the composition of bacterial communities showed that higher number of OTUs 322 significantly contributing to differences between months 15 and 29 were found on BL (Metastats, p <323 0.05, Fig. 4). The number of OTUs significantly contributing to differences between litter types was the 324 highest in month 29 and the lowest in month 19 (Metastats, p < 0.05). Rarefaction curves demonstrated that bacterial diversity was higher for the BL than the SL in months 15 and 19 (Fig. S6).

326

Heat maps (supported by Metastats) showed differences between BL and SL between months 15 and 29 (Table S5 A, B). On BL proportions of 155 OTUs differed (Metastats, p < 0.05), out of which 123 OTUs proportions increased and 32 OTUs decreased. On SL, proportions of only 67 OTUs differed, out of which 30 increased and 37 decreased during that period. The most abundant bacterial groups separating samples from month 15 and month 29 were on BL especially *Actinobacteria, Proteobacteria, Acidobacteria, Verrucomicrobia, Bacteroidetes, Firmicutes* and *WPS-2* (Table S5 A), while on SL it was

333 Acidobacteria, Actinobacteria, Proteobacteria, Patescibacteria and Firmicutes (Table S5 B).

### 338 **3.5. NMDS analysis**

339 NMDS distinguished bacterial communities into two groups corresponding to BL and SL (Fig. 5). 340 The bacterial community on BL most strongly positively correlated to DOC, oxalate, K w, followed by 341  $A_{254}$ , Mn<sub>tot</sub>, pH, Ca<sub>tot</sub>, Ca w, Mg<sup>2+</sup> w and bacterial diversity (Fig. 5). The bacterial community on SL most 342 strongly positively correlated to Ptot, followed by Few, Ntot, Stot, Fetot (Fig. 5).

343 Composition of bacterial communities at both sites significantly correlated to pH,  $Ca_{tot}$ ,  $Ca^{2+}_{w}$ ,

- 344 Mg<sup>2+</sup><sub>w</sub>, Fetot, Fe<sub>w</sub>, Mn<sub>w</sub>, Mn<sub>tot</sub>, Ptot, PO4<sup>3-</sup><sub>w</sub>, Ktot, K<sup>+</sup><sub>w</sub>, Ntot, Stot, Altot, DOC, A254, Acetate<sub>w</sub>, Oxalate<sub>w</sub>, HIX,
- 345 mass loss and bacterial diversity (Table S6).

## 355 **4. Discussion**

Abundances of bacteria and fungi did not differ between beech (BL) and spruce litter (SL) but different bacterial communities were established on the two litter types after 15, 19 and 29 months of decomposition, when it reached the exponential stage. The litter mainly differed by the length of time to reach the exponential stage but also by chemistry of litter and its changes over the following period. That complied with previous findings that the succession of bacterial communities rather than abundance reflected chemical differences between litter types [50,51] and that this was transferred to situations of the later decomposition stage [52,53].

363 More specifically, beech was typical by accumulation of Ca and Mg in leaves, which led to 364 concentration of those elements in shallow soil layers and consequently to improvement of soil quality. 365 That activity is called the base-pump strategy, which describes how trees selectively uptake certain 366 nutrients from lower horizons by their roots and via litter fall increase their concentration in top soil 367 horizons [5]. In contrast, spruce needles accumulated N and S, which probably originated in anthropogenic acidification (in form of  $HNO_3^-$  and  $SO_4^{2^-}$ , respectively) occurring in the past [16]. Also, the fresh needles 368 were enriched in Fe and Al, possibly due to preferential uptake of those elements from the granite bedrock 369 370 by spruce [21,54].

On beech litter, bacterial communities were most strongly correlated to DOC, oxalate and K<sub>w</sub>. Total DOC increased after the initial stage of decomposition and exposed higher degree of aromatic compounds (A<sub>254</sub>) [12]. Therefore, the correlation of BL community to DOC demonstrates the litter degradability, which enables microbes to utilize released C specific to a given stage of decomposition. The positive correlation between LMMOA (low molecular mass organic acids), especially oxalate and Ca<sup>2+</sup> to BL community can be explained by microbe solubilization of Ca from poorly dissolved biominerals e.g. calcium oxalate [55]. Additionally, BL bacterial community correlation to Mn<sub>tot</sub> may reflect the activity of manganese peroxidase, since  $Mn^{2+}$  is an essential component of this ligninolytic enzyme [4,9]. The positive relationship of organic compounds such as DOC, A<sub>254</sub> and LMMOA with the BL community together with higher weight loss supports the observed more complete decomposition of this substrate and confirms that BL was subjected to a more advanced stage of decay probably entering the exponential stage of decomposition [15].

383 On spruce litter, a positive relationship of SL bacterial community to P, Fe, N and S showed that 384 these elements were not only higher there but also available to bacterial inhabitants. More precisely, P 385 was probably not precipitated by basic cations as it happened in the BL [17] and was intensively depleted 386 from SL over time. Similarly, Fe often occurs in organo-mineral complexes [56] or complexes with P-PO<sub>4</sub><sup>3-</sup> [57], which are resistant to degradation. However, the correlation of SL community to both Fe and 387 P suggests that the community may be enriched with bacteria, which can solubilize those complexes 388 389 possibly using organic acids or siderophores [58]. It is typical for activities of Actinobacteria, which 390 indeed dominated SL. A positive correlation to N may reflect either increased N litter concentration or 391 possibly also N fixation by specialized bacteria [59]. Nitrogen and P typically promote decomposition in 392 earlier stages, and thus their relatively high content may enable a gradual shift of SL into the exponential 393 decomposition stage, which was already partially noticeable [10]. Above that, N together with S belong 394 among the main agents causing soil acidification and thus, might explain the community shift towards 395 acidophilic taxa, such as a proportional increase of Acidobacteria [16,18].

Interestingly, no effect of Al on bacterial communities was determined on either litter type, suggesting that bacterial communities may be protected from its toxicity by three different processes; i.e. while acidic SL might release Al to lower organic horizons, Al on BL might be bound by cations, inorganic anions  $(SO_4^{2-}, F^-)$  and organic compounds (e.g. fulvic acid, DOC and organic acids) [60,61], which function as natural complexation agents eliminating Al toxicity [3] or that the bacteria are adapted by 401 resistance developed over the time of exposure [62].

402 Differing content and availability of nutrients of the two litter types corresponded to bacterial 403 functional groups represented by typical taxa. Proteobacteria, Bacteroidetes, Verrucomicrobia dominated 404 on BL. Especially, Betaproteobacteria and Bacteroidetes are considered r-selected, preferentially utilizing 405 easily accessible substrates in balanced environment [63]. SL was typical by higher proportion of 406 Actinobacteria, Acidobacteria and Firmicutes. Actinobacteria and Firmicutes are typical K-selected litter 407 decomposers [64] and Acidobacteria are a group, which preferentially inhabits low pH forest soils [18,65]. 408 The most pronounced differences between the communities on the two studied litter types were 409 found in *Firmicutes*, of which *Bacillaceae* and *Paenibacilaceae* had higher proportions on BL, while 410 Alicyclobacilales dominated on SL. Out of those, Bacilli and Paenibacilli are highly abundant in organic 411 soil horizons, where they participate at decomposition of calcareous substrates. They are also involved in 412 the N cycle, including N fixation and P solubilization in soil [66]. In comparison, the family 413 Alicyclobacilaceae suggests shifting of the SL community towards acidophilic members since its 414 members were described as thermo-acidophilic [67]. However, Bacillaceae as well as Alicyclobacilaceae 415 significantly decrease over the exponential stage on BL and SL suggesting a correlation with nutrients 416 typical for each litter type.

417 Other important exponential stage decomposers were *Actinobacteria*. *Actinobacteria* may promote 418 availability of some limiting nutrients because they produce an array of enzymes, organic acids and 419 siderophores, which participate in solubilization of organic matter and soil complexes [68]. In particular, 420 a higher proportion of *Solirubrobacteraceae* was observed on SL and they belong among plant growth 421 promoting bacteria [69]. Additionally, Trebon clade, a new clade of *Actinobacteria* occurring in acidic 422 soils [70] had higher relative abundance on SL.

423

The different modes of pedogenesis observed under spruce or beech [16] resulted from both litter

424 chemistry and bacterial community composition, which together provide a particular potential for 425 decomposing activities and explain the diverging decomposition rates [71]. Furthermore, on the BL, 426 higher litter Catot positively correlated to soluble C, C turnover and diversity of soil microbes, which may 427 further improve the development of soil horizons [72]. In contrast, SL with lower amounts of Mn and Ca, 428 higher amounts of Fetot, Stot, Ntot and Ptot and low pH, reduced the rate of microbial decomposition, 429 resulting in higher accumulation of lower quality litter in the soil. More specifically, lower pH in SL can 430 lead to increased mobility of Al, Mn and Fe, which leach from the L horizon to deeper parts of soil profile 431 causing the differentiation of soil profiles - creating podzol (e.g. Sauer et al. [73]). It has been observed previously that even small differences between the quality of humus and soil chemistry (pH) led to 432 433 increasing podsolization process in cambisols [74]. Similar observation was previously reported from the 434 Giant Mountains (Czechia) [75]. Thus, soils with different characteristics are developed under the two 435 tree species and their different microbial communities and decomposition rate may have consequences in 436 the stability and resilience of beech and spruce forests.

#### 438 **5.** Conclusions

Our study compared the litter decomposition rate of beech litter (BL) and spruce litter (SL). The BL displayed lower C accumulation and higher release of aromatic DOC after 15, 19 and 29 months of decomposition, while SL showed lower pH and higher amount of Fe, S, N and P, resulting in accumulation of organic matter and thus, C sequestration in the soil.

The BL had the lag-time of decomposition delayed until month 15 but after that period the decomposition was relatively fast and supported by readily available compounds, while promoting the growth of r-selected taxa. On the contrary, SL was described as an oligotrophic environment typical with K-selected taxa, which together with acidic conditions caused that the SL substrate to remain in the lag-phase during the entire experiment.

The litter chemical quality and specific decomposition pathways determined by the presence of soil microorganisms with different life strategies lead to a consequent transformation of litter to humus with different quality in beech and spruce forests. Finally, that process results to the development of soils, which undergo podsolization under spruce but not beech.

# Litter traits and rainfall reduction alter microbial litter decomposers: the evidence from three Mediterranean forests

# ABSTRACT

The objective of the study was to evaluate changes in microbial communities with the predicted arrival of new species to Mediterranean forests under projected intensification of water stress conditions. For that, litter from three Mediterranean forests dominated respectively by *Quercus pubescens* Willd., *Quercus ilex* L. and *Pinus halepensis* Mill. were collected, and placed to their 'home' forest but also to the two other forests under natural and amplified drought conditions (i.e. rainfall reduction of 30%). Quantitative PCR showed that overall, actinobacteria and total bacteria were more abundant in *Q. pubescens* and *Q. ilex* than in *P. halepensis* litter. However, the abundance of both groups was dependent on the forest sites: placement of allochthonous litter to *Q. pubescens* and *P. halepensis* forests (i.e. *P. halepensis* and *Q. pubescens*, respectively) increased bacterial and fungal abundances, while no effect was observed in *Q. ilex* forest. *P. halepensis* litter in *Q. pubescens* and *Q. ilex* forests significantly reduced actinobacteria (A/F) and total bacteria (B/F) to fungi ratios. The reduction of rainfall did not influence actinobacteria and bacteria but caused an increase of fungi. As a result, a reduction of A/F ratio is expected with the plant community change towards the dominance of spreading *P. halepensis* under amplified drought conditions.

# **INTRODUCTION**

Microorganisms are key actors in nutrient cycling and carbon turnover during litter decomposition (Gessner et al. 2010; Garcia-Pausas and Paterson 2011). At a global scale, it is estimated that the soil C coming from soil microbial biomass is about 16.7 Pg C, which represents approximately 2.3-2.4% of total organic C found in soil in the top 30 cm (Xu, Thornton

and Post 2013). Heterotrophic respiration resulting from microbial litter decomposing activity can account for 10–90% of the  $CO_2$  efflux from soils and substantially affect the atmospheric  $CO_2$  concentration (Manzoni *et al.* 2012). However, annual reduction of rainfall by up to 30% predicted for the Mediterranean basin (Giorgi and Lionello 2008; IPCC 2014; Hertig and Tramblay 2017) may significantly impact microbial abundance and structure, and thus, also the overall C dynamics (Wardle and Putten 2002).

Studies have already demonstrated shifts in plant community composition in response to the changed climatic conditions (Morales et al. 2007; Bertrand et al. 2011; Guiot and Cramer 2016). In southern France, dominating downy oak (Quercus pubescens Willd.) is expected to be replaced by more drought tolerant species: the sclerophylls' evergreen holm oak (Quercus ilex L.) and Aleppo pine (Pinus halepensis Mill.) (Barbero et al. 1990; Fortunel et al. 2009). Additionally, the increase of water stress may induce the synthesis of plant secondary metabolites (e.g. phenolics) known for their phytotoxic activities and anti-appetizing effects, which limit leaf consumption by fauna (Chomel et al. 2014). This investment in defence mechanisms over primary metabolic processes may result on the one hand to the decrease of primary productivity (Ogaya and Peñuelas 2007) and thus litter inputs, and on the other hand, in the reduction of litter quality through the increase of recalcitrant organic compounds (i.e. lignin, wax, polyphenolics) (Ormeño et al. 2006; Hättenschwiler and Jørgensen 2010; Sagova-Mareckova et al. 2011). Moreover, the reduction of moisture level may induce physiological stress and limit dispersal of microorganisms, enzymatic activities and substrate diffusion (Bouskill et al. 2013). Thus, the reduction of moisture levels and aboveground litter quality and quantity may impose new community dynamics belowground (Lunghini et al. 2013; Cleveland et al. 2014) and lead to a shift of soil microbial communities to more drought tolerant species, capable of using recalcitrant C sources and resistant to desiccation (Yuste et al. 2011; Peñuelas et al. 2012; Allison et al. 2013). Actinobacteria are known to thrive in low resource environments (Fierer, Bradford and Jackson 2007) and low soil moisture conditions (Yuste et al. 2011; De Vries and Shade 2013; Acosta-Martinez et al. 2014) reaching high abundance in arid soils (Okoro et al. 2009). They are well protected by a strong, thick interlinked peptidoglycan cell wall, which explains their high resistance to low osmotic potential conditions (Davet 2004). They produce enzymes able to degrade a wide range of biopolymers, whose building blocks including aromatic compounds (McCarthy and Williams 1992) have a vital role in organic matter turnover and humus formations (Anandan, Dharumadurai and Manogaran 2016). They produce a variety of secondary metabolites (Anandan et al. 2016), through which they interact with other microbial groups (Lewin et al. 2016). However, little is known about how microbial communities and actinobacteria in particular, would be affected by future reduction of rainfall, both directly by decrease of moisture level and indirectly through the plant species shift. In general, litter types sharing a common history with local microbial communities (autochthonous) have faster decomposition rates than litter types coming from distant (allochthonous) habitats (Gholz et al. 2000; Strickland et al. 2009). Consequently, changes in biochemical composition of local litter with the arrival of new species may constrain microbial activity and impact negatively litter decomposition (Schimel, Balser and Wallenstein 2007).

In here, we examine how reduction of rainfall and change in plant species may affect belowground microbial community's (actinobacteria, fungi and total bacteria) abundance and structure and consequently also the litter decomposition process. For that, we performed a litter transplanting experiment between three main Mediterranean forests (Q. *pubescens* Willd., Q. *ilex* L., and P. *halepensis* Mill.) occurring in Southeast of France, under natural and amplified drought conditions for simulating the 30% rainfall reduction. We hypothesised that the arrival of new litter under amplified drought conditions will have a negative impact on microbial abundance and litter decomposition.

# MATERIALS AND METHODS

#### Sites description

This study was conducted at the three forest sites in the Mediterranean region in southern France: the Q. pubescens forest at Oak Observatory at the 'Observatoire de Haute Provence' (O<sub>3</sub>HP; Santonja et al. 2015a), the Q. ilex forest at Puéchabon (Limousin et al. 2008) and the mixed P. halepensis forest at Font-Blanche (Table 1). During the study period, the mean annual temperature was 12.1°C, 13.7°C and 14.0°C, and the cumulative annual precipitation was 609 mm, 794 mm and 632 mm, respectively (Table 1; Supplementary Figure 1, Supporting Information). There were no significant differences between sites in the mean annual temperature and cumulative annual precipitation during the study period (One-way ANOVA, P < 0.05). Each site included a control plot (natural drought-ND) and a rain exclusion plot (amplified drought—AD) to mimic the future reduction of rainfall predicted by the climatic model for the Mediterranean Region (about -30% yearly; Table 1 and Supplementary Figure 2, Supporting Information).

#### Experimental design and sample processing

In 2014, senescent leaves were collected in the control plot of the three forests. For that, litter traps were used during the abscission period that occurred from October to November for the broadleaves (*Q. ilex* and *Q. pubescens*) and from June to September for the needles (*P. halepensis*). Leaves and needles were air dried and stored at room temperature in paper boxes until the beginning of the experiment.

Litter decomposition was assessed by using the litter bag method (Swift *et al.* 1979). Four-mm mesh litter bags ( $20 \times 20$ cm) containing 10 g (air-dried) of the senescent material were used to perform the experiment. Litter transplants were made between each site for the three species considered, i.e. a litter bag containing the litter of each species placed on each forest site, under two drought conditions: natural (ND) and amplified (AD) (see Supplementary Figure 3, Supporting Information).

Thus, the experiment consisted in 18 modalities corresponding to the 3 forests Q. ilex, Q. pubescens and P. halepensis)  $\times$  3 plant species (Q. ilex, Q. pubescens and P. halepensis)  $\times$  2 drought conditions (ND and AD). In total, 126 litter bags (18 modalities  $\times$  1 sampling date  $\times$  7 replicates) were analysed. Litter bags were placed perpendicularly to the gutters system in Aleppo pine and holm oak forests and under the rain exclusion device in the downy oak forest, by using a transect in blocks (7 columns x 6 lines), equidistantly one from each other (1 m distance between the 7 columns and 0.6 m between the 6 lines). Transects were E-W oriented. They were disposed in the ground floor after the removal of litter layer and fixed to the soil with galvanised nails to prevent movement by animals or wind. Litter layer was then replaced over the litterbags.

Litter bags were retrieved after 1 year (December 2015). Litterbags were placed in zipped plastic bags to prevent the loss of

biological material. In the laboratory, the soil and other debris were removed from the litter bags. Then, they were freeze-dried (Lyovac GT2) for 72 hours and the remaining dry mass (%) was calculated. A 1 g of dry mass aliquote was collected, grounded to powder (Retsch® MM400, 30 Hz during 30s) and kept at -20°C for posteriori microbial DNA analysis.

#### Initial litter chemical characteristics

At the beginning of the experiment, 5 replicates from each leaf species collected from trees in control plots were grounded to powder (Retsch® MM400, 30 Hz during 30s). Carbon (C) and nitrogen (N) were determined by thermal combustion on a Flash EA 1112 series C/N elemental analyser (Thermo-Scientific, U.S.A). Phosphorus (P) and cations (Ca, K, Mg and Na) were extracted from 80 mg of ground litter sample with 8 ml of nitric acid and 2 ml of  $H_2O_2$  at 175°C for 40 min using a microwave digestion system (Ethos One, Milestone SRL, Sorisole, Italy). After the mineralisation, each sample was adjusted to 50 ml with demineralised water. Phosphorus concentration was measured at 720 nm using a microplate reader (Victor, Perkin Elmer, Waltham, MA, USA). Cations were determined using an atom absorption spectrometer (AAS, iCE 3000 series, Thermo-Scientific, China). Leaf structural compounds (lignin, cellulose and hemicellulose) and water-soluble compounds (WSC) concentrations were determined according to the van Soest extraction protocol (Van Soest and Wine 1967), using a fiber analyser (Fibersac 24; Ankom®, Macedon, NJ, USA). Total phenolic concentrations were measured by colorimetry according to the method of Peñuelas et al. (1996) using gallic acid as standard. Aqueous extracts were made by dissolving 0.25 g of litter powder in 20 ml of 70% aqueous methanol solution with shaking for 1 hour and filtered (0.45  $\mu$ m). A total of 25 ml of extracts obtained were then mixed with 0.25 ml of Folin-Ciocalteu reagent (Folin and Denis 1915), 0.5 ml of saturated aqueous Na<sub>2</sub>CO<sub>3</sub> (to stabilize the colorimetric reaction) and 4 ml of distilled water. After 60 min, the reaction was completed and the concentration of phenolics was measured at 765 nm using a UV / Vis spectrophotometer (Thermoscientific, U.S.A.).

To determine the water holding capacity (WHC), twenty-one freshly abscised leaves (3 species x 5 replicates) were soaked in distilled water for 24 hours, drained and weighted (wet weight). The dry weight was measured after drying the samples for 48 hours at 60°C. Water holding capacity (in %) was calculated according to the formula: (wet weight/dry weight)  $\times$  100 (Santonja *et al.* 2015b). Specific leaf area (SLA) was determined by using the Image J software (https://imagej.nih.gov/ij/, MA, USA). Specific leaf area was calculated as the ratio between leaf area and leaf dry weight.

#### **DNA** extraction

Environmental DNA from leaf litter samples was extracted with the NucleoSpin® soil kit (Macherey-Nagel, Düren, Germany), following the standard protocol with a slight adjustment. In brief, approximately 250 mg of dry litter was added to the NucleoSpin Bead tubes. Lysis conditions were performed by using buffer SL1 (700 µl, vortex for 5 min, room temperature, 11 000 x g for 2 min), and buffer SL3 (150µl, vortex 5 min, 0–4°C, 14 000 g for 1 min). This procedure was repeated twice using the same sample to optimise the DNA extraction. The filtration of the supernatant was performed in the NucleoSpin Inhibitor Removal Column followed by 11 000 x g for 1 min. DNA binding was done in the Nucleo Spin Soil column after adding 250 µl of Buffer SB to the supernatant followed by 11 000 x g for 1 min. A series of successive DNA washing was performed: 500 µl buffer SB (11 000 x g, 3 sec), 550 µl buffer SW1 (11 000 x g, 3 sec), 700 µl SW2 (2 sec vortex, 11 000 x q, 3 sec). At each step, flow-through were discarded. Finally, DNA was eluted in 30  $\mu$ l of Buffer SE followed by incubation at room temperature for 1 min and 11 000 x g for 30 seconds and kept at -20°C until further analysis. DNA quantification was performed in the ND-1000 spectrophotometer (Nanodrop Technology, Wilmington, DE).

#### Quantitative real-time PCR analysis

Abundances of total bacteria, actinobacteria and fungi were assessed using a quantitative real-time PCR analysis (qPCR)

method. Microbial abundance was quantified as copy number of a target gene. Partial 16S rRNA gene sequences were amplified from the total bacteria using primers COM1 (5'-CAG CAGCCGCGGTAATAC-3') and 769R (5'-ATCCTGTTTGMTMCCCV CRC-3', annealing temperature 59°C) (Dorn-In et al. 2015), and from actinobacteria using primers S-P-Acti-1154-a-S-19 (5'-GRD ACYGCCGGGGTYAACT-3' annealing temperature 59°C) and S-P-Acti-1339-a-A-18 (5'-TCWGCGATTACTAGCGAC-3') (Pfeiffer et al. 2014). Partial 18S rRNA genes from fungi were amplified with primers FF390 (5'-CGATAACGAACGAGACCT-3') and FR1 (5'-A ICCATTCAATCGGTAIT-3', annealing temperature 50°C) (Vainio and Hantula 2000). All PCR reactions were done 15 µl total volume containing 1  $\times$  SYBR® Green Gotaq PCR Master Mix (Promega), primers at 600 nM for total bacteria and fungi, and 200 nM for actinobacteria, and 0.2-2 ng environmental DNA. The cycling parameters were: 10 min at 95°C followed by 45 cycles at 95°C (15 sec), 59°C (30 sec), 72°C (30 sec). Melting curves were recorded to ensure qPCR specificity, and gel electrophoresis analyses were performed to confirm the expected size of amplified products. All qPCR reactions were run in triplicate on StepOne Plus Real-Time PCR System (Applied Biosystems, Foster City, CA). To quantify the target gene copy numbers, standard dilution curves of known concentrations of previously cloned standards of the target genes were determined. Baseline and threshold calculations and data analysis were performed with the StepOne v. 2.2.2 software.

The primer pair recommended by Dorn-In et al. (2015) for amplification of bacterial 16S rRNA gene fragment from plant samples, Com1/769R (Rastogi et al. 2010; Fredriksson, Hermansson and Wilén 2013) was used for quantitative real-time PCR analysis of the total bacteria. The primer pair does not amplify 16 rRNA genes from chloroplasts, however, consequently also its coverage of the domain Bacteria is incomplete. In silico analysis using TestPrime 1.0 (Klindworth et al. 2013) against the Silva database, release 132 (www.arb-silva.de), showed 75% overall coverage of Bacteria with varying representation of the phyla, e.g. 88% Proteobacteria, 81.9% Firmicutes, 93.6% Bacteroidetes, but only 56.2% Actinobacteria, 20.5% Acidobacteria and 17.5% Verrucomicrobia. Therefore, the results can be used as a proxy of bacterial abundance when comparing between samples, but not to compare with qPCR quantification of individual bacterial phyla or lower taxonomic units using group-specific primers.

## Statistical analysis

All statistical analyses were performed in R v.3.1.3 software (R Development Core Team 2017). One-way analysis of variance (ANOVA) was used to determine differences between the initial parameters of litter plant species and between forest sites for each litter species and microbial group. Three-way ANOVA was also used to test the effects of forest sites (S), litter species (L) and drought treatment (D) on litter mass loss and microbial abundance (total bacteria (B), actinobacteria (A), fungi (F) and the respective B/F and A/F ratios, followed by *post-hoc* Tukey tests. Microbial abundance was log-transformed to fit the assumption of normality and homoscedasticity.

#### RESULTS

#### Initial litter composition

Initial litter characteristics varied significantly among species (Table 2, One-way ANOVA, P < 0.05). Quercus ilex showed a significantly higher N (9.62 mg  $g^{-1})$  and P (3.48 mg  $g^{-1})$  contents than the two other species, particularly P. halepensis (5.36 mg  $g^{-1}$ and 1.56 mg  $g^{-1}$ ), which resulted in a lowest C/N and C/P ratio for Q. ilex and highest ratios for P. halepensis (Table 2). Regarding the cations, Q. pubescens showed significantly higher content of Ca (32.90 mg  $g^{-1}$ ) and Mg (2.83 mg  $g^{-1}$ ), and lower content of K  $(0.84 \text{ mg g}^{-1})$  and Na  $(0.04 \text{ mg g}^{-1})$  than the two other species. Concerning the structural compounds of the leaves, Q. ilex had higher lignin (337.38 mg  $g^{-1})$  and cellulose content (204.99 mg g<sup>-1</sup>) than the two other species. Finally, Q. pubescens showed higher total phenolics content compared to Q. ilex, and the highest specific leaf area (133.13 mg g<sup>-1</sup>) and water holding capacity (146.90 mg g<sup>-1</sup>). Pinus halepensis showed higher water-soluble compounds (340.02 mg  $g^{-1}$ ) and lower water holding capacity  $(113.89 \text{ mg g}^{-1}).$ 

#### Litter mass loss

After 357 days of decomposition, litter mass loss was statistically different among sites and plant species with interaction effects (Table 3). On average, significantly higher mass loss occurred at *Q. pubescens* forest (36.94%) in comparison with *Q. ilex* forest (33.88%) and *P. halepensis* forest (33.80%). Regarding the litter, *P. halepensis* (36.81%) and *Q. ilex* (35.07%) lost significantly

higher mass than Q. pubescens (32.72%). Concerning interactions, P. halepensis lost most of its mass at Q. pubescens and P. halepensis forests compared to the Q. ilex forest (Fig. 1A). No significant effect of rain exclusion was found on the litter mass loss (Table 3).

#### Microbial abundance and structure

Abundances of actinobacteria, total bacteria and fungi differed significantly according to forest sites, when control and amplified drought conditions were combined (Table 3, Fig. 1) The highest abundances of all microbial groups were observed at P. halepensis forest and lowest at Q. ilex forest. However, it differed according to plant litter species producing a site x species interaction effect (Table 3; Fig. 1). Actinobacteria and total bacteria had the highest abundance in Q. ilex litter and lowest in P. halepensis at Q. ilex and P. halepensis forests, respectively (Fig. 1B and C). Roughly, higher abundance of fungi was observed in P. halepensis litter at Q. pubescens forest, Q. ilex litter at Q. ilex forest and Q. pubescens litter at P. halepensis forest (Fig. 1D). Regarding the actinobacteria to fungi (A/F) ratio, it was significantly higher in Q. pubescens and Q. ilex litter and lower in P. halepensis litter at Q. pubescens and Q. ilex forests (Fig. 1E). Total bacteria to fungi (B/F) ratio was significantly higher in Q. ilex litter and lowest in P. halepensis litter, at Q. ilex and P. halepensis forests (Fig. 1F).

Overall, there was a significant increase of fungal abundance and a decrease of A/F ratio under amplified drought (AD) in comparison with natural conditions (Table 3). No main effect of drought conditions was observed for actinobacteria, total bacteria and bacteria to fungi (B/F) ratio (Table 3). However, an interaction effect was observed between site and drought conditions for total bacteria, fungi and total bacteria to fungi ratio (Table 3; see Supplementary Table 1, Supporting Information). Thus, we observed a significant increase of total bacterial (Fig. 2A) and fungal abundance (Fig. 2B) under AD conditions at the P. halepensis forest, and a decrease of B/F ratio in Q. pubescens forest (Fig. 2C).

# DISCUSSION

In this study, we evaluated how reduction of rainfall and change in plant species may affect belowground microbial community's abundance and structure and consequently the litter decomposition process in three dominant Mediterranean forests of southern France. Our findings are that (i) actinobacteria and total bacteria were more affected by changes of plant species than by the decrease of water availability; (ii) fungi were positively impacted by the reduction of rainfall and (iii) the future arrival of *P. halepensis* litter to *Q. pubescens* and *Q. ilex* forest and rainfall reduction could alter the relative proportion of fungi and bacteria in the community hence having implication in microbial decomposers activity.

# Effects of litter quality on microbial communities and mass loss

Our results showed the importance of leaf litter initial litter with respect to microbial composition and litter mass loss dynamics. We observed higher abundance of actinobacteria and total bacteria in oak litter than in pine. This is in line with previous studies, which showed a preference of bacteria for high quality litter (i.e. low C/N, C/P, lignin: P and lignin/N ratio) (Hodge, Robinson and Fitter 2000; De Boer et al. 2005 ; Romaní et al. 2006). Both oaks Q. pubescens and Q. ilex are characterised by high N and P content, which are efficiently utilised by bacterial enzymes (Romani et al. 2006) and then are consistently considered key factors in litter decomposition and good predictors of litter mass loss (Moro and Domingo 2000; Garcia-Pausas, Casals and Romanya 2004; Güsewell and Gessner 2009). However, our results only partially corroborate with this by showing that Q. ilex and P. halepensis litter had higher mass loss than Q. pubescens. That is possibly due to higher initial content of total phenolics determined in Q. pubescens compared to Q. ilex, which are known to inhibit litter microbial communities and N mineralisation, during the early stage of decomposition (Lambers 1993; Souto, Chiapusio and Pellissier 2000; Ormeño et al. 2006; Chomel et al. 2014). This may explain the lower mass loss of its litter in comparison with Q. ilex and P. halepensis. The high mass loss of P. halepensis litter may be also explained by the leaching of high content of water-soluble compounds (Tripathi and Singh 1992; Kaushal et al. 2012) and high Na content (Gressel et al. 1995), which both are known to positive correlated litter decay. Gressel et al. (1995) observed that salt accumulation in P. halepensis needles enhanced their breakdown compared to Q. coccifera leaves in a typical Mediterranean mixed woodland.

# Effects of litter-site interaction on litter decomposition processes

The influence of plant species on litter decomposition varied according to the forest sites as shown by strong litter-site interaction. At Q. pubescens forest, we observed the highest abundance of fungi associated with P. halepensis litter, associated to a reduction of the A/F ratio. This is consistent with the findings by Hodge *et al.* (2000) and Wardle *et al.* (2004) who showed that fungi are favoured by litter with high C/N ratio. In addition, fungi

are rather considered specialists and are more equipped enzymatically to assimilate recalcitrant material than more generalist bacteria (Møller, Miller and Kjøller 1999; Romaní et al. 2006). The high abundance of total bacteria observed in *P. halepensis* litter may be explained by the synergistic relationship between bacteria and fungi because bacteria may benefit by the presence of fungi, which may provide them resources that bacteria were not able to acquire on their own (Romaní et al. 2006). At *Q.* ilex forest, microorganisms were more numerous with *Q.* ilex litter in comparison with the two other species, which suggests the high specificity of decomposers for decomposing the autochthonous litter in this forest (Ayres et al. 2009). However, this difference in microbial abundance did not lead to a significant difference in mass loss of *Q.* ilex litter in its own forest compared to the two other forests. This may due to the presence of decomposers able to use different sources of carbon. Decomposers can also develop preferences for some resources they are not used to (St John *et al.* 2011). Taking into account the three litter species, our results showed that *P. halepensis* forest had generally higher microbial abundance (actinobacteria, total bacteria and fungi) than other sites, possibly because this is the only mixed woodland out of the three studied forests and it was demonstrated that an increase of plant diversity promotes litter microbial growth (Chapman and Newman 2010; Santonja *et al.* 2017). Indeed, litter dissimilarity may decrease resource competition between functional groups and thus increase the abundance, activity, and hence efficiency of decomposers (Barbe *et al.* 2017).

# Effects of rainfall reduction on litter mass loss and microbial community

Contrary to our expectations, amplified drought conditions (AD) had no effect on litter mass loss after 1 year of decomposition. This may be explained by the extremely dry year during which the study was performed (Saunier et al. 2018). Actinobacteria were not directly affected by AD conditions, contrary to previous studies (Bouskill et al. 2013; Felsmann et al. 2015). Nevertheless, a reduction in the A/F ratio was observed, probably due to the positive effect of AD conditions on fungal abundance. The increase of fungal abundance under drier conditions was also observed in other Mediterranean forests (Hawkes et al. 2011; Sherman, Sternberg and Steinberger 2012; Allison et al. 2013; Alster et al. 2013). It is well recognised that fungi are more resistant to drought than bacteria (De Vries and Shade 2013; Guhr et al. 2015) and might get competitive advantage over bacteria during dry periods (Six 2012; Yuste et al. 2011). Moreover, the

expansion of fungal hyphae reported by some studies under drought periods (Allison et al. 2013; Zeglin et al. 2013) may result from the reduction of predatory pressure (i.e. grazers activity or number) under water stressed conditions (Davet 2004 ; Bapiri, Bååth and Rousk 2010; Barnard, Osborne and Firestone 2013). The observed decrease of the A/F ratio under AD conditions in Q. pubescens litter was possibly related to the persistence of phenolics due to the decrease of leaching processes under AD conditions, which delayed microbial colonisation by decomposers in that litter (Chomel et al. 2014). Contrary to fungi, total bacteria were not affected by changes in drought conditions. Bacterial biomass stability under drought was also observed by Hartmann et al. (2017), and it was explained by independence of bacteria on water film for dispersal (Mohammadipanah and Wink 2016). Nevertheless, those results varied according to forest site and litter type. For example, in the P. halepensis forest, an increase of total bacteria biomass was observed under AD conditions, which may be explained by (i) natural selection of the most droughttolerant bacterial groups (Barnard, Osborne and Firestone 2013) and/or (ii) bacteria resilience to drought resulting from their predominating r-selected life strategy, which enables rapid recovery after a period of disturbance (i.e. drought) (Barnard, Osborne and Firestone 2013; Meisner, Rousk and Bååth 2015).

## **CONCLUSIONS**

Our results showed that microbial litter decomposers respond differently to intensification of water stress conditions in the Mediterranean forests. Actinobacteria and total bacteria were more negatively affected by plant litter changes (Q. ilex and Q. pubescens higher than P. halepensis) than by the direct rainfall reduction. In contrary, fungal communities seemed to be more tolerant and even favored to water limitation. Also, the potential resilience of bacterial communities was proposed, while fungal response seemed to reflect a higher degree of adaptation to decreased water availability. Finally, the arrival of P. halepensis litter to a Q. pubescens and Q. ilex forest may change litter microbial communities, leading to a decrease of A/F and B/F ratios and promoting fungi and certain groups of bacteria, which are more capable of using complex carbon sources. Therefore, the intensification of drought conditions in Mediterranean forest may introduce a fungi dominated community over bacteria, by either the capability of degrading more recalcitrant litter or/and tolerance to future climate conditions.
