## **General introduction**

Organopalladium chemistry has found a variety of applications in organic synthesis, including cross-coupling reactions, C–H functionalization, asymmetric catalysis, and domino reactions. In particular, the palladium-catalyzed allylation is a very important transformation that allows to build-up complex structures in one or few synthetic operations.<sup>[1]</sup> In addition, allylsulfones constitute an extremely useful functional group that plays a key role in a number of important organic reactions. In this context, our group pioneered the palladium chemistry of sulfenate anions (RSO<sup>-</sup>),<sup>[2]</sup> showing that the palladium-catalyzed allylation of *in situ* generated sulfenate anions provides an efficient route to generate corresponding allyl sulfoxides, and allows the development of interesting pseudo-domino processes.<sup>[3]</sup>

My PhD project aimed to develop new transformations involving palladium catalysis and exploring the chemistry of sulfones, and can be divided into two projects. The first one deals with the development of a new domino reaction to access 1,3,5-trienes via a sequence of three consecutive reactions, two of them being catalyzed by palladium complexes. In the event, steps 1 and 2 are both Pd(0)-catalyzed, and, provided that a strong base is added after the first step, all steps could in principle be run in a one-pot mode. The subsequent sulfone elimination is also base promoted (Scheme 1).

The second project deals with the preparation of allylsulfones by Pd(II)-catalyzed allylic C–H activation. Direct PdX<sub>2</sub>-catalyzed C–H activation/functionalization is a powerful method for the construction of carbon-carbon bonds and carbon-heteroatom bonds.<sup>[4]</sup> However, the direct PdX<sub>2</sub>-catalyzed C-H sulfonylation procedure for the formation of the C-S bond has never been reported. Considering that the classical method to synthesize allylsulfones has the drawback of lacking economical and environment-friendly properties, it is a necessity to develop more efficient methods to prepare allylsulfones.

Based on previous reports from the literature, [5] we seek to find out reaction conditions that allow the synthesis of allylsulfones starting from abundant and commercially available terminal alkenes (Scheme 2).

The structure of the thesis consists of four chapters. In the first chapter, I will give a brief introduction to palladium chemistry and allylsulfones, along with some literature reporting Pd-catalysis in relation to allyl sulfones. The second chapter concerns the study of the Pd-catalyzed domino sequence towards the synthesis of conjugated trienes. The introduction of allylic C–H sulfonylation and PdX<sub>2</sub>-catalyzed allylic C-H activation will be presented in Chapter 3. In the last chapter, the optimization and scope of the PdX<sub>2</sub>-catalyzed allylic C–H sulfonylation will be described.

# Chapter 1. Introduction to $\eta^3$ -allylpalladium chemistry and allylsulfones.

#### 1. Introduction

Among the huge number of transformations associated to sulfones, some of them are palladium-catalyzed processes (Scheme 3). This is the case of the generation of sulfinate anions (RSO<sub>2</sub>-)<sup>[6]</sup> from aryl (or heteroaryl) halides and SO<sub>2</sub> sources ( $K_2S_2O_5$  or DABSO<sup>[7,8]</sup>) (equation a), the formation of allyl sulfones by the reaction between sulfinate anions and allyl esters (equation b);<sup>[9,10]</sup> the deprotonation of allyl sulfones by strong bases ( $pK_{a(DMSO)}$  PhSO<sub>2</sub>allyl = 22) and *in situ*  $\alpha$ -alkylation with electrophiles, including  $\eta^3$ -allylpalladium complexes,<sup>[11]</sup> (equation c), and the allylation of malonates with allylsulfones (equation d).<sup>[12]</sup>

The rational combination of the above, unrelated, rather old catalytic transformations may enable the development of smart and unprecedented coupling protocols. The optimization of disjointed catalytic transformations into a single domino sequence is not a simple task and may require a delicate and careful fine-tuning of several reaction parameters.

My initial PhD project aimed to develop a new sequence to access 1,3,5-trienes via a sequence of three consecutive reactions – possibly achievable in domino mode – two of which catalyzed by

palladium.<sup>[13]</sup> The sequence is the following: a) a Pd-catalyzed allylation of an aryl sulfinate anion by reaction with an allylic electrophile;<sup>[9,10]</sup> b) the subsequent Pd-catalyzed  $\alpha$ -allylation of the carbanion of the resulting allyl sulfone by reaction with a second allylic electrophile,<sup>[11]</sup> and c) the base promoted elimination of the resulting (3-arylsulfonyl)hexa-1,5-diene, to give the desired 1,3,5-triene (Scheme 4).

As this project is based on palladium catalysis and domino reactions, I will start this manuscript with a brief introduction of palladium catalysis in general. Then, I will describe the state of the art of Pd(0)-catalyzed allylations of sulfur-based nucleophiles, as well as the reactivity of allyl sulfones. Finally, I will disclose some concepts and selected precedents of Pd-catalyzed domino sequences.

## 2. The Chemistry of Palladium

Organopalladium chemistry has found a variety of applications in organic synthesis, especially in industrial processes. Indeed, the development of palladium-catalyzed cross-coupling reactions has been awarded with the Nobel prize in chemistry in 2010 for Richard F. Heck, Akira Suzuki and Ei-ichi Negishi. Palladium catalysts are able to favor and accelerate transformations that are hard to perform with more classical techniques. In most cases, palladium-catalyzed reactions take place under mild reaction conditions and tolerate a lot of functional groups. Palladium-catalyzed couplings have proven to be powerful and key reactions for the synthesis of a great number of targets, including carboand heterocycles. [14a,14c,15]

Palladium is a transition metal of the nickel triad, located in the second row of the periodic table.

Its ground-state electronic structure is [Kr]  $4d^{10}5s^0$ . Except rare exceptions, palladium complexes exist in the three oxidation states: Pd(0), Pd(II), Pd(IV), Pd(IV),

As a function of the nature of the ligands and reagents involved, the equilibria of these reactions may be more or less displaced to the left or right side, reversible or irreversible. All the Pd-catalyzed reactions feature a combination of the above elementary steps. The starting elementary step of the catalytic cycle can be the oxidative addition, the ligand coordination, or the ligand exchange, while the closing elementary step may be the reductive elimination or the depalladation step (usually dehydropalladation).

Thus, for example, phosphine- or NHC-ligated Pd(0) complexes are  $d^{10}$  electron-rich, nucleophilic species and can oxidatively add to electrophilic partners to give square planar Pd(II) 16 valence-electron (VE) complexes. This is for example the case of: a) allylic derivatives, which form  $\eta^3$ -allylpalladium(II) complexes **B**; b) aryl halides (or pseudo-halides), which form  $\sigma$ -arylpalladium(II) halides **C**; and c) molecular oxygen, which forms the  $\eta^2$ -peroxopalladium(II) complex **D** (Scheme 6).

The  $\eta^3$ -allylpalladium(II) complexes **B** and the  $\sigma$ -arylpalladium(II) halides **C** are important electrophilic intermediates in organic chemistry. The former ones, reversibly formed by oxidative addition of Pd(0) complexes and allylic systems (see above), as a function of the nature of the nucleophile, can suffer two types of allylic substitution: a) exterior attack of the nucleophile at the allylic ligand, *anti* to the Pd atom (*alias anti*-reductive elimination) (observed with soft nucleophiles); or b) ligand displacement at Pd atom, followed by *syn*-reductive elimination (observed with hard nucleophiles).  $\sigma$ -Arylpalladium(II) halides **C**, usually irreversibly formed by oxidative addition of Pd(0) to aryl halides or pseudo-halides (see above), also suffer ligand substitution on palladium followed by reductive elimination. On the other hand, C(sp³) organopalladium complexes bearing a  $\beta$ -H atom **D**, tend to undergo a very easy dehydropalladation (Scheme 7).

Pd(IV) complexes are quite rare, although a few complexes are known. These complexes have hardly been isolated, but transient Pd(IV) species are increasingly considered as intermediates in palladium-catalyzed reactions (Scheme 8).

## 2.1. $\eta^3$ -Allylpalladium Complexes

As early as 1959, Hüttel<sup>[18]</sup> and Hafner<sup>[19]</sup> independently reported the first preparation of the  $\eta^3$ -allylpalladium chloride dimer. While the former protocol relied on what we would now call a C–H allylic activation of simple olefin (Scheme 9, top left equation), the second one was likely due to *in situ* reduction of PdCl<sub>2</sub> to Pd(0), followed by oxidative addition of the alcohol (Scheme 9, bottom equation). In a series of subsequent papers Hüttel showed, *inter alia*, the thermally induced reductive elimination of these dimeric complexes to give the corresponding allylic chloride. However, no synthetic application was reported at that time.


Scheme 9. Pioneering generation of  $\eta^3$ -allylpalladium complexes.

In solution, these complexes are fluxional molecules and can be engaged in several dynamic equilibrations. In the absence of a nucleophile, or if the trapping step is slow enough, the  $\pi$ -allylpalladium complex may undergo the following four different equilibria: a)  $\eta^3 \rightarrow \eta^1$  isomerization, b) ligand association, c) ligand dissociation, d) nucleophilic displacement by a Pd(0)L<sub>n</sub> complex. Activation of these equilibria depends on the reaction conditions and can trigger exchange of the allyl face

complexed by the metal (with or without *syn-anti* switch of the allylic substituents), or the formal rotation of the allyl moiety with respect to the other coordinated ligands (Scheme 10).

 $\eta^3 \rightarrow \eta^1$  Isomerization followed by C-C bond rotation and  $\eta^1 \rightarrow \eta^3$  equilibration leads to a global *synanti* exchange of the substituent pair concerned in the rotation, with simultaneous exchange of the complexed allyl face. This equilibrium is very facile when  $R^1 = R^2 = H$ , and normally displaced toward the *syn* isomer side in the case of monosubstitution (Scheme 11, equation 1).<sup>[20]</sup> On the other hand, apparent allyl rotation involves the formal rotation of the allyl moiety around the imaginary Pd-allyl bond axis (Scheme 11, equation 2).

 $PdX_2$  promoted nucleophilic addition to 1,3-dienes, allenes, or vinyl- and methylenecyclopropanes<sup>[21]</sup> and (d) transmetalation of allyl organometallics such as allylmagnesium halides, allylsilanes and allylstannanes with palladium(II) salts (Scheme 12).<sup>[22]</sup> Within this manuscript, we will exclusively focus on the generation of  $n^3$ -allylpalladium complexes from allyl esters.

As anticipated above, a variety of nucleophiles can undergo nucleophilic attack with  $\eta^3$ -allylpalladium complexes to allow the formation of carbon-carbon bonds and carbon-heteroatom bonds. The most used nucleophiles are those containing nitrogen (amines, amides, sulfonamides), carbon (activated methylene species), sulfur (thiols, sulfonates and sulfinates) and oxygen atoms (carboxylates, alcohols, and water). The nature of the nucleophile has also some importance, since soft nucleophiles attack the  $\pi$ -allyl moiety *anti* with respect to Pd via an outer sphere mechanism, while hard nucleophiles firstly attack the metal center via an inner sphere mechanism and then undergo reductive elimination (Scheme 13).

## 2.2. Pd(0)-catalyzed electrophilic allylations[1]

A few years after the first preparation of  $\eta^3$ -allylpalladium complexes, Tsuji reported that ethyl malonate, acetoacetate as well as an enamine derived from cyclohexanone could react smoothly with dimeric  $\eta^3$ -allylpalladium chloride to afford the corresponding allylated products (Scheme 14).<sup>[23]</sup>

The first catalytic version was independently reported in 1970 in publications or patents by Atkins,<sup>[24]</sup> Hata,<sup>[25]</sup> and Shryne, from Union Carbide, Toray Industries, and Shell Oil,<sup>[26]</sup> respectively, and concerned the Pd(0)-catalyzed allylation of alcohols, amines and active methylenes. Six years later Trost applied this Pd(0)-catalyzed allylation protocol to the synthesis of desethylibogamin alkaloid, and in 1977 he reported the first asymmetric version.<sup>[27]</sup> This redox-neutral Pd(0)-catalyzed protocol, often named Tsuji-Trost reaction or allylic-alkylation (for carbon nucleophiles) or -amination (for nitrogen nucleophiles), gained an enormous success because of its power, mildness, functional group tolerance, and possibility of asymmetric versions (Scheme 15).



## 3. The Chemistry of Sulfones

The extraordinary flexibility of sulfones has been widely exploited in organic synthesis over several decades. Indeed, sulfones are invaluable reagents for organic synthesis<sup>[28]</sup> allowing to carry out a number of synthetically useful transformations. Their relevance and versatility is so high<sup>[28,29]</sup> that B. M. Trost defined them as *chemical chameleons*,<sup>[30a]</sup> and P. L. Fuchs as *pluripotent*.<sup>[30b]</sup> Sulfones can be incorporated in an organic molecule in several ways. Oxidation of a thioether is the most popular method. Furthermore, they can be introduced in a nucleophilic fashion by alkylating sulfinate anions, or, electrophilically, by reacting a carbon nucleophile with a sulfonyl halide or anhydride. As to the modification of this functional group, the C–S bond in a sulfone can be cleaved to generate carbanions or carbon-centered radicals. Furthermore, a sulfone can activate an adjacent deprotonation, and  $\pi$ -bonds conjugated to a sulfone can undergo conjugate additions. Finally, the sulfinate ion can behave as leaving group (Scheme 16).

## 3.1. Sulfonyl $\alpha$ -carbanions

Sulfones can be deprotonated at the  $\alpha$ -position, usually by strong bases such as n-butyllithium, sodium hydride, Grignard reagents, etc. The resulting sulfonyl  $\alpha$ -carbanions can react with halocarbons, introducing alkyl groups at the  $\alpha$ -position; and also ring-opening reaction with epoxides for instance, to form carbon-carbon bonds. Meanwhile, the sulfonyl  $\alpha$ -carbanions can be involved in nucleophilic addition reactions with aldehydes or ketones to form  $\beta$ -hydroxy sulfones, which are generally intermediates for carbon-carbon double bond formation through further removal of the sulfonyl group





(Julia-olefination).  $^{[33]}$   $\alpha$ -carbanions can also add to esters or acyl chlorides to form  $\beta$ -ketosulfones in Claisen-type reactions.  $^{[34]}$   $\alpha$ -Carbanions are also employed in Michael addition reactions with  $\alpha,\beta$ -unsaturated carbonyl compounds.  $^{[35]}$  The sulfonyl  $\alpha$ -carbanions can react with allylic substrates bearing a leaving group in the presence of a palladium catalyst for the formation of carbon-carbon bonds (Scheme 17).

Sulfones are intermediates in synthetically relevant carbon-carbon bond forming reactions, such as the Ramberg–Bäcklund, [36] the Julia–Lythgoe, [37] as well as the modified Julia olefination (Scheme 18). [38]

## 3.2. Allylsulfones

Allylsulfones represent are very useful subclass of sulfones that has proven to be extremely useful as nucleophilic as well as electrophilic building blocks, following ionic or radical mechanisms depending on the reaction conditions adopted. [12,39,40,41,42] Furthermore, the allylsulfone motif can be found in a number of molecules that show diverse biological and pharmacological activities, [43] such as anticancer, antibacterial, antifungal, anti-inflammatory, etc. (Scheme 19).

## 3.3. Synthesis of allylsulfones

Allylsulfones can be obtained in several different ways. A selection of them is described here below.



#### 3.3.1. Oxidation of allyl thioethers

The oxidation of thioethers or sulfoxides is the oldest and most common method used to obtain sulfones. Commonly used oxidants to perform this oxidation are as hydrogen peroxide  $(H_2O_2)$  or peroxyacids. [44] Research in recent years has focused on catalytic systems for milder and more efficient oxidation systems. Here below are a couple of modern examples. In 2015, the Royo's group reported that a titanium silsesquioxane complex, which exhibited stability and reusability, was able to catalyze the oxidation of thioethers to sulfones (Scheme 20) in the presence of hydrogen peroxide as terminal oxidant and methanol as solvent. [45]

In 2016, Zhou *et al.* reported that alkylimidazolium/alkylpyridinium octamolybdates were efficient catalysts for the oxidation of thioethers to sulfones using hydrogen peroxide as terminal oxidant (Scheme 21).<sup>[46]</sup>

#### 3.3.2. <u>Nucleophilic substitution of allylic substrates with sulfinate anions</u>

Another well-known and straightforward way to access allylsulfones involves the coupling between substrates bearing an allylic leaving group (LG) and sulfinate anions (Scheme 22).

In 1985, the Crandall's group reported the preparation of allyl aryl sulfones by reacting sodium aryl sulfinates with an allylic chloride or bromide in the presence of catalytic amounts of *tetra-n*-butylammonium bromide (TBAB) as the phase-transfer catalyst in the ternary medium water, benzene and acetone (Scheme 23).<sup>[47]</sup>

In 1990, Ishii and co-workers described the preparation of allylic sulfones from allylic alcohols via iodination (TMS-CI, NaI) followed by treatment of the resulting allylic iodide by sodium benzenesulfinate (Scheme 24).<sup>[48]</sup>

In 1997, Zhang *et al.* described that treatment allylzinc reagents, in turn formed by the interaction between allyl bromides and Zn dust, react with aryl or alkyl sulfonyl chlorides to give the corresponding allylsulfones. However, only small variations of both substrates were studied. (Scheme 25).<sup>[49]</sup>

In 2009, Tian *et al.* reported that allylsulfones can be prepared by the reaction between benzylic, or allylic, alcohols and various aryl sulfinyl chlorides, in the absence of external catalysts and additives (Scheme 26).<sup>[50]</sup> The mechanism of this reaction is expected to involve the initial formation of the O-protonated allylic sulfonate, which breaks to the corresponding allylic cation and sulfinic acid. Their subsequent S<sub>N</sub>1-type interaction generates the corresponding allylic sulfone and HCl.

In the same year, Reddy *et al.* reported that the reaction between arenesulfonyl cyanides and simple allylic alcohols allowed the generation of the corresponding allylsulfones in good yields (Scheme 27).<sup>[51]</sup>

The authors proposed the following mechanism for this transformation. First, the allylic alcohol adds to the nitrile function of the arenesulfonyl cyanide in the presence of a base. Cleavage of the resulting adduct generates a nucleophilic arenesulfinate and an electrophilic 3-cyanatoprop-1-ene derivative, whose  $S_N2'$  reaction generates the allylsulfone product with expulsion of cyanate anion (Scheme 28).

In 2013, Li and Xu obtained allylsulfones in moderate yields by the coupling between Baylis-Hillman acetates and sulfonylhydrazides, in the presence of *tert*-butyl hydroperoxide (TBHP) and catalytic amounts of tetrabutylammonium iodide (TBAI) in water.<sup>[52]</sup> In this case the mechanism is radical (Scheme 29).

More recently, Xie, Loh and co-workers reported a highly efficient water-promoted dehydrative cross-coupling between sulfinic acids and allylic alcohols–including Morita-Baylis adducts–at room temperature. [43c] The desired allylic sulfones were obtained in high yields with excellent selectivity. DFT calculations showed that the crucial role of water is to create an intermolecular H bonding (Scheme 30).

Scheme 30. Water-promoted reaction between allylic alcohols and sulfinic acids.


Sulfonylhydrazones have also been used as sulfinate precursors in palladium-catalyzed hydrosulfination of allenes. While terminal allenes were providing the corresponding (E)-allylsulfones in the presence of 10 mol% of palladium(II) acetate, dppf as the ligand and 1.0 equiv. of acetic acid (Scheme 31, equation 1),<sup>[53]</sup> allenyl alcohols could generate (Z)-allylic sulfones through coordination of the alcohol function with the palladium catalyst during the carbopalladation step on the allene (Scheme 31, equation 2).<sup>[54]</sup>

In 2019, Cantat *et al.* developed a new palladium-catalyzed synthesis of allyl aryl sulfones through coupling between allylsilanes, aryl halides, and sulfur dioxide, in the presence of tetrabutylammonium difluorotriphenylsilicate (TBAT) as the fluoride source. [55] Experimental and theoretical investigations demonstrated the preformation of allyl sulfinate anion. Accordingly, the authors proposed a mechanism involving the initial oxidative addition of Pd(0) to the aryl halide, followed by ligand exchange of the resulting arylpalladium complex with the preformed sulfinate anion (Scheme 32).




Scheme 32. Allylsulfones via Pd(0)-catalyzed coupling between allylsilanes, SO<sub>2</sub>, and aryl iodides.

## 3.4. General reactivity of allylsulfones

Allylsulfones play a key role in a number of organic reactions, finding applications in various synthetic methods. Being the sulfonyl group a strongly electron-withdrawing group, an allyl sulfone carrying  $\alpha$ -H atoms possesses a relatively high acidity (for example,  $pK_{a(DMSO)}$  PhSO<sub>2</sub>CH<sub>2</sub>CHCH<sub>2</sub> = 22). Therefore, it can be easily deprotonated by a strong base to afford the corresponding delocalized allyl carbanion. At the same time, the allylically located sulfonyl group can also behave as a leaving group, thereby generating an allylic electrophile (Scheme 33).

#### 3.4.1. <u>Carbanions of allylsulfones</u>

As other alkylsufones (see above), allylsulfones can be deprotonated at the  $\alpha$  position by strong bases. However, they are special in that the resulting carbanion is a delocalized allylanion, which can in principle react with an electrophilic reagent at  $C\alpha$  or at  $C\gamma$  (Scheme 34).

In 1978, Manchand *et al.*, at Hoffmann-La Roche, reported a synthesis of vitamin A involving  $\eta^3$ -allylpalladium chemistry. An advanced allylsulfone intermediate was deprotonated with sodium hydride, and then reacted with a stoichiometric amount of a dimeric  $\eta^3$ -allylpalladium chloride, in the presence of triphenylphosphine in DMF. Treatment of the resulting  $\alpha$ -allylation product with sodium ethoxide in EtOH at reflux brought about sulfinate anion elimination, generating the targeted all-*trans* Vitamin A as the major product in an 81% yield (Scheme 35).<sup>[56]</sup>

In 1990, the Jones' group described a straightforward, convergent approach to 1,11-epithiosteroids. The three-component tandem coupling of 2-methylbut-2-enyl-*p*-tolylsulfone with 2-methylcyclopentenone and 2-bromomethylbenzothiophene in the presence of *n*-butyllithium formed an adduct that underwent Lewis acid-activated cyclization to give a precursor of the 1,11-epithiosteroids (Scheme 36).<sup>[57]</sup>

In 2001, an approach to retinol-related anhydro vitamin A was described by the Bhat's group. [58] A 3-sulfolene derivative was deprotonated, and then added to a  $C_{14}$ -aldehyde derived from  $\beta$ -cyclocitral. The resulting  $\alpha$ -adduct was desulfonylated and dehydrated by treatment with POCl<sub>3</sub> and pyridine, to generate anhydro vitamin A (Scheme 37).

# 3.4.2. Allylsulfones as allylic electrophiles

The sulfonyl group of allylsulfones can behave as a leaving group, too. Such a desulfinative reactivity is typically obtained in Pd-catalyzed substitution of allylsulfones using soft carbanions<sup>[59]</sup> or hydrides<sup>[60]</sup> as nucleophiles (Scheme 38).

Recently, visible light photocatalysis has proven effective at catalytically generating a variety of radicals under near ambient conditions, often resulting in useful reactions that are remarkably tolerant of functional groups. In 2019, the Weaver's group developed a method based on a visible light photoredox-mediated prenylation of 2-bromo-azoles, aryl iodides,  $\alpha$ -bromo-carbonyls and anilines with allylphenylsulfones.<sup>[61]</sup> A photocatalytic system consisting in 0.3 mol% of an Ir-photocatalyst and a combination of formic acid and DIPEA and blue LEDs has been developed for 2-bromoazole, aryl iodide and  $\alpha$ -carbonyl substrates (Scheme 39, equation 1). Another photocatalytic system with 0.3 mol% of the organic photocatalyst Eosin Y and *tert*-butylnitrite was developed for aniline substrates (Scheme 39, equation 2). The latter are *in situ* transformed into diazonium salts by oxidation with the nitrite

oxidant which is transformed into the aryl radical by abstraction of N<sub>2</sub>.

# 4. Palladium and Sulfones

# 4.1. Allylsulfones via Pd(0)-catalyzed sulfinate anions allylation

A commonly used method for the regio- and stereoselective preparation of allylic sulfones consists in a Pd(0)-catalyzed coupling of allylic electrophiles (allylic carboxylates, carbonates, alcohols or nitro compounds) with sulfinate salts or sulfinic acids. Reactivities and regioselectivities can differ significantly depending on the structure of the allyl electrophile and the catalyst system (Scheme 40). [62]



In 1981, Kotake *et al.* reported that tetrakis(triphenylphosphine) palladium(0) (Pd(PPh<sub>3</sub>)<sub>4</sub>) was able to catalyze the coupling between sodium p-toluenesulfinate and allylic acetates in THF and methanol to give the corresponding allylic sulfones. The role of methanol was to solubilize the sulfinate anion. In particular, when the reaction mixture was stirred for a short time, branched allylsulfones were the major products. On the other hand, only the linear allylsulfones were obtained after stirring overnight (Scheme 41).

The above results clearly indicate that reaction is reversible, the branched allylsulfone being the kinetic product, while the linear is the thermodynamic one. The kinetic preference for the more substituted allyl terminus is undoubtedly due to the fact that the internal allyl terminus stabilizes the positive charge better than the external one (Scheme 42).

The general mechanism involves first the formation of a  $\eta^3$ -allylpalladium intermediate **A** by oxidative addition (Scheme 43). Nucleophilic attack of the sulfinate on the  $\pi$ -allylpalladium intermediate generates then an  $\eta^2$ -allylsulfone palladium intermediate **B** which decoordinates to regenerate [Pd(0)] active species and liberates the desired allylsulfone. As mentioned above, the reaction is expected to be reversible. Therefore, the interaction between the allylsulfone and [Pd(0)] can regenerate back the corresponding  $\eta^3$ -allylpalladium intermediate **A**.

Further studies on the sulfonylation of cinnamyl acetate, chosen as a model reaction, were addressed considering greener reaction conditions, different Pd-sources [Pd(PPh<sub>3</sub>)<sub>4</sub>], solvents [DMAc, H<sub>2</sub>O, H<sub>2</sub>O/MeOH, ionic liquids], ligands [PPh<sub>3</sub>, TPPTS], allylic leaving groups [OCO<sub>2</sub>Me]<sup>[64,65]</sup> reaction heating [microwave irradiation] (Scheme 44). In all the cases studied, the reaction turned out to be almost quantitative. A notable point is represented by the poor solubility of the sulfinate salt, which is soluble only in very polar or protic solvents. <sup>[66,67,68]</sup>

In 2019, Chen and co-workers developed an efficient regioselective palladium-catalyzed coupling between variously substituted sulfinates and a vinyl ethylene carbonate. [69] The coupling afforded the corresponding (*Z*)-sulfonyl butenols in good yields (Scheme 45).

The mechanism proposed by the authors involves the initial  $\eta^2$ -coordination of the alkene of the substrate to Pd(0) **A**, to afford intermediate **B**. Following oxidative cleavage generates the zwitterionic  $\pi$ -allylpalladium intermediate **C**. After **C**-to-**D** *anti/syn* equilibration through a  $\pi$ - $\sigma$ - $\pi$  interconversion, oxapalladacyclohexene **E** is formed with carbon dioxide extrusion. Following sulfinate anion attack generates the allylsulfone **F** and regenerates the catalytic active species **A**. Intermediate **F** undergoes a rapid 1,5-proton shift to form carbanionic intermediate **G**, before being quenched by a protic source (Scheme 46).

In 1986, Tamura reported that treatment of allylic nitro compounds with sodium benzenesulfinate in the presence of Pd(PPh<sub>3</sub>)<sub>4</sub> catalyst resulted in the formation of allylic sulfones with predominance of

kinetically-controlled products.<sup>[70]</sup> When the R group was an electron-donating group such as alkyl groups, the substitution reaction took place at the most hindered site to give the branched allylic sulfones regioselectively. On the contrary, when the R group was an electron-withdrawing group, the reverse regioselectivity was observed and linear allylic sulfones were obtained (Scheme 47).


In 1986, the Chandrasekhar's group reported the direct Pd(0)-catalyzed reaction between sulfinates and allylic alcohols (Scheme 48). The coupling, which needs the presence of triethylborane, afforded the corresponding linear allyl sulfones in good yields.<sup>[71]</sup>

The proposed mechanism involves activation the allylic alcohol by the Lewis acid triethylborane (Scheme 49).

In 2020, Loh and Xie developed a  $Pd/Ca(NTf_2)_2$  co-catalyzed direct cross-coupling between sulfinic acids and allylic alcohols, which allowed to obtain a vast range of allylic sulfones (Scheme 50).<sup>[72]</sup>

The proposed mechanism involves an oxidative addition step through a 6-membered cyclic mechanism featuring a chair-like transition state with double H-bonding. According to the authors, the calcium salt might facilitate the generation of intermediate  $\bf A$ , which undergoes oxidative addition to afford the  $\pi$ -allylpalladium intermediate  $\bf B$  (Scheme 51).

Allylamines are competent precursors of  $\pi$ -allylpalladium complexes, too. In 2012, the Tian's group developed the first Pd-catalyzed direct substitution of primary allylic amines with sulfinate salts to afford the corresponding allylsulfones with (*E*) stereochemistry (Scheme 52).<sup>[73]</sup> As to the mechanism, the amine function is expected to coordinate to boric acid, which triggers the oxidative addition step.

When  $\alpha$ -stereogenic enantiopure allylic amines were used as substrates, the sulfonylation took place with excellent stereoretention. In this case, the ligand dppb was replaced by rac-BINOL as ligand. The stereoretention observed in this reaction when using BINOL as ligand is expected to be the result of two subsequent stereoinversions (Scheme 53).



# 4.2. Pd(0)-catalyzed allylation and elimination of allyl sulfones

In the context of the synthesis of a pre-vitamin A model, in 1980, Trost et~al. reported a Pd(0)-catalyzed coupling between the carbanion of an allyl sulfone and an allyl acetate, which gave the corresponding  $\alpha$ -alkylated allylsulfone in an 85% yield. Heating the coupled product with DBU in DMSO failed to produce the desired trienone, which was instead successfully achieved repeating the reaction with the additional presence of the Pd(0) catalyst. The authors speculated that the high acidity of the H  $\alpha$  to the sulfone was likely the reason of the failure of the elimination in the sole presence of DBU. On the other hand, the presence of the Pd(0) catalyst solved the issue. Carrying out the same two-step sequence in a one-pot process by using DMSO as solvent, gave directly the trienone in 77% yield (Scheme 54).

Allylic acetates are the most commonly used precursors of  $\pi$ -allylpalladium intermediates. In this reaction, generally a stoichiometric amount of base such as sodium hydride is used for carbanion generation to carry out the reaction smoothly. In 1982, Tsuji and co-workers described that the reaction of allylsulfones with allyl carbonates was achieved by Pd(0)-catalysis without addition of external bases. For instance, reaction between allyl-p-tolylsulfone and diallylcarbonate afforded monoallylated allylsulfone in 57% yield together with diallylated allylsulfone byproduct with 12% yield (Scheme 55). [74]

Three years later, Tsuji and Takahashi found out that  $Pd_2(dba)_3$  in combination with dppe was able to catalyze the allylation of geranyl-p-tolylsulfone with an allylcarbonate under neutral conditions. <sup>[75]</sup> Then, a desulfonylation of allylsulfone with a Na-Hg amalgam gave farnesyl acetone in 49% yield as a 5:1 mixture of E/Z isomers (Scheme 56).

The possibility of carrying out base-free Pd-catalyzed coupling can be explained as follows. Oxidative addition of the Pd(0)-phosphine complex to allylic carbonates generates a  $\eta^3$ -allylpalladium carbonate **A**, which suffers decarboxylation to the corresponding cationic  $\eta^3$ -allylpalladium alkoxide **B**. The alkoxide counter-anion deprotonates the allylsulfone bringing about a counterion exchange of the  $\eta^3$ -allylpalladium complex. Final reductive elimination of the resulting diallylpalladium complex **C** affords the allylated product and regenerates the Pd(0) catalyst (Scheme 57). In 1998, Poli and coworkers showed that even the common acetate leaving group can perform as endogenous deprotonation anion, provided that the pronucleophile is acid enough.<sup>[76]</sup>

# 4.3. Palladium(0)-catalyzed reductive desulfonylation of allyl sulfones.

In 1982, Hutchins and Learn described a Pd(0)-catalyzed allylic reduction using the super hydride LiBHEt<sub>3</sub> as the reducing agent (Scheme 58). With this method, which is expected to involve hydride addition to a transient  $\eta^3$ -allylpalladium intermediate, primary allylic sulfones could be transformed into the corresponding 2-alkenes with good regio- and stereoselectivity.<sup>[77]</sup>

# 5. Palladium-catalyzed domino reactions Involving $\eta^3$ -Allylpalladium Complexes.

The construction of complex molecular structures in a facile and efficient method remains an overarching goal of the chemical sciences. Cascade (or domino) reactions allow improved atom and step economy in organic synthesis and therefore represent significant progress toward this goal. [78] Transition metal-mediated domino reactions play an important role in organic chemistry, because they allow the formation of complex molecular structures in a single synthetic operation and usually the reaction is performed under mild conditions.


According to the commonly accepted definition by Tietze<sup>[79]</sup>: "a domino reaction is a process involving two or more bond-forming transformations which take place under the same reaction conditions without additional reagents and catalysts, and in which the subsequent reactions result as a consequence of the functionality formed in the previous step." However, when the above domino process is transition metal-catalyzed, three conceptually distinct classes may be further discriminated. The process may either involve a single catalytic cycle driven by a single catalytic system ("M") and featuring several distinct transition metal-catalyzed transformations, or be made up of sequential, yet mechanistically independent, catalytic cycles, each one involving a simple catalytic transformation. According to the above consideration, our team proposed to distinguish and classify these two transition-metal-catalyzed transformations as pure-domino (TM-DOM) and pseudo-domino (TM-DOM)



PDOM) processes, respectively. Furthermore, the latter type of process may either involve a single "multipurpose" catalytic system ("M") sharing the sequential cycles (type I), or call for reciprocally compatible catalytic systems of different nature ("M1, M2,..") (type II) (Scheme 59). [80]

Our group has a longstanding experience in Pd-catalyzed domino reactions.<sup>[81]</sup> Two examples from our team, chosen among several, are presented below. In the context of TM-PDOM sequences, in 2002 we developed a doubly intramolecular Pd-catalyzed allylation / Heck coupling leading to a tetracyclic coupling product.<sup>[82]</sup> Further transformations of the coupled product allowed to attain the desired picropodophyllin aza-analog (Scheme 60).

In a more recent study, our group developed a Pd-catalyzed triple domino sequence consisting in an intermolecular Tsuji-Trost allylation / intramolecular nitrogen 1,4-addition sequence / intramolecular keto  $\alpha$ -arylation (Scheme 61). This sequence allowed the generation of two new cycles



and three new bonds in the same synthetic operation.<sup>[83]</sup>

A plausible mechanism for this annulation is presented in the next scheme (Scheme 62). The sequence starts with an oxidative addition of the bis-electrophile onto the Pd(0) complex to generate the corresponding transient  $\eta^3$ -allyl-complex **B** through the  $\eta^2$ -alkene complex **A** (*steps*  $\underline{a}$  *and*  $\underline{b}$ ). The amidinium-enolate of the bis-nucleophile formed in the meantime (step  $\underline{c}$ ), enters the catalytic cycle through C-allylation. Then, a new deprotonation by DBU and an oxidative addition of its aryl halide to Pd(0) generates amidate **C** (step  $\underline{d}$ ). Pd(0) decoordination (step  $\underline{e}$ ), to form **D**, opens the way to the intramolecular aza-conjugate addition to afford bicyclic enolate **E** (step  $\underline{f}$ ). Subsequent enolate-palladation (step  $\underline{g}$ ) followed by reductive elimination generates the final tricyclic product and the Pd(0) complex.

# Chapter 2. Approach toward the synthesis of conjugated trienes by a Pd-catalyzed domino process involving allyl sulfones.

# 1. Introduction

Conjugated polyenes are chemical units of great importance in organic chemistry since they can be found in a huge number of natural products (Scheme 63). [84] This family of molecules can be divided into two main groups. The former group is represented by the polyene antibiotics, whose biological properties depend by their interaction with non-polar molecules such as sterols or liposomes. [85] The latter group is constituted by pigments, whose color is due the absorption of specific wavelengths of the solar light thanks to the delocalization of the conjugated  $\pi$ -electrons.

Scheme 63. Polyene-containing natural products.


Common methods for the synthesis of polyenes include olefin-generating reactions, such as the Wittig, Horner–Wadsworth–Emmons and Julia olefinations, and the metal-catalyzed crossing-coupling

reactions, most notably, the Suzuki-Miyaura reaction, or the Stille reaction. [14a,86]

As mentioned in Chapter 1, palladium-catalyzed domino sequences represent ideal approaches to the construction of complex molecules. In this context, we envisaged a strategy toward conjugated trienes that involves a sequence of three reactions that could be run in cascade. This strategy involves an initial Pd(0)-catalyzed allylation of a sulfinate anion to produce an allyl sulfone, followed by a second Pd(0)-catalyzed allylation of the anion of the allyl sulfone to produce a 3-sulfonyl-1,5-diene. A final sulfinate elimination is expected to generate the desired conjugated 1,3,5-triene (Scheme 64). The main challenge here is to combine all of these steps in a single process without the palladium catalyst to be deactivated in the course of the reaction. Another challenge consists in the selective addition of only one allyl reagent during step 2.

Our objective was to combine these reactions together and verify if a domino process could allow us an easy access to trienic moieties. In the following paragraphs, step 1 will concern the palladium-catalyzed allylic sulfonylation of allyl acetates or carbonates, step 2 will designate the palladium-catalyzed  $\alpha$ -allylation of allyl sulfones and step 3 will apply to the elimination reaction to form the triene. As seen in Chapter 1, taken separately, each of these three steps is a known transformation. So, the challenge of this project resides in the ability to put these transformations in an unprecedented domino sequence. It has to be noted that the optimization of disjointed transformations into a single domino sequence is far from being a simple task and may require a delicate and careful fine-tuning of several reaction parameters.

# 2. Synthesis of allyl acetates and allyl carbonates

The first task consisted into the preparation of various allyl acetates and allyl carbonates as the allylating agents for steps 1 and 2. Accordingly, cinnamyl alcohol was acetylated by treatment with acetic anhydride and pyridine in dichloromethane, providing cinnamyl acetate **1a** in 83% isolated yield (Scheme 65, equation 1).<sup>[87]</sup> Similarly, treatment of cinnamyl alcohol or geraniol with methyl chloroformate and pyridine in dichloromethane, gave cinnamyl methyl carbonate **2a** and geranyl methyl carbonate **2b** in 88% and 68% yield, respectively (Scheme 65, equations 2 and 3).<sup>[88]</sup>

When the aldehyde, instead of the allylic alcohol, was commercially available, the substrate was converted into the corresponding  $\alpha,\beta$ -unsaturated methyl ester by a HWE olefination with trimethyl phosphonoacetate, [89] and the resulting ester was reduced to the corresponding allylic alcohol with

DIBAL-H.<sup>[90,91]</sup> Finally, the alcohol was converted into the corresponding allyl methyl carbonate under standard conditions.<sup>[88]</sup> Using this strategy, 3,4-dimethoxybenzaldehyde and 1-naphthyl aldehyde could be first converted into the corresponding  $\alpha$ , $\beta$ -unsaturated esters **3c** and **3d** in a quantitative yield in each case (Scheme 66). Then, reduction of the ester function with an excess of DIBAL-H lead to allylic alcohols **4c** and **4d** with 71% and 82% yield respectively. Conversion of the alcohols into the methyl carbonates was achieved affording allyl carbonates **2c** and **2d** with 72% and 85% yield, respectively.

Following that, 3-methylbut-2-enal was reduced in the presence of sodium borohydride according to reported conditions leading to 3-methylbut-2-enol **4e** in 39% yield. Likewise, cyclohex-2-en-1-one was reduced to cyclohex-2-en-1-ol **4f** using Luche conditions providing in 96% yield. Both alcohols were then converted into the corresponding methyl carbonates **2e** and **2f** in 52% and 50% yield, respectively (Scheme 67). See

# 3. First studies on the compatibility of the reaction conditions for the domino process.

In order to accomplish a domino process, we first needed to check if the reaction conditions used for the first step are compatible with those used for the second step.

# 3.1. Studies on cinnamyl acetate 1a.

## 3.1.1. <u>Studies on step 1: Sulfonylation of cinnamyl acetate 1a.</u>

The next task was finding out the most suitable conditions for the first step of the planned domino process, *i.e.* the sulfonylation of cinnamyl acetate **1a**. Accordingly, following the protocol of Kotake, <sup>[63]</sup> treatment of cinnamyl acetate **1a** and sodium benzenesulfinate **5a** in the presence of 5 mol% of Pd(PPh<sub>3</sub>)<sub>4</sub> in THF/MeOH, at rt, gave the desired cinnamyl sulfone **6a** in 79% (Table 1, entry 1). Since Pd(II) complexes can react with methanol generating Pd(0) and formaldehyde<sup>[93]</sup> and because we wished to use the same catalyst for steps 1 and 2 of the domino sequence, other solvents under otherwise similar conditions were screened. When switching to DMF or THF as the sole solvent, the desired product **6a** was obtained in 70% and 86% yield, respectively (Table 1, entries 2-3). In this case, the reaction mixture had to be heated to solubilize completely the sulfinate salt. This resulted in longer

reaction times when using THF. Other reported conditions favoring the solubilization of the sulfinate were tested. Treatment of cinnamyl acetate **1a** and sodium benzenesulfinate **5a** with 10% Pd/C and triphenylphosphine in water at 70°C for 18 h resulted in the formation of the desired product **6a** in 87% yield (Table 1, entry 4).<sup>[67]</sup> We then selected conditions that were close to those described for the second step of the domino sequence and checked whether they were compatible for the first step.<sup>[74,75]</sup> The use of a catalytic system consisting of 5 mol% of Pd<sub>2</sub>(dba)<sub>3</sub> and 20 mol% of dppe, working in THF at 65°C for 2.5 h, allowed to obtain the desired cinnamyl sulfone **6a** in an excellent 93% yield (Table 1, entry 5). These conditions have been considered to be the optimal not only because of the high yield of the product, but also because they are close to those reported for the second step of the domino process.

### 3.1.2. Studies on step 2: Pd-catalyzed $\alpha$ -allylation of cinnamyl sulfone **6a**.

We then passed to study step 2, the Pd-catalyzed  $\alpha$ -allylation of cinnamyl sulfone **6a**, testing first the reaction conditions reported by Trost. [12a] Thus, treating cinnamyl sulfone **6a** with 1.1 equivalents

of sodium hydride (NaH), to deprotonate the allylic position, and then with 1.1 equivalents of allyl acetate **1b**, in the presence of catalytic amounts of Pd(PPh<sub>3</sub>), in THF at 65°C for 30 h, provided the desired monoallylated product **7a** in 38% yield together with 7% yield of byproduct **8a**, resulting from the double  $\alpha$ -allylation of cinnamyl sulfone. Under these conditions, the conversion of the substrate was only of 61% (Table 2, entry 1). Performing the reaction in the presence of methanol as a co-solvent (like in step 1), brought about substrate decomposition (Table 2, entry 2). When potassium *tert*-butoxide (*t*-BuOK) was used as the base, the conversion was still not complete, giving and after 27 h the monoallylated product **7a** in 36% yield and the diallylated byproduct **8a** in 12% yield (Table 2, entry 3), and generating palladium black. Introduction of triphenylphosphine (PPh<sub>3</sub>), in the hope of stabilizing the palladium catalyst, again gave unsatisfactory results (Table 2, entry 4). Using the best conditions for step 1, and in the presence of NaH as the base, gave only decomposition (Table 2, entry 5). The use of 10 mol% of palladium (II) acetate (Pd(OAc)<sub>2</sub>) and dppe (20 mol%) as the catalyst system also failed to improve the result, although gave only the monoallylated product (Table 2, entry 6).

The above results suggest that the second allylation tend to compete with the first allylation, thus partially subtracting the allylating agent to the starting allyl sulfone. Given the poor results obtained in terms of conversion and yield of **7a**, and on the basis of the work by Tsuji *et al.*,<sup>[74]</sup> we considered the use of allyl carbonates as allylating agents. As described in Chapter **1**, they are much more reactive than allyl acetates in Pd-catalyzed allylations, and need no external base.

# 3.2. Further studies on step 2: on the use of allyl methyl carbonate **2g** in the allylation of cinnamyl sulfone **6a**.

When step 2 was carried out by treating cinnamyl phenyl sulfone **6a** with 2.0 equivalents of allyl methyl carbonate **2g** in the presence of 5 mol% of Pd<sub>2</sub>dba<sub>3</sub> and 20 mol% of dppe in THF at 65°C for 4 h, the diallylated byproduct **8a** was obtained in 60% yield together with the monoallylated product **7a** in 33% yield. In another experiment carried out at higher dilution (0.1 M), the  $\alpha$ -monoallylated sulfone **7a** was obtained in 64% yield, while the  $\alpha$ -diallylated sulfone **8a** was formed in only 12% yield (Scheme 68). These reaction conditions were selected to test step 2, which appear very close to the best conditions previously selected for step 1.

# 4. Combination of steps 1 and 2 in a domino process.

With the aim of finding reaction conditions compatible with the sequential *in situ* achievement of step 1 and 2, we started to test the combination of the two steps. Accordingly, after treatment of

cinnamyl acetate **1a** and sodium benzenesulfinate **5a** with Pd<sub>2</sub>dba<sub>3</sub> (5 mol%) and dppe (20 mol%) in THF (0.25 M) at 65°C for 2.5h, the resulting mixture (formation of sulfone **6a** verified by TLC), was treated with 2.0 equivalents of allyl methyl carbonate **2g** at the same temperature. After 49h stirring at this 65°C, this protocol gave the desired monoallylated product **7a** in 7% yield, accompanied by the remaining cinnamyl sulfone **6a** in 60% (Scheme 69).

Scheme 69. First trial on the combination of steps 1 and 2 in the domino sequence.

In the above experiment, precipitation of Pd-black was observed during step 1. Therefore, we surmised that step 2 only barely proceed due to the extensive inactivation of the palladium catalyst. Furthermore, increasing the loading of Pd<sub>2</sub>(dba)<sub>3</sub> to 10 mol%, gave only decomposition products (Table 3, entry 2). Accordingly, we envisaged to look for catalytic systems that remain active at the end of step 2. Adding new Pd<sub>2</sub>dba<sub>3</sub> (5 mol%) and dppe (20 mol%) after first step was completed, the domino reaction produced the target product **7a** in 58% yield, along with the diallylated byproduct **8a** in 23% yield (Table 3, entry 3). Use of the diphosphines dppp or dppf, instead of dppe, in the reaction did not bring any improvement, too (Table 3, entries 4-5). On the other hand, the use of the large bite-angle ligand XantPhos, gave **7a** and **8a** in 43% and 17% yield, respectively (Table 3, entry 6), without having to add a second batch of catalyst. Gladily, when cinnamylmethylcarbonate **2a** was used as starting material under the same reaction conditions as in entry **1**, we obtained the desired monoallylated product **7a** in 50% yield and recovered cinnamylphenylsulfone **6a** in 17% yield (Table 3, entry 7). In this case, fortunately, no diallylated byproduct **8a** was generated.

At this stage, we had two sets of reaction conditions for the preparation of the desired monoallylated sulfone **7a**: a) the double addition of the catalytic system [Pd<sub>2</sub>dba<sub>3</sub> (5 mol%) and dppe (20 mol%)] starting from cinnamyl acetate **1a**; b) the use of cinnamyl methyl carbonate **2b**. Next, we turned our attention to the study on the elimination step (step 3 of the domino sequence).

# 5. Studies on step 3: Synthesis of conjugated trienes by elimination of the sulfone moiety.

As seen in chapter 1, the elimination reaction can take place in the presence of a base, with or without the presence of an additional palladium-catalyst. <sup>[94]</sup> In the event, treatment of the monoallylated allyl sulfone **7a** with potassium *tert*-butoxide (*t*-BuOK) or sodium hydride (NaH) in THF at 65°C led to decomposition of the reaction mixture (Table 4, entries 1-2). On the other hand, the use of DBU left the substrate untouched (Table 4, entries 3), which is not surprising given the work reported by Trost. <sup>[12a]</sup> In view of these negative results, we decided to screen conditions involving palladium catalysis. However, treatment of **7a** with potassium *tert*-butoxide (*t*-BuOK) in the presence of Pd<sub>2</sub>(dba)<sub>3</sub> (5 mol%) and dppe (20 mol%), in THF at 65°C or rt, brought about a rapid decomposition (Table 4, entries 4 and 5), and the same decomposition happened replacing *t*-BuOK with NaH or DBU (Table 4, entries 6 and 7). Finally, following a protocol reported by Koo, <sup>[95]</sup> treatment of **7a** with KOH at 80 °C for 4 h in toluene and in the presence of 20 equivalents each of *t*-BuOH/EtOH, gave apparently the desired elimination product, as detected by signals compatible with a 1,3,5-triene on the crude <sup>1</sup>H NMR spectrum. However, due to the low polarity of this product, its chromatographic separation failed. At this point, we should note that no palladium catalyst was required with these conditions.

# 6. Studies on the domino reaction from allyl carbonate 2c.

Considering the issues met above, we decided to start a new study of domino sequence, this time using ( $\it E$ )-3-(3,4-dimethoxycinnamyl) methyl carbonate  $\it 2c$  as starting allylic electrophile instead of the very apolar cinnamyl methyl carbonate  $\it 2a$ . This new substrate was prepared under standard conditions from the commercially available ( $\it E$ )-3,4-dimethoxybenzaldehyde. With the new substrate  $\it 2c$  in hand, we first checked if the reaction conditions optimized for the two steps of the domino sequence were still compatible. Accordingly, reacting an equimolar mixture of the carbonate  $\it 2c$  and sodium benzenesulfinate  $\it 5a$  in the presence of  $\it Pd_2dba_3$  (5 mol%) and dppe (20 mol%) in THF at 65°C allowed to isolate 3,4-dimethoxycinnamylsulfone  $\it 6b$  in 95% yield (Scheme 70). We used precisely 1.0 equivalent of sodium benzenesulfinate  $\it 5a$  to eliminate any potential impact of an excess of sodium sulfinate on the second reaction. Then, reacting 3,4-dimethoxycinnamylsulfone  $\it 6b$  with two equivalents of allyl carbonate  $\it 2c$  in the presence of the same catalytic system as that of step 1, and under the same reaction conditions as those of step 1, gave the desired monoallylated product  $\it 7b$  in 62% yield, without formation of the diallylated byproduct  $\it 8b$  (Scheme 70).

# 6.1. Combination of steps 1 and 2 of the domino process and elimination studies

Keeping the same reaction conditions as in the previous experiments, we started to test the domino process. Hence, in a first experiment, after having reacted the 3,4-dimethoxycinnamyl carbonate **2c** with the sulfinate **5a** at 65°C for 2.5 h according to step **1**, the resulting reaction mixture containing the newly generated **6b** was directly treated with allyl carbonate **2g** and stirring at 65°C was continued for **18h**. However, work up of this experiment gave only the intermediate of the domino process **3**,4-dimethoxycinnamylsulfone **6b** in 54% yield, while no target product **7b** was detected (Table **5**, entry **1**). In a second experiment, the same reaction as above was repeated, except for the addition of sodium methoxide (NaOMe) (1.2 equiv.). However, in this case as well, no desired product **7b** was observed, and **6b** was still produced with 55% yield after 22 hours (Table **5**, entry **2**). Further experiments using sodium acetate (NaOAc) or sodium hydride (NaH) as bases generated the desired product **7b** in 28% and 42% yield, respectively, together with the intermediate allyl sulfone **6b** in 34% and 10% yield (Table **5**, entries **3**-4). Other inorganic bases such as cesium carbonate (Cs<sub>2</sub>CO<sub>3</sub>) and potassium *tert*-butoxide (*t*-BuOK) gave the desired product **7b** in 25% and 40% yield, together with the diallylated byproduct **8b** in 30% and 12% yield, respectively (Table **5**, entries **5**-6). Use of the organic base DBU resulted only in degradation products (Table **5**, entry **7**). Finally, using a combination of *N*,*O*-

bis(trimethylsilyl)acetamide (BSA) with 10 mol% of potassium acetate (AcOK)<sup>[96]</sup> led to the exclusive formation of the diallylated product **8b** in 48% isolated yield (Table 5, entry 8). In summary, the results obtained from the above study suggest that the kinetics of the  $\alpha$ -allylation of **7b** to **8b** is likely of the same order of magnitude as that of **6b** to **7b**, which renders very hard to stop the allylation to **7b**. However, although we were unable to obtain the desired 1,5-diene **7b** in a synthetically useful yield using a one-pot procedure, we did find a protocol that generated triene **8b**, resulting from a two successive  $\alpha$ -allylations of **7b**, in an acceptable yield.

As the monoallylated product **7b** was not obtained in a synthetically acceptable yield via a one-pot process, we decided to prepare the new targeted 3-sulfonyl hexa-1,5-diene via a stepwise protocol, to test it in the elimination reaction (step 3). Accordingly, treatment of 3,4-dimethoxy cinnamyl acetate


**1c** with sodium benzenesulfinate **5a** under the previously set up Pd-catalyzed conditions yielded the allyl sulfone **6b** in a 71% yield (Scheme 71). It has to be noted that the same reaction using 3,4-dimethoxycinnamyl carbonate gave 95% yield. The latter was subsequently reacted with cinnamyl carbonate **2a** under Pd(0)-catalysis to produce monoallylated product **7c** with a 69% yield. Treatment of **7c** with KOH at 80 °C for 4 h in toluene, in the presence of 20 equivalents of *t*-BuOH/EtOH, allowed to isolate the desired 1,3,5-triene **9b** in only 5% yield. The exact configuration of the product **9b** could not be determined by NMR analyses (Scheme 71).

# 7. Domino Pd(0)-catalyzed sulfonylation/ $\alpha$ -diallylation

In view of the results obtained in the previous study, we decided to focus on the development of a method to generate 4-sulfonyl 4-vinylhepta-1,6-dienes ( $\alpha$ -diallylated allyl sulfones) starting from a sulfinate salt and allylating agents via three sequential one-pot Pd(0)-catalyzed allylations (Scheme 72). The importance of this hitherto unknown sequence lies in its potential to have access to densely functionalized polyunsaturated synthons in a single synthetic operation. Given the presence of three unsaturations and a sulfonyl group at specific positions, and in view of the rich chemistry of these functional groups, these synthons may be ideal starting building blocks to important targets, such as

cyclopentenes via ring closure metathesis, for example. Henceforth, in the following paragraphs, step 1 will concern the Pd(0)-catalyzed coupling between a sulfinate anion and an allyl acetate (or carbonate) to give an allyl sulfone, step 2 will designate the Pd(0)-catalyzed  $\alpha$ -allylation of an allyl sulfone to give a 3-sulfonyl hexa-1,5-diene ( $\alpha$ -allylated sulfone), and step 3 will apply to the Pd(0)-catalyzed allylation of the  $\alpha$ -allylated sulfone to give a 4-sulfonyl 4-vinylhepta-1,6-diene ( $\alpha$ -diallylated sulfone) (Scheme 72).



Scheme 72. Triple domino Pd(0)-catalyzed allylation reaction for the synthesis of  $\alpha$ -diallylated allyl sulfones.

# 7.1. Optimization of the triple Pd(0)-catalyzed domino sequence

### 7.1.1. <u>Screening of palladium catalysts</u>

We started this study by screening several Pd(0) complexes and Pd(II) salts as potential catalyst or pre-catalysts. As described above, the use of the system [Pd<sub>2</sub>dba<sub>3</sub> (5mol %)]; dppe (20 mol%); BSA (1.2 equiv.); AcOK (10 mol%)] allowed to obtain the diallylated allylsulfone **8b** in 52% NMR yield (Table 6, entry 1). In the presence of Pd<sub>2</sub>dba<sub>3</sub>·CHCl<sub>3</sub>, Pd(PPh<sub>3</sub>)<sub>4</sub> or Pd(dba)<sub>2</sub>, the desired product **8b** was obtained in lower yields (Table 6, entries 2-4). When the reaction was carried out with Pd(II) pre-catalysts such as palladium(II) acetate or [Pd( $\eta^3$ -C<sub>3</sub>H<sub>5</sub>)Cl]<sub>2</sub>, the yields of diallylated product **8b** did not improve (Table 6, entries 5 and 6). In the end, Pd<sub>2</sub>dba<sub>3</sub> proved to be the best palladium catalyst for this domino reaction.

### 7.1.2. Screening of ligands

Following the catalyst screening, the impact of different ligands on the efficiency of the triple Pd(0)-catalyzed domino sequence was evaluated. When dppe was used, the desired diallylated product **8b** was obtained in 52% NMR yield (Table 7, entry 1). When using monophosphine ligands such as triphenylphosphine or XPhos, no improvement was achieved (entries 2 and 3). Other diphosphine ligands like dppf, dppb or dppp proved to be more efficient than monophosphine ligands but less than dppe (Table 7, entries 4-6), the desired diallylated product **8b** being obtained in 34-40% yields with monoallylated product **7b** generated in lower yields. However, using diphosphine ligands with a large bite angle such as DPEPhos or XantPhos proved to be less efficient in promoting this domino reaction (Table 7, entries 7-8). With DPEPhos, mono- and diallylated products **7b** and **8b** were respectively obtained with 15% and 19% yield. With XantPhos, the diallylated product **8b** was generated in 8% yield. Finally, these experiments showed that dppe is the best ligand for this domino reaction.

#### 7.1.3. Screening of the nature of the second allylic precursor

After the catalyst and ligand screening, a variety of allyl precursors for the second step were investigated. When 3,4-dimethoxycinnamylcarbonate **2c**, sodium benzenesulfinate **5a** and allyl acetate **1b** reacted together under a catalyst system composed of Pd<sub>2</sub>(dba)<sub>3</sub> and dppe in THF at 65 °C, the monoallylated product **7b** and diallylated product **8b** were obtained with 32% and 31% yield respectively (Table 8, entry 1). Diallyl carbonate **2h** did not perform much better in this domino sequence (Table 8, entry 2). Moreover, the use of allyl *N*,*N*-diisopropyl carbamate **2i** or allyl *tert*-butyl carbonate **2j** as alternative allyl reagents did not lead to significant improvements in product yield (Table 8, entries 3 and 4). Additionally, increasing the amount of allyl methyl carbonate **2g** to 2.5 equivalents failed to give a more favorable outcome (Table 8, entry 5) compared to the best conditions found (Table 8, entry 6).

### 7.1.4. Influence of the solvent and temperature on the reaction outcome

Further experimentation revealed that the reactivity of this domino reaction varies with different solvents and temperature. Using highly polar aprotic solvents such as DMSO or DMF only gave 3,4-dimethoxycinnamylsulfone **6b** in 46% and 26% yield respectively, without the desired diallylated product **8b** (Table 9, entries 1 and 2). No improvement was achieved in the presence of 1,4-dioxane (Table 9, entry 3). When THF was used at lower temperatures such as room temperature or 50°C, the product **8b** was obtained with a lower yield (Table 9, entry 5 and 6). Even raising the temperature to 100°C did not result in a higher yield of the desired product **8b** (Table 9, entry 7).

All in all, the best conditions we keep for this transformation are the use of a catalyst system consisting of 5 mol% of Pd<sub>2</sub>(dba)<sub>3</sub> and 20 mol% of dppe in THF at 65°C for 3 h, followed by the addition of 2.0 equivalents of allyl methyl carbonate **2g**, 2.0 equivalents of BSA and 10 mol% of potassium acetate at 65°C for further 18 h.

# 7.2. Scope study on the triple domino sequence

With the best reaction conditions in hand, the scope of the Pd-catalyzed domino sequence was evaluated.

### 7.2.1. <u>Variation on the second allylic coupling partner</u>

Next, we performed the domino reactions using 3,4-dimethoxycinnamylcarbonate 2c for the initial sulfinate allylation, with various other allyl methyl carbonates were performed (Scheme 73). We saw previously that the triple Pd-catalyzed domino sequence  $\{[5a+2c\rightarrow 6b]/[6b+2g\rightarrow 7b]/[7b+2g\rightarrow 8b]\}$  gave the  $\alpha$ -diallylated allyl sulfone 8b in 48% isolated yield, without formation of the intermediate


**7b**. However, repeating the same domino sequence as above, but using cinnamyl methyl carbonate **2a** instead of allyl methyl carbonate **2g** gave only degradation products. Similarly, when prenyl methyl carbonate **2e** was used as the second allylating agent, the corresponding mono- and diallylated products **7d** and **8d** could not be obtained. Using cyclohexyl methyl carbonate **2f** as the second coupling partner was also unsuccessful. In the last two cases, step 2 did not work, and only allyl sulfone **6b** was detected. These reaction outcomes were disappointing and suggest that the reaction may be sensitive to the steric hindrance of the second coupling partner. The sequence seems to be very substrate dependent.

## 7.2.2. <u>Variations on the first allylic coupling partner.</u>

We next passed to change the first allylic coupling partner, keeping allyl methyl carbonate as the second coupling partner, under our optimized reaction conditions. Accordingly, applying our domino protocol to cinnamyl methyl carbonate 2a {planned sequence  $[5a + 2a \rightarrow 6a] / [6a + 2a \rightarrow 7a] / [7a + 2a \rightarrow 8a]$ }, the  $\alpha$ -allylated sulfone 7a and the  $\alpha$ -diallylated sulfone 8a were obtained in 25% and 49% yield, respectively. By replacing allyl methyl carbonate 2g with cinnamyl methyl carbonate 2a, as the second allylating agent gave the  $\alpha$ -allylated sulfone 7f and  $\alpha$ -diallylated sulfone 8f, each in 11% yield.

This lower yield could possibly be explained by the fact that cinnamyl methyl carbonate is somewhat bulkier than allyl methyl carbonate. Using the (*E*)-3-naphthalen-1-yl-allyl methyl carbonate 2d as the first allylating agent and allyl methyl carbonate 2g as the second, completion of the first step was not achieved within 12 h and allylsulfone 6ac was isolated with 23% yield and diallylated product 8g was produced with 11% yield after 40 h of reaction. Using of geranyl methyl carbonate 2b as the first allylating agent and allyl methyl carbonate 2g as the second did not yield the desired products 7h and 8h due to unsuccessful completion of the first step, resulting in no conversion. Finally, reacting prenyl carbonate 2e as the first allylating agent and 2g as the second one, the initial allylation with sodium benzenesulfinate 5a failed to generate a linear allyl sulfone and instead led to the branched allyl sulfone 6c in 64% yield. These results show that the limitations of this reaction conditions are significant as a very limited number of substrates seem to work (Scheme 74).

Further exploration and re-optimization of the reaction conditions may be necessary to overcome these challenges and expand the applicability of the reaction to different substrates.

## 7.3. Study of a pure-domino procedure.

Due to the limited substrate scope observed in the above experimental methods, the construction of S–C/C–C/C–C bonds in a domino sequence remains a significant challenge. In the hope to overcome this issue, we passed to study a triple Pd-catalyzed process that would run not only as a one-pot procedure, but also as a pure domino process. That is to say, eliminating the addition of one component during the process. In a pure domino sequence, all the reactions components have to be present at the outset of the experiment, and this fact may help reducing the risk of Pd-catalyst deactivation.

## 7.3.1. <u>Development of a pure-domino process from allyl carbonate **2a**.</u>

In the first trial, we reacted 3.0 equivalents of cinnamylmethylcarbonate 2a and 1.0 equivalent of sodium benzenesulfinate 5a in the presence of 5 mol% of Pd<sub>2</sub>dba<sub>3</sub>, 20 mol% of dppe and with the combination of 1.2 equiv. of BSA and 10 mol% of potassium acetate as the base in THF at 65°C for 4 h. Since cinnamyl methyl carbonate 2a is expected to participate as the first, the second and the third allylating agent, at least 3 equivalents of substrate 2a are theoretically required. With these conditions, the monoallylated product 7f and diallylated sulfone 8f were obtained in 22% and 15% yield, respectively (Table 10, entry 1). Increasing the amount of cinnamyl carbonate 2a to 4.0 equivalents led to the formation of diallylated product 8f in 38% yield, while the monoallylated product 7f was not observed (Table 10, entry 2). However, using cesium carbonate as the base provided both mono- and diallylated products 7f and 8f in 30% and 16% yield respectively (Table 10, entry 3). Further attempts to improve the yield by increasing or decreasing the amount of base did not yield better results (Table 10, entries 4 and 5). In addition, the domino reaction could not provide a better yield of the products when no external base was used (Table 10, entry 6).

As can be seen from the above results, the pure domino sequence did provide the desired diallylated product **8f**, although the yield remained moderate. Since the former study employing cinnamyl methyl carbonate showed poor yield, we decided to study the same kind of pure domino process with allyl methyl carbonate **2g**.

## 7.3.2. Development of a pure domino process from allyl methyl carbonate 2g.

Applying our optimal reaction conditions for the pure domino process to allyl carbonate **2g**, after 4 h of heating and stirring, the reaction produced 42% of the monoallylated product **7j** and 14% of the diallylated product **8j** (Table 11, entry 1). Prolonging the reaction time to 18 h resulted in an increase in the yield of the diallylated product **8j** to 37%. However, 23% of allylsulfone **6d** remained unreacted, without undergoing further transformation to the monoallylated product **7j** (Table 11, entry 2). The

addition of 5 mol% of Pd<sub>2</sub>(dba)<sub>3</sub> and 20 mol% of dppe to the reaction mixture after 4 h resulted in the major product being the monoallylated product **7j** with 51% yield (Table 11, entry 3). However, despite this improvement, 23% of allylsulfone **6d** remained unreacted. The observation that a significant amount of the starting material and allyl methyl carbonate **2g** remained unreacted despite the use of additional Pd-catalyst and longer reaction times, suggests that the allyl carbonate may undergo decomposition during the reaction progress, highlighting the need for further optimization to improve the yield and selectivity of the domino reaction.

## 7.3.3. <u>Kinetic studies on the pure domino process.</u>




Figure 1. Kinetic study with allyl methyl carbonate 2g.

To investigate the above hypothesis, we followed the kinetics of the above process. Accordingly, we reacted 0.4 mmol of allyl methyl carbonate 2g with 0.1 mmol of sodium benzenesulfinate 5a in THF- $d^8$ , at 65°C, using the catalytic system described above and monitoring the reaction progress via  $^1$ H NMR at hourly intervals, using 1,4-dinitrobenzene as an internal standard (Figure 1). The starting material 2g was rapidly consumed and products 6d, 7j and 8j were all produced within a short period of time (5 hours), then the amount of allyl carbonate 2g decreases slowly, while products 6d and 8j

kept almost unchanged as the reaction proceeded. The rise of the  $\alpha$ -allylated sulfone **7j** is pretty fast within the first 2h. Then, its amount decreases to the profit of the  $\alpha$ -diallylated sulfone **8j** (from 2 to 3 hours). At the end of the reaction, the formation of the monoallylated product **7j** becomes very slow but increases a little. These results seem to indicate that the starting material is consumed faster than the mono and diallylated allyl sulfones are formed without accumulation of the allyl sulfone **6d**, highlighting a potential degradation or an unidentified side-reaction happening. The slow formation of the products may also suggest that the palladium catalyst deactivates after a certain amount of time (around 5h) and becomes less effective.

Since allyl methyl carbonate **2g** seemed to engage in other transformations than the planned domino reaction, we changed the substrate and selected commercial allyl acetate **1b** for further studies. We followed the kinetics of the reaction by monitoring the reaction of 0.4 mmol of allyl acetate **1b** with




Figure 2. Kinetic study with allyl acetate 1b.

0.1 mmol of sodium benzenesulfinate **5a** by quantitative <sup>1</sup>H NMR with the introduction of **1**,4-dinitrobenzene as an internal standard (Figure 2). From this study, we can observe that allyl acetate **1b** was rapidly consumed and allyl sulfone **6d** was rapidly produced in a short period of time (up to 2h), but the mono- and diallylated products **7j** and **8j** were obtained only in small amounts. With the time, the amount of allyl acetate **1b** decreases and remains almost unchanged after 6h of reaction. The yield of allyl sulfone **6d** increased gradually, while the yields of **7j** and **8j** remained almost unchanged. Although the reactivity of allyl acetate **1b** was lower than that of allyl methyl carbonate **2g**, unreacted **1b** remained stable throughout the duration of the experiment. Therefore, further optimization of this reaction was conducted.

We performed a reaction with 4.0 equivalents of allylacetate **1b**, 1.0 equivalent of sodium benzenesulfinate **5a** using a catalytic system consisting of 5 mol% of Pd<sub>2</sub>dba<sub>3</sub> and 20 mol% of dppe, with 1.2 equiv. of BSA and 10 mol% of potassium acetate as the base for 20 h. This reaction provided allyl phenyl sulfone **6d**, the monoallylated product **7j** and the diallylated product **8j** in 76%, 14% and 5%

yield respectively (Table 12, entry 1). The use of BSA alone as the base (an acetate anion being formed during the formation of the  $\pi$ -allylpalladium species) could increase the yield of monoallylated product 7j to 34% yield with a short decrease of the quantity of allyl sulfone 6d (Table 12, entry 2). Increasing the amount of Pd catalyst and ligand did not lead to an improvement in the reaction (Table 12, entry 3). When 5 mol% of Pd<sub>2</sub>dba<sub>3</sub> and 20 mol% of dppe were added after 5h of reaction, the monoallylated product 7j could be obtained with 65% isolated yield together with 25% of allyl sulfone 6d and a small amount of diallyl sulfone 8j (Table 12, entry 4).

Unfortunately, after several trials, we were not able to obtain a synthetically useful domino sequence. After two years of unsuccessful attempts on this project, we decided to shift our attention toward the Pd-catalyzed generation of allyl sulfones via a C–H activation process.


In summary, Pd-catalyzed domino sequences were studied in coupling reactions between allyl

acetates (or carbonates), and sodium benzenesulfinate. Such planned domino sequences involves three sequential intermolecular Pd-catalyzed allylations generating 4-sulfonyl 4-vinylhepta-1,6-diene motifs through the construction of three new bonds (S–C/C–C/C–C) in a single synthetic operation. Although in some instances we did obtain the desired triene products, the substrate scope for this process remains very limited. A Pd-catalyzed pure domino sequence has been investigated between allyl acetate **1b** (or allyl carbonate **2g**) and sodium benzenesulfinate **5a**. Although this type of protocol has demonstrated improved efficiency compared to the sequential method, it cannot be considered synthetically relevant.

## Chapter 3. Access to allyl sulfones via alkene C–H sulfonylation

## 1. Introduction

The first project, described in chapter 2, involved the study of the *redox neutral* Pd(0)-catalyzed coupling between a sulfinate anion and an allylically oxidized alkene, coupled with the *in situ* Pd(0)-catalyzed allylation of the resulting allyl sulfone with another allylically oxidized alkene (Scheme 75, blue box). The second project of this thesis work deals with the hitherto unknow alternative generation allyl sulfones via an *oxidative* PdX<sub>2</sub>-catalyzed coupling between a sulfinate anion and an alkene (Scheme 75, red box).



Scheme 75. Project #1 and Project #2 of the thesis and their interconnection. Z = hydrogen acceptor.

This chapter introduces this new project by first presenting the very few reported precedents of allyl sulfone synthesis via alkene C–H sulfonylation. Furthermore, since the planned strategy relies on the direct PdX<sub>2</sub>-catalyzed allylic C–H activation / functionalization of alkenes, a brief state of the art of this topic will be also presented.

## 2. Allylic C-H sulfonylation of alkenes


In 2012, Li and co-workers reported that substituted allylic sulfones could be obtained through tetrabutylammonium iodide (TBAI) catalyzed direct allylic C–H coupling between  $\alpha$ -methylstyrenes and arylsulfonylhydrazides using *tert*-butyl hydroperoxide (TBHP) as oxidant (Scheme 76). [98]

Scheme 76. TBAI-catalyzed allylic direct C-H sulfonylation.

The authors proposed a mechanism for this transformation involving the initial iodide-catalyzed decomposition of TBHP to generate the *tert*-butoxyl and *tert*-butylperoxy radicals (Scheme 77, top). These radicals bring about three consecutive H atom abstractions from the sulfonylhydrazide to generate a sulfonyl radical with the release of molecular nitrogen. Addition of resultant sulfonyl radical to the alkene and subsequent H atom abstraction by *tert*-butoxyl or *tert*-butylperoxy radical affords the allyl sulfone (Scheme 77, bottom).

In 2017, the Chang's group reported that  $ZnI_2$  promoted the C–H sulfonylation of substituted  $\alpha$ -methylstyrenes with sodium sulfinates to generate the corresponding  $\alpha$ -sulfonyl methylstyrenes (Scheme 78). [99] Electron-rich  $\alpha$ -methylstyrenes did not give the desired products. On the other hand, electron-rich as well as electron-poor aryl sulfinates provided goods yields of the corresponding allyl sulfones. The mechanism postulated by the authors entails the initial interaction between the styrene and  $ZnI_2$  to afford an apparently electrophilic allylzinc intermediate, which undergoes allylic substitution by the sulfinate anion (Scheme 78).

Scheme 78. Znl<sub>2</sub>-mediated allylic C–H sulfonylation.


Finally last year, Wang et al. reported the Cu(OTf)<sub>2</sub> catalyzed C-H coupling between α-

methylstyrenes and arylsulfonyl chlorides, which gave the corresponding allylsulfones in moderate yields (Scheme 79).[100]

Scheme 79. Copper-catalyzed allylic C–H sulfonylation.

The authors propose for this reaction a radical mechanism involving the initial generation of a CuX active catalyst. A single electron transfer (SET) follows between the Cu(I) species and the sulfonyl chloride, generating a sulfonyl radical and a Cu(II) intermediate. Addition of the sulfonyl radical to  $\alpha$ -methylstyrene generates a new benzylic radical intermediate that is oxidized to the corresponding benzylic carbocation by the Cu(II) salt, which in turn reduced to a Cu(I) species. Final elimination gives the  $\alpha$ -sulfonyl methylstyrene product (Scheme 80).

## 3. $\eta^3$ -Allylpalladium complexes through direct allylic C-H activation and their reactivity

### 3.1. Introduction

Recently, the concept of step-economical synthesis has emerged as one the most challenging topics in organic chemistry. One of the most effective ways to decrease the number of steps of a synthesis is to sidestep the functional group manipulations typically needed to obtain pre-oxidized substrates, to carry out key carbon-carbon or carbon-heteroatom bond formations. One solution to achieve this goal is to realize the direct activation of a C-H bond in an organic substrate. Such an accomplishment allows including the omnipresent C–H bond to the list of the more popular functional groups such as halides, alcohols, carbonyls, etc, thus bypassing intermediate functional group installation. [101]

A major challenge in this strategy consists in the regio-, chemo- and stereoselective activation of the selected C–H bond, leaving the remaining C–H bonds intact. Reactivity of C–H bonds is highly dependent on the hybridation of the carbon atom. Specifically, while C(sp)–H and  $C(sp^2)$ –H can be activated more readily,  $C(sp^3)$ –H are much less reactive, with the notable exception of those in enolizable positions. However,  $C(sp^3)$ –H bonds in allylic position can be activated more easily than the remaining ones.

Therefore, the direct functionalization of allylic C–H bonds has been intensely studied. Various transition metals are capable of promoting this activation, and palladium is one of the most interesting metals to accomplish this task, considering both the cost of the metal salt and its reactivity. As a result, several Pd-catalyzed direct allylic oxylations<sup>[102]</sup> and aminations<sup>[103]</sup> have been published recently. <sup>[1,4b]</sup> In 1959, Hüttel<sup>[18]</sup> reported the first preparation of the  $\eta^3$ -allylpalladium chloride dimer via allylic C-H

activation by reacting 2-methylprop-1-ene with palladium(II) chloride, sodium acetate in acetic acid. In a series of subsequent papers, Hüttel showed that heating these complexes brings about reductive elimination to give the corresponding allylic chloride (Scheme 81).

Scheme 81. Pioneering generation of  $\eta^3$ -allylpalladium complexes.


The generation of an  $\eta^3$ -allylpalladium intermediate from an alkene with a Pd(II) salt implies the C–H activation of the allylic position of an alkene. Therefore, an  $\eta^3$ -allylpalladium intermediate can be generated either by the interaction between a Pd(0) complex and an allylically oxidized alkene (see chapter 1), or by the interaction between a PdX<sub>2</sub> salt and an alkene having an allylic hydrogen. Therefore, while in the former case the substrate is oxidized and the metal is reduced, the situation is the other way around in the latter case (Scheme 82).

Scheme 82. Two alternative ways to generate  $\eta^3$ -allylpalladium complexes

In both cases, a Pd-catalysis can be obtained, although under different conditions. Indeed, in the former case, catalysis begins and ends with a [Pd(0)] complex. We already saw several examples of this *redox neutral* catalysis in chapter 1. In the latter case, after the generation of the desired product, the starting Pd(II) salt is reduced to Pd(0). Therefore, a sacrificial oxidant (H<sub>2</sub> acceptor, Z) that brings the metal back to the pristine II oxidation state is here normally<sup>[104]</sup> needed (Scheme 83).

The possibility of accomplishing oxidative Pd-catalyzed catalytic cycles opened the way to a number of C–H activation-based<sup>[105]</sup> allylic functionalizations of alkenes in the presence of several oxygen-, nitrogen- and carbon-based nucleophilic partners.<sup>[106]</sup> It should be noted, however, that since these transformations require a sacrificial oxidant, the nucleophile must be compatible with the latter. This chemistry has been recently exploited to generate new C–O (*vide infra*), C-N and C-C bonds by the coupling between alkenes and carboxylic acids, amine derivatives, or carbanions, respectively. On the other hand, the generation of a new C–S bond was unknown before our study. Since the present thesis work required Pd-catalyzed oxidative allyl acyloxylation at some point, a quick state of the art on this C–O bond-forming transformation follows.

## 3.2. Pd(II)-catalyzed allylic C–H acyloxylations of alkenes

Allylic acetates are useful intermediates in organic synthesis. Traditionally, these substrates can be prepared in one step by esterification of commercially available allylic alcohols with acetic anhydride. However, allylic alcohols are not abundant from commercial sources. For example, the preparation of primary allylic acetates RCH=CHCH<sub>2</sub>OAc usually requires three steps from commercially available

aldehydes. The sequence involves a Horner-Wadsworth-Emmons (HWE) olefination that generates an  $\alpha,\beta$ -unsaturated ester, which is reduced with two equivalents of di-*iso*-butylaluminium hydride (DIBAL-H), to form an allylic alcohol. [91,107] Finally, the allylic alcohol is transformed into the corresponding allylic acetate by reaction with acetic anhydride. As the above sequence, although of general applicability and efficient, is rather tedious, simpler methods are welcome. The direct allylic acetoxylation of alkenes is a much simpler way to access allylic acetates. In this transformation, a C(sp³)-H bond in an allylic position is formally replaced by an acetate moiety.

In 1984, Åkermark reported that treatment of cycloalkenes with catalytic amounts of Pd(OAc)<sub>2</sub> in the presence of MnO<sub>2</sub> as terminal oxidant afforded the corresponding allylic acetates (Scheme 84).<sup>[108]</sup> On the other hand, applying these reaction conditions to terminal alkenes usually produced Wacker oxidation products.

The first example of Pd(II)-catalyzed allylic C–H oxidation of a linear alkene was reported by McMurry in 1984.<sup>[109]</sup> Treatment of geranyl acetone with the catalytic system [Pd(TFA)<sub>2</sub> (5 mol%)/ o-methoxyacetophenone (20 mol%)], in the presence of one equivalent of benzoquinone in acetic acid brought about the allylic acetoxylation of the external alkene with an approximatively 66:34 linear / branched ratio. The other examples dealt with cyclic alkenes (Scheme 85).

During the following decades, palladium-catalyzed allylic oxidations have been the object of a

number of studies.<sup>[110]</sup> In the early 2000s, White's group disclosed a series of Pd-catalyzed allylic acetoxylation protocols for the selective conversion of monosubstituted olefins into the corresponding linear or branched allylic acetates. The competitive Wacker side reaction could be inhibited when a suitable sulfoxide-based ligand was selected. In particular, use of DMSO (as solvent) in the presence of BQ, acetic acid and catalytic amounts of palladium(II) acetate gave the linear (*E*)-allylic acetates with high regio- and stereoselectivities, whereas the presence of a bis-sulfoxide ligand (White's catalyst) instead of DMSO resulted in the formation of the branched allylic acetates (Scheme 86).<sup>[5a,111]</sup>

The above outcome can be explained as follows. In the presence of DMSO as solvent, abstraction of an allylic proton by the coordinated acetate ligand from the substrate is expected to generate a cationic  $\eta^3$ -allylpalladium complex (excess DMSO displaces BQ from the Pd coordination sphere). Following trapping by an external acetate anion at the distal allylic position through an outer sphere attack generates a linear allylic acetate. The disulfoxide ligand favors an allylic C–H activation, too. However, in this case, after the C–H activation step, BQ may replace the sulfoxide ligand in the metal coordination sphere (serial ligand catalysis), and the resulting neutral  $\eta^3$ -allylpalladium complex (with enhanced electrophilicity due to the  $\pi$ -acidic character of BQ) is attacked by an acetate anion at the internal allyl terminus via an inner sphere attack generating the branched allylic acetate (Scheme 87). [112]

## 3.2.1. <u>Use of other carboxylic acids for intermolecular allylic C-H acylations.</u>

The PdX<sub>2</sub>-catalyzed allylic acetoxylation protocols normally need the presence of acetic acid in a large excess or even as a solvent. This mass effect favors the formation of the products and is easy to implement due to the availability of acetic acid. However, if more complex allylic acyloxylations are desired, the amount of the nucleophile has to be reduced. A general procedure that avoids the use of an excess of carboxylic acid was reported by the group of White in 2010.<sup>[107]</sup> This protocol makes use of 1.5 to 3.0 equivalents of carboxylic acids in the presence of the cationic Pd(II) complex (Pd(CH<sub>3</sub>CN)<sub>4</sub>(BF<sub>4</sub>)<sub>2</sub>) and DMSO as the ligand. Allylarenes (Scheme 88, equation 1) as well as aliphatic terminal alkenes (Scheme 88, equation 2) could be converted into the corresponding allylic esters in moderate to good yields in excellent linear/branched ratio and diastereoselectivity in favor of the (*E*)-alkene. The reaction was compatible with many carboxylic acids, including aliphatic acids and amino acid derivatives.

A couple of years later, Itami *et al.* developed a catalytic system which, thanks to a sterically hindered N,S-bidentate sulfoxide-oxazoline (SOX) ligand, allowed the Pd-catalyzed conversion of monosubstituted terminal alkenes into the corresponding branched allylic esters.<sup>[113]</sup> The specific design of the ligand allowed the authors to obtain high selectivities in favor of branched allyl acylates (Scheme 89).

One of the major issues met in Pd-catalyzed allylic acyloxylations is the high catalytic loading of the palladium catalyst needed (usually around 10 mol%). This problem has been partially solved by the group of Tsurugi, Seki and Mashima in 2021, in the acylation of terminal alkenes with p-nitrobenzoic acid. They noticed that the combination of this acid with silver carbonate (Ag<sub>2</sub>CO<sub>3</sub>) greatly enhanced the kinetics of the Pd(II)-catalyzed allylic C–H acylation of aliphatic terminal as well as cyclic alkenes. In the presence of 1 mol% of Ag<sub>2</sub>CO<sub>3</sub> and 1.5 equiv. of BQ, they managed to prepare selectively branched

allyl esters using only 1 mol% of commercially available White catalyst for terminal alkenes and 2 mol% of catalyst for cyclic alkenes. The reaction was faster (24h *vs* 48-72h for other procedures) and proceeded in moderate to excellent yields, depending on the nature of the substrate (Scheme 90).

## 3.2.2. <u>Intramolecular allylic C-H acylation reactions</u>

In 2006, White's group reported the first conversion of linear  $\omega$ -alkenoic acids into macrolides of different sizes through a Pd/bis-sulfoxide catalyzed intramolecular allylic C–H acetoxylation (Scheme 91).<sup>[115]</sup> An application to the total synthesis of 6-deoxyerythronolide B was also later reported by the same group.<sup>[116]</sup>

In 2011, White's group also reported an intramolecular C–H allylation of a substituted 2-(but-3-en-1-yloxy)acetic acid leading to a 1,4-dioxan-2-one. [117] The intramolecular C–H acyloxylation was possible in the presence of White's catalyst (10 mol%), Cr(salen)Cl (10 mol%), and benzoquinone in 1,4-dioxane at 65°C. The dioxanones were obtained in good yields and moderate to good diastereomeric ratios, and always highly favoring the *anti* isomer. The resulting products could be converted into several molecular scaffolds such as differentiated *syn* diols, polyoxidized motifs, as well as dihydropyrans (Scheme 92).

In 2015, our group reported the  $PdX_2$ -catalyzed intramolecular allylic acyloxylation of unsaturated carboxylic acids, leading to the corresponding lactones.<sup>[118]</sup> In particular, a mechanistic study was performed to determine whether the reaction involves a C–H activation or an oxypalladation step (Scheme 93). The study determined that the longer the chain, the lower the yield of the lactone.

## 3.2.3. <u>Asymmetric direct allylic C-H oxylations</u>

In 2008, White's group managed to perform the direct asymmetric Pd-catalyzed acetoxylation of terminal alkenes working in the presence of catalytic amounts of the chiral enantiopure Cr(III)(salen) complex (Scheme 94).<sup>[119]</sup>

A few years later, White's team developed the asymmetric  $PdX_2$ -catalyzed direct intramolecular allylic C–H alkoxylation of a number of terminal alkenes to obtain isochromanes in high ee% using a chiral enantiopure SOX-ligand (Scheme 95). [120]

## 3.2.4. <u>Use of more environment-friendly oxidants</u>

Many oxidative transformations involving palladium catalysis are accomplished in the presence of stoichiometric amounts of benzoquinones, which, besides of acting as terminal (sacrificial) oxidizing agents, behave also as  $\pi$ -acidic ligands for palladium. However, quinones are rather toxic, normally used in excess, and, once reduced, they form one equivalent of hydroquinone waste. Therefore, the replacement of quinones with more sustainable oxidizing agents is highly desirable. In this context, molecular oxygen is the environmentally friendly oxidant by excellence, being a low-cost molecule, and its only side product is  $H_2O_2$  or  $H_2O$ . The reaction conditions for an oxidative transformation using

oxygen as a sacrificial oxidant are termed *aerobic* because they mimic the mechanism of action of *oxidase* enzymes in living cells, which catalyze the transfer of two electrons from the substrate to oxygen, without oxygen incorporation. While the first Pd-catalyzed aerobic transformations were reported by the group of Smidt at the time the Wacker process was unveiled, [121] Kaneda's group was the first to adopt these reaction conditions in Pd-catalyzed allylic acetoxylations of terminal olefins, which afforded selectively the linear allylic acetates in a poor E/Z ratio (Scheme 96). [122]

In 2010, Stahl *et al.* performed PdX<sub>2</sub>-catalyzed BQ-free aerobic allylic acetoxylations using 4,5-diazafluoren-9-one (DAF) as the ligand. This specially designed ligand allowed the conversion of terminal alkenes into linear allylacetates in good yields and selectivities (Scheme 97).<sup>[123]</sup>

Mechanistic studies revealed that the DAF ligand facilitated the C-O forming reductive elimination

step from the  $\pi$ -allyl-Pd(II) intermediate **A**, thereby eliminating the requirement for benzoquinone as ligand (Scheme 98).

Other sustainable oxidants such as  $Oxone^{\otimes[124]}$  or sodium perborate tetrahydrate (SPB) can be used. On the one hand, the group of Stoltz reported that palladium(II) hexafluoroacetylacetonate (Pd(hfacac)<sub>2</sub>) catalyzes the allylic acetoxylation of  $\alpha$ -allyllactams in the presence of acetic acid and  $Oxone^{\otimes}$  as the terminal oxidant (Scheme 99, equation 1).<sup>[125]</sup> On the other hand, the group of Szabó described the allylic acetoxylation of terminal alkenes with palladium(II) acetate as the catalyst and SPB as the terminal oxidant (Scheme 99, equation 2).<sup>[126]</sup> In both cases, the desired product was obtained in moderate to good yields. In general, the use of these alternative oxidants results in lower yields than molecular oxygen, but they are easier to handle.

# Chapter 4. Synthesis of allylsulfones by palladium-catalyzed C-H activation of terminal alkenes.

## 1. Introduction

As mentioned earlier, organosulfur compounds are essential molecules in various fields of chemistry, and, in particular, allyl sulfones are very useful building blocks. However, their synthesis using traditional methods requires multiple steps, due to the limited availability of allylic precursors. [63,64,67,91] Although the direct C–H sulfonylation of alkenes could offer an efficient and elegant route to synthesizing allylsulfones, this approach has been so far limited to a very narrow scope, only allowing for the sulfonylation of methyl styrenes. [98-100]

Considering the recent studies reported by us and others on the Pd-catalyzed allylic C–H amination<sup>[5b]</sup> and acetoxylation of alkenes,  $^{[92,107-112,121-126]}$  we became interested in developing reaction conditions for a Pd-catalyzed allylic C–H sulfonylation of terminal alkenes. Our group reported two complementary strategies for the Pd-catalyzed intermolecular allylic amination of but-3-enoic acid derivatives. The first strategy involves a direct Pd(II)-catalyzed allylic amination, while the second one a palladium(II)-catalyzed allylic pivaloylation, to produce the corresponding  $\alpha$ , $\beta$ -unsaturated- $\gamma$ -pivaloyloxy butenoic acid derivative, which is submitted *in situ* to a palladium(0)-catalyzed amination. Indeed, with relatively acidic nitrogen nucleophiles such as N-tosyl carbamates or saccharin, the direct Pd(II)-catalyzed allylic amination was possible (Scheme 100, equation 1). On the other hand, with the less acidic nitrogen nucleophiles such as N-phthalimide, the sequential one-pot Pd(II)-catalyzed pivaloxylation/Pd(0)-catalyzed amination reaction was only possible (Scheme 100, equation 2).

Scheme 100. Previous strategies for the Pd-catalyzed allylic C-H amination of but-3-enoic acid derivatives from our group.

Accordingly, we decided to explore the two above-described strategies to obtain the allylic C–H sulfonylation of terminal alkenes (Scheme 101).

Scheme 101. Envisaged strategies for the Pd-catalyzed allylic C-H sulfonylation of terminal alkenes.

## 2. Synthesis of substrates.

## 2.1. Synthesis of sodium sulfinates.

Although some sulfinate salts are commercially available, some others have been synthesized. This was obtained by treatment of commercially available sulfonyl chlorides with sodium bicarbonate and

sodium sulfite in water at 80°C (Scheme 102).<sup>[127]</sup> With the exception of *p*-nitrobenzene sulfonyl chloride, which gave the corresponding sulfinate **5d** in a low yield (39%), both, electron-rich and electron-poor aromatic sulfonyl chlorides provided the desired aromatic sodium sulfinates **5c-5g** in excellent yields. 2-Thiophene sulfonyl chloride also gave the corresponding sodium sulfinate **5h** in an excellent yield of 87%. Aliphatic sodium sulfinates **5i-5m** were also prepared efficiently from *iso*-propyl-, cyclopropyl, methyl, benzyl and (+)-10-camphor sulfonyl chlorides with yields ranging between 67% and >99%.

## 2.2. Synthesis of the terminal alkenes.

Most of the terminal alkenes used for the study were commercially available and ready to use, while a couple of them had to be modified. Accordingly, the phenol functions of *o*-allylphenol and of the naturally occurring eugenol were protected as the benzyl ethers **10a** and **10b** by deprotonation with sodium hydride and reaction with benzyl bromide in DMF<sup>[128]</sup> (Scheme 103, equations 1 and 2). Similar conditions, except for the replacement of DMF by THF, were used for the benzylation of the

aliphatic terminal alkene hex-5-en-1-ol to generate 10c (Scheme 103, equation 3). [129]

## 3. Preliminary results and optimization of the reaction conditions.

## 3.1. Preliminary studies.

We first studied the direct C–H sulfonylation strategy, selecting the coupling between allylbenzene **10d** and sodium *p*-toluenesulfinate **5b** as the model reaction. Happily, treatment of 1.0 equivalent of **10d** with 2.0 equivalents of **5b**, in the presence of 10 mol% of palladium acetate and 2.0 equivalents of 2,6-dimethylbenzoquinone (2,6-DMBQ) as the terminal oxidant, in freshly distilled acetonitrile (0.2 M) at 80°C under argon, resulted in the formation of the expected allylsulfone **6e** in 42% yield after 72 hours, with a conversion of 85% (Scheme 104). When we performed the reaction under aerobic conditions (under air), the same result was obtained.

## 3.2. Optimization of the direct allylic C-H sulfonylation procedure.

The influence of various parameters (temperature, solvent, oxidant, ligand, and palladium source) on the outcome of the reaction was studied next.

## 3.2.1. <u>Variation of the solvent.</u>

A screening of polar solvents (propionitrile, DMSO, DMF, THF, 1,4-dioxane, MTBE, HFIP, dimethyl carbonate) showed that none of them gave a better yield than acetonitrile (Table 13, entries 2-9). With propionitrile, a similar result was obtained when the reaction was performed at 110°C (Table 13, entry 2). Suspecting that the moderate yield and the long reaction time could be due to a poor solubility of the sulfinate salt in acetonitrile, we tested methanol or *tert*-butanol as a cosolvents. However, performing the reaction in a 4:1 v/v mixture of acetonitrile and MeOH gave a poor yield of 29%, while in a 4:1 v/v mixture of acetonitrile and *tert*-butanol gave a similar yield of 34% (Table 13, entries 10 and 11). In the end, acetonitrile proved to be the best solvent for the reaction.

## 3.2.2. Variation of the oxidant.

We next investigated the influence of the oxidant, while keeping acetonitrile as the solvent, to find out the most efficient Pd(0)-to-Pd(II) reoxidation in the catalytic cycle. The best results were obtained with 1,4-benzoquinone derivatives, especially with the dimethylated quinone oxidants (2,5- and 2,6-DMBQ) (Table 14, entries 1 and 4). Simple 1,4-benzoquinone led essentially to degradation products, with only trace amount of the desired product **6e** (Table 14, entry 2). DDQ also proved to be unsuccessful to provide allylsulfone **6e** (Table 14, entry 3). Duroquinone (DQ) led to a very low yield (10%) of allylsulfone **6e** (Table 14, entry 5). Changing the oxidant to metal acetates such as silver acetate and copper(II) acetate led to the formation of trace amounts of products accompanied by various amounts of an isomeric mixture of the desulfonylated product (Table 14, entries 6-7). Switch to other oxidants such as manganese dioxide, molecular oxygen (1 atm), diacetoxyiodobenzene or *tert*-butylhydroperoxide, gave no product, only degradation or byproducts being observed (Table 14, entries 8-11). So, 2,6-DMBQ revealed to be the best oxidant.

## 3.2.3. <u>Variation of the palladium source.</u>

A variety of palladium(II) sources were investigated next. When palladium(II) pivalate, which carries a bulky carboxylate ligand, was tested, the allylsulfone **6e** was obtained in only 12% yield after 71h (Table 15, entry 1), and the electron-poor palladium(II) trifluoroacetate did not improve the yield of **6e**, too (Table 15, entry 2). Palladium(II) acetylacetonate gave results similar to palladium(II) acetate (Table 15, entry 4). Palladium(II) chloride and dichlorobis(acetonitrile)palladium(II) also failed to produce better yields (Table 15, entries 5 and 6). We finally decided to retain palladium(II) acetylacetonate, as with palladium(II) acetate some reproducibility problems due to the variable purity of commercial batches were encountered.<sup>[131]</sup>

## 3.2.4. Introduction of a ligand.

Hypothesizing that the moderate yields of the allylic sulfonylation might be due to catalyst deactivation, we decided to check whether the introduction of a ligand could avoid, or at least moderate, the loss of catalytic activity. The bidentate White sulfoxide ligand 1,2-bis(phenylsulfinyl)ethane, [5a,111] or the monodentate ligand like phenylvinylsulfoxide and DMSO did not give better yields compared to the previously reported ligandless conditions (Table 16, entries 2-4). 4,5-Diazafluoren-9-one (DAF), known for dehydrogenation reactions, [132] and pyridine provided the desired product 6e in comparable yields of 37 and 38% (Table 16, entries 5-6). Other pyridine-type ligands such as 1,10-phenanthroline, 2,2'-bipyridine, 2,2'-bipyrimidine and dtbpy proved to be much less effective (Table 16, entries 7-10). N-acetylamino acids are known to favor C–H activation processes via a Concerted Metalation Deprotonation (CMD) mechanism. [133] However, the use of *N*-acetyl-*L*-leucine as the ligand did not provide a better yield than that carried out under ligandless conditions (Table 16, entry 11). Phosphine ligands were also ineffective (Table 16, entries 12-13). In light of the above experiments, we decided to stick to the original ligandless conditions for the rest of the study.

## 3.2.5. Molarity and amounts of oxidant and sulfinate.

The impact of the concentration on the coupling was studied next. Decrease of the concentration to 0.1M reduced the yield of **6e** to 28% (Table 17, entry 2), while increase to 0.66M raised it to 47% (Table 17, entry 4). Hence, we decided to pursue the study with the latter molarity. Reduction of the amount of sulfinate salt and of the oxidant was also investigated. Unfortunately, all the experiments carried out failed to achieve better yields than the original one, which calls for 2.0 equiv. of 2,6-DMBQ and 2.0 equiv. of sodium sulfinate (Table 17, entries 6-9).

In summary, the final conditions we kept for the coupling between allyl arenes and sodium sulfinates (2.0 equiv.) consist in Pd(acac)<sub>2</sub> (10 mol%) as the catalyst, and 2,6-DMBQ (2.0 equiv.) as the terminal oxidant, in acetonitrile (0.66M) at 80°C. In the following paragraphs, these conditions will be named "method A".

#### 3.3. Scope of the direct sulfonylation procedure.

#### 3.3.1. Aryl- and alkyl sulfinates.

With the optimized reaction conditions in hand, the scope of the reaction was then evaluated, starting with the coupling between allylbenzene **10d** and various sulfinate salts (Scheme 105). Electronrich phenyl-, *p*-toluene-, and 4-methoxyphenylsulfinates **5a**, **5b** and **5c** provided the corresponding allylsulfones **6a**, **6e** and **6f** in 58%, 47% and 41% isolated yield respectively. Electron-poor aryl sulfinates reacted too, although their coupling turned out to be much more sluggish. For example, only 57% conversion was detected by quantitative <sup>1</sup>H NMR analysis after 72h reaction between sodium 4-nitrobenzenesulfinate **5d** and allylbenzene **10d**. Nevertheless, the desired allylsulfones **6g** and **6h** could be obtained with 11% and 37% yield, respectively. Sodium 4-bromophenylsulfinate **5f** gave the corresponding allylsulfone **6i** in 45% isolated yield. Worthy of note, the C–Br bond was not affected by the transient formation of Pd(0) in the catalytic cycle (Scheme 105).

Alkyl sulfinates proved also to be reactive. Indeed, reaction between sodium propane-2-sulfinate  $\bf 5i$ , or sodium cyclopropane sulfinate  $\bf 5j$  gave allyl sulfones  $\bf 6j$  and  $\bf 6k$  in 22% and 51% yield, respectively. Unfortunately, sodium  $\alpha$ -naphthyl sulfinate  $\bf 5d$ , 2-thiophenylsulfinate  $\bf 5h$ , methyl sulfinate  $\bf 5k$ , benzyl sulfinate  $\bf 5l$  and camphor sulfinate  $\bf 5m$  gave no conversion or degradation products (Scheme 105). The reaction was also totally ineffective with the very electron-poor sodium trifluoromethyl sulfinate (Langlois' reagent)  $\bf 5n$ .

#### 3.3.2. <u>Allyl arenes as terminal alkenes</u>

We then studied the influence of the nature of the alkene on the reaction outcome with the developed conditions (method A). For this study, sodium benzenesulfinate **5a** was chosen as the reaction partner, because it is the nucleophile that gave the best results. Moreover, the corresponding allyl sulfones can be considered as synthetic intermediates in the Julia olefinations.

The coupling between the electron-rich allyl arenes **10e** and **10f** and sodium benzenesulfinate **5a** provided the corresponding allylsulfones **6l** and **6m** in 41% and 42% yield respectively (Scheme 106). When the *ortho*-substituted allylbenzene **10g** was tested, the corresponding allylsulfone **6n** was obtained in 40% yield. However, the phenolic derivatives benzyl eugenol **10a** and 2-*O*-benzylallylbenzene **10b** gave the corresponding allylsulfones **6o** and **6p** in lower yields of 33% and 24% respectively. The electron-poor allylarene **10h** bearing a *para*-trifluoromethyl group afforded the expected allylsulfone **6q** in 20% yield (Scheme 106).

#### 3.3.3. <u>Aliphatic terminal alkenes as substrates.</u>

We next evaluated terminal aliphatic alkene substrates in the developed reaction conditions (method A). Undec-1-ene **10i**, dec-1-ene **10j**, non-1-ene **10k**, oct-1-ene **10l** and hex-1-ene **10n** were engaged in the presence of sodium benzenesulfinate **5a**, providing the linear allylsulfones **6r-6v** with total regioselectivity and with yields ranging between 30% and 45%. In most cases, the pure (E)-configurated allylsulfones were isolated, although trace amounts of the (Z) isomers could be detected in the  $^1$ H NMR spectra of the crude reaction products. Only in the case of allylsulfone **6t**, both (E)- and (Z)-isomers could be isolated separately (Scheme **107**).

Methylenecyclopentane **10n** could also be converted into allylsulfone **6w** in a moderate 30% yield. Further studies were conducted on various functionalized aliphatic alkenes. Among them, the benzyl ether derivative **10c** led to its degradation, whereas the ester **10o** gave the allylsulfone **6y** in a low yield of 12% and only 40% conversion for the reaction. However, no conversion was observed for the alkene **10p** under the reaction conditions (Scheme 107).



On the basis of previous reports on Pd-catalyzed allylic C–H activation reactions, a tentative mechanism is proposed (Scheme 108). [1a,4b,5a,134] After coordination of the alkene to the Pd(II) catalyst, an allylic proton is abstracted via a probable concerted metalation deprotonation (CMD) mechanism, and the thus generated  $\eta^3$ -allylpalladium intermediate undergoes substitution by the sulfinate anion. Finally, after product decoordination, the generated Pd(0) complex, is reoxidized by the coordinated benzoquinone.

## 3.4. Optimization of the in situ sequential sulfonylation procedure (Method B).

Due to the moderate yields obtained with method A in some cases, a variation of the protocol was also considered. Specifically, based on previous reports from our group, [5b] we decided to attempt an *in situ* sequential protocol consisting in an initial oxidative Pd(II)-catalyzed allylic C–H alkene acetoxylation, followed by an *in situ* redox-neutral Pd(0)-catalyzed allylic sulfonylation of the resulting allylic acetate. The major challenge of this process consists in the use of the same palladium source for both transformations. In the event, reacting allylbenzene **10d** (1.0 equiv.) with acetic acid (10.0 equiv.) in the presence of 2,6-DMBQ (2.0 equiv.) and Pd(OAc)<sub>2</sub> (10 mol%) in DMSO (0.2M) at 80°C gave the corresponding allylic acetate **1a**. The latter was not isolated but its formation was checked by TLC. After that, *in situ* addition of *rac*-BINAP (20 mol%), *N,N*-di-*iso*propylethylamine (11.5 equiv.) and sodium *p*-toluenesulfinate **5b** (2.0 equiv.) with further stirring at 80°C under air gave the desired allylsulfone **6e** in 82% yield (Scheme 109).

Given that the amount of acetic acid and base introduced (to quench the acid) is very high, we tried to see whether it was possible to reduce it. We first conducted experiments with 10.0 equivalents of both reagents and observed that the allylsulfone **6e** was obtained with a similar yield (83%), but with a significantly longer reaction time for the second step (Table 18, entry 2). However, reducing the amount of acetic acid and DIPEA to 7.0, 5.0, or 3.0 equivalents resulted in generally longer reaction times for the second step and lower yields (Table 18, entries 3-5). We thus decided to keep the conditions used during the preliminary investigations of the *in situ* sequential protocol. In the following paragraphs, these conditions will be named "method B".

#### 3.5. Scope of the in situ sequential sulfonylation procedure.

#### 3.5.1. <u>Aryl- and alkyl sulfinates.</u>


With the new protocol (Method B) in hand for the benchmark reaction between 10d and 5b, we re-evaluated the sulfonylation of allylbenzene 10d with the other sulfinate salts previously used with method A (Scheme 110, yields obtained with method A are indicated for comparison). The reaction turned out to be equally efficient with electron-rich sulfinates 5a-5c as well as with electron poor sulfinate **5f**, affording satisfactory isolated yields of the desired allylsulfone, ranging from 77% to 82%. In these cases, much higher yields were obtained with method B in comparison to method A. Such increases in yield when switching from method A to method B with reduced reaction times underscore the synthetic importance of the in situ sequential procedure, although this strategy is less elegant than the previous one. Contrary to what was observed with method A, sodium 4-nitrobenzenesulfinate 5d did not react with the intermediate cinnamyl acetate 1a, which was recovered in 75% yield. With sodium 4-bromophenylsulfinate 5f, only a partial conversion of intermediate cinnamyl acetate 1a was detected (40% recovered) and the final allylsulfone 6i was isolated in only 45% yield. Such a low reactivity is likely due to competitive oxidative addition of the C-Br bond of the sulfinate to Pd(0) formed during the second step of the sequential process. However, increasing the amount of sulfinate 5f to 3.0 equivalents resulted in the completion of the second step of the sequential procedure and the formation of allylsulfone 6i with 63% isolated yield. Alkyl sulfinates 5i and 5j were also efficient with this protocol, affording the corresponding allylsulfones 6j and 6k in 77% and 73% yield respectively. In the case of sodium cyclopropyl sulfinate 5j, 3.0 equivalents were also needed to obtain a satisfactory yield of cinnamyl sulfone 6k, as only 28% isolated yield was obtained when using 2.0 equivalents of the sulfinate. In addition, and in contrast to method A, sodium  $\alpha$ -naphthyl sulfinate **5d** gave 13% of cinnamyl sulfone 6aa, while sodium methyl sulfinate 5k provided the corresponding allylsulfone 6ab in a moderate 48% yield. In this case, 4.4 equivalents of sodium methyl sulfinate 5k were necessary to obtain cinnamyl methylsulfone 6ab (Scheme 110).

#### 3.5.2. <u>Allylarenes as substrates.</u>

To further investigate the impact of the nature of the alkene on the reaction outcome, we reevaluated these couplings using the *in situ* sequential reaction conditions (Method B). Notably, when
the electron-rich allylarenes **10e** and **10f** were employed in the reaction with sodium benzenesulfinate **5a**, the corresponding allylsulfones **6l** and **6m** were obtained in yields comparable to those obtained
with method A (48% and 44% yield respectively) (Scheme 111). Interestingly, when the *ortho*substituted allylbenzene **10g** was subjected to method B, it failed to yield the corresponding
allylsulfone **6n** and produced (*E*)-4-methylcinnamyl acetate **1c** with 26% yield. Furthermore, benzyl
eugenol **10a** and 2-*O*-benzylallylbenzene **10b** showed higher yields of the corresponding allylsulfones **6o** and **6p** with method B (67% and 44% yield respectively) as compared to method A. The electronpoor allylarene **10h**, bearing a *para*-trifluoromethyl group, yielded the expected allylsulfone **6q** in 23%
isolated yield. However, in this case, the reaction does proceed pretty well, as testified by the 68% NMR
yield, the low isolated yield being due to difficulties during the purification process.

Unfortunately, none of the aliphatic terminal alkenes reacted with method B, due to the failure in the generation the allylacetate intermediates. However, a new product was unexpectedly generated when reacting exomethylenecyclopentane **10n**. Careful analysis, including single crystal X-ray diffraction analysis and IR analysis, showed the product to be hydroquinone **11**, which was formed in 22% isolated yield (Scheme **112**).

#### 3.6. Reoptimization of method B for aliphatic terminal alkenes.

Since the Pd(II)-catalyzed C-H allylic acetoxylation of aliphatic terminal alkenes has been reported by the group of White, [5a,111] we considered these reaction conditions to the first step of the in situ sequential procedure. Following a variant of White's protocol, undecene 10i was treated with Pd(OAc)2 (10 mol%) in the presence of 1,2-bis(phenylsulfinyl)ethane (10 mol%) as the ligand, benzoic acid (1.5 equiv.), benzoquinone (2.0 equiv.) as the oxidant and 4Å MS (50 mg) in 1,4-dioxane. After 48h stirring at 43°C, treatment of the resulting branched allyl benzoate 1d (TLC and ¹H NMR verification) with DIPEA (2.5 equiv.), sodium benzenesulfinate 5a (2.0 equiv.) and rac-BINAP (20 mol%) with heating at 80°C, didn't afford the desired allylsulfone 6r. The branched allyl benzoate 1d was detected instead by quantitative <sup>1</sup>H NMR (48% yield) (Table 19, entry 2). We speculate that the bis-sulfoxide ligand may prevent the phosphine promoted Pd(II)-to-Pd(0) reduction, thus halting the second, Pd(0)-catalyzed, step. However, the use of phenylvinylsulfoxide (10 mol%) instead of 1,2-bis(phenylsulfinyl)ethane allowed the formation of the desired allyl sulfone 6r in 23% NMR yield together with the branched allyl benzoate intermediate 1d in 27% yield (Table 19, entry 3). When increasing the amount of benzoic acid to 10.0 equivalents and the amount of DIPEA to 11.5 equivalents, only the desired allylsulfone 6r could be obtained in 43% NMR yield (Table 19, entry 4). The new conditions set up are named Method B' in the following paragraphs.




Using the newly established conditions, re-evaluation of the reactivity of aliphatic terminal alkenes **10c-10p** for the synthesis of their corresponding allylsulfones **6r-6z**, was carried out, as depicted in Scheme **113**. Allylsulfone **6r** was obtained in 40% yield from undec-1-ene **10i**. Other aliphatic allylsulfones **6s**, **6t**, **6u** and **6v** were obtained from dec-1-ene **10j**, non-1-ene **10k**, oct-1-ene **10l** and hex-1-ene **10m**, in isolated yields of 37%, 49%, 12%, and 48%, respectively. These results are similar to those observed with method A. Here again, <sup>1</sup>H NMR spectra of the crude reaction products revealed the presence of *E/Z* isomer mixtures, the former isomers being always the major ones.

Methylenecyclopentane **10n** could not be converted into the corresponding allylsulfone **6w** with Method B' and no hydroquinone by-product **11** could be formed in this case. More functionalized aliphatic alkenes such as benzylether **10c** and esters **10o** and **10p**, which gave no or trace amounts of sulfonylated products with method A or B, provided the desired allylsulfones **6x**, **6y**, and **6z** in 51%, 68 and 58% yields, respectively using method B'. In all these cases, *E/Z* mixtures were constantly obtained, with the (*E*)-isomer prevailing. This protocol, though requiring a long reaction time (4-5 days), is to date the only way to afford such allyl sulfones via allylic C–H functionalization (Scheme **113**).

The mechanism associated to the conditions in method B' is expected to contain two different, yet connected, catalytic cycles.

Coordination of the terminal alkene and the sulfoxide ligand to the palladium atom of the *in situ* formed palladium dibenzoate generates the corresponding  $\eta^3$ -allylpalladium complex via a likely CMD mechanism. Following inner sphere benzoate ligand transfer to the internal terminus of the  $\pi$ -complexed allyl fragment generates the branched allylic benzoate and a BQ-complexed Pd(0) intermediate, which regenerates palladium dibenzoate after oxidation with BQ.<sup>[1a,5a]</sup> Once the

formation of the allylic benzoate is complete, addition of DIPEA and rac-BINAP to the reaction mixture sets the stage for the second catalytic cycle. Indeed, the amine quenches the excess of benzoic acid making the corresponding salt, while the diphosphine reduces the palladium dibenzoate and complexes the thus generated Pd(0) via  $\kappa^2$ -coordination. [Erreur! Signet non défini.] After coordination of the alkene function of the allylic benzoate to the Pd(0) complex, a new, ionic,  $\eta^3$ -allylpalladium complex is formed. The latter is intercepted by the sulfinate anion, which generates the allylic sulfone product and regenerates the Pd(0) complex (Scheme 114).

## 4. Attempted optimization of the synthesis of the hydroquinone byproduct 11.

As an ancillary project, we decided to optimize the synthesis of the by-product hydroquinone **11**. This work has been performed in collaboration with Dr. Filipa Siopa and Prof. Carlos Afonso from the Faculty of Pharmacy of the University of Lisbon, in Portugal. As previous reports suggest, the conjugate addition on quinones predominantly occurs at the 3- or 5-position of the aromatic ring. [135] Despite this, there is a lack of reports on "side-chain" conjugate addition of alkyl quinones. Consequently, there is a growing interest in studying the "side-chain" functionalization of substituted quinones.

This side-chain reactivity was pioneered by the group of Smith in 1936, in the reaction between trimethyl quinone and sodium acetoacetic ester/sodium malonic ester.<sup>[136]</sup> The formation of a C-C bond on the side-chain of the quinone gave access to coumarins and coumarones. Methyl quinones were later used in Diels-Alder cycloadditions for the synthesis of polycyclic scaffolds.<sup>[137]</sup> More recently, Clift *et al.* reported the successful synthesis of benzylamines through the side-chain amination of alkyl quinones.<sup>[138]</sup> Based on this finding, we can hypothesize that in our case, a base-promoted tautomerization of the alkyl quinone resulted in the formation of a key quinone methide intermediate,

which subsequently underwent a rapid reaction with the sodium aryl sulfinic acid nucleophile to yield the desired product **11** (Scheme 115). Worthy of note, formation of C-S bonds using this strategy was reported in 1980 by Thomson and Worthington for the preparation of thioethers.<sup>[139]</sup>

#### 4.1. Optimization of the reaction conditions.

#### 4.1.1. <u>Preliminary experiments.</u>

We investigated the influence of various parameters on the reaction outcome. The reaction of 2,6-DMBQ with sodium benzenesulfinate **5a**, using DIPEA as the base and working in DMSO at 80°C, resulted in degradation products (Table 20, entries 1-2). Lowering the reaction temperature to room temperature did not yield the desired product **11** (Table 20, entry 3). Following the work of Clift, [138a] we also tested *iso*-propanol as the solvent and triethylamine as the base. However, in our case the starting material underwent decomposition (Table 20, entry 4).

We then repeated the initial reaction conditions that generated by-product **11**, to verify the reproducibility of the coupling and in the hope to find out the key parameters that favor this reaction. In fact, we predicted that not all the reagents used in the initial experiment were likely to be needed for its formation.

In the event, adding all the reaction components and reagents at the outset of the reaction, and allowing the reaction to proceed for 24 hours at 80°C, we were able to obtain the desired benzylic sulfone **11** in 48% yield (Table 21, entry 1).

To determine the essential reagents required for the formation of the desired benzylic sulfone **11**, a series of experiments were conducted, wherein the different reagents were removed one by one. Significantly, when 2,6-DMBQ (1.0 equiv.) and sodium benzenesulfinate **5a** (1.0 equiv.) were reacted in the absence of DIPEA, the formation of the desired product **11** was achieved in a yield of 10% after 24 hours (Table 21, entry 2). In the absence of *rac*-BINAP, of 1-hexene, or of palladium(II) acetate, the desired product **11** was obtained in 27%, 16%, and 18% yield respectively (Table 21, entries 3-5). Notably, when acetic acid was removed, the desired product could not be obtained (Table 21, entry 6). This result indicates that acetic acid is an essential reagent for the synthesis of the benzylic sulfone **11**.

Based on the above results, it can be hypothesized that acetic acid is an acidic catalyst for this reaction, and a possible mechanism could involve the initial AcOH promoted enolization the quinone, followed by the conjugate addition of sulfinic acid to the resulting protonated *ortho*-quinone methide (Scheme 116).

Scheme 116. A possible mechanism for this reaction.

#### 4.1.2. <u>Influence of the amount of 2,6-DMBQ and sulfinate.</u>

Additional experiments were carried out in the hope to find out the optimal reaction conditions generating by-product **11**. In particular, the reaction of 2,6-DMBQ (1.0 equiv.) and sodium

benzenesulfinate **5a** (1.0 equiv.) in the presence of acetic acid (5.0 equiv.) and DMSO as the solvent at 80°C provided the desired product **11** in 17% yield, along with disulfone **13** in 18% yield (Table 22, entry 1). Decreasing the reaction temperature to room temperature, disulfone **13** could be obtained in a higher isolated yield of 29% (Table 22, entry 2). Additionally, when acetic acid was used as the solvent, product **13** and sulfonyl hydroquinone **12** were obtained in 18% and 15% yield, respectively, without the formation of **11** (Table 22, entry 3). Increasing the amount of **5a** to 2.0 equivalents inhibited the reaction and lead to a very low yield of disulfone **13** with 2% yield (Table 22, entry 4). The reaction between 2.0 equivalents of 2,6-DMBQ and 1.0 equivalent of sodium benzenesulfinate **5a** in DMSO resulted in the targeted product **11** in 38% yield with no formation of any byproduct (Table 22, entry 5). This result is the best we had so far. Increasing the quantity of 2,6-DMBQ to 2.5 equivalents did not improve the yield of **11** and led to a slightly diminished yield of 30% (Table 22, entry 6).

#### 4.1.3. Variation of the solvent.

A screening of various reaction solvents as also carried out. THF, acetonitrile, DMF, HFIP, 1,4-dioxane and ethanol, did not provide better yields than the previously studied AcOH or DMSO (Table 23, entries 1-6). Interestingly, when water or dichloromethane was used as solvent, the byproduct 12 became the major product, with 66% and 79% yield respectively, but no desired product 11 was obtained (Table 23, entries 7-8). Therefore, DMSO was found to be the most effective solvent for this reaction.

#### 4.1.4. <u>Variation of the acid.</u>

Following the solvent screening, we further investigated the role of the acid in the reaction. We hypothesized that both Brønsted and Lewis acids could be used. Initially, we tried the reaction between 2,6-DMBQ and sodium benzenesulfinate **5a** in the presence of iron(III) chloride as the catalyst and trimethylsilyl chloride as an additive according to reported conditions. <sup>[140]</sup> Unfortunately, this reaction condition only provided the by-product **12** in 96% yield, without the formation of the desired product

11 (Table 24, entry 1). We also tested the Lewis acids copper(II) triflate and ytterbium(III) triflate, which gave the new product 14 in 31% and 46% yield respectively (Table 24, entries 2-3). When palladium(II) acetate was used as an additive and acetic acid was used as the acid, the reaction provided by-product 14 in 24% yield (Table 24, entry 4). Interestingly, the use of benzoic acid as the acid resulted in the formation of the targeted by-product 11, but in a yield of 30% (Table 24, entry 5).

In summary, the targeted by-product **11** could not be obtained in satisfactory yields, rendering further studies of limited value.

In this study, we have successfully developed and compared two distinct and effective protocols for the preparation of allylsulfones from commercially available alkenes via palladium-catalyzed allylic C–H activation. The first method is involving a direct allylic C–H sulfonylation and the second procedure is involving a one-pot sequential Pd(II)-catalyzed allylic C–H acetoxylation followed by a Pd(0)-catalyzed sulfonylation. While the direct sulfonylation protocol is more straightforward and appealing, the

sequential acetoxylation-sulfonylation protocol exhibits a broader substrate scope and often higher yields. In addition, we propose plausible mechanisms for both protocols. Further research on this topic will be worthy. As an ancillary investigation, we tried to optimize the synthesis of a sulfonyl hydroquinone by-product obtained during the coupling when using 2,6-dimethylbenzoquinone. Our findings showed that acetic acid played a crucial role in facilitating the side chain sulfonylation of 2,6-dimethylbenzoquinone. However, despite an extensive screening of the reaction conditions, we failed to improve the yield of formation of this product. Further investigation will be necessary to improve the yield of this side product.

### **General conclusion**

On the one hand, our research group has devoted over two decades to investigating the chemistry of  $\eta^3$ -allylpalladium complexes, which offers a number of ways to constructing complex molecular frameworks with atom- as well as step economy. On another hand, allylsulfones are functional groups of particular significance, serving as building blocks for many organic reactions. In the present PhD thesis, I focused my research on the discovery of new domino or C–H activation strategies involving Pd-catalysis and sulfones. In the first part of my work, I tackled a one-pot Pd-catalyzed C-S/C-C/C-C bond forming triple intermolecular allylation sequence involving allyl carbonates and benzenesulfinate salts as reaction partners (Scheme 117, top). Unfortunately, despite the good potential, the substrate scope turned out to be rather limited. As an alternative, I explored a one-step Pd-catalyzed domino sequence with allyl acetate or carbonate and sodium benzenesulfinate, but reproducibility problems appeared (Scheme 117, bottom).

The second part of this thesis is dedicated to the Pd-catalyzed synthesis of allyl sulfones starting from terminal alkenes and sulfinate anions. Specifically, two new protocols have been developed. The first one involved the direct PdX<sub>2</sub>-catalyzed allylic C-H sulfonylation, while the second consisted in a one-pot sequential process entailing a first oxidative PdX<sub>2</sub>-catalyzed allylic C-H acetoxylation, followed by a redox neutral Pd(0)-catalyzed allylic sulfonylation of the intermediate allylic acetate (Scheme 118). While the direct sulfonylation protocol is more straightforward and appealing, the sequential

acetoxylation-sulfonylation protocol offers a wider substrate scope and often achieves higher conversion rates.

Finally, I investigated a side-reaction that occurred within the latter project. Namely, the reaction between 2,6-dimethyl benzoquinone and sodium benzenesulfinate, which resulted in the formation of a sulfonyl dihydroquinone. The studies accomplished found that acetic acid was necessary to promote the side-chain sulfonylation of 2,6-dimethylbenzoquinone (Scheme 119). However, it was impossible to obtain the targeted product in a synthetically useful yield.

### **Experimental Section**

#### 1. General Remarks

**Reactions:** All reactions were carried out under an argon atmosphere by standard syringe and septa techniques. Glassware was flame-dried under vacuum or taken directly from the oven (100 °C) and let cool under vacuum prior to use. Purifications by flash column chromatography were performed using silica gel Merck Geduran® SI 60 (40-63  $\mu$ m). Yields refer to chromatographically and spectroscopically pure compounds, unless otherwise mentioned.

Reagents and solvents: Reagents and solvents were purchased from commercial sources and generally used as received. Commercially available reagents were purchased at Alfa Aesar, Acros Organics, Sigma Aldrich, TCI Chemicals and Fluorochem suppliers. Solvents were purchased at Carlo Erba. Dichloromethane and THF were dried on a Mbraun purification system MB SPS-800. Acetonitrile was dried and then distilled over calcium hydride. DMSO, methanol, propionitrile and 1,4-dioxane were purchased anhydrous, dried appropriately and kept under inert atmosphere.

**TLC:** Reactions were magnetically stirred and monitored by thin layer chromatography using Merck-Kieselgel  $60F_{254}$  plates and analyzed with either an ultra-violet lamp ( $\lambda = 254$  nm) and using potassium permanganate or *p*-anisaldehyde as a stain.

**NMR:** NMR spectra ( $^{1}$ H,  $^{13}$ C and  $^{19}$ F) were recorded on a Bruker AM 300 MHz or on a Bruker AVANCE 400 MHz spectrophotometer. NMR experiments were carried out at room temperature in CDCl<sub>3</sub>. Chemical shifts are given in parts per million (ppm) using the CDCl<sub>3</sub> residual non-deuterated signals as reference ( $^{6}$   $^{1}$ H = 7.26 ppm;  $^{6}$   $^{13}$ C = 77.16 ppm). The terms m, s, d, t and q correspond to multiplet, singulet, doublet, triplet and quartet, respectively. The term br. and app. are respectively used when the peak is broad or apparent, and in the latter case when the correct real multiplicity cannot be surely assigned. Coupling constants (J) are given in Hertz (Hz). When mixtures of diastereoisomers were found, we indicated the assignable signals to one of the diastereoisomers with the terms "major" and "minor" respectively for the major and minor diastereoisomers. For known compounds, a reference where the characterization can be found was indicated. In addition,  $^{1}$ H NMR data for these products was shown.

IR: IR spectra were recorded with a Tensor 27 (ATR Diamond) Bruker spectrophotometer and a

Spectrum Two (ATR diamond) PerkinElmer spectrometer. IR spectra were reported as characteristic bands (cm<sup>-1</sup>).

**HRMS:** High resolution mass spectra (HRMS) were obtained using a mass spectrometer MicroTOF from Bruker with an electron spray source (ESI) or an atmospheric pressure chemical ionization (APCI) source and a TOF detector at Institut Parisien de Chimie Moléculaire (FR 2769).

**Melting points:** Melting points were measured in capillary tubes on a Stuart Scientific SMP3 apparatus and are uncorrected.

# 2. Chapter 2: Towards the synthesis of conjugated trienes by a Pd-catalyzed domino process involving allylsulfones.

#### 2.1. Synthesis and characterization of starting materials

#### 2.1.1. <u>Synthesis of allyl acetates and allyl carbonates</u>

Allylic alcohols **4a**, **4b** and **4g** are commercially available. Allylic alcohols **4c** and **4d** were prepared following a slightly modified version of a reported procedure. Allylic alcohols **4e** and **4f** were reported according to reported procedures.

General procedure: Synthesis of allylic alcohols

#### **Step 1:** General procedure for the HWE olefination of aldehydes.

A round bottom flask was charged with sodium hydride (60 wt% in mineral oil, 4.0 equiv.) and the flask was placed under vacuum. It was then backfilled with argon and the vacuum/argon cycles were repeated twice. The base was suspended in dry THF (C = 1.0M) and the suspension was cooled to  $0^{\circ}$ C (ice/water bath). Trimethyl phosphonoacetate (1.2 equiv.) was added dropwise. The mixture was stirred for 10 min, and a solution of carbonyl substrate (1.0 equiv.) in THF (C = 1.0M) was added. The mixture was stirred for 15 min at  $0^{\circ}$ C, then slowly warmed to rt and stirred for an additional 2 h. The advancement of the reaction was checked by  $^{1}$ H NMR of an aliquot of the reaction mixture. The reaction was quenched by addition of a saturated aqueous solution of ammonium chloride (2 mL/mmol of limiting reagent) and ethyl acetate (5 mL/mmol of limiting reagent) was added. The biphasic mixture was separated and the aqueous layer was extracted with ethyl acetate (3 x 3 mL/mmol of limiting reagent). The combined organic layers were dried over anhydrous magnesium sulfate, filtered and the filtrate was concentrated under reduced pressure. The crude product was purified by silica-gel column chromatography to give desired product.

#### Methyl trans-3,4-dimethoxycinnamate (3c)

Prepared from trimethyl phosphonoacetate (16.0 mL, 96.0 mmol, 2.5 equiv.), 3,4-dimethoxybenzaldehyde (13.7 g, 80.0 mmol, 1.2 equiv.) and sodium hydride (4.4 g, 110 mmol, 60 wt% in paraffin oil, 1.4 equiv.) in 200 mL of dry THF. After workup, and purification by flash column chromatography on silica gel (cyclohexane/ethyl acetate 1:2), the methyl *trans*-3,4-dimethoxycinnamate **3c** was obtained as a yellowish oil (18.3 g, quantitative yield). The characterization data are in accordance with the ones reported in the literature. [143]

#### Methyl (2E)-3-(1-naphthalenyl)-2-propenoate (3d)

Prepared from trimethyl phosphonoacetate (16.0 mL, 24.0 mmol, 1.2 equiv.), 1-naphthalenecarboxaldehyde (13.7 g, 20.0 mmol, 1.0 equiv.) and sodium hydride (960 mg, 24.0 mmol, 60 wt% in paraffin oil, 1.2 equiv.) in 100 mL of dry THF. After workup, and purification by flash column chromatography on silica gel (cyclohexane/ethyl acetate 2:1), methyl (2*E*)-3-(1-naphthalenyl)-2-propenoate **3d** was obtained as a yellowish oil (4.24 g, quantitative yield). The characterization data are in accordance with the ones reported in the literature.<sup>[144]</sup>

#### **Step 2:** General procedure for the reduction of the $\alpha$ , $\beta$ -unsaturated ester.

A round bottom flask was charged with the  $\alpha$ , $\beta$ -unsaturated ester (1.0 equiv.) and the flask was placed under vacuum. It was then backfilled with argon and the vacuum/argon cycles were repeated twice. The ester was dissolved in dry dichloromethane (C = 0.2M) and at the solution was cooled to 0°C. To this cold solution was added dropwise DIBAL-H (1.5-2.5 equiv., 1.0-1.2M in toluene). After stirring for 1 h at 0°C, the reaction mixture was warmed to rt. The reaction mixture was stirred until complete conversion of the ester as observed by TLC. The reaction was slowly quenched with a saturated aqueous solution of Rochelle salt and diluted with water. The biphasic mixture was separated and the aqueous layer was extracted three times with dichloromethane. The combined organic layers were dried with anhydrous magnesium sulfate and filtered. The filtrate was concentrated under reduced pressure. The crude product was purified by silica-gel column chromatography to give the desired allylic alcohol.

#### Synthesis of 3-methylbut-2-en-1-ol (4e)

To a solution of 3-methylcrotonaldehyde (2.89 mL, 30.0 mmol, 1.0 equiv.) in 30 mL of a 1:1 v/v mixture of methanol and THF was added sodium borohydride (1.24 g, 33.0 mmol, 1.1 equiv.) over a 10 min period of time at 0°C (ice/water bath). The reaction mixture was stirred until complete conversion of 3-methylcrotonaldehyde as seen by TLC (20 min). The reaction was then quenched by the addition of 50 mL of ice-cold brine and organoaqueous mixture was extracted with diethyl ether (3 x 50 mL). The combined organic layers were washed with brine, dried with MgSO<sub>4</sub> and filtered. The filtrate was concentrated under reduced pressure. The crude mixture was purified by flash column chromatography on silica gel (cyclohexane/ethyl acetate 10:1) to give 3-methylbut-2-en-1-ol **4e** as a colorless oil (1.10 g, 39% yield). The characterization data are in accordance with the ones reported in the literature. [147]

To a solution of cyclohexenone (960 mg, 10.0 mmol, 1.0 equiv.) and cerium(III) chloride heptahydrate (3.72 g, 10.0 mmol, 1.0 equiv.) in 10 mL of methanol was added sodium borohydride (570 mg, 15.0 mmol, 1.5 equiv.) portionswise over a 10 min period of time. The reaction mixture was stirred for 3 h at rt. When conversion of cyclohexanone was complete, as checked by TLC, the reaction mixture was quenched with 10 mL of water and the organoaqueous layer was extracted with diethyl ether ( $3 \times 10$ )

mL). The combined organic layers were washed with water, dried with anhydrous magnesium sulfate and filtered. The filtrate was concentrated under reduced pressure. The crude mixture was purified by flash column chromatography on silica gel (cyclohexane/ethyl acetate 1:1) to give 2-cyclohexen-1-ol **4f** as a colorless oil (0.91 g, 92% yield). The characterization data are in accordance with the ones reported in the literature.<sup>[148]</sup>

#### 2.1.2. Synthesis of cinnamyl acetate (1a).

Cinnamyl acetate **1a** was prepared following a reported procedure. [149] Allyl acetate **1b** is commercially available.

A round bottom flask was charged with cinnamyl alcohol ( $6.50\,\mathrm{mL}$ ,  $50.0\,\mathrm{mmol}$ ) and the flask was placed under vacuum before being backfilled with argon. The vacuum/argon cycles were repeated twice and the alcohol was dissolved in 10 mL of dry dichloromethane. The mixture was cooled to 0°C (ice/water bath) and acetic anhydride ( $16.0\,\mathrm{mL}$ ,  $170\,\mathrm{mmol}$ ,  $3.4\,\mathrm{equiv.}$ ) and pyridine ( $13.5\,\mathrm{mL}$ ,  $170\,\mathrm{mmol}$ ,  $3.4\,\mathrm{equiv.}$ ) were successively added dropwise. The mixture was warmed at rt and stirred at this temperature until starting material was fully consumed, as checked by TLC (18h). The reaction mixture was hydrolyzed with  $100\,\mathrm{mL}$  of water and the biphasic mixture was separated. The aqueous layer was extracted with dichloromethane ( $2\times100\,\mathrm{mL}$ ). The combined organic layers were washed with  $100\,\mathrm{mL}$  of brine, dried over anhydrous magnesium sulfate and filtered. The filtrate was concentrated under reduced pressure. The crude mixture was purified by flash column chromatography (cyclohexane/ethyl acetate 9:1) to give trans-cinnamyl acetate 1a as a colorless liquid ( $7.61\,\mathrm{g}$ , 86% yield). #### 2.1.3. Synthesis of allyl carbonates and carbamates

Allyl methyl carbonates were prepared following a reported procedure.<sup>[150]</sup> Allyl methyl carbonate **2g** and diallyl carbonate **2h** are commercially available.

A round bottom flask was charged with the allylic alcohol (1.0 equiv.) and the flask was placed under vacuum before being backfilled with argon. The vacuum/argon cycles were repeated twice and the allylic alcohol was dissolved in dry dichloromethane (C = 0.2M). The flask was cooled to 0°C (ice/water bath) and to this cold solution was successively introduced dropwise pyridine (3.0 equiv.) and methyl chloroformate (3.0 equiv.). The resulting suspension was warmed to rt. Upon complete consumption of the starting material, as checked by TLC, the reaction mixture was quenched by addition of water and stirred vigorously for at least 15 min. The biphasic mixture was separated. The organic layer was washed twice with a 1M aqueous solution of hydrochloric acid and once with a saturated solution of sodium bicarbonate. The resulting organic layer was dried over anhydrous magnesium sulfate and filtered. The filtrate was concentrated under reduced pressure. The crude mixture was then purified by silica gel chromatography to give the desired allyl carbonates.

#### Synthesis of allyl *N*,*N*-di-*iso*-propylcarbamate (2i)

Allyl *N,N*-di-*iso*-propyl carbamate **2i** was prepared according to a procedure reported in the literature.<sup>[153]</sup>

A round bottom flask was charged with allyl alcohol (0.38 mL, 4.80 mmol, 1.2 equiv.) and 4-DMAP (4.00 mg, 0.48 mmol, 12 mol%). The flask was placed under vacuum and backfilled with argon. The vacuum/argon cycles were repeated twice and pyridine (0.50 mL, 6.00 mmol, 1.5 equiv.) was added. *N,N*-di-*iso*-propyl carbamoyl chloride (655 mg, 4.00 mmol, 1.0 equiv.) was then introduced in one portion at rt and the mixture was heated to 100°C. After complete conversion as checked by TLC, the mixture was cooled to rt and quenched with 12 mL of an aqueous 1M solution of hydrochloric acid. The organoaqueous layer was extracted with 2 x 16 mL of ethyl acetate. The resulting organic layer was washed with 2x16 mL of water, dried over anhydrous magnesium sulfate and filtered. The filtrate was

#### Synthesis of allyl tert-butyl carbonate (2j)

Allyl tert-butyl carbonate 2j was prepared according to a procedure reported in the literature. [154]

A two-neck round bottom flask equipped with a reflux condenser was charged with di-*tert*-butyl dicarbonate (10.0 g, 47.5 mmol, 1.0 equiv.). The flask was placed under vacuum and then backfilled with argon. The vacuum/argon cycles were repeated twice and allylic alcohol (10.0 mL, 147 mmol, 3.2 equiv.) was added. 4-DMAP (275 mg, 2.25 mmol, 5 mol%) was then introduced in one portion. Gas evolution started and lasted for about 1h. The reaction mixture was stirred at rt until conversion was found to be complete as checked by TLC. The crude mixture was directly purified by flash column chromatography on silica gel (cyclohexane/ethyl acetate 95:5) to give allyl *tert*-butyl carbonate **2j** (4.58 g, 61% yield) as a colorless oil. ### 2.2. Pd(0)-catalyzed domino sulfonylation/allylation of allylacetates and - carbonates.

### 2.2.1. Studies on the sulfonylation and $\alpha$ -allylation of the domino sequence. General procedure for the synthesis of cinnamyl sulfones

A sealed tube equipped with a stirring bar was charged with  $Pd_2dba_3$  (22.9 mg, 2.50 x  $10^{-2}$  mmol, 5 mol%), dppe (39.8 mg, 0.10 mmol, 20 mol%) and sodium benzenesulfinate **5a** (0.50-0.55 mmol, 1.0-1.1 equiv.). The tube was placed under vacuum and then backfilled with argon. The vacuum/argon cycles were repeated twice and 2 to 5 mL of distilled THF (0.10-0.25M) was introduced. To this suspension was introduced cinnamyl acetate **1a** or (*E*)-3-(3,4-dimethoxyphenyl)allyl methyl carbonate **2c** (0.50 mmol, 1.0 equiv.) and the mixture was stirred at 65°C until conversion was complete as checked by TLC. After cooling to rt, the mixture was filtered over a pad of silica gel with 50 mL of ethyl acetate. The filtrate was concentrated under reduced pressure and the residue was purified by flash column chromatography on silica gel to give the desired product.

#### General procedure for the $\alpha$ -allylation of allyl sulfones

A sealed tube equipped with a stirring bar was charged with  $Pd_2dba_3$  (22.9 mg, 2.50 x  $10^{-2}$  mmol, 5 mol%), dppe (39.8 mg, 0.10 mmol, 20 mol%) and the allylic sulfone **6a** or **6b** (0.50 mmol, 1.0 equiv.). The tube was placed under vacuum and then backfilled with argon. The vacuum/argon cycles were repeated twice and 5 mL of distilled THF (0.1M) was introduced. To this suspension was added 110  $\mu$ L of allyl methyl carbonate **2g** (1.00 mmol, 2.0 equiv.) and the mixture was stirred at 65°C until conversion was complete as checked by TLC. The mixture was filtered over a pad of silica gel with 50 mL of ethyl acetate. The filtrate was concentrated under reduced pressure and the residue was purified by flash column chromatography on silica gel to give the desired products.

After workup, the crude mixture was purified by flash column chromatography (cyclohexane/ethyl acetate 4:1) to give *1,2-dimethoxy-4-((1E,5E)-6-phenyl-3-(phenylsulfonyl)hexa-1,5-dien-1-yl)benzene* **7c** as a colorless liquid (149.8 mg, 69% yield).

#### 2-dimethoxy-4-((5*E*)-6-phenylhexa-1,3,5-trien-1-yl)benzene (9b)

2-dimethoxy-4-((5*E*)-6-phenylhexa-1,3,5-trien-1-yl)benzene **9b** was prepared according to a procedure reported in the literature.<sup>[95]</sup>

A round bottom flask was charged with 7c (217.1 mg, 0.5 mmol, 1.0 equiv.) and KOH (42.1 mg, 0.75

mmol, 1.5 equiv.). The flask was placed under vacuum and backfilled with argon. The vacuum/argon cycles were repeated twice and toluene (7 mL) was then introduced in one portion at rt. *Tert*-butanol (1.00 mL, 10.0 mmol, 20.0 equiv.) and ethanol (0.60 mL, 10.0 mmol, 20.0 equiv.) were then added and the mixture was heated at 80°C. After complete conversion as checked by TLC, the mixture was cooled to rt and most of solvent was removed under reduced pressure. The residue was dissolved in ethyl acetate and washed with a 1 M aqueous hydrochloric acid solution. The aqueous layer was extracted with ethyl acetate (15 mL x 4). The combined organic layers were dried over anhydrous magnesium sulfate and filtered. The filtrate was concentrated under reduced pressure and the residue was purified by flash column chromatography (cyclohexane/ethyl acetate 50:1) to give *2-dimethoxy-4-((5E)-6-phenylhexa-1,3,5-trien-1-yl)benzene* **9b** (7.3 mg, 5%) as a colorless oil.

# 2.2.3. <u>Synthesis and characterization of diallylated allylsulfones</u> General procedure for the Pd(0)-catalyzed triple allylation domino sequence

A sealed tube equipped with a stirring bar was charged with  $Pd_2dba_3$  (22.9 mg, 2.50 x  $10^{-2}$  mmol, 5 mol%), dppe (39.8 mg, 0.10 mmol, 20 mol%) and sodium benzenesulfinate **5a** (82.1 mg, 0.50 mmol, 1.0 equiv.). The tube was placed under vacuum and then backfilled with argon. The vacuum/argon cycles were repeated twice and 5 mL of distilled THF (0.1 M) was introduced. To this suspension was added the first allyl carbonate (1.00 mmol, 2.0 equiv.) and the mixture was stirred at 65°C until conversion was complete as checked by TLC. The mixture was cooled to rt and the second allyl carbonate (1.00 mmol, 2.0 equiv.) was introduced followed by BSA (145  $\mu$ L, 0.60 mmol, 1.2 equiv.) and

potassium acetate (4.50 mg, 0.05 mmol, 10 mol%). The mixture was stirred at 65°C until conversion of the allylsulfone intermediate was complete as checked by TLC. The mixture was filtered over a pad of silica gel with 50 mL of ethyl acetate. The filtrate was concentrated under reduced pressure and the residue was purified by flash column chromatography on silica gel to give the desired products.

# 2.2.4. <u>Description of the kinetic study and characterization of the products</u> obtained from the pure domino sequence.

A sealed tube equipped with a magnetic stirrer was charged with 9.2 mg (0.01 mmol, 5 mol%) of  $Pd_2(dba)_3$ , 15.9 mg (0.04 mmol, 20 mol%) of dppe, 1.8 mg (0.02 mmol, 10 mol%) of AcOK, 16.4 mg (0.20 mmol, 1.0 equiv.) of sodium benzenesulfinate **5a** and 8.4 mg (0.05 mmol, 0.5 equiv.) of 1,4-dinitrobenzene. The tube was placed under vacuum and then backfilled with argon. The vacuum/argon cycles were repeated twice and 2.0 mL of dry THF-d<sup>8</sup> (0.1 M) were introduced. To this suspension was added allyl methyl carbonate or acetate **2g** or **1b** (0.8 mmol, 4.0 equiv.) followed by BSA (59  $\mu$ L, 0.24 mmol, 1.2 equiv.) and the mixture was stirred at 65°C. The progress of the reaction was monitored every hour by quantitative <sup>1</sup>H NMR using the 1,4-dinitrobenzene introduced as an internal standard.

In addition, for their characterization, allylated products resulting from the pure domino sequence were isolated and characterized. Allyl phenyl sulfone is commercially available and its detection on <sup>1</sup>H NMR could be done by comparison with a <sup>1</sup>H NMR of a commercial sample.

# 3. Chapter 4: Synthesis of allylsulfones by palladium-catalyzed allylic C-H activation

# 3.1. Synthesis and characterization of starting materials.

### 3.1.1. Synthesis of sodium sulfinates.

Langlois' reagent (sodium trifluoromethanesulfinate) **5n** and sulfinates **5a** and **5b** were purchased from commercial sources. Sodium sulfinates were prepared according to a procedure reported in the literature.<sup>[158]</sup>

#### General procedure for the synthesis of sodium sulfinates.

A round bottomed flask equipped with a magnetic stirring bar was charged with 5.04 g (40.0 mmol, 2.0 equiv.) of sodium sulfite, 3.36 g (40.0 mmol, 2.0 equiv.) of sodium bicarbonate, the sulfonyl chloride (20.0 mmol, 1.0 equiv.) and 20 mL of water. The flask was then equipped with a condenser and the reaction mixture was heated to 80°C for 4h. The crude mixture was then cooled to rt and the solvent was concentrated under reduced pressure. The resulting residue was suspended in 25 mL of ethanol and the suspension was filtered over Büchner. The solid was washed with 25 mL of ethanol. The filtrate was then concentrated under reduced pressure to give the desired sulfinates.

#### Sodium 4-methoxybenzene sulfinate (5c).

Prepared from 4-methoxybenzenesulfonyl chloride (4.13 g, 20.0 mmol), sodium sulfite (5.04 g, 40.0 mmol) and sodium bicarbonate (3.36 g, 40.0 mmol) in 20 mL of water. After workup, sodium 4-

# 3.1.2. Synthesis of terminal alkenes

#### Synthesis of O-benzyleugenol (10a).

O-benzyleugenol **10a** was prepared according to a procedure reported in the literature. [161] A round bottom flask was charged with 1.64 g (10.0 mmol, 1.0 equiv.) of eugenol. The flask was placed under vacuum before being backfilled with argon. The vacuum/argon cycles were repeated twice and 20 mL of anhydrous DMF were introduced. The solution was cooled down to 0°C (ice/water bath) and 288 mg (12.0 mmol, 1.2 equiv., 60 wt% in paraffin oil) of sodium hydride was added portionswise. The suspension was stirred at 0°C until gas evolution stopped and 2.05 g (12.0 mmol, 1.2 equiv.) of benzyl bromide were then introduced dropwise. The resulting mixture was stirred until conversion was complete as checked by TLC. Then the reaction was quenched by a slow addition of saturated aqueous NH<sub>4</sub>Cl (50 mL) and then ethyl acetate (50 mL). The organic layer was collected, and the aqueous layer was extracted with ethyl acetate (3×50 mL). The combined extracts were washed with water (4×50 mL), brine (40 mL), dried over MgSO<sub>4</sub> and concentrated under reduced pressure. The residue was purified by flash column chromatography on silica gel (Cyclohexane/ethyl acetate 1:0 then 8:2), *O*-benzyleugenol **10a** was obtained as a yellowish oil (1.05 g, 41% yield). The characterization data is in accordance with the ones reported in the literature. [162]

1-allyl-2-benzyloxybenzene **10b** was prepared according to a procedure reported in the literature. [161]

A round bottom flask was charged with 1.13 g (10.0 mmol, 1.0 equiv.) of 2-allylphenol. The flask was placed under vacuum before being backfilled with argon. The vacuum/argon cycles were repeated twice and 20 mL of anhydrous DMF were introduced. The solution was cooled down to 0°C (ice/water bath) and 288 mg (12.0 mmol, 1.2 equiv., 60 wt% in paraffin oil) of sodium hydride was added portionswise. The suspension was stirred at 0°C until gas evolution stopped and 2.05 g (12.0 mmol, 1.2 equiv.) of benzyl bromide were then introduced dropwise. The resulting mixture was stirred until conversion was complete as checked by TLC. Then the reaction was quenched by a slow addition of saturated aqueous NH<sub>4</sub>Cl (50 mL) and then ethyl acetate (50 mL). The organic layer was collected and the aqueous layer was extracted with ethyl acetate (3×50 mL). The combined extracts were washed with water (4×50 mL), brine (40 mL) and dried over anhydrous MgSO<sub>4</sub> and concentrated under reduced pressure. The residue was purified by flash column chromatography on silica gel (Cyclohexane/ethyl acetate 1:0 then 9:1) to give 1-allyl-2-benzyloxybenzene 10b as a yellowish oil (762 mg, 34% yield). #### Synthesis of 6-benzyloxyhex-1-ene (10c)

6-benzyloxyhex-1-ene **10c** was prepared according to a procedure reported in the literature. <sup>[164]</sup> To a suspension of 360 mg of NaH (15.0 mmol, 1.5 equiv., 60%wt% in paraffin oil,) in distilled THF (10 mL) at 0 °C was added a solution of 5-hexen-1-ol (1.2 mL, 10.0 mmol, 1.0 equiv.) in distilled THF (10 mL) *via* cannula. After 5 min, 1.28 mL of benzyl bromide (10.7 mmol, 1.07 equiv.) was added and the reaction mixture allowed to warm to RT. The resulting mixture was stirred until conversion was complete as checked by TLC. The reaction mixture was quenched by slow addition of methanol (2 mL), followed by

addition of a saturated aqueous solution of ammonium chloride (10 mL). The biphasic mixture was separated and the aqueous layer was extracted with  $Et_2O$  (3 × 50 mL). An ace pressure tube equipped with a magnetic stirrer was charged with 15.2 mg (0.05 mmol, 10 mol%) of palladium(II) acetylacetonate, 136 mg (1.00 mmol, 2.0 equiv.) of 2,6-dimethyl-1,4-benzoquinone and the sulfinate 5a-5j (1.00 mmol, 2.0 equiv.). The tube was placed under vacuum and then backfilled with argon. The vacuum/argon cycles were repeated twice and 0.75 mL of distilled acetonitrile (0.66 M) was introduced. To this suspension was introduced the alkene 10a-10o (0.50 mmol, 1.0 equiv.) and the mixture was heated to 80 °C under stirring until conversion was complete as checked by TLC. The mixture was then cooled to rt and filtered over a pad of silica gel with 50 mL of ethyl acetate. The filtrate was concentrated under reduced pressure and the residue was purified by flash column chromatography on silica gel to give the desired products.

#### General procedure for one-pot sequential allylic C-H sulfonylation of alkenes (method B):

An ace pressure tube equipped with a magnetic stirrer was charged with 11.2 mg (0.05 mmol, 10 mol%) of palladium(II) acetate, 136.2 mg (1.00 mmol, 2.0 equiv.) of 2,6-dimethylbenzo-1,4-quinone and 50 mg of 4 Å molecular sieves. The solids were suspended in 1.5 mL of anhydrous DMSO and 0.29 mL (5.00 mmol, 10.0 equiv.) of acetic acid was introduced followed by the alkene 10a-10h (0.50 mmol, 1.0 equiv.). The mixture was heated to  $80 ^{\circ}\text{C}$  until complete conversion of the alkene was reached as checked by TLC. The mixture was cooled to rt and 62.0 mg (0.10 mmol, 20 mol%) of rac-BINAP followed by 1.0 mL (7.25 mmol, 11.5 equiv.) of N, N-diisopropylethylamine were added to the reaction mixture. The sulfinate 5a-5k (1.00 mmol, 2.0 equiv.) was then introduced and the ace pressure tube was closed. The reaction mixture was then heated to  $80 ^{\circ}\text{C}$  until complete conversion of the intermediate allylacetate was seen by TLC. The mixture was then cooled to rt and filtered over a pad of silica gel with 50 mL of ethyl acetate to remove the salts. The filtrate was placed into a separatory funnel and washed with 50 mL of water. The aqueous layer was extracted with  $2 \times 20 \text{ mL}$  of ethyl acetate. The combined organic layers were dried over anhydrous MgSO<sub>4</sub> and filtered. The filtrate was concentrated under reduced pressure and the residue was purified by flash column chromatography on silica gel to give the desired products.

General procedure for one-pot sequential allylic C-H sulfonylation of aliphatic terminal alkenes (method B'):

An ace pressure tube equipped with a magnetic stirrer was charged with 4.5 mg (0.02 mmol, 10 mol%) of palladium(II) acetate,  $2.7 \mu L$  (0.02 mmol, 10 mol%) of phenylvinylsulfoxide and 43.3 mg (0.4 mmol, 2.0 equiv.) of 1,4-benzoquinone. The solids were suspended in 0.6 mL of anhydrous 1,4-dioxane and

244.2 mg (2.00 mmol, 10.0 equiv.) of benzoic acid was introduced followed by the alkene **10c-10p** (0.2 mmol, 1.0 equiv.). The mixture was heated to 43°C until complete conversion of the alkene was reached as checked by TLC or ¹H NMR (usually 66–72 h). The mixture was cooled to rt and 25.0 mg (0.04 mmol, 20 mol%) of *rac*-BINAP followed by 0.4 mL (2.30 mmol, 11.5 equiv.) of *N*, *N*-diisopropylethylamine were added to the reaction mixture. To this mixture was introduced 65.4 mg (0.40 mmol, 2.0 equiv.) of sodium benzenesulfinate **5a** and the sealed tube was closed. The reaction mixture was then heated to 80°C until complete conversion of the intermediate allylbenzoate was seen by TLC. The mixture was then cooled to rt and filtered over a pad of silica gel with 25 mL of ethyl acetate to remove the salts. The filtrate was concentrated under reduced pressure and the residue was purified by flash column chromatography on silica gel to give the desired products.

#### trans-Cinnamylphenyl sulfone (6a).

Prepared according to **method A** from sodium benzene sulfinate **5a** (164 mg, 1.00 mmol) and allylbenzene **10d** (59.1 mg, 0.50 mmol). After workup, the crude mixture was purified by flash column chromatography (cyclohexane/ethyl acetate 5:1) to give *trans*-cinnamylphenyl sulfone **6a** as a colorless solid (74.8 mg, 58% yield).

Prepared according to **method B** from sodium benzene sulfinate **5a** (164 mg, 1.00 mmol) and allylbenzene **10d** (59.1 mg, 0.50 mmol). # 3.3. Studies on the synthesis of the hydroquinone byproduct **11**.


#### 3.3.1. Side-chain Sulfonylation of 2,6-dimethyl-1,4-benzoquinone

A sealed tube equipped with a magnetic stirring bar was charged with 27.6 mg (0.20 mmol, 1.0 equiv.) of 2,6-dimethyl-1,4-benzoquinone, 9.2 mg (0.01 mmol, 5 mol%) of palladium(II) acetate, 15.9 mg (0.04 mmol, 20 mol%) of *rac*-BINAP, 8.4 mg (0.10 mmol, 0.5 equiv.) of 1-hexene, 23.0 mg of 4Å MS and 32.8 mg (0.20 mmol, 1.0 equiv.) of sodium benzenesulfinate **5a**. The tube was placed under vacuum and then backfilled with argon. The vacuum/argon cycles were repeated twice and 0.3 mL of DMSO (0.66

M),  $58 \,\mu\text{L}$  (1.00 mmol,  $5.0 \,\text{equiv.}$ ) of AcOH and  $200 \,\mu\text{L}$  (1.15 mmol,  $5.75 \,\text{equiv.}$ ) of DIPEA was introduced. The mixture was stirred at  $80 \,^{\circ}\text{C}$  until conversion was complete as checked by TLC. The reaction was quenched by addition of a saturated aqueous sodium bicarbonate (3 mL) and then diluted with ethyl acetate (5 mL). The layers were separated and the aqueous layer was extracted with ethyl acetate (3 x 10 mL). The combined organic layers were dried over anhydrous magnesium sulfate, filtered and the filtrate was concentrated under reduced pressure. The crude product was purified by flash column chromatography (cyclohexane/ethyl acetate 2:1) to give *2-methyl-6-((phenylsulfonyl)methyl)benzene-1,4-diol* **11** as a yellow solid (26.7 mg, 48% yield).

# 3.3.2. Reductive sulfonylation of 2,6-DMBQ on the endocyclic position.

A sealed tube equipped with a magnetic stirring bar was charged with 27.6 mg (0.20 mmol, 1.0 equiv.) of 2,6-dimethyl-1,4-benzoquinone, 6.5 mg (0.04 mmol, 20 mol%) of iron(III) chloride and 49.2 mg of sodium benzenesulfinate  $\bf 5a$  (0.30 mmol, 1.5 equiv.). The tube was placed under vacuum and then backfilled with argon. The vacuum/argon cycles were repeated twice and 0.3 mL of distilled dichloromethane (0.66 M) followed by 30  $\mu$ L of chlorotrimethylsilane (0.24 mmol, 1.2 equiv.) were introduced. The mixture was stirred at room temperature until conversion was complete as checked by TLC. The reaction was quenched by addition of a saturated aqueous solution of sodium bicarbonate (3 mL) and diluted with ethyl acetate (5 mL). The layers were separated and the aqueous layer was extracted with ethyl acetate (3 x 10 mL). The combined organic layers were dried over anhydrous magnesium sulfate and filtered. The filtrate was concentrated under reduced pressure. The crude product was purified by flash column chromatography (cyclohexane/ethyl acetate 3:1) to give 3,5-dimethyl-2-(phenylsulfonyl)benzene-1,4-diol  $\bf 12$  as a yellow solid (36.2 mg, 65% yield). The characterization data are in accordance with the ones reported in the literature.  $\bf 100$

# 3.3.3. <u>Bis-sulfonylation of 2,6-DMBQ.</u>

A sealed tube equipped with a magnetic stirring bar was charged with 27.6 mg (0.20 mmol, 1.0 equiv.) of 2,6-dimethyl-1,4-benzoquinone, 32.8 mg (0.20 mmol, 1.0 equiv.) of sodium benzenesulfinate **5a**. The tube was placed under vacuum and then backfilled with argon. The vacuum/argon cycles were repeated twice and 0.3 mL of DMSO (0.66 M) followed by 58 µL (1.00 mmol, 5.0 equiv.) of acetic acid were introduced. The mixture was stirred at room temperature until conversion was complete as checked by TLC. The mixture was filtered over a pad of silica gel with 25 mL of ethyl acetate. The filtrate was concentrated under reduced pressure and the residue was purified by flash column chromatography (cyclohexane/ethyl acetate 1:1) to give *3-methyl-2-(phenylsulfonyl)-5-((phenylsulfonyl)methyl)benzene-1,4-diol* **13** as a yellow solid (24.2 mg, 29% yield).

# 3.3.4. O-Sulfonylation of 2,6-DMBQ.

A sealed tube equipped with a magnetic stirring bar was charged with 55.2 mg (0.40 mmol, 2.0 equiv.) of 2,6-dimethyl-1,4-benzoquinone, 24.8 mg (0.04 mmol, 20 mol%) of ytterbium(III) triflate and 32.8 mg of sodium benzenesulfinate **5a** (0.20 mmol, 1.0 equiv.). The tube was placed under vacuum and then backfilled with argon. The vacuum/argon cycles were repeated twice and 0.3 mL of dry DMSO (0.66 M) was introduced. The mixture was stirred at 80°C until conversion was complete as checked by TLC. The mixture was filtered over a pad of silica gel with 25 mL of ethyl acetate. The filtrate was concentrated under reduced pressure and the residue was purified by flash column chromatography (cyclohexane/ethyl acetate 5:1) to give *4-hydroxy-3,5-dimethylphenyl benzenesulfonate* **14** as a yellow solid (10.6 mg, 19% yield).

# Allylsulfones through Palladium-Catalyzed Allylic C—H Sulfonylation of Terminal Alkenes

Two previously unknown protocols for Pd-catalyzed allylic C–H sulfonylation of terminal alkenes have been developed. While the former consists of a direct Pd(II)-catalyzed oxidative C–H allylic sulfonylation in the presence of sulfinate anions, the

latter involves a sequential one-pot Pd(II)-catalyzed C–H allylic acetoxylation followed by a Pd(0)-catalyzed sulfonylation. The scope of both protocols was studied on 25 examples.

#### Introduction

Organosulfur compounds represent an important class of molecules that play a key role in a number of organic reactions, and find applications in various fields of chemistry. In particular, the relevance and versatility of sulfones<sup>[1]</sup> is so high that B. M. Trost<sup>[2]</sup> defined them as chemical *chameleons*, and P. L. Fuchs<sup>[3]</sup> as *pluripotent*. In addition, sulfones are intermediates in synthetically relevant reactions such as the Julia-Lythgoe olefination, the modified Julia,<sup>[4]</sup> and the Julia-Kociensky olefination,<sup>[5]</sup> the Ramberg-Bäcklund reaction,<sup>[6]</sup> as well as a number of other desulfonylative transformations.<sup>[7]</sup>

In the course of a project directed toward the synthesis of conjugated polyenes, we became interested in the preparation of allylsulfones. The classic way to access these compounds involves the coupling between substrates bearing an allylic leaving group (LG) and sulfinate anions. [8,9] This well-known strategy (Scheme 1, equation 1), although normally effective, often implies several synthetic steps, as the required allylic precursors are not always commercially available. Conversely, the direct C–H sulfonylation of alkenes, which, thanks to its step-economy and the abundance of the alkenes would represent a much more elegant access to allylsulfones, has

been so far reported only for the very restricted case of  $\alpha$ -methylstyrenes (Scheme 1, equation 2).<sup>[10]</sup>

Considering the recent studies by us and others on the Pdcatalyzed allylic C–H activation of alkenes to form C–O,<sup>[11]</sup> C–N<sup>[12]</sup> and C–C bonds (Scheme 1, equation 3),<sup>[13]</sup> we decided to investigate the direct C–H sulfonylation of terminal alkenes.<sup>[14]</sup>

We describe in this article the development of two protocols of Pd-catalyzed direct C–H sulfonylation of terminal alkenes (Scheme 1, equation 4).

#### **Results and Discussion**

We started our study choosing for our model reaction the coupling between allylbenzene ( $1\,a$ ) and sodium p-toluenesulfinate ( $2\,a$ ). Gratifyingly, reacting  $1\,a$  ( $1.0\,$  equiv.) with  $2\,a$  ( $2.0\,$  equiv.) in the presence of palladium acetate ( $10\,$  mol%) and 2,6-dimethylbenzoquinone (2,6-DMBQ) ( $2.0\,$  equiv.) as the terminal oxidant, in freshly distilled acetonitrile ( $0.2\,$ M), at  $80\,$ °C under argon, gave after  $72\,$ h of reaction the expected allylsulfone  $3\,$ aa in  $42\,$ % yield (Table 1, entry 1). Performing the reaction under aerobic conditions led to the same result.

We then studied the influence of several parameters on the outcome of the reaction. A screening of polar solvents (propionitrile, DMF, DMSO, THF, 1,4-dioxane, MTBE, HFIP) showed that none of them gave a better yield than acetonitrile (Table 1, entries 2-8). With propionitrile, a similar result was obtained when the reaction was performed at 110°C (Table 1, entry 2, note c). Suspecting that the moderate yield and the long reaction time could be due to a poor solubility of the sulfinate salt in acetonitrile, we tested methanol as a cosolvent. However, performing the reaction in CH<sub>3</sub>CN/MeOH 4:1 v/v gave a poor yield of 29% (Table 1, entry 9). We next investigated the influence of the oxidant while keeping acetonitrile as the solvent. The use of other quinones such as benzoquinone (BO). 2,3-dichloro-5,6-dicyano-1,4-benzoquinone (DDQ), duroquinone (DQ) and 2,5-dimethyl-1,4-benzoquinone (2,5-DMBQ) proved to be unfruitful (Table 1, entries 10-13).[15] We thus decided to keep 2,6-DMBQ as the oxidant and screened other palladium(II) sources. However, except for palladium(II) acetylacetonate, which gave results similar to palladium(II) acetate (Table 1, entry 16), none of the other catalysts provided better yields (Table 1, entries 14-18). We finally decided to retain palladium(II) acetylacetonate, as some reproducibility problems were encountered with palladium(II) acetate due to the variable purity of commercial batches. The use of ancillary ligands was also evaluated. However, none of those tested (bis-sulfoxide, pyridine-type, phenanthroline, pyridones, *N*-acetyl amino acids) gave allylsulfone **3 aa** with a better yield than without ligands (See Supporting Information). Finally, changing the concentration of the reaction to 0.66 M increased slightly the yield of **3 aa** to 47 % (Table 1, entry 19).

With the optimized reaction conditions in hand (Method A), the scope of the reaction was then evaluated, starting with the couplings between allylbenzene 1a and various sulfinates (Scheme 3). Electron-rich p-toluene-, phenyl- and 4-methoxyphenylsulfinates 2a, 2b and 2c provided the corresponding allylsulfones 3 aa, 3 ab and 3 ac in 47%, 58% and 41% isolated yield. Sodium  $\alpha$ -naphthylsulfinate gave only degradation products. Electron-poor arylsulfinates reacted too, although their coupling was much more sluggish. For example, only 57% conversion was measured by quantitative <sup>1</sup>H NMR analysis after 72 h of reaction of sodium 4-nitrobenzenesulfinate 2f. Nevertheless, the desired allylsulfones 3 ae and 3 af could be obtained with 11% yield and 37% yield, respectively. Sodium 4bromophenylsulfinate 2g gave the corresponding allylsulfone 3 ag with 45% isolated yield. Worthy of note, the C-Br bond was not affected. Sodium thiophene-2-sulfinate gave only degradation products.

Alkylsulfinates proved also to be reactive. Indeed, reaction between sodium propane-2-sulfinate **2h**, or sodium cyclopropanesulfinate **2i**, gave allylsulfones **3ah** and **3ai** in 22% and 51% yield, respectively. Sodium methylsulfinate, sodium camphorsulfinate and sodium benzylsulfinate, gave no conversion or degradation products. Therefore, cyclopropylsulfinate **2i** turned out to be the only alkylsulfinate able to give the coupling. The reaction was also totally ineffective with very electron-poor sulfinates such as sodium trifluoromethylsulfinate (Langlois' reagent).

On the basis of previous reports on Pd-catalyzed allylic C—H activation reactions, a tentative mechanism is proposed (Scheme 2). After coordination of the alkene to the Pd(II) catalyst, an allylic proton is abstracted via a likely concerted

metalation deprotonation (CMD) mechanism, and the thus generated  $\eta^3$ -allylpalladium intermediate undergoes substitution by the sulfinate anion. Finally, after product decoordination, the generated Pd(0) complex, is reoxidized by the coordinated benzoquinone.

Given the moderate yields associated to some of the direct C—H sulfonylations, we decided to study an alternative protocol. Accordingly, on the basis of our previous work on the amination of but-3-enoic acids, [12h] we envisioned to perform a sequential one-pot doubly Pd-catalyzed procedure consisting in an initial oxidative Pd(II)-catalyzed allylic C—H alkene acetoxylation, followed by a redox-neutral Pd(0)-catalyzed allylic sulfonylation. The major challenge of this process consists in the use of the same palladium source for both the transformations. In the event, reacting allylbenzene (1.0 equiv.) with acetic acid (10.0 equiv.), in the presence of 2,6-DMBQ (2.0 equiv.) and Pd(OAc)<sub>2</sub> (10 mol%), in DMSO (0.2 M) at 80 °C gave the corresponding allylic acetate, which was not isolated (TLC

verification). Subsequent in situ addition of *rac*-BINAP (20 mol%), DIPEA (11.5 equiv.), and sodium *p*-toluenesulfinate (2.0 equiv.) with further stirring at 80 °C under air gave the desired allylsulfinate **3 aa** in 82% yield (Table 2, entry 1). When 10.0 equivalents of both acetic acid and base were used, the allylsulfone **3 aa** was obtained with a similar yield (83%), but in a much longer reaction time for the second step (Table 2, entry 2). Reducing this amount to 7.0, 5.0 or 3.0 equivalents resulted in generally longer reaction times for the second step accompanied with lower yields (Table 2, entries 3–5). We thus decided to keep our first conditions for the one-pot sequential protocol (Method B).

With the new one-pot sequential protocol in hand for the model coupling 1a+2a, we re-evaluated the sulfonylation of allylbenzene with the sulfinate salts previously used in the direct procedure (method A). The couplings turned out to be equally efficient with electron-rich sulfinates 2a-2c as well as with electron poor sulfinate 2e, affording satisfactory isolated


yields, ranging from 77% to 82% (Scheme 3). Such increases in yield when switching from Method A to Method B with reduced reaction times underscore the synthetic importance of the sequential one-pot procedure. However, with this protocol sodium  $\alpha$ -naphtylsulfinate **2d** gave a low yield of cinnamylsulfone 3 ad, and sodium 4-nitrobenzenesulfinate 2f did not sulfonylate the intermediate cinnamylacetate 4, which was recovered in 75% yield. When utilizing 2.0 equivalents of sodium 4-bromophenylsulfinate 2q, only a partial conversion of intermediate cinnamylacetate 4 was detected (40% recovered) and the allylsulfone 3 ag was isolated with 45% yield. Such a low reactivity might be due to competitive oxidative addition of the carbon-bromine bond of the sulfinate to Pd(0). However, increasing the amount of sulfinate 2 g to 3.0 equivalents, the second step of the sequential procedure was complete and allylsufone 3 ag was isolated with 63% yield. Alkylsulfinates 2 h, 2i and 2i were also relatively efficient with this one-pot protocol, affording the corresponding allylsulfones 3ah, 3ai and 3 aj in 77%, 73% and 48% yield, respectively (Scheme 3). In the case of sodium cyclopropylsulfinate 2i, 3.0 equivalents were also needed to obtain a satisfactory yield of cinnamylsulfone 3 ai, as only 28% yield was obtained when using 2.0 equivalents of the sulfinate. Also, 4.4 equivalents of sodium methylsulfinate 2i were necessary to obtain cinnamylmethylsulfone 3ai.

We next studied the influence of the nature of the alkene on the reaction outcome with the two sets of conditions. For this study, sodium benzenesulfinate **2b** was chosen as the reaction partner, because it is the nucleophile that gave the best results and the corresponding allylsulfones are synthetic intermediates for Julia olefinations. Thus, submission of the

electron-rich allylarenes **1 b** and **1 c** to the coupling with sodium benzenesulfinate provided the corresponding allylsulfones **3 bb** and **3 cb** in 41% and 42% yield by Method A, and 48% and 44% yield by Method B (Scheme 4), respectively. *Ortho*-substituted allylbenzene **1 d** gave allylsulfone **3 db** in 40% yield with Method A, while no product was observed when using the sequential procedure of Method B. The phenolic derivatives benzyleugenol **1 e** and 2-*O*-benzylallylbenzene **1 f** gave the corresponding allylsulfones **3 eb** and **3 fb** in 33% and 24% yields with Method A, and in 67% and 42% yields with Method B. The electron-poor allylarene **1 g** bearing a *para*-trifluoromethyl substituent afforded the expected allylsulfone **3 gb** in 20% yield with Method A and in 23% yield with Method B (Scheme 4). [16]

We next evaluated terminal aliphatic alkenes in the developed reaction conditions (Scheme 5). Undec-1-ene 1h, dec-1-ene 1i, non-1-ene 1j, oct-1-ene 1k, and hex-1-ene 1l were engaged in the presence of sodium benzenesulfinate 2b, providing with total regioselectivity the linear allylsulfones 3hb–3lb with yields ranging between 30% and 45% with Method A. In most cases, the pure (*E*)-configurated allylsulfones were isolated, although minor amounts of the (*Z*) isomers could be detected in the <sup>1</sup>H NMR spectra of the crude reaction products. Only in the case of allylsulfone 3jb, both (*E*)- and (*Z*)-isomers could be isolated separately.

Unfortunately, with these aliphatic substrates the reaction conditions of Method B do not allow the generation of the intermediate allylacetate. Since the Pd(II)-catalyzed C–H allylic acetoxylation of terminal alkenes has been reported, [11e] we decided to adopt these reaction conditions



as the first step of Method B. In the event, following a variant of White's protocol, undec-1-ene **1h** was treated with Pd-(OAc)<sub>2</sub> (10 mol%), in the presence of phenylvinylsulfoxide


(10 mol%) BzOH (10.0 equiv.), benzoquinone (2.0 equiv.), and 4 ÅMS (50 mg), in 1,4-dioxane (0.2 M). After 45 h stirring at 43 °C, treatment of the resulting branched allylic allylbenzoate 5 (TLC and ¹H NMR verification) with DIPEA (11.5 equiv.), sodium benzenesulfinate 2b (2.0 equiv.), rac-BINAP (20 mol%) with heating at 80 °C, afforded the desired allylsulfone 3 hb in 43 % NMR yield (Scheme 6). On the other hand, use of 1,2-bis(phenylsulfinyl)ethane (10 mol%) instead of phenylvinylsulfoxide, did not allow the formation of the allyl sulfone, giving only allylbenzoate 5 in 48% spectroscopic yield. We speculate that the disulfoxide ligand may prevent the phosphine promoted Pd(II)-to-Pd(0) reduction, thus halting the second, Pd(0)-catalyzed, step.

With these new conditions in hand, aliphatic terminal alkenes  $1\,h$ – $1\,p$  were evaluated for the synthesis of the corresponding allylsulfones  $3\,hb$ – $3\,pb$  (Scheme 5). Besides allylsulfone  $3\,hb$  which was isolated with  $40\,\%$  isolated yield, aliphatic allylsulfones  $3\,ib$ ,  $3\,jb$ ,  $3\,kb$  and  $3\,lb$  were obtained from dec-1-ene  $1\,i$ , non-1-ene  $1\,j$ , oct-1-ene  $1\,k$  and hex-1-ene  $1\,l$  respectively with  $39\,\%$ ,  $49\,\%$ ,  $12\,\%$  and  $48\,\%$  isolated yield. Here again, E/Z mixtures of isomers were detected in the NMR spectra of the crude reaction products, the (E)-isomers being always the major ones.

Methylenecyclopentane 1 m could also be converted into allylsulfone 3 mb with Method A in a moderate 30% yield, while Method B and B' failed. More functionalized aliphatic alkenes such as benzylether 1 n and esters 1 o and 1 p gave no or trace amounts of sulfonylated product with Methods A or B. Besides, Method B' allowed to obtain the corresponding allylsulfones 3 nb, 3 ob, and 3 pb and in 51%, 68% and 58% yields, respectively. In all these cases, E/Z mixtures were constantly obtained, with the (E)-isomer prevailing. This protocol, though requiring a long reaction time (4-5 days), is


Scheme 6. Adapted sequential conditions for the reaction of undecene 1 h (Method B').

to date the only way to afford such allylsulfones via allylic C–H functionalization. [17]

The mechanism associated to Method B' is expected to entail two different, but connected, catalytic cycles. Coordination of the terminal alkene and of the sulfoxide ligand to the palladium atom of the in situ formed palladium dibenzoate generates the corresponding  $\eta^3$ -allylpalladium complex via a likely CMD mechanism. Following inner sphere benzoate ligand transfer to the internal terminus of the  $\pi$ complexed allyl fragment generates the branched allylic benzoate and BQ-complexed Pd(0), which regenerates palladium dibenzoate. [11e,14a] Once the formation of the allylic benzoate is complete, addition of DIPEA and rac-BINAP to the reaction mixture sets the stage for the second catalytic cycle. Indeed, the amine quenches the excess of benzoic acid making the corresponding salt, while the diphosphine reduces [18] the palladium diacetate and complexes the thus generated Pd(0) via  $\kappa^2$ -coordination. After coordination of the alkene function of the allylic benzoate to the Pd(0) complex, a new, ionic,  $\eta^3$ -allylpalladium complex is formed. This latter is intercepted by the sulfinate anion, which generates the allylic sulfone product and regenerates the Pd(0) complex (Scheme 7).

### Conclusion

In summary, we developed two distinct protocols for the preparation of allylsulfones from commercially available alkenes through allylic C–H activation. The first method consists in the palladium-catalyzed direct allylic C–H sulfonylation of terminal alkenes, while the second procedure deals with a one-pot sequential Pd(II)-catalyzed allylic C–H acetoxylation, followed by a Pd(0)-catalyzed sulfonylation. While the first protocol is more straightforward, the second one gave often higher yields with a broader substrate scope, yet allowing to use the same palladium pre-catalyst for the two steps. A plausible mechanism is proposed in both cases. Future work will be dedicated to the improvement of the

above studied protocols as well as the in situ further reaction of the resulting allylsulfones.

## **Experimental Section**

General procedure for direct allylic C–H sulfonylation of alkenes (Method A): An ace pressure tube equipped with a magnetic stirrer was charged with 15.2 mg (0.05 mmol, 10 mol%) of palladium(II) acetylacetonate, 136 mg (1.0 mmol, 2.0 equiv.) of 2,6-dimethyl-1,4-benzoquinone and the sulfinate 2a-2j (1.0 mmol, 2.0 equiv.). The tube was placed under vacuum and then backfilled with argon. The vacuum/argon cycles were repeated twice and 0.75 mL of distilled acetonitrile (0.66 M) was introduced. To this suspension was introduced the alkene 1b-1q (0.5 mmol, 1.0 equiv.) and the mixture was heated to 80 °C under stirring until conversion was complete as checked by TLC. The mixture was then cooled to rt and filtered over a pad of silica gel with 50 mL of ethyl acetate. The filtrate was concentrated under reduced pressure and the residue was purified by flash column chromatography on silica gel to give the desired products.

General procedure for one-pot sequential allylic C–H sulfonylation of allylarenes (Method B): An ace pressure tube equipped with a magnetic stirrer was charged with 11.2 mg (0.05 mmol, 10 mol%) of palladium(II) acetate, 136.2 mg (1.0 mmol, 2.0 equiv.)



of 2,6-dimethylbenzo-1,4-quinone and 50 mg of 4 Å molecular sieves. The solids were suspended in 1.5 mL of anhydrous DMSO and 0.29 mL (5.0 mmol, 10.0 equiv.) of acetic acid was introduced followed by the alkene 1b-1g (0.5 mmol, 1.0 equiv.). The mixture was heated to 80°C until complete conversion of the alkene was reached as checked by TLC. The mixture was cooled to rt and 62.0 mg (0.1 mmol, 20 mol%) of rac-BINAP followed by 1.0 mL (7.25 mmol, 11.5 equiv.) of N,N-diisopropylethylamine were added to the reaction mixture. The sulfinate 2a-2i (1.0 mmol, 2.0 equiv.) was then introduced and the ace pressure tube was closed. The reaction mixture was then heated to 80 °C until complete conversion of the intermediate allylacetate was seen by TLC. The mixture was then cooled to rt and filtered over a pad of silica gel with 50 mL of ethyl acetate to remove the salts. The filtrate was placed into a separatory funnel and washed with 50 mL of water. The aqueous layer was extracted with  $2\times$ 20 mL of ethyl acetate. The combined organic layers were dried over anhydrous MgSO<sub>4</sub> and filtered. The filtrate was concentrated under reduced pressure and the residue was purified by flash column chromatography on silica gel to give the desired products.

General procedure for one-pot sequential allylic C-H sulfonylation of terminal aliphatic alkenes (Method B'): An ace pressure tube equipped with a magnetic stirrer was charged with 4.5 mg (0.02 mmol, 10 mol%) of palladium(II) acetate, 2.7 μL (0.02 mmol, 10 mol%) of phenylvinylsulfoxide and 43.3 mg (0.4 mmol, 2.0 equiv.) of 1,4-benzoguinone. The solids were suspended in 0.6 mL of anhydrous 1.4-dioxane and 244.2 mg (2.0 mmol, 10.0 equiv.) of benzoic acid was introduced followed by the alkene 1 h-1 q (0.2 mmol, 1.0 equiv.). The mixture was heated to 43 °C until complete conversion of the alkene was reached as checked by TLC or <sup>1</sup>H NMR (usually 66-72 h). The mixture was cooled to rt and 25.0 mg (0.04 mmol, 20 mol%) of rac-BINAP followed by 0.4 mL (2.3 mmol, 11.5 equiv.) of N,Ndiisopropylethylamine were added to the reaction mixture. To this mixture was introduced 65.4 mg (0.4 mmol, 2.0 equiv.) of Sodium benzenesulfinate 2b and the sealed tube was closed. The reaction mixture was then heated to 80 °C until complete conversion of the intermediate allylbenzoate was seen by TLC. The mixture was then cooled to rt and filtered over a pad of silica gel with 25 mL of ethyl acetate to remove the salts. The filtrate was concentrated under reduced pressure and the residue was purified by flash column chromatography on silica gel to give the desired products.

This thesis work is dealing with the study of synthetic opportunities offered by allylsulfones and

palladium in chemistry. Firstly, we attempted to develop a new domino sequence, which involves the

reaction between allyl carbonates/ally acetates and sodium sulfinates. This domino reaction involves a

triple intermolecular Pd-catalyzed allylation reaction and allows the construction of C-S/C-C/C-C bonds.

Secondly, we have successfully developed and compared two distinct and effective protocols for the

preparation of allylsulfones from commercially available alkenes via PdX2-catalyzed allylic C-H

activation/sulfonylation. The first protocol is involving a direct PdX<sub>2</sub>-catalyzed allylic C-H sulfonylation

and the second protocol a one-pot sequential PdX2-catalyzed allylic C-H acetoxylation followed by a

Pd(0)-catalyzed sulfonylation.

Lastly, we tried to improve the generation of a dihydroquino-sulfone side product, studying the reaction

conditions for its synthesis.

Génération et Réactivité des Allylsulfones par Catalyse au Palladium

Ce travail de thèse porte sur l'étude des opportunités synthétiques offertes par les allylsulfones et la

chimie du palladium. Tout d'abord, une nouvelle séquence domino a été développée, qui implique la

réaction entre les carbonates/acétates d'allyle et des sulfinates de sodium. Cette réaction domino

implique une triple réaction d'allylation intermoléculaire catalysée par le Pd et permet la construction

de liaisons C-S/C-C/C-C.

Deuxièmement, nous avons développé et comparé avec succès deux protocoles distincts et efficaces

pour la préparation d'allylsulfones à partir d'alcènes disponibles dans le commerce via

l'activation/sulfonylation C-H allylique catalysée par PdX2. Le premier protocole implique une

sulfonylation C-H allylique catalysée directement par PdX2 et le second protocole implique une

acétoxylation C-H allylique « one-pot » catalysée par PdX<sub>2</sub> suivie d'une sulfonylation catalysée par du

Pd(0).

Enfin, nous avons essayé de préparer un produit secondaire de type dihydroquino-sulfone et étudié les

conditions de réaction pour sa synthèse.
